(57) **CLAIM**

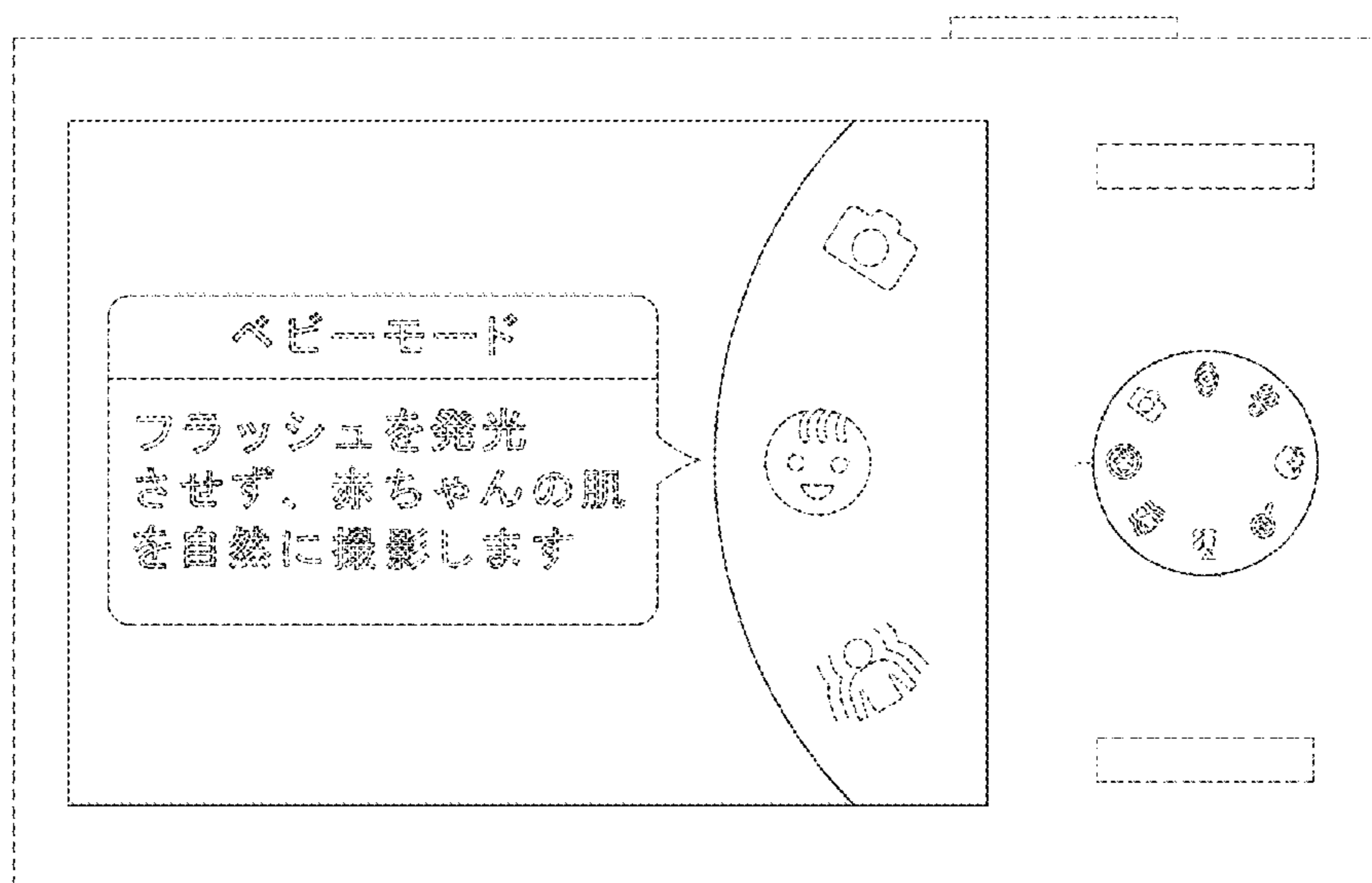
The ornamental design for a combined electronic camera display screen with icon and electronic camera, as shown and described.
