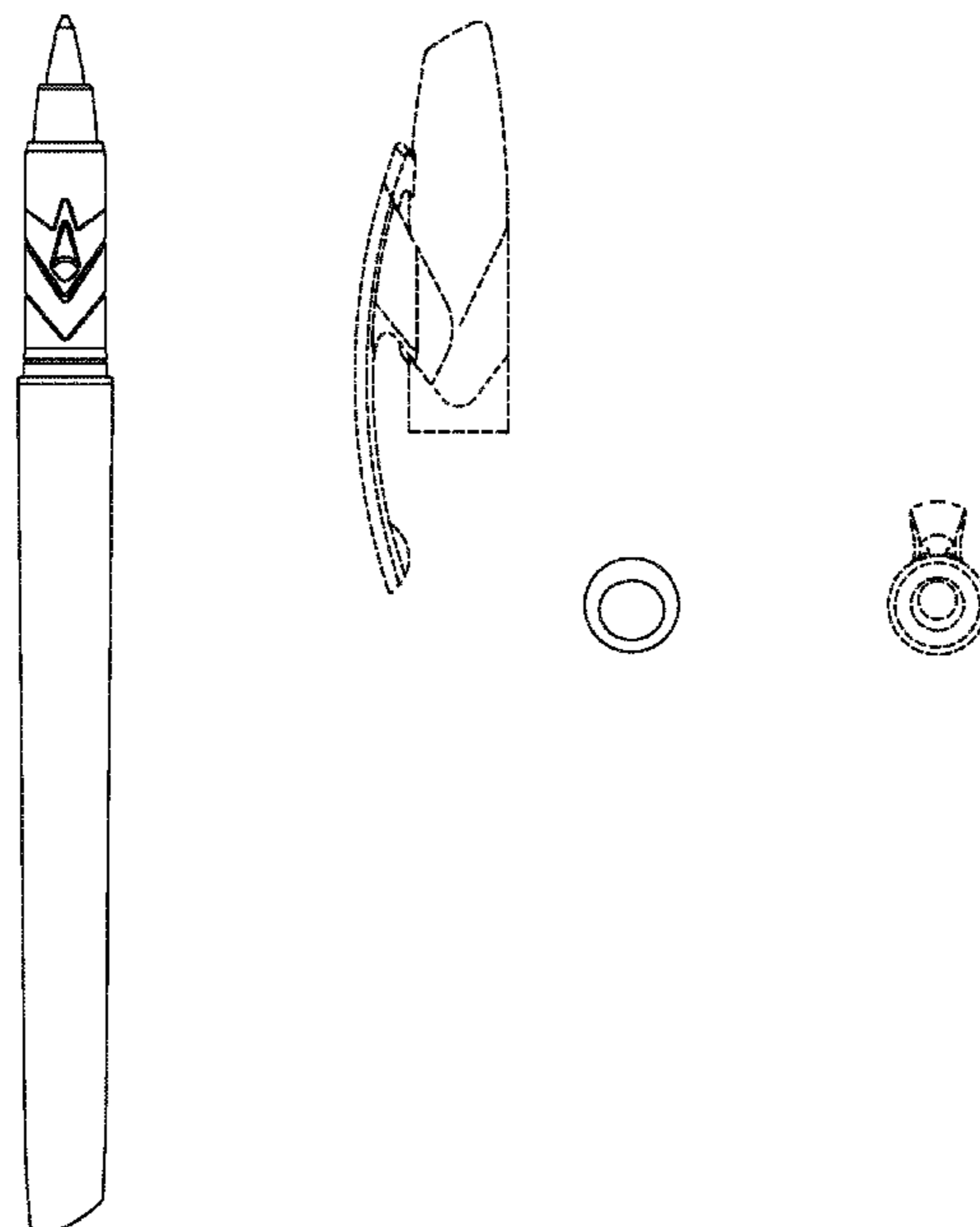
(57) **CLAIM**

The ornamental design for a writing instrument, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, side perspective view of a writing instrument according to the present design;
FIG. 2 is a front view of the writing instrument of FIG. 1;
FIG. 3 is a rear view of the writing instrument of FIG. 1;
FIG. 4 is a right side view of the writing instrument of FIG. 1;
FIG. 5 is a left side view of the writing instrument of FIG. 1;
FIG. 6 is a top view of the writing instrument of FIGS. 1; and,
FIG. 7 is a bottom view of the writing instrument of FIG. 1.

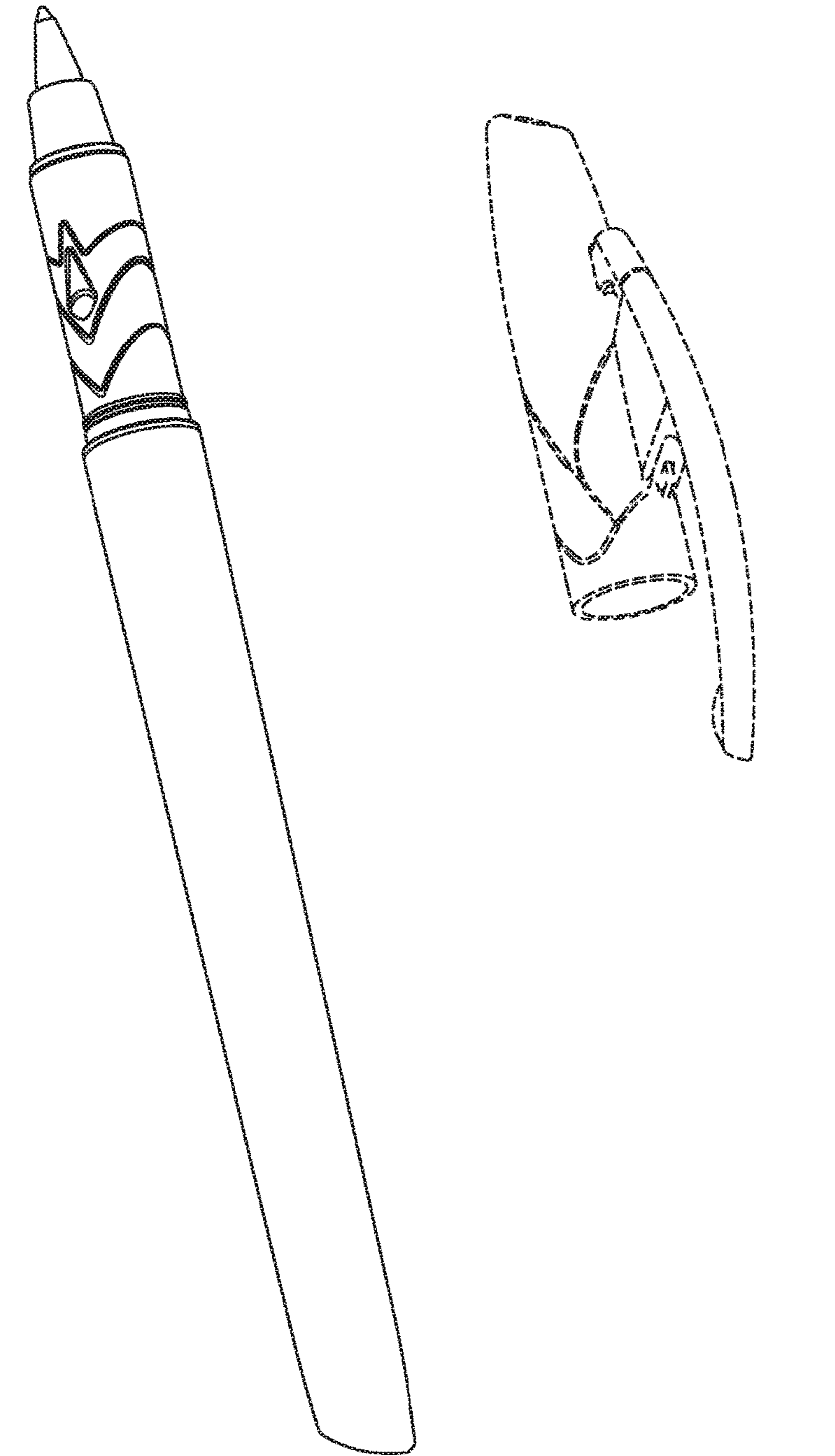

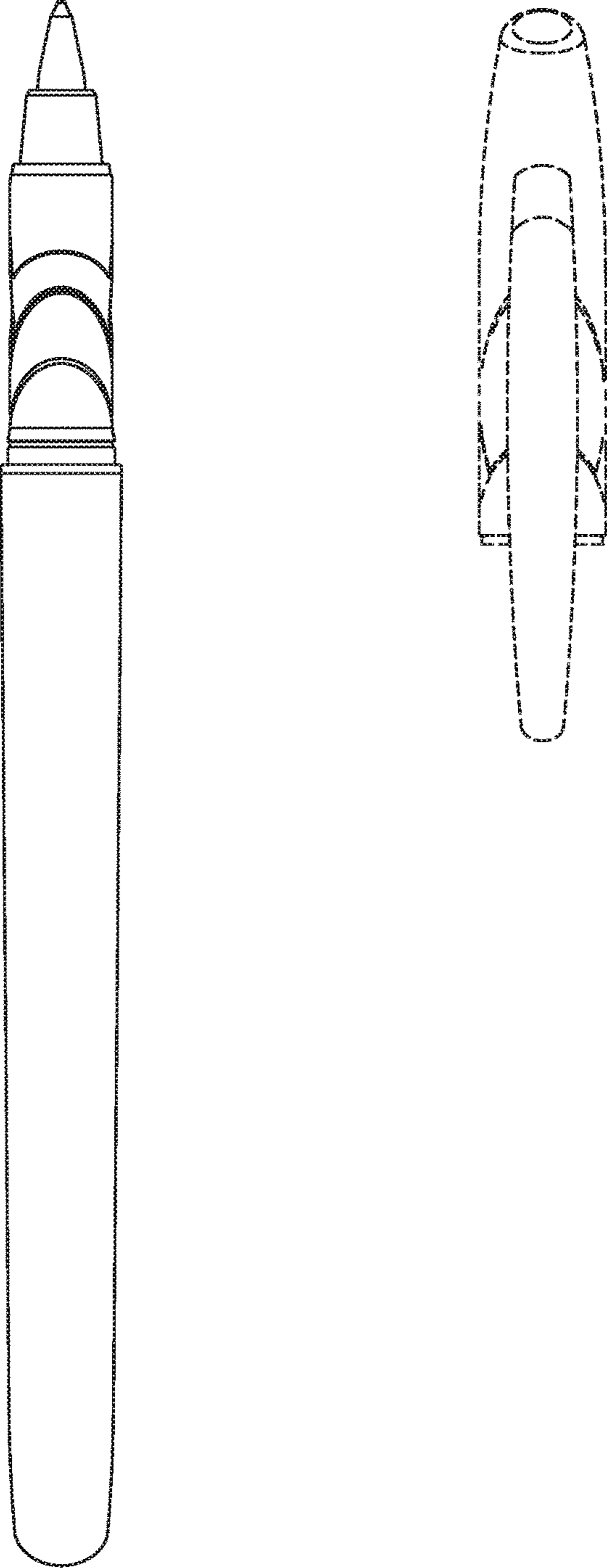

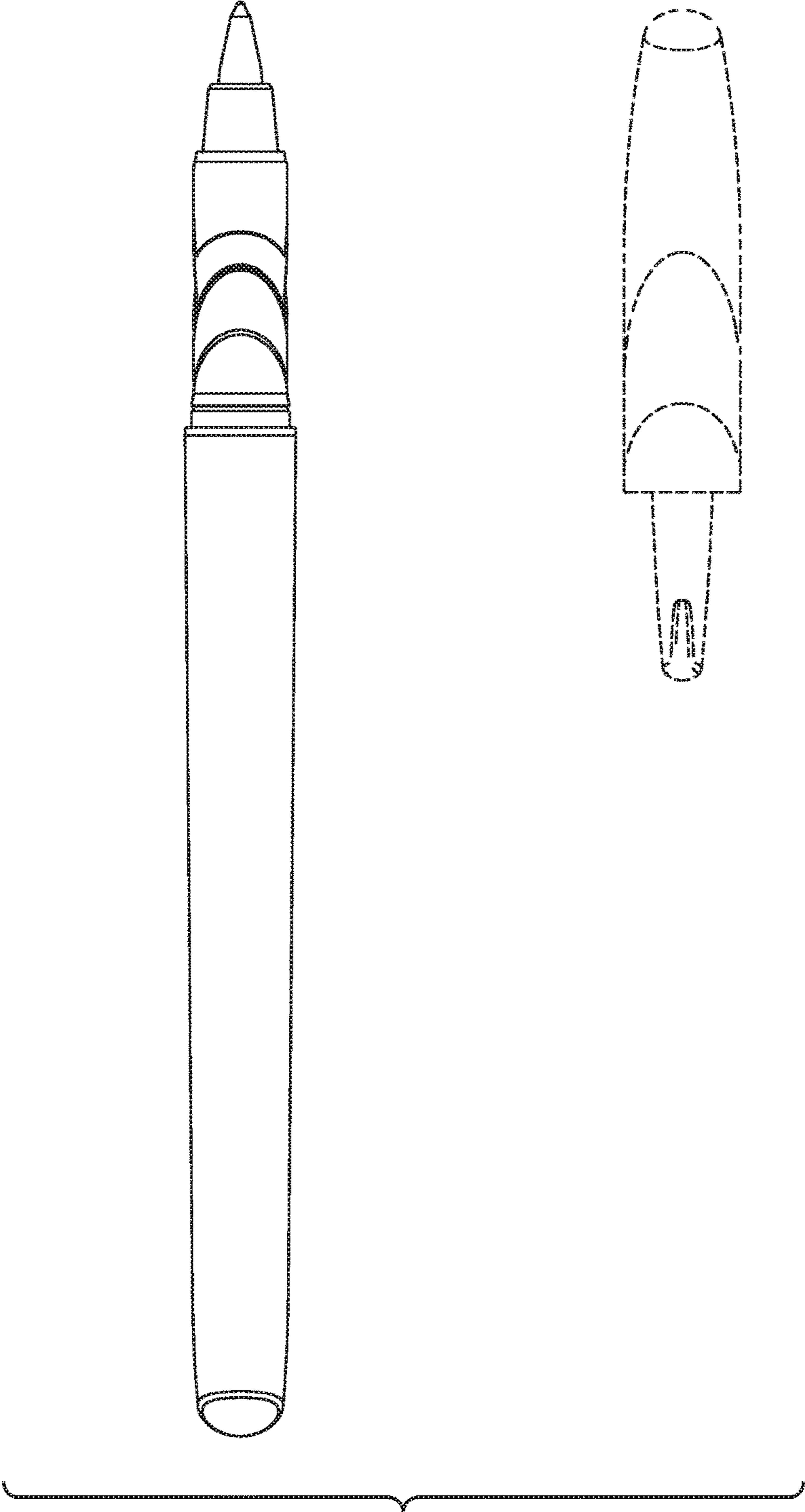

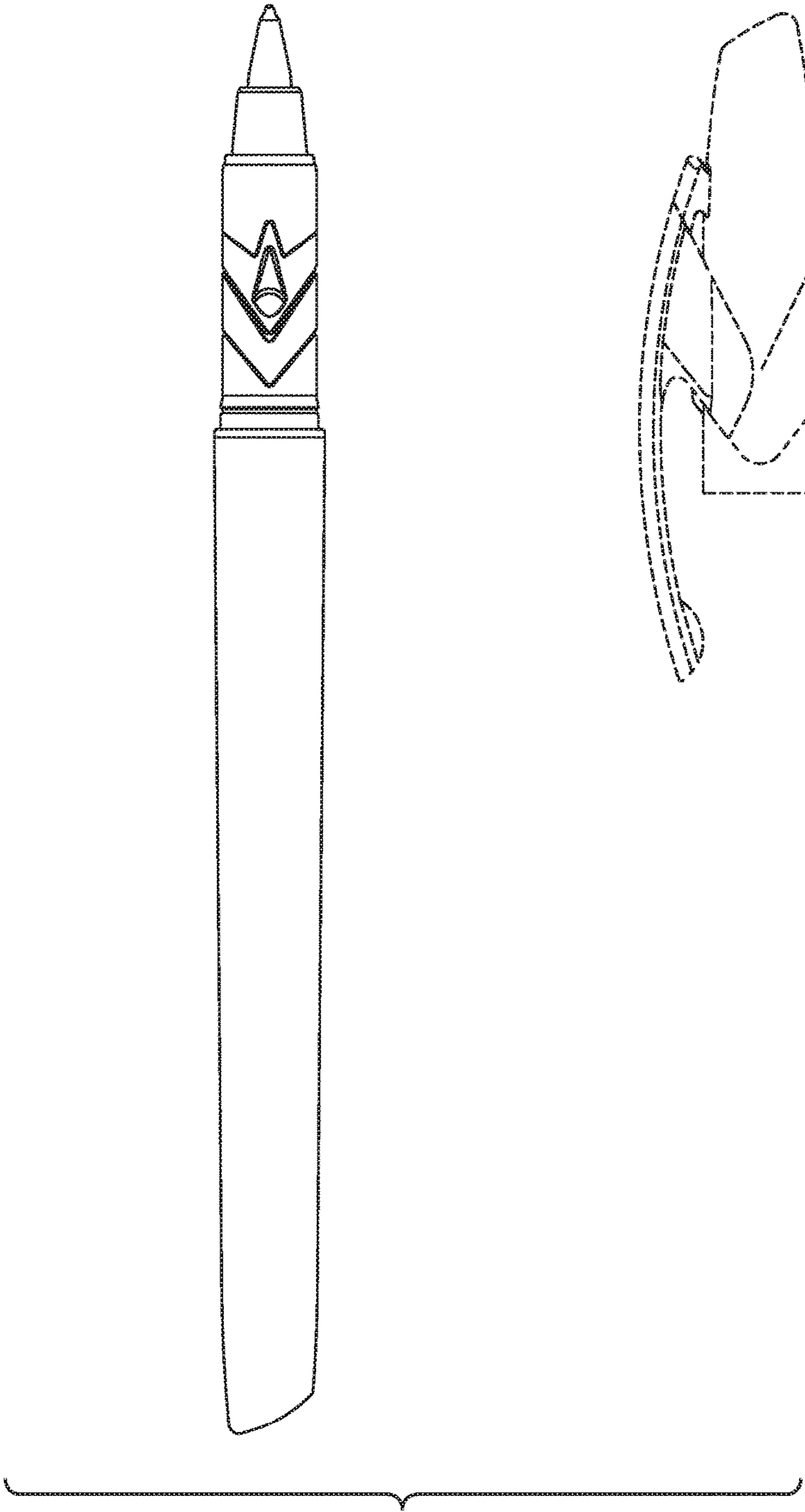

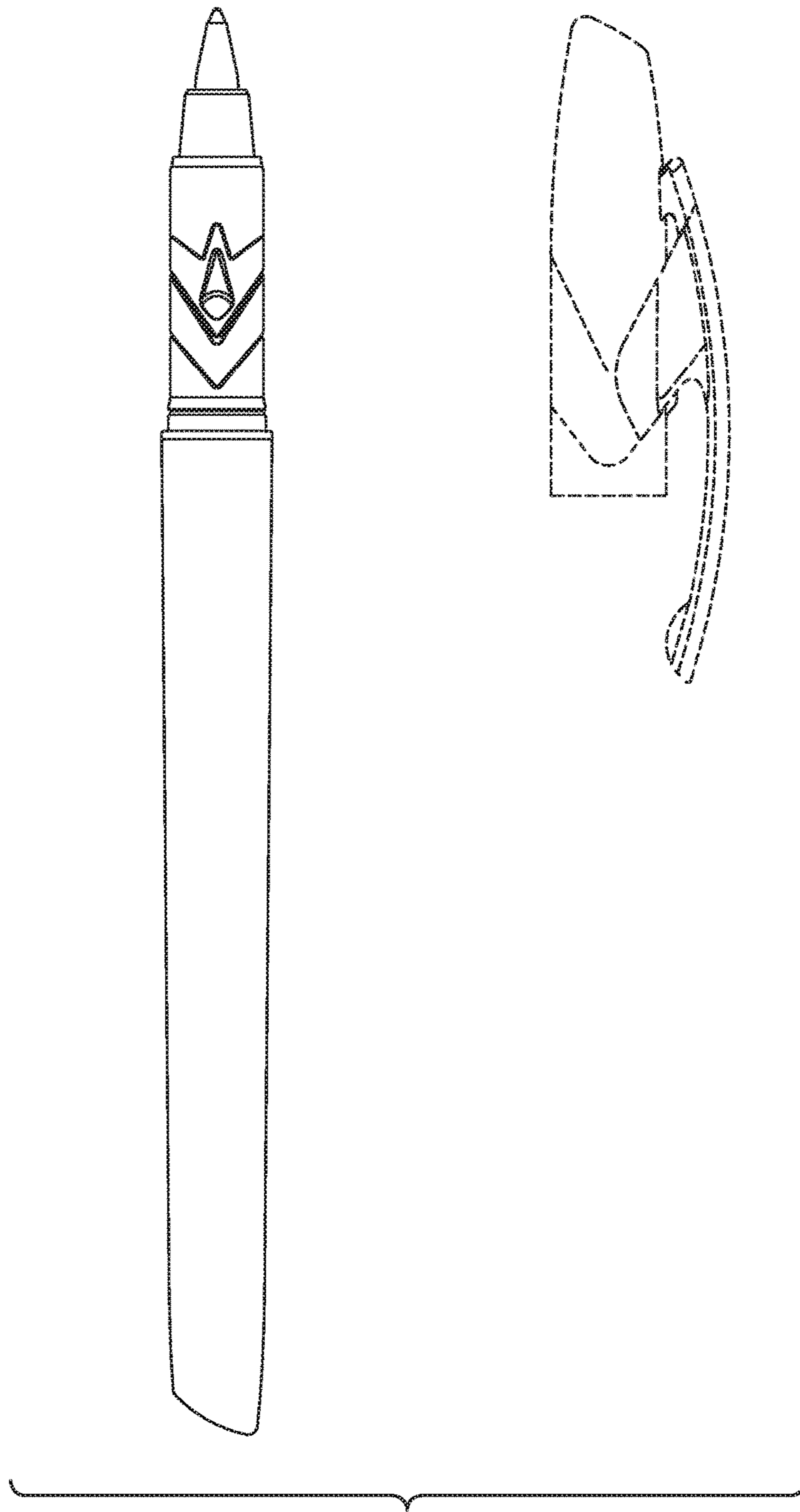

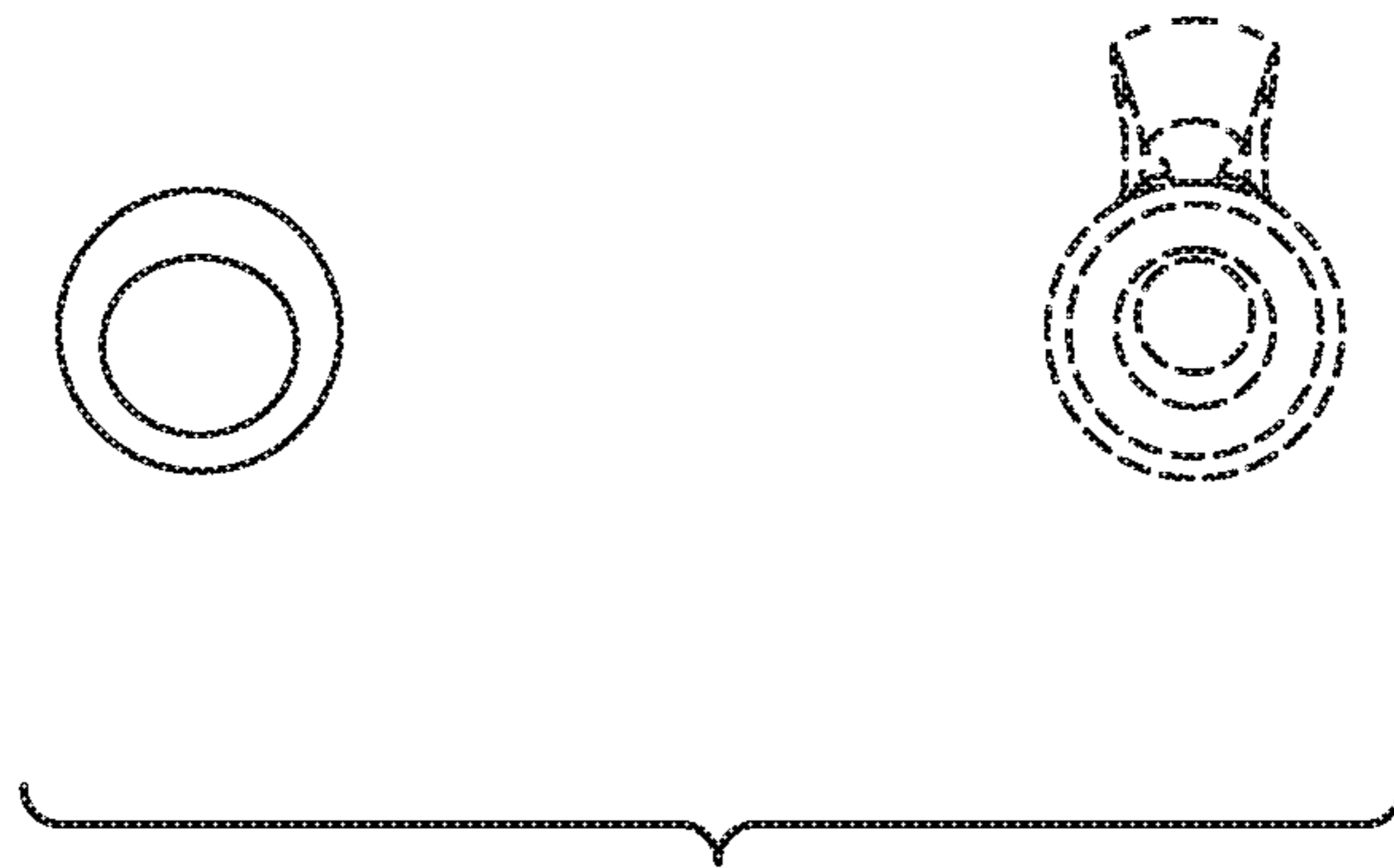

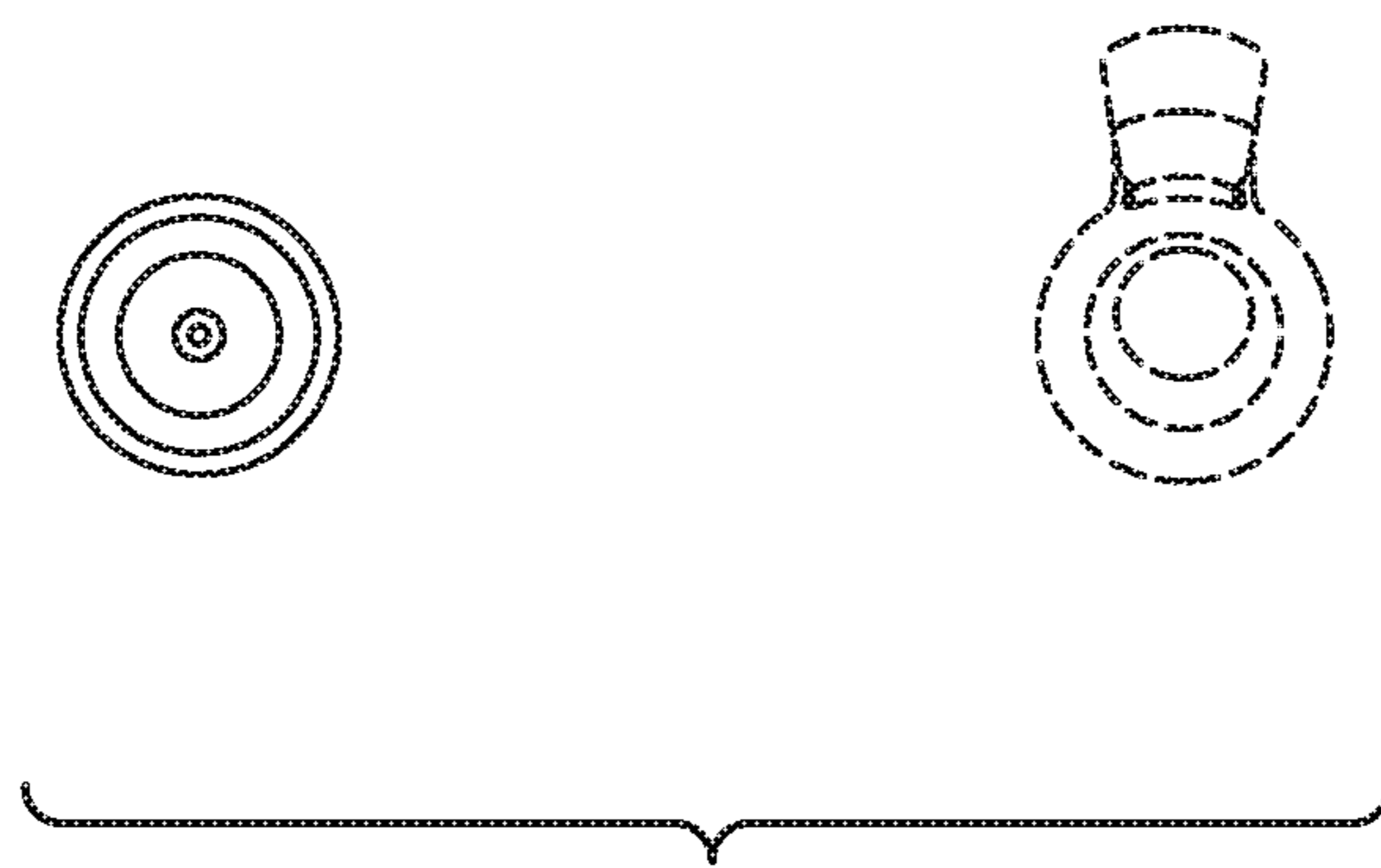
