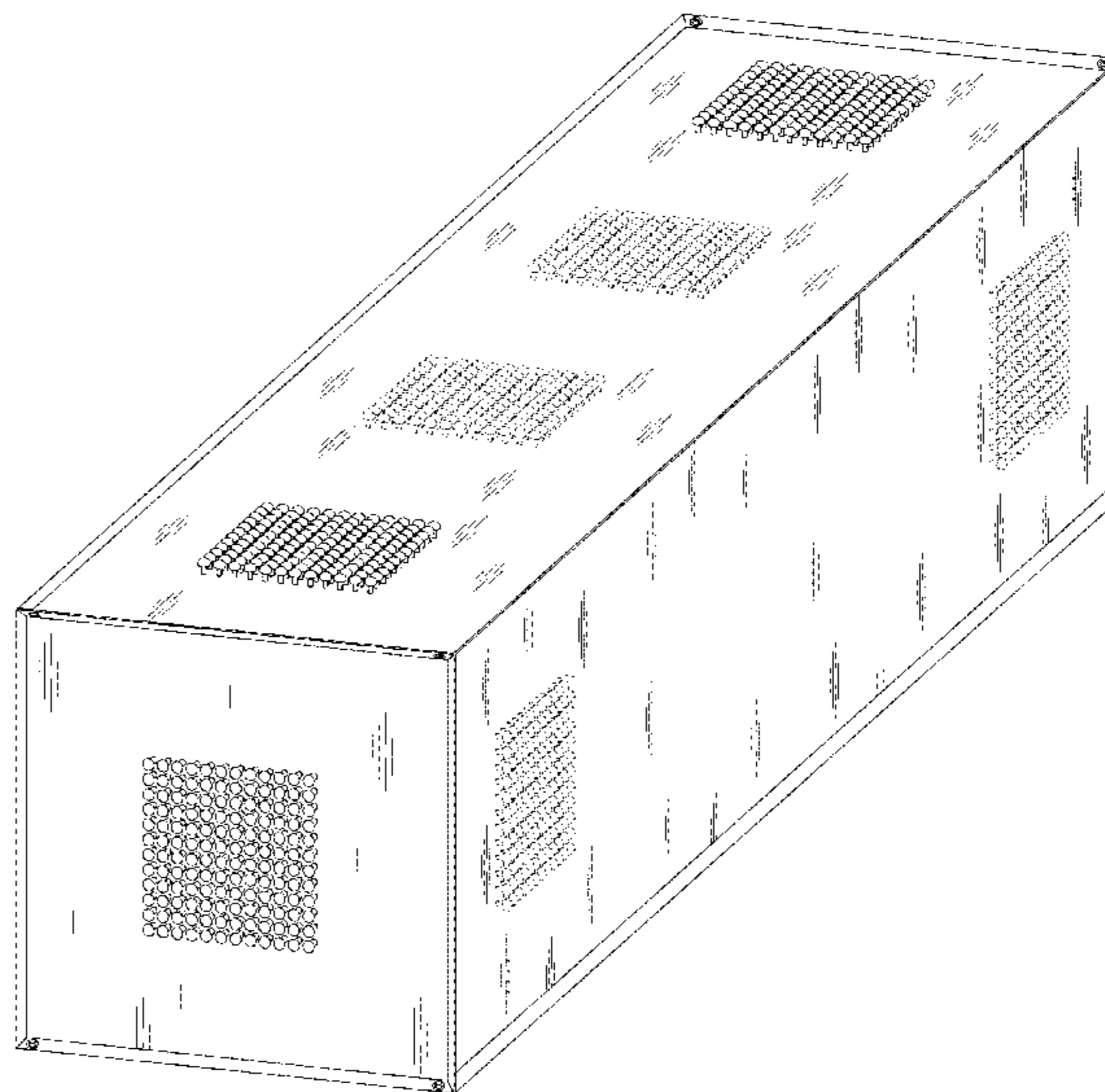
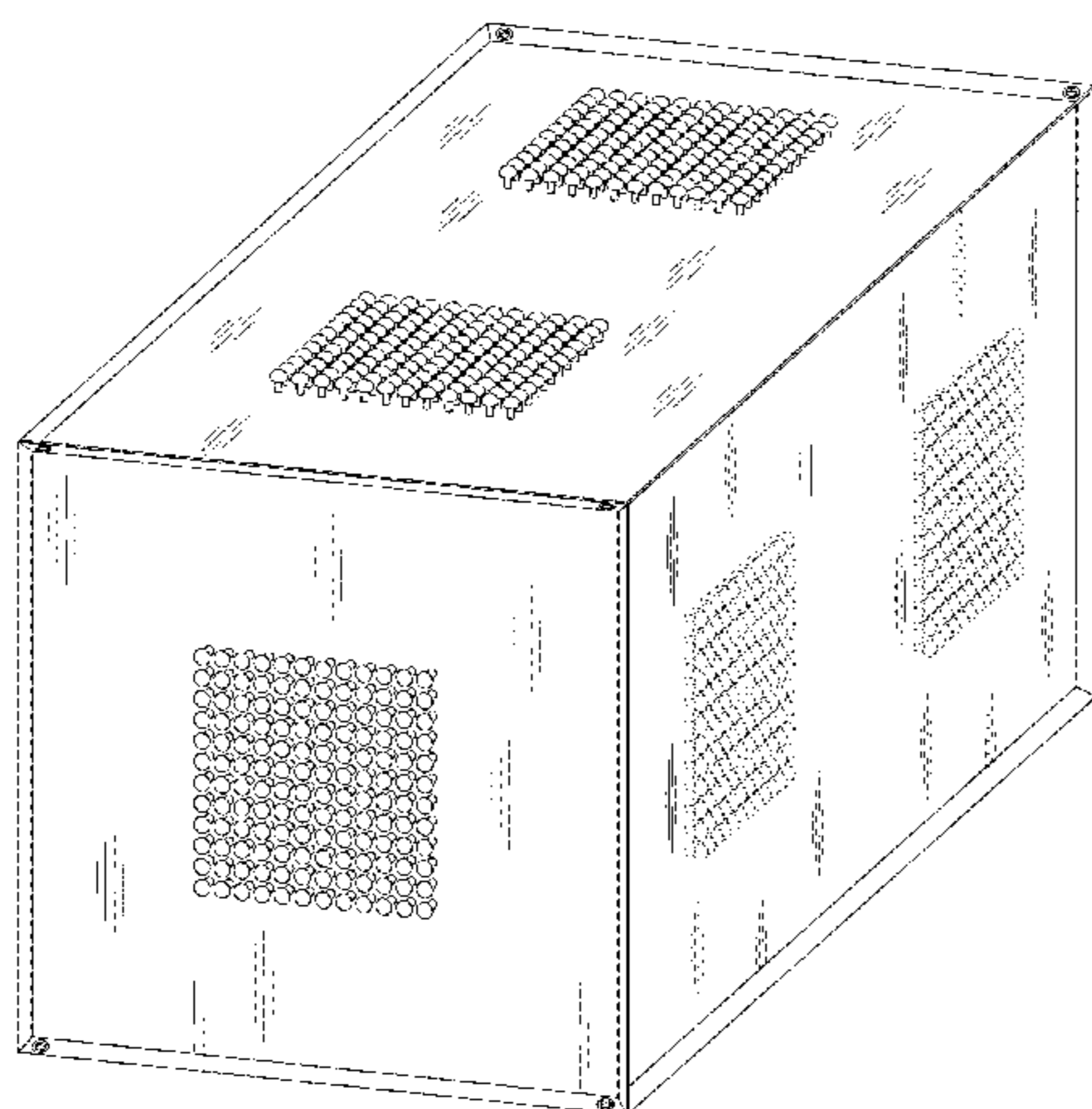
The ornamental design for an inflatable building block rectangle, as shown and described.

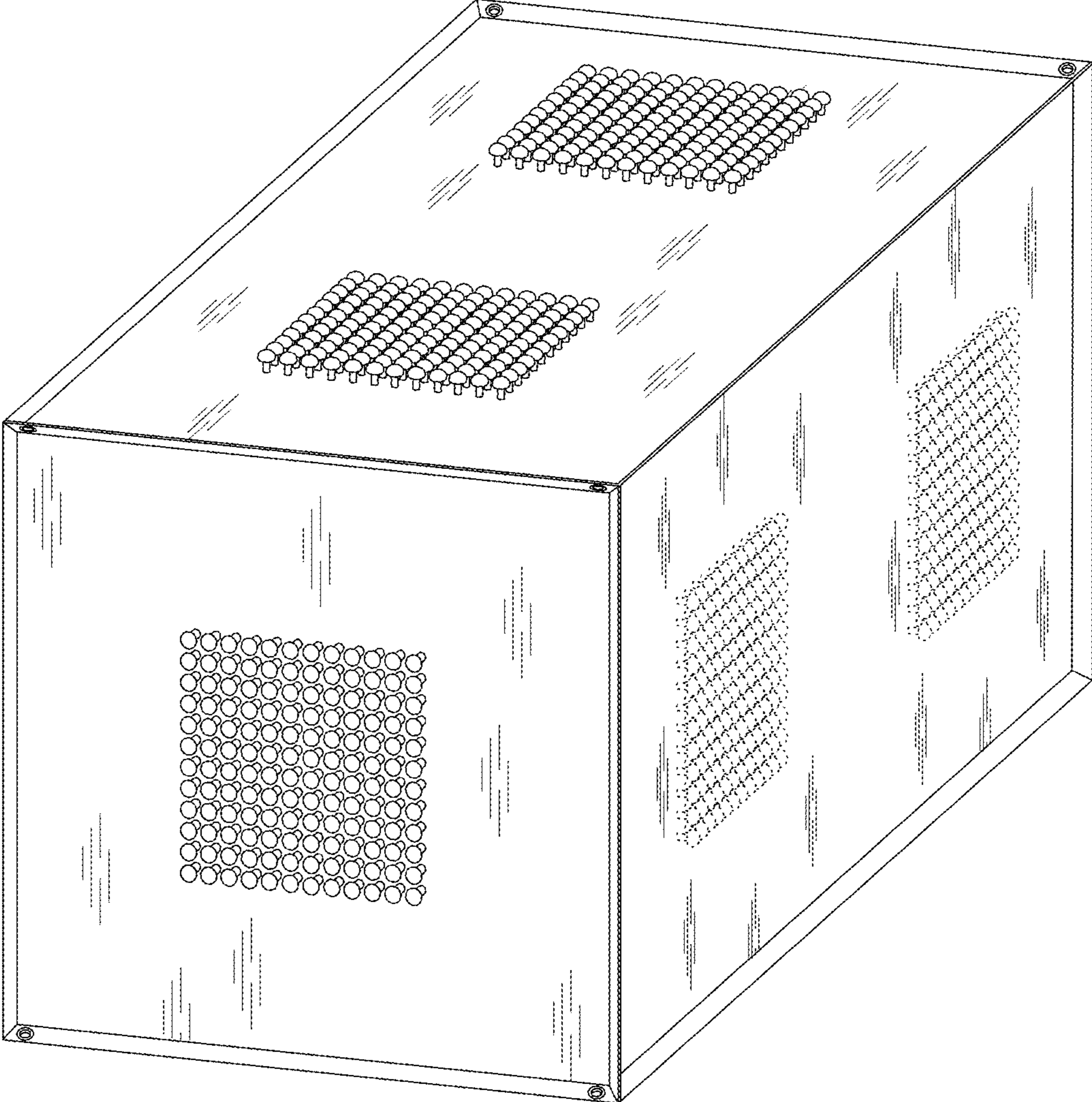

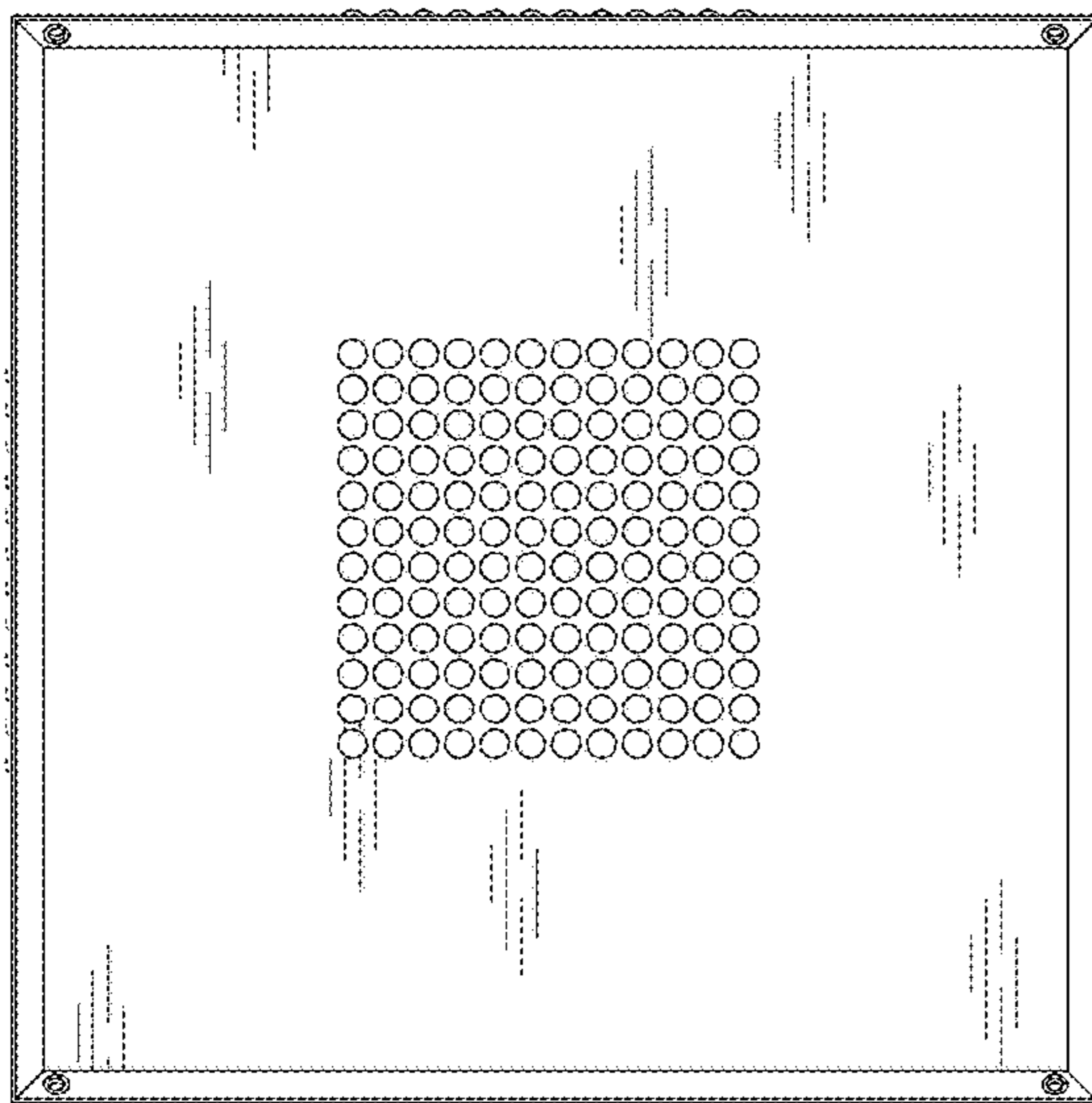

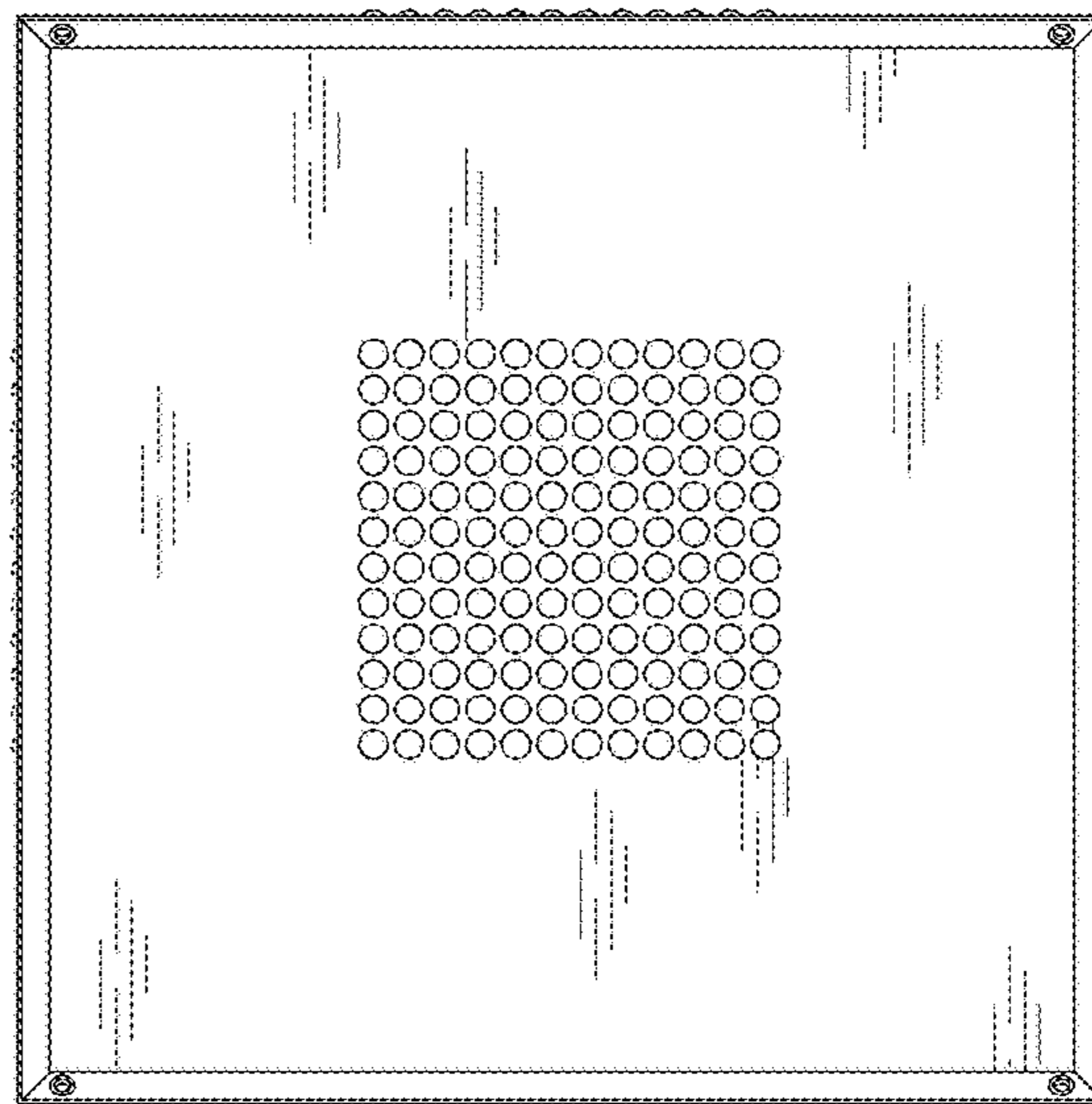

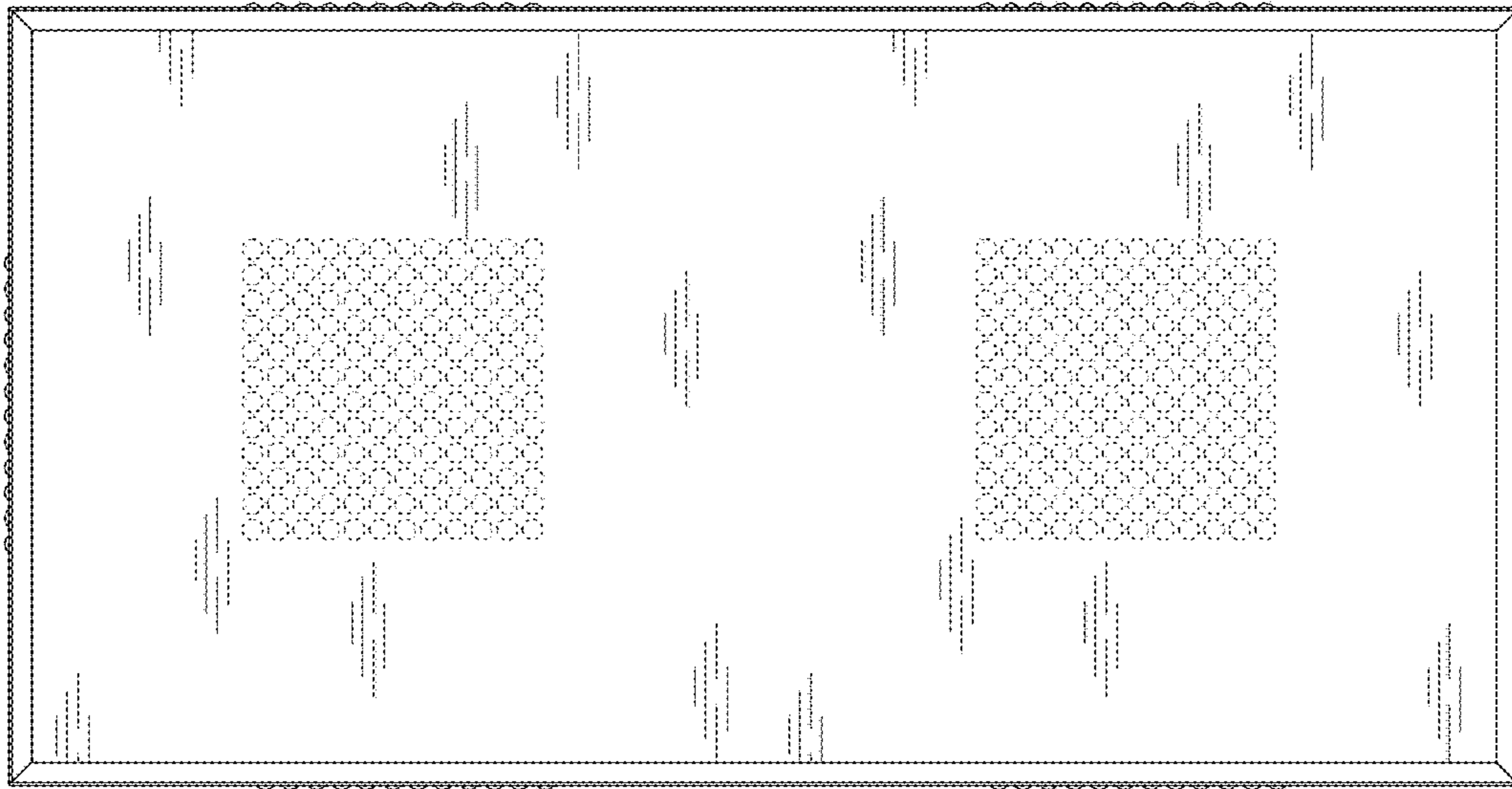

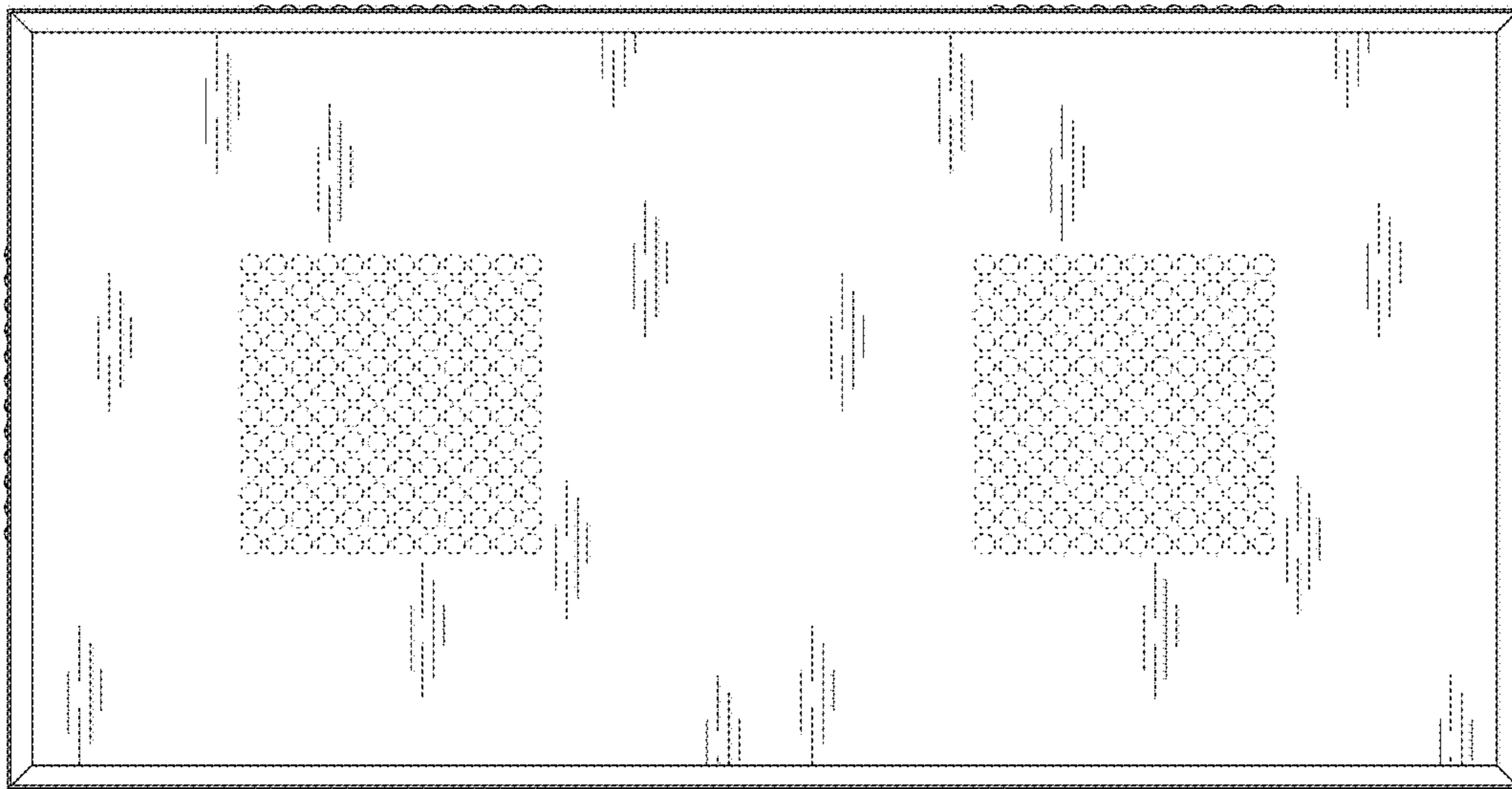

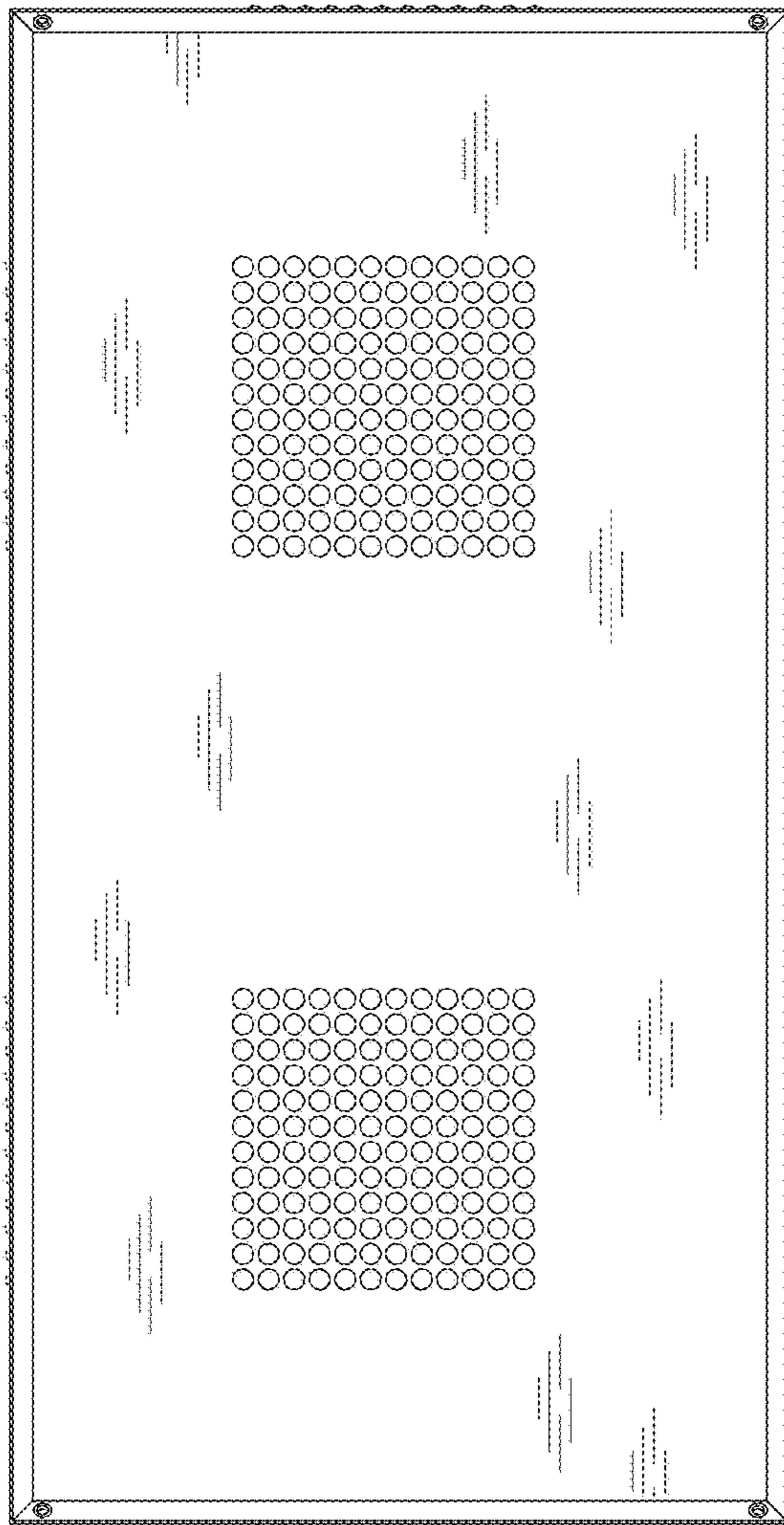

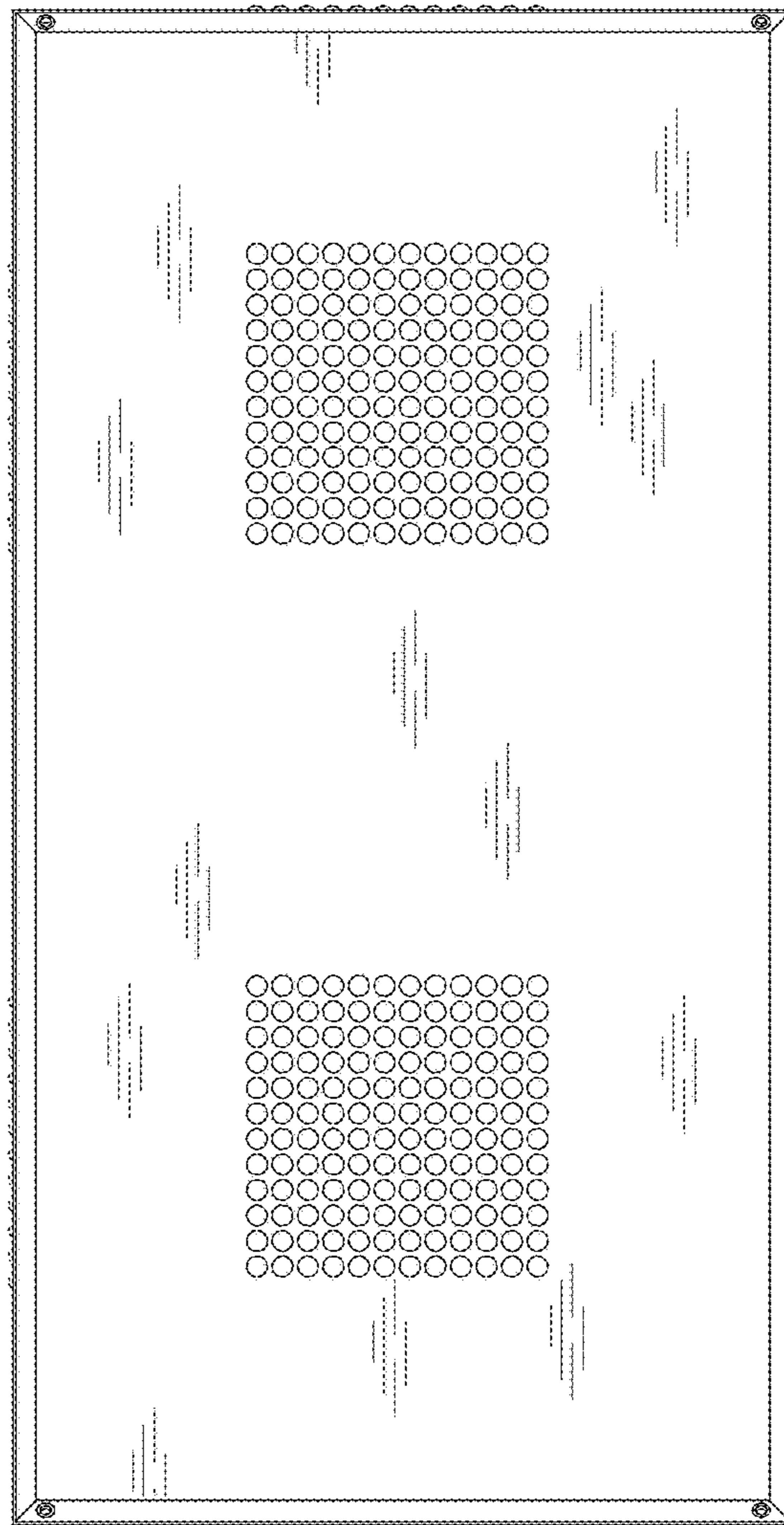

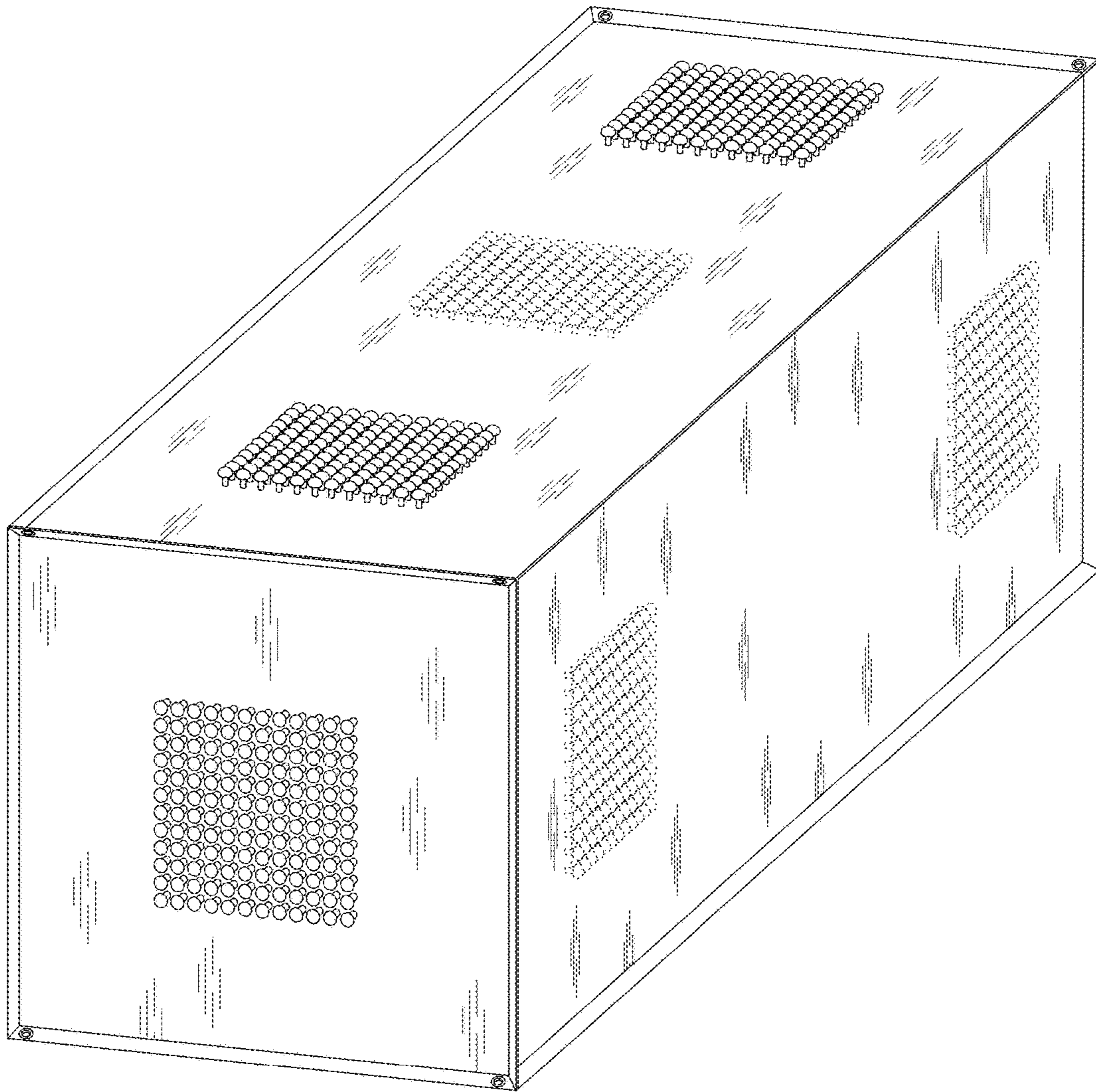

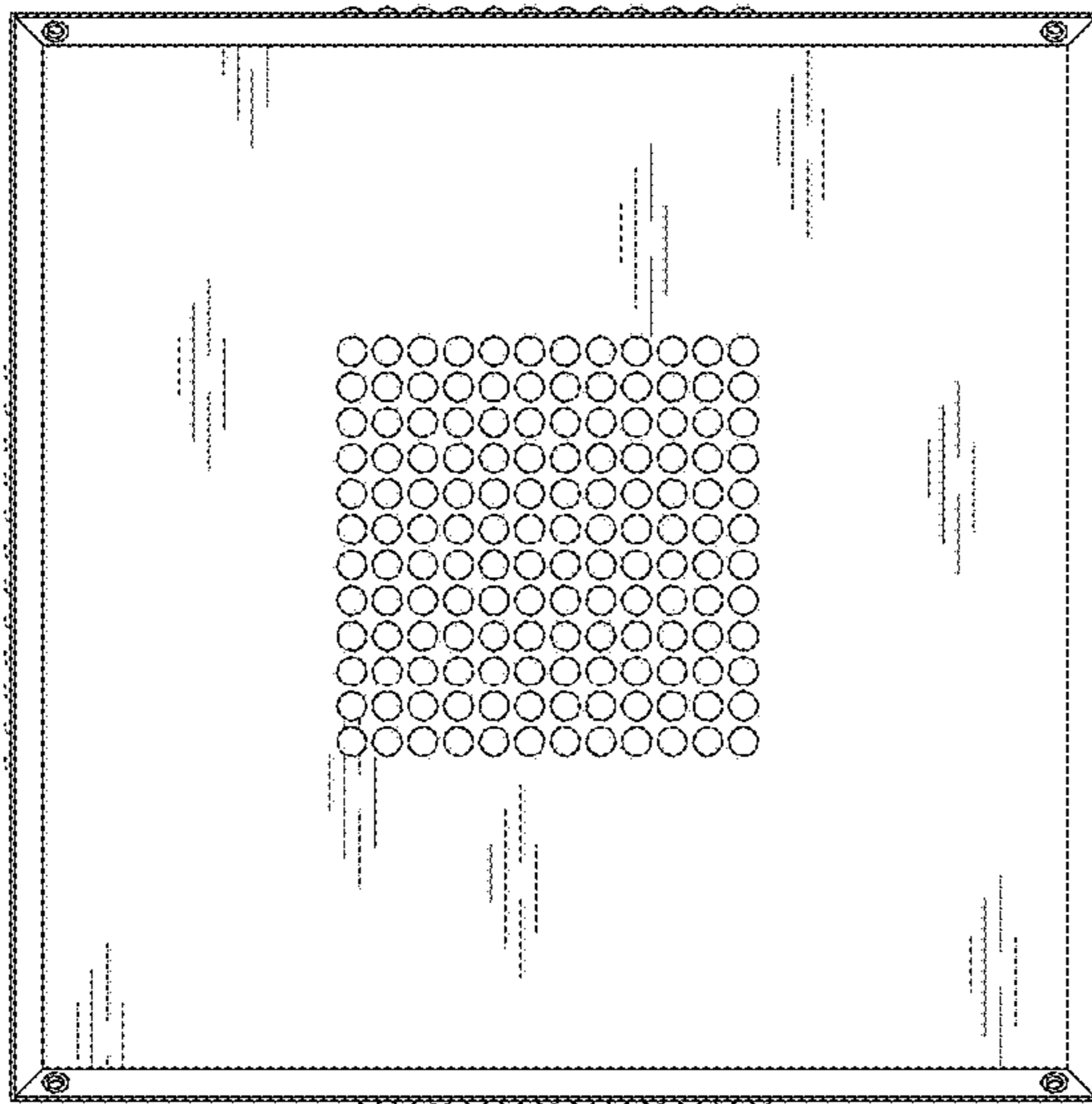

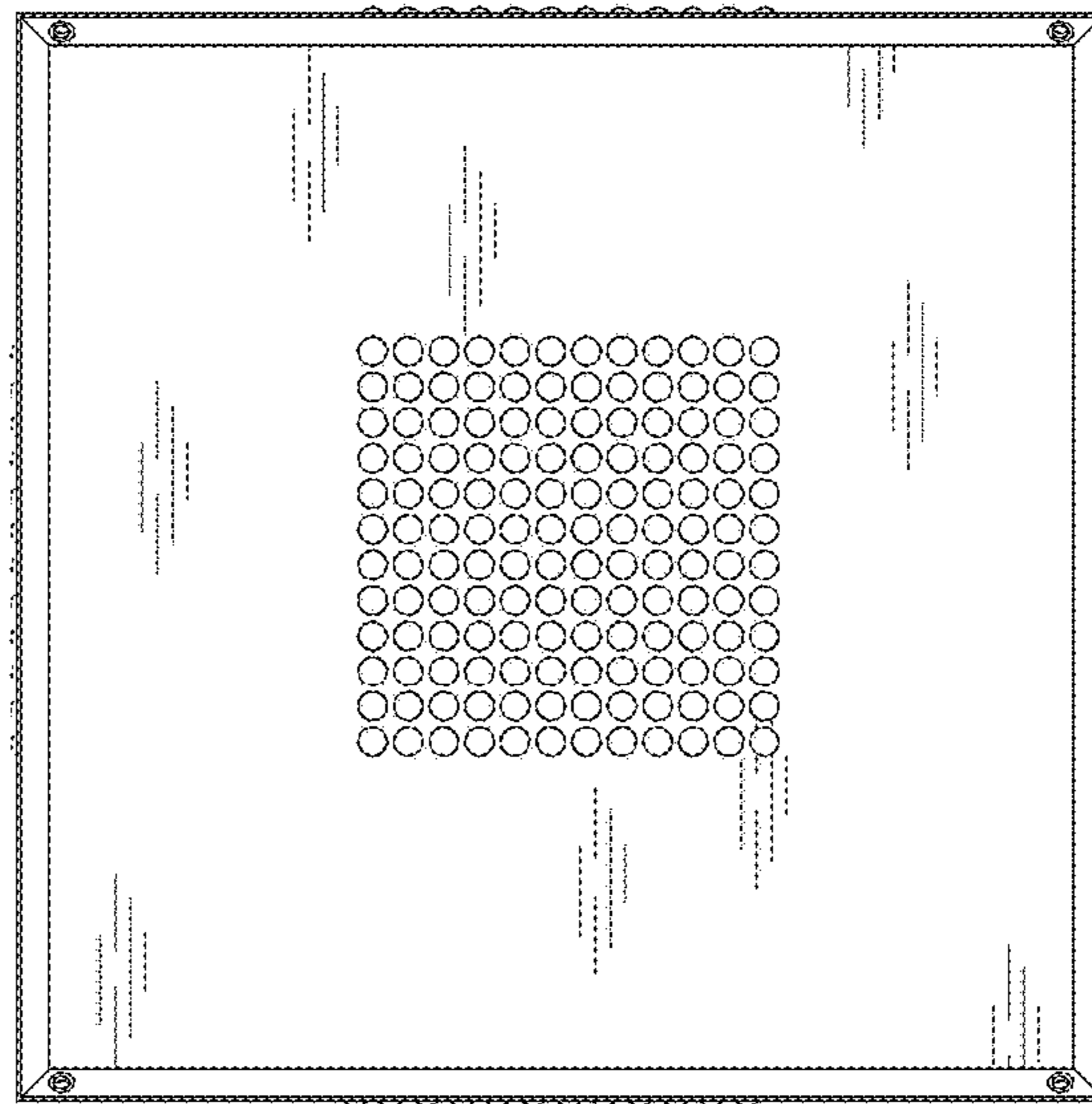

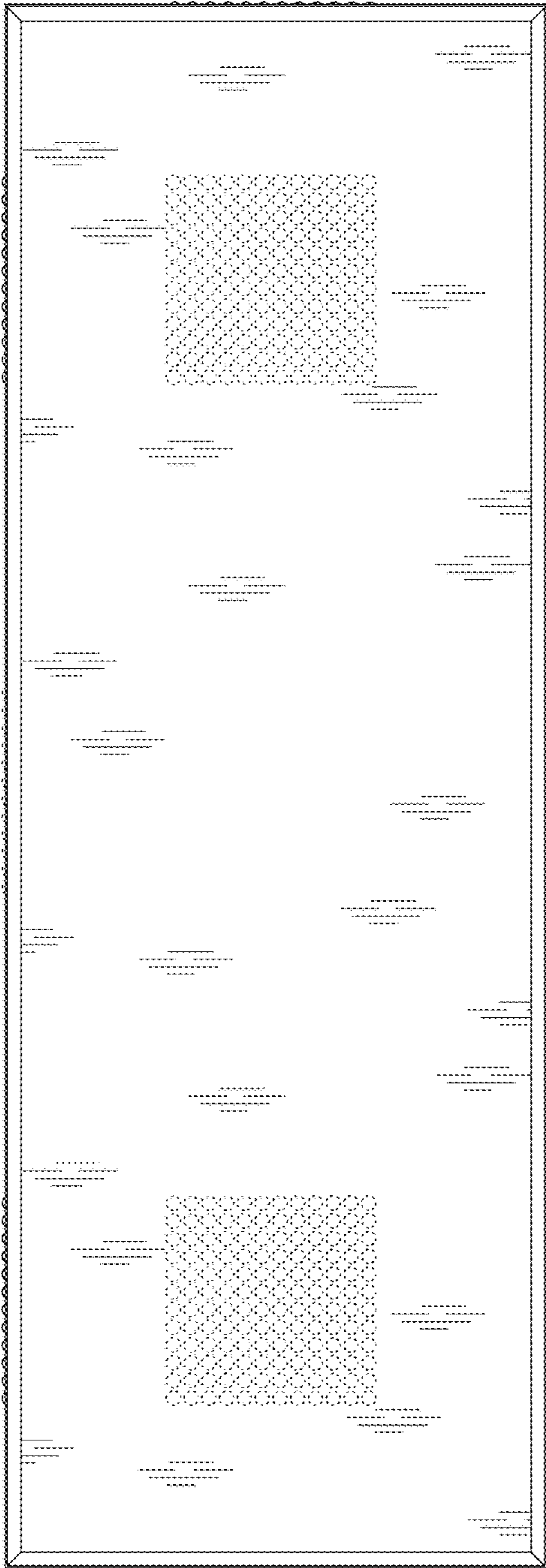

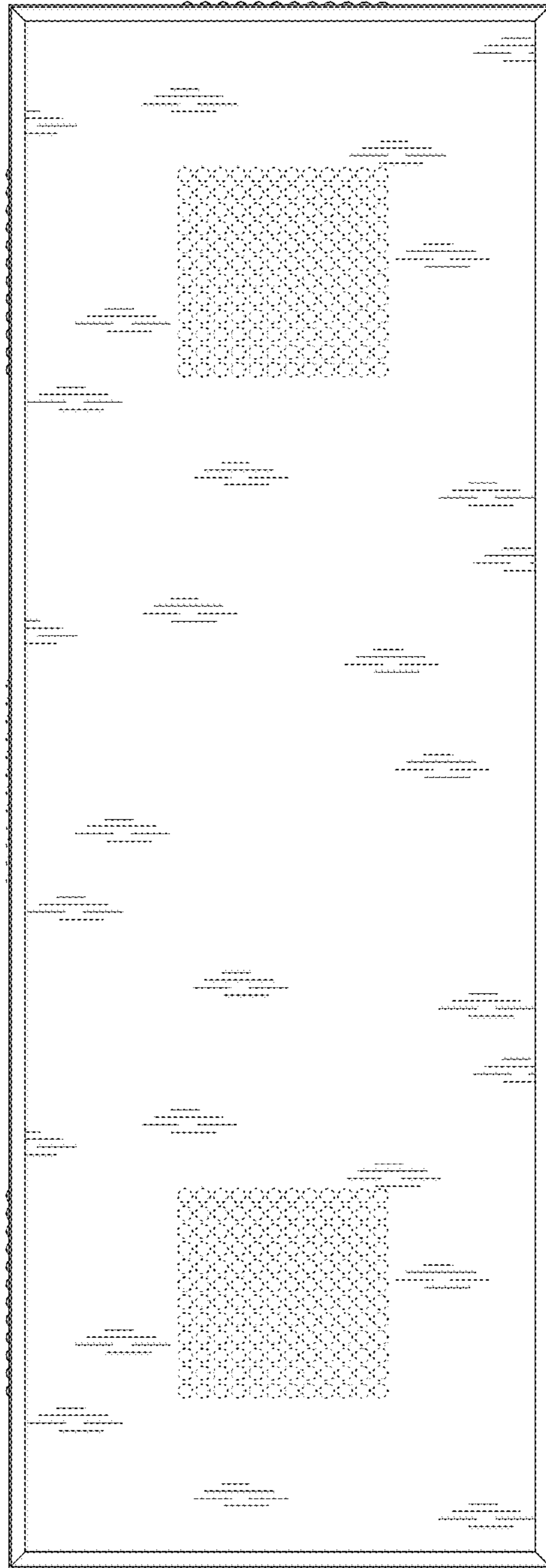

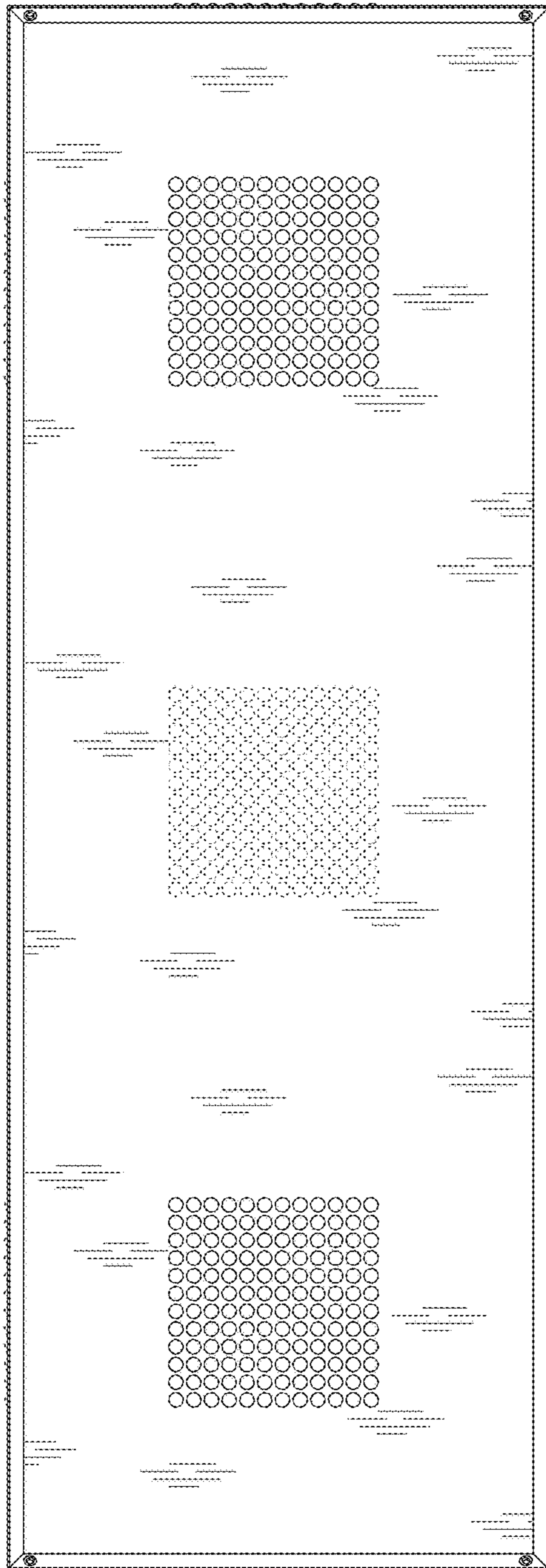

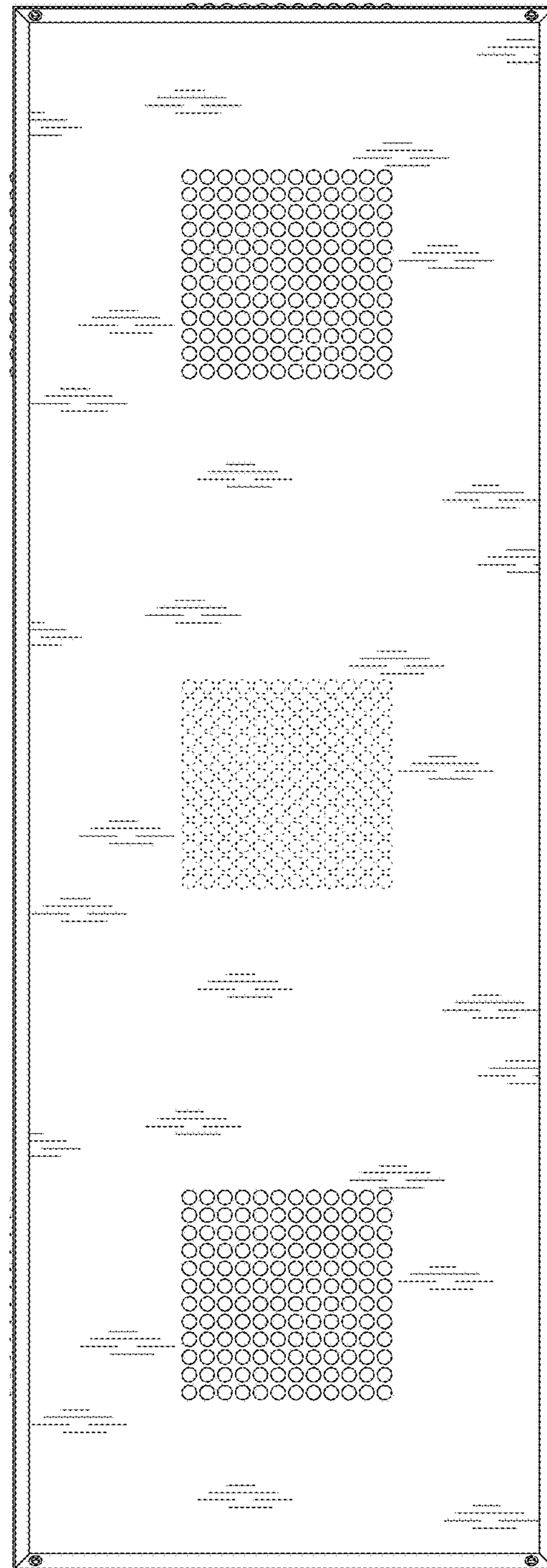

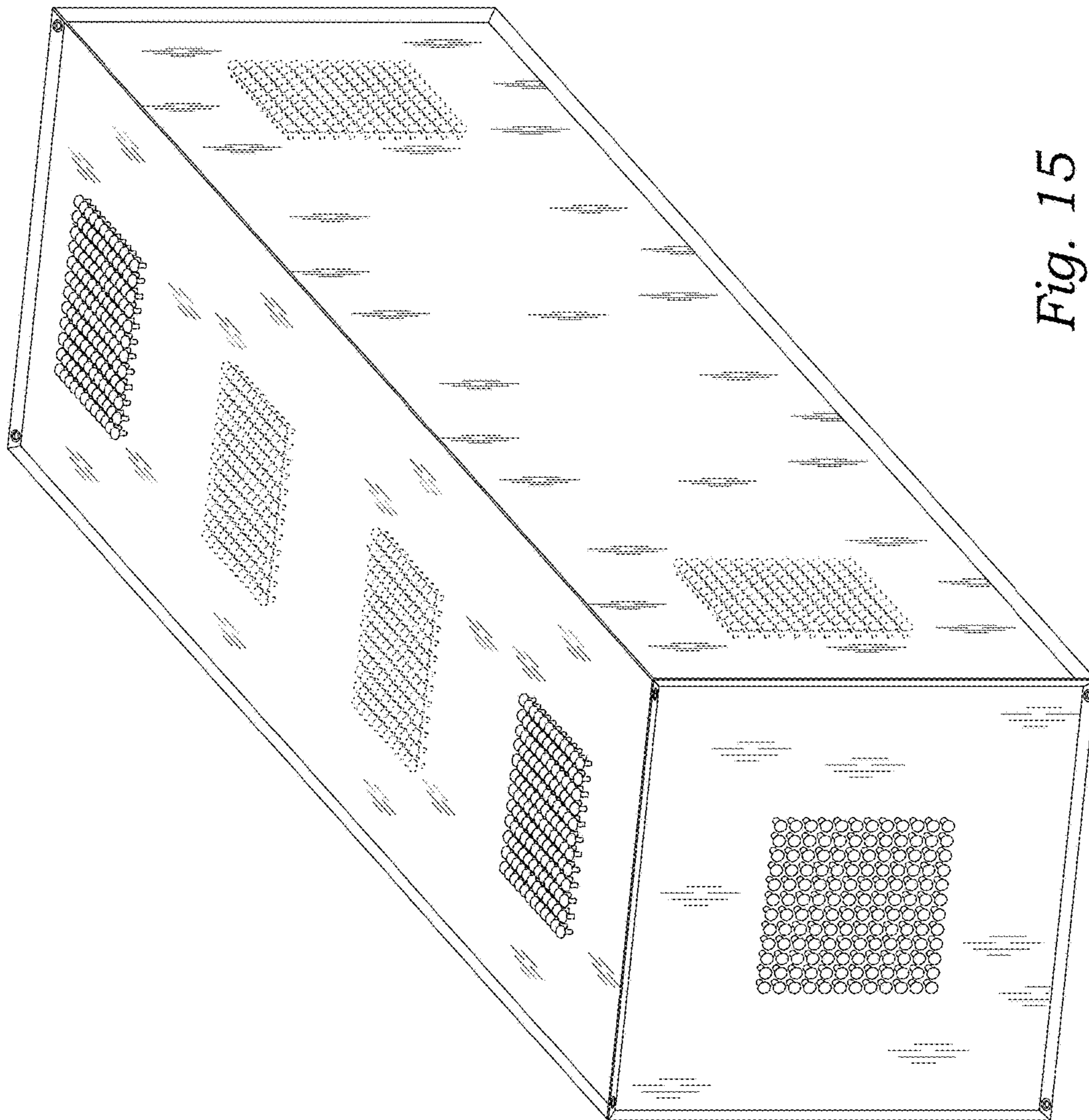

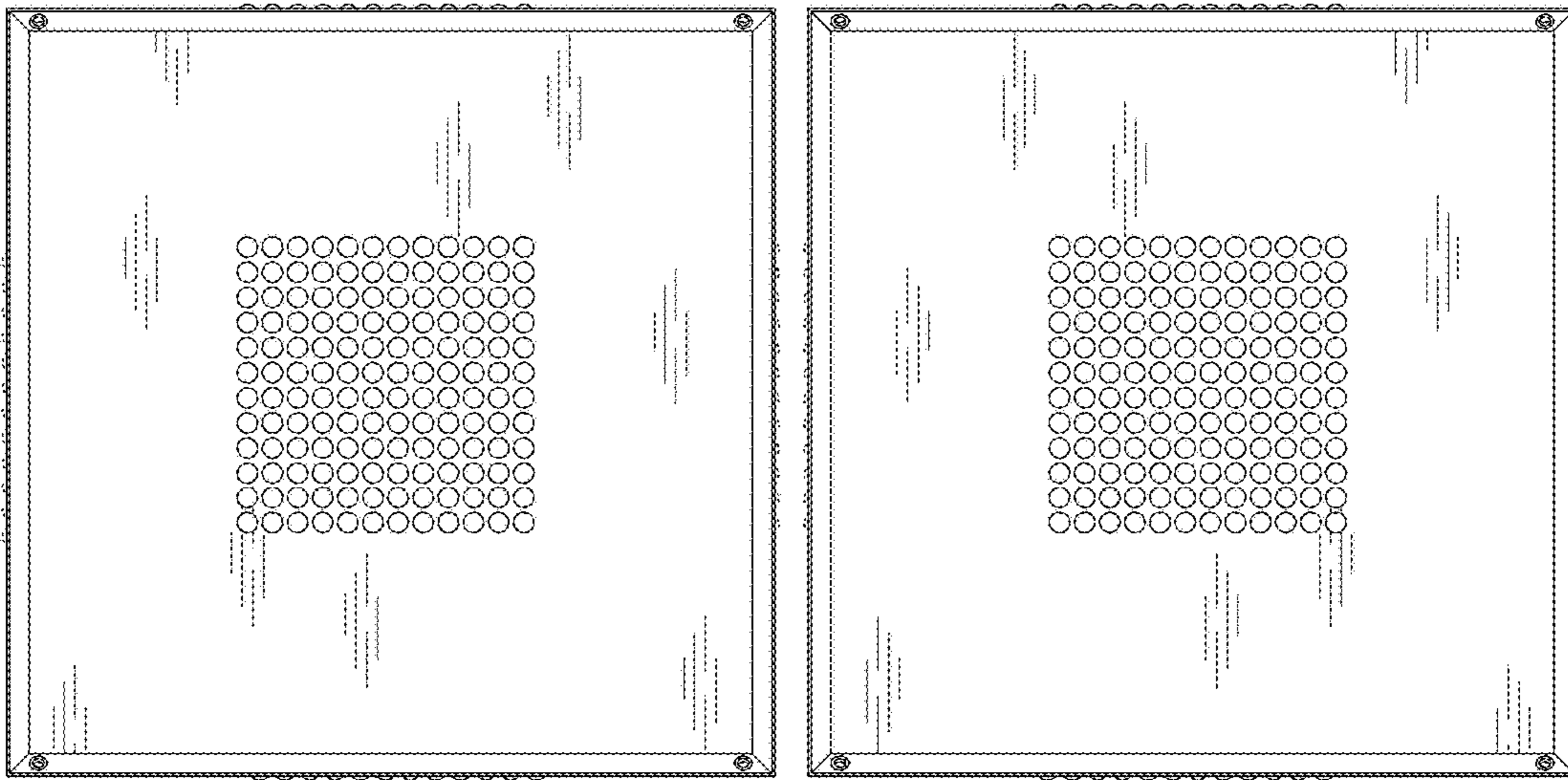

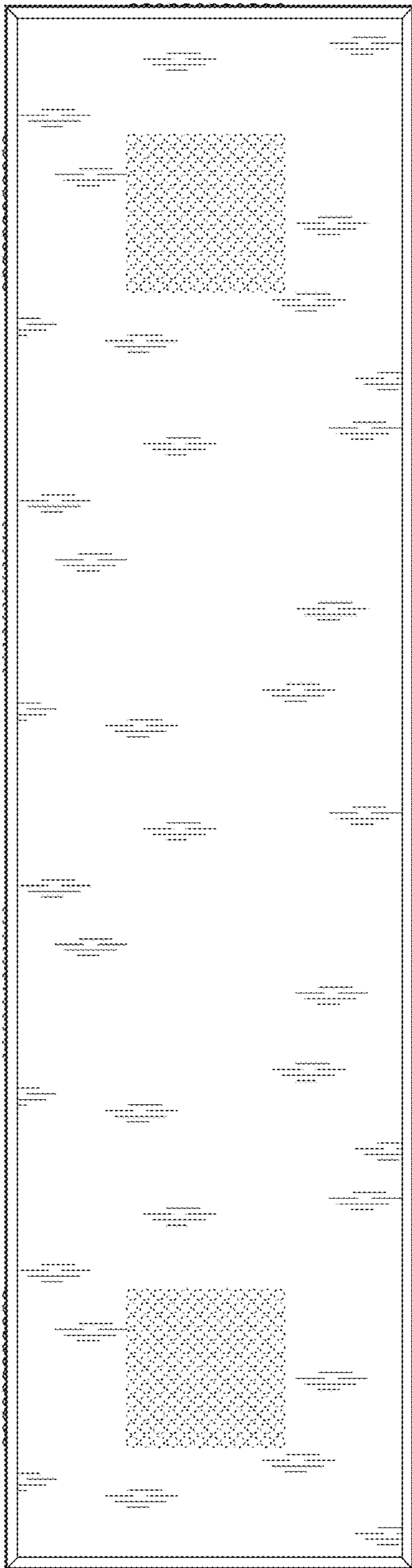

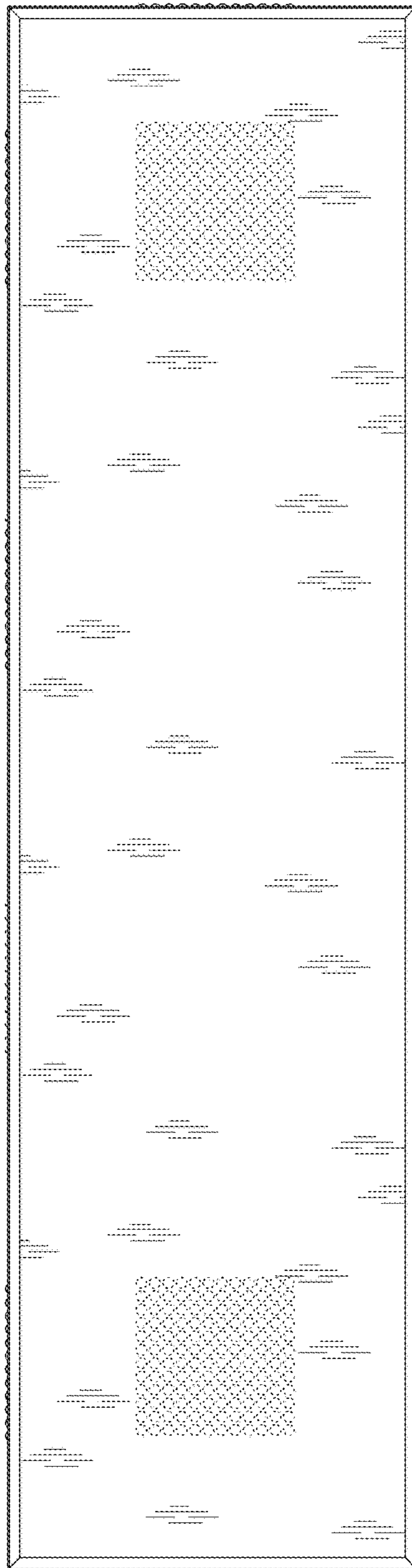

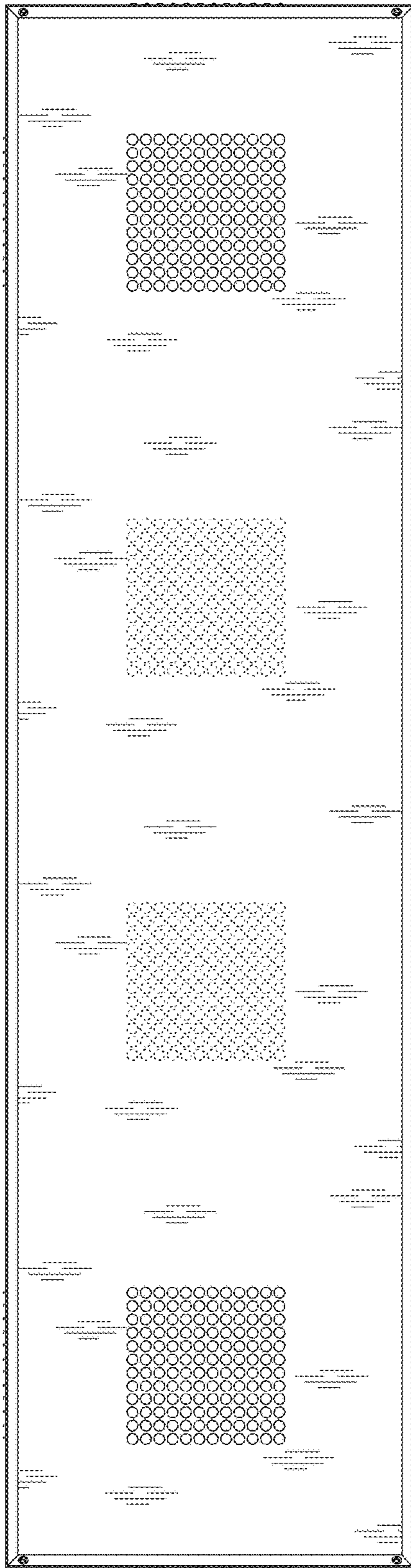

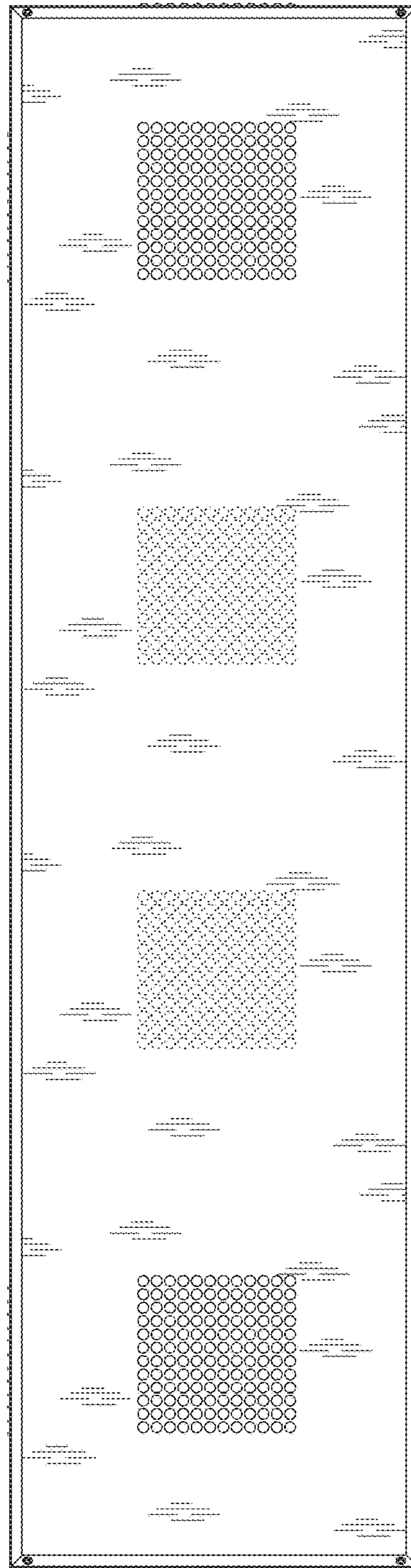

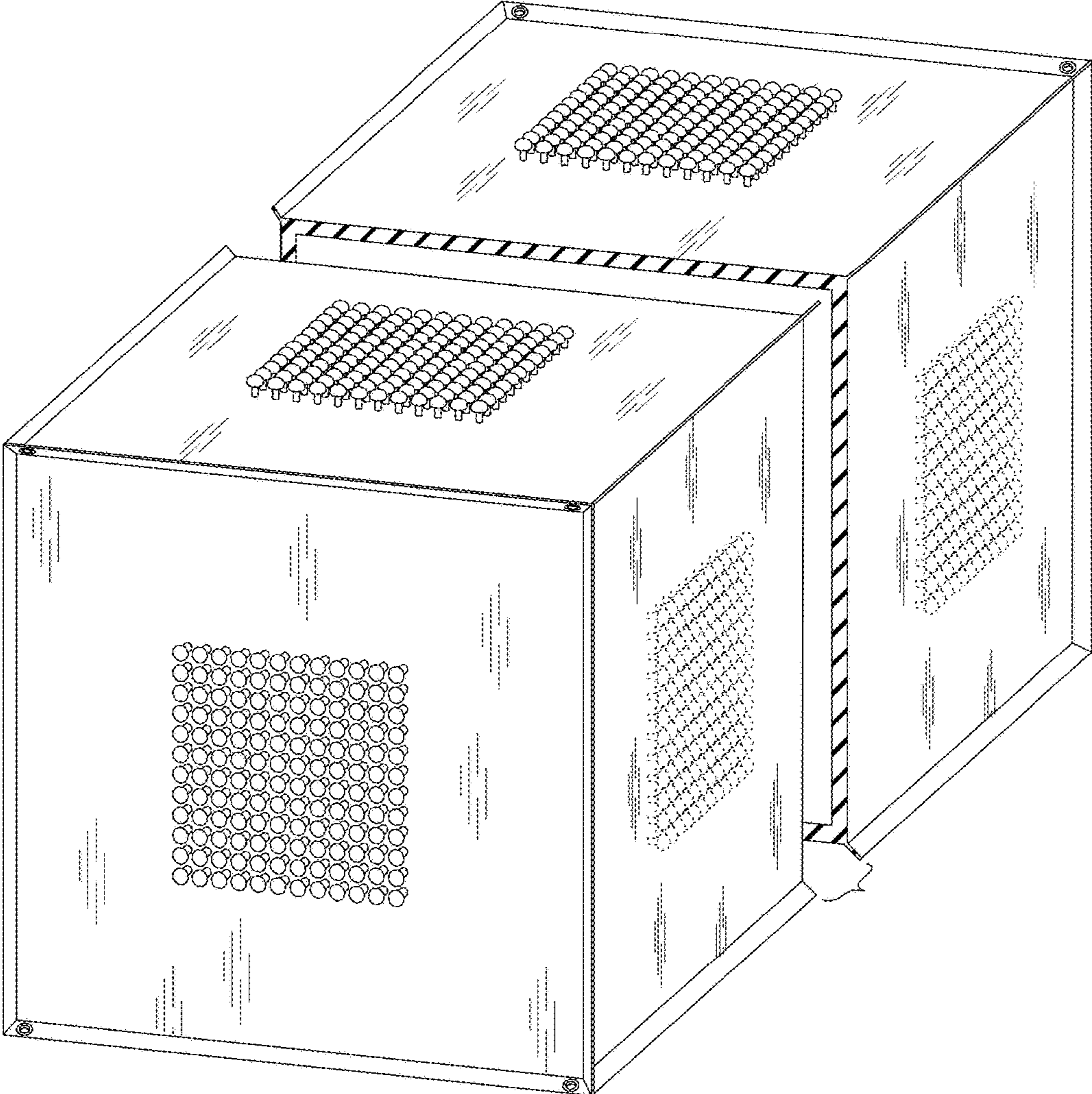

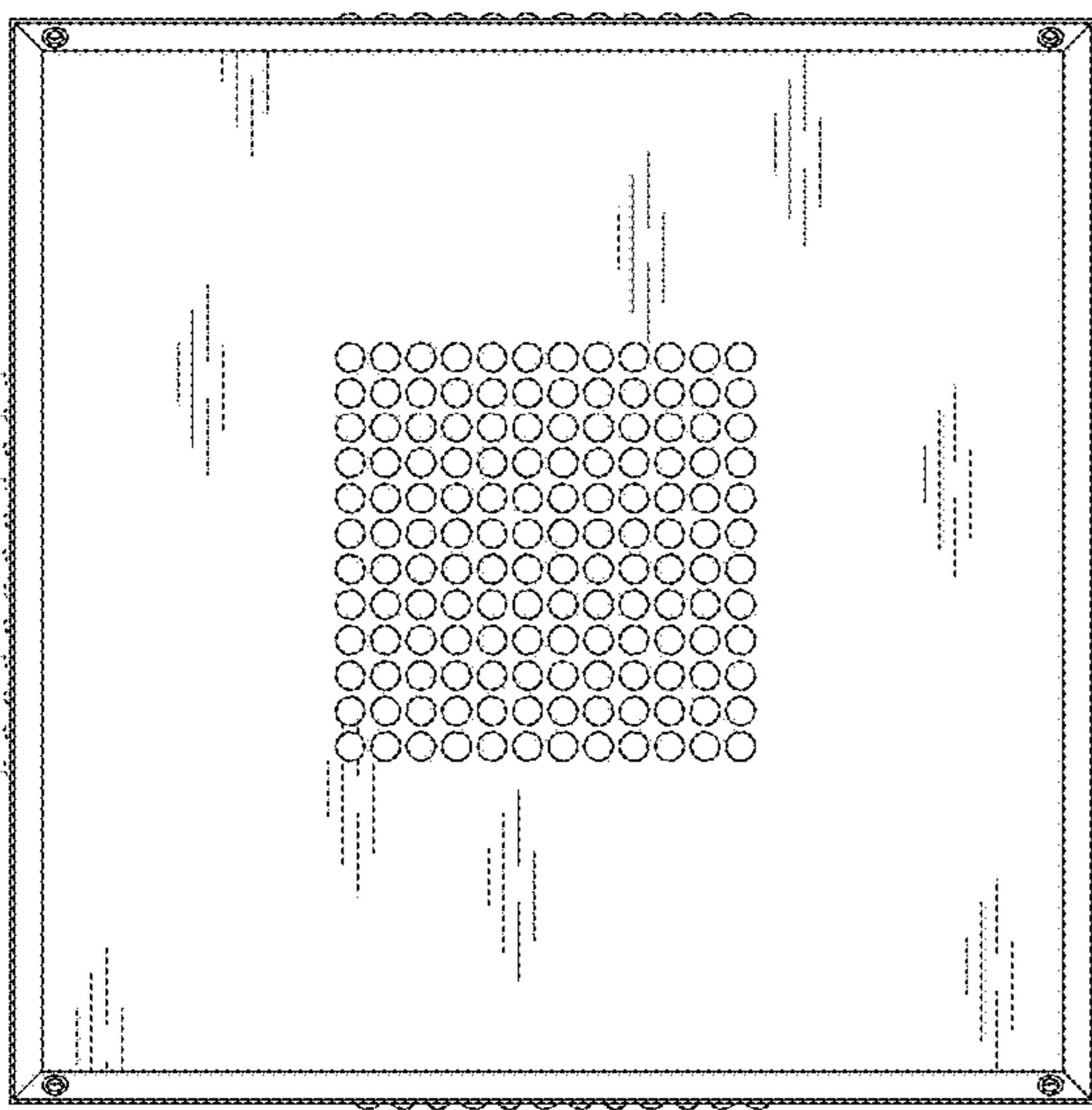

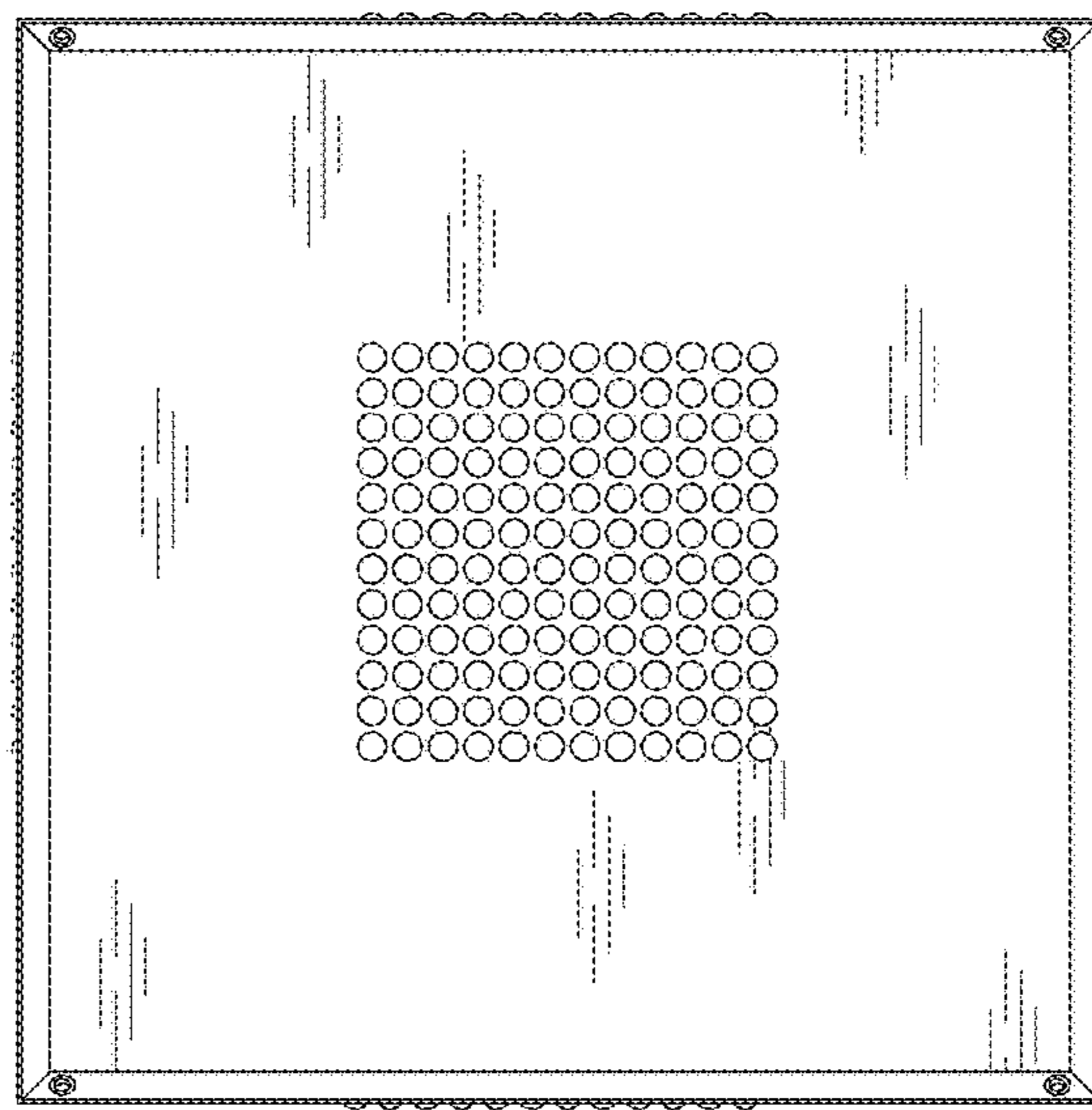

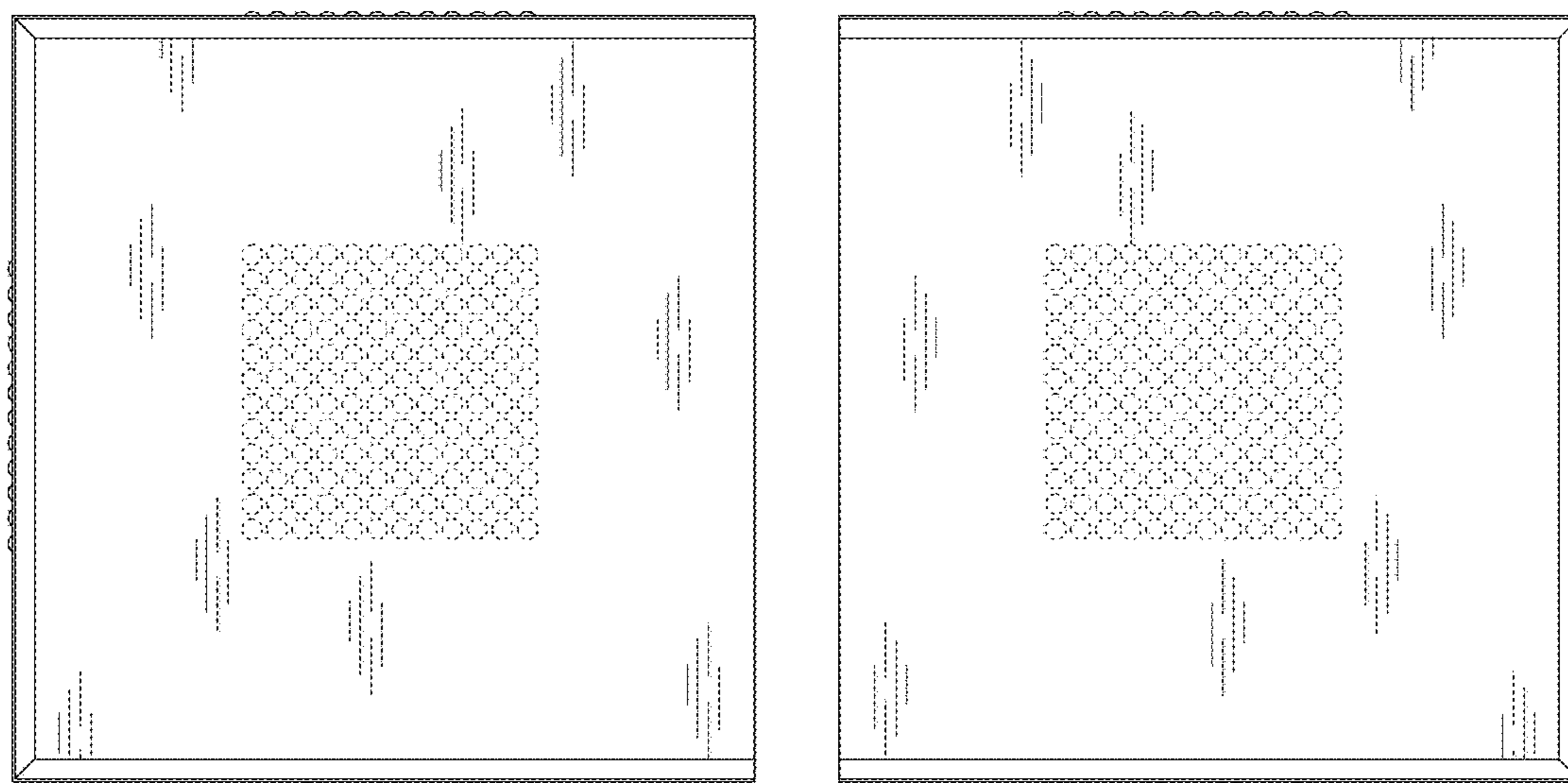

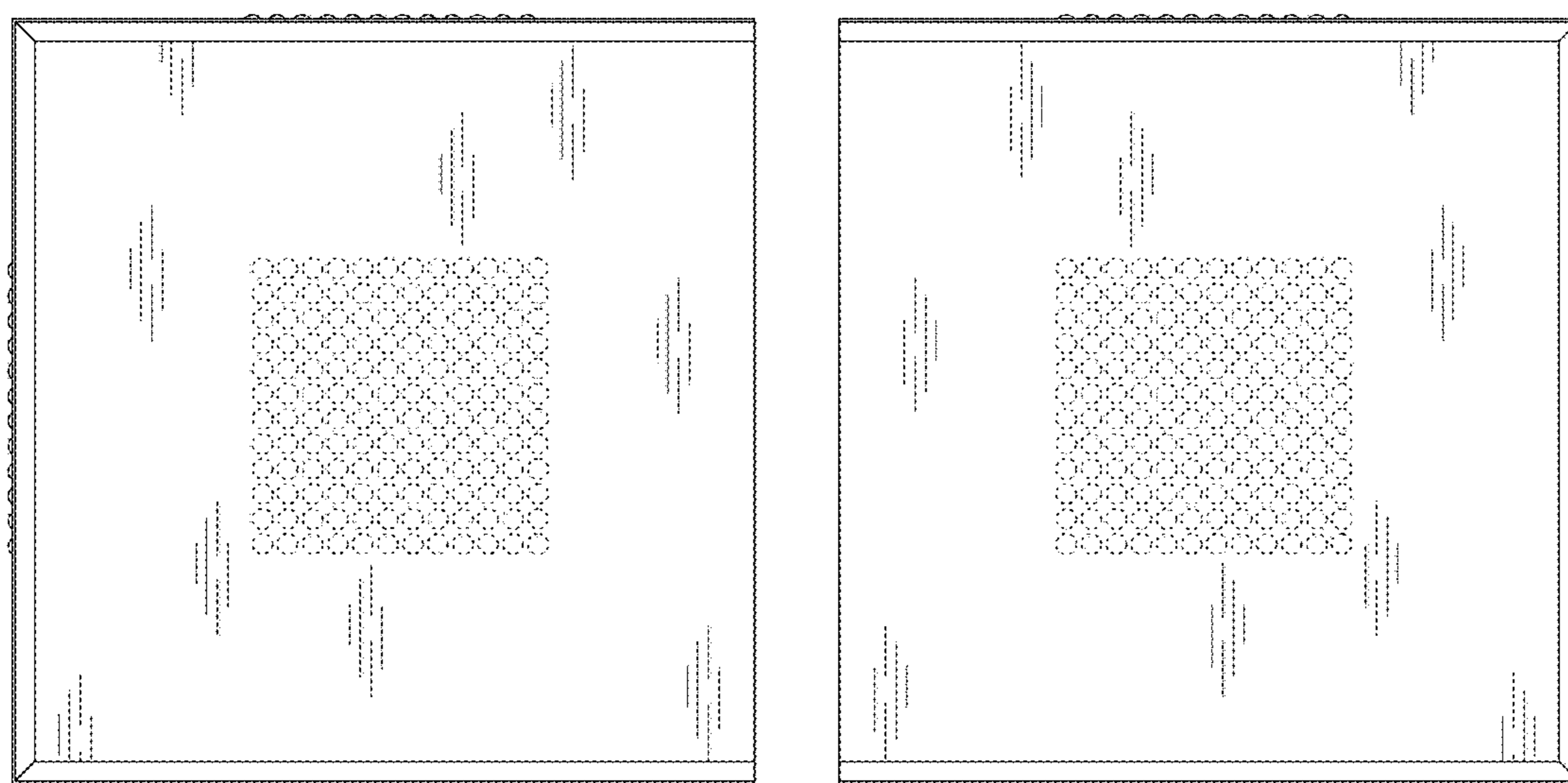

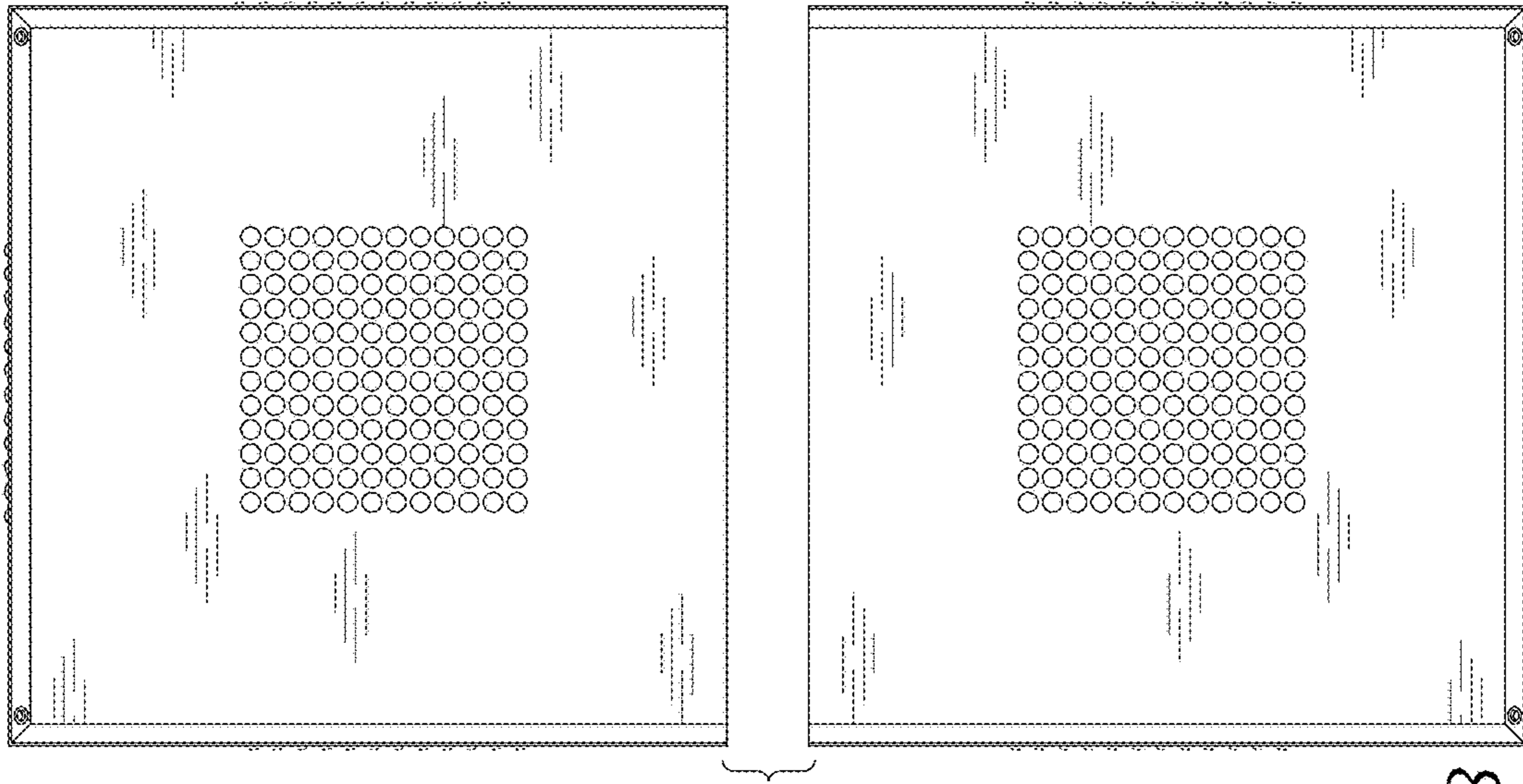

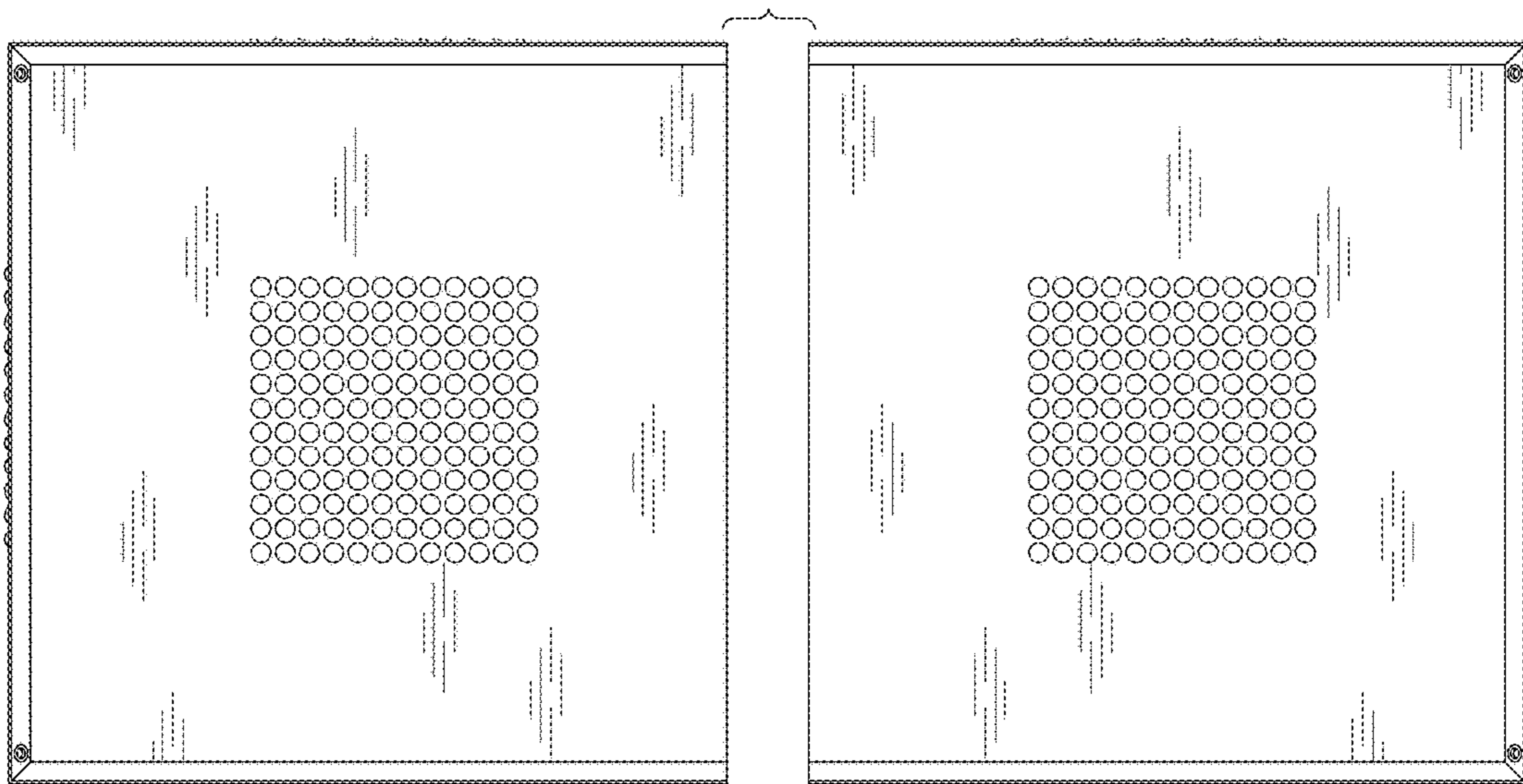
