DESCRIPTION

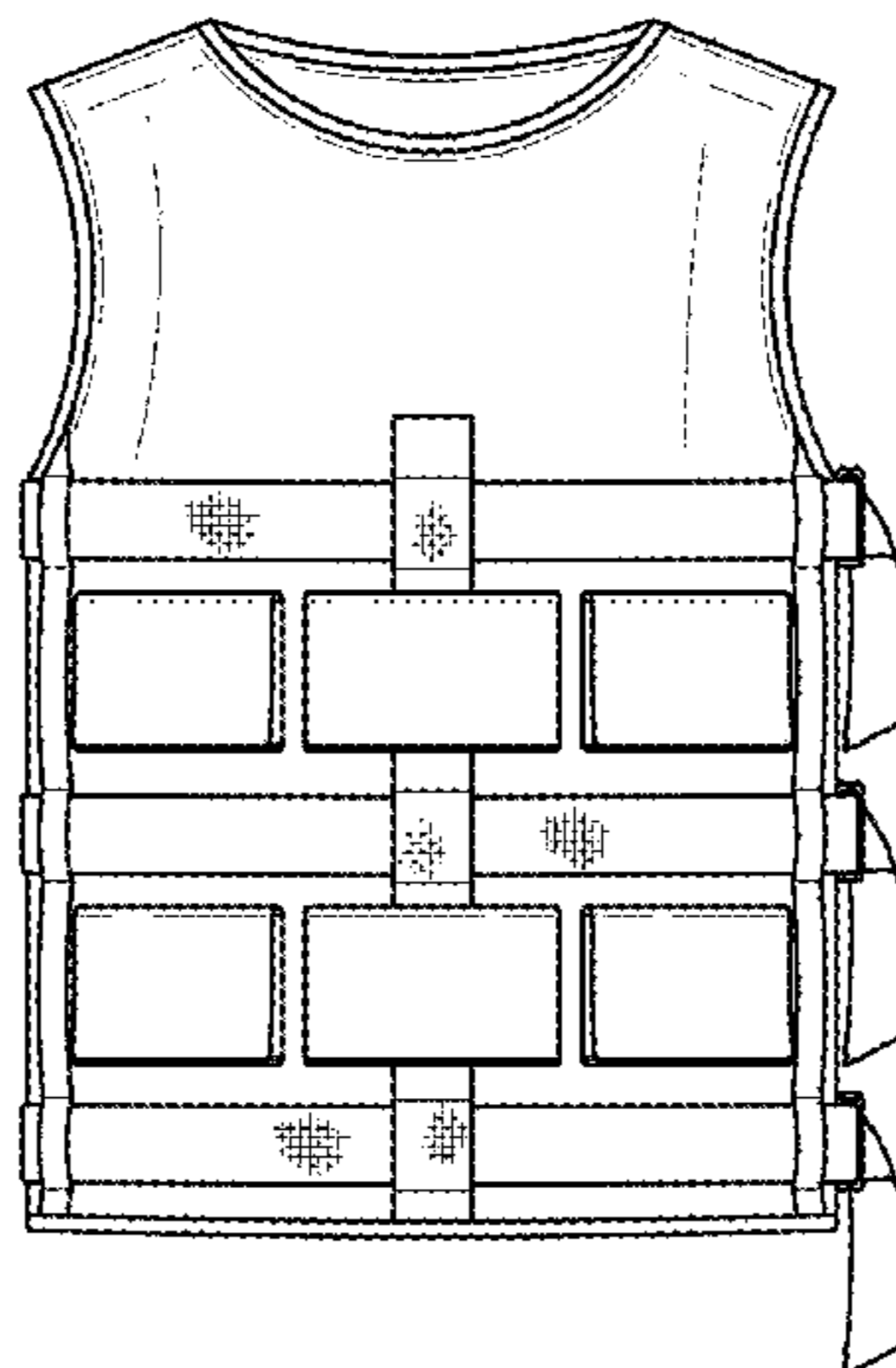
FIG. 1 is a front view of the push up vest embodied in the present invention;

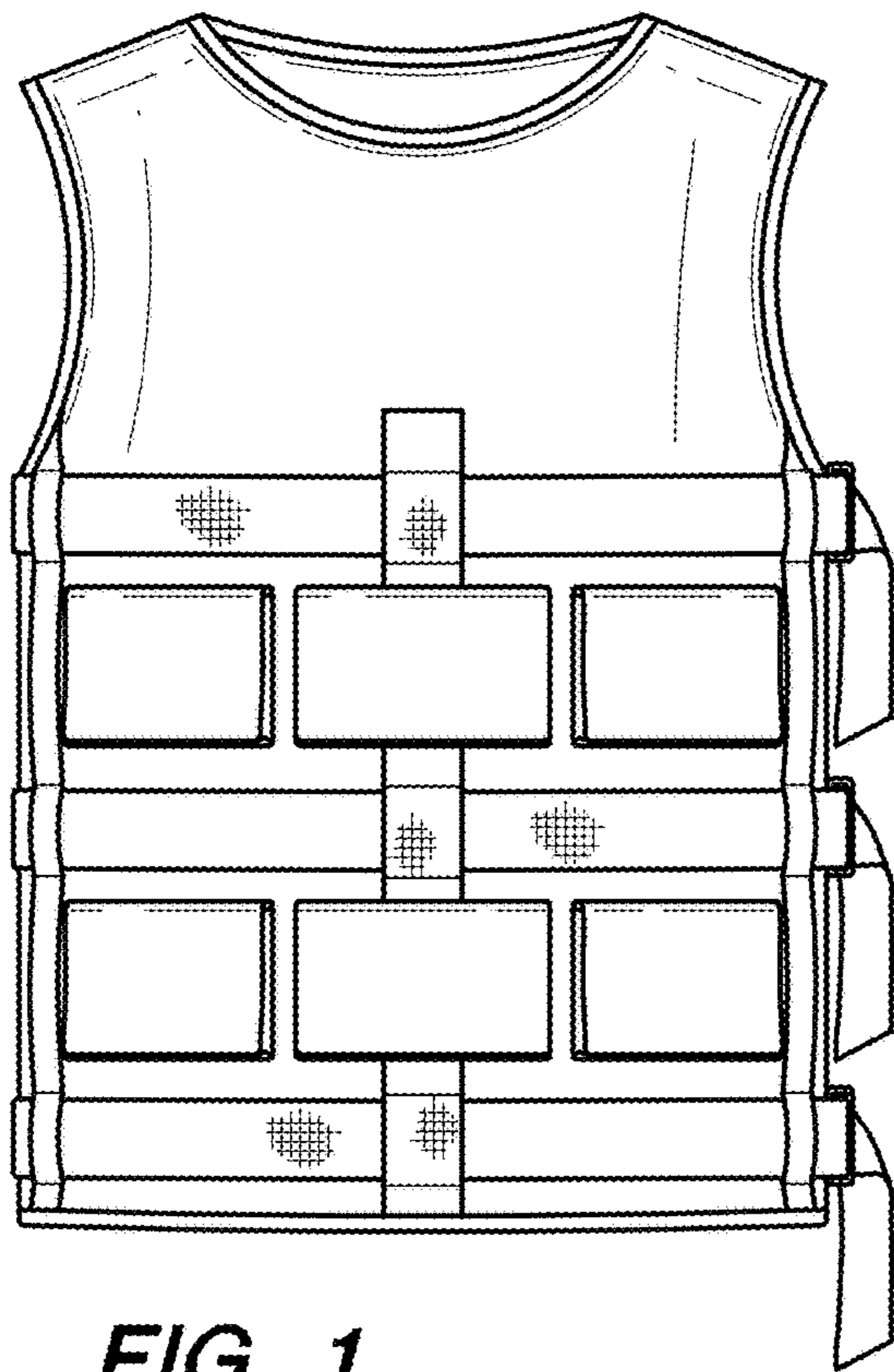

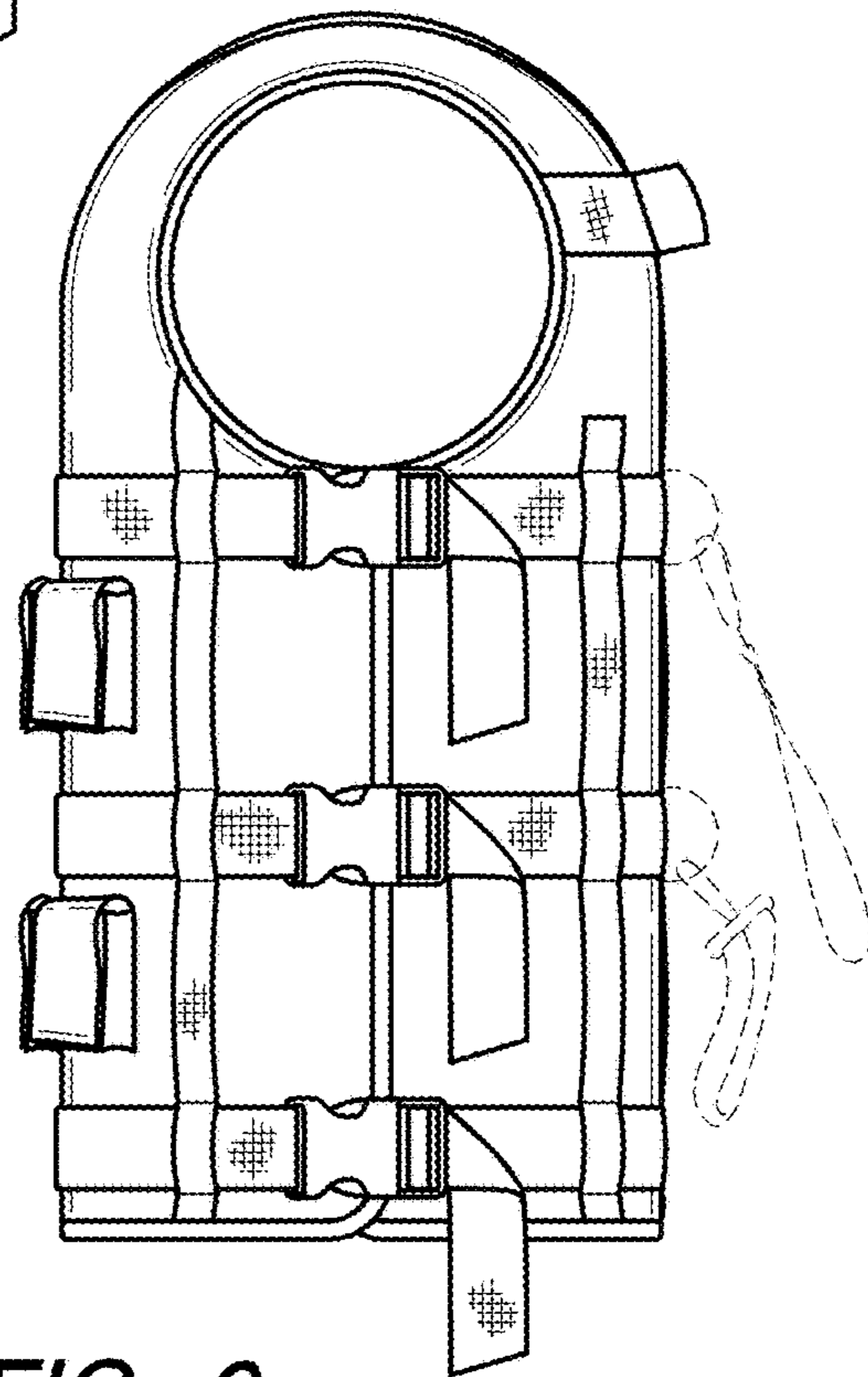

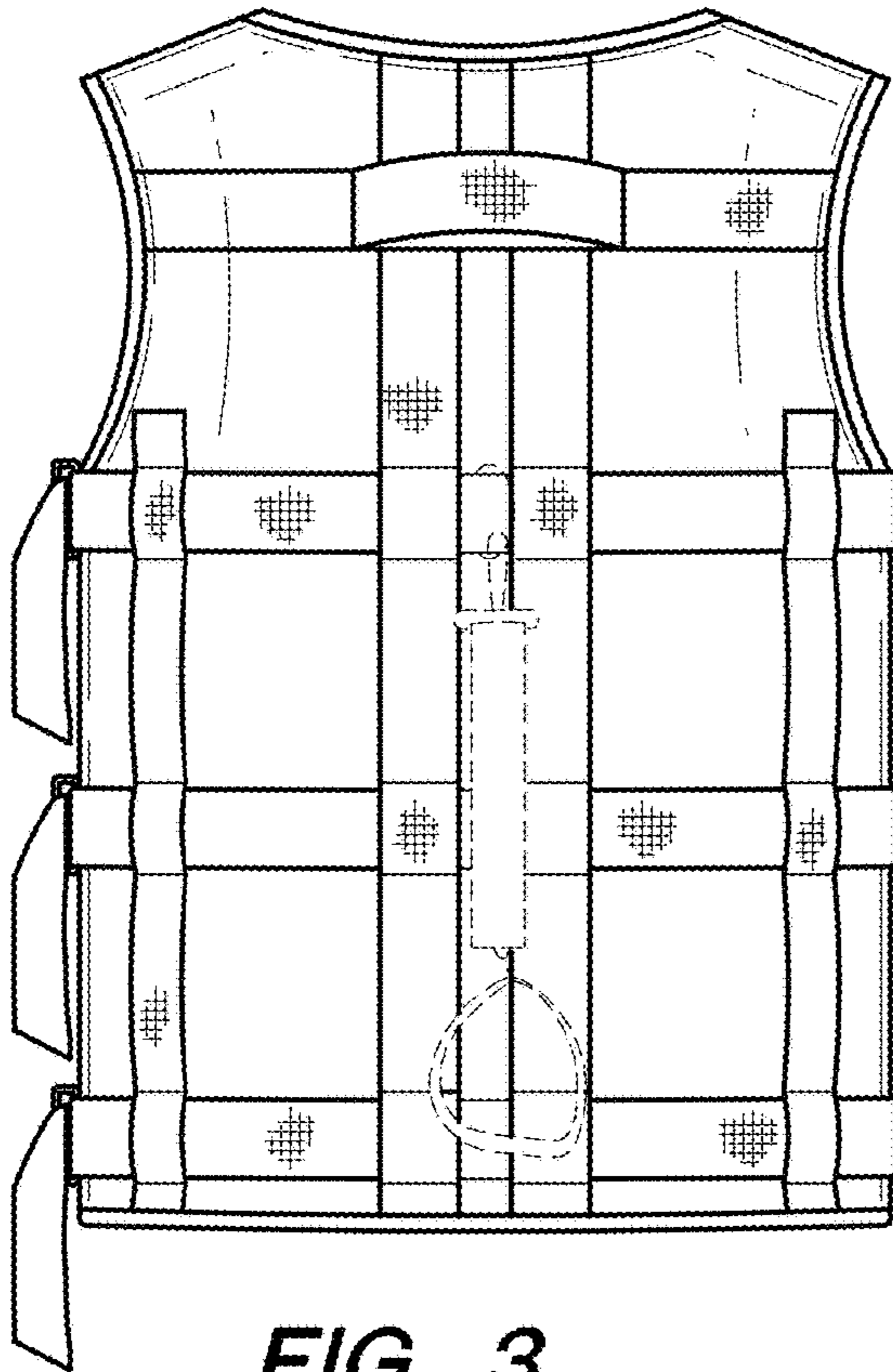

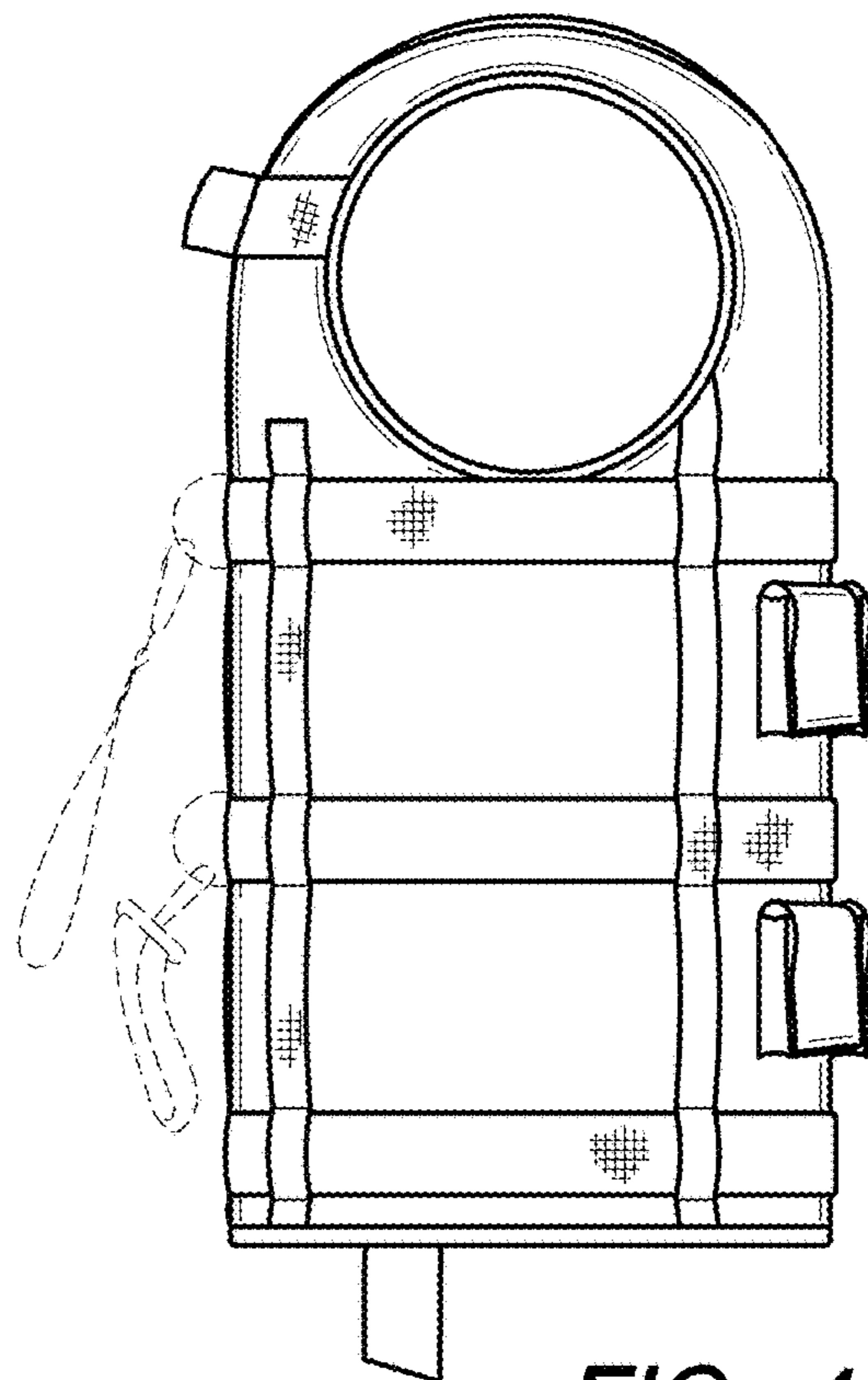

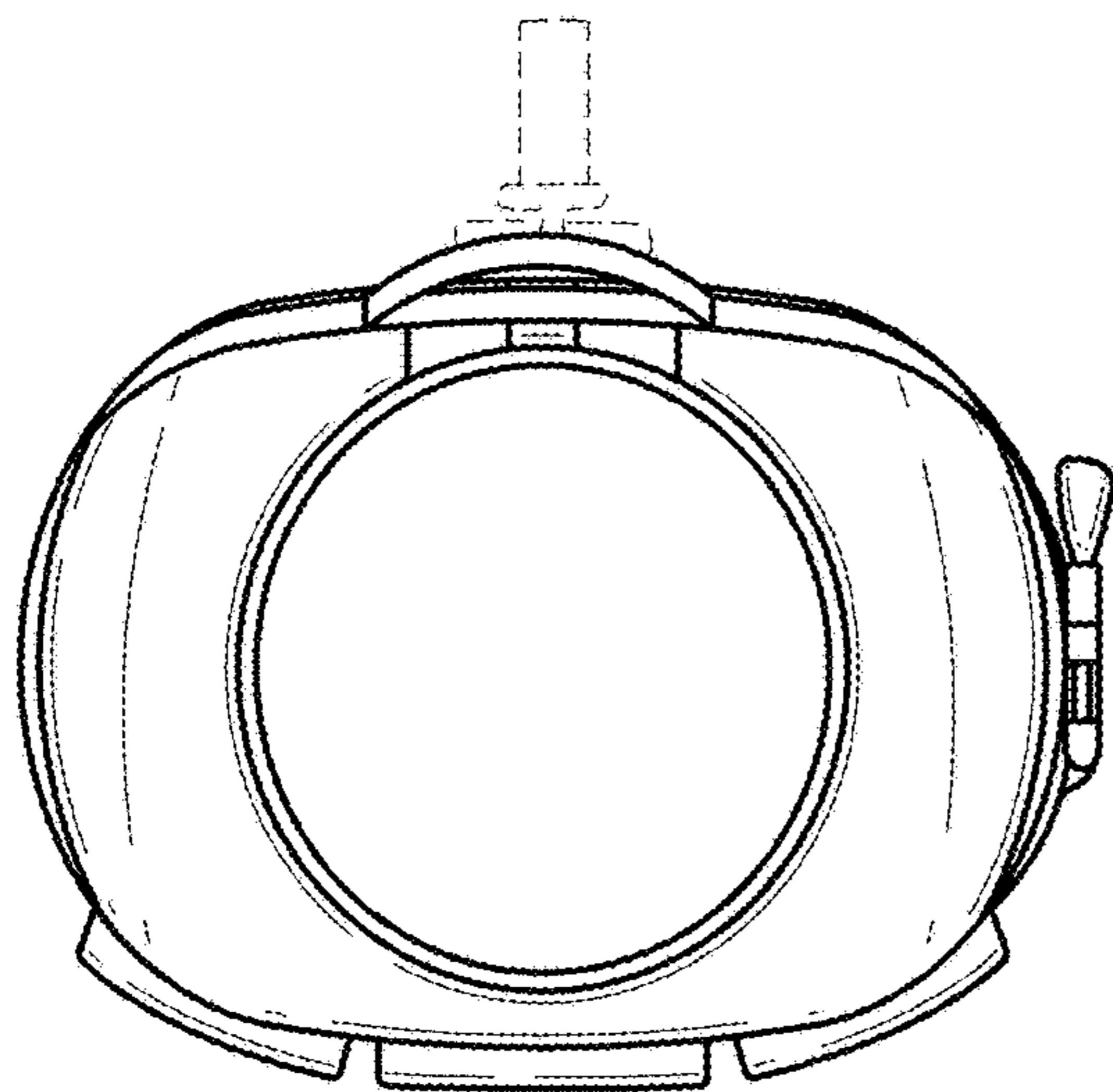

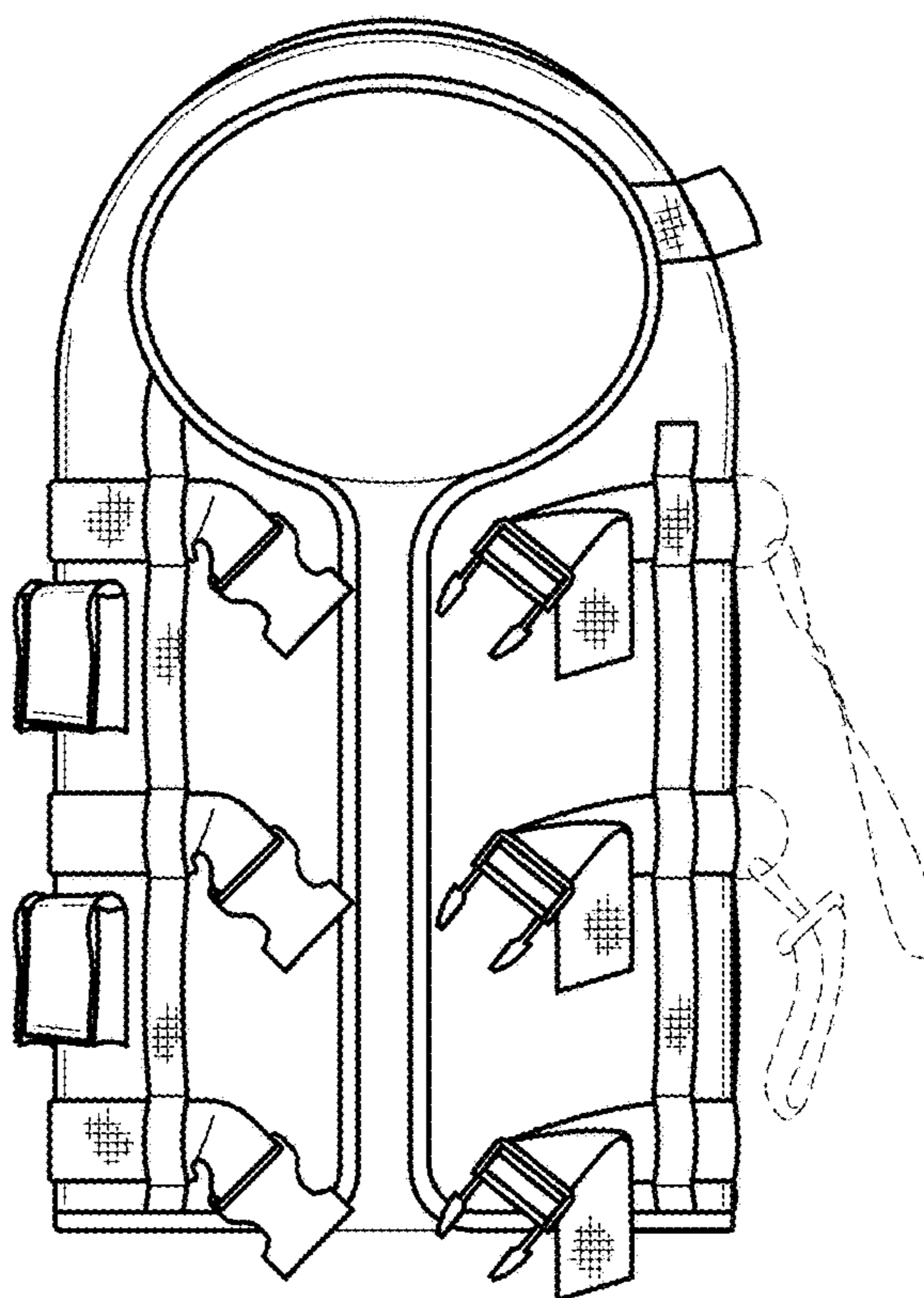

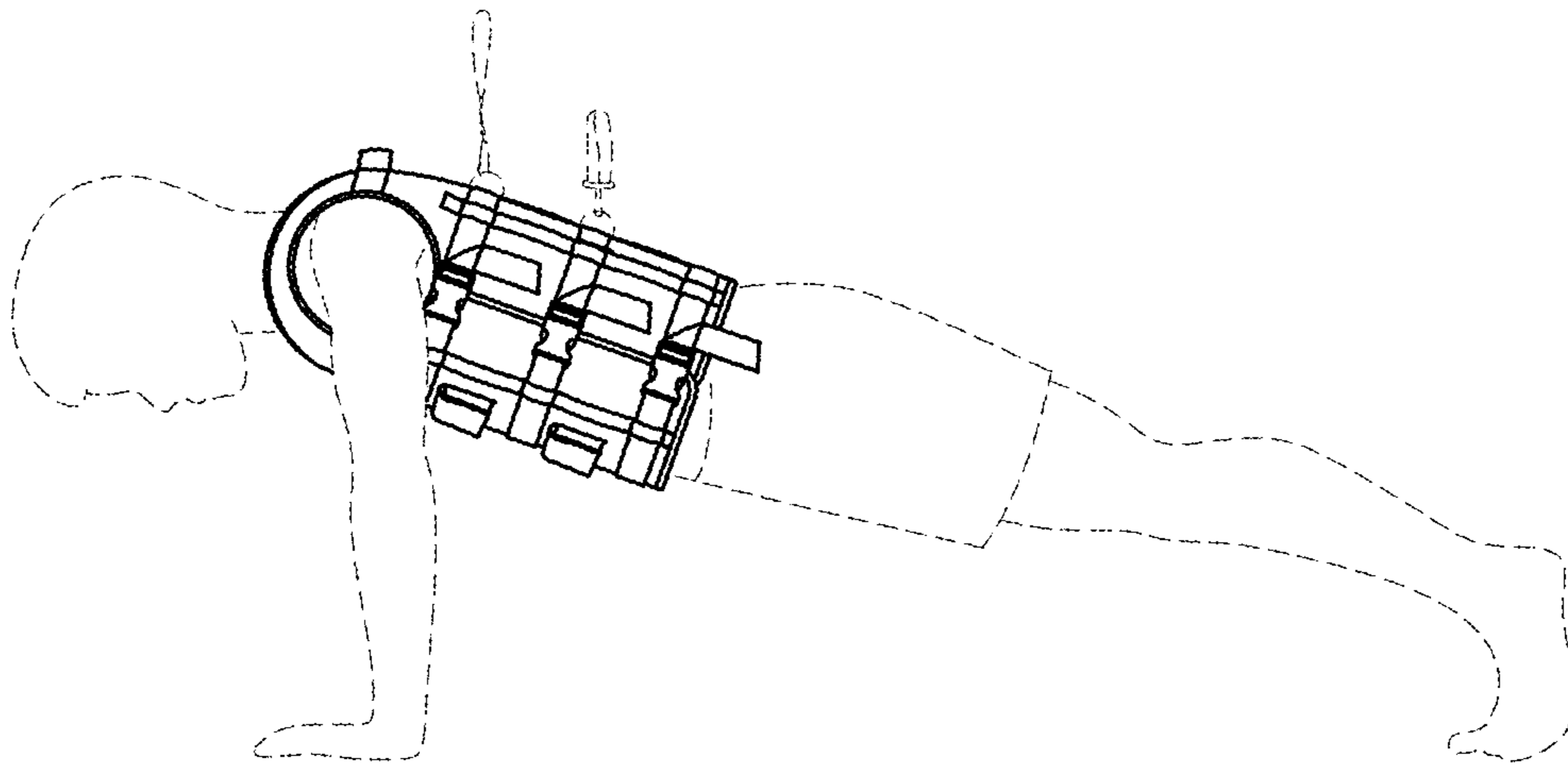
