DESCRIPTION

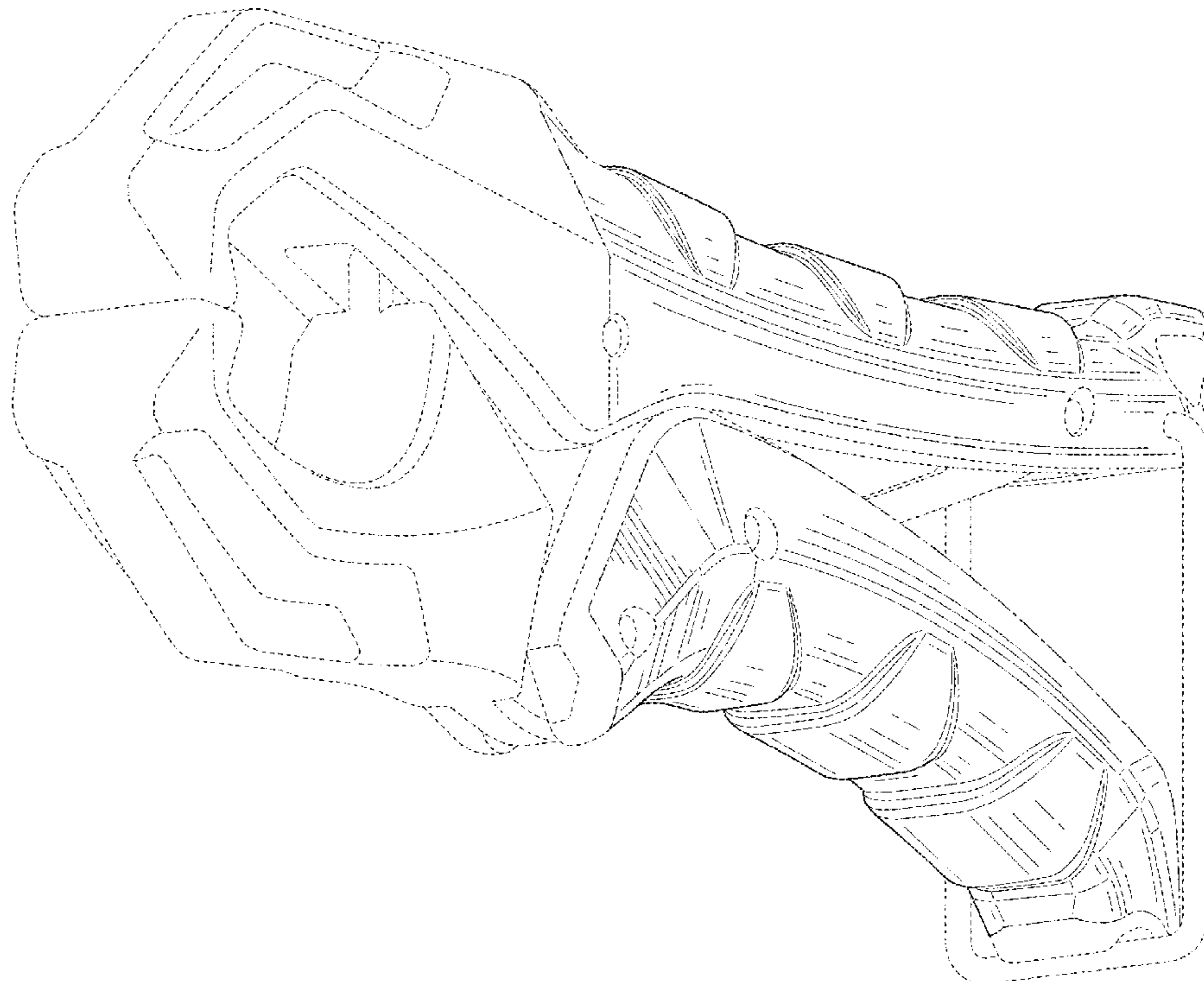
FIG. 1 is a perspective view of the fish gripper according to the present invention;

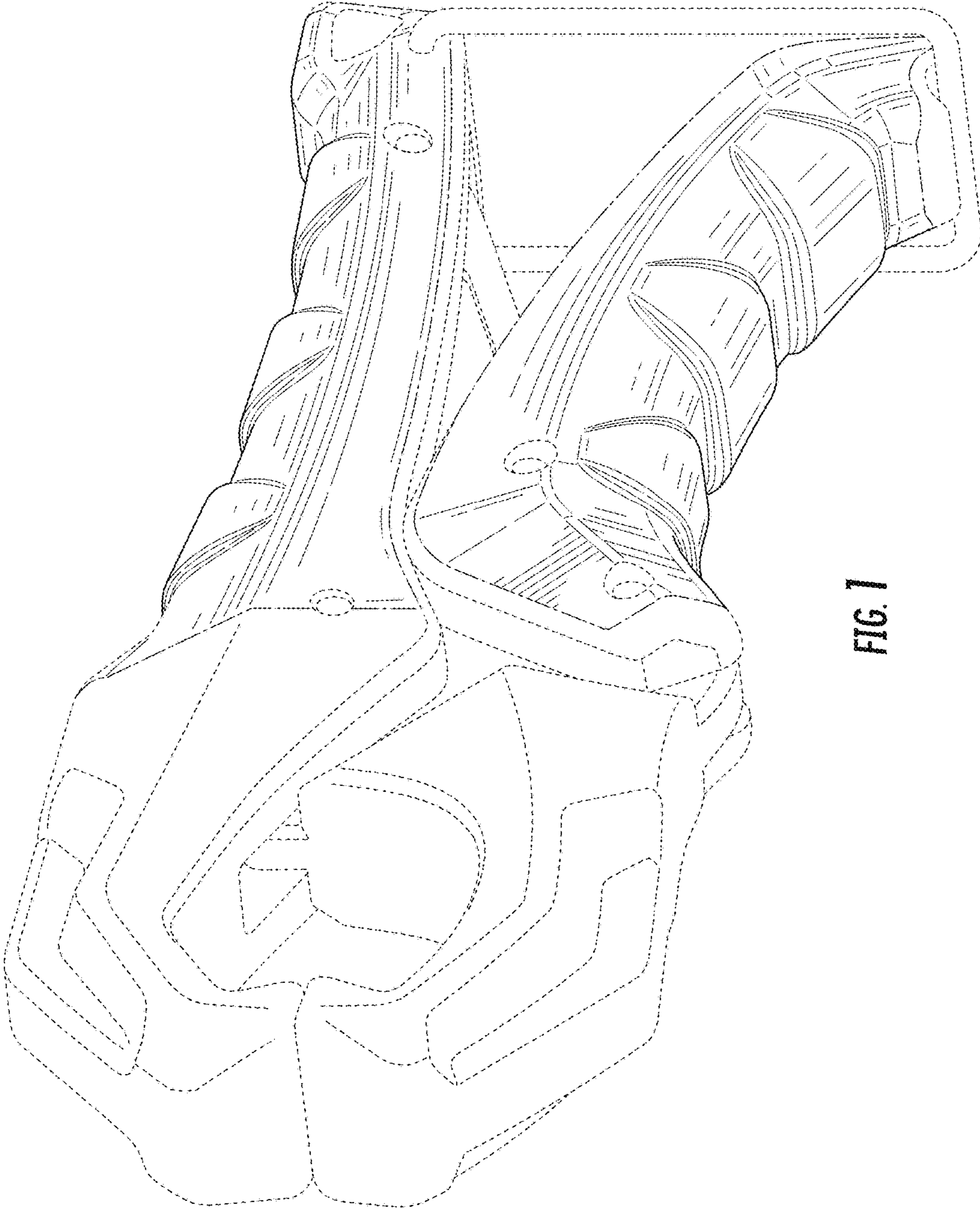

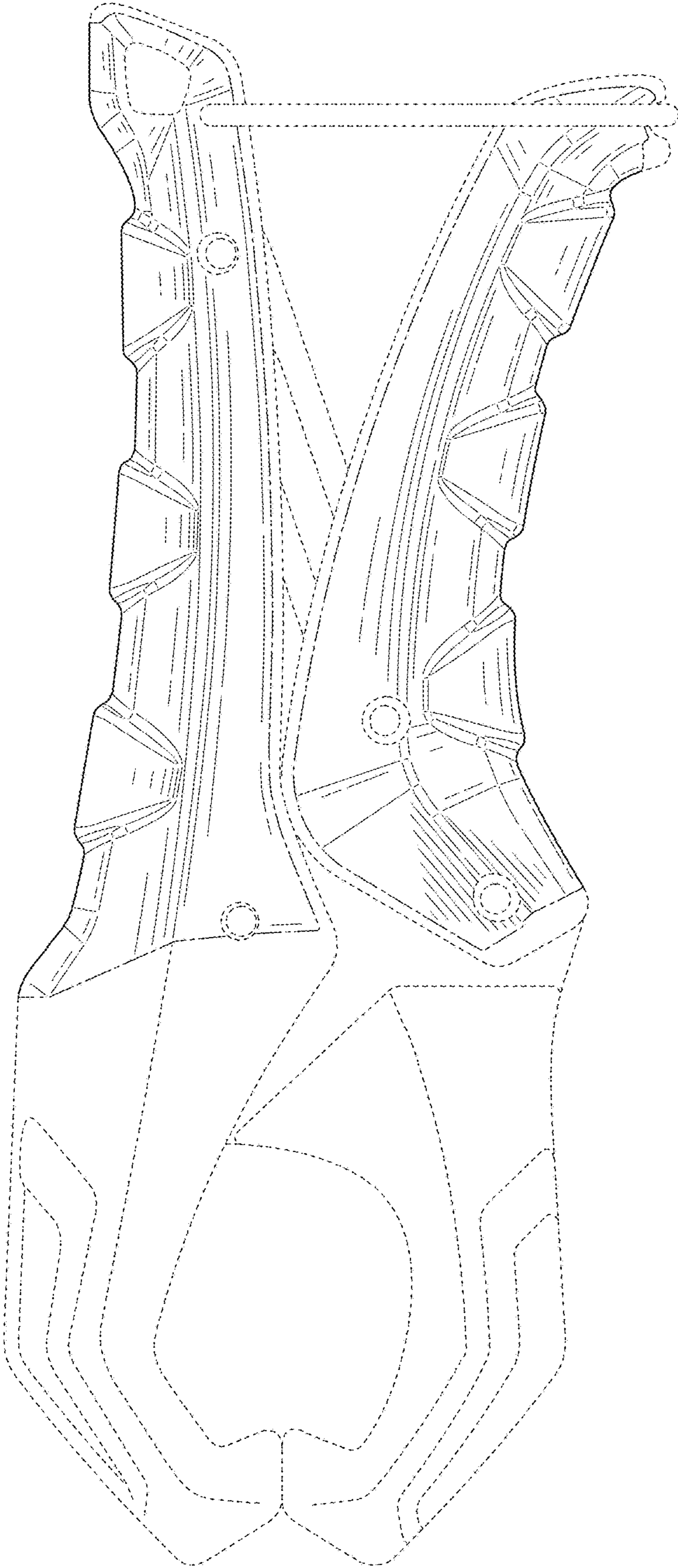

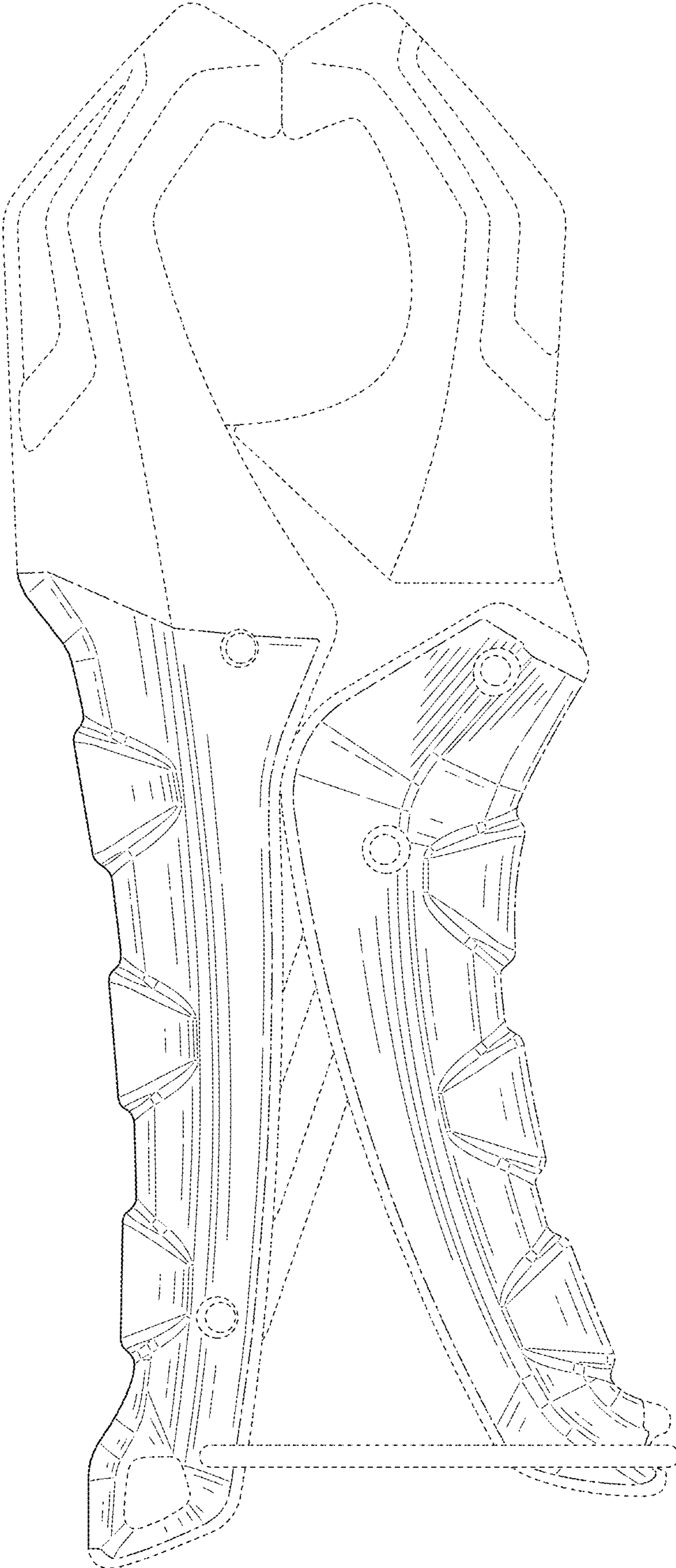

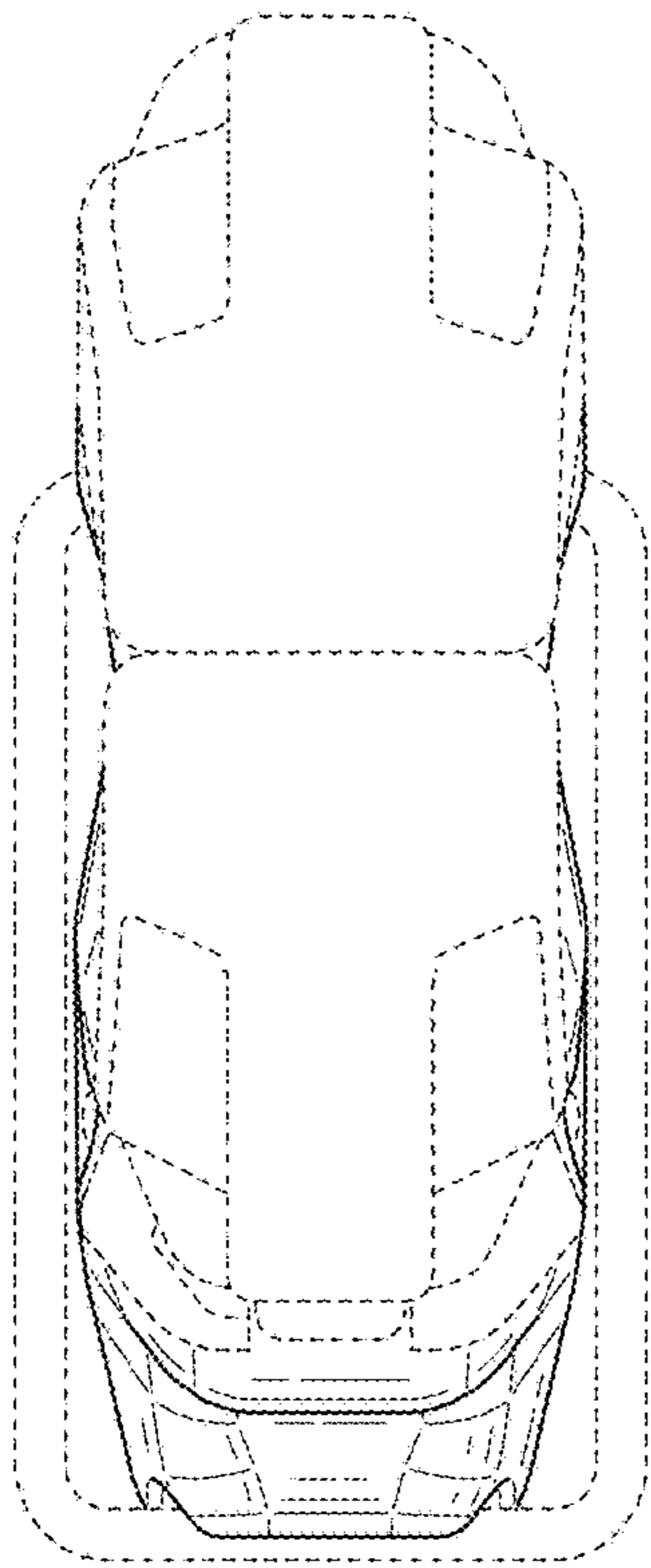

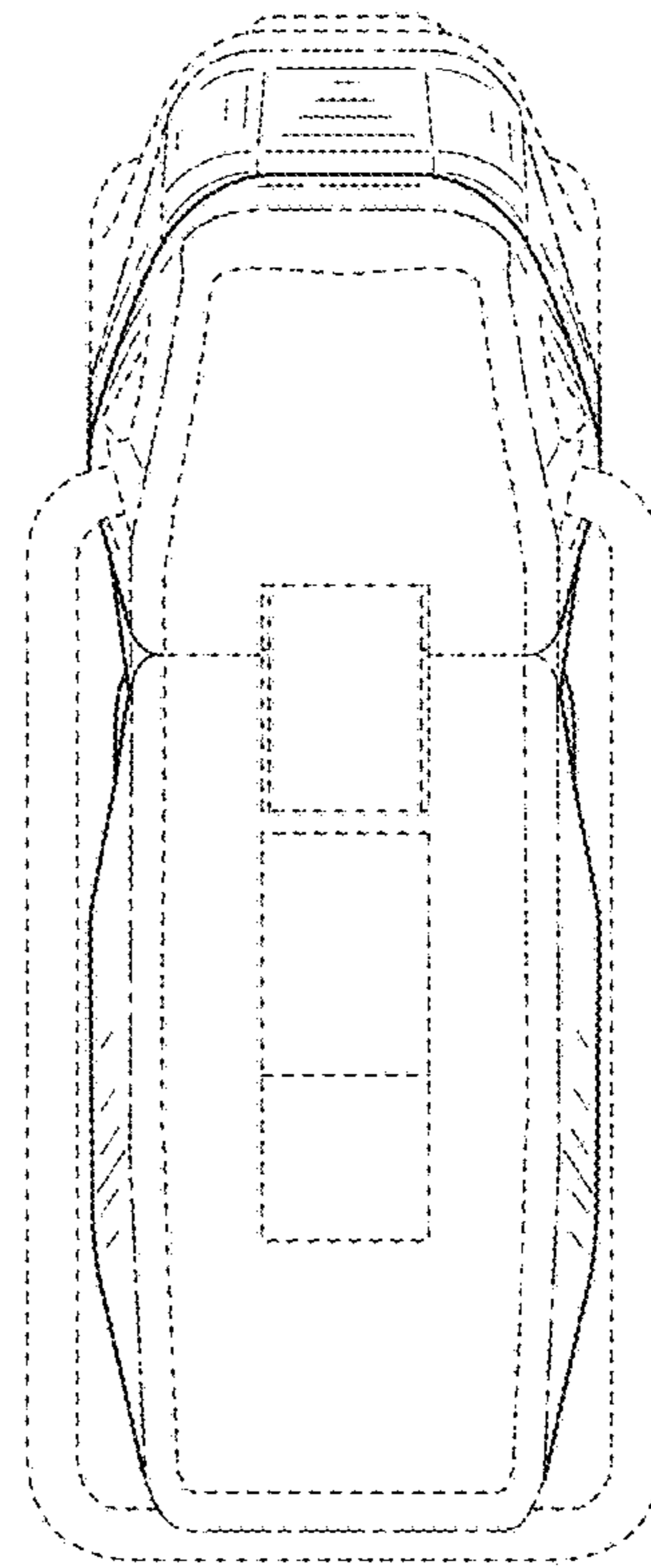

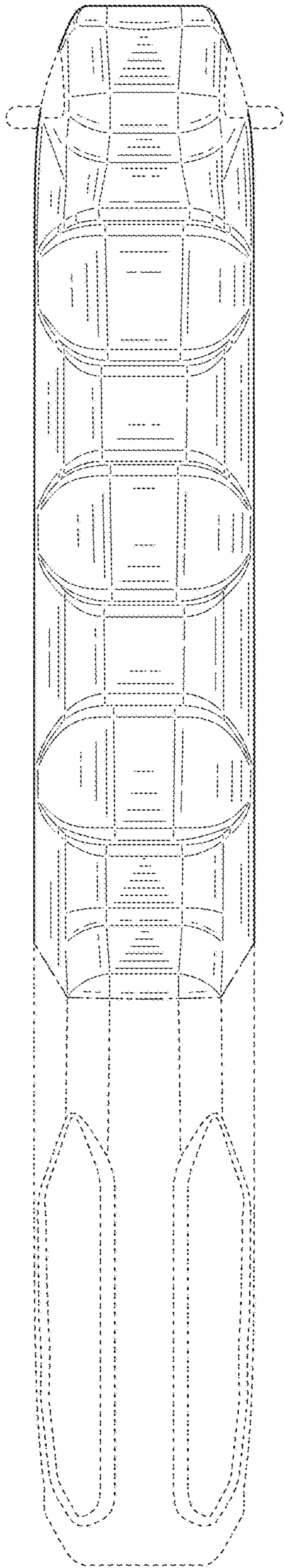

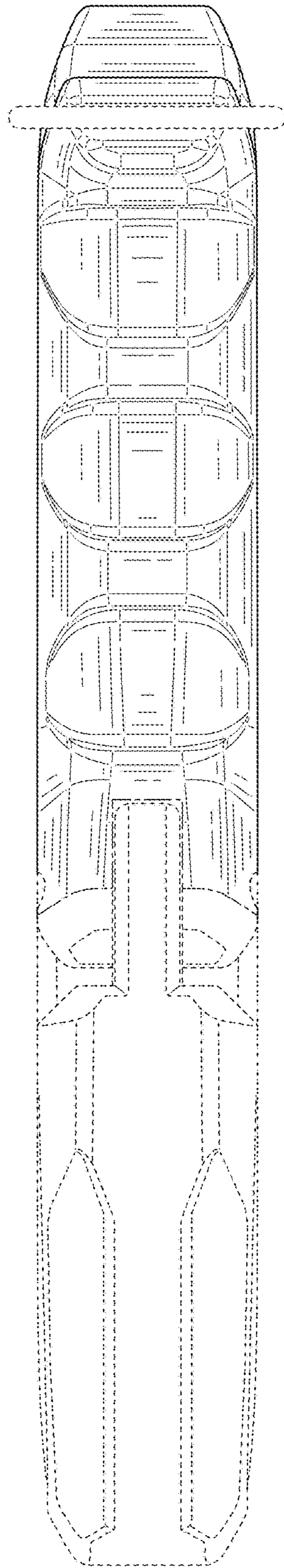
