FIG. 14 is a front view of the padded tape of FIG. 8.

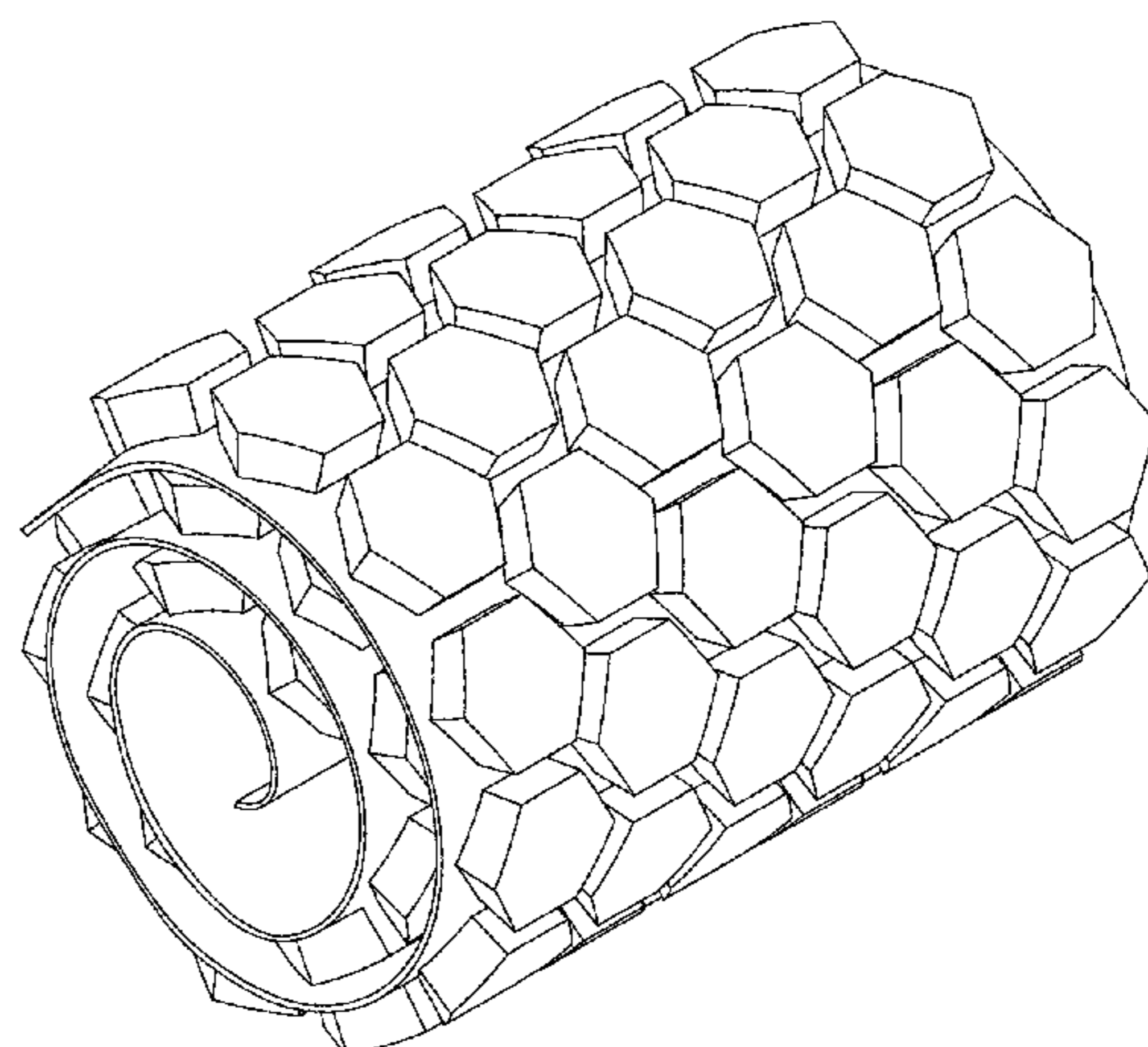
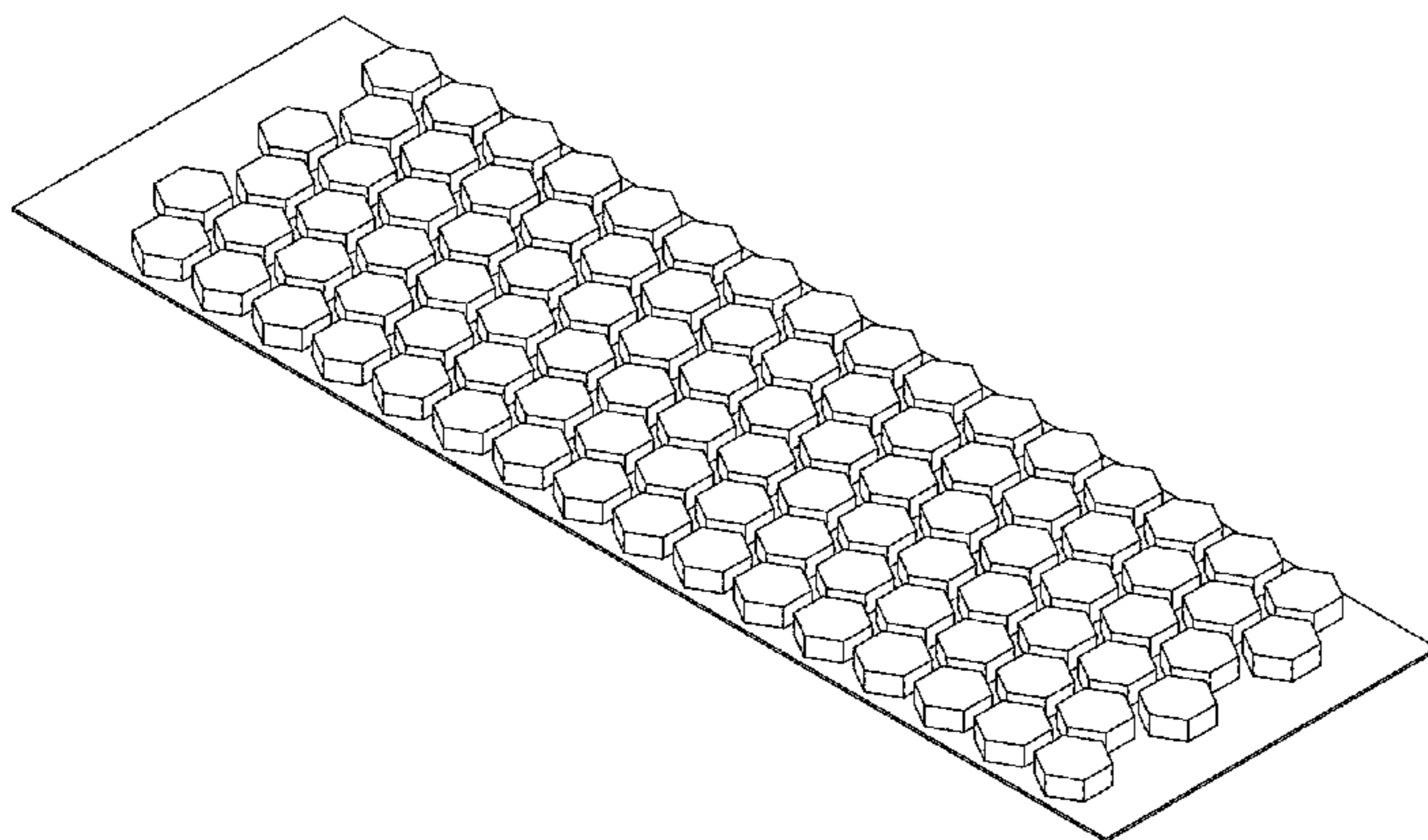

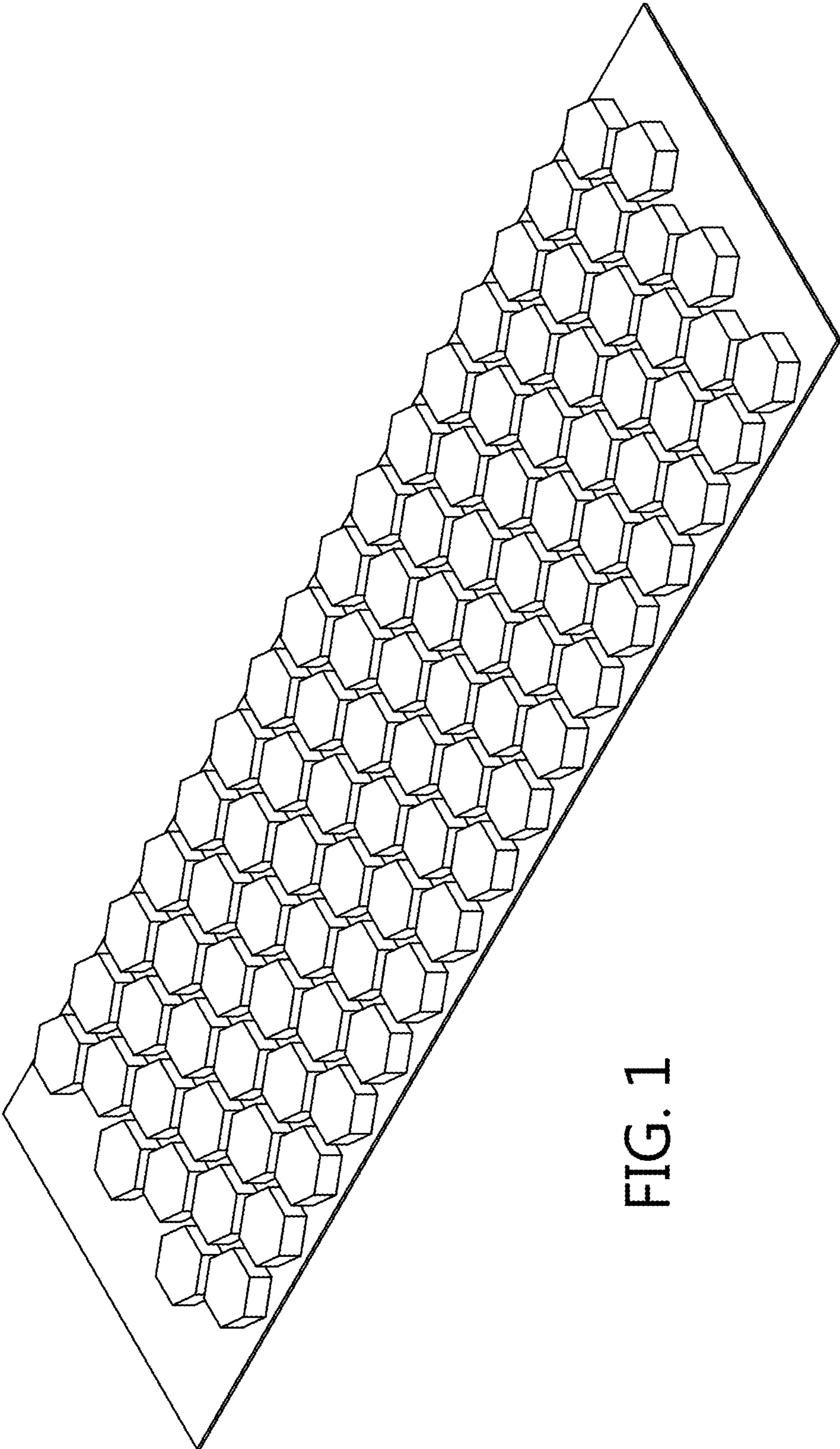

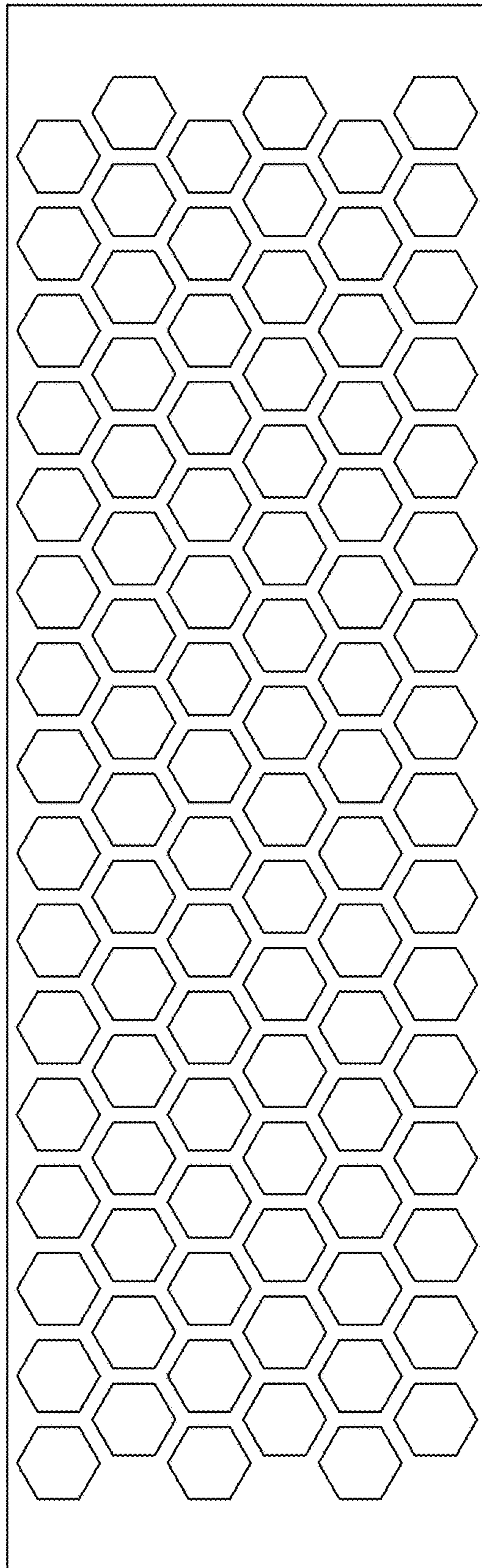

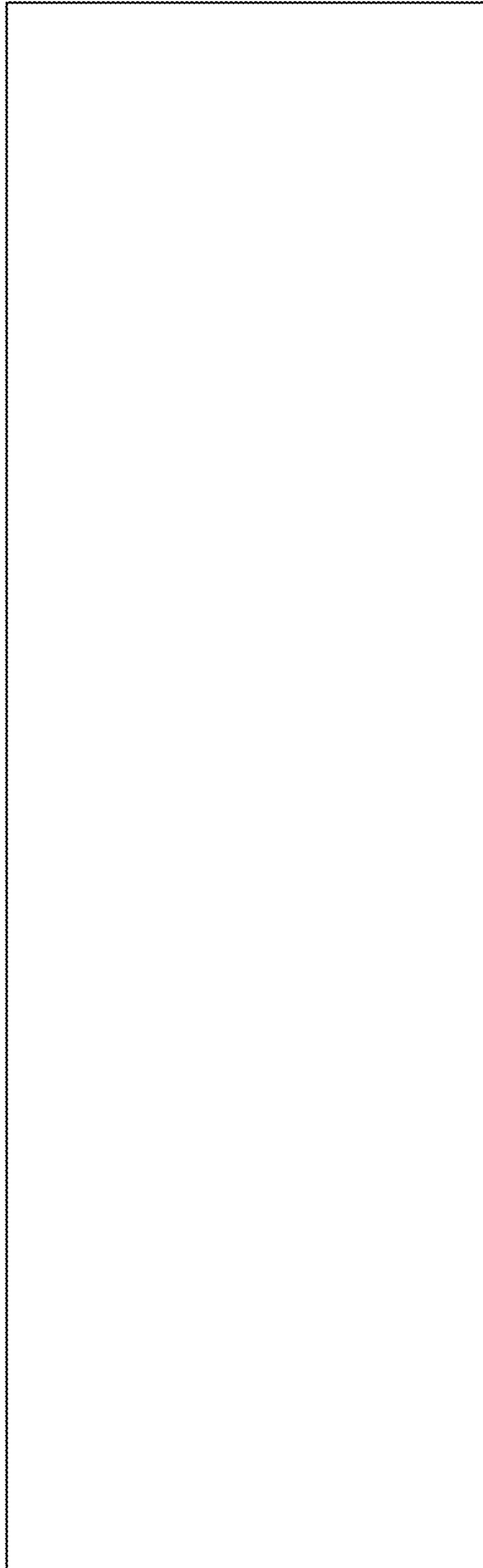

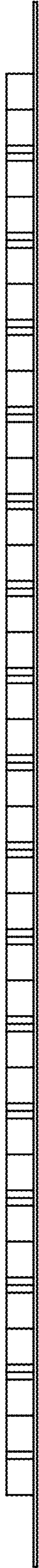

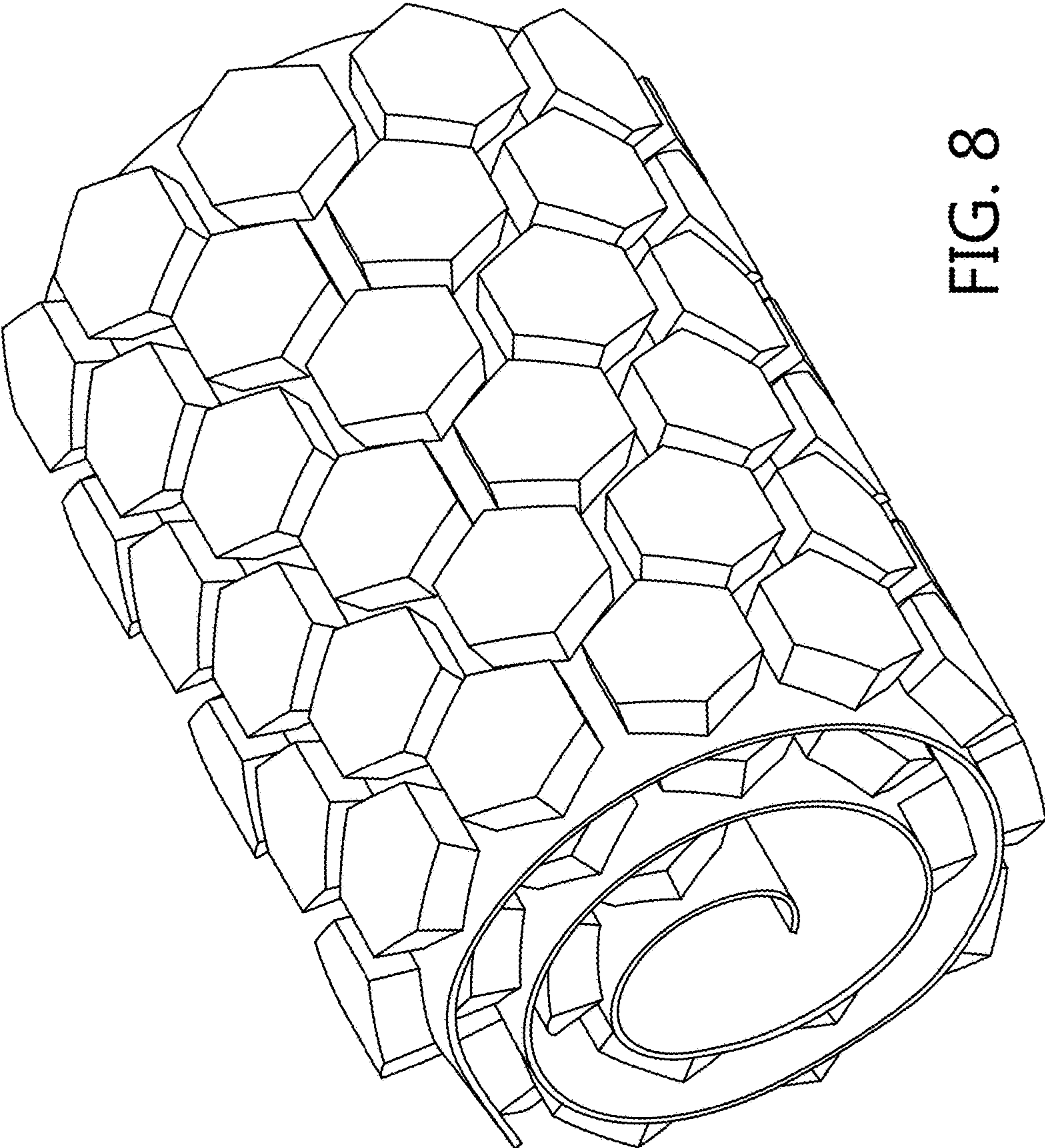

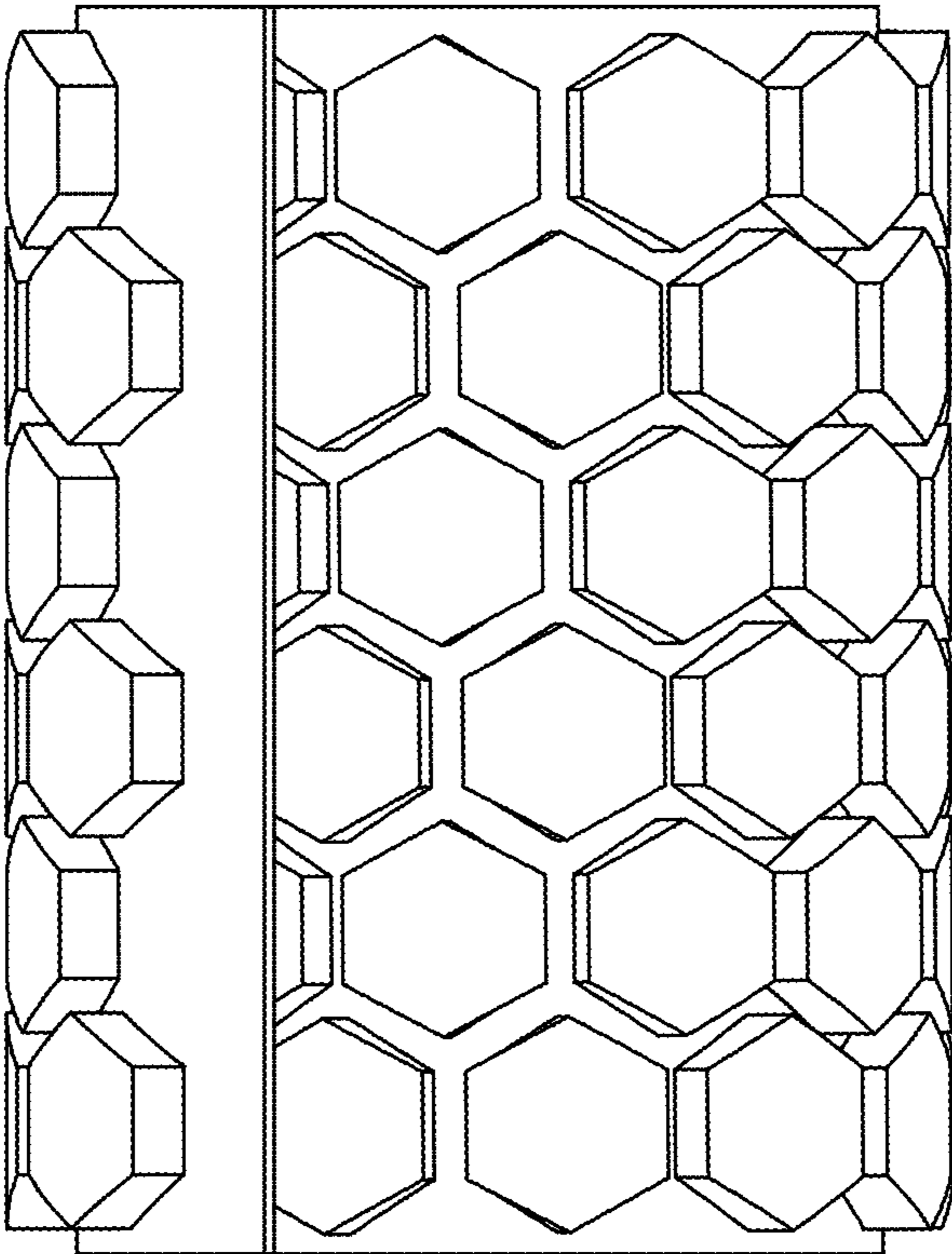

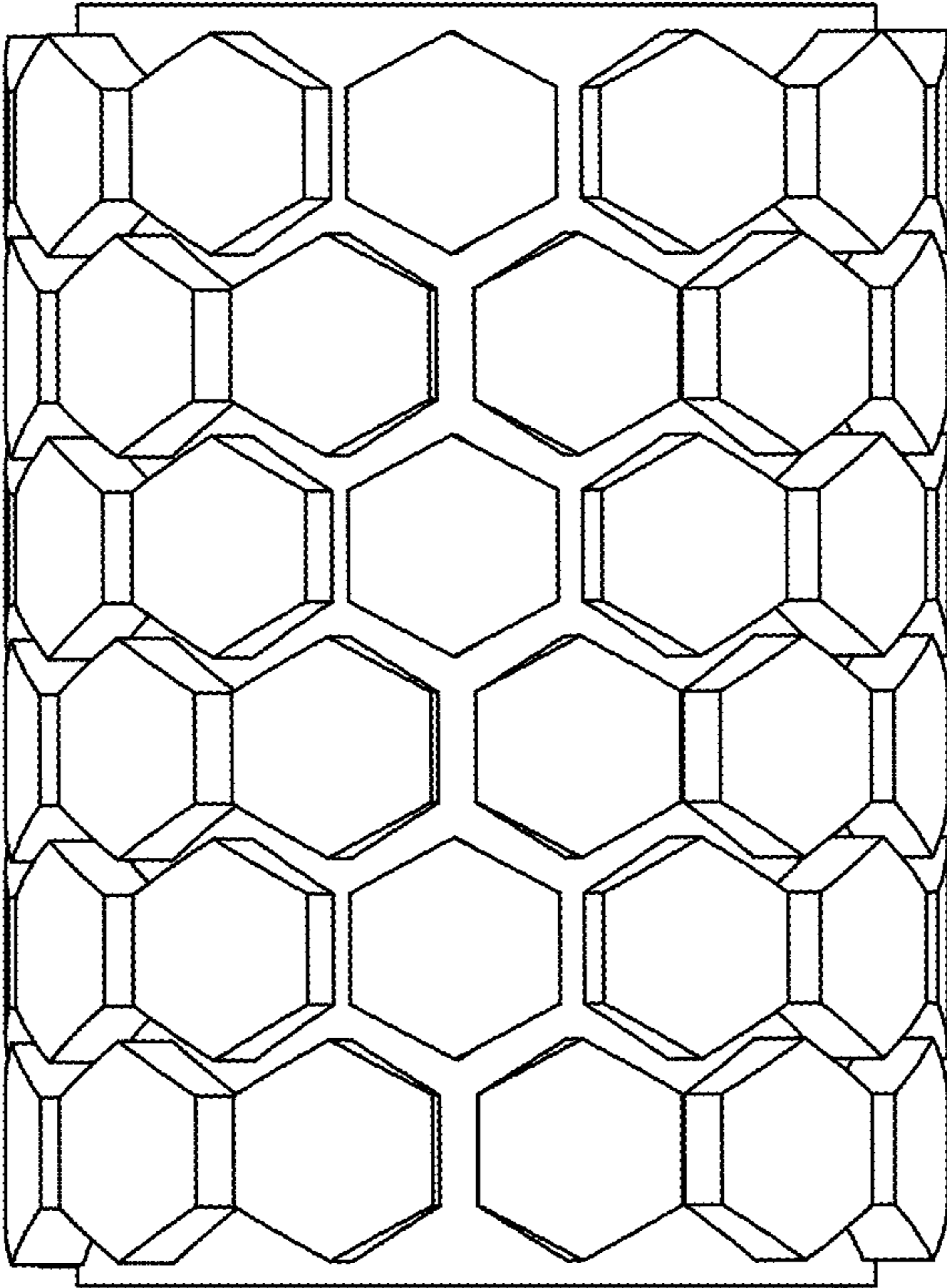

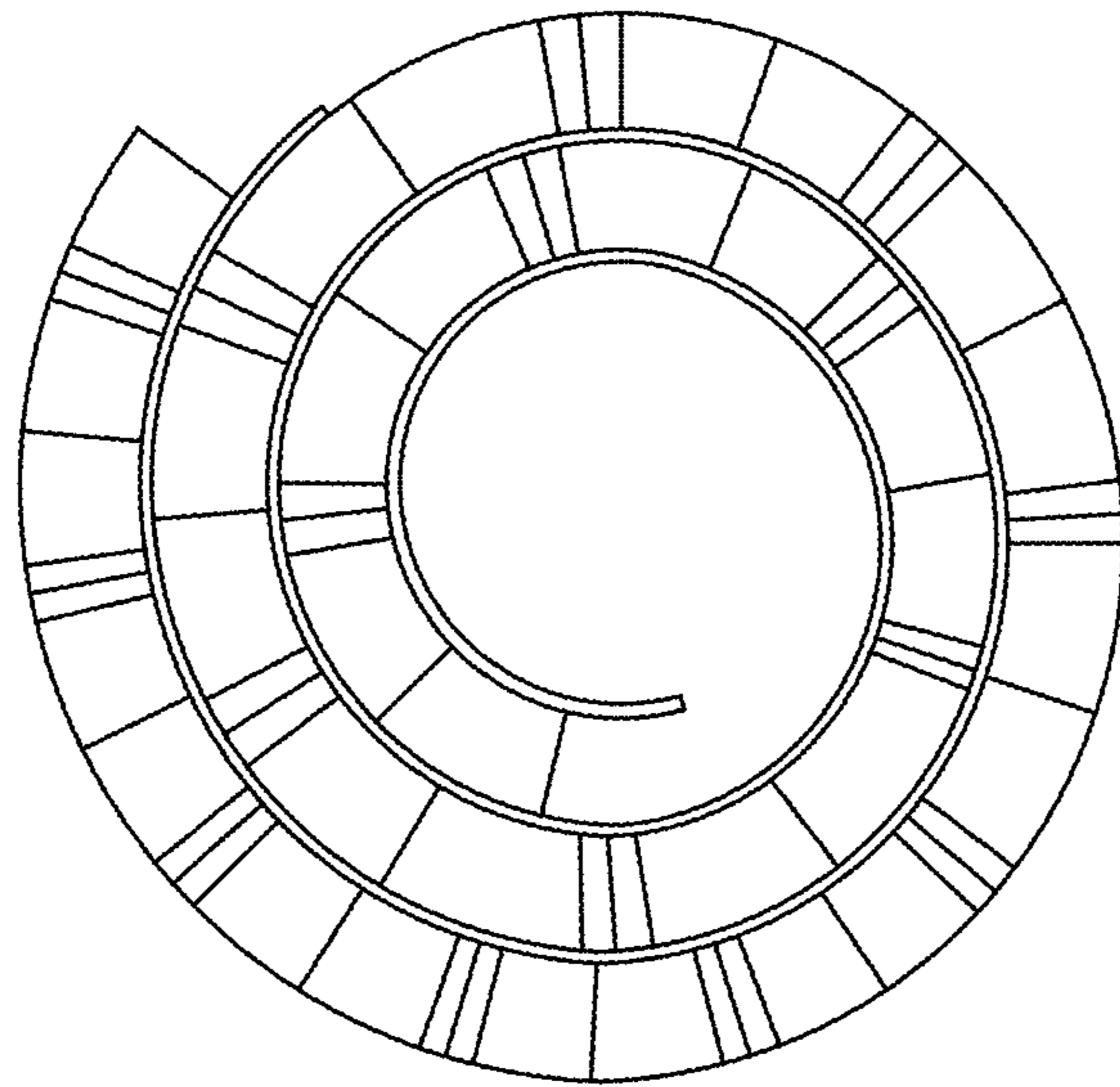

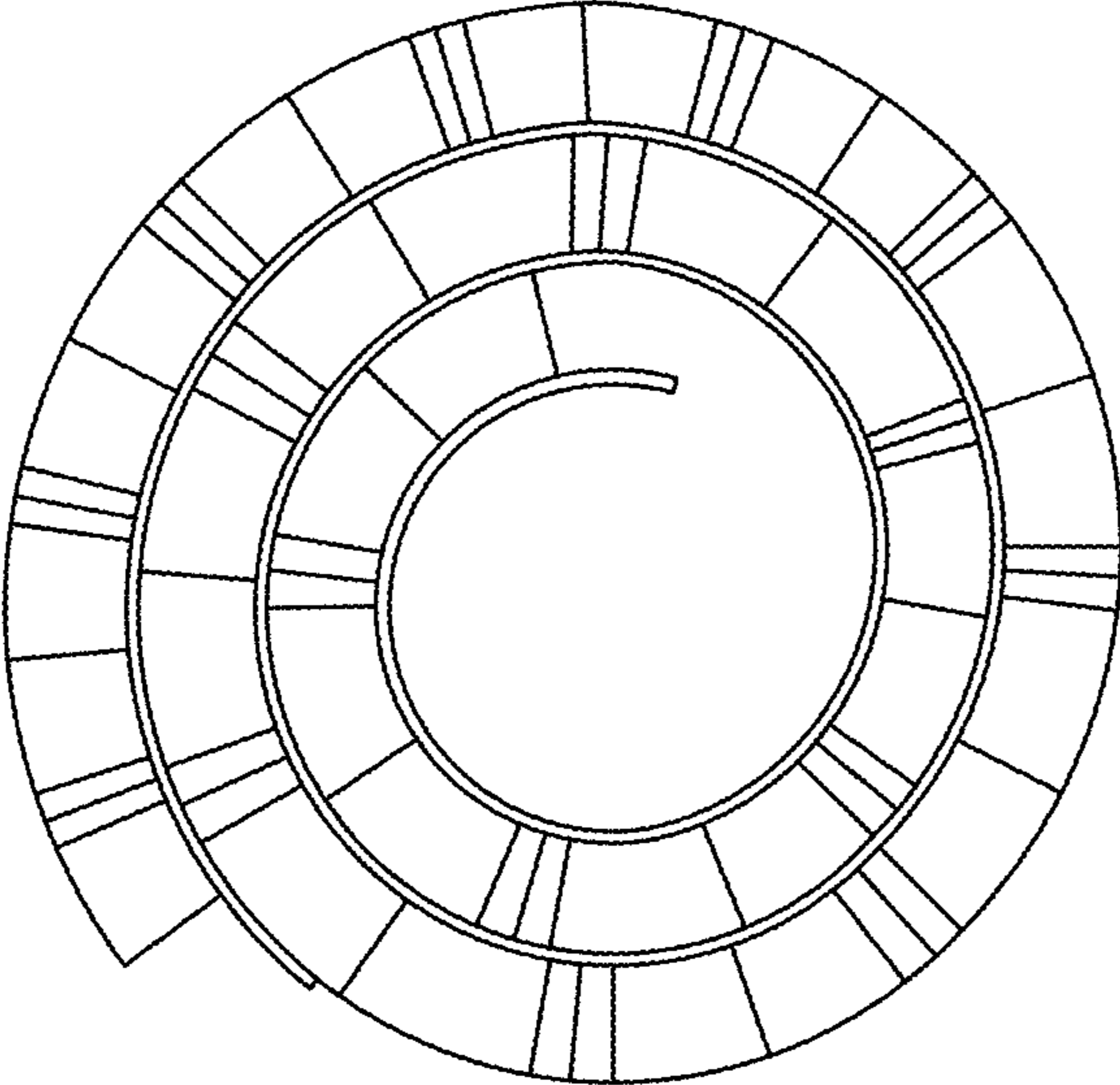

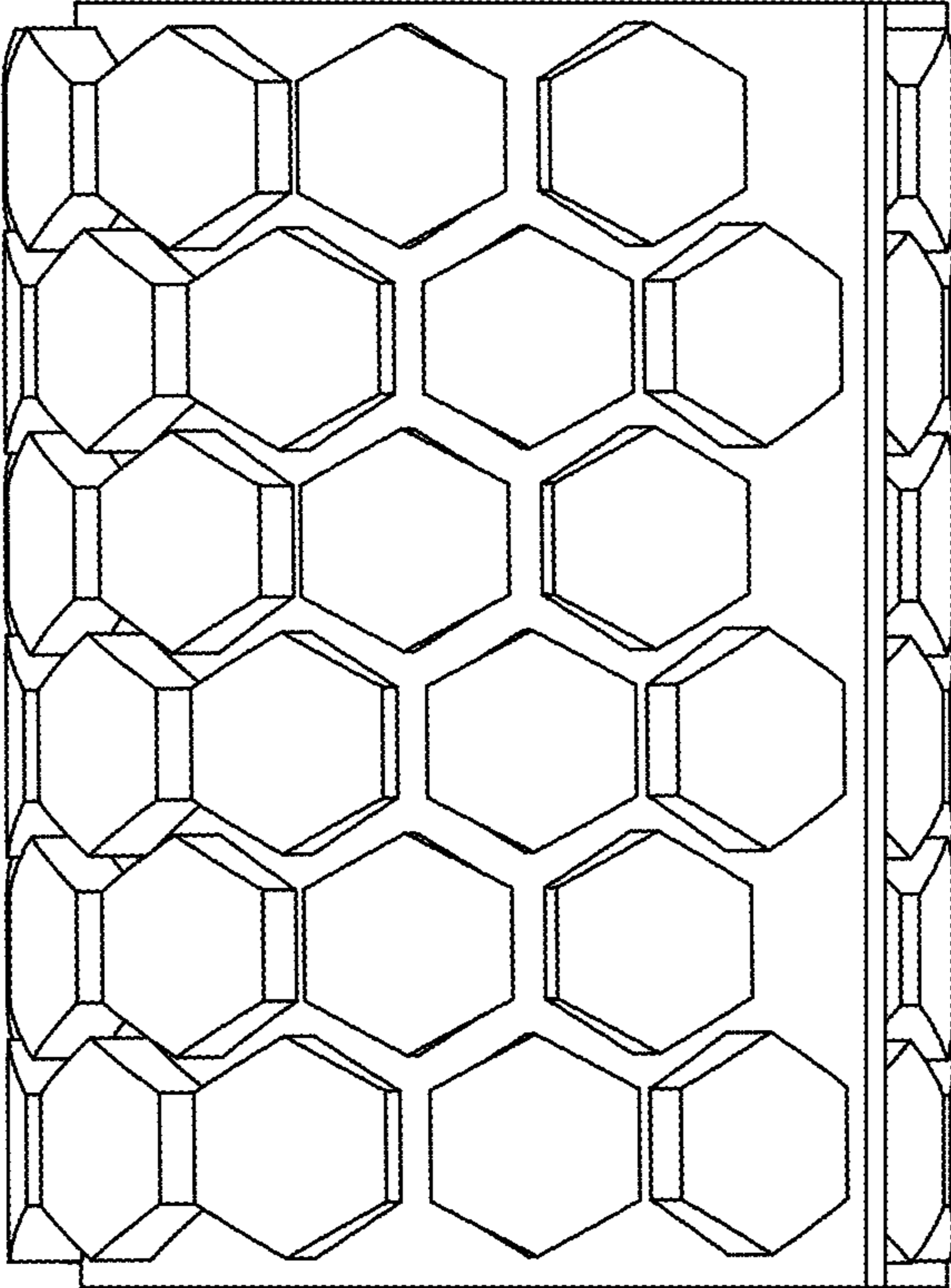

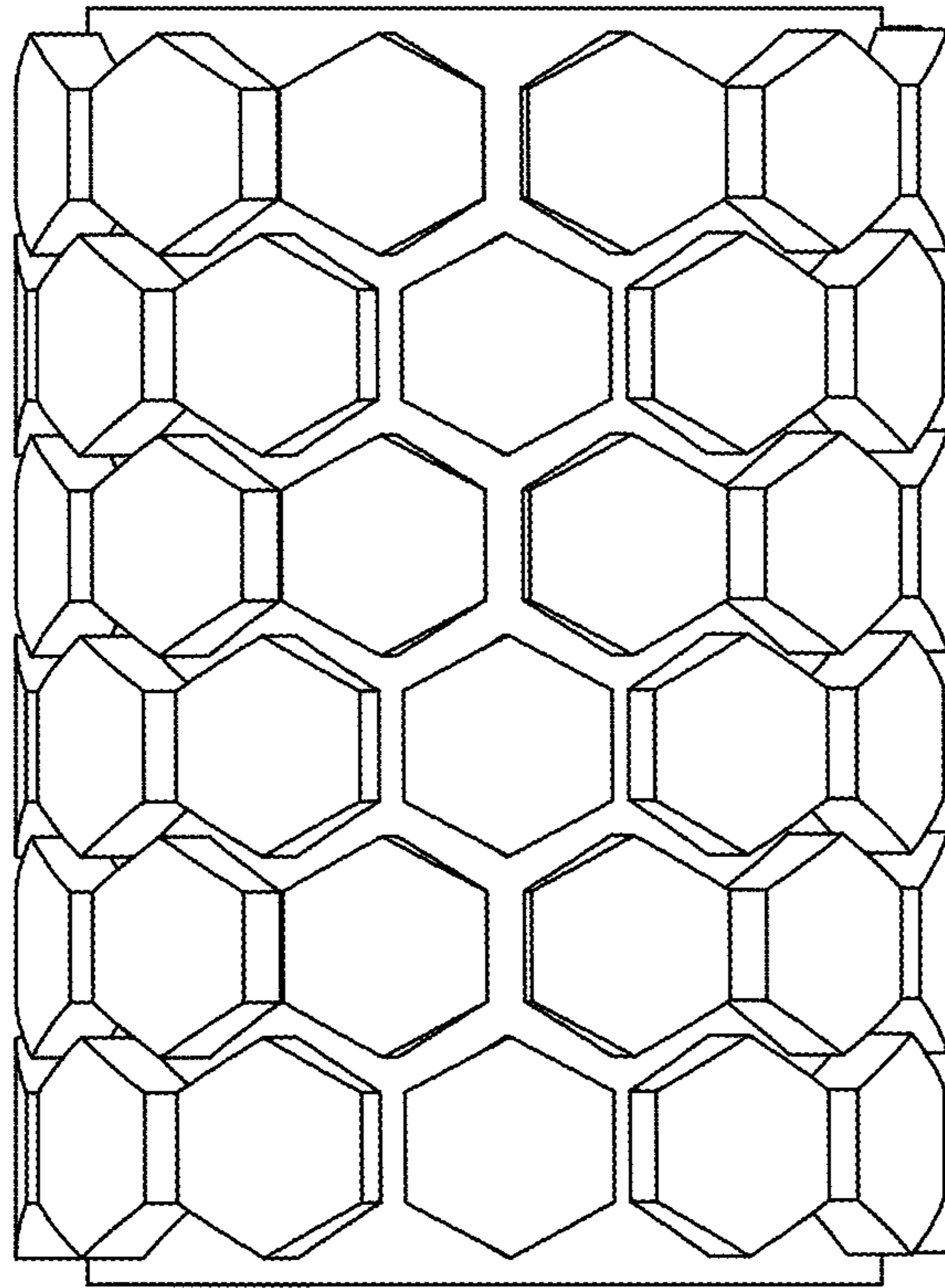
