 FIG. 7 is a rear view thereof.

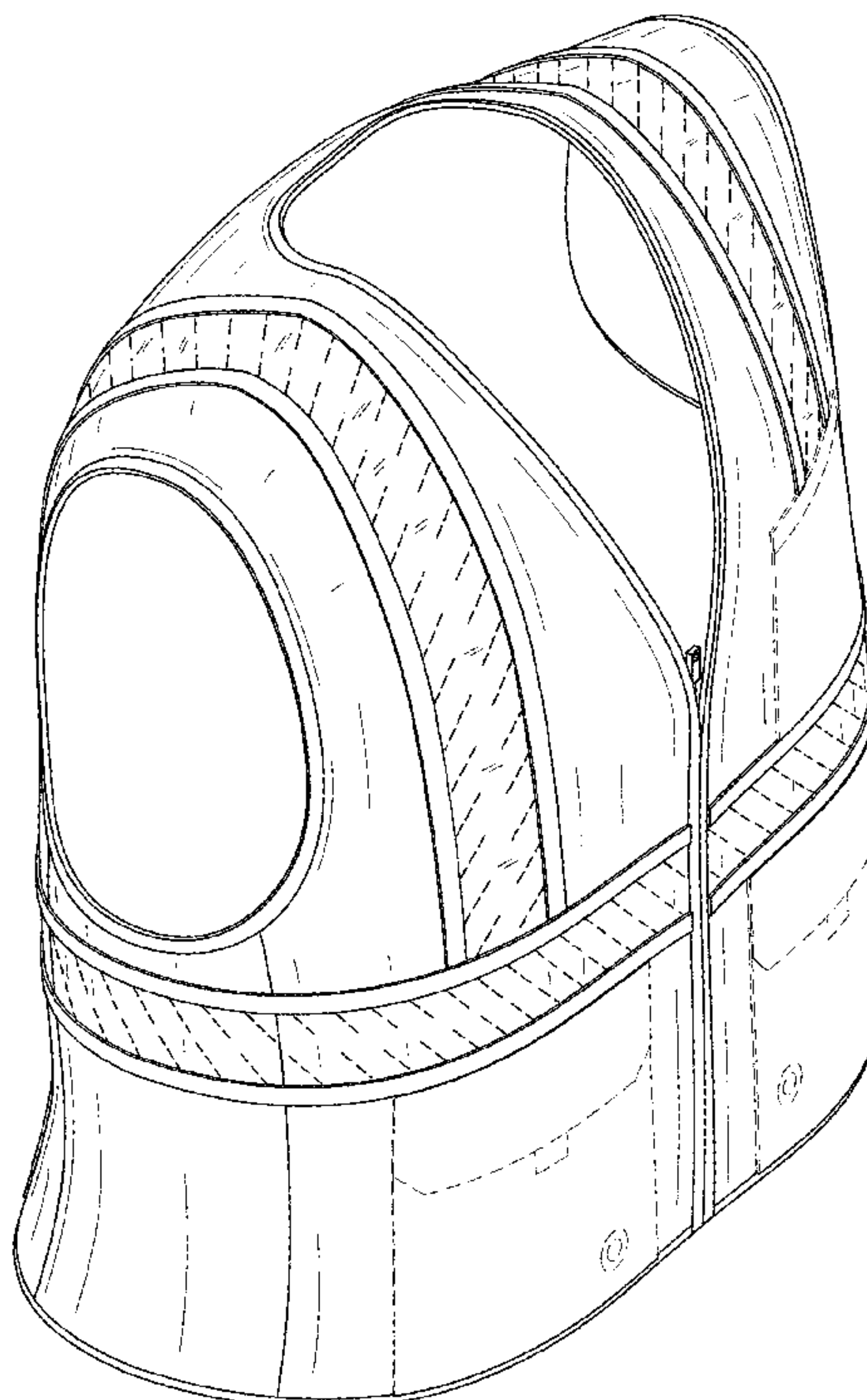
The broken lines shown in the drawings illustrate portions of the safety vest with tread pattern strips that form no part of the claimed invention.

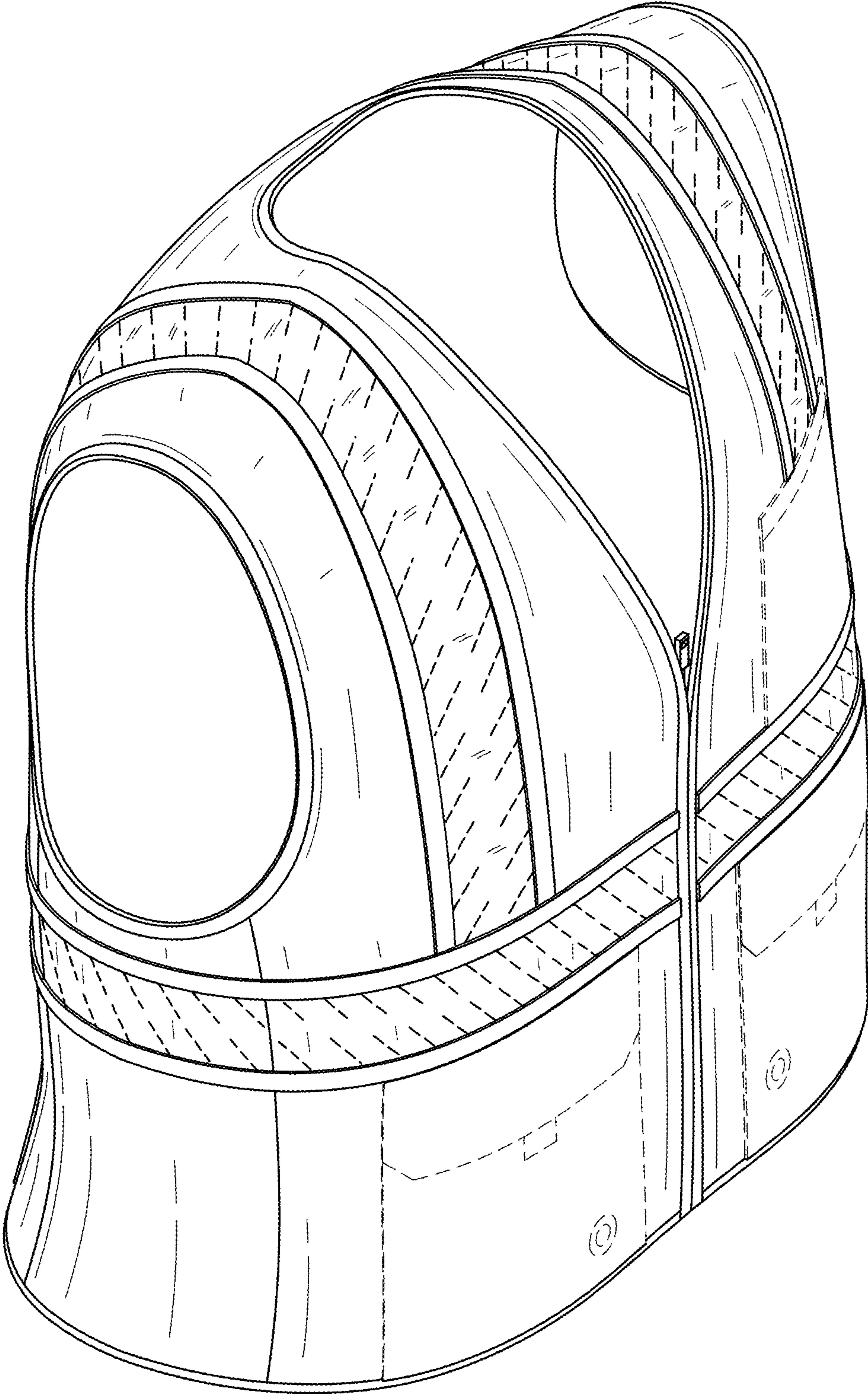

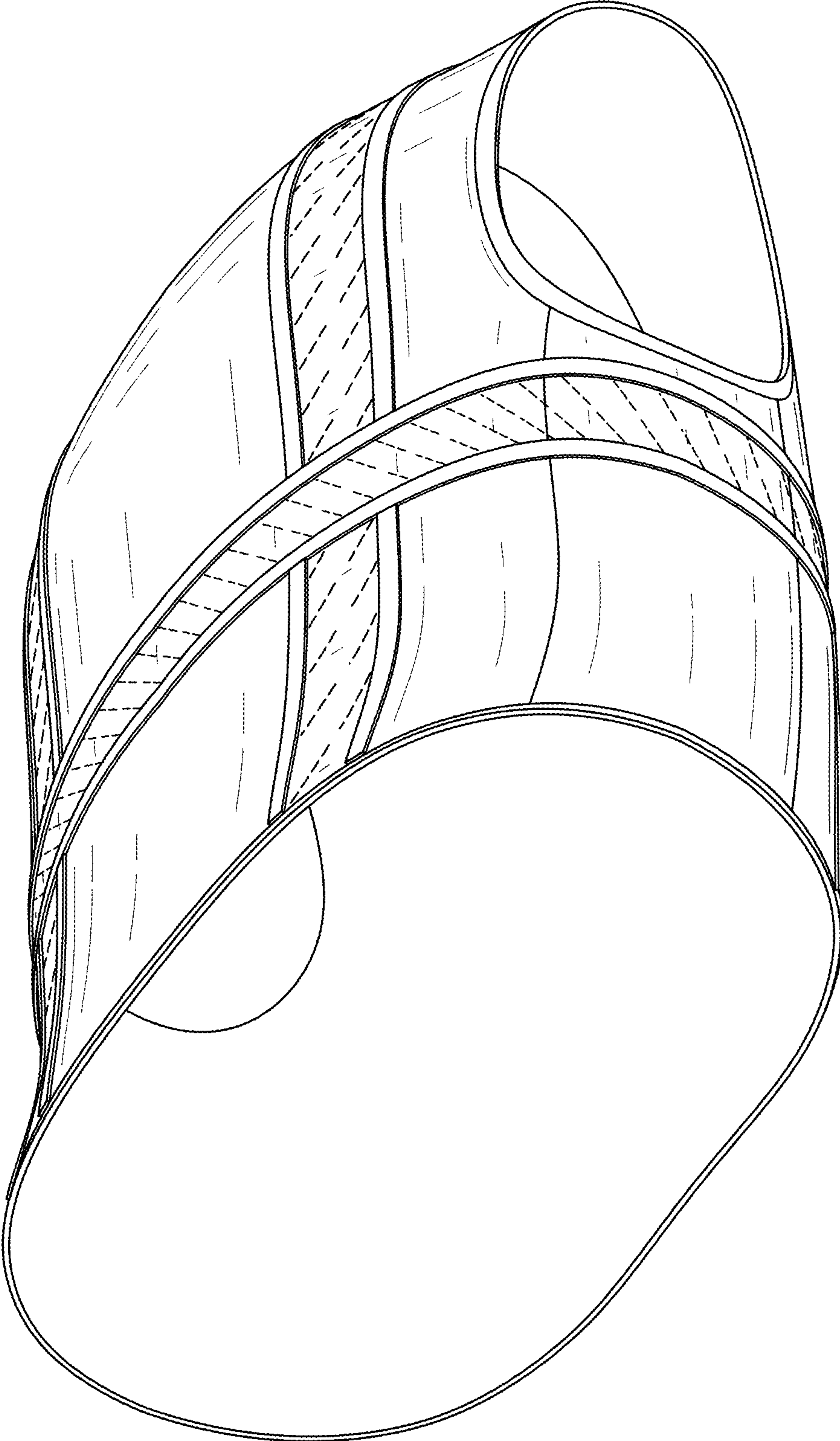

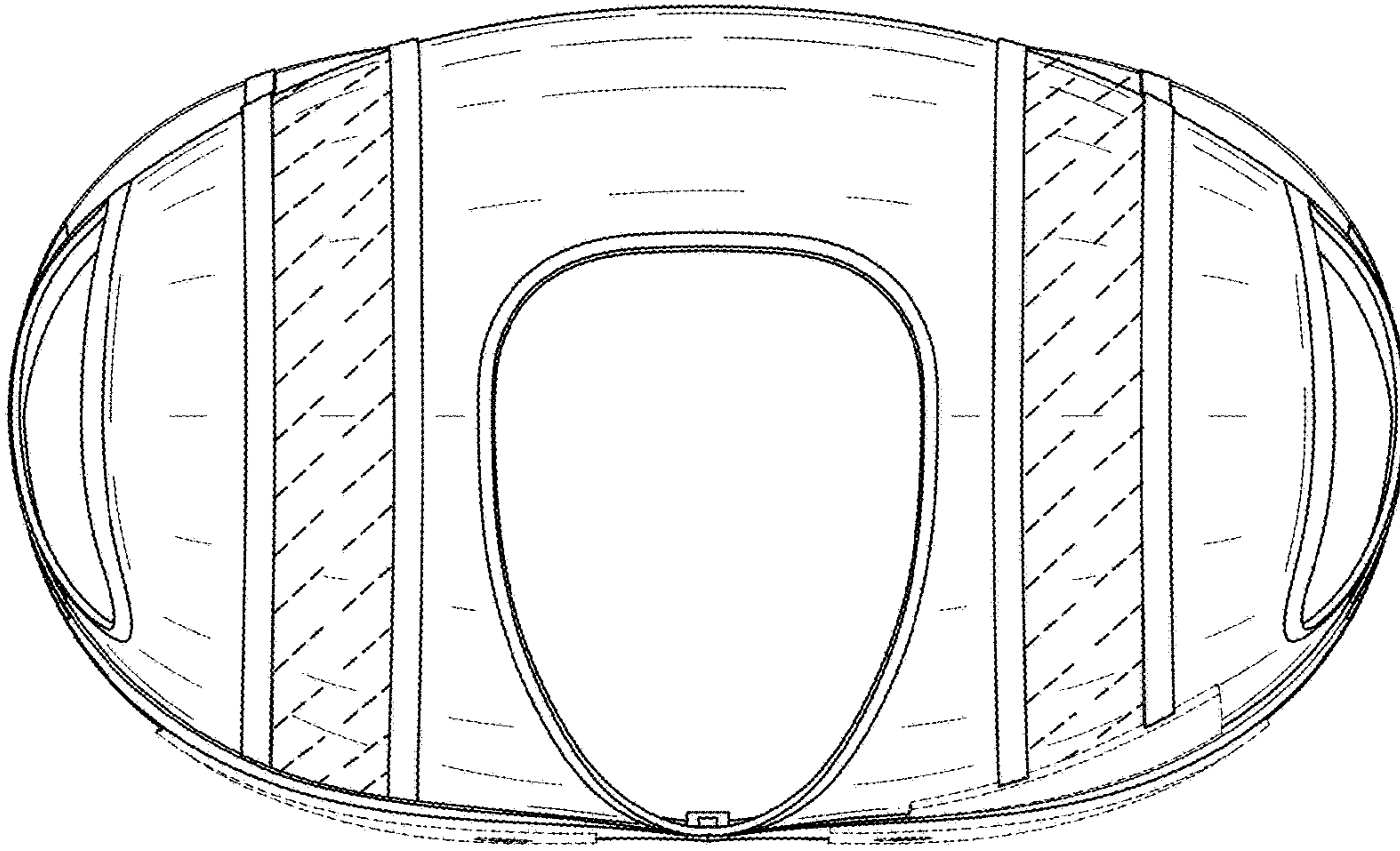

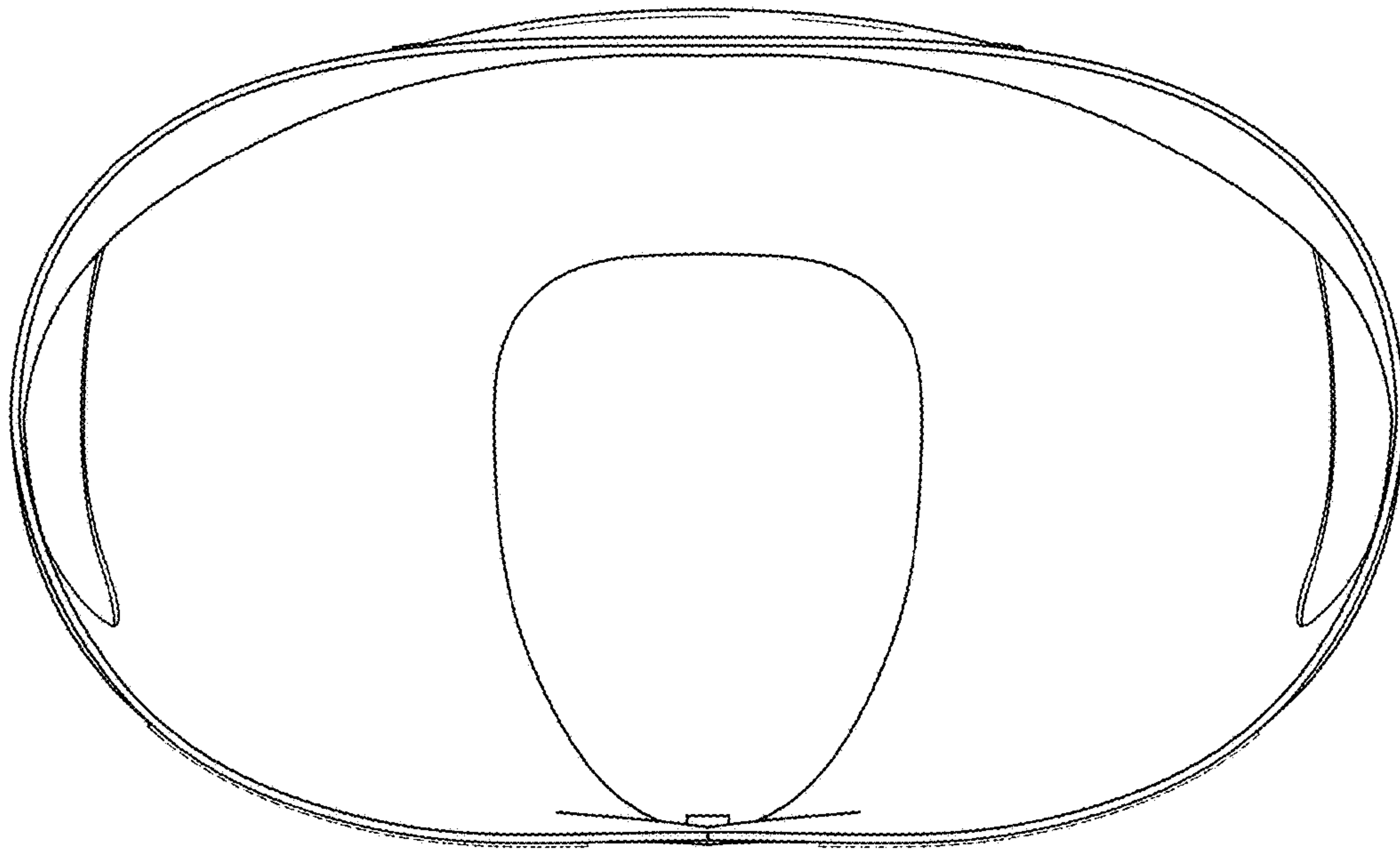

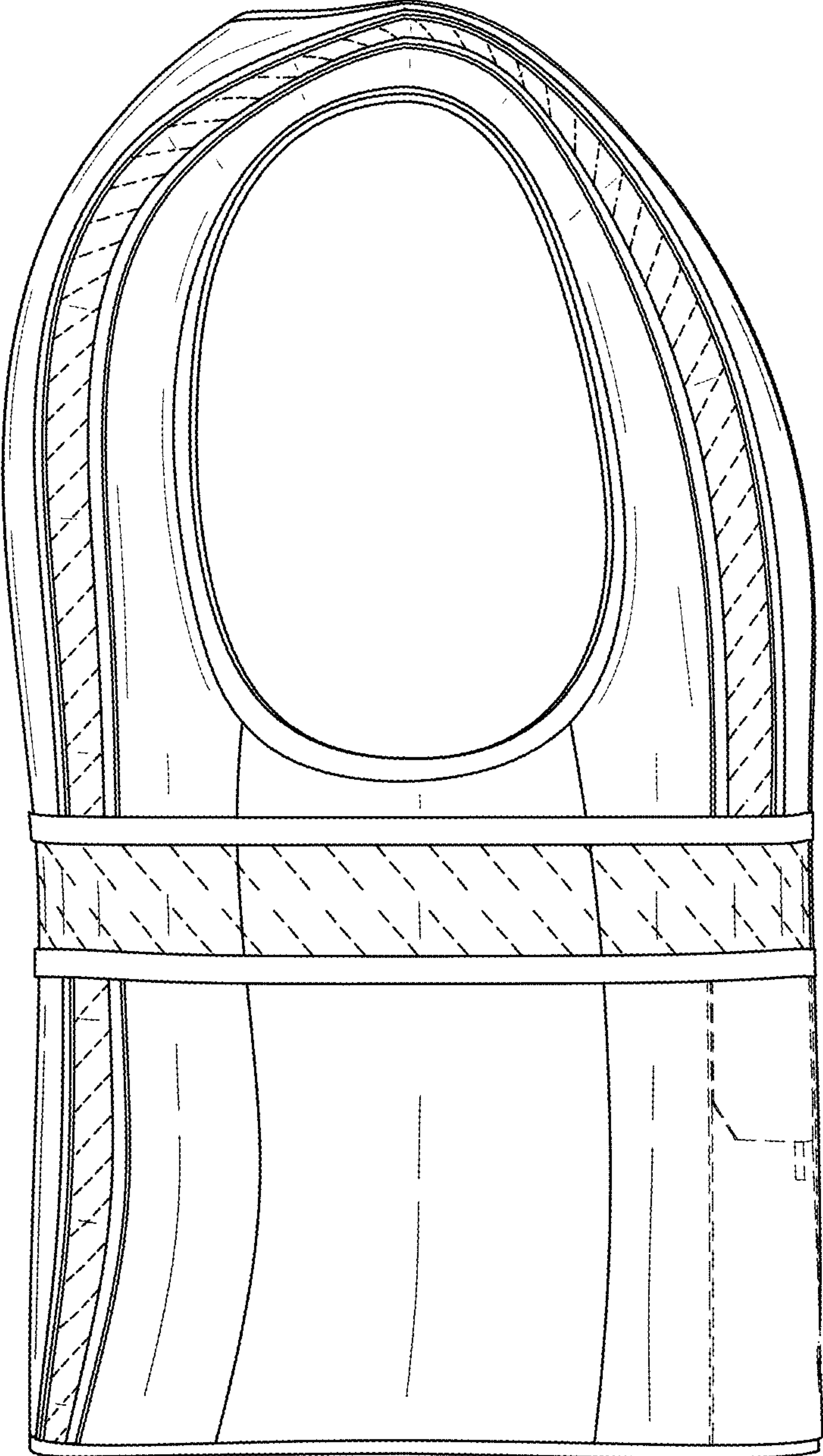

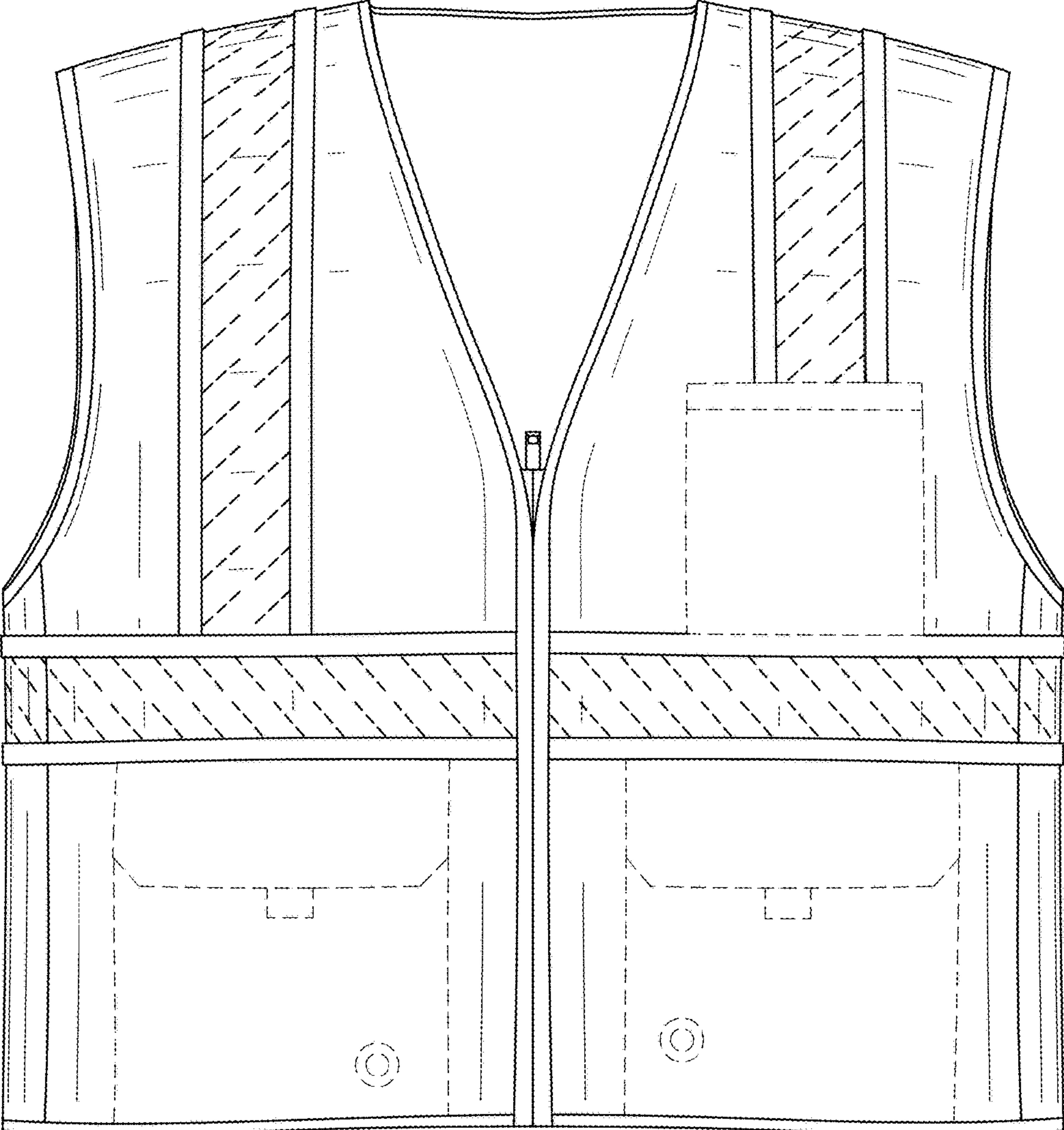

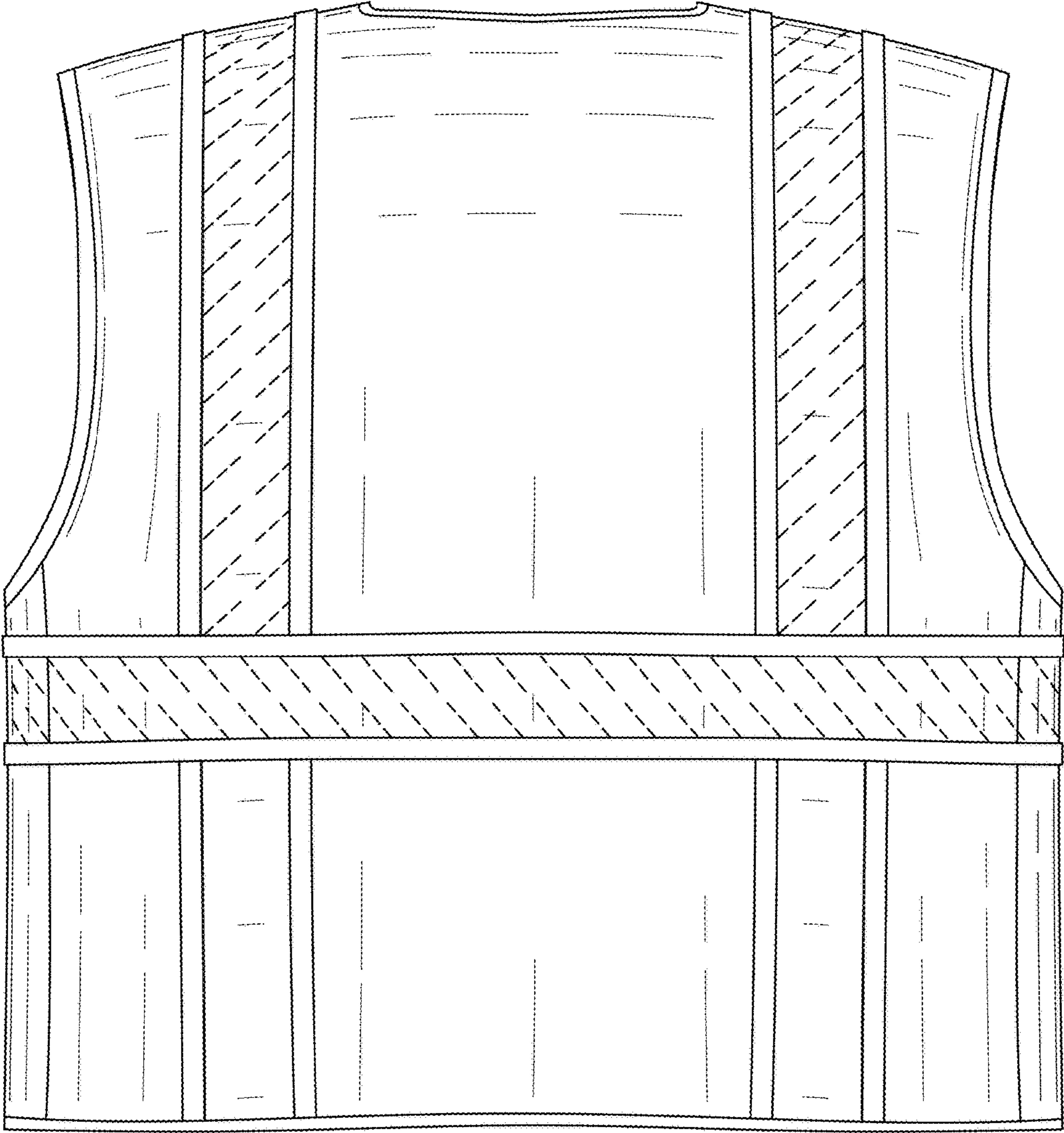
