DESCRIPTION

FIG. 1 is tridimensional view of a goalie glove showing my new design;

FIG. 4 is a first side view thereof;

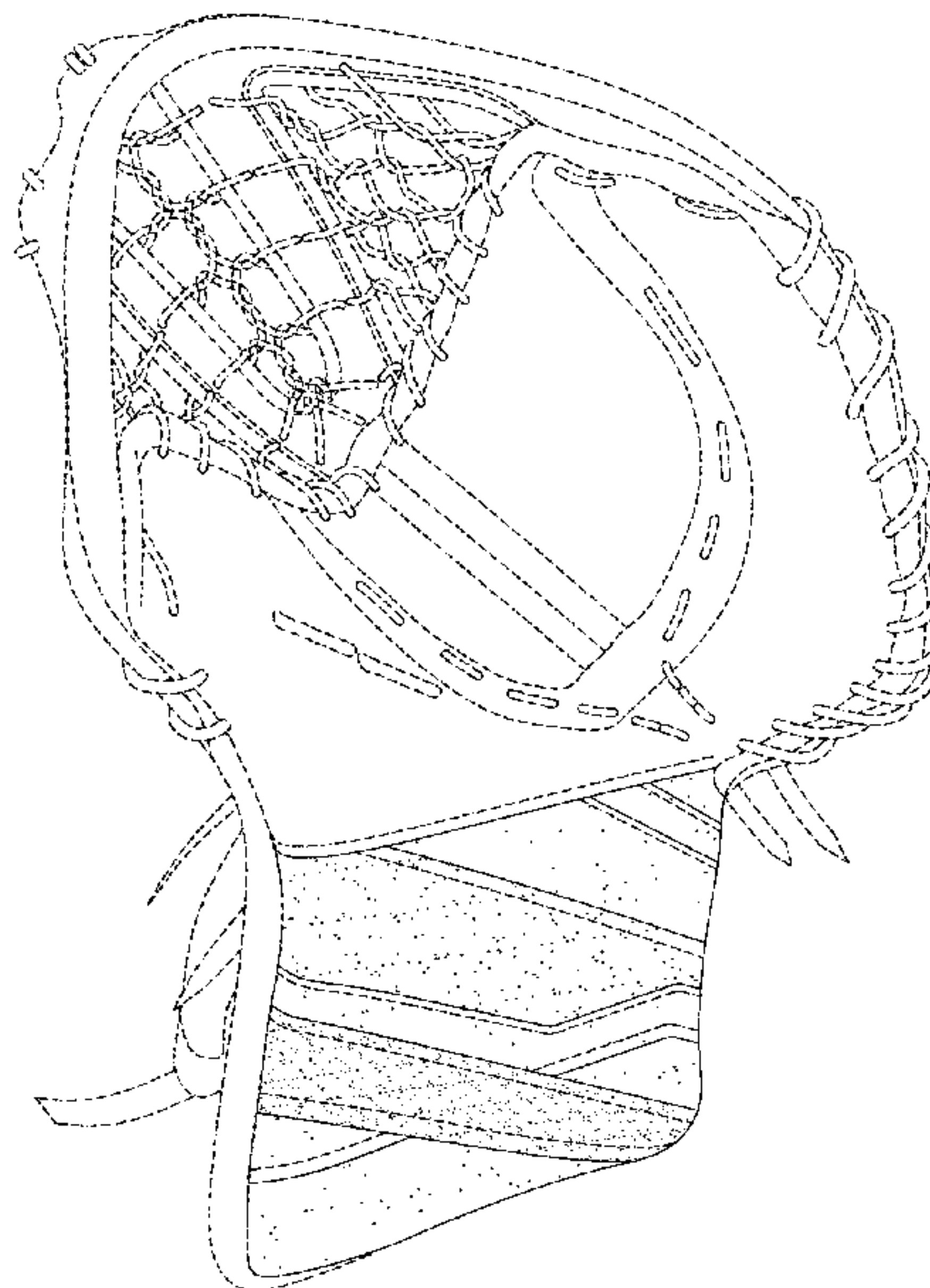
FIG. 5 is second side view thereof, opposite the first side;

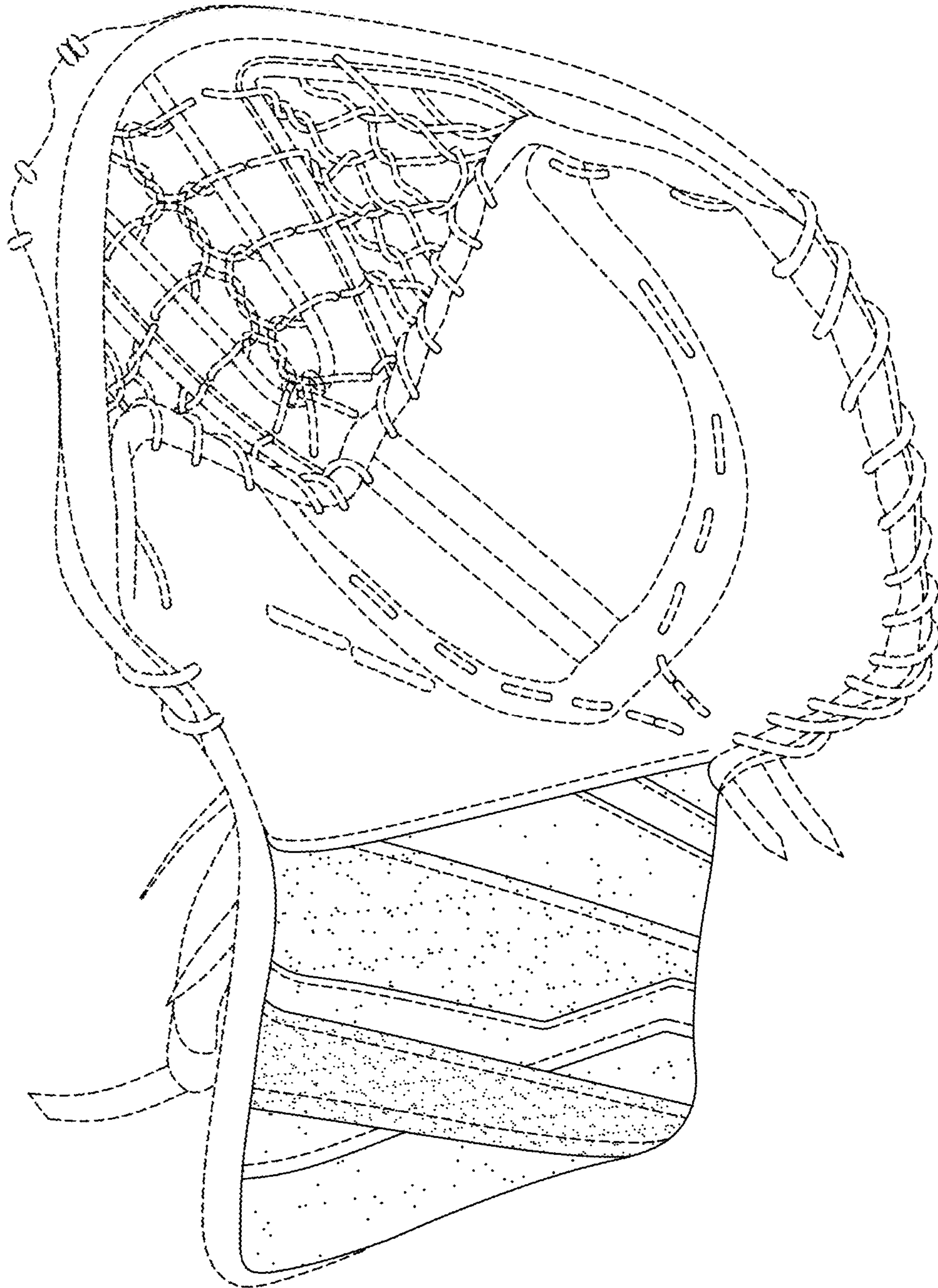

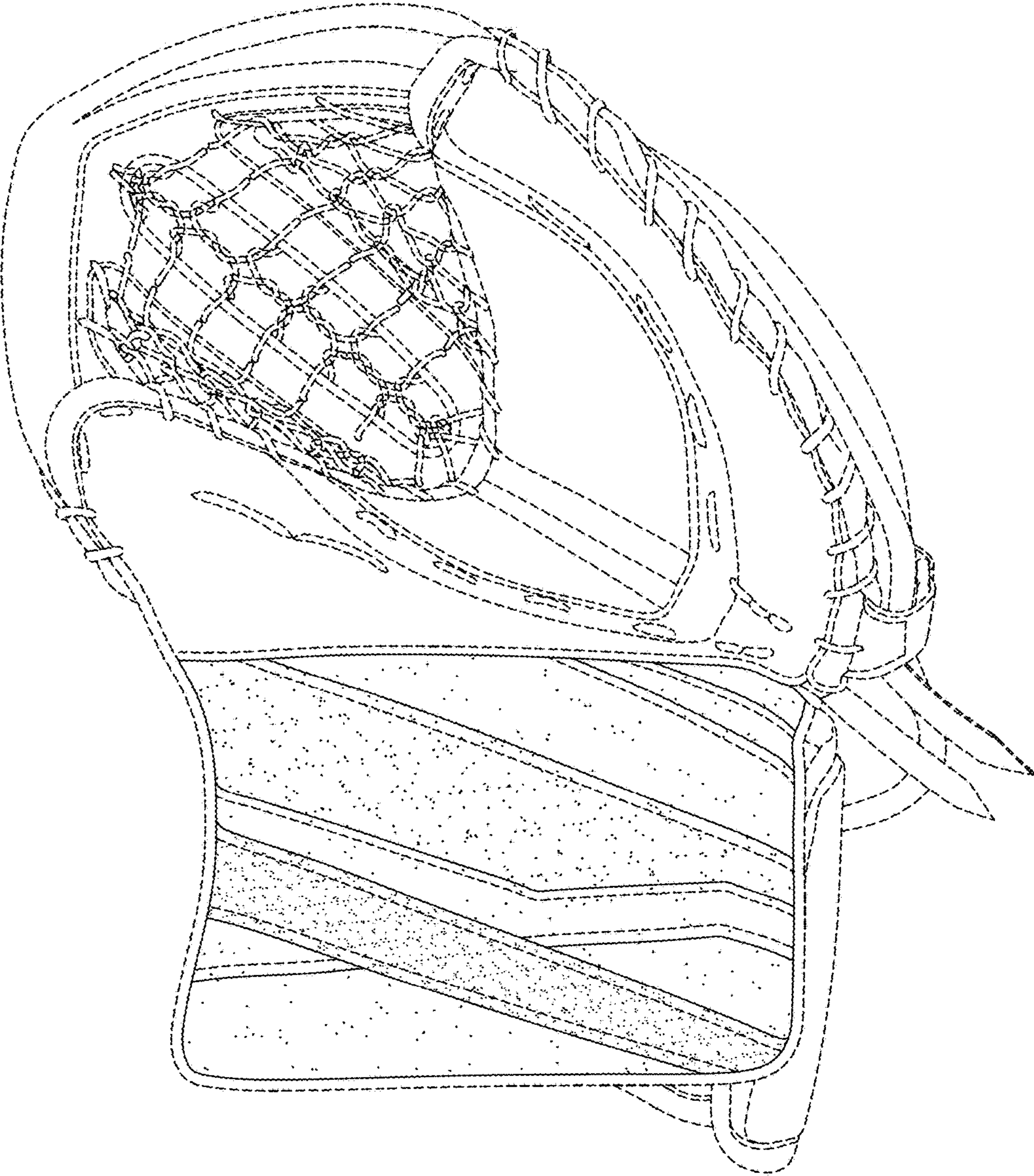

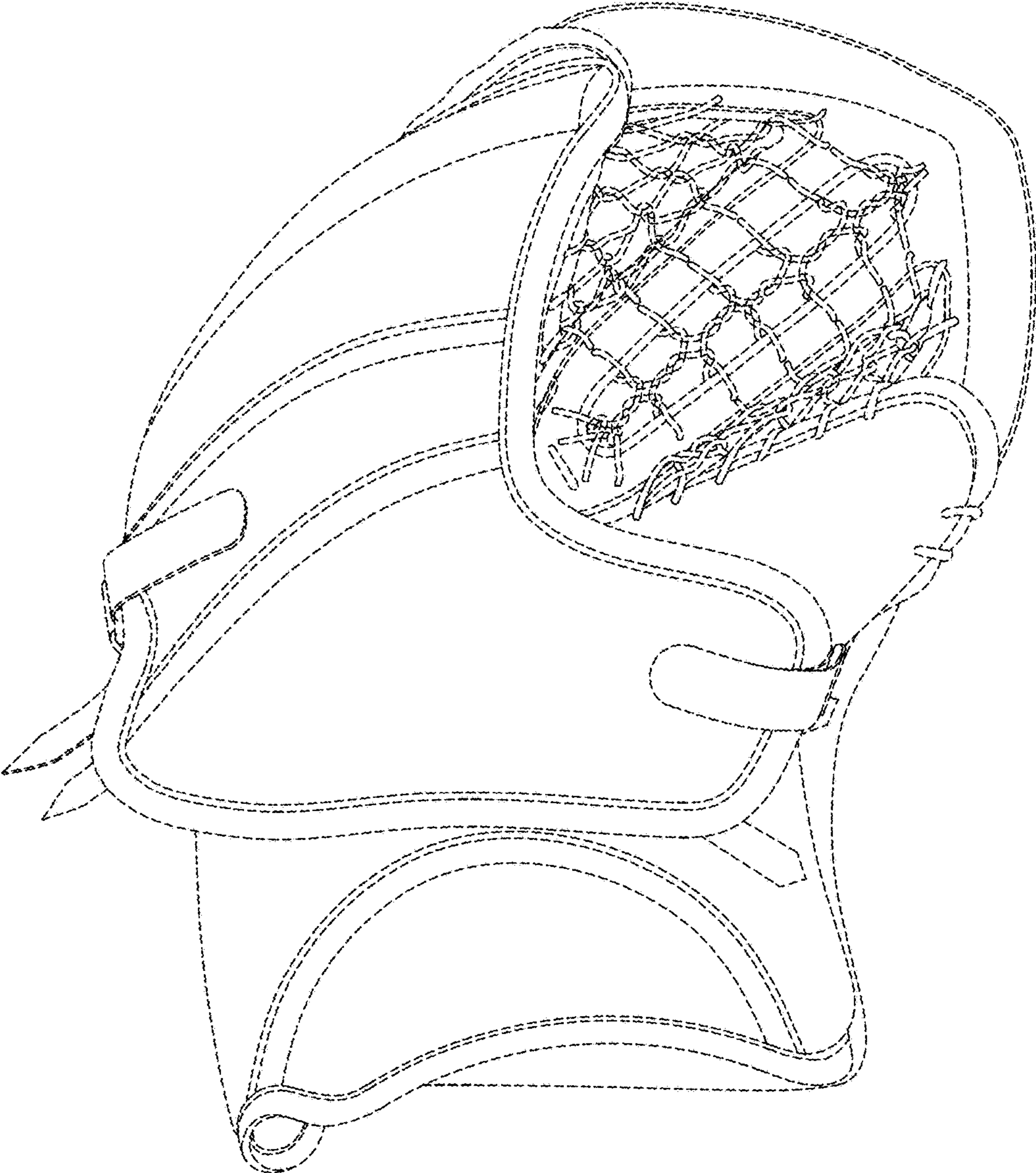

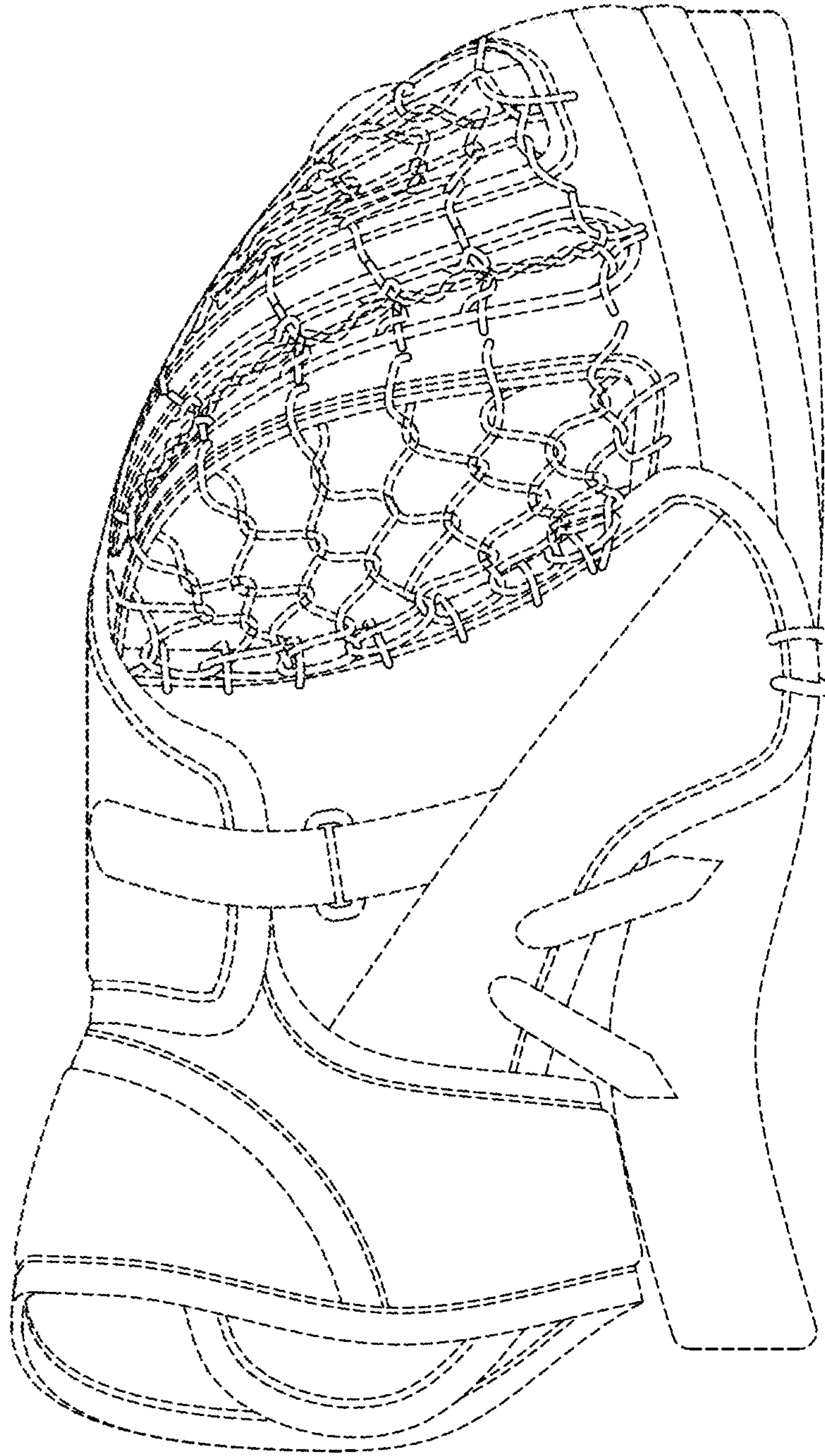

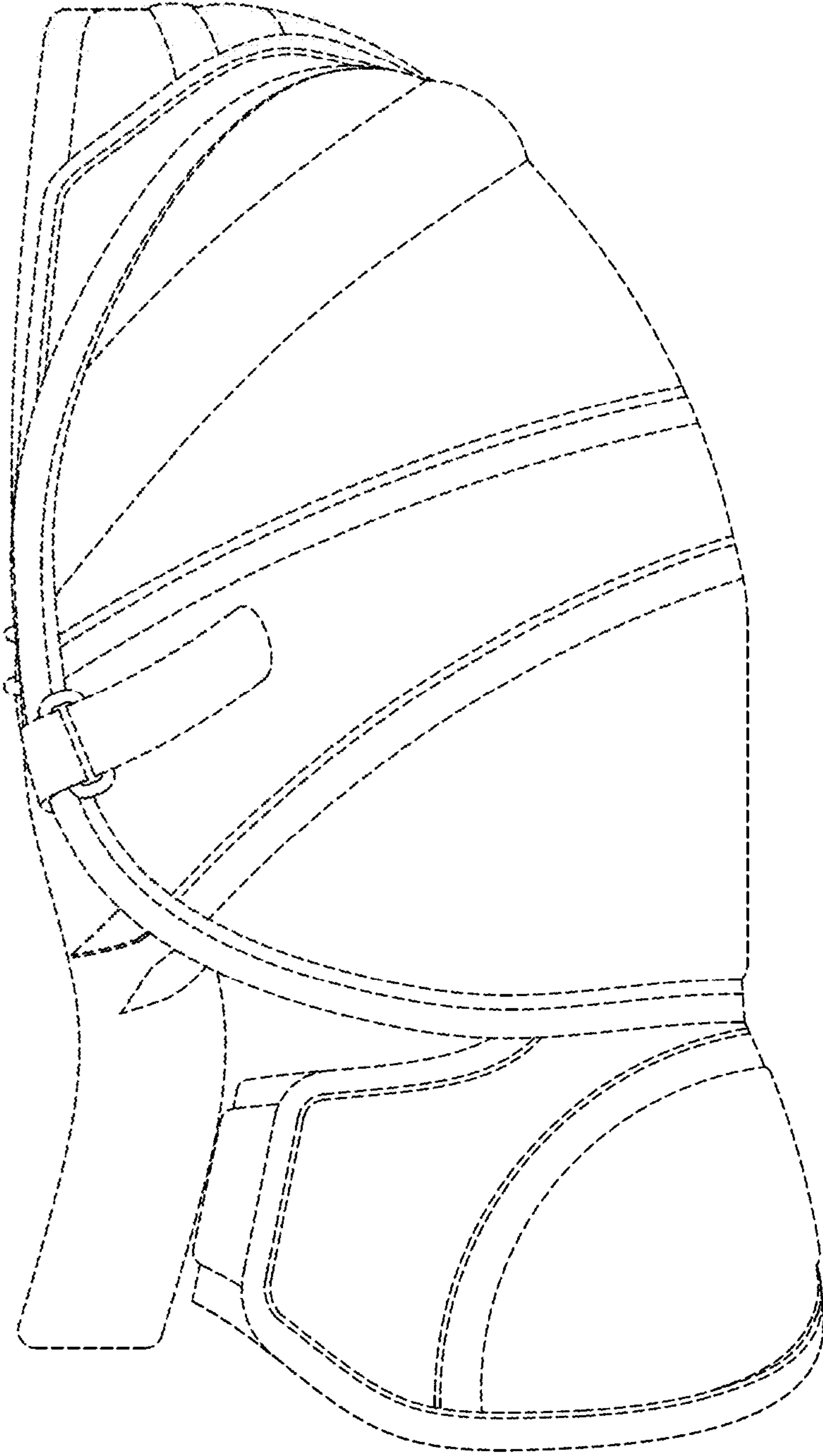

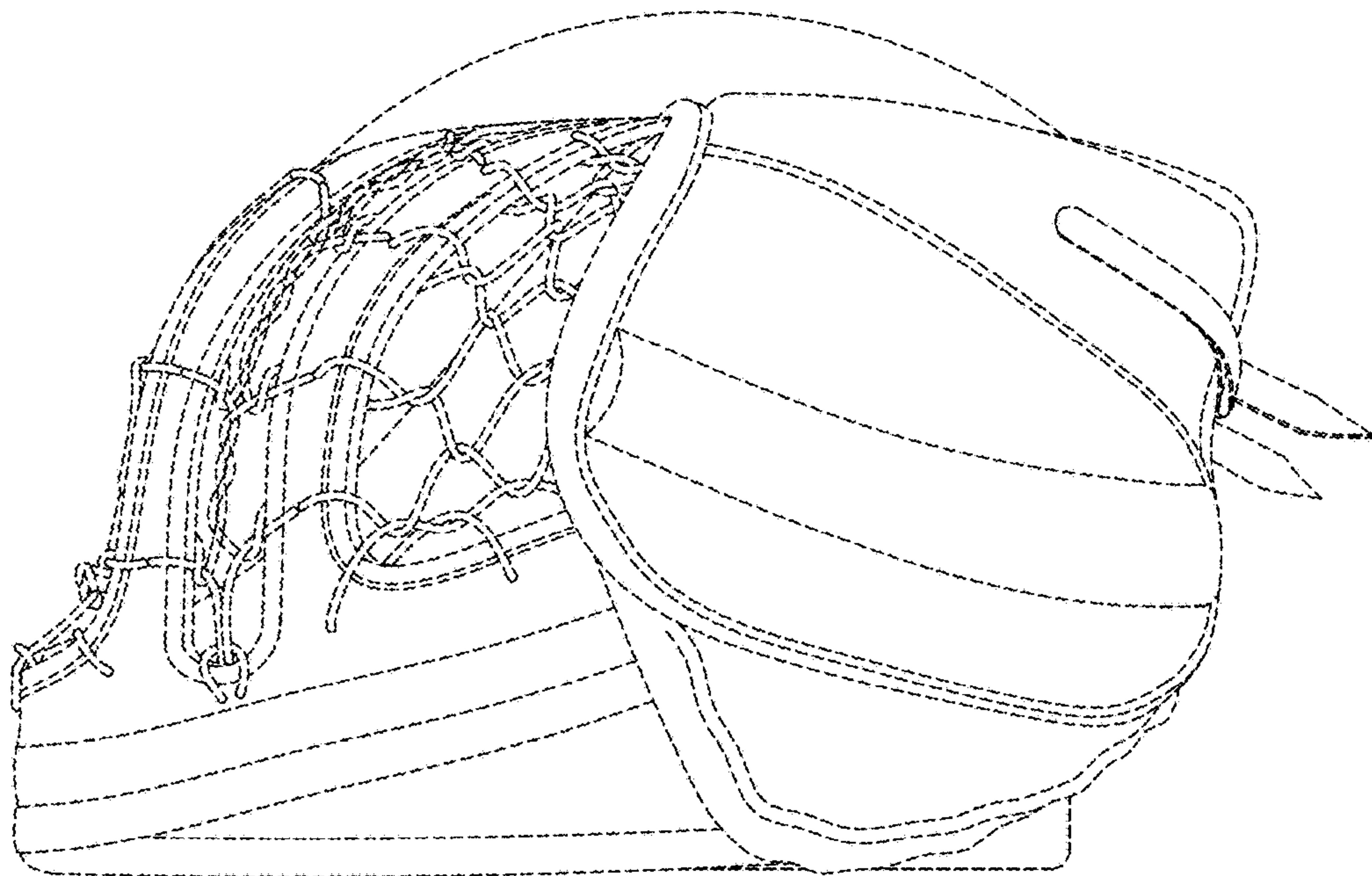

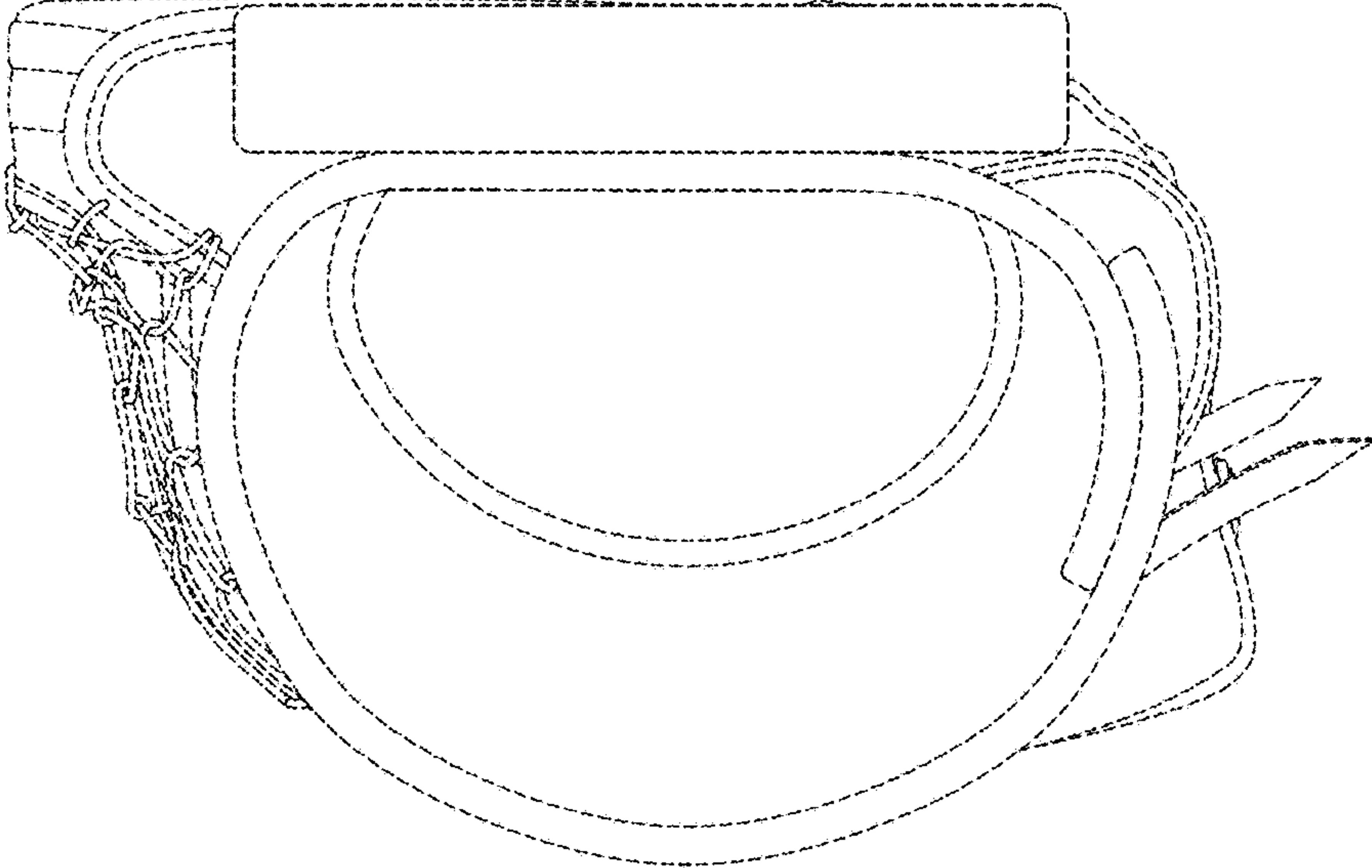
