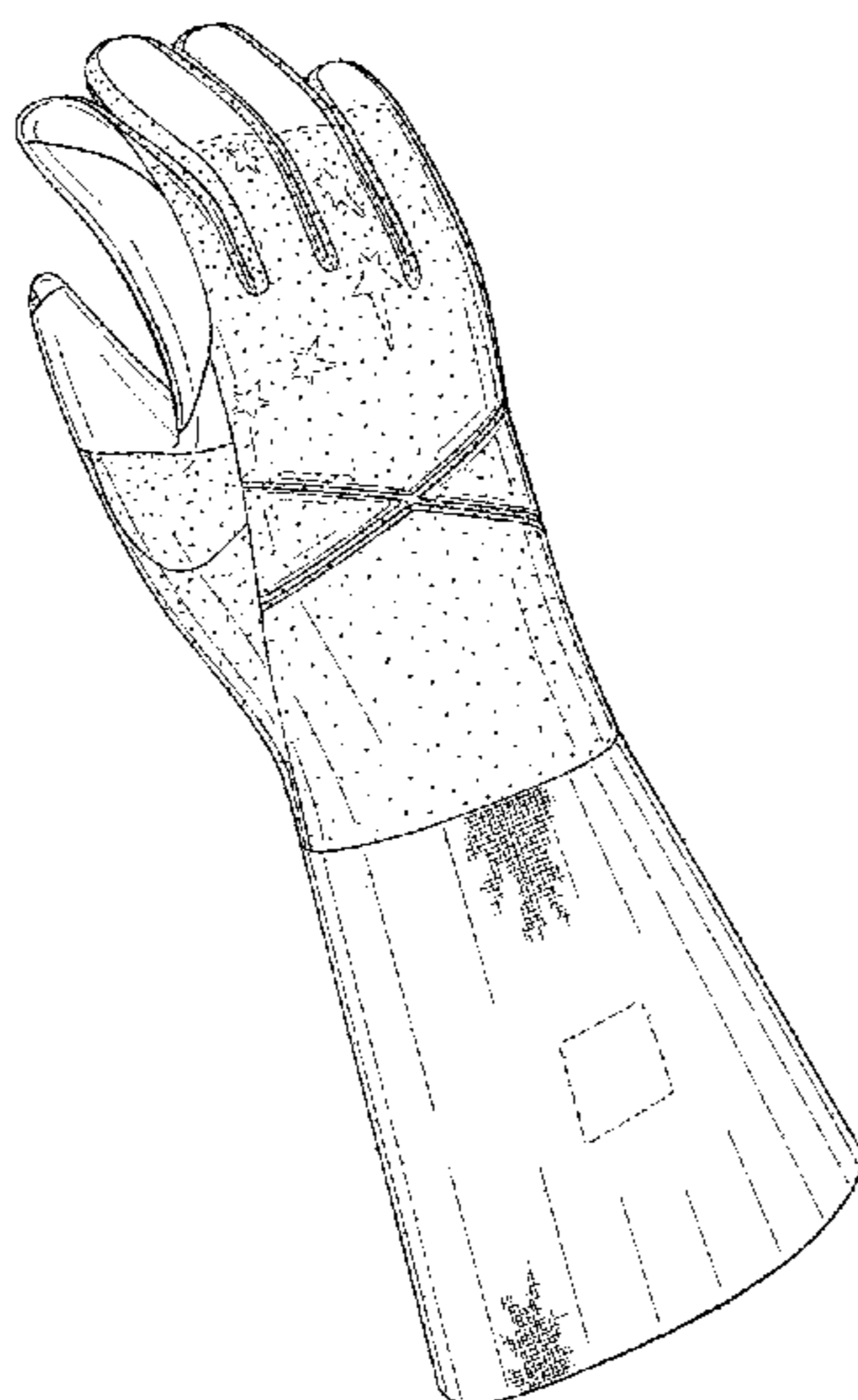
(57) **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a glove showing our new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is top, front, left side perspective view thereof.
The broken lines represent portions of the glove that form no part of the claimed design. The stippling represents a contrast in material between the stippled area and the wrist area shown without stippling.

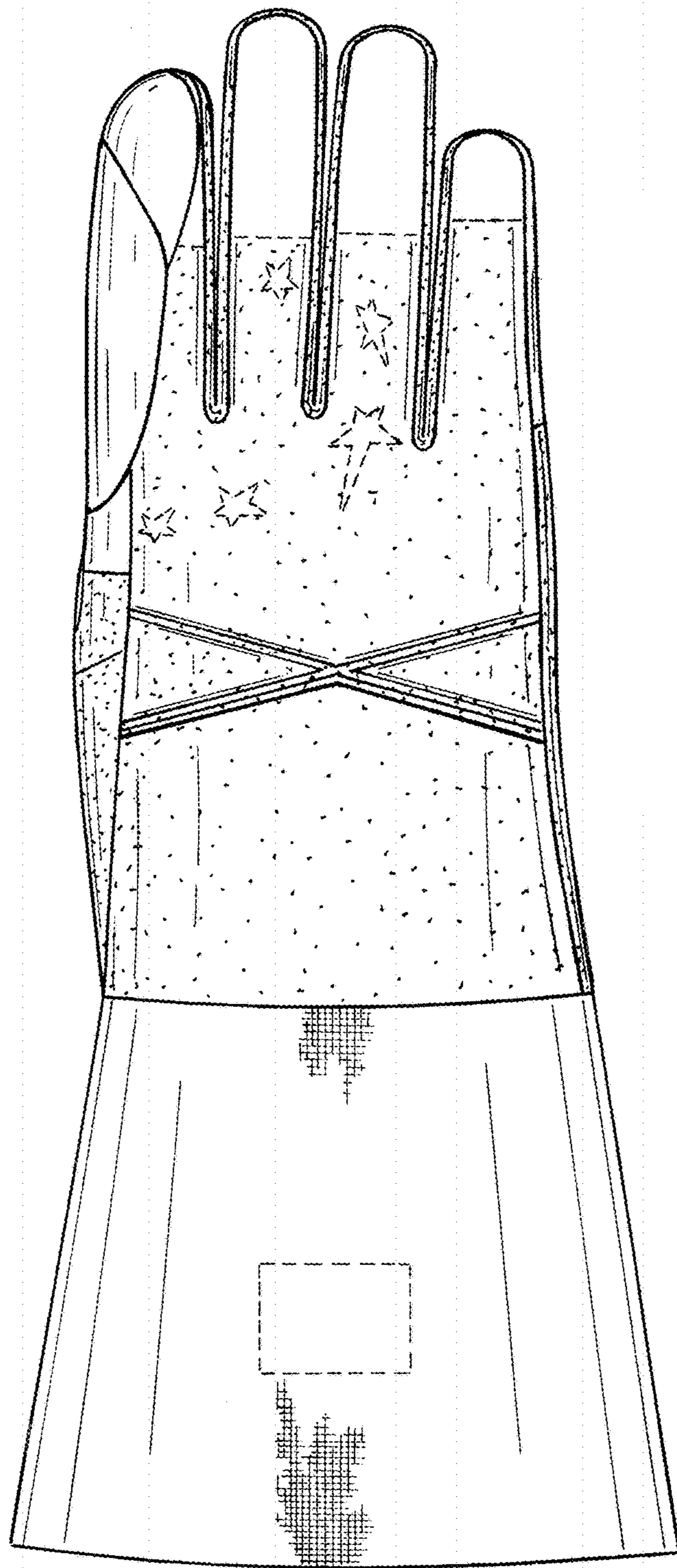

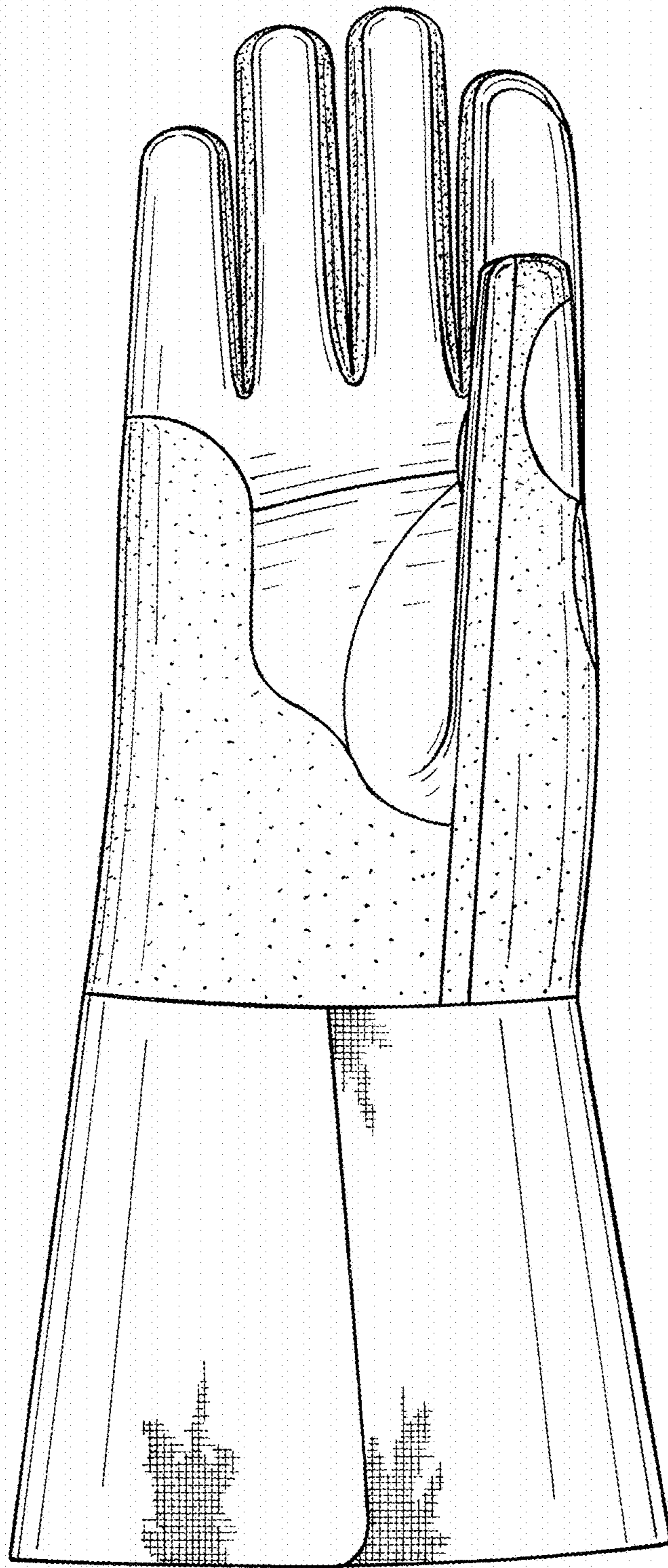

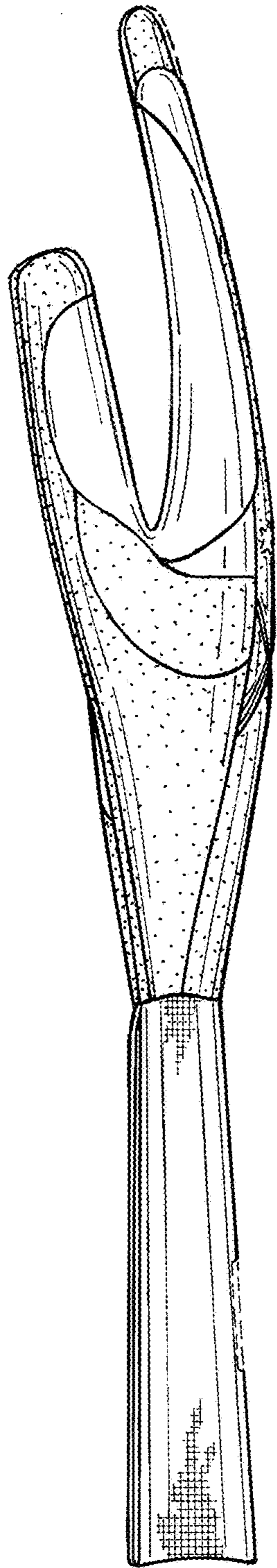

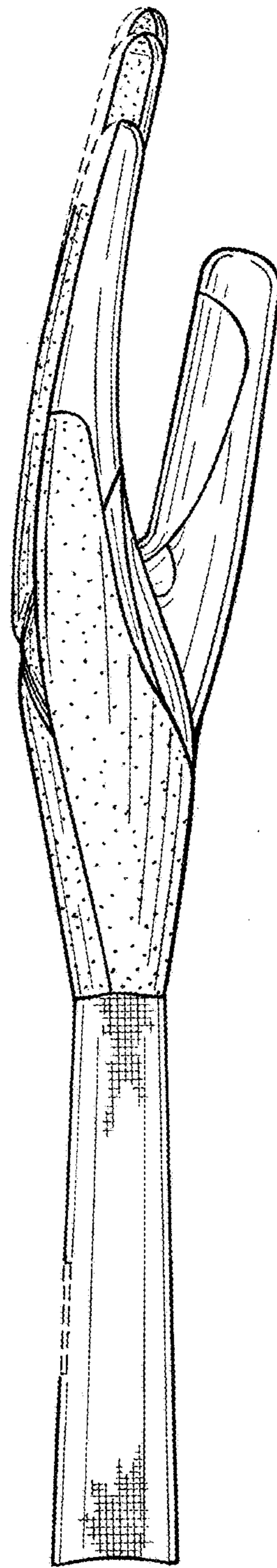

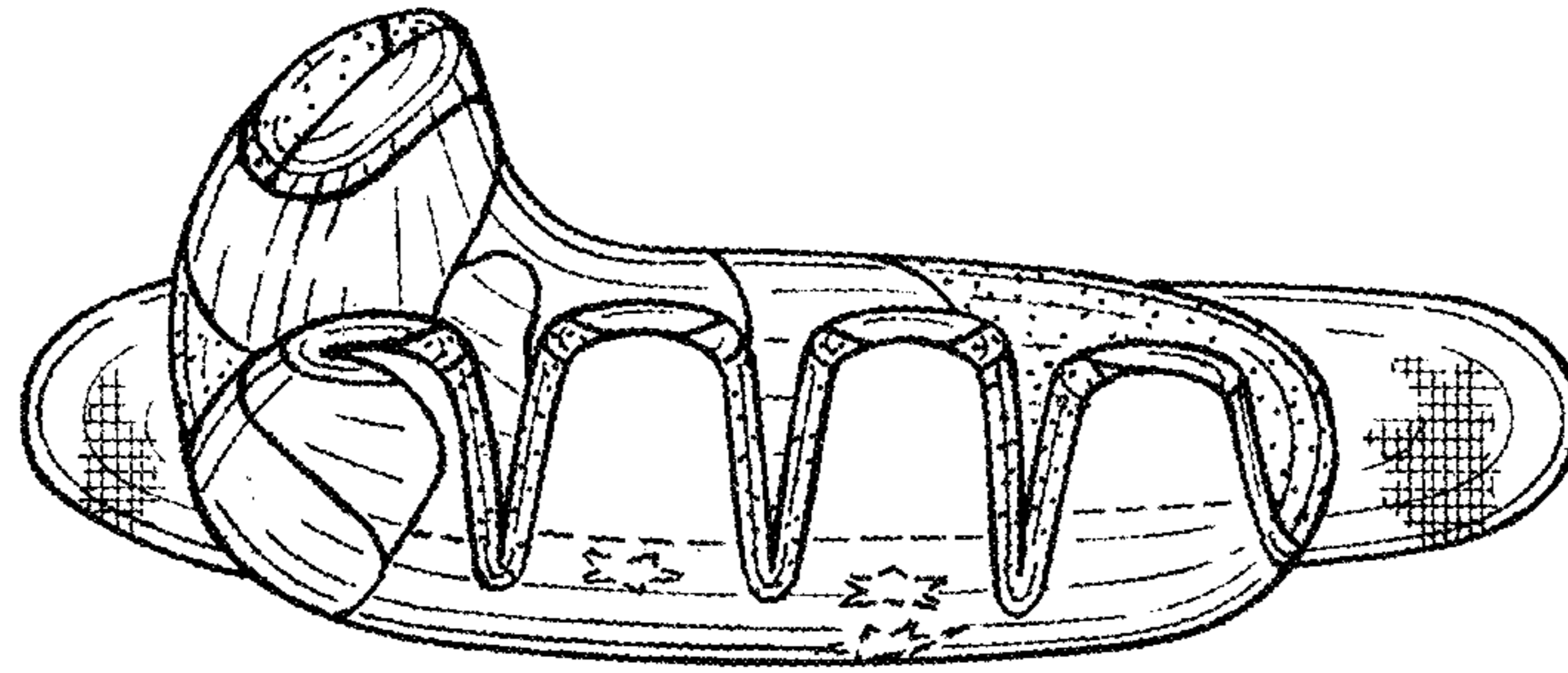

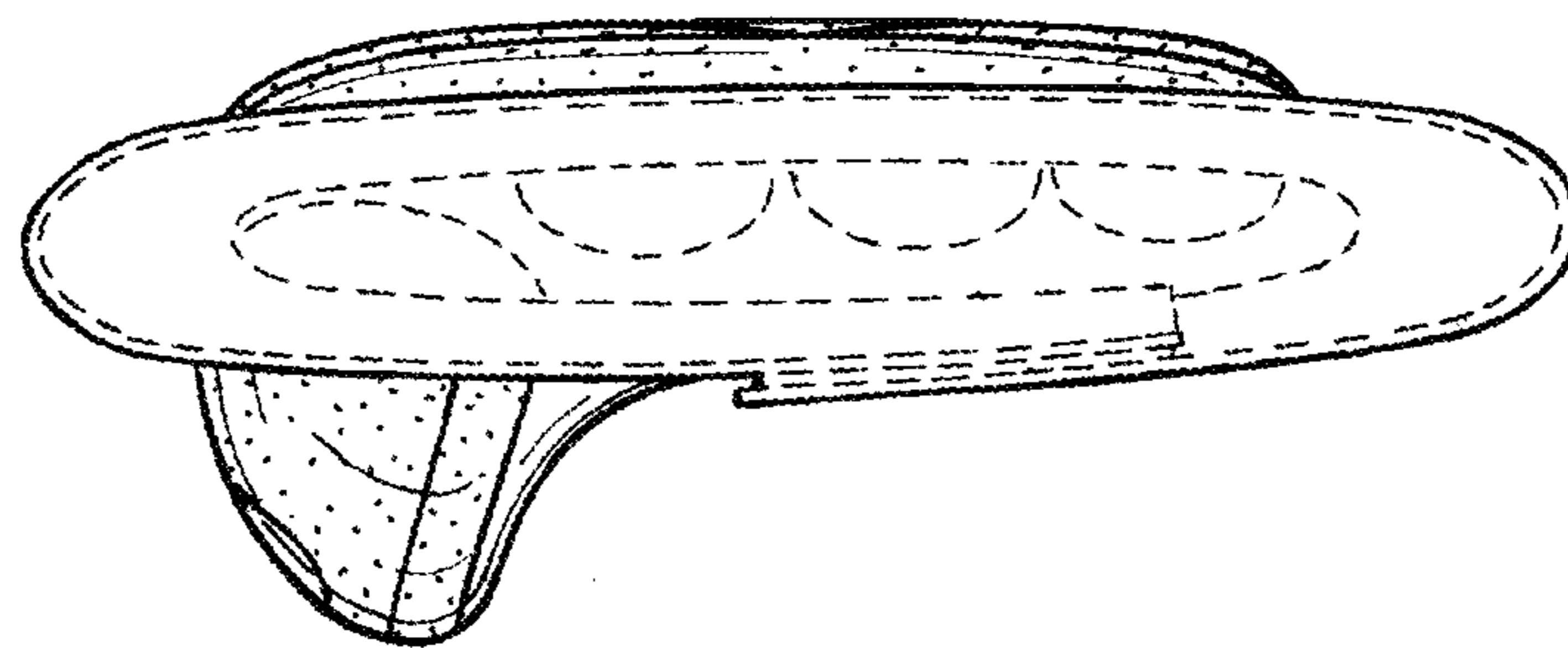

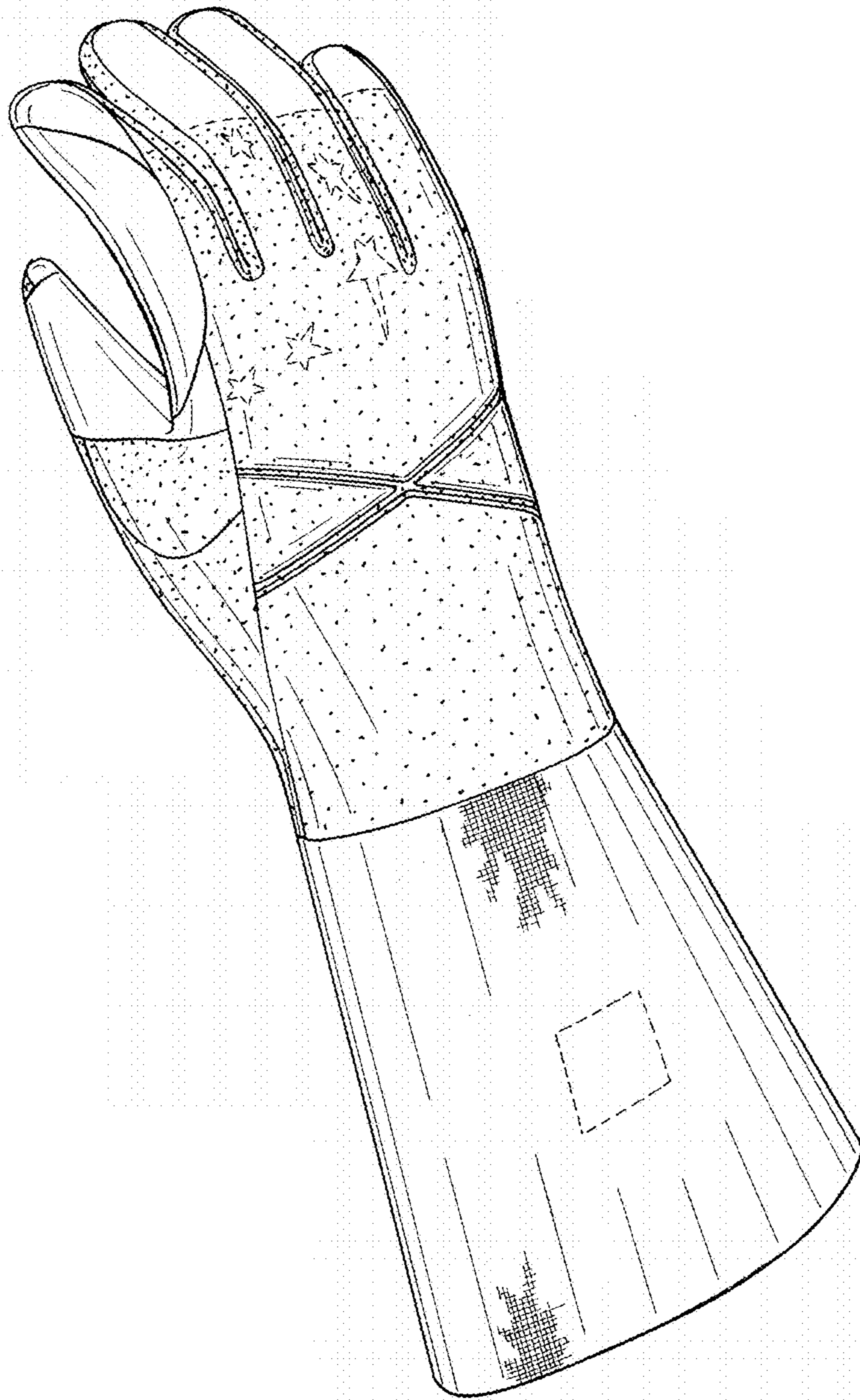
