DESCRIPTION

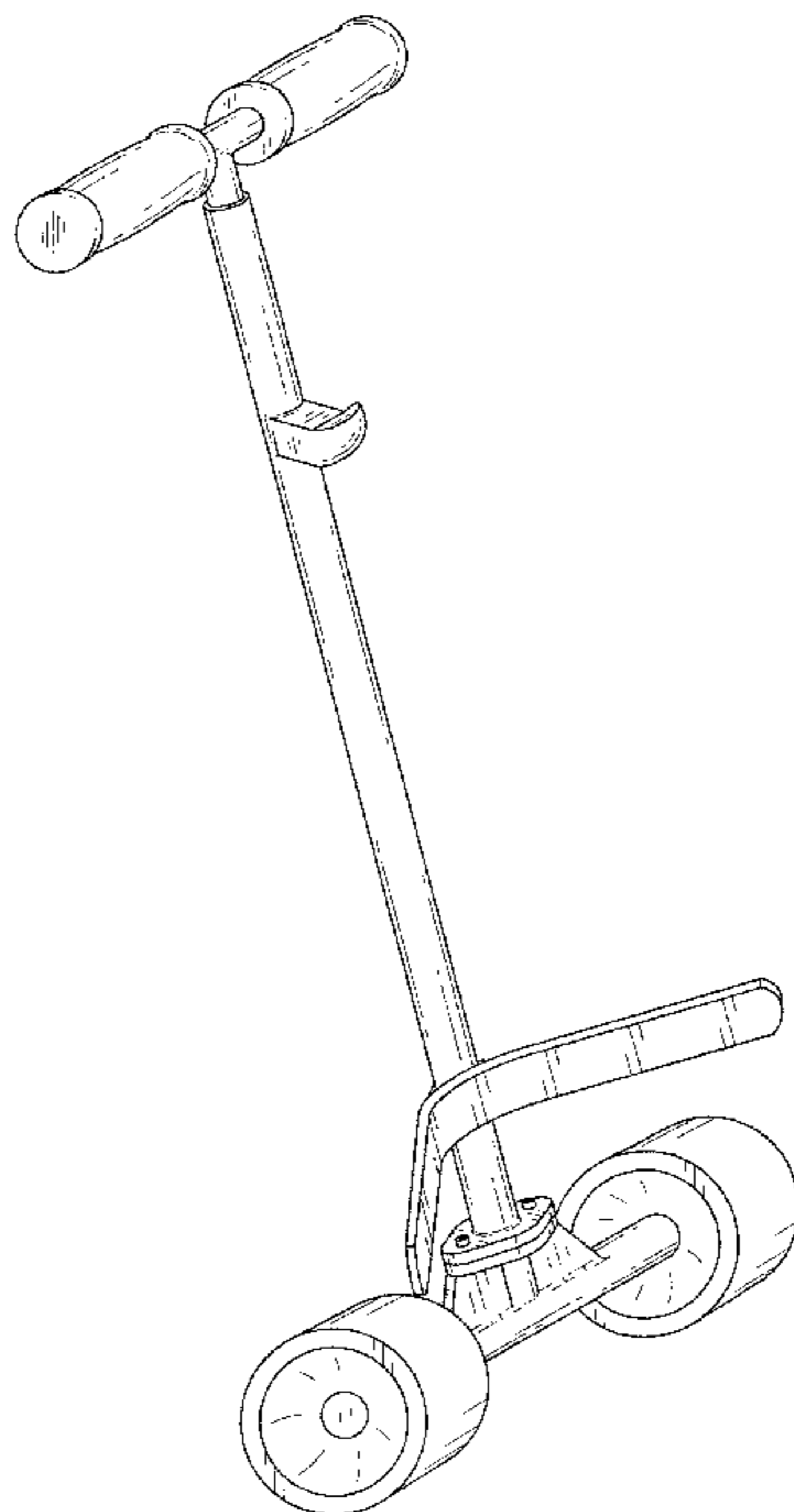
FIG. 1 is a perspective view of the top, left side, and front of a keg transporter, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a rear elevational view thereof; and, FIG. 8 is a perspective view of the top, left side, and rear thereof.

The broken lines in FIG. 8 show environmental structure that forms no part of the claimed design.

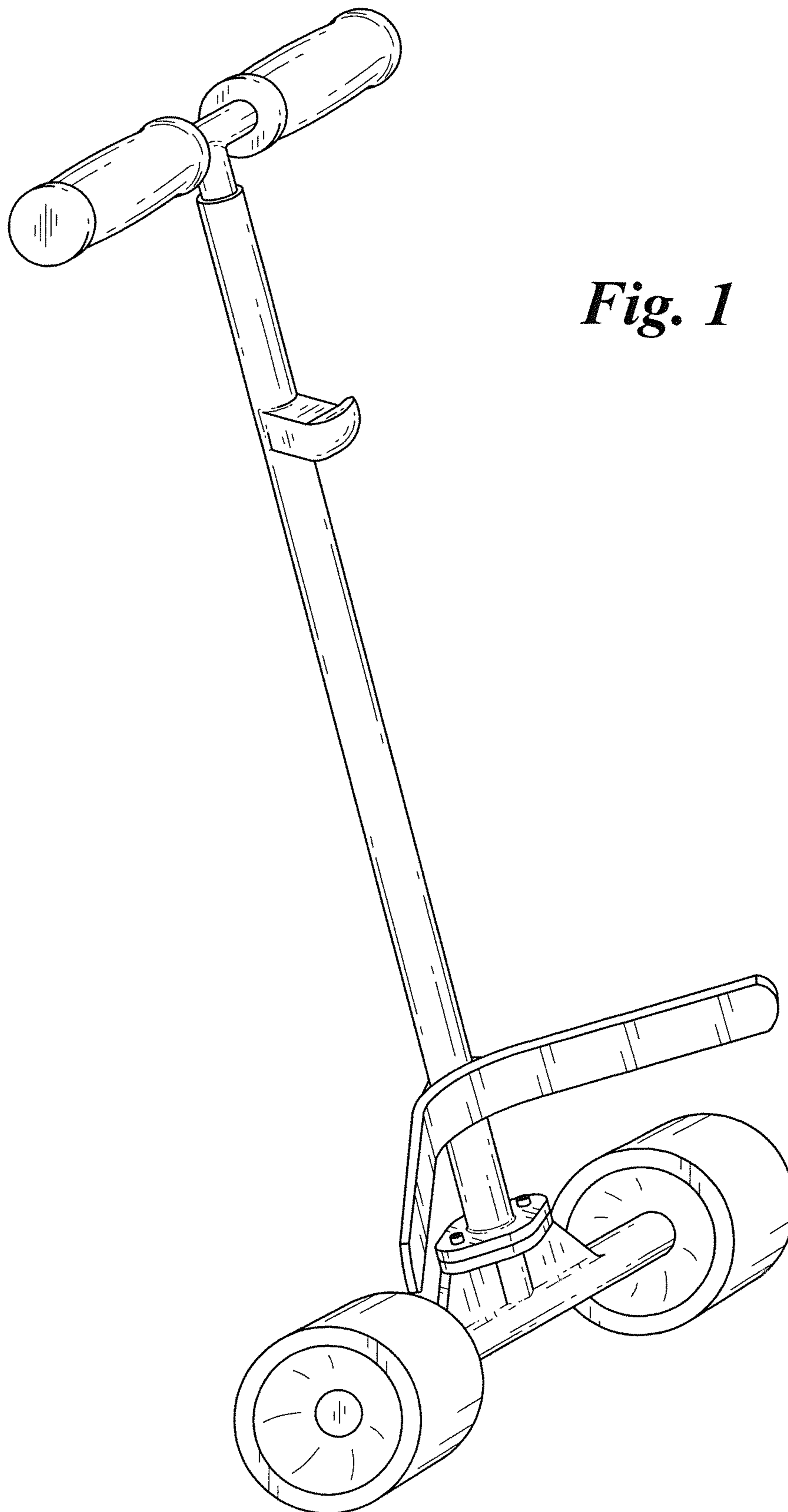

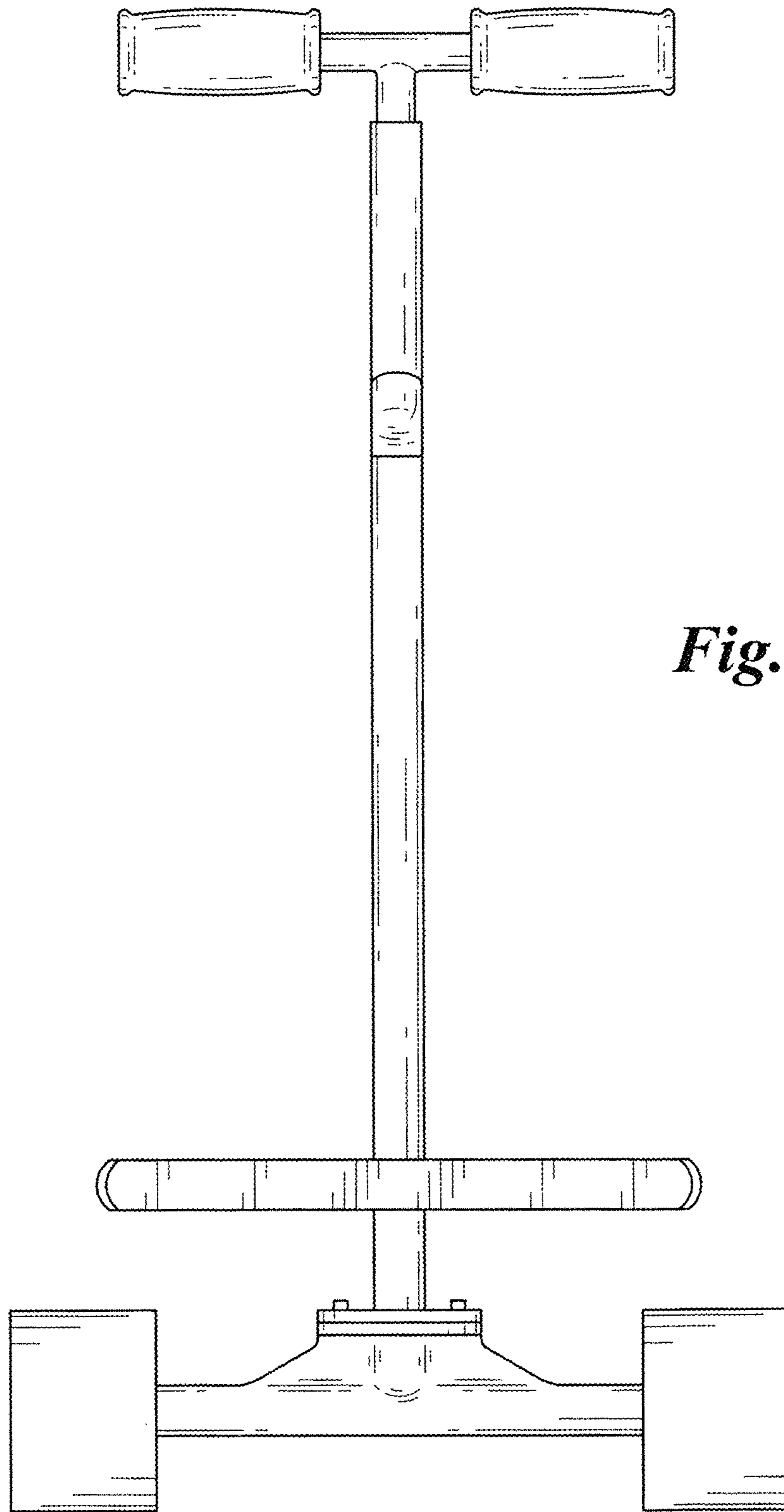

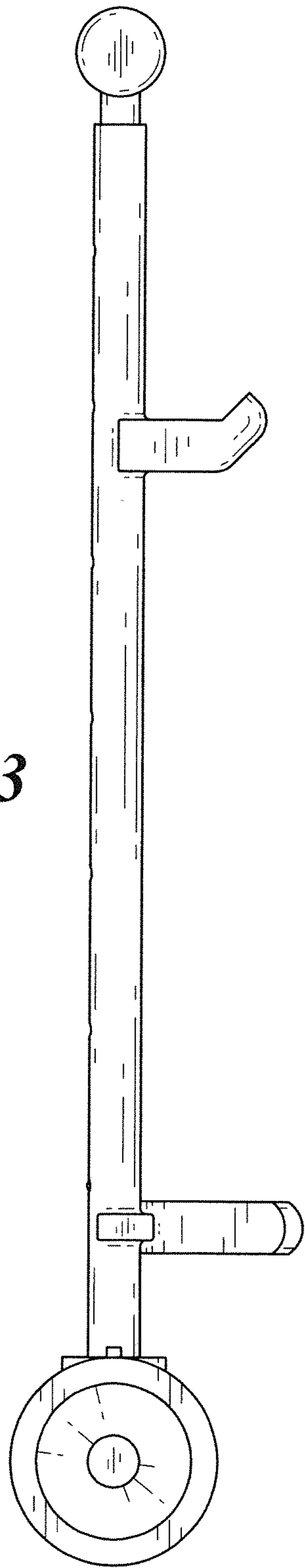

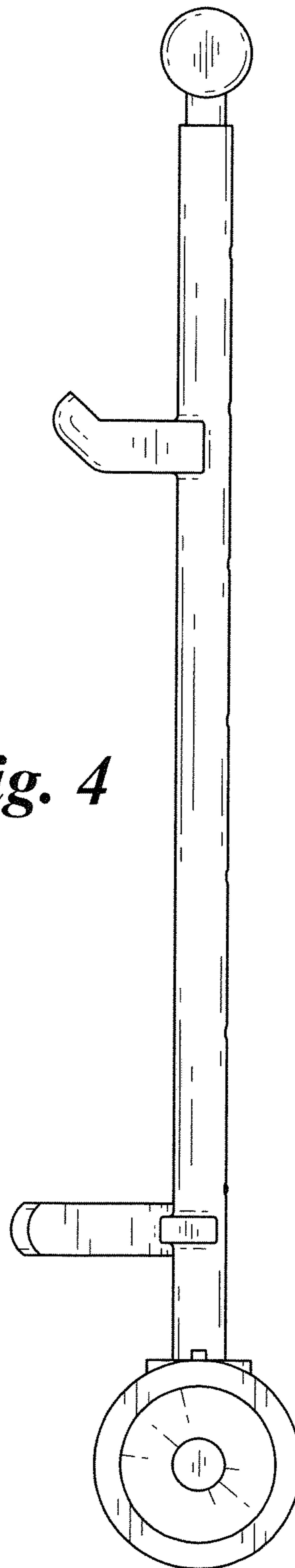

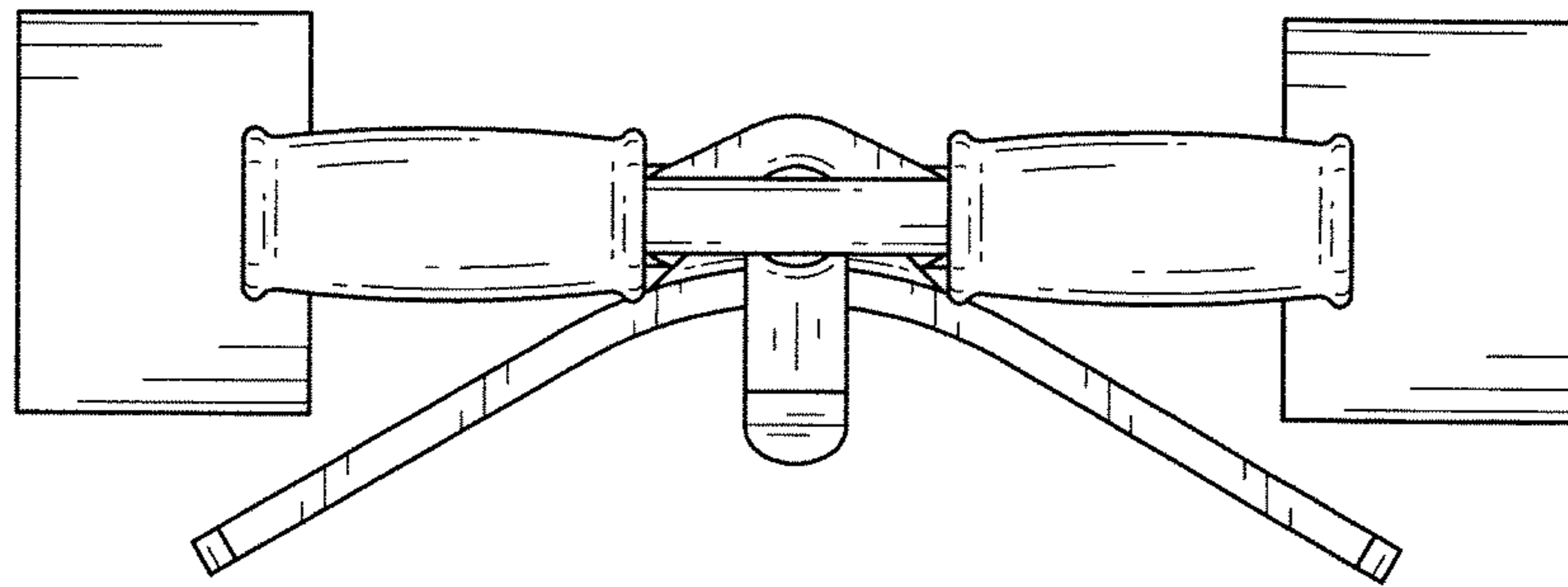

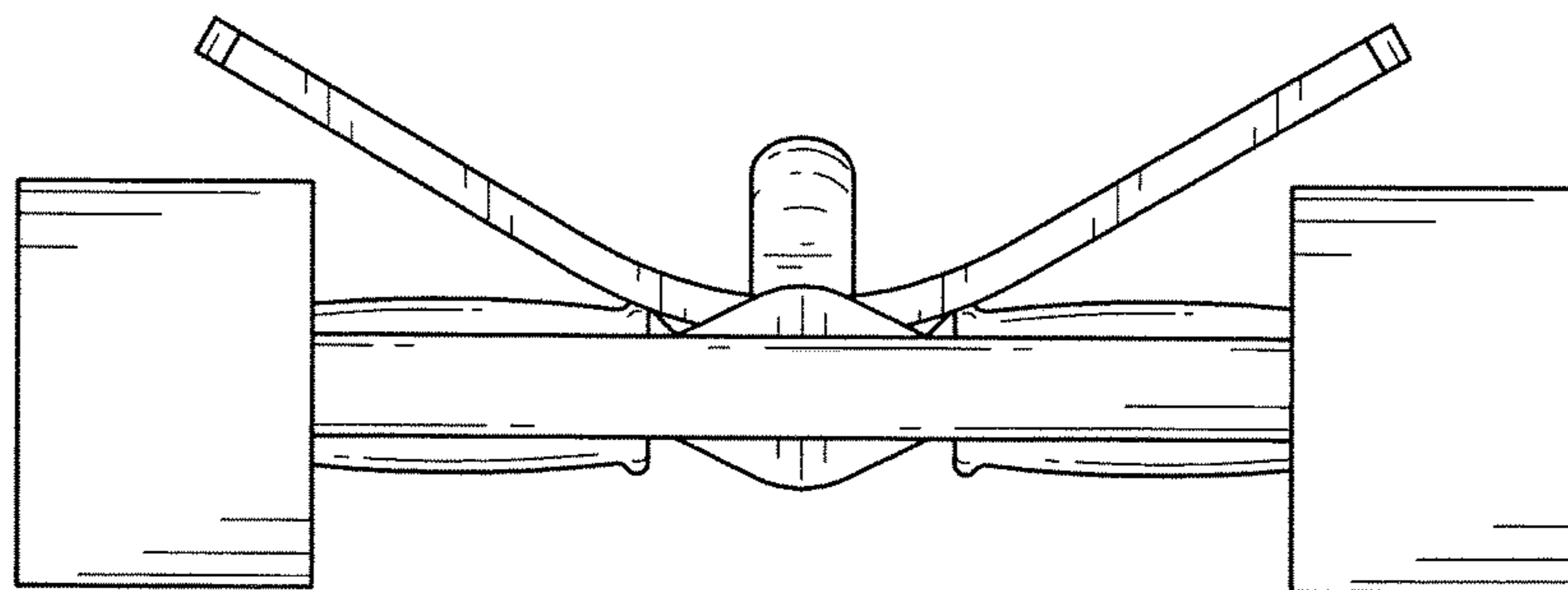

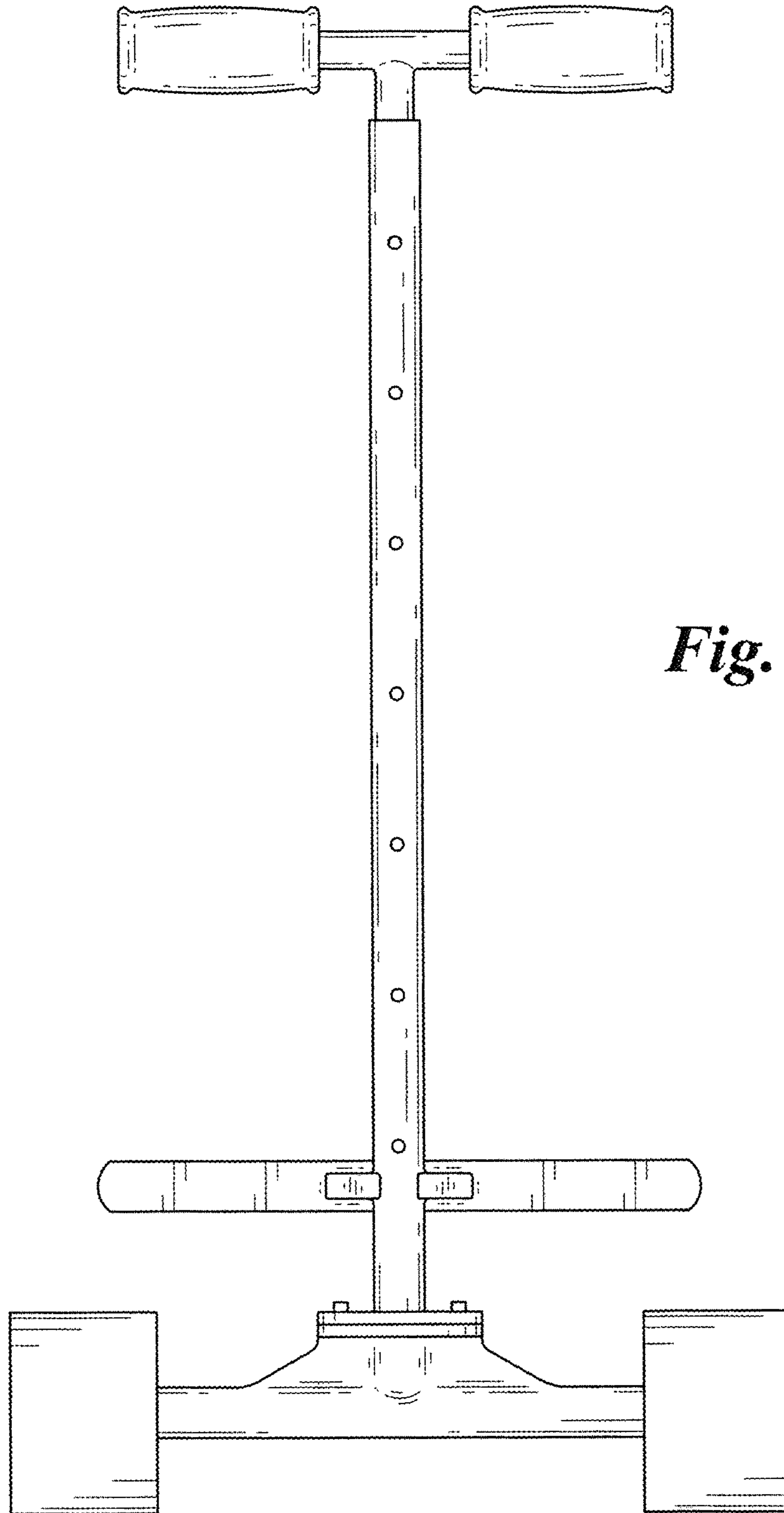

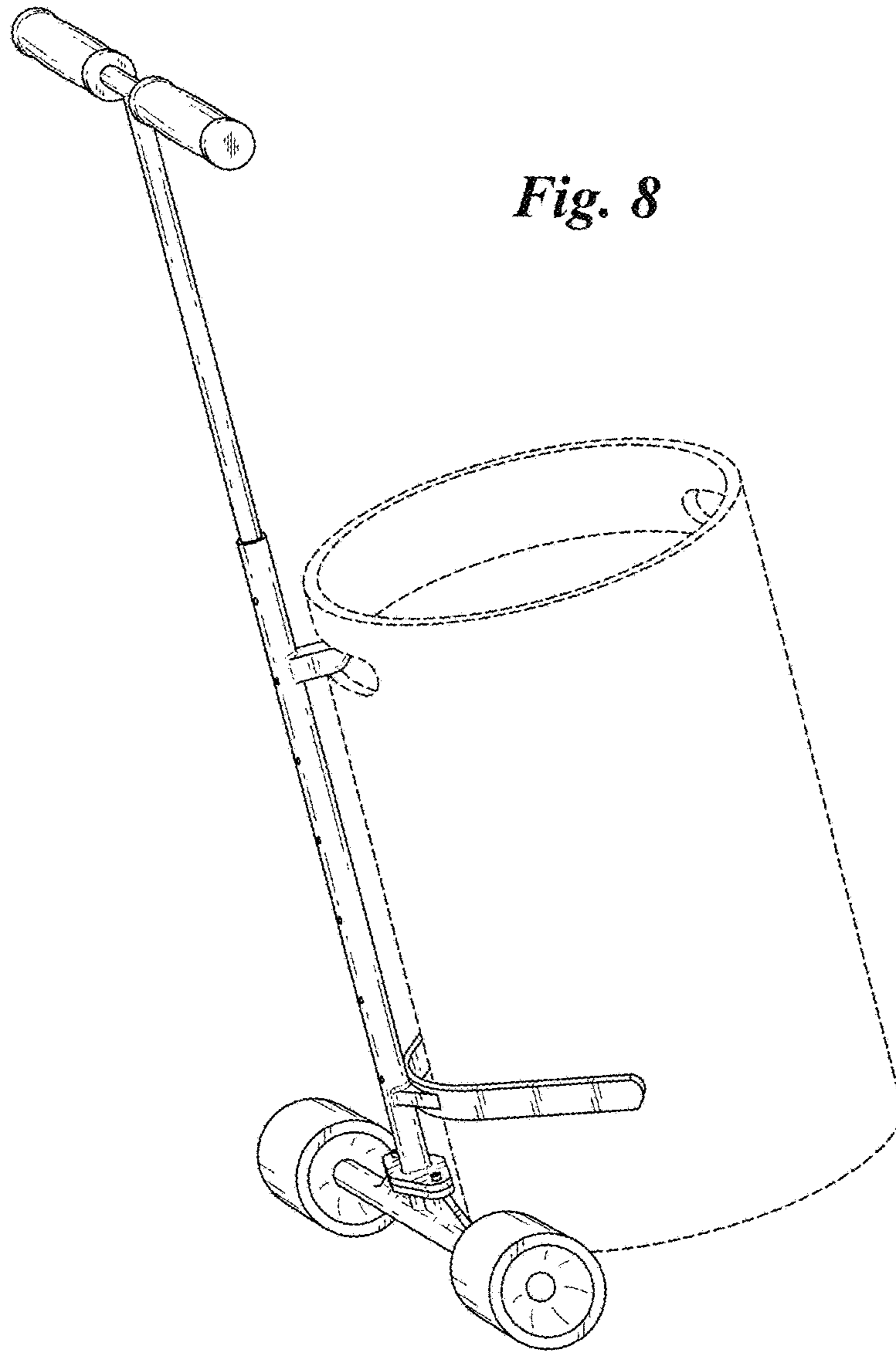
