(57) **CLAIM**

The ornamental design for a baby feet rosary, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a baby feet rosary showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines shown in the drawings are included for the purpose of illustrating portions of the baby feet rosary that form no part of the claimed design.

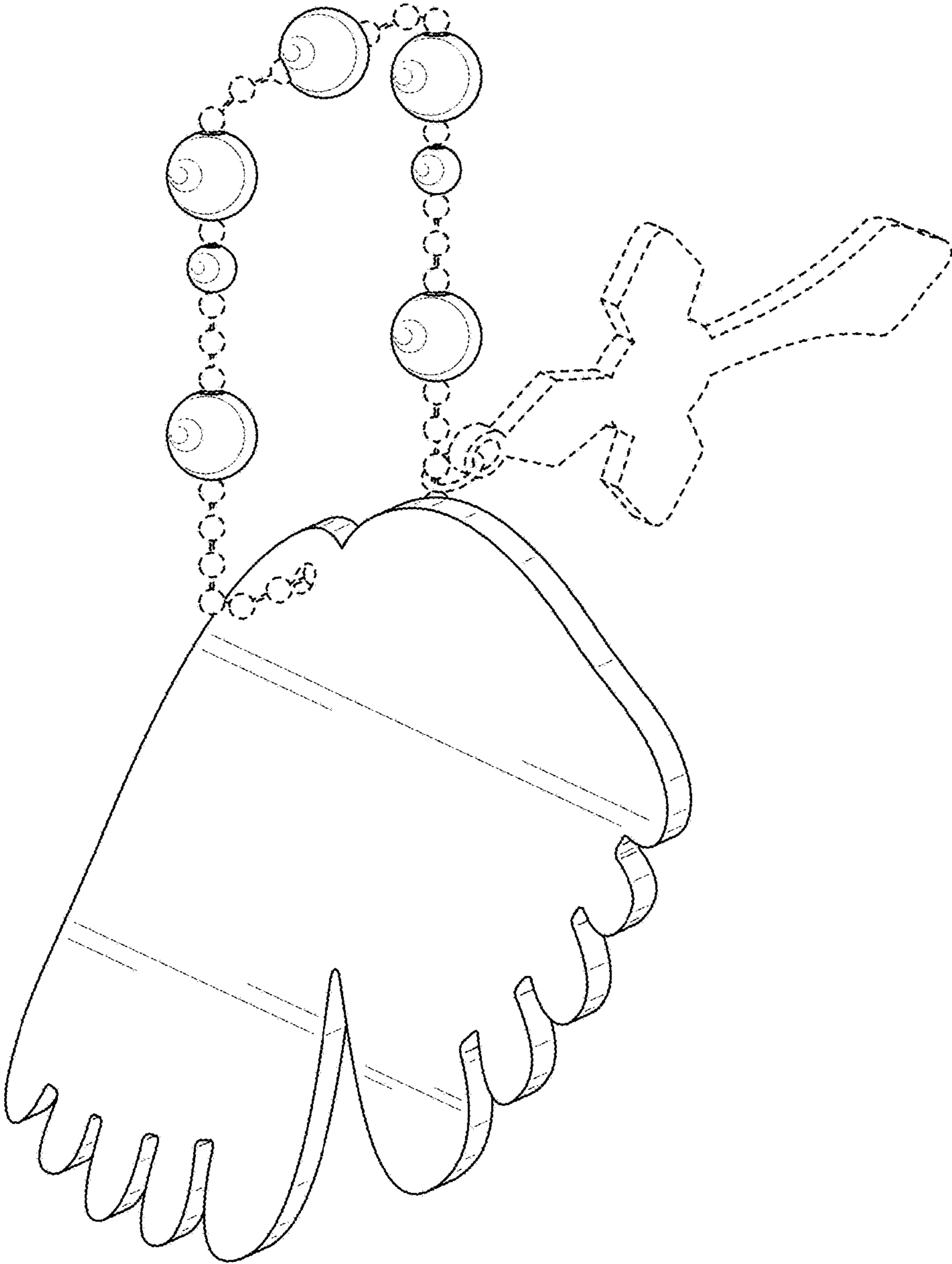

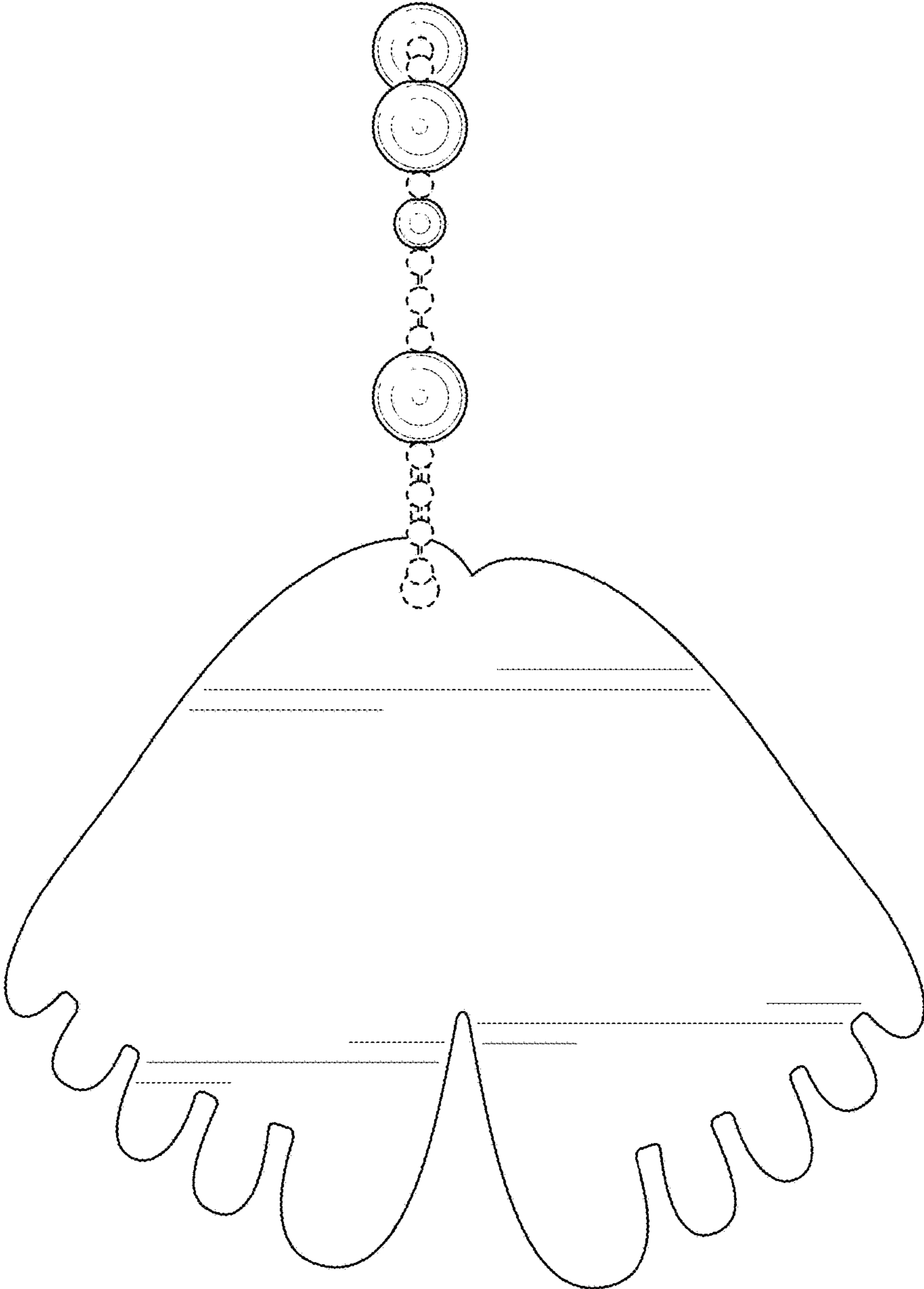

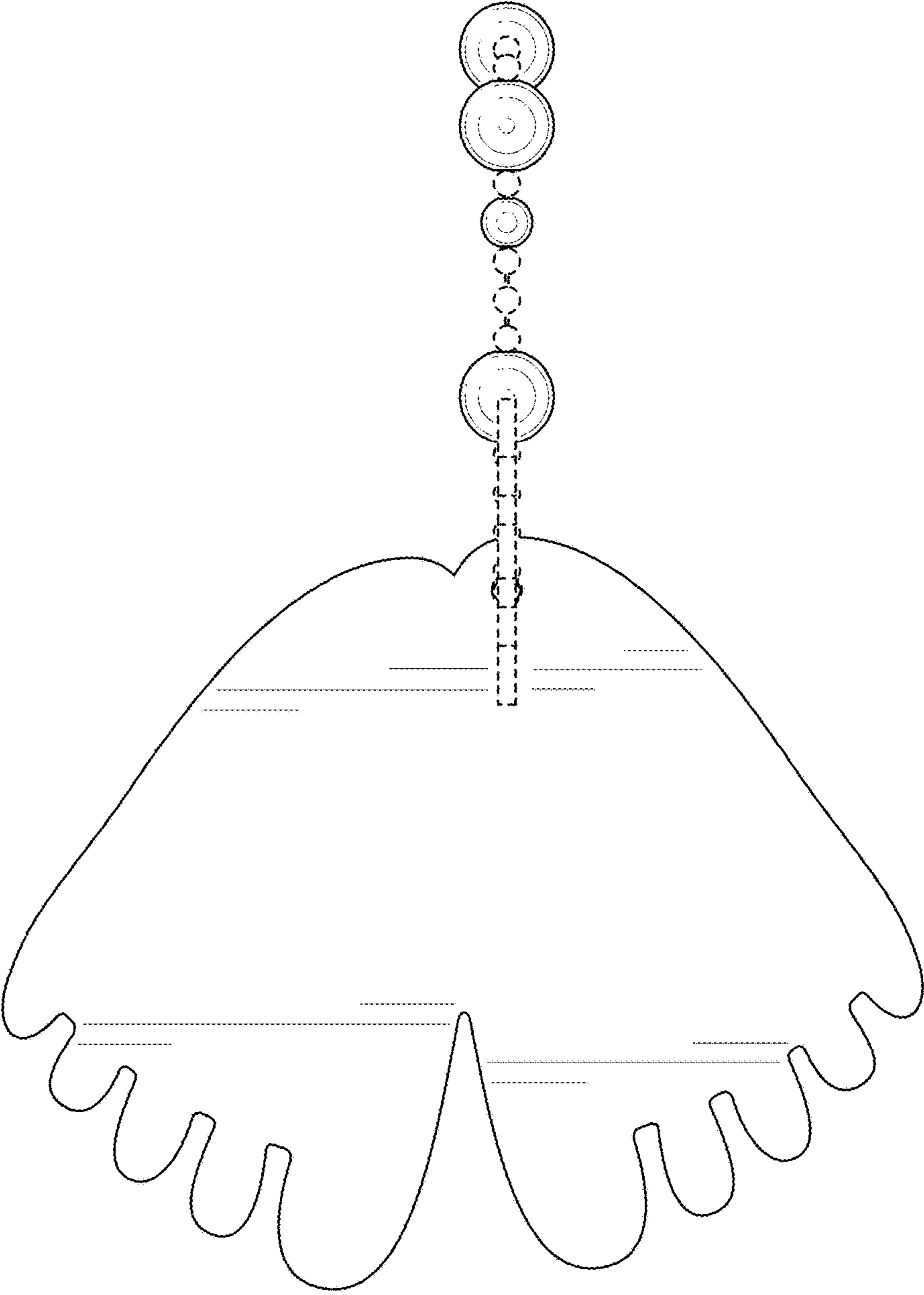

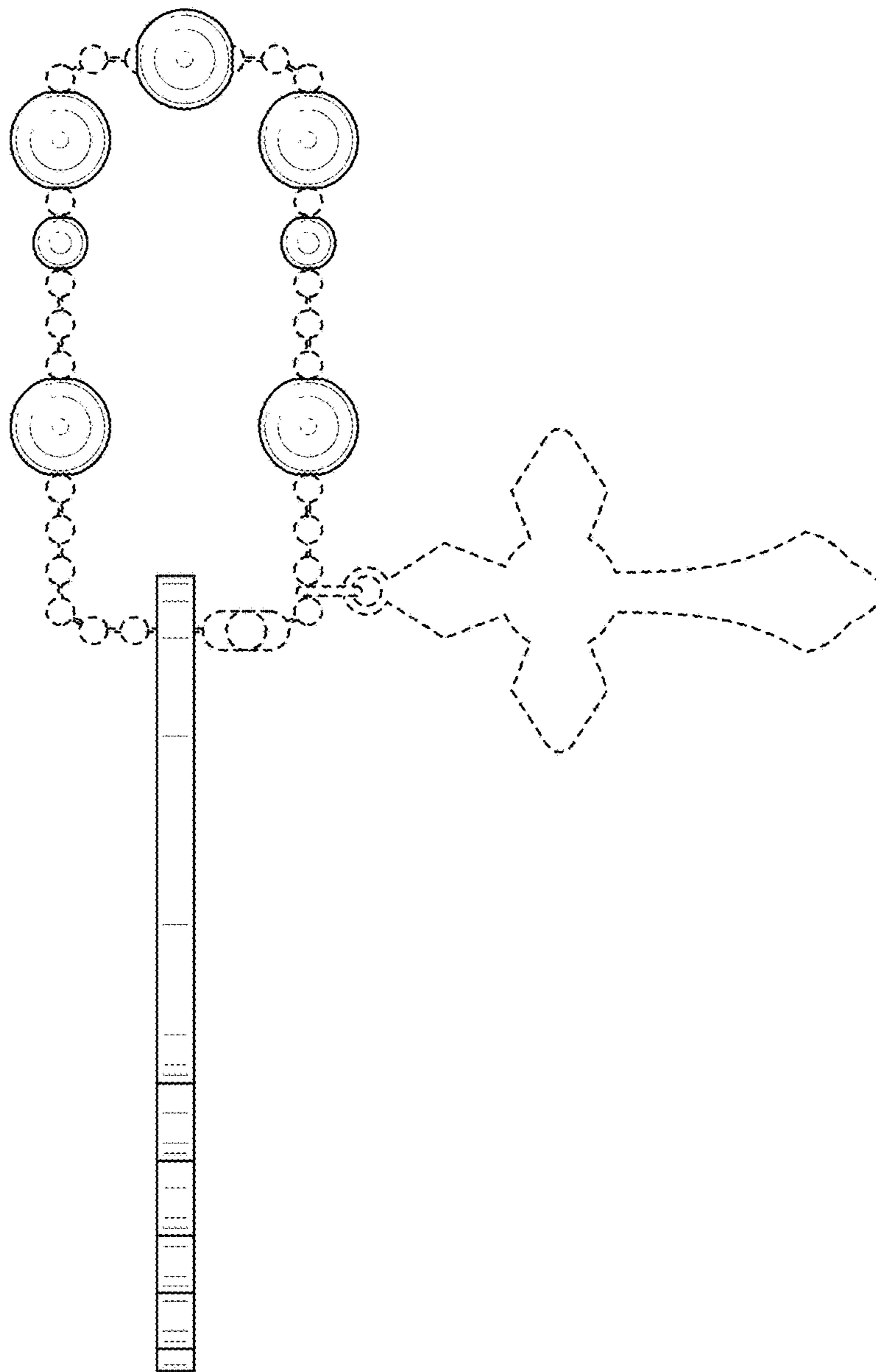

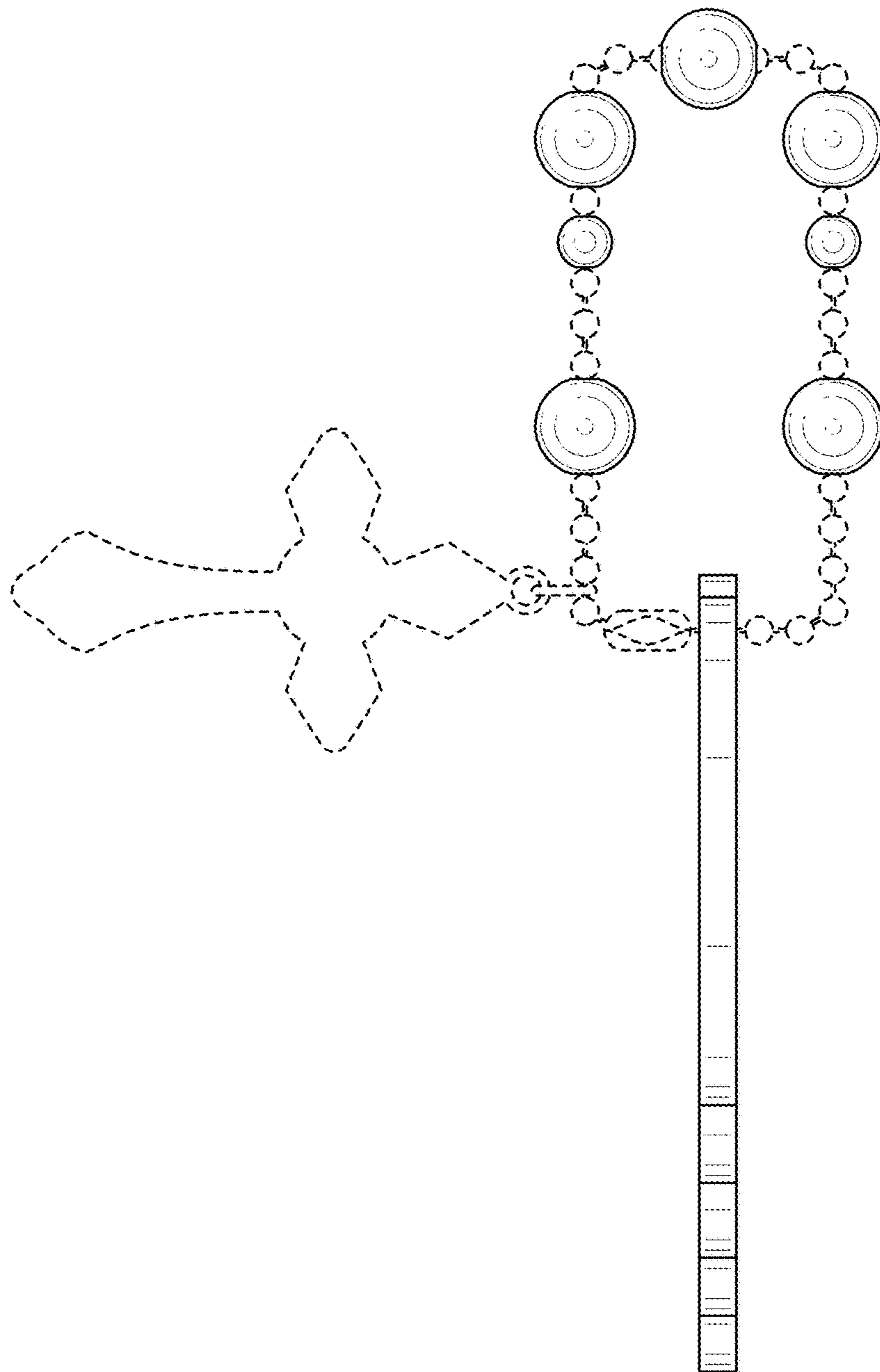

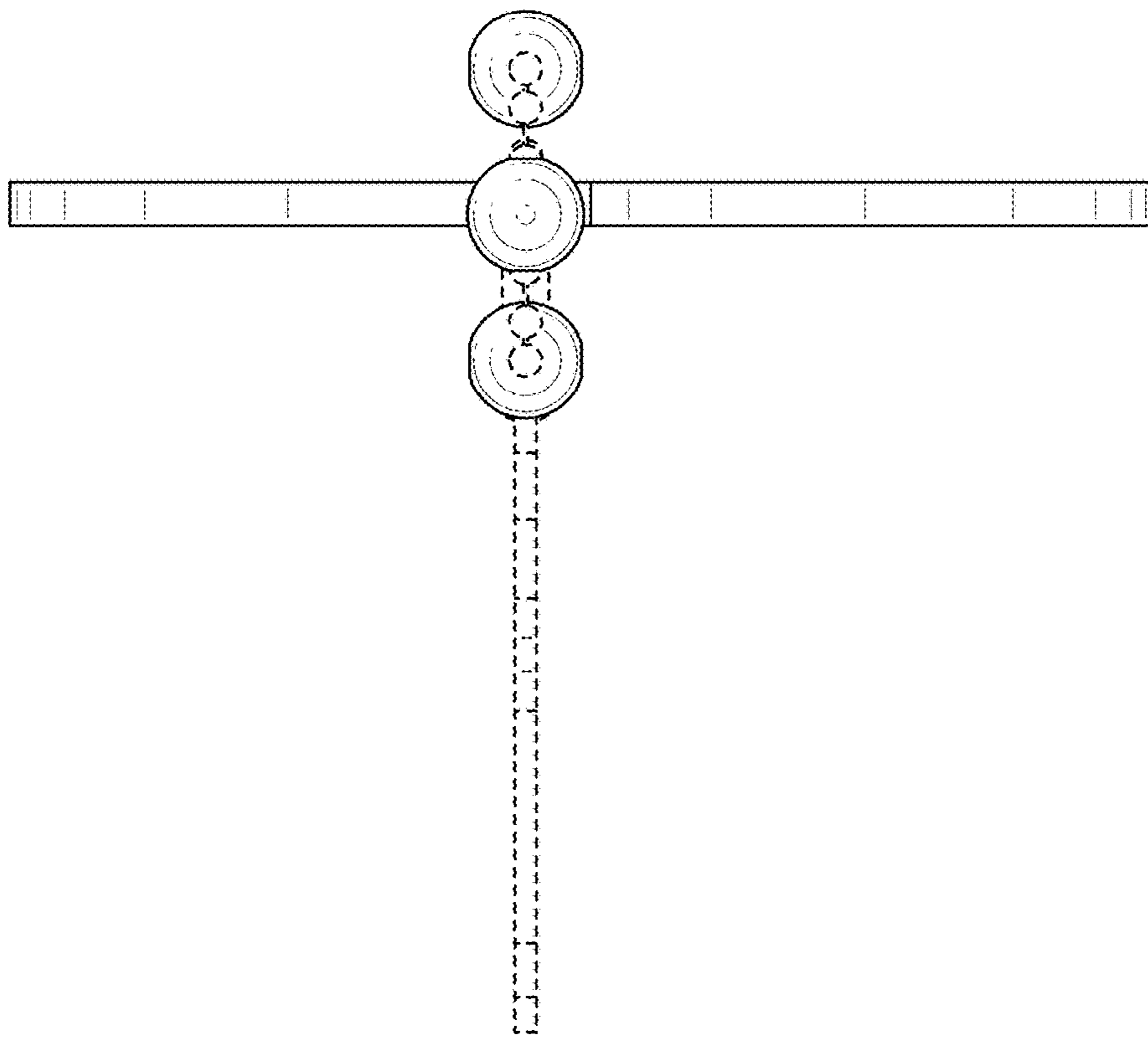

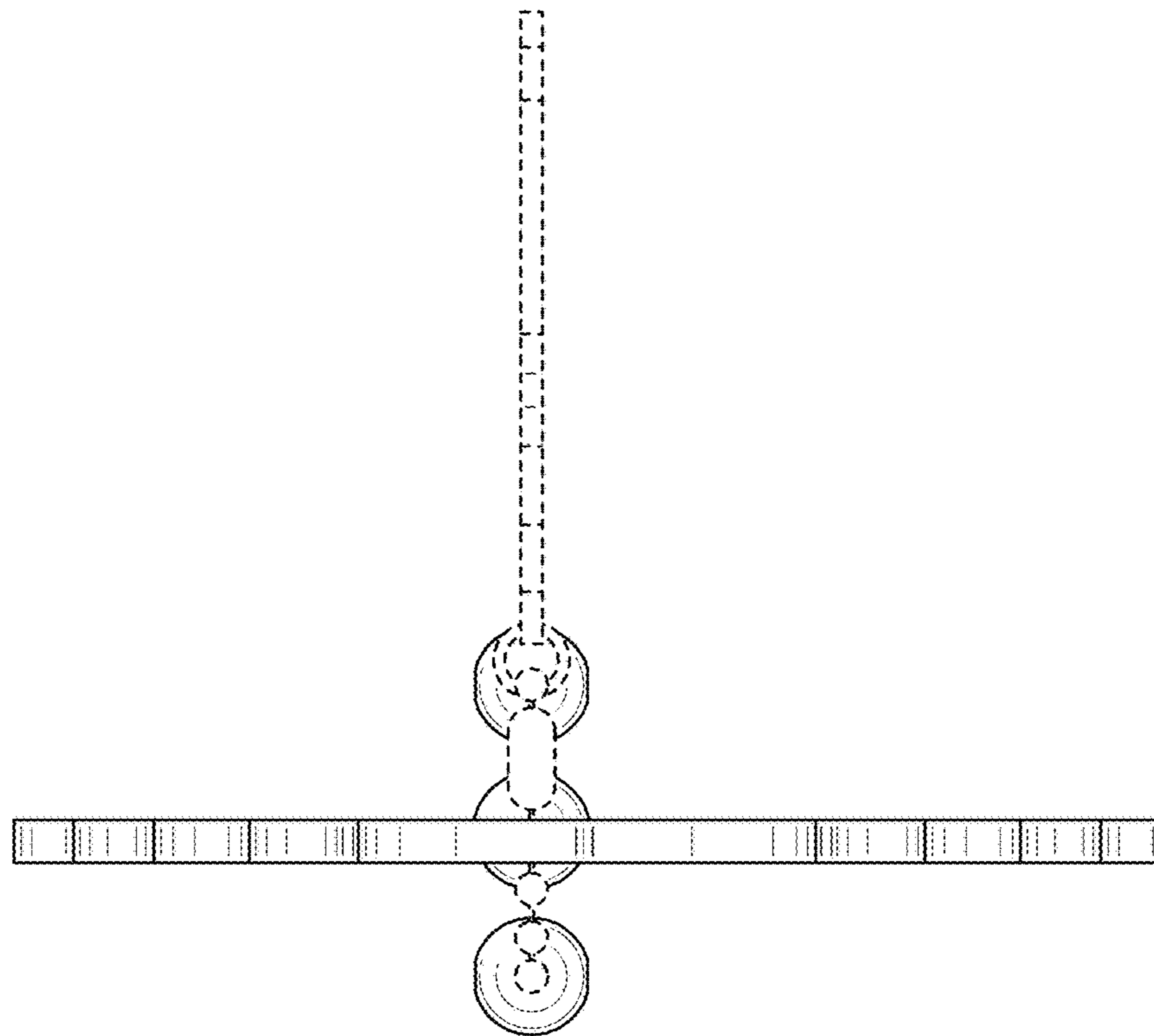
