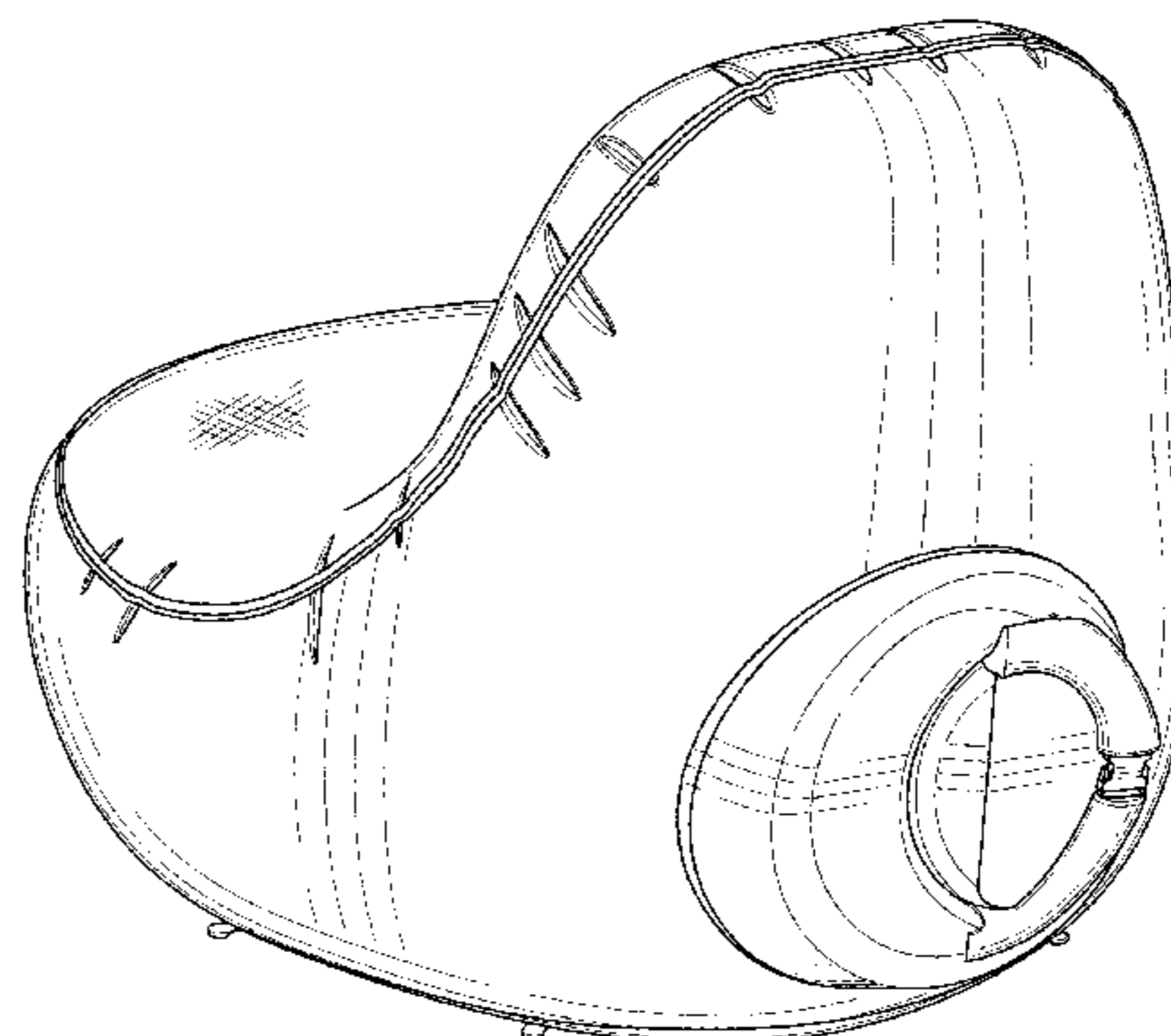
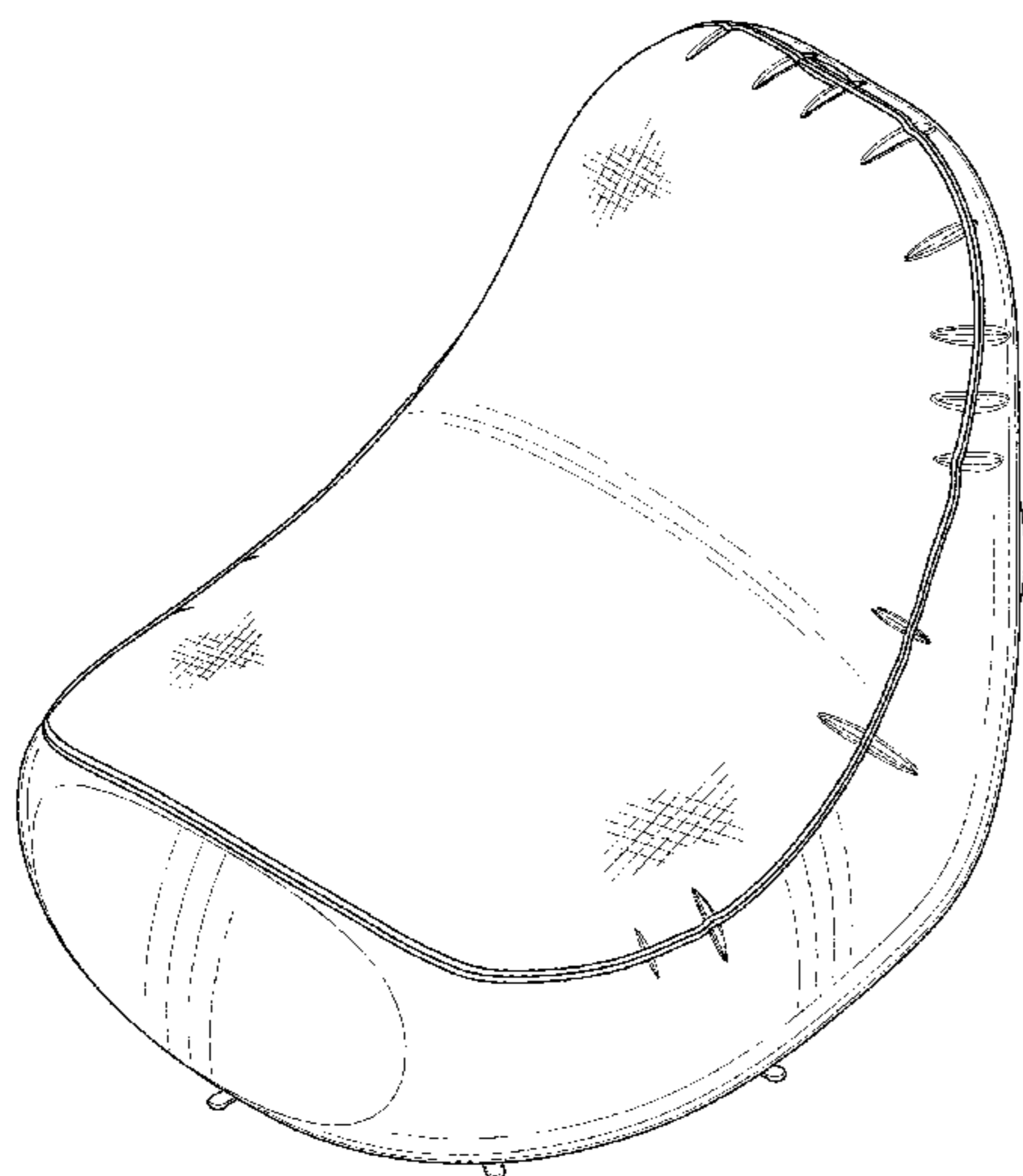
(57) **CLAIM**

The ornamental design for an inflatable chair and cover, as shown.

DESCRIPTION

FIG. 1 is a front isometric view of the inflatable chair and cover of the present invention;
 FIG. 2 is a back isometric view of the invention;
 FIG. 3 is a front view of the invention;
 FIG. 4 is a rear view of the invention;
 FIG. 5 is a side view of the invention, as seen from the left side of FIG. 3;
 FIG. 6 is a side view of the invention, as seen from the right side of FIG. 3;
 FIG. 7 is a top plan view of the invention;
 FIG. 8 is another isometric view of the invention having the cover made of suede; and,
 FIG. 9 is another isometric view of the invention having the cover made of fur.
 The hash markings in the figures are used to represent features that can have a fabric surface, including a material of woven or braided fibers such as cotton.

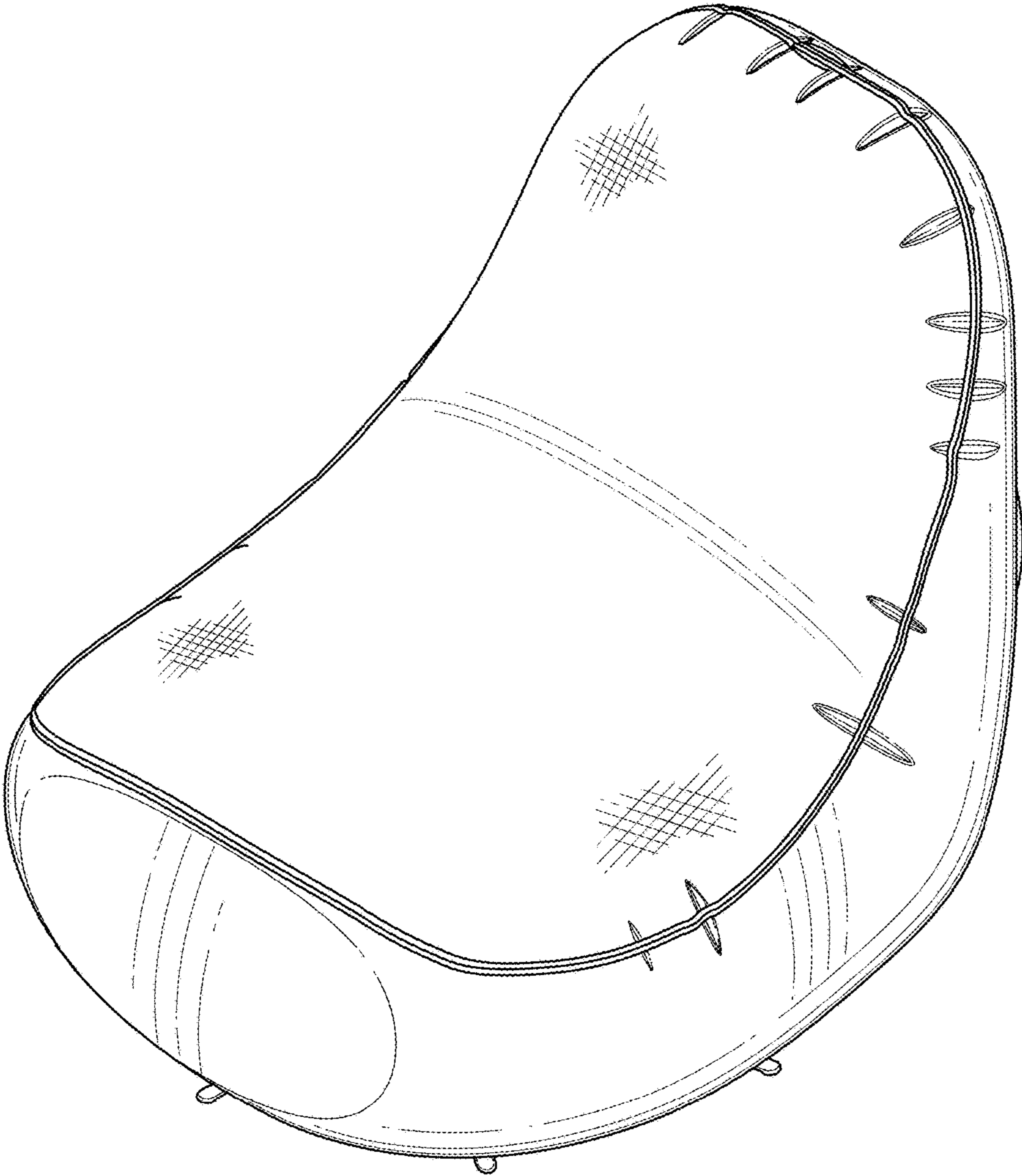

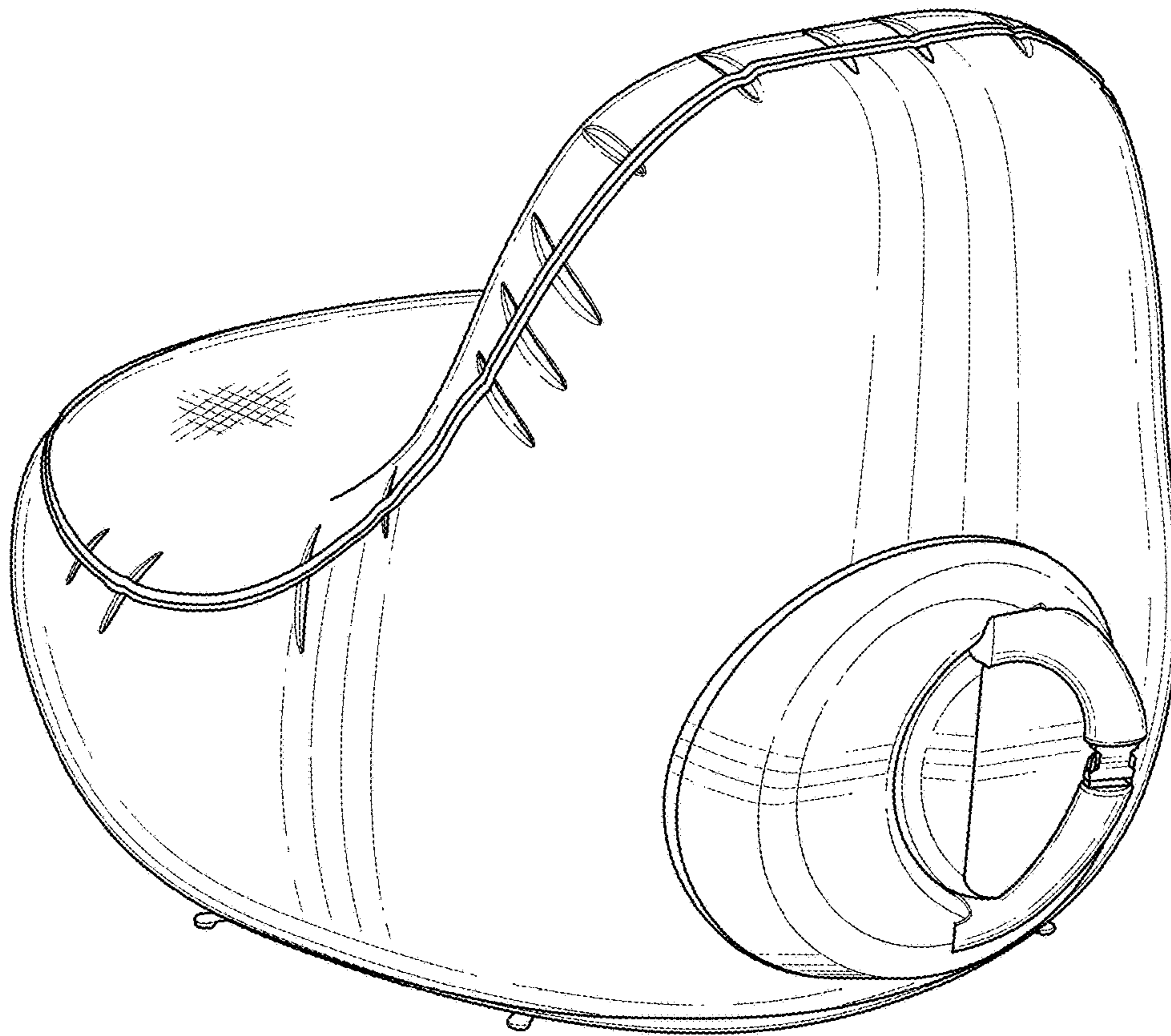

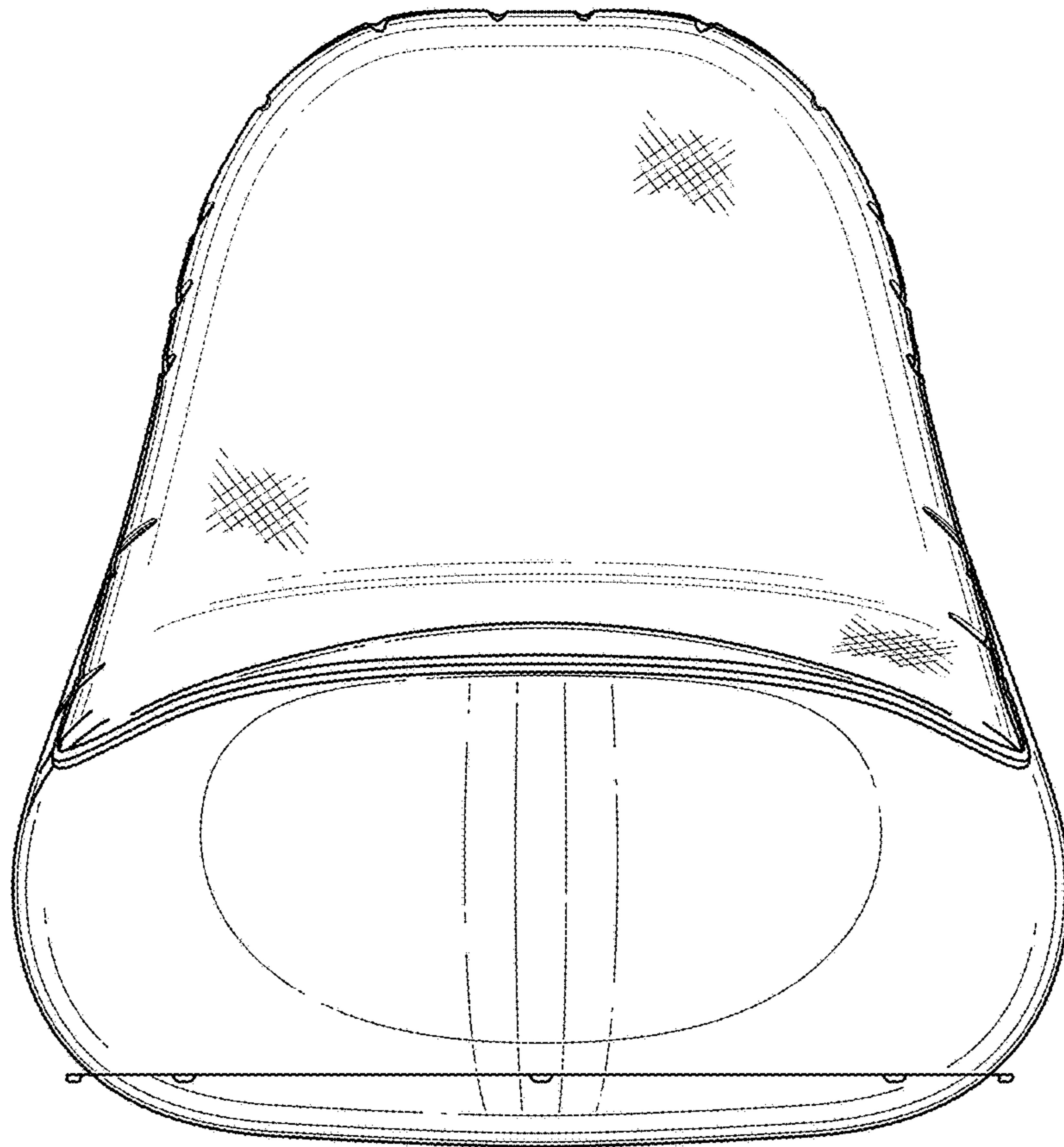

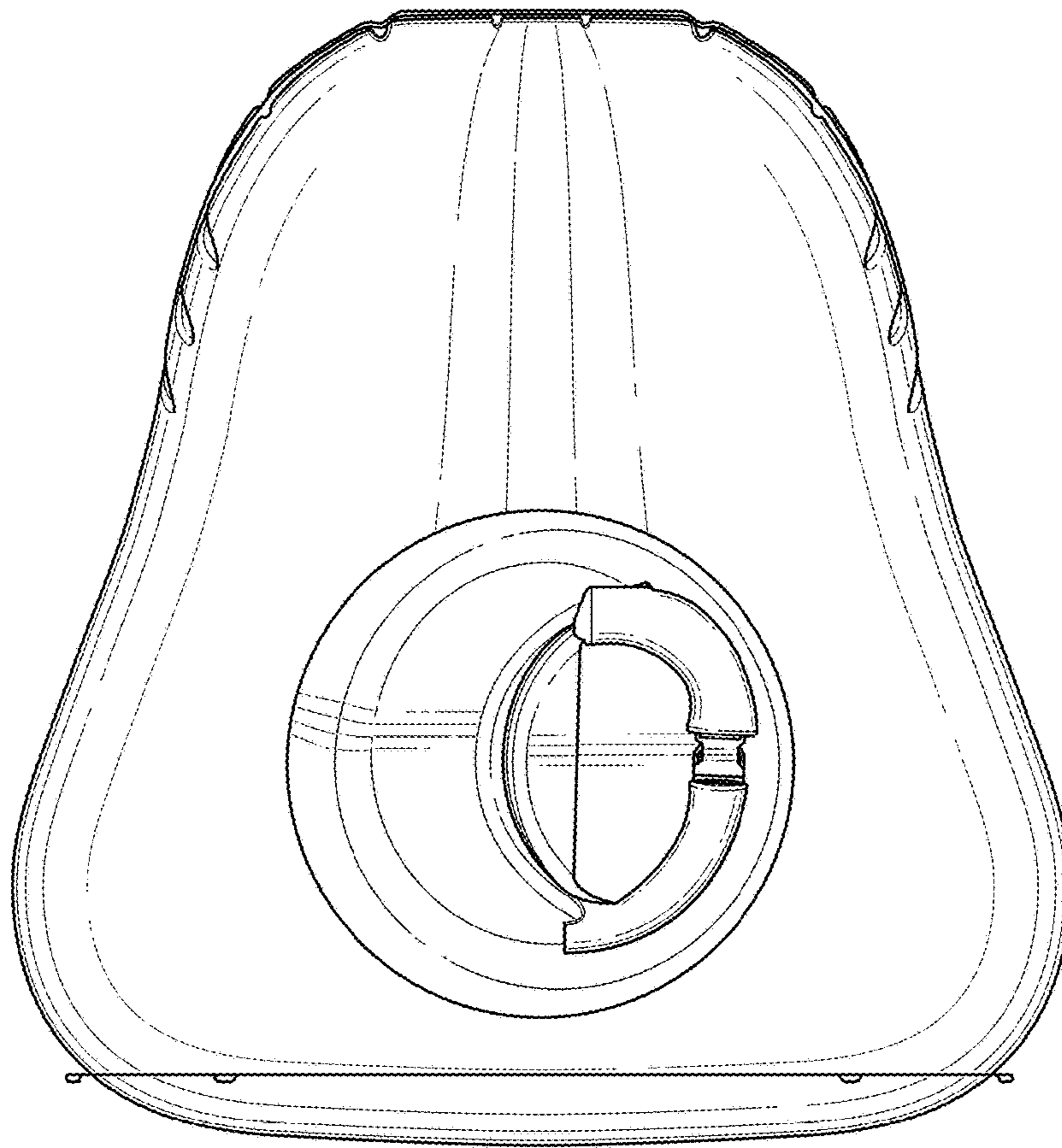

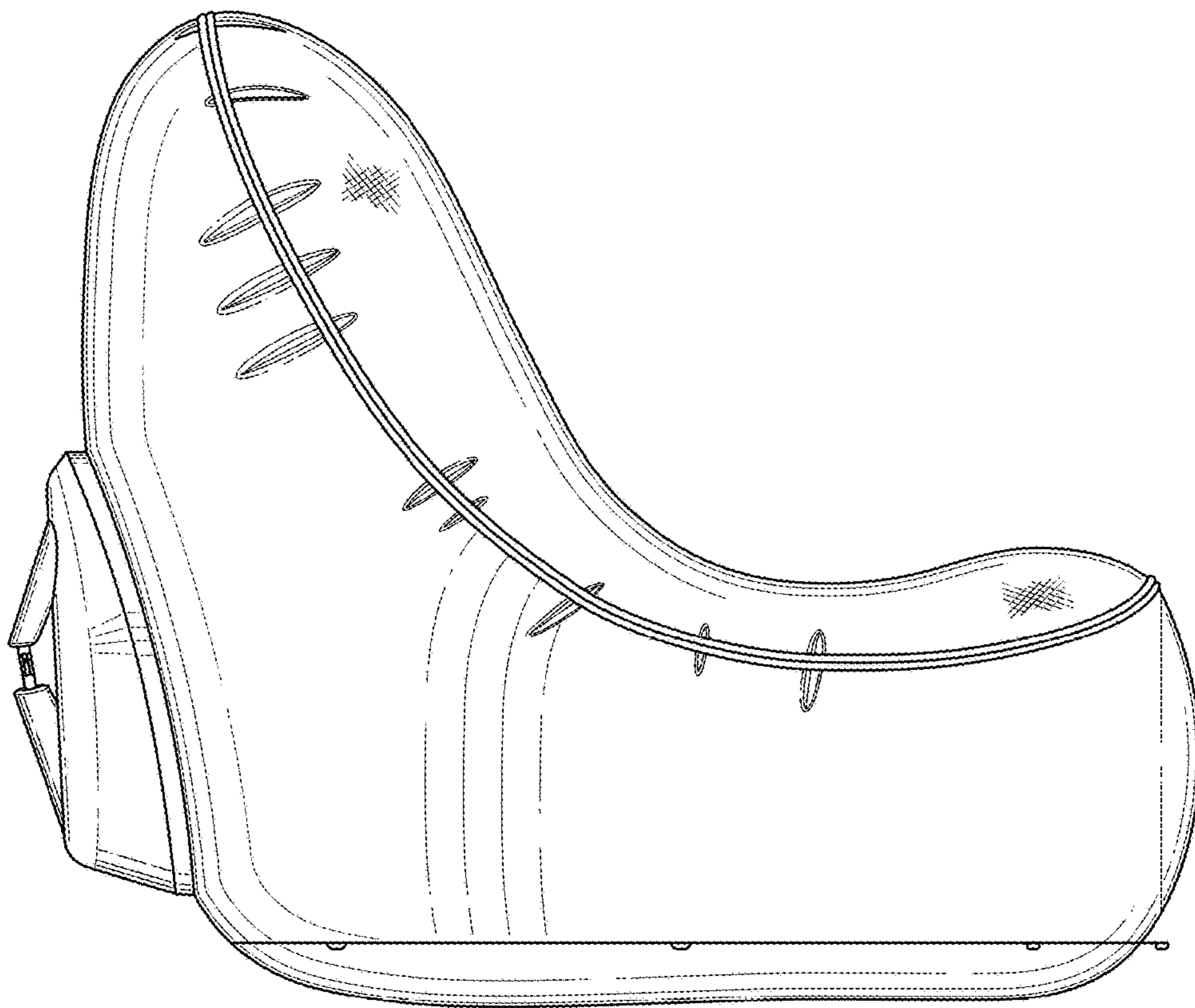

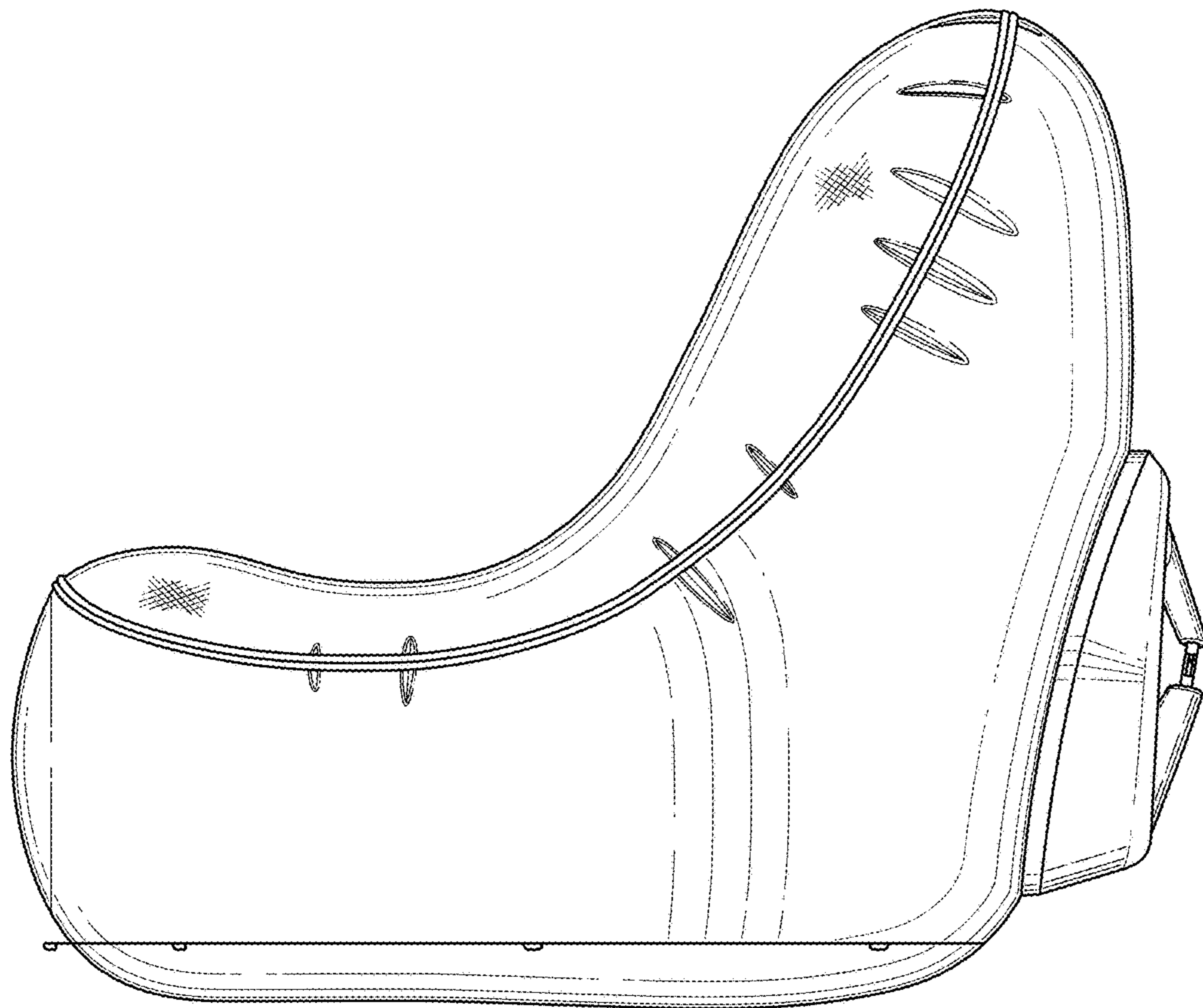

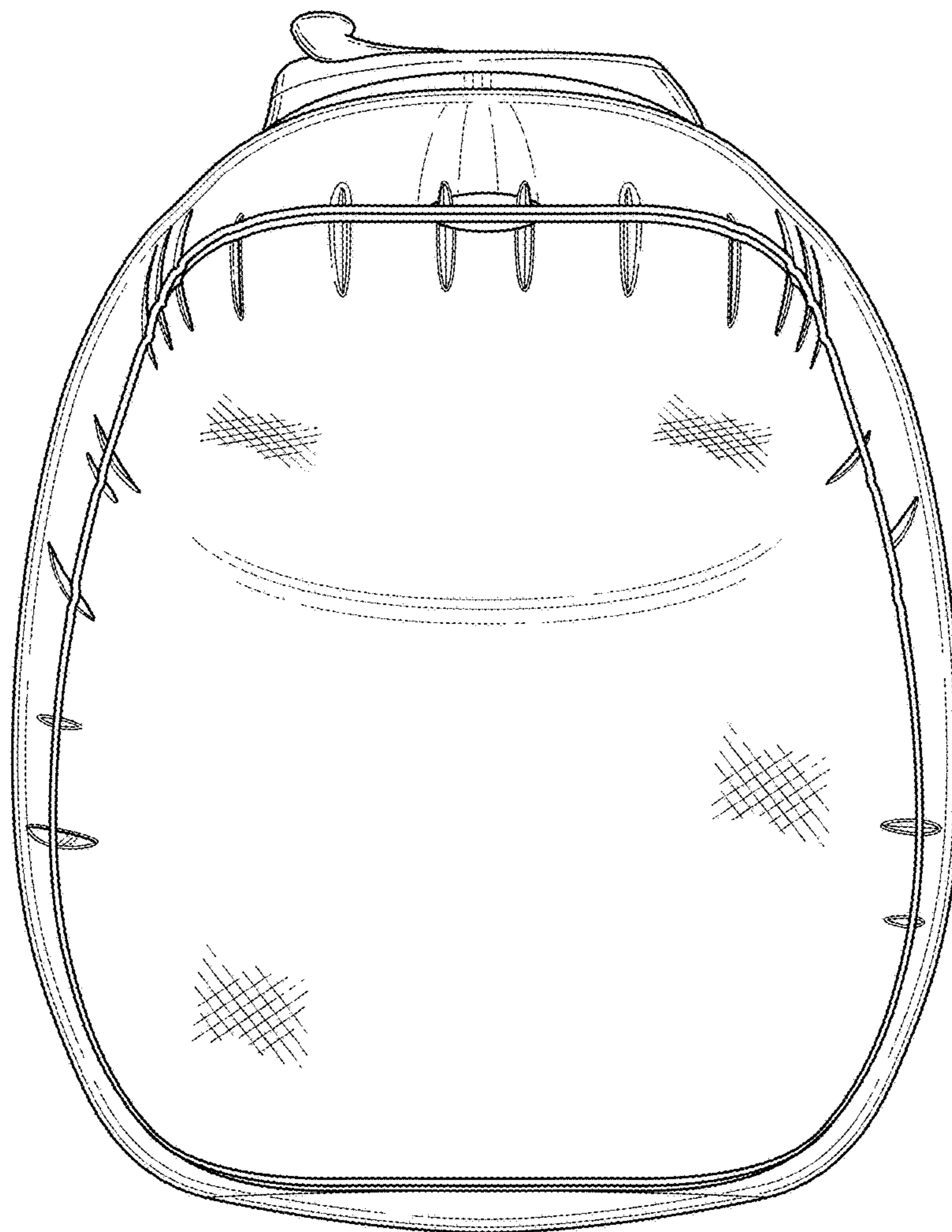

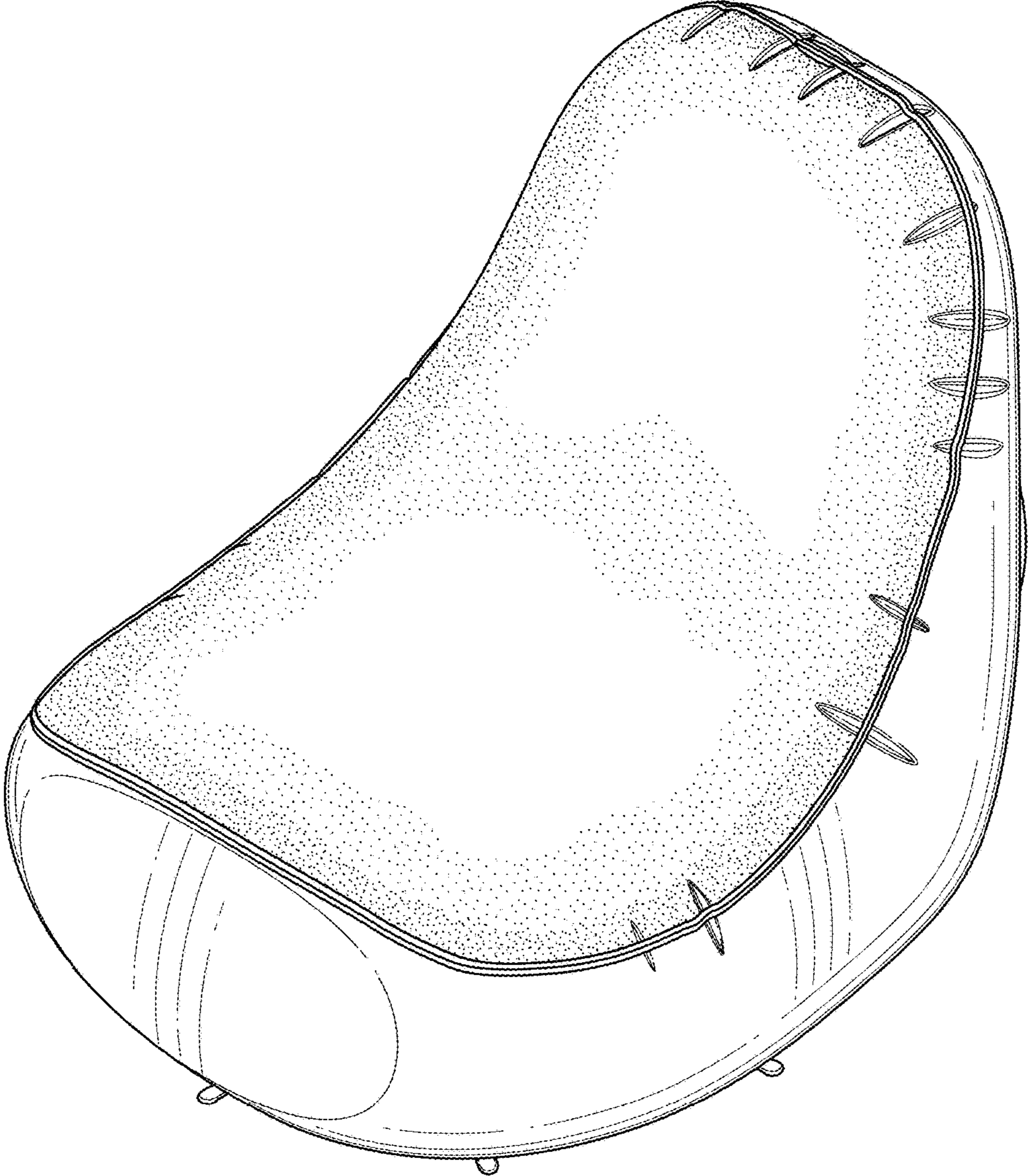

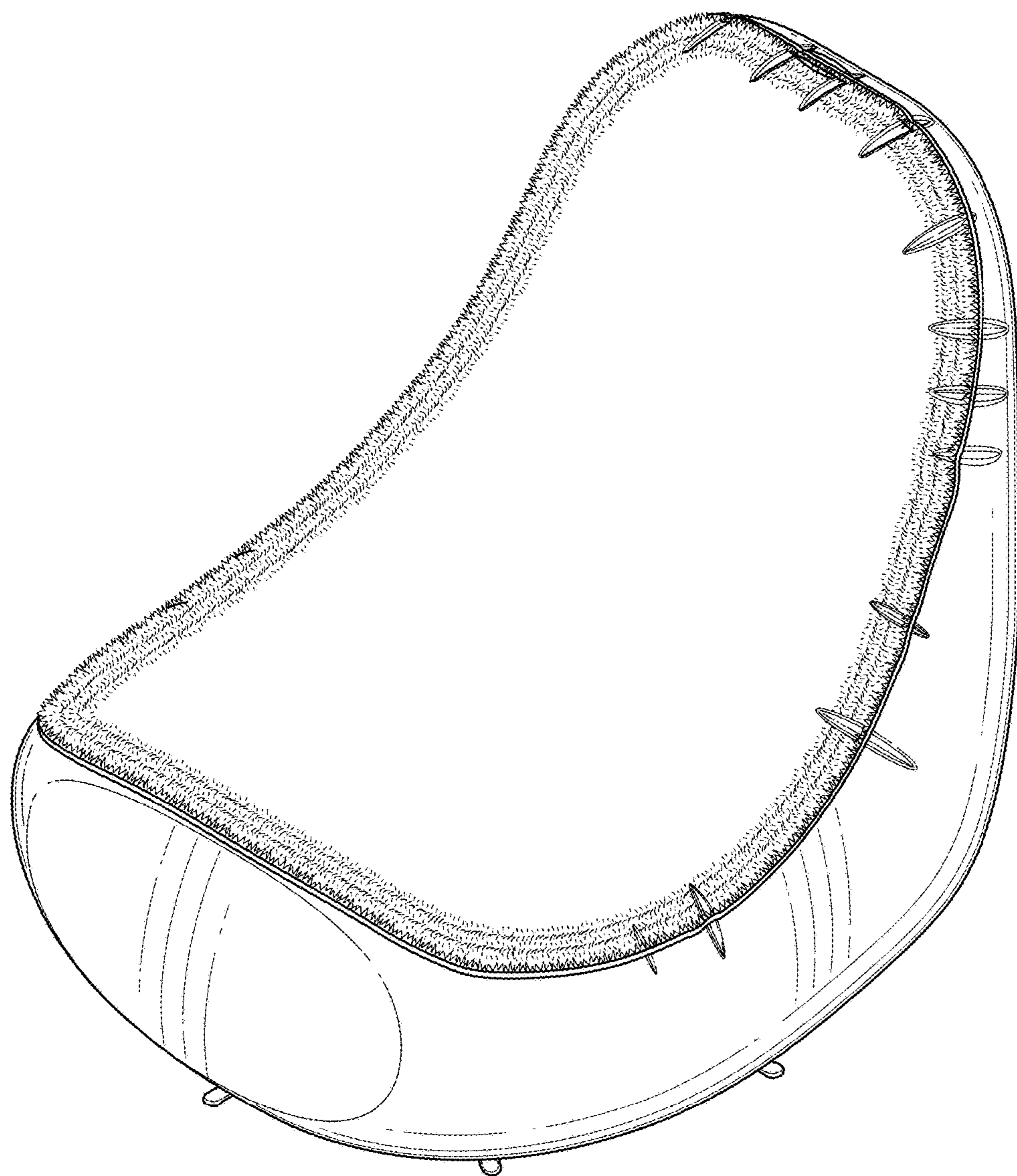
