(57) **CLAIM**

The ornamental design of a vehicle seat, as shown in the figures and described.

DESCRIPTION

FIG. 1 is a front view of a vehicle seat illustrating the design of the present invention;
FIG. 2 is a front perspective view of the vehicle seat of FIG. 1;
FIG. 3 is a right-side view of the vehicle seat of FIG. 1;
FIG. 4 is a rear view of the vehicle seat of FIG. 1;
FIG. 5 is a rear perspective view of the vehicle seat of FIG. 1;
FIG. 6 is a left-side view of the vehicle seat of FIG. 1;
FIG. 7 is a top view of the vehicle seat of FIG. 1; and,
FIG. 8 is a bottom view of the vehicle seat of FIG. 1.

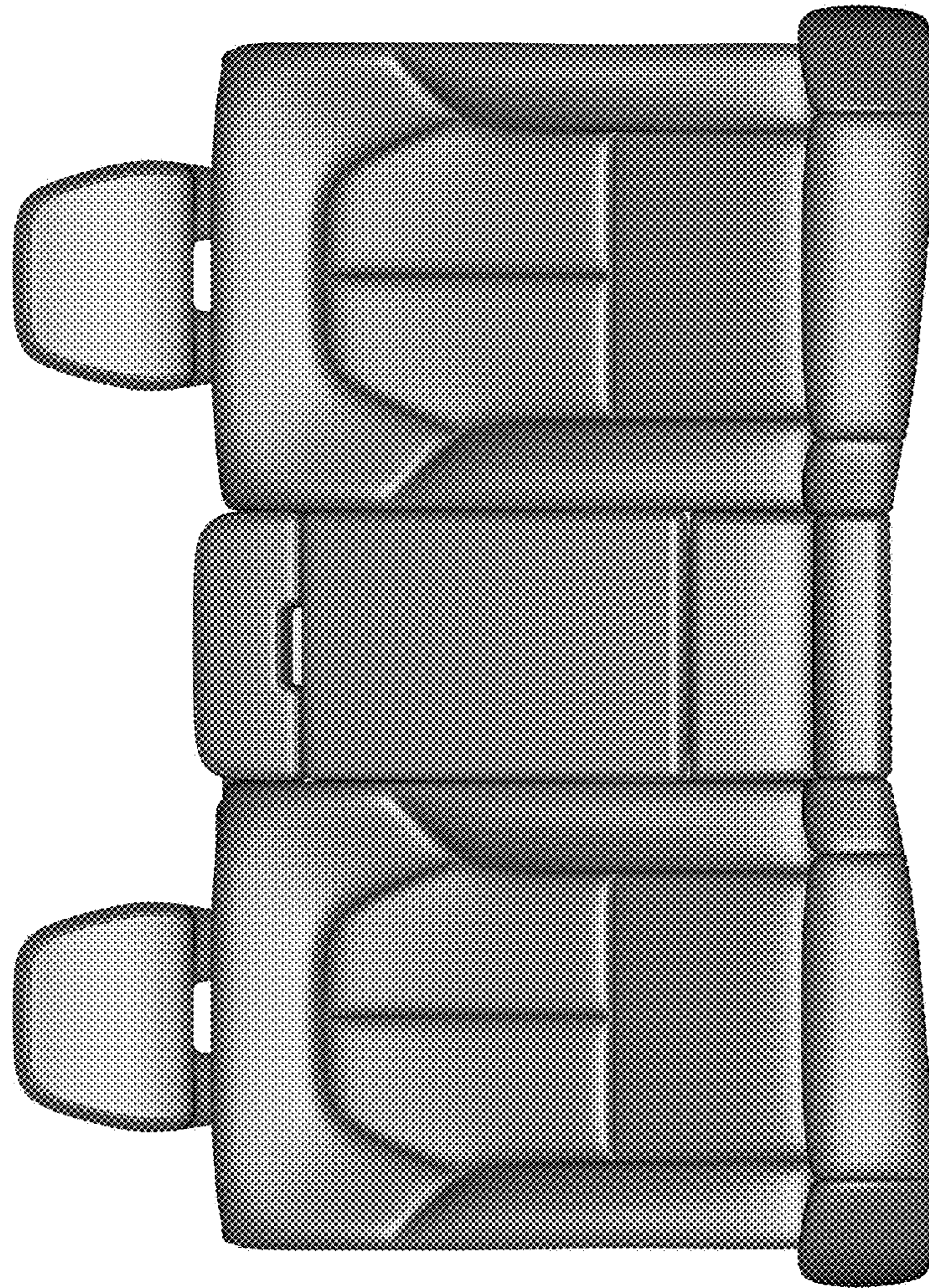

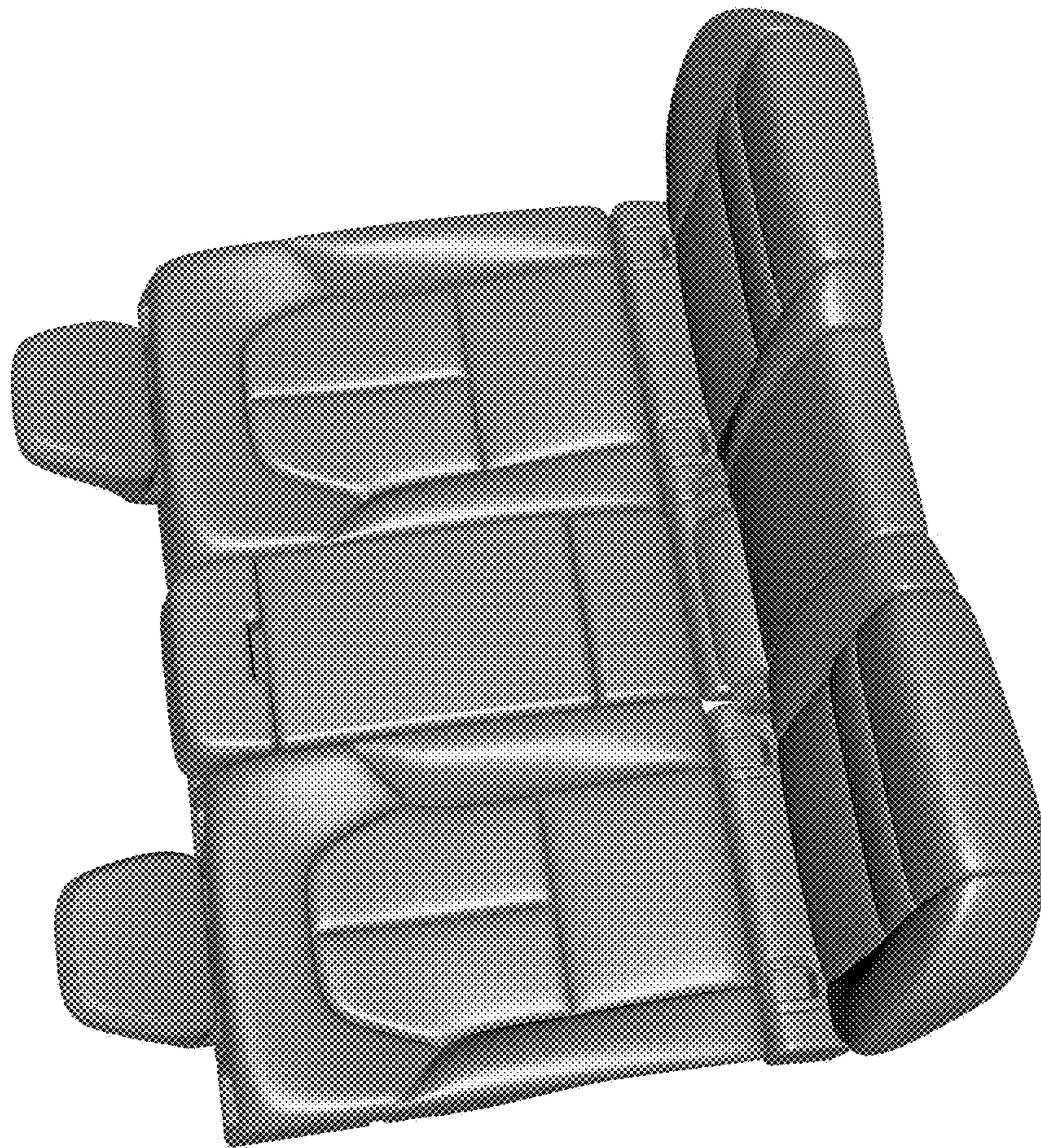

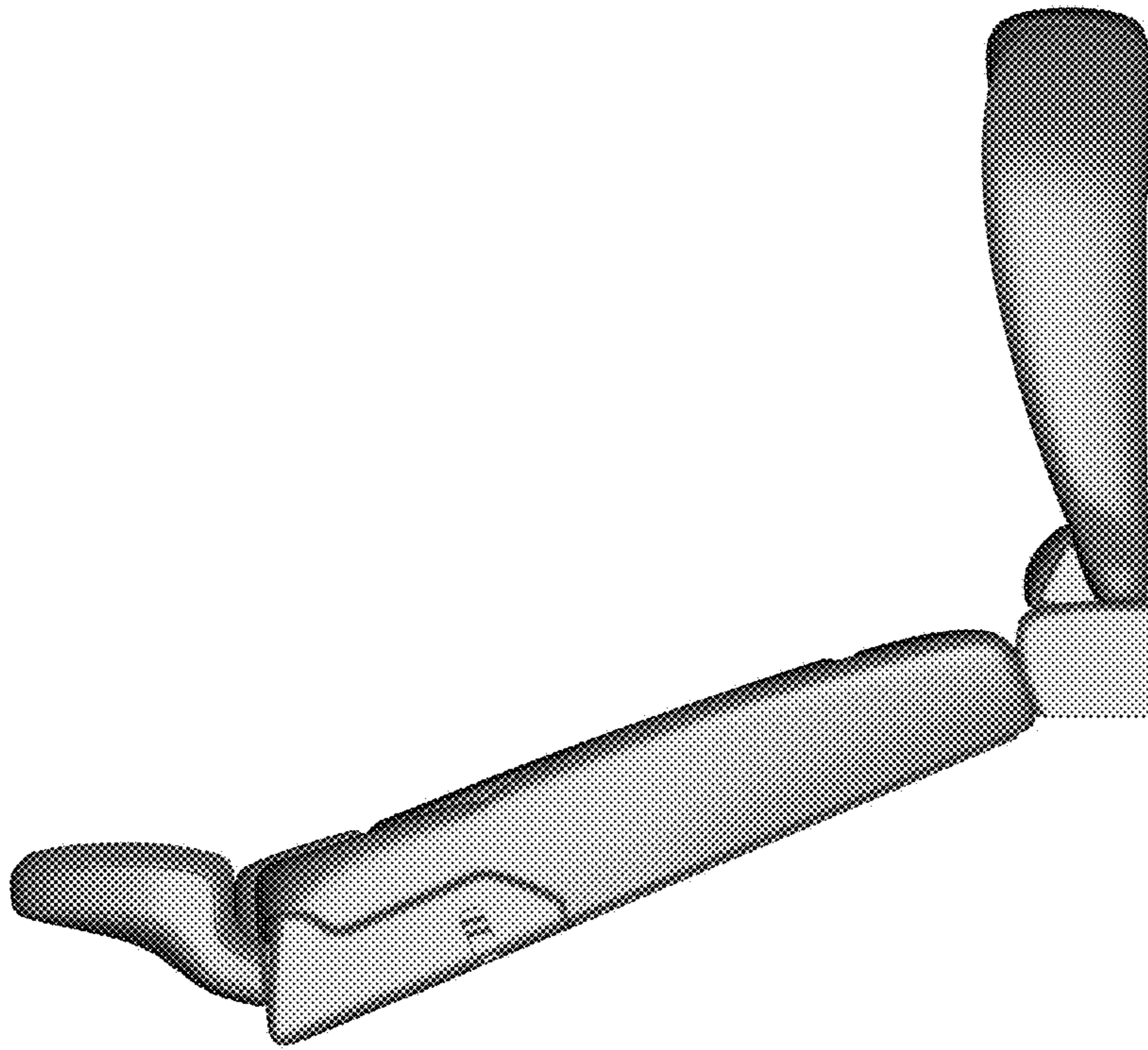

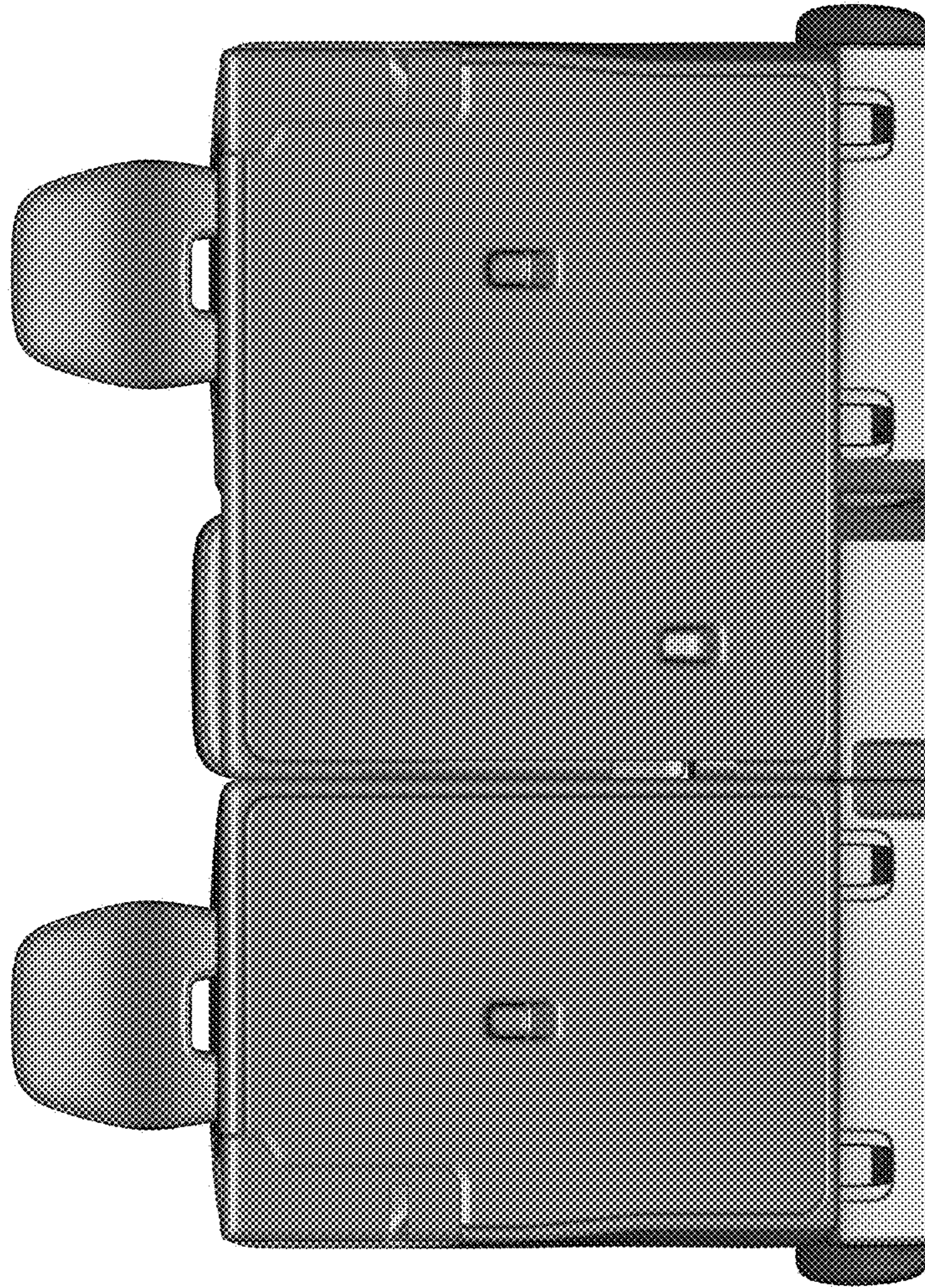

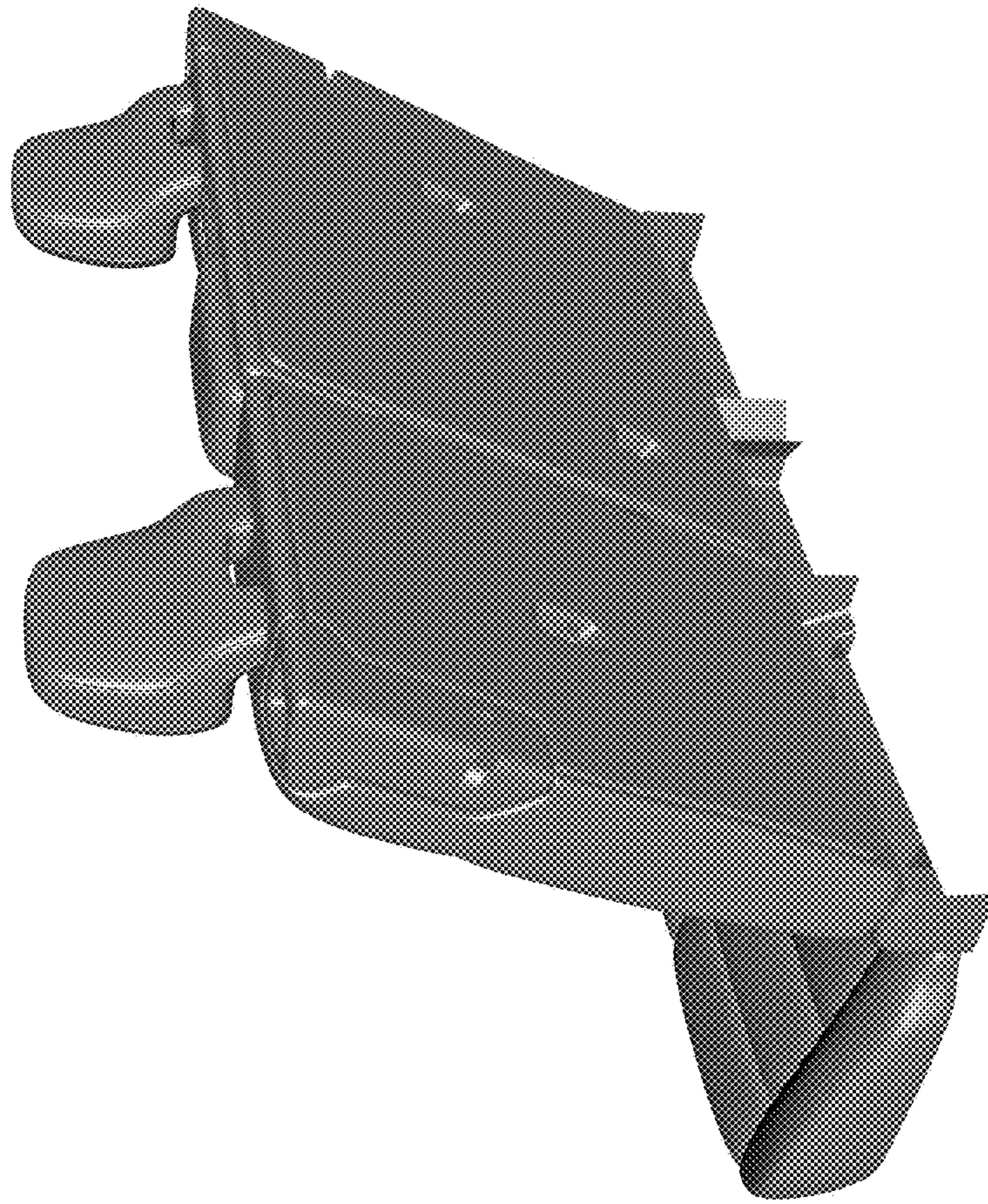

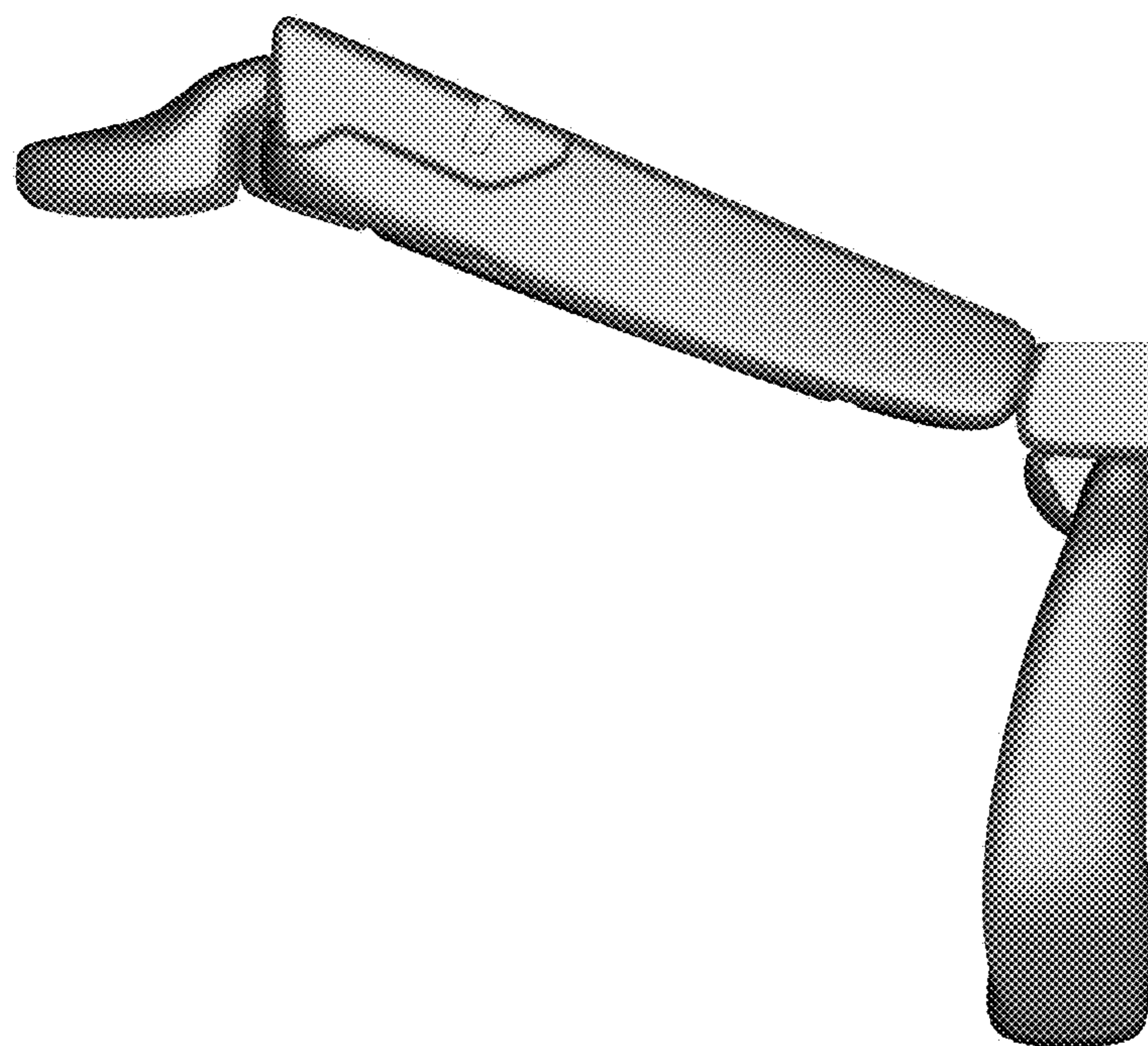

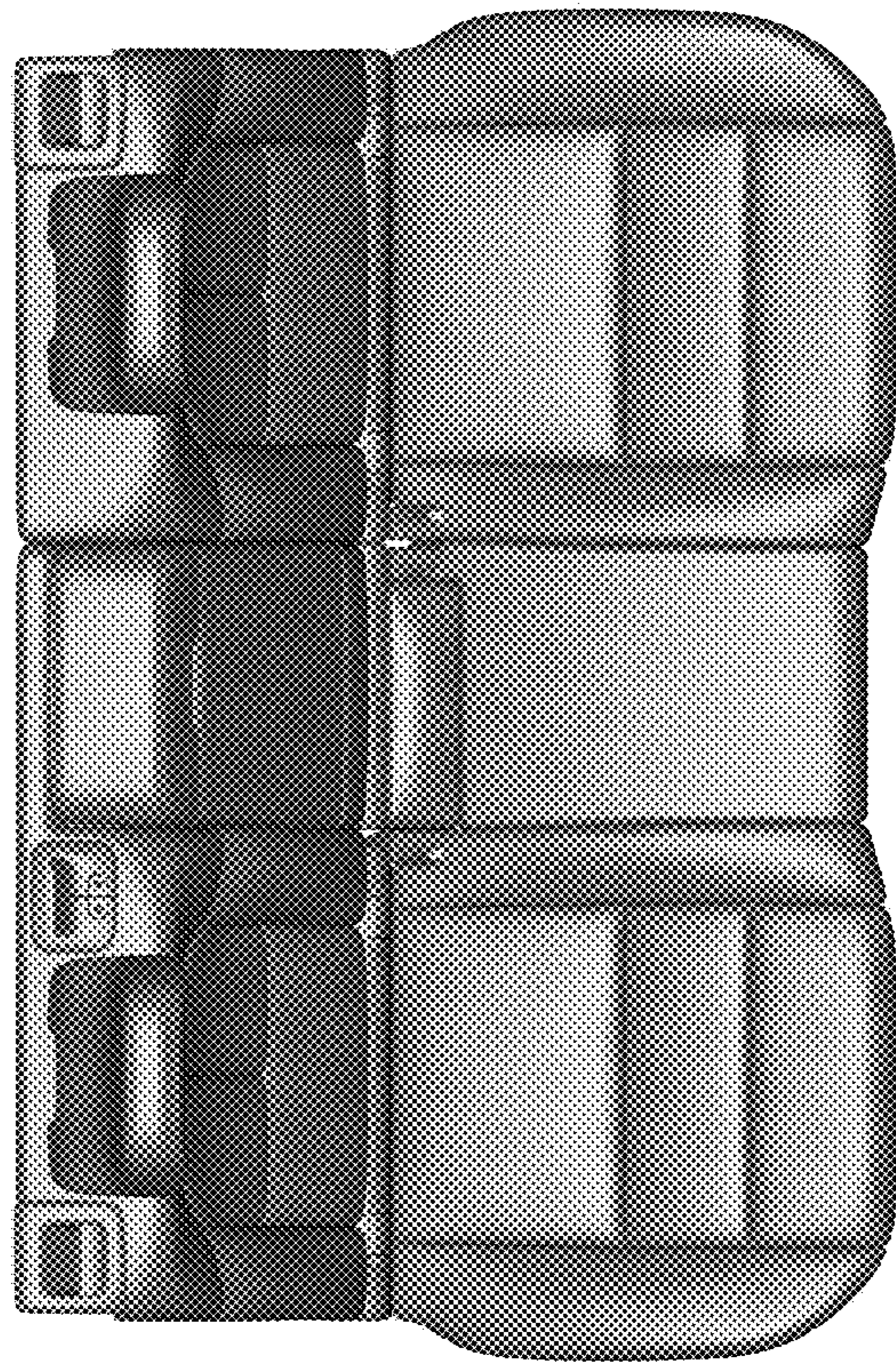

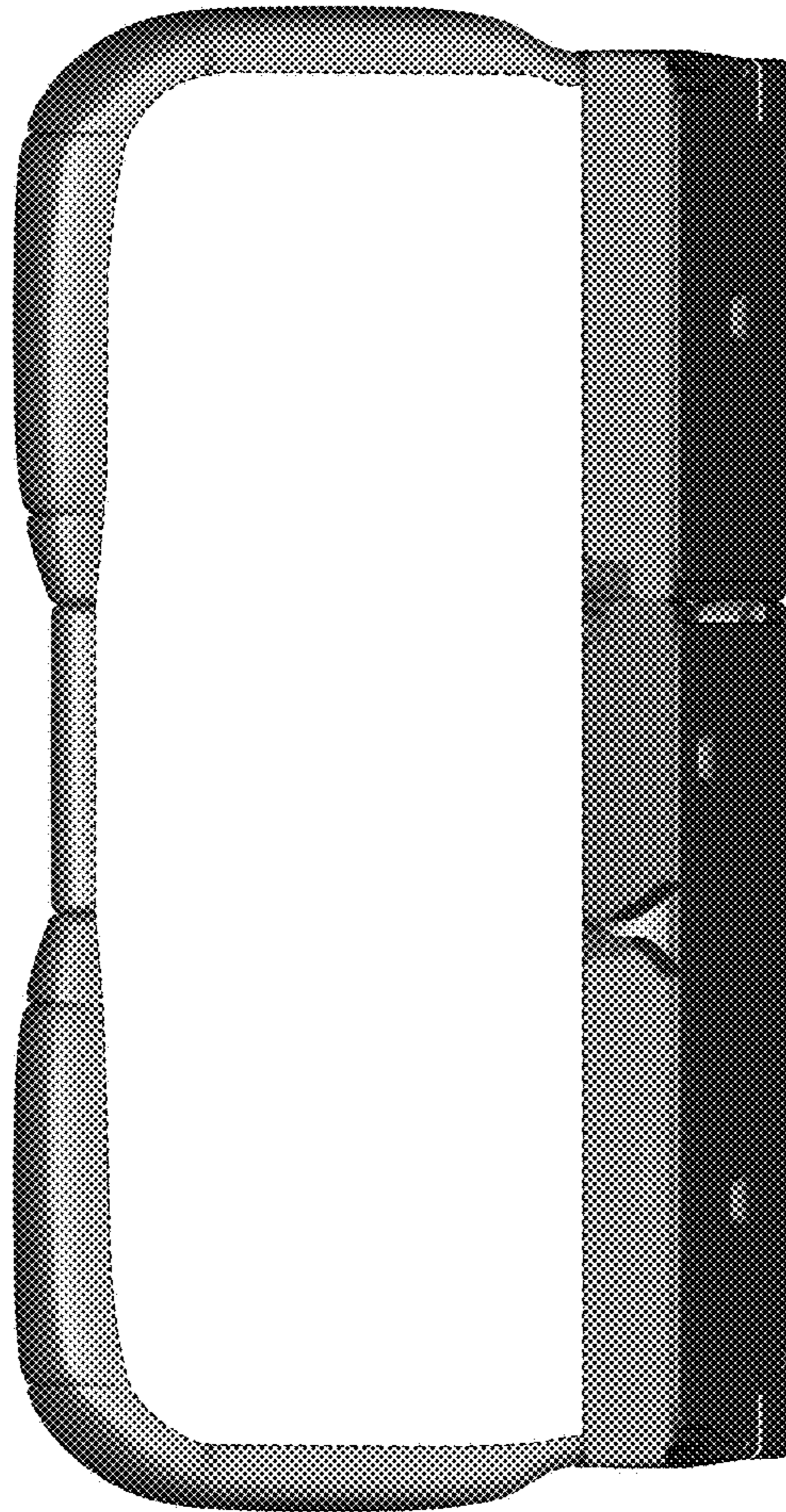
