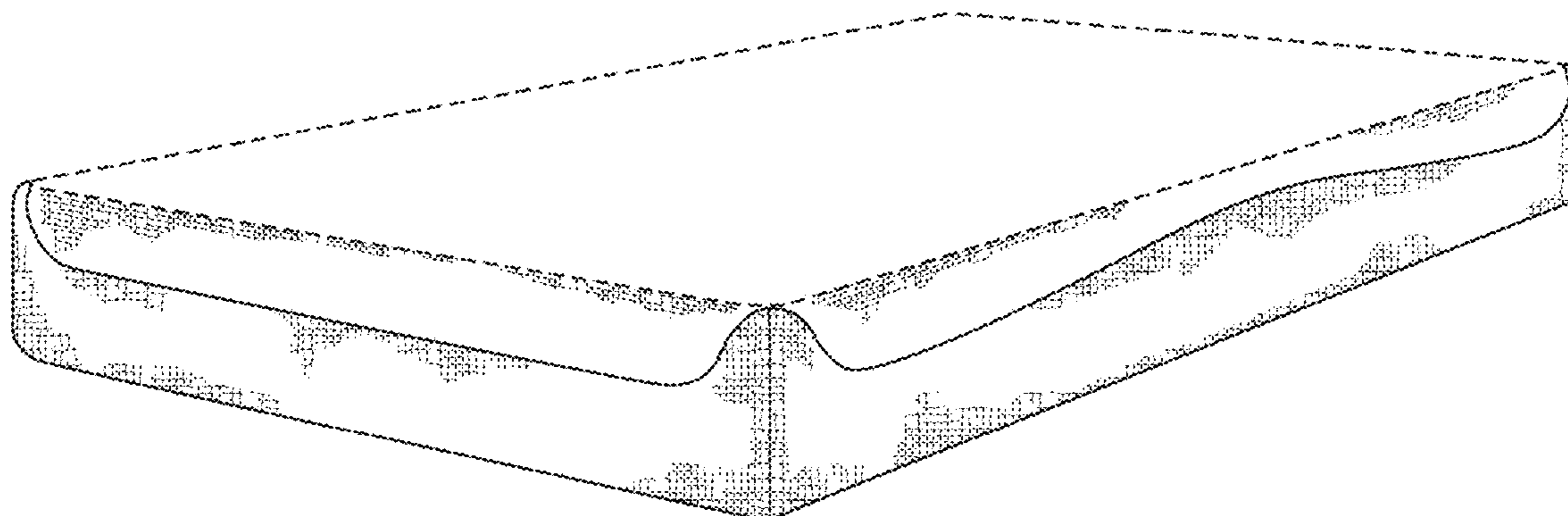
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a mattress;
FIG. 2 is a back end view of the mattress, the front end view
being identical thereto;
FIG. 3 is a left side view of the mattress, the right side view
being identical thereto; and,
FIG. 4 is a bottom view of the mattress.
The broken line showing of the top and bottom of the
mattress is for the purpose of illustrating structure and forms
no part of the claimed design.

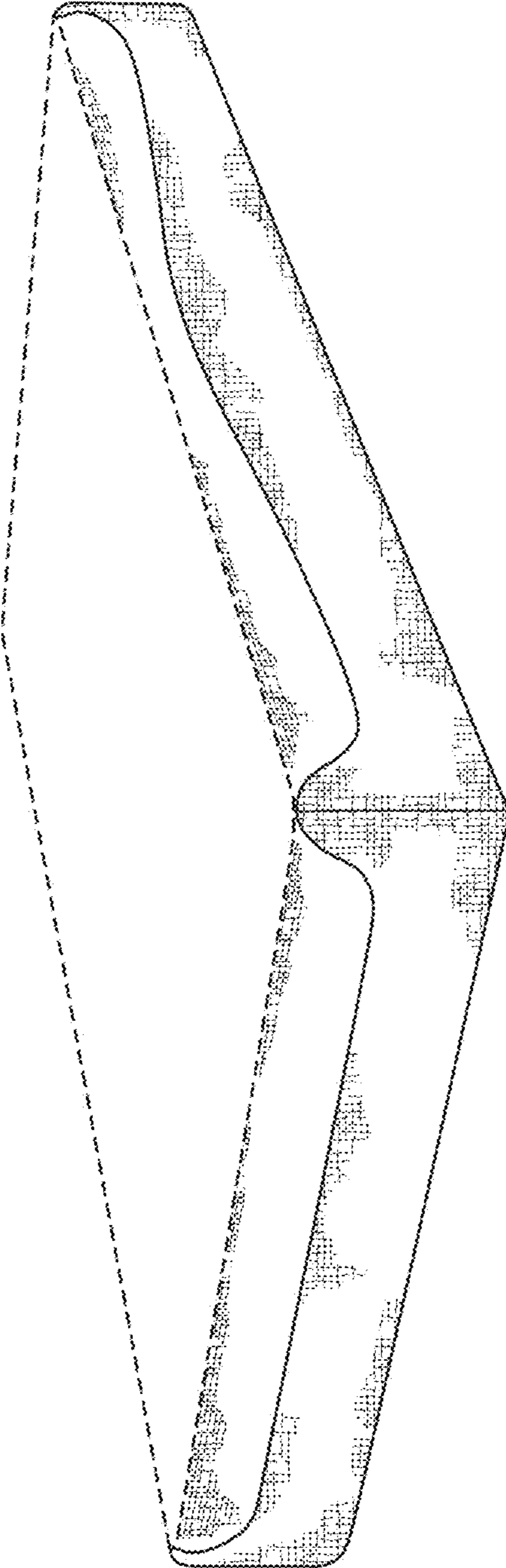

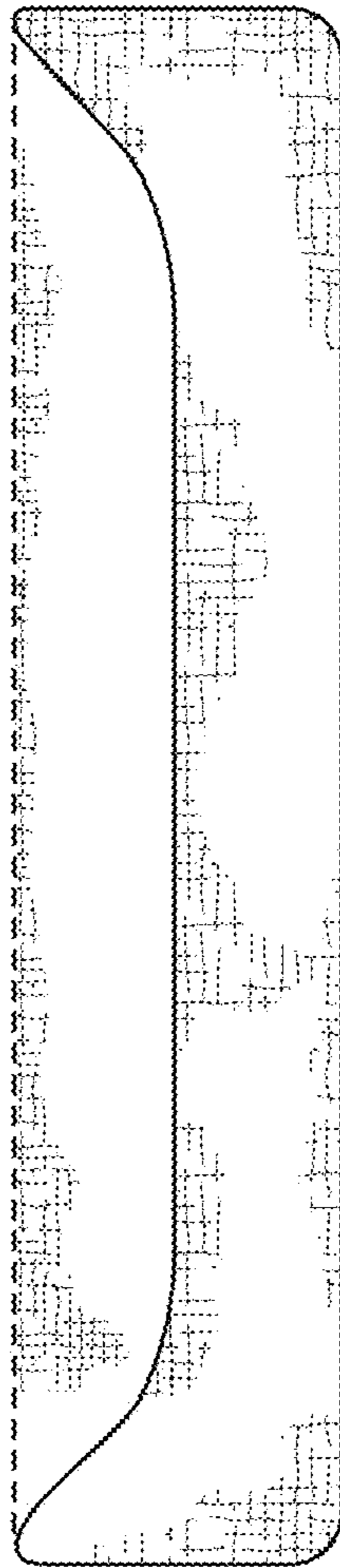

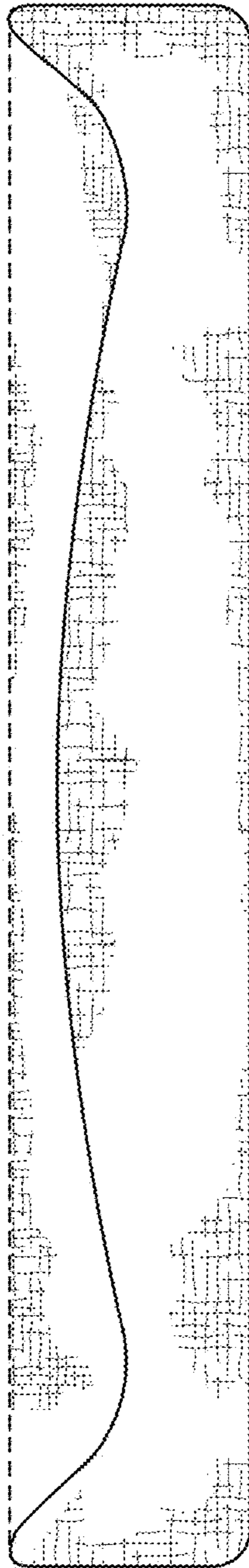

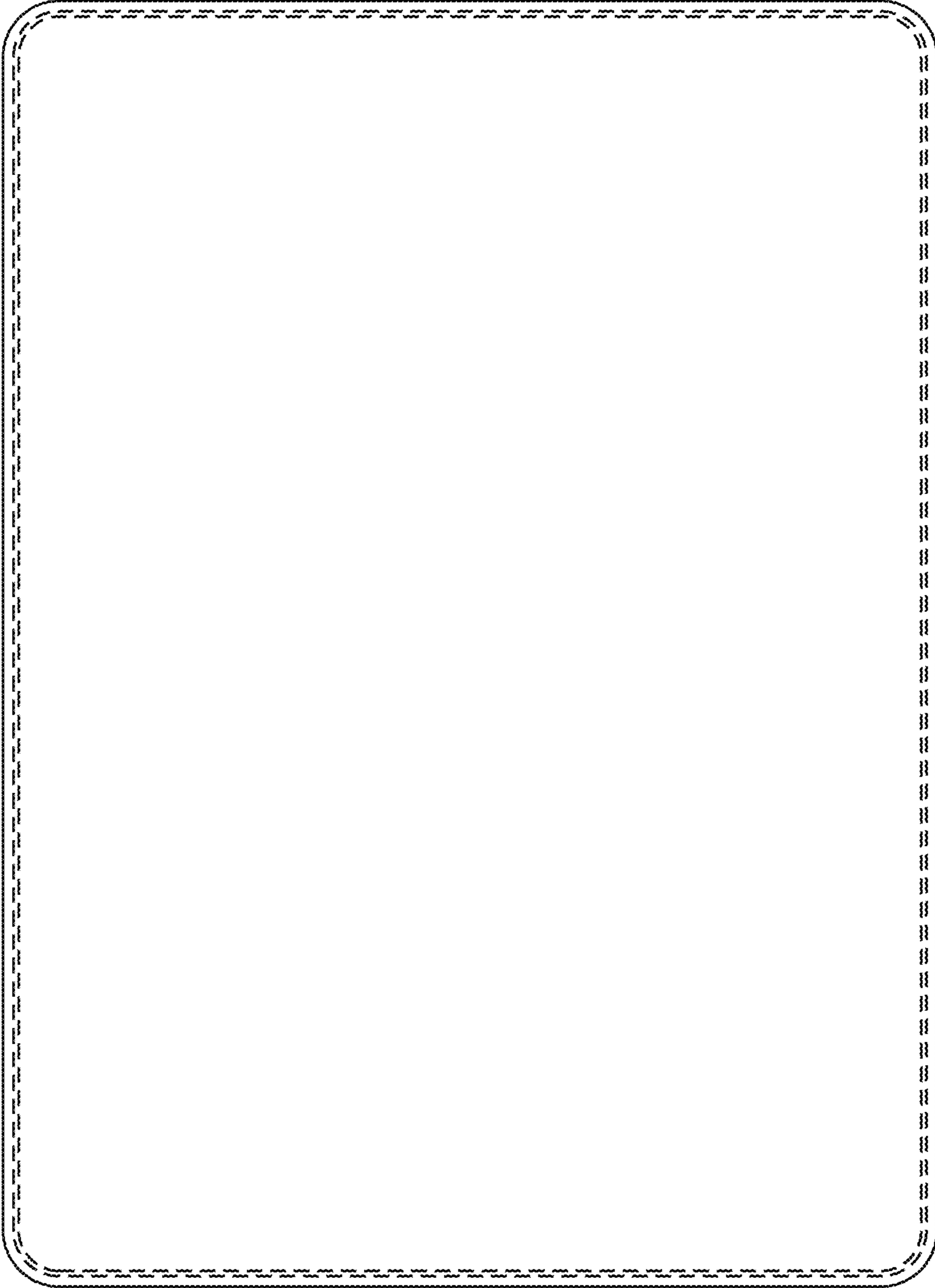
