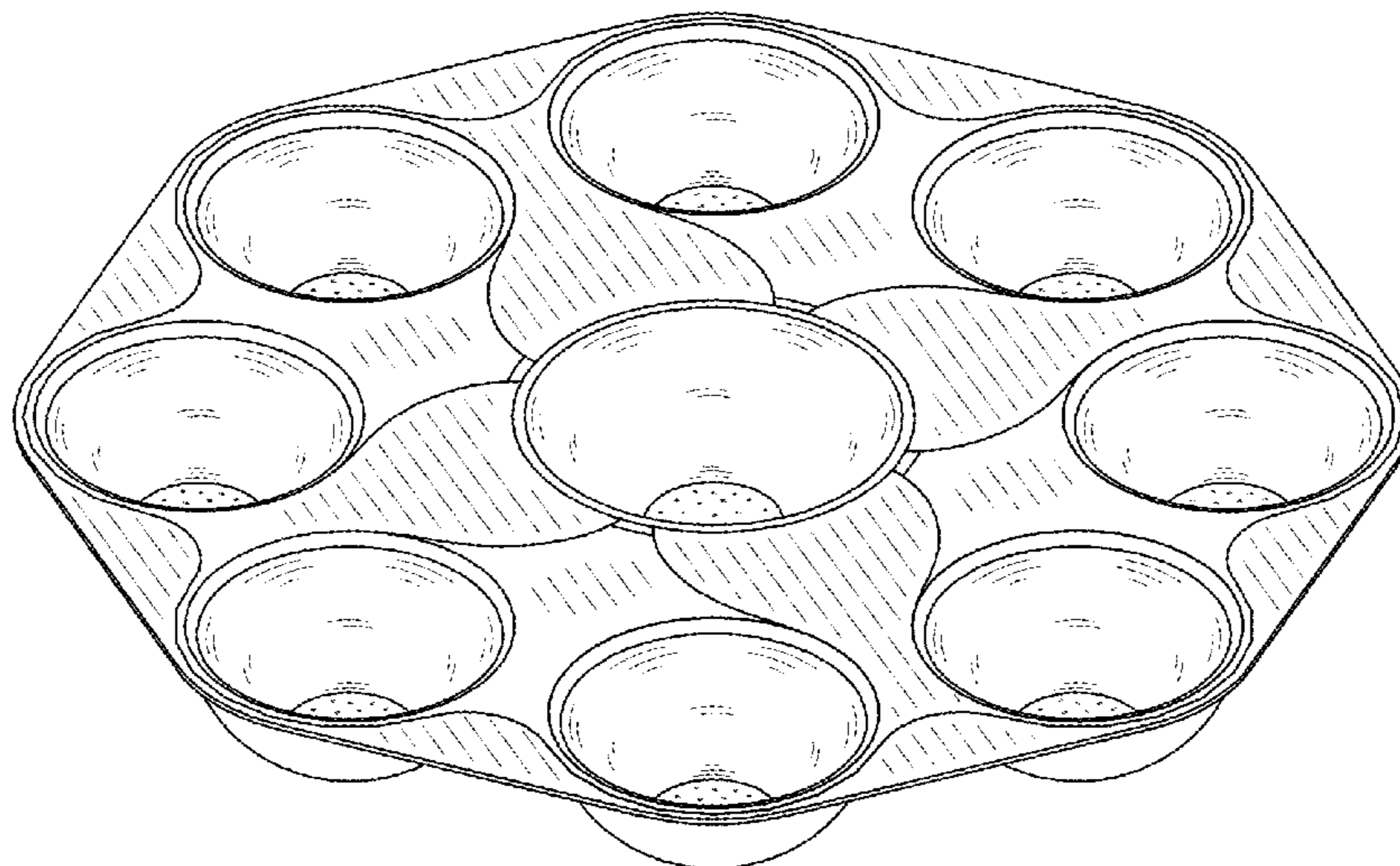
(57) **CLAIM**

The ornamental design for a jewelry bowl, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a jewelry bowl showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a side view thereof; and,
FIG. 5 is a lower perspective view thereof.
The light, evenly spaced lines and dot-like markings shown on the jewelry bowl represent surface shading and not surface ornamentation.

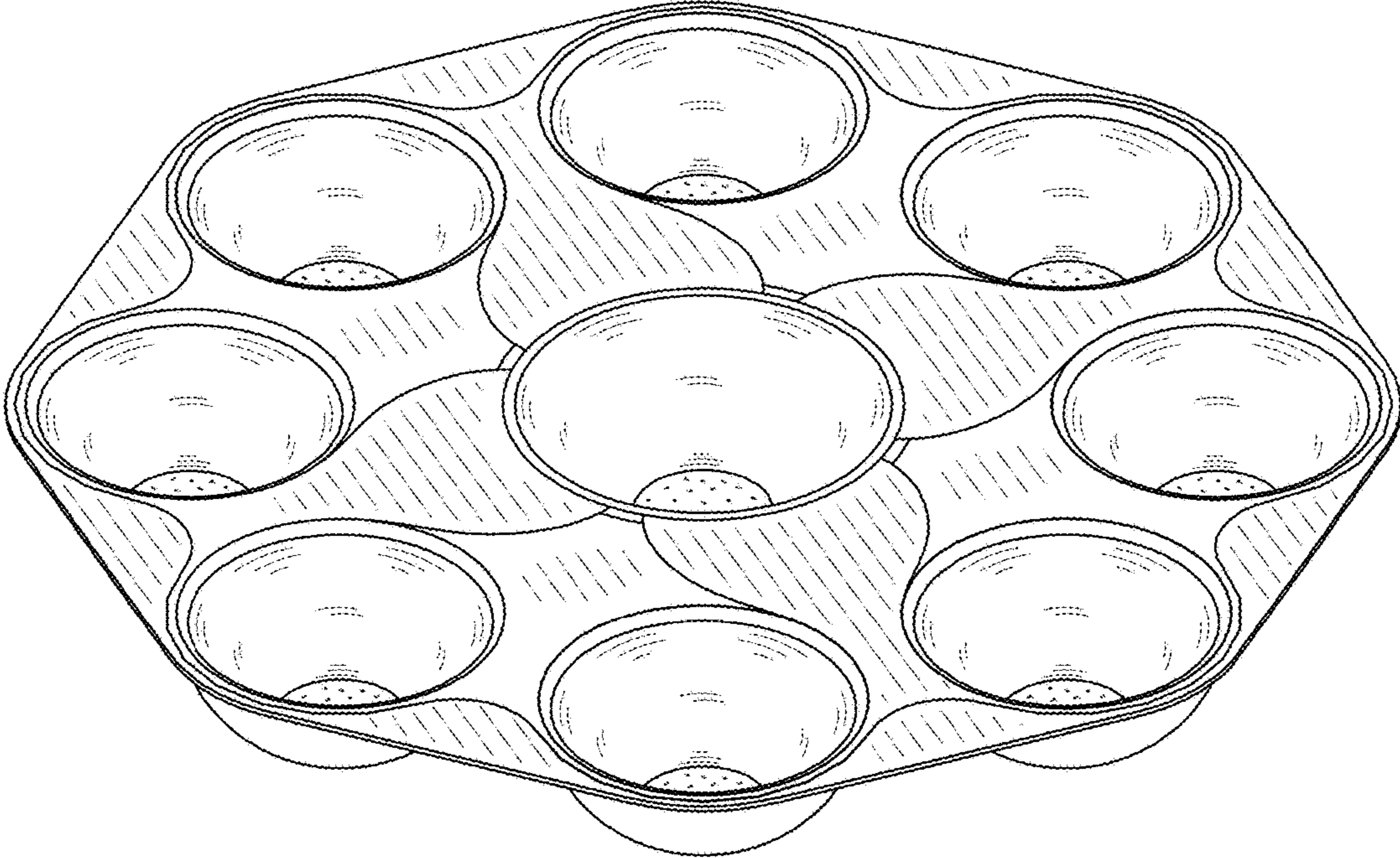

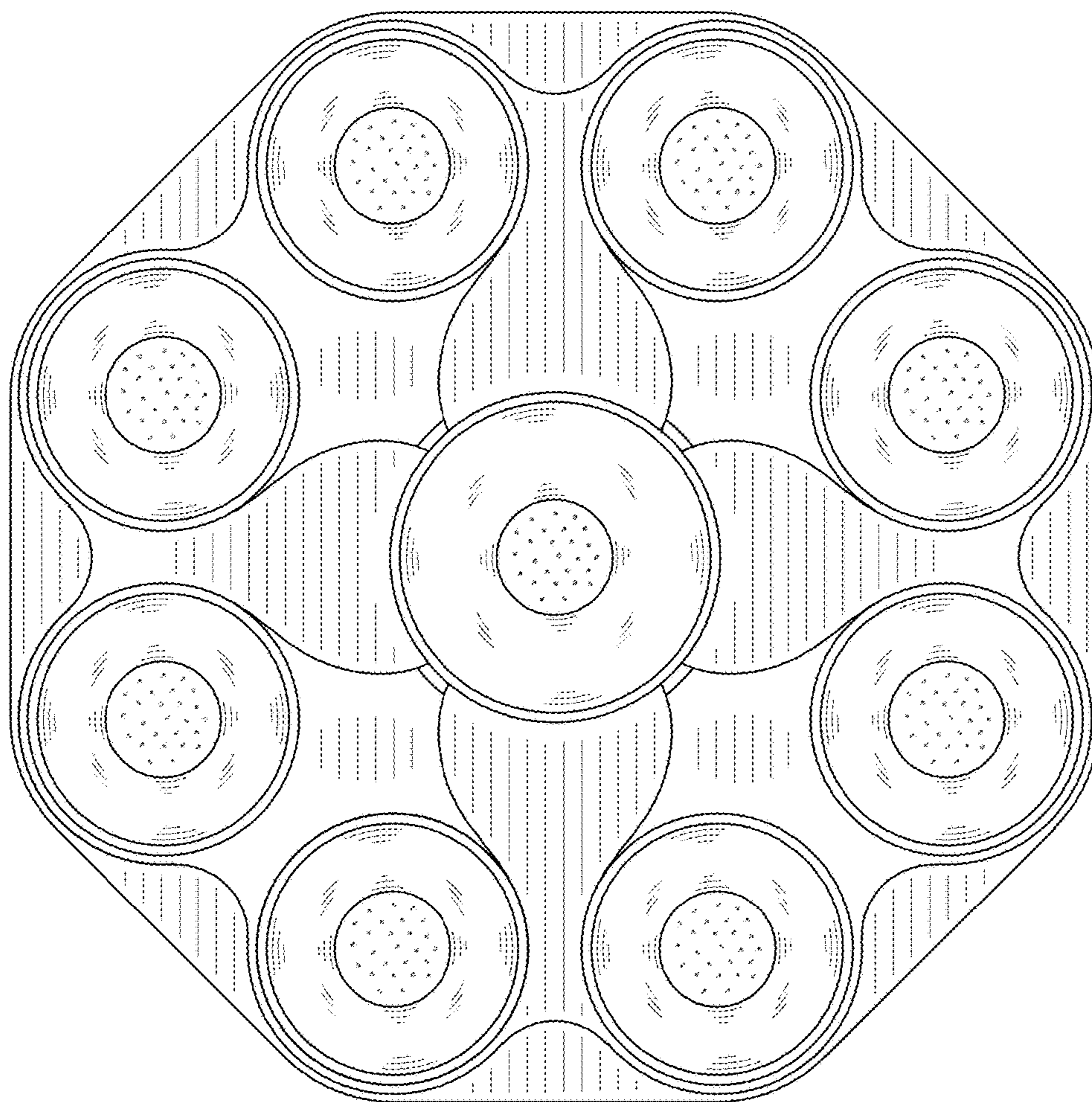

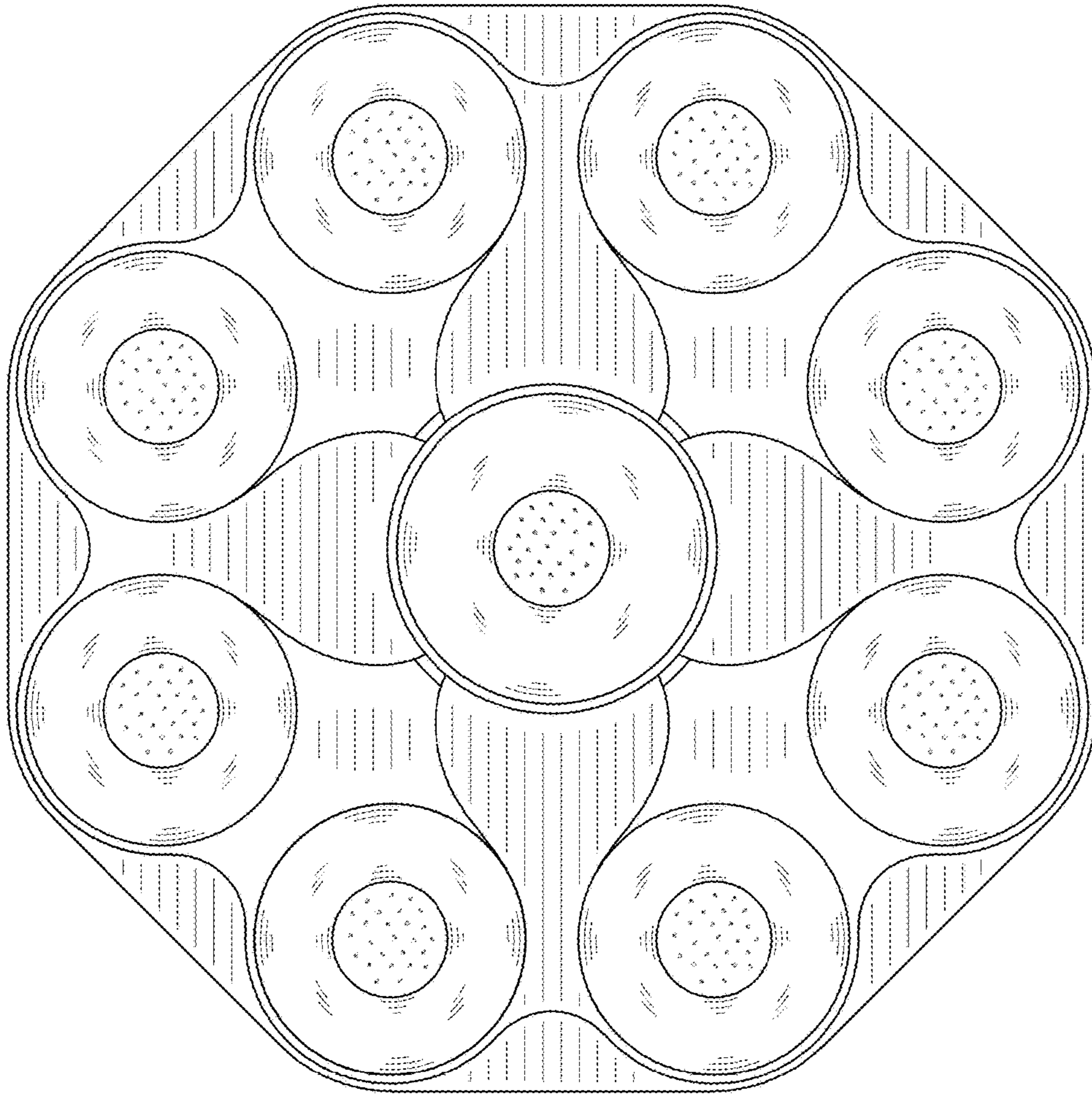

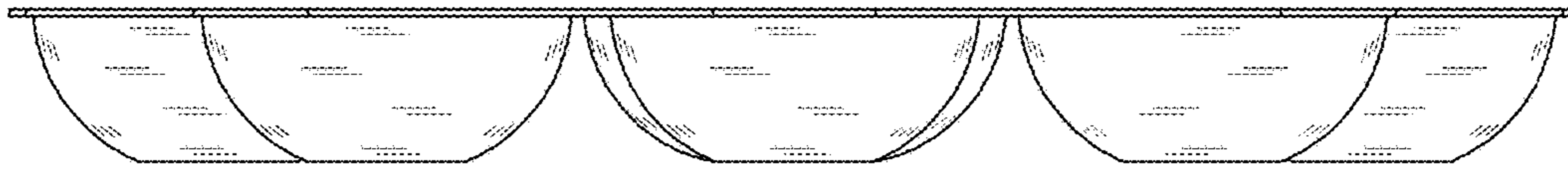

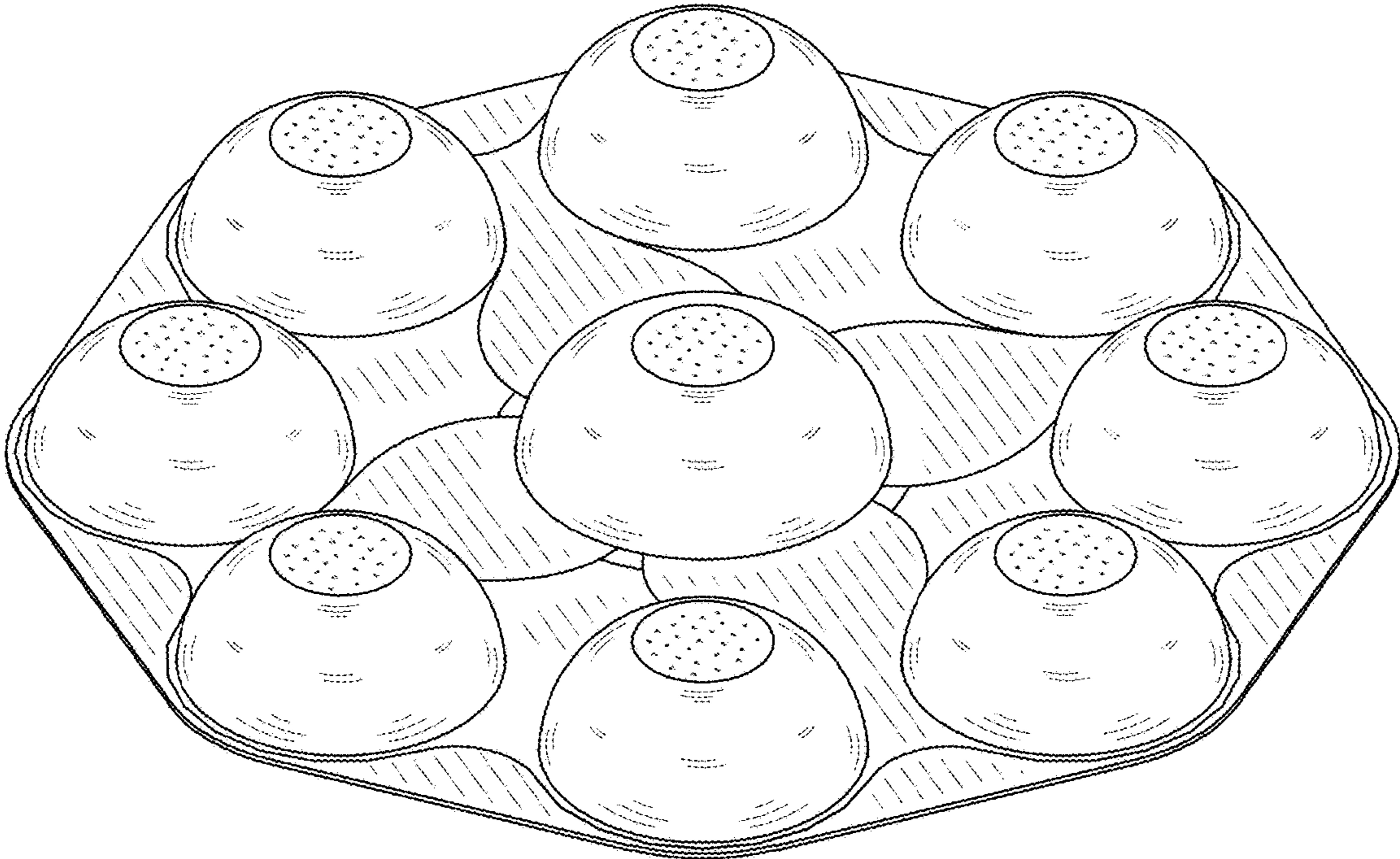
