**DESCRIPTION**

FIG. 1 is a perspective view of the front and left side of the activity tracker band according to an embodiment of the present disclosure.

FIG. 5 is a left side view of the activity tracker band of FIG. 1.

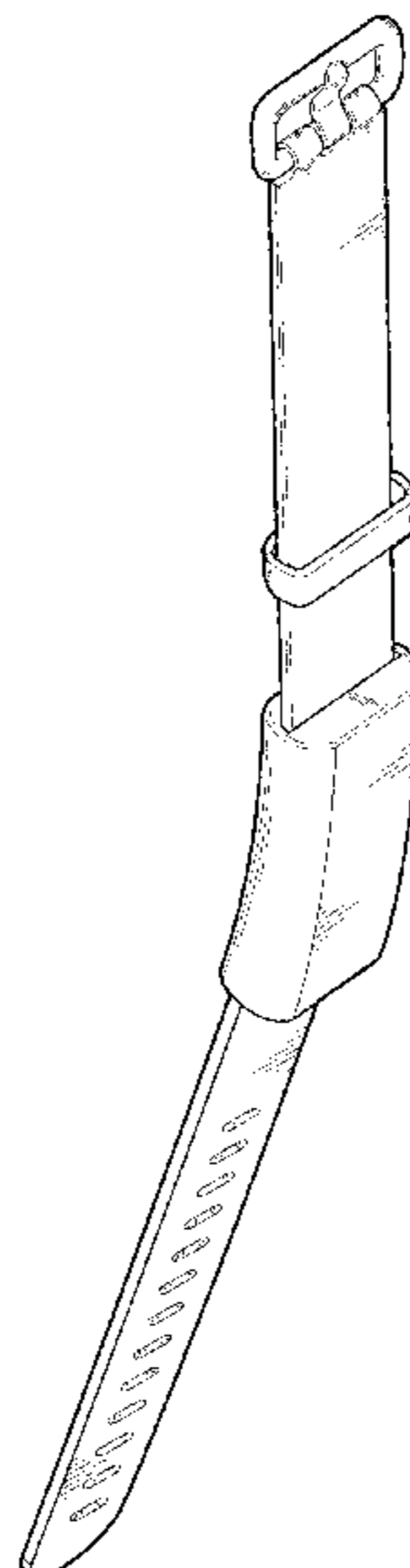
FIG. 6 is a top view of the activity tracker band of FIG. 1; and,

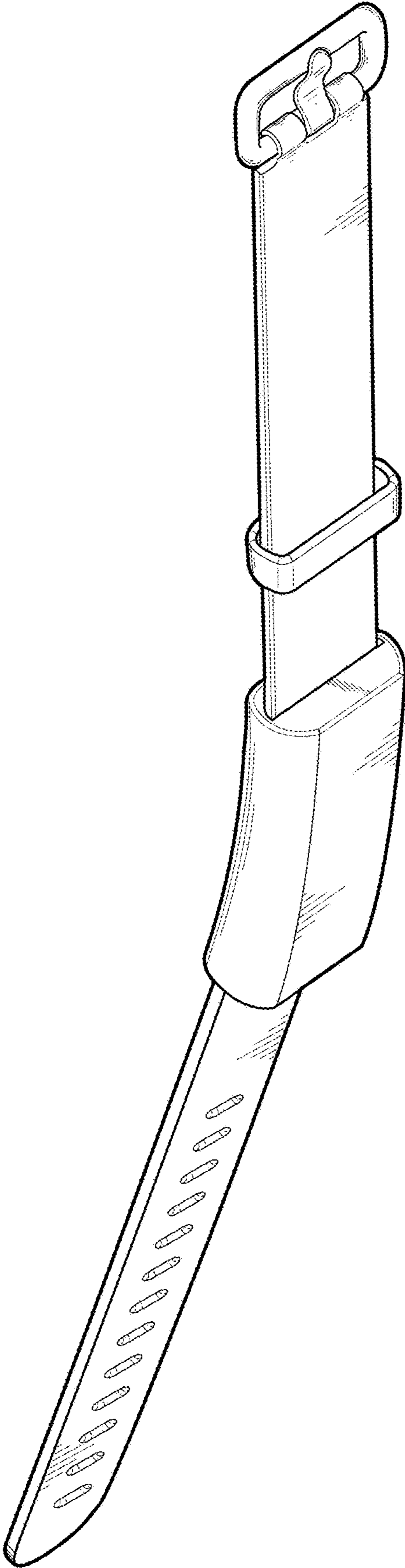

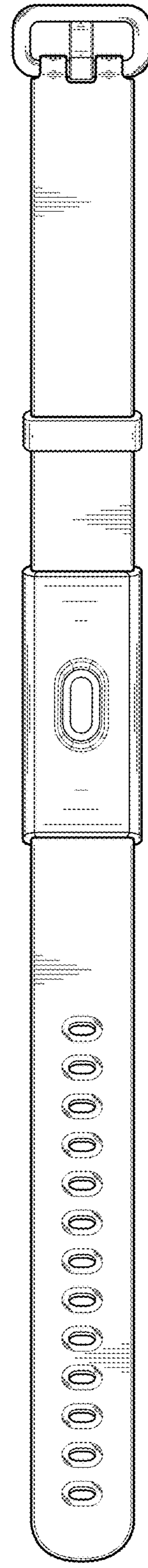
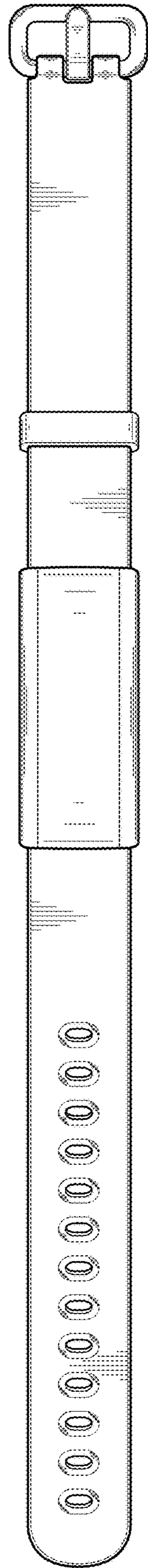

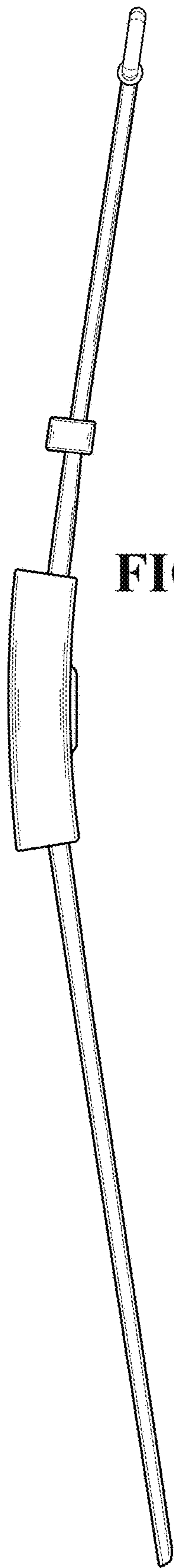

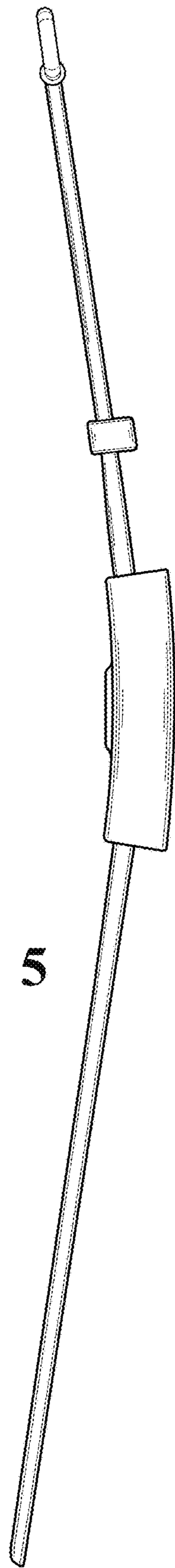

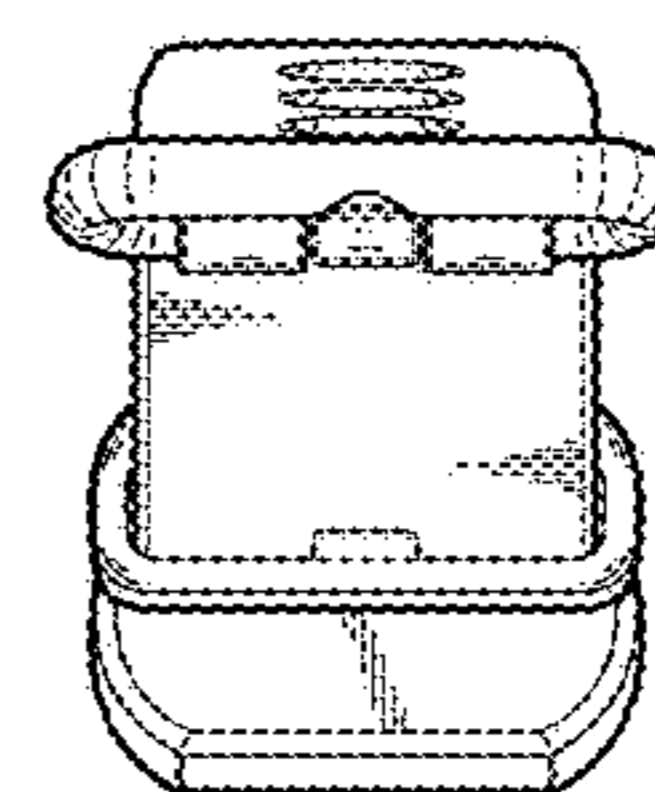

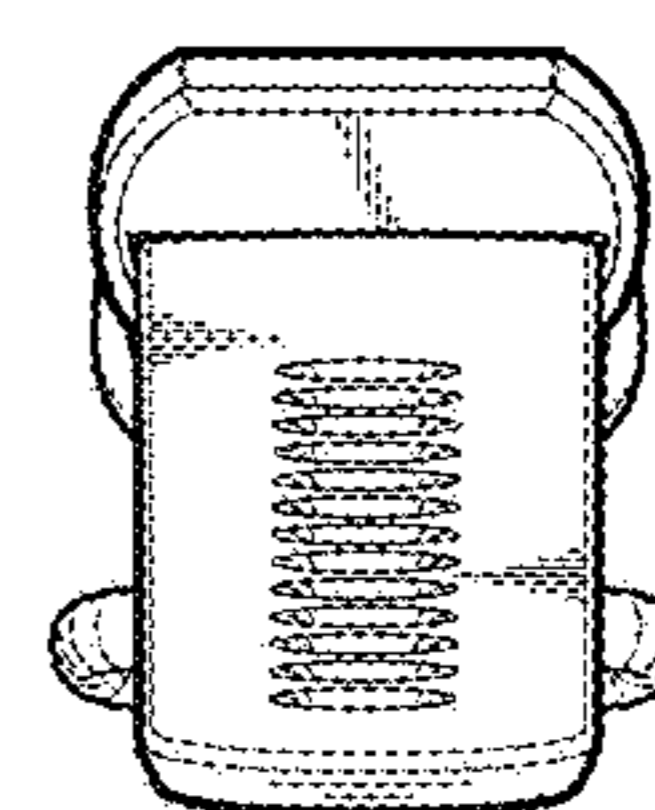
