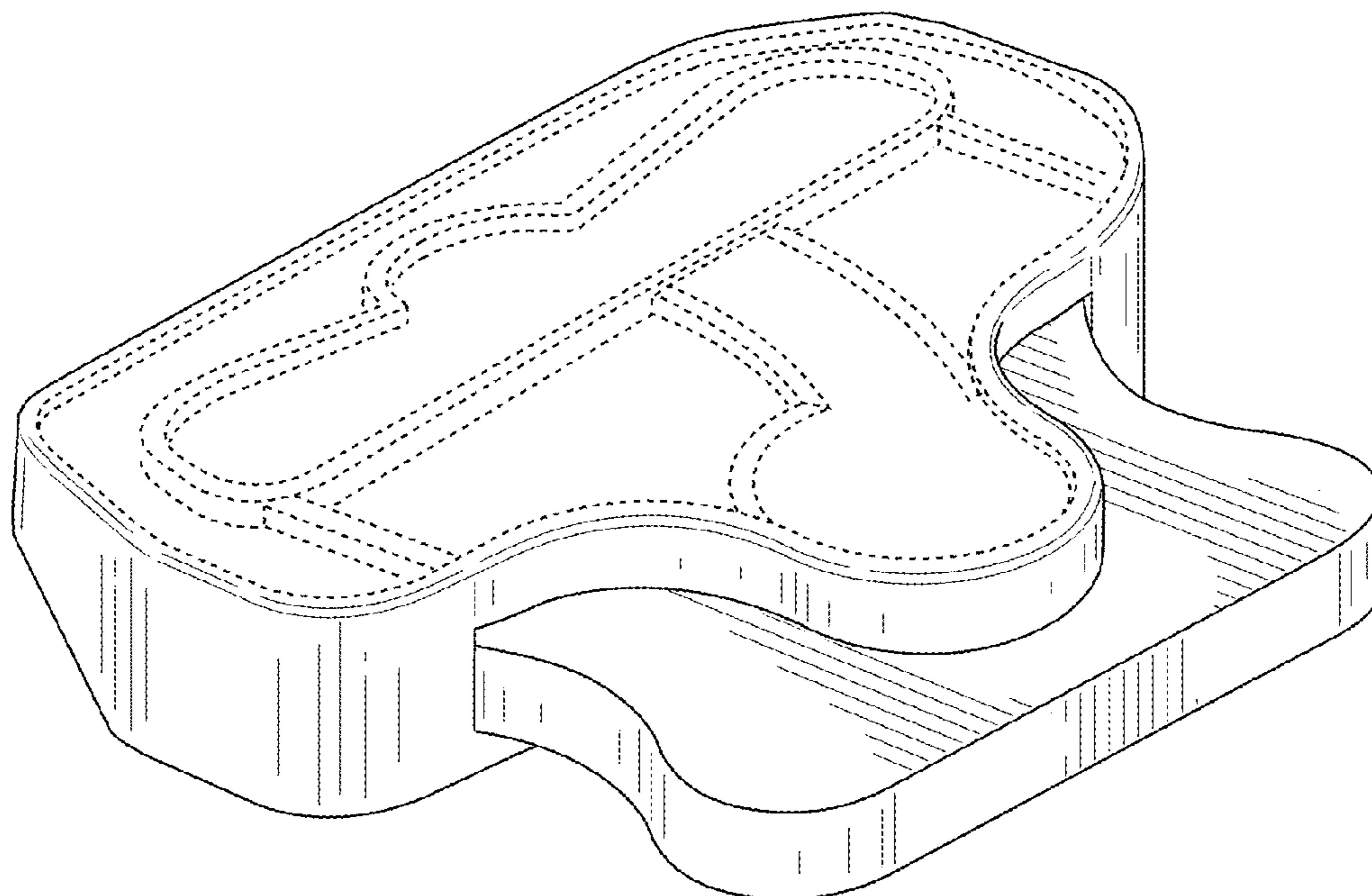
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a security tag in accordance with our new design;
FIG. 2 is a front view of the security tag of FIG. 1;

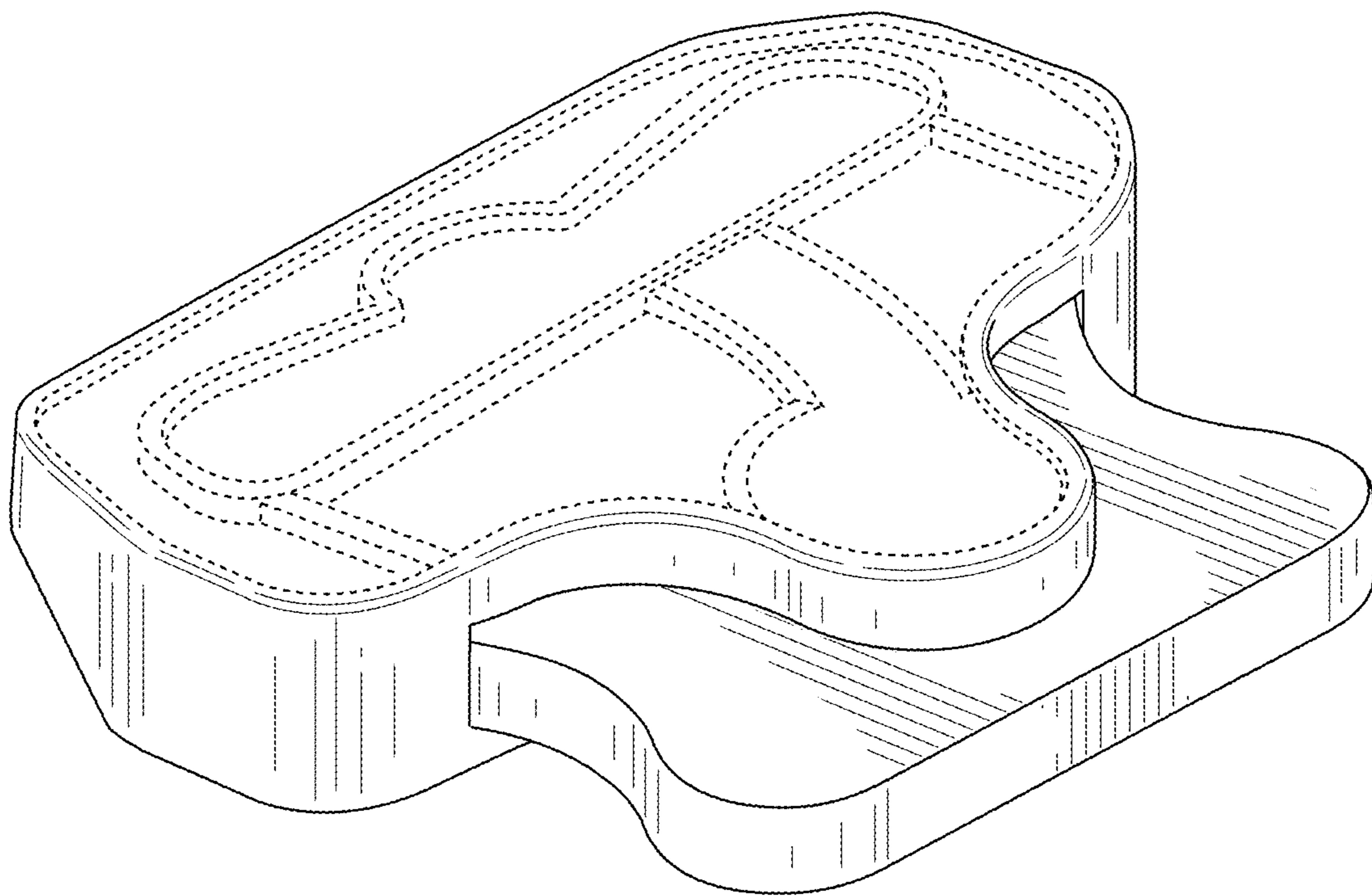

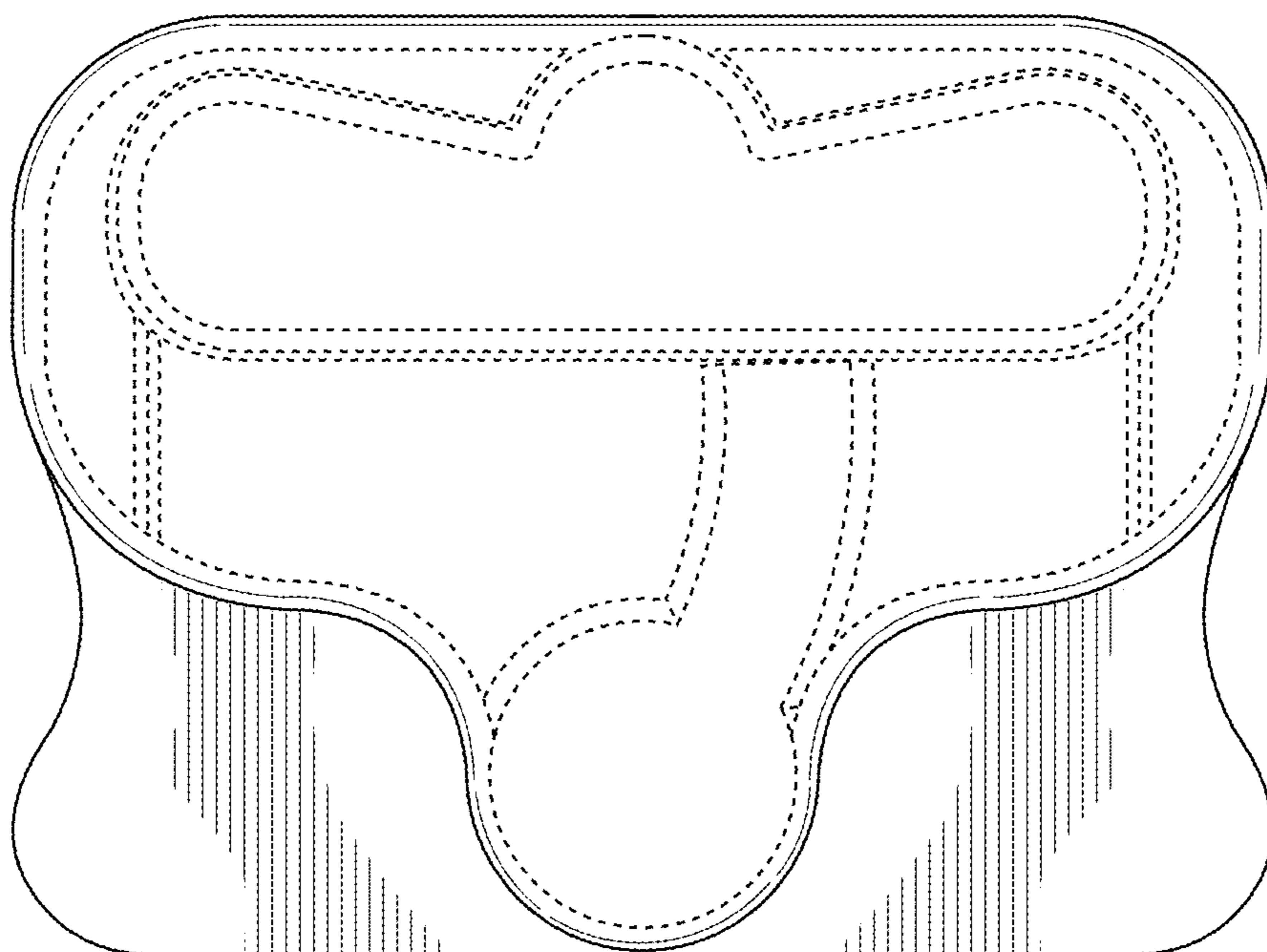

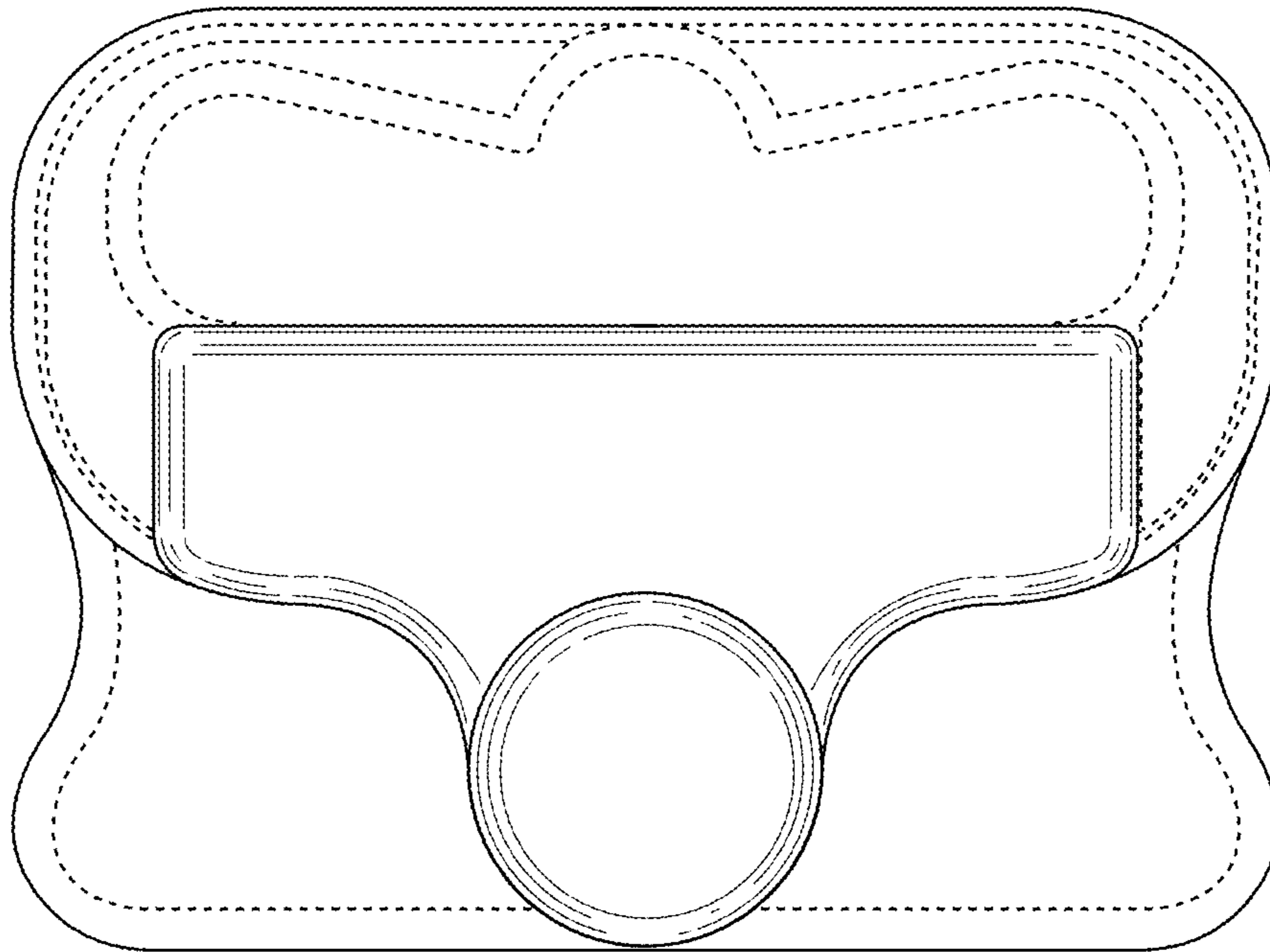

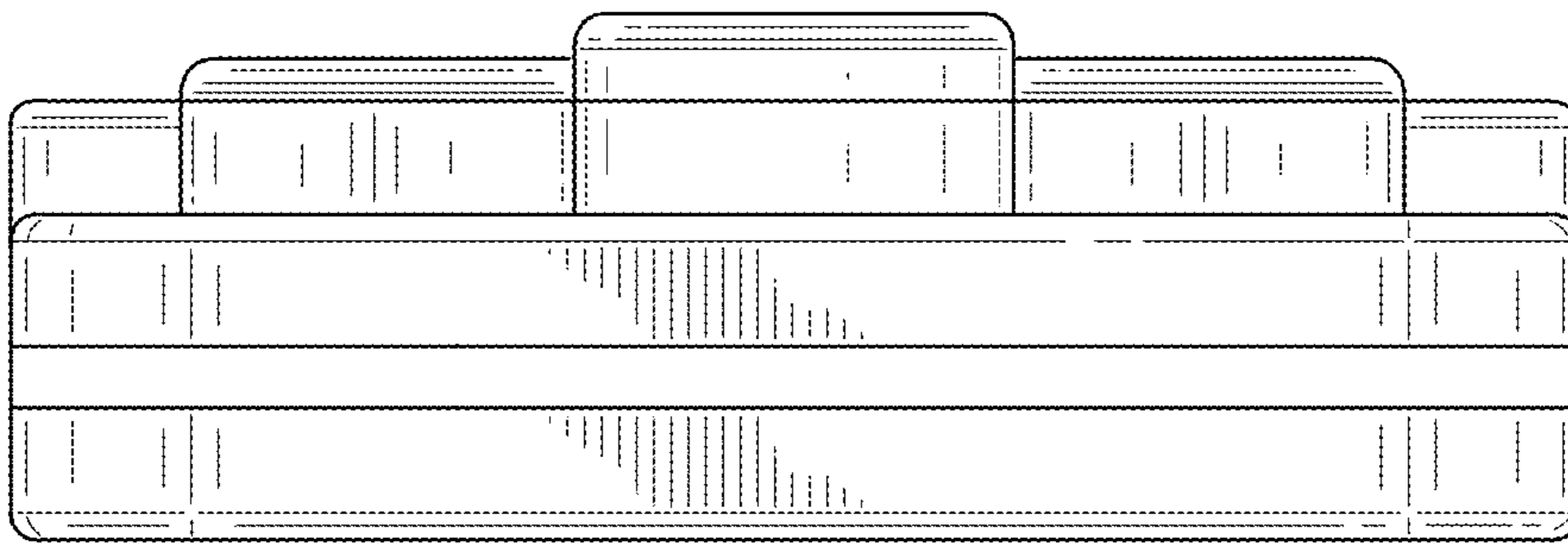

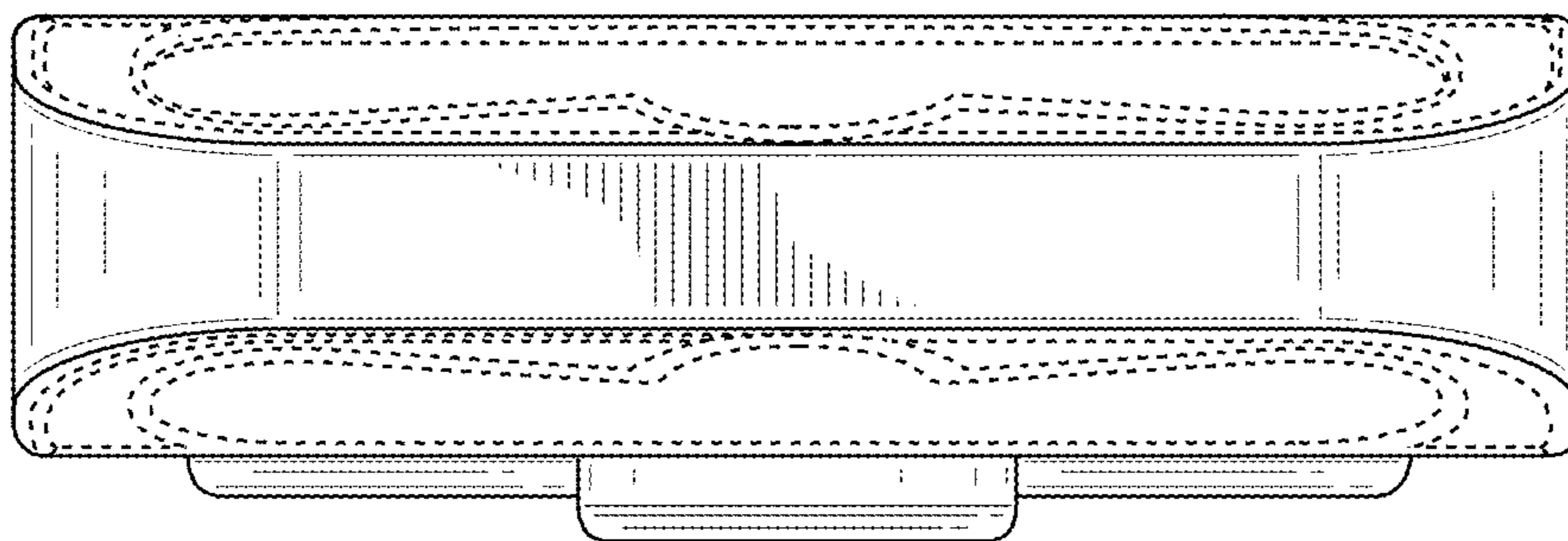

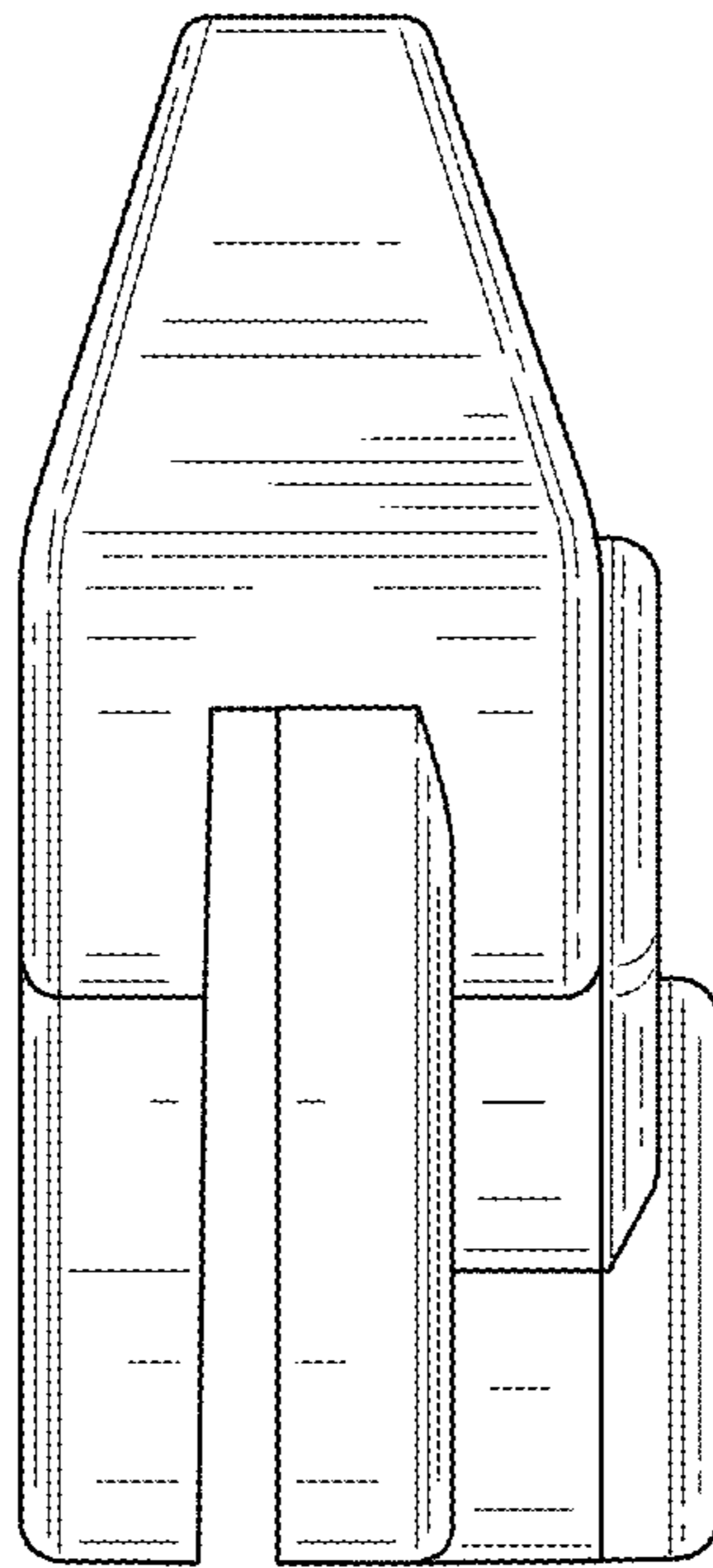

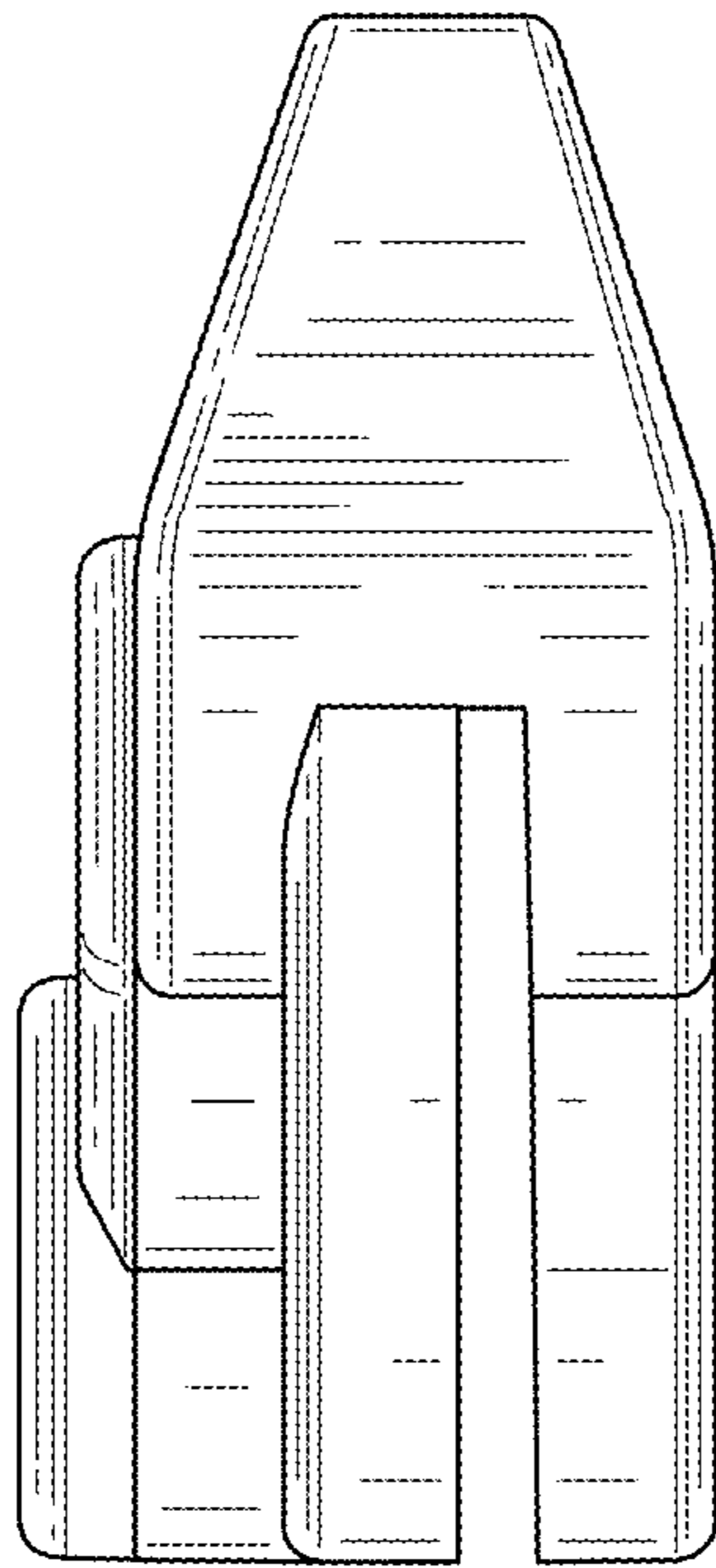
