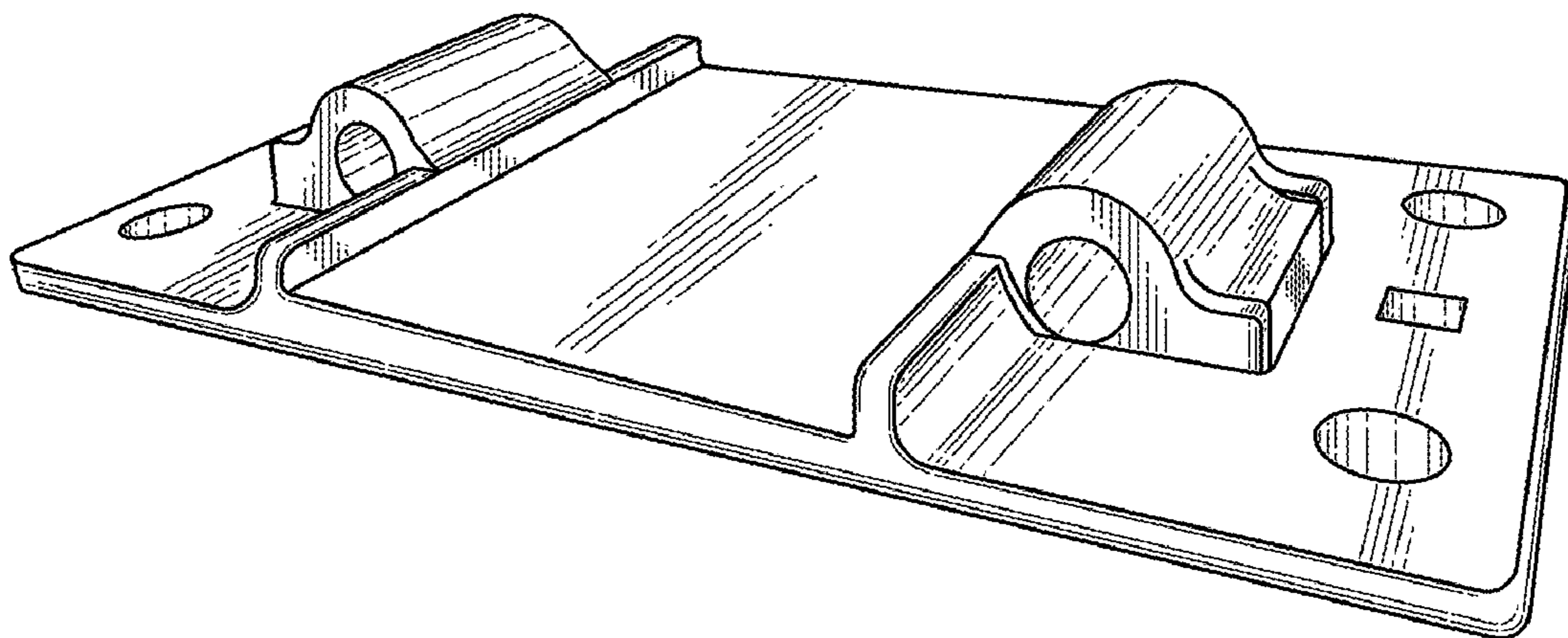
(57) **CLAIM**

The ornamental design for a hot forged tie plate for railroad, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hot forged tie plate for railroad showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left elevation view thereof; and, FIG. 7 is a right elevation view thereof. 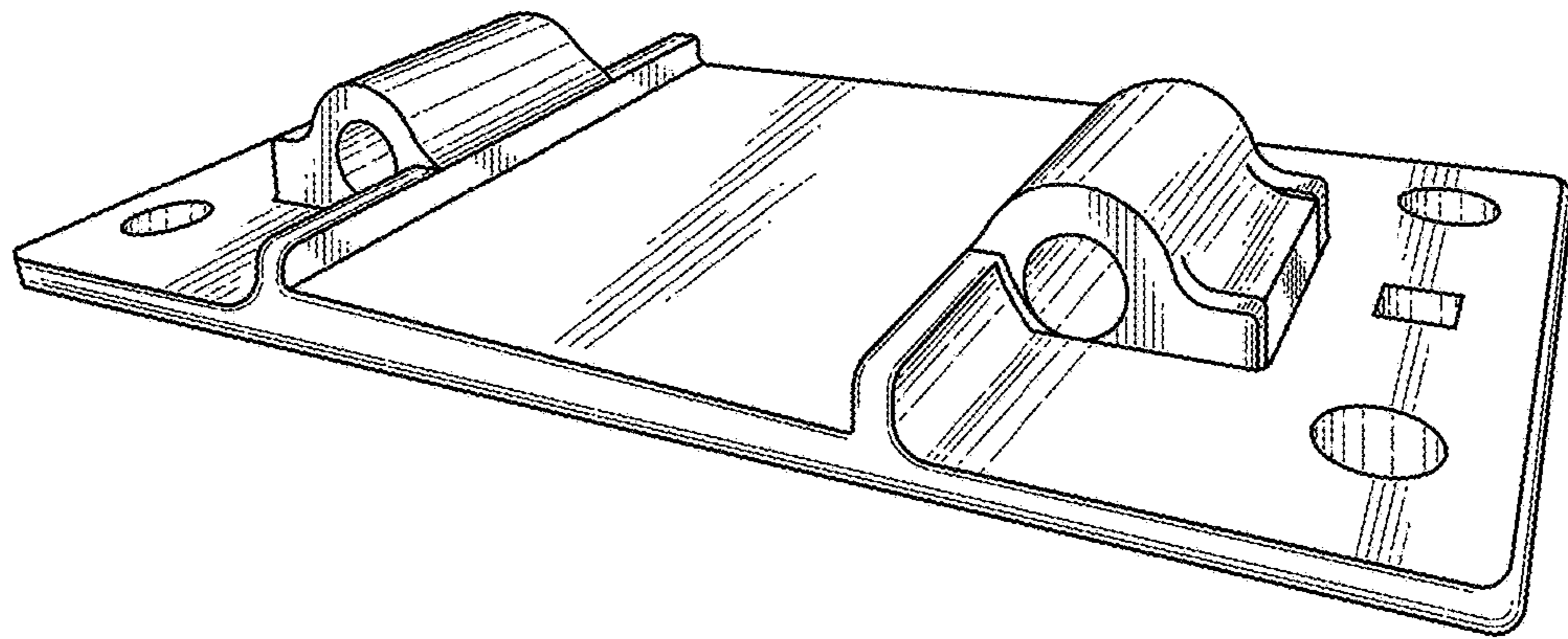

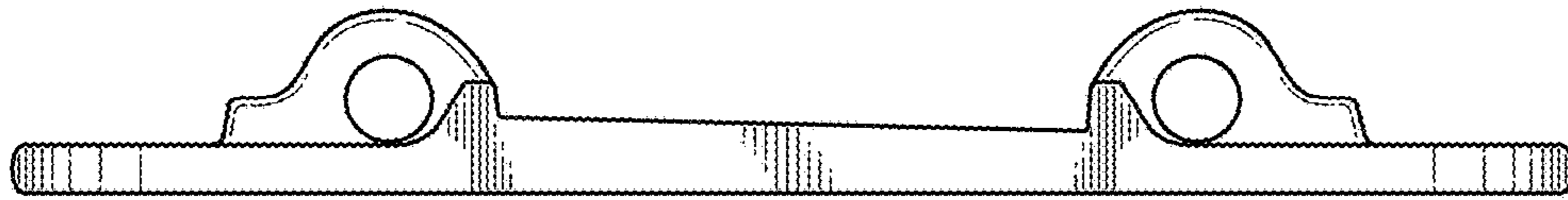

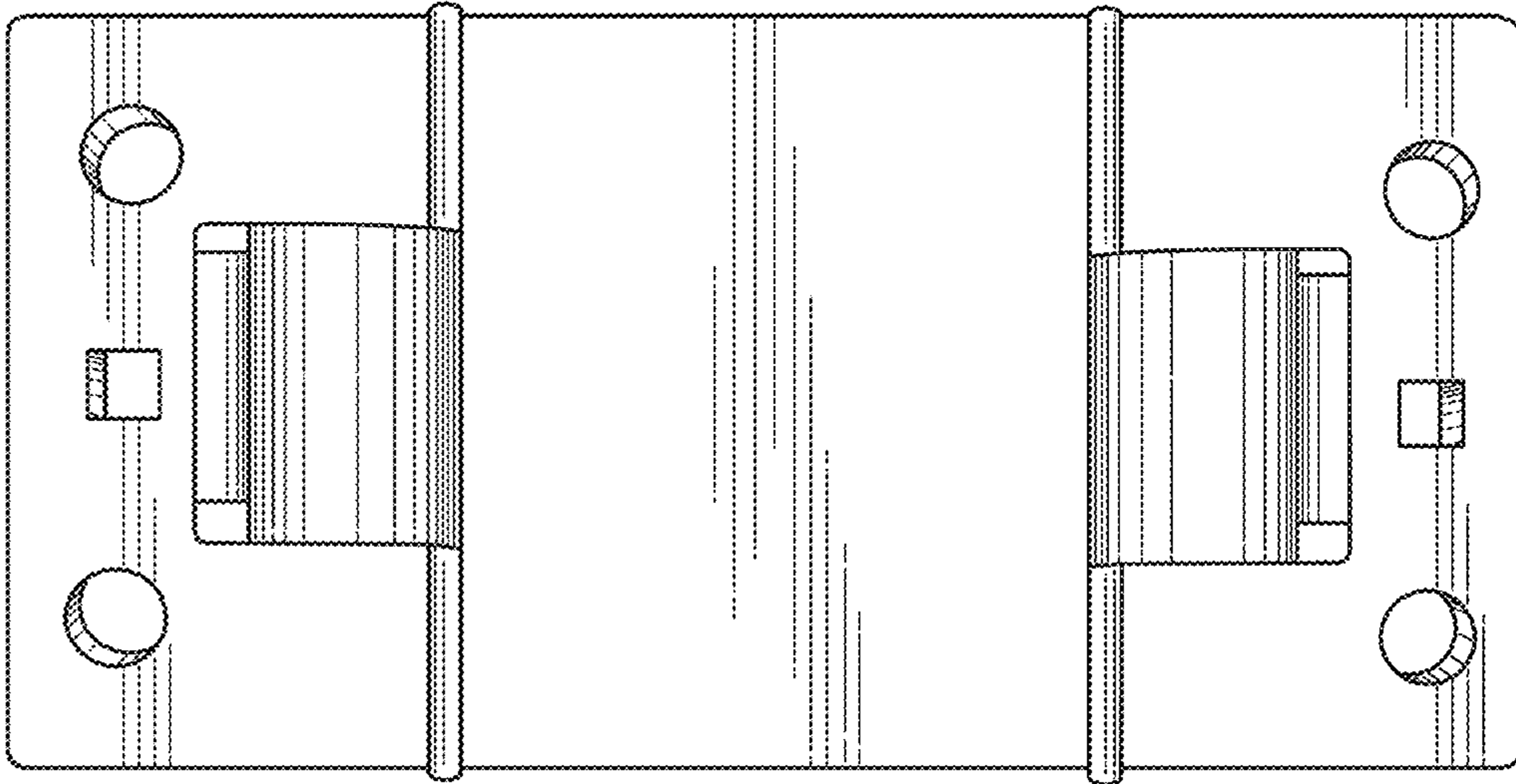

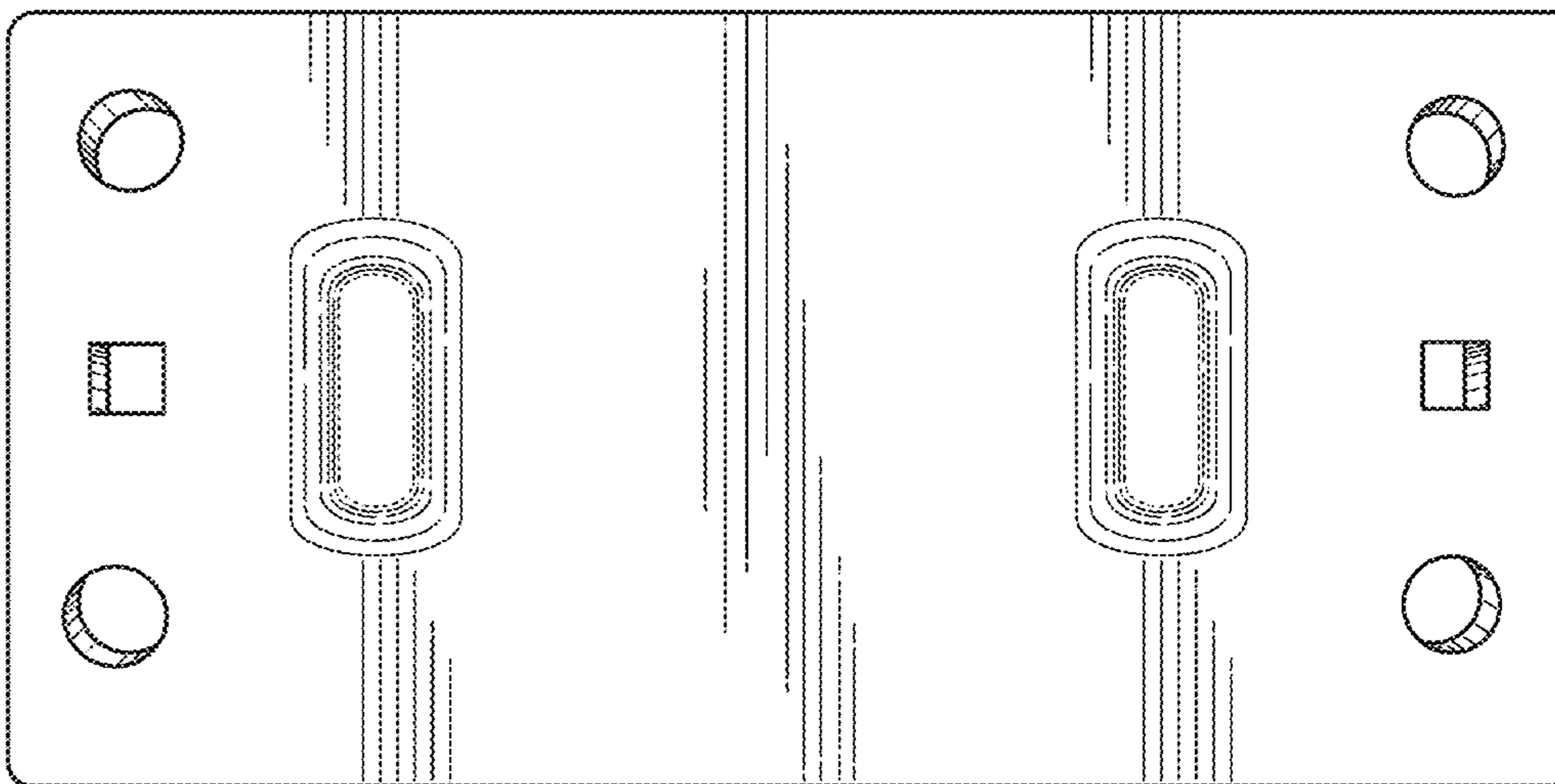

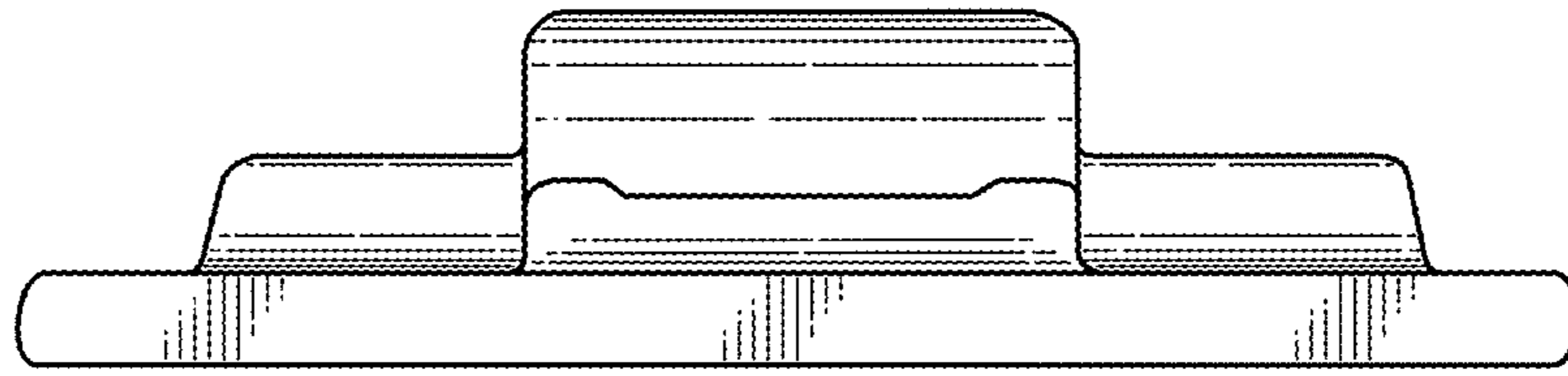

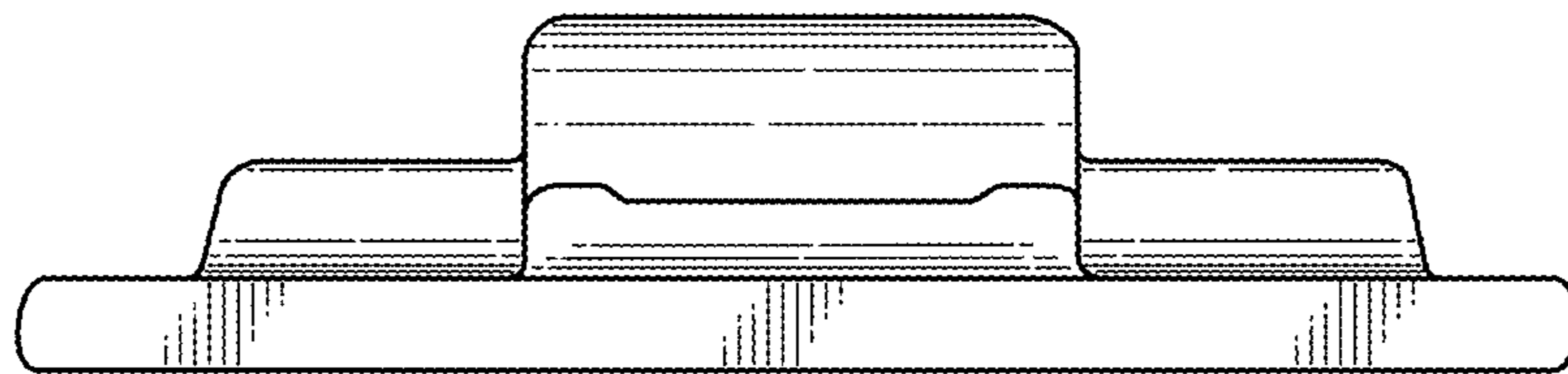
