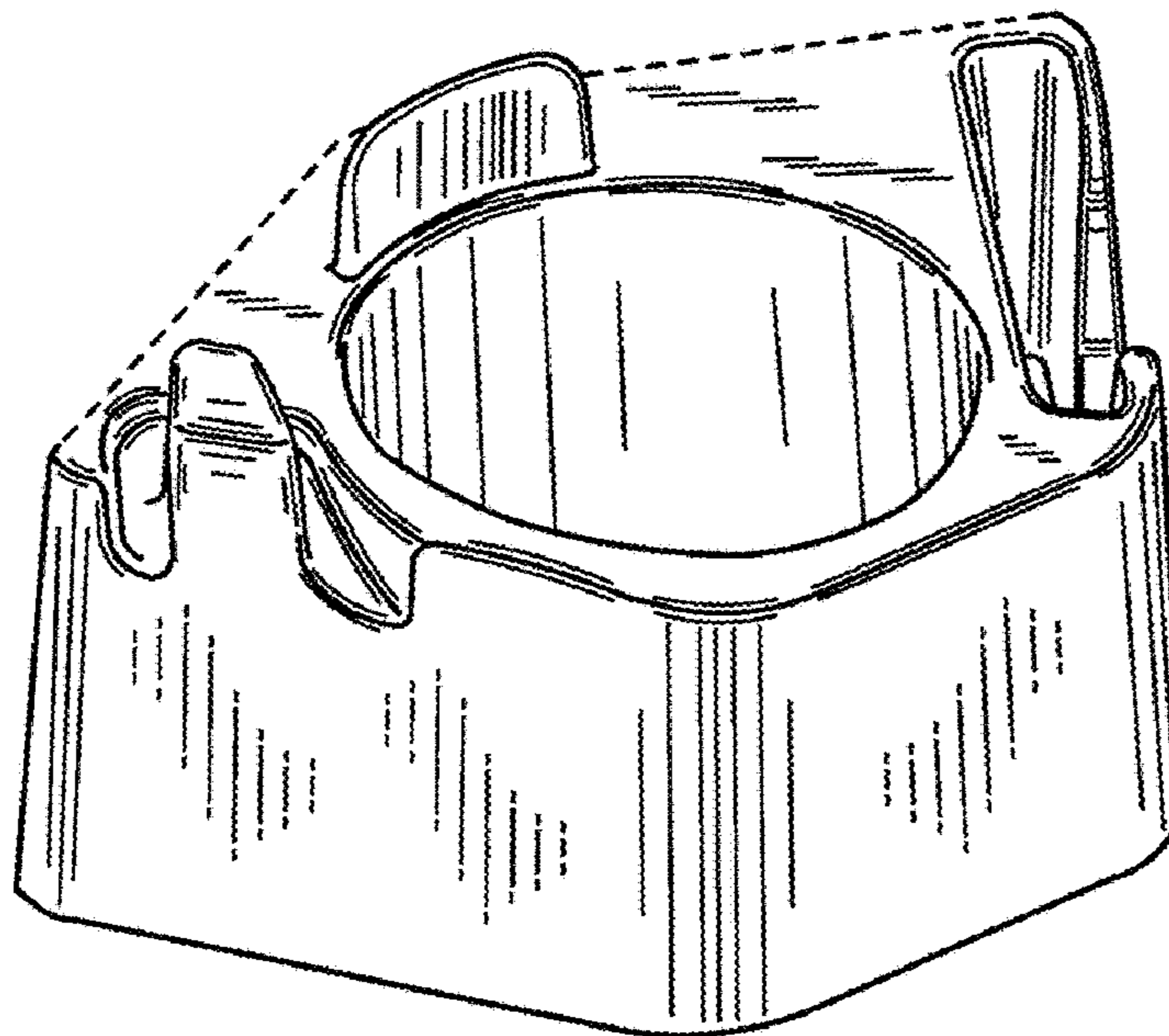
The ornamental design for a cup holder, as shown and described.

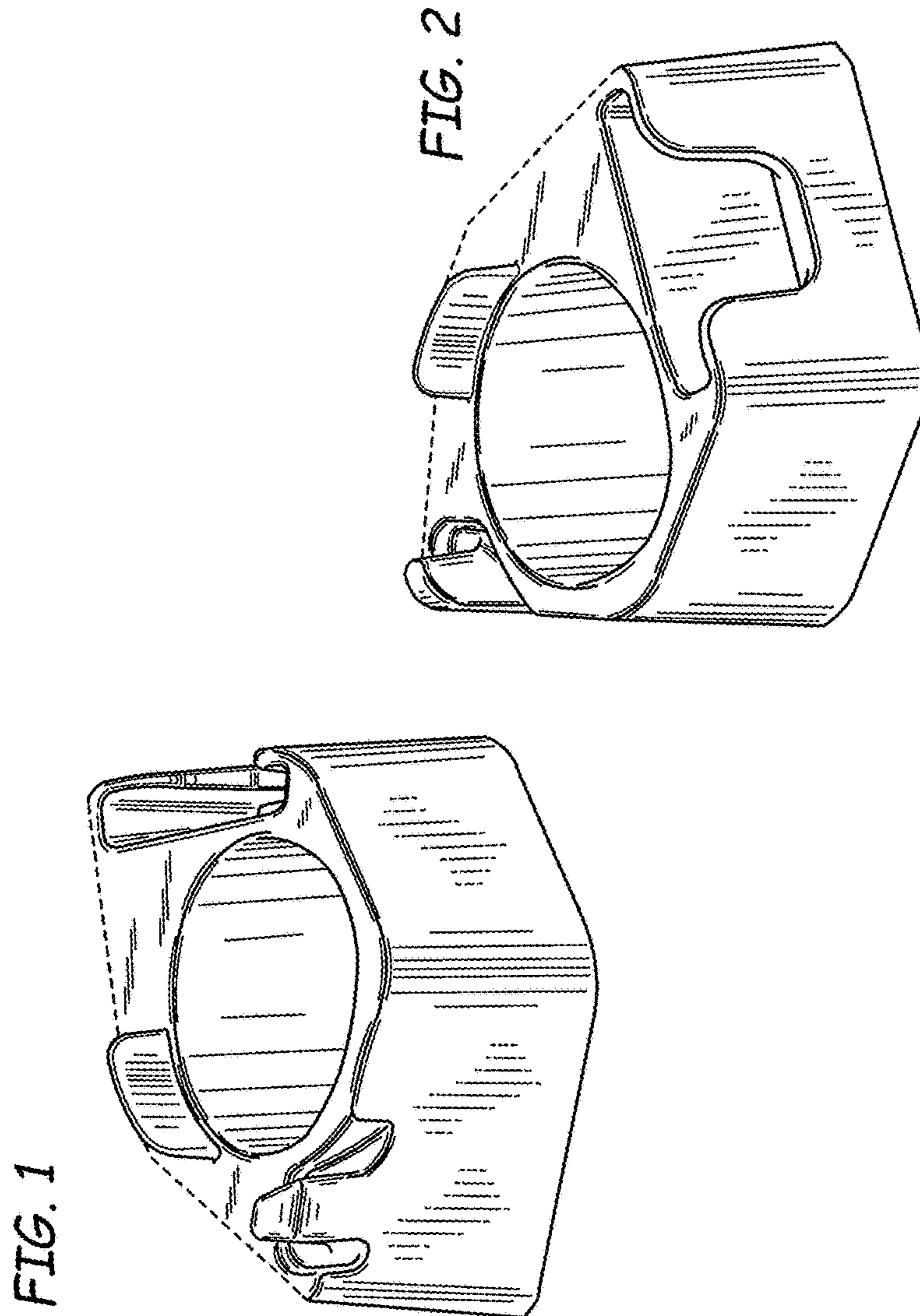
DESCRIPTION

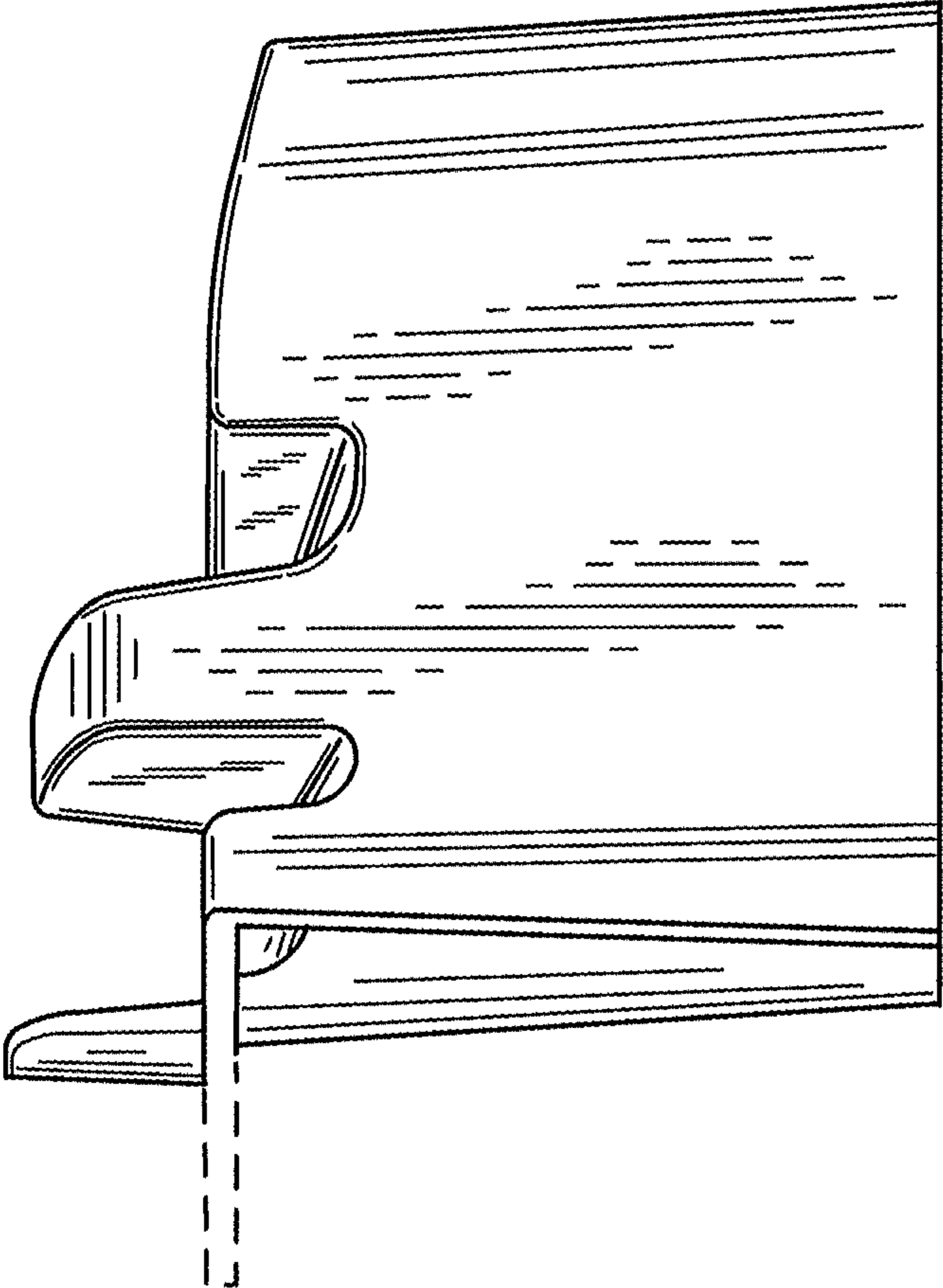

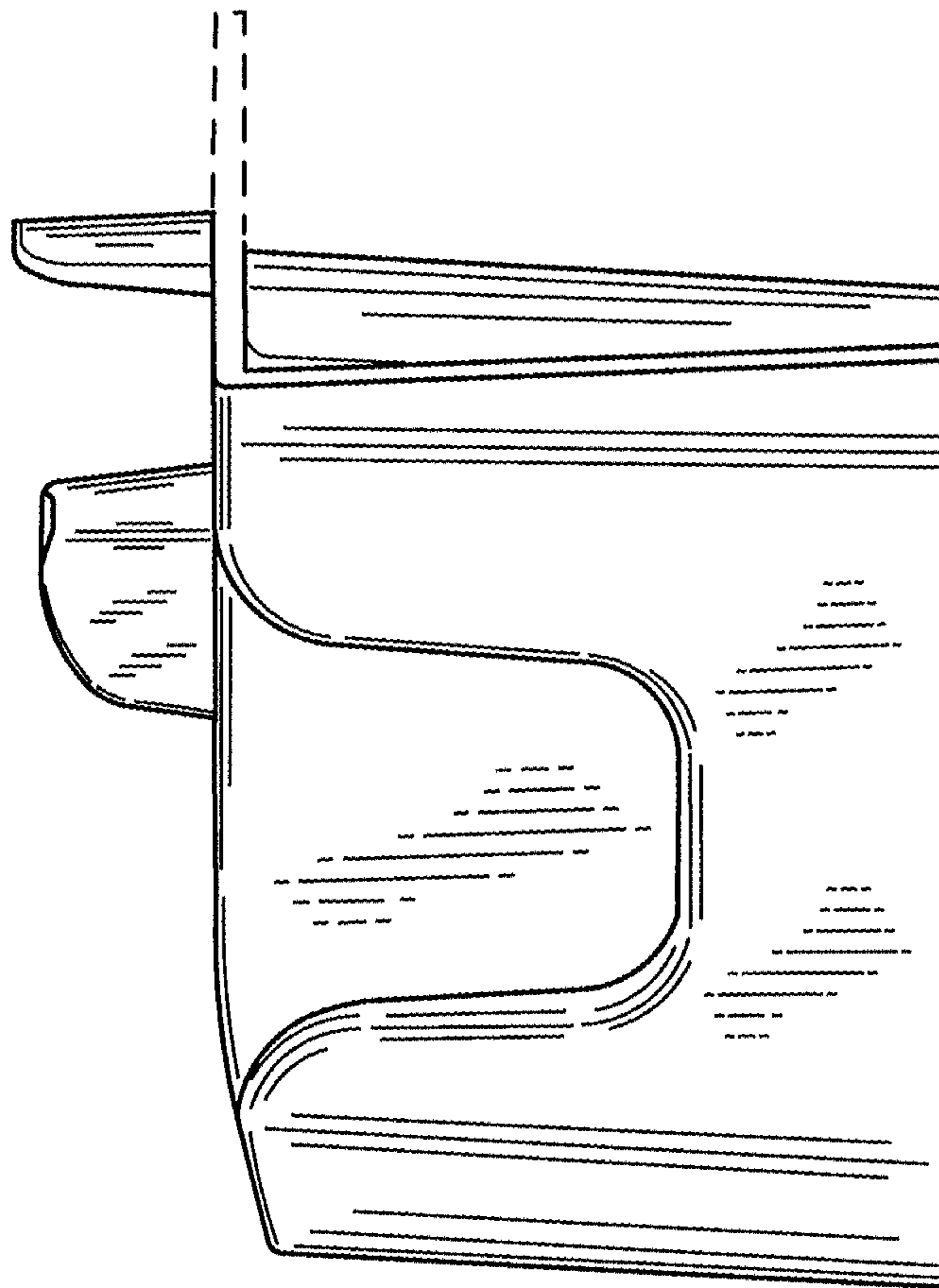

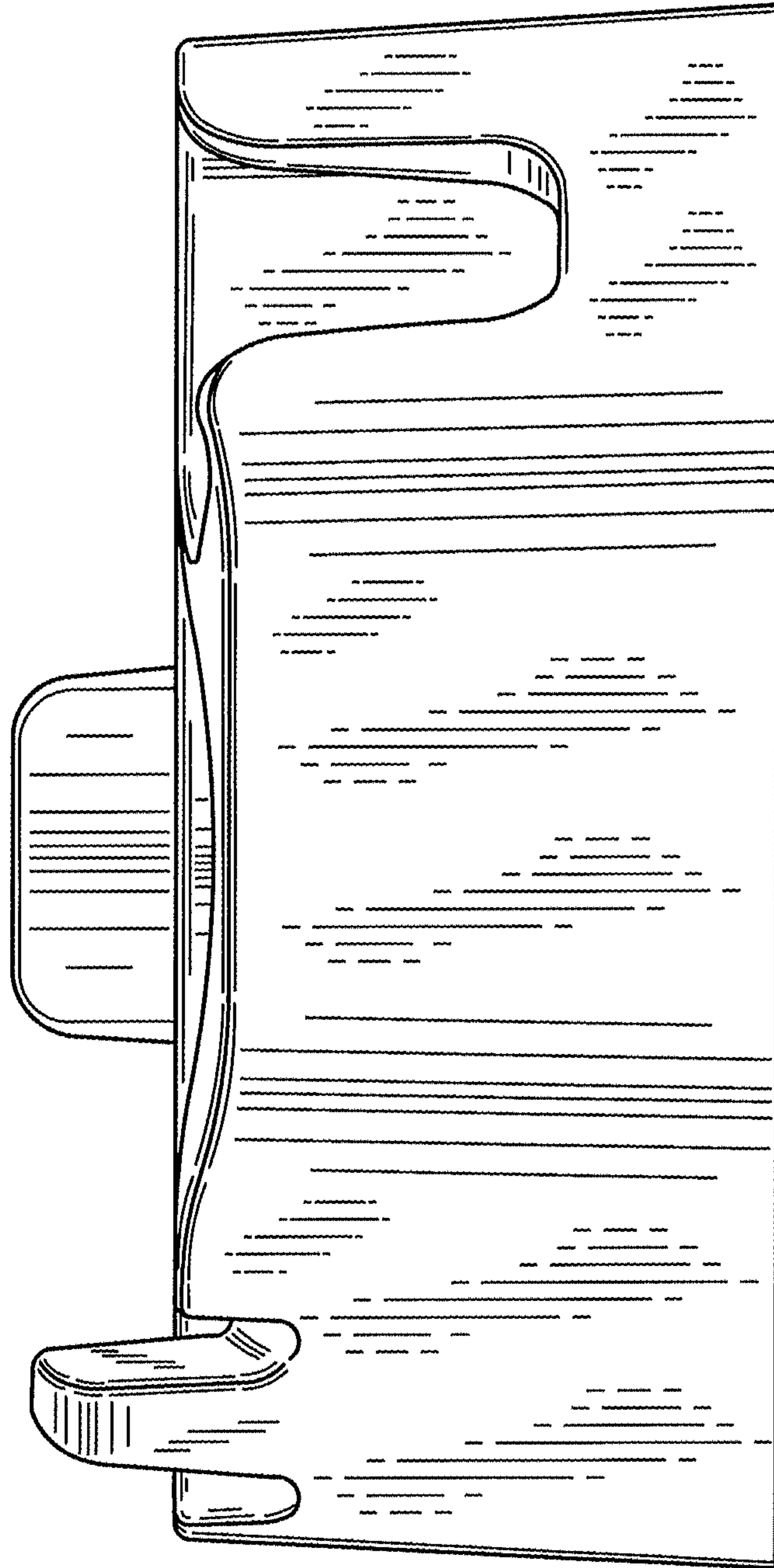

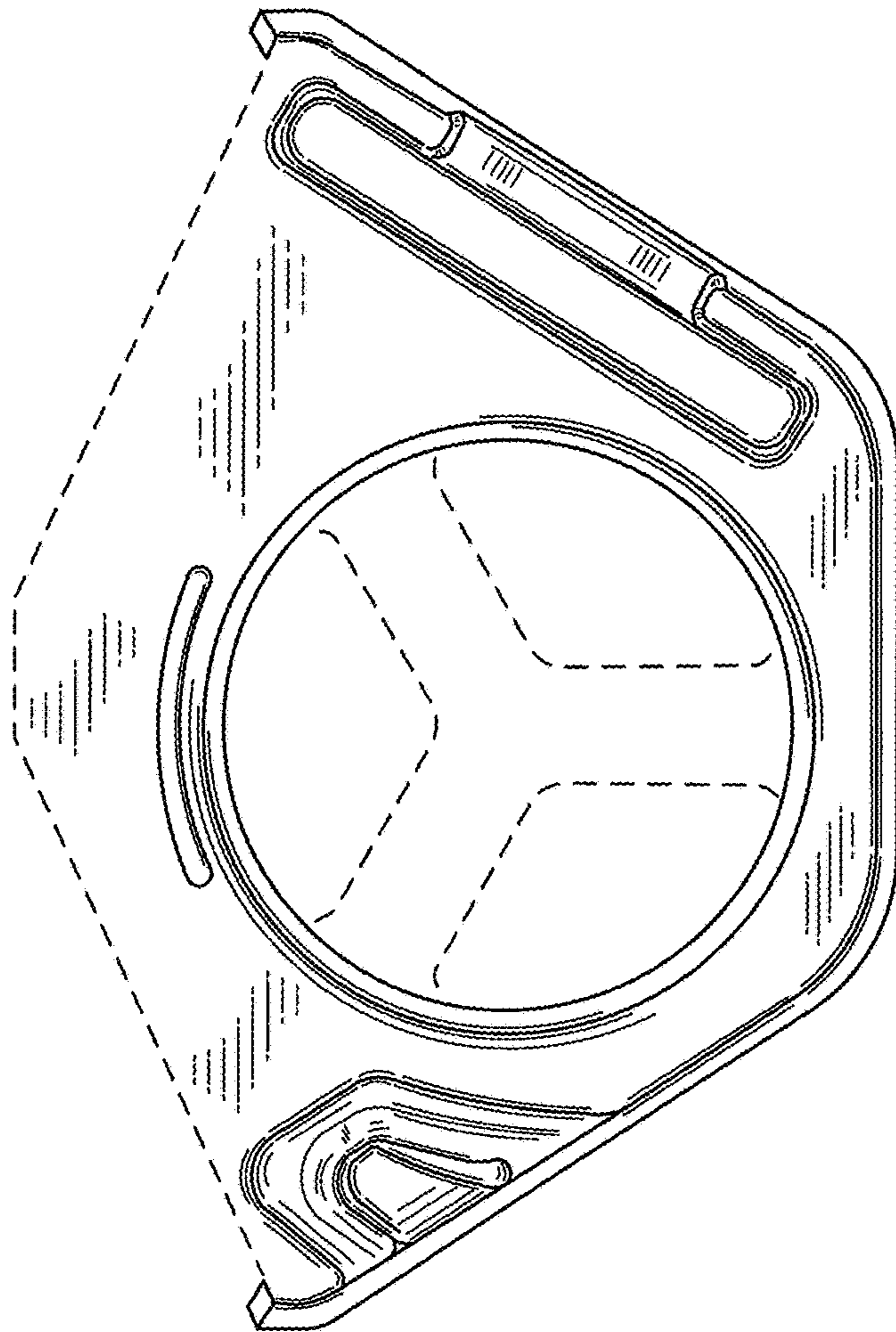
