**DESCRIPTION**

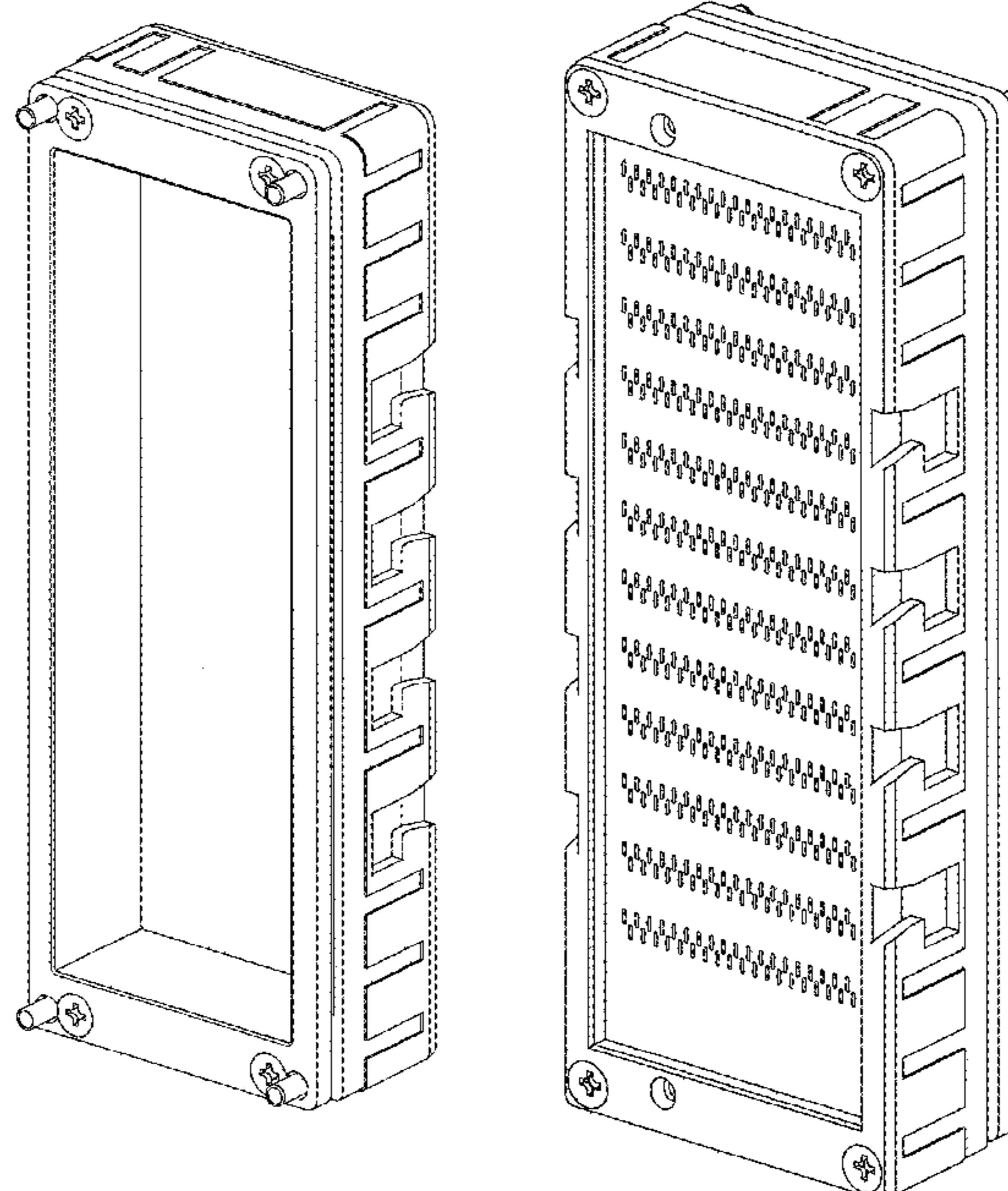

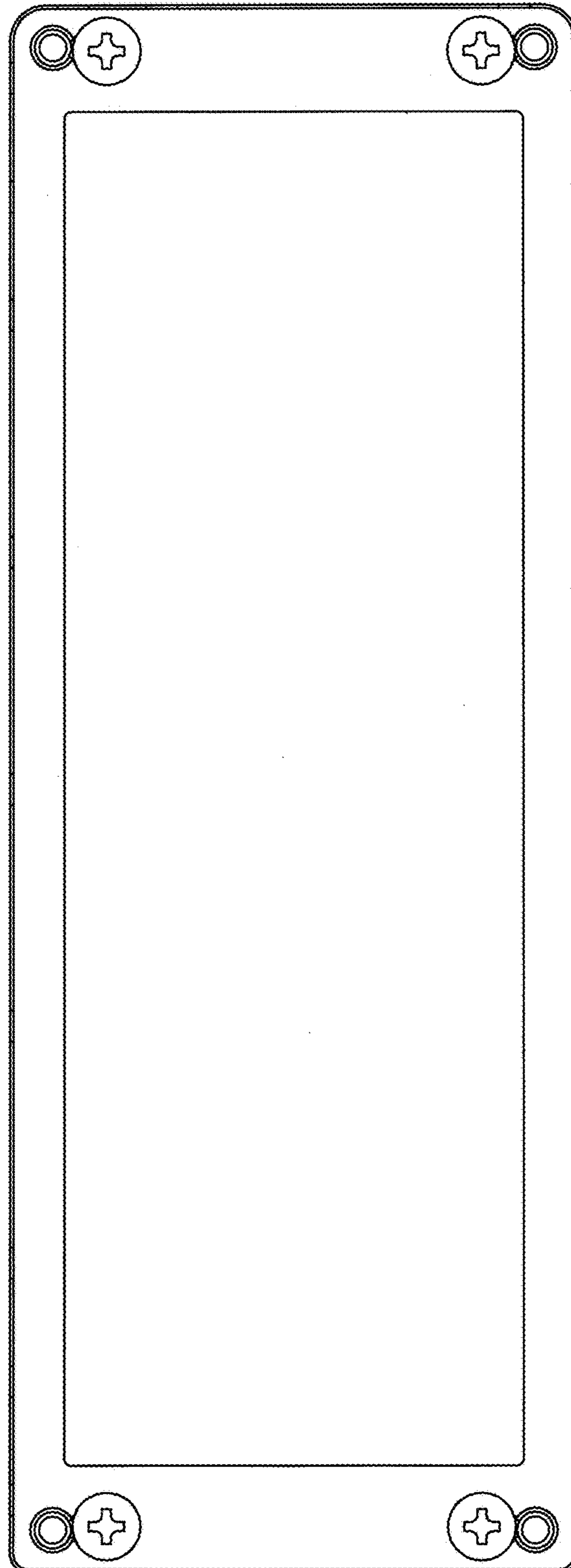

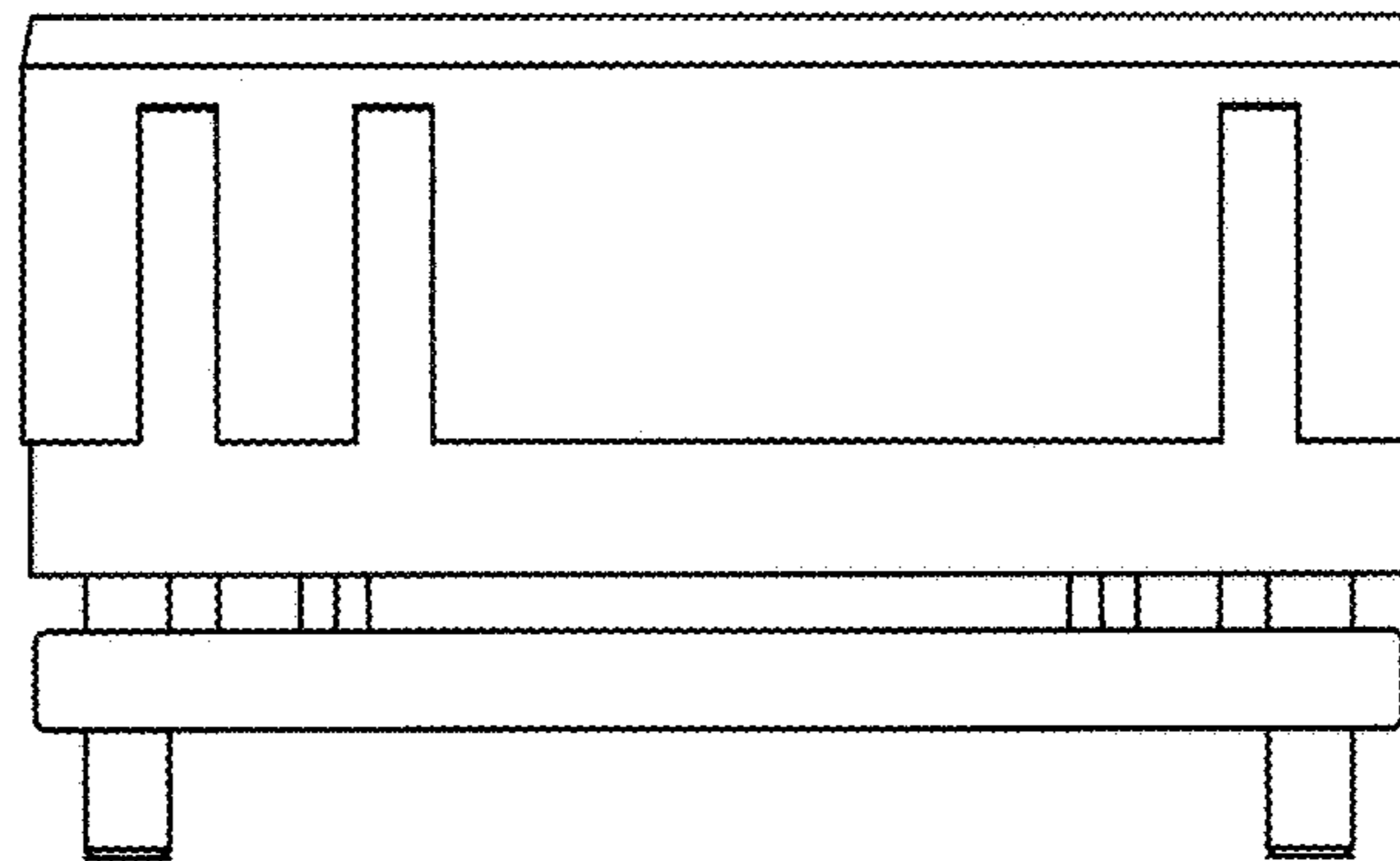

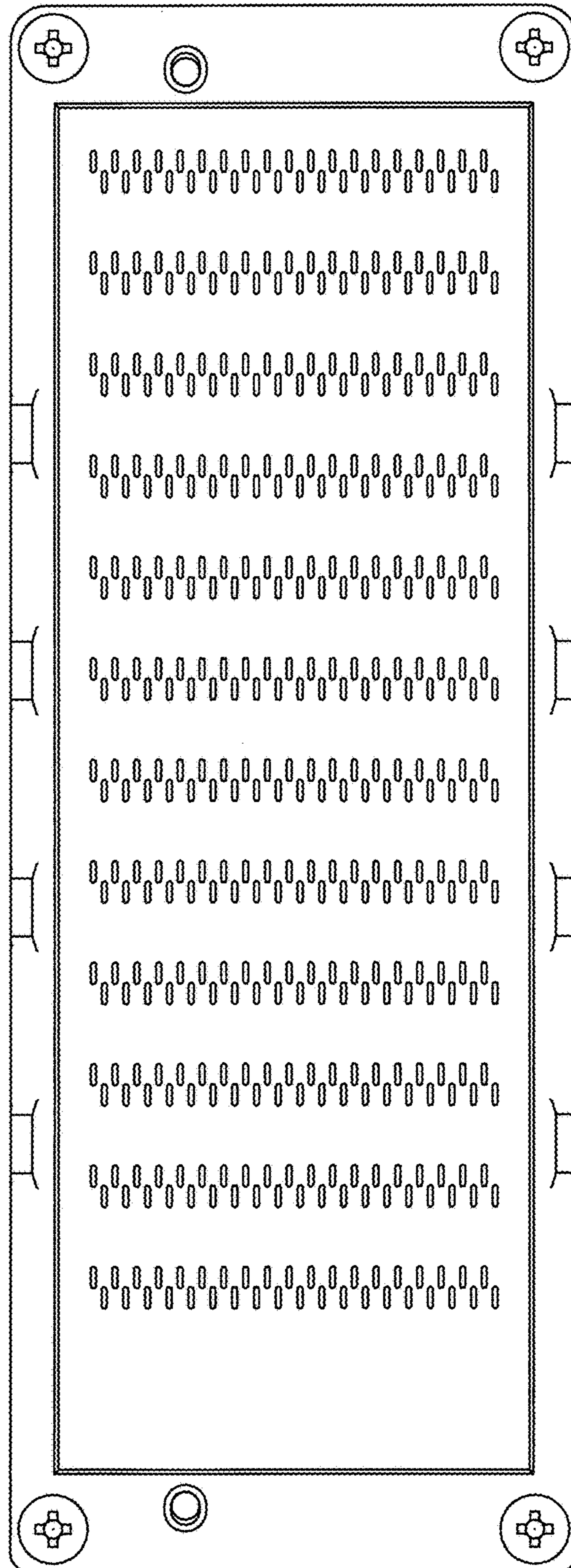

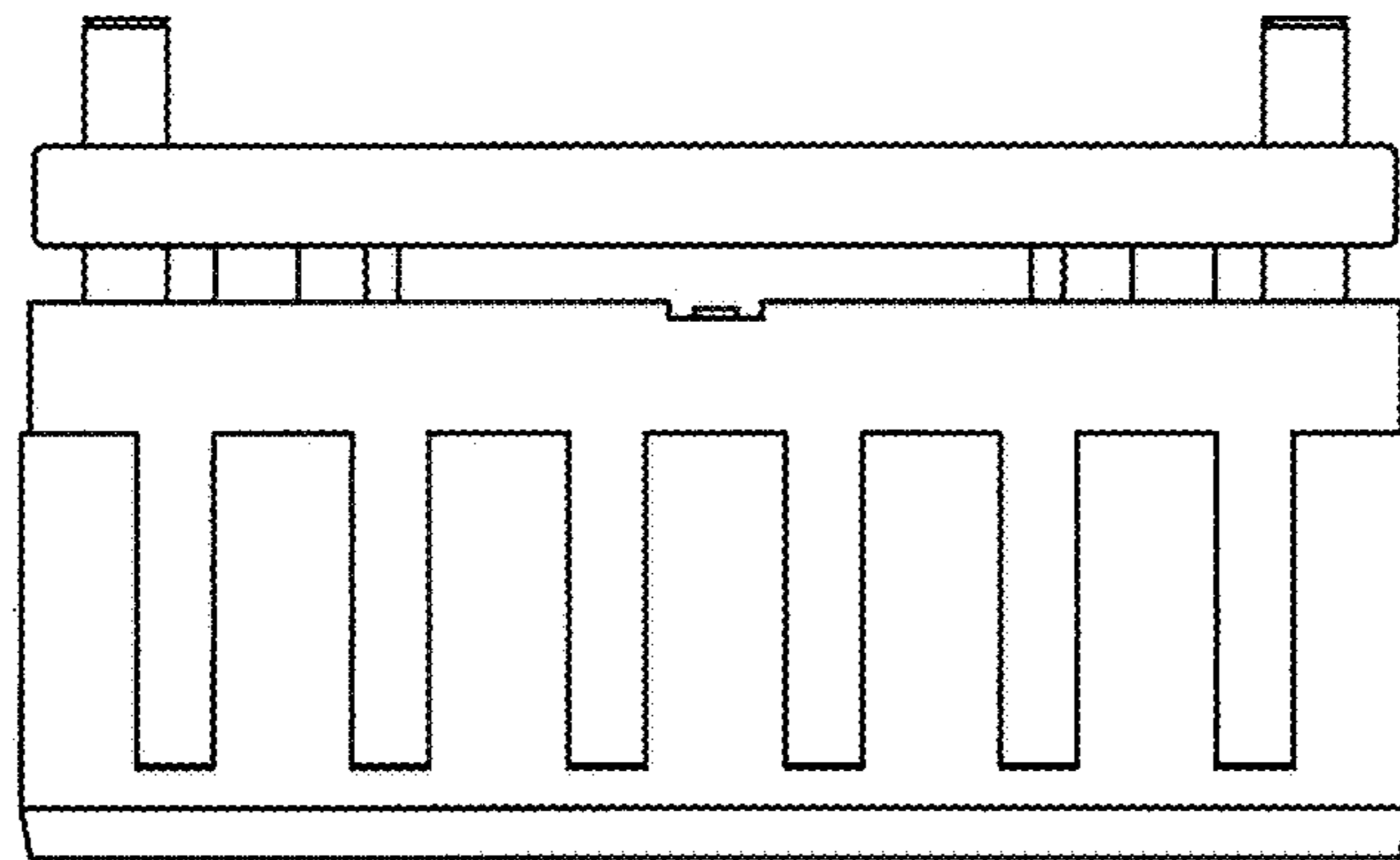

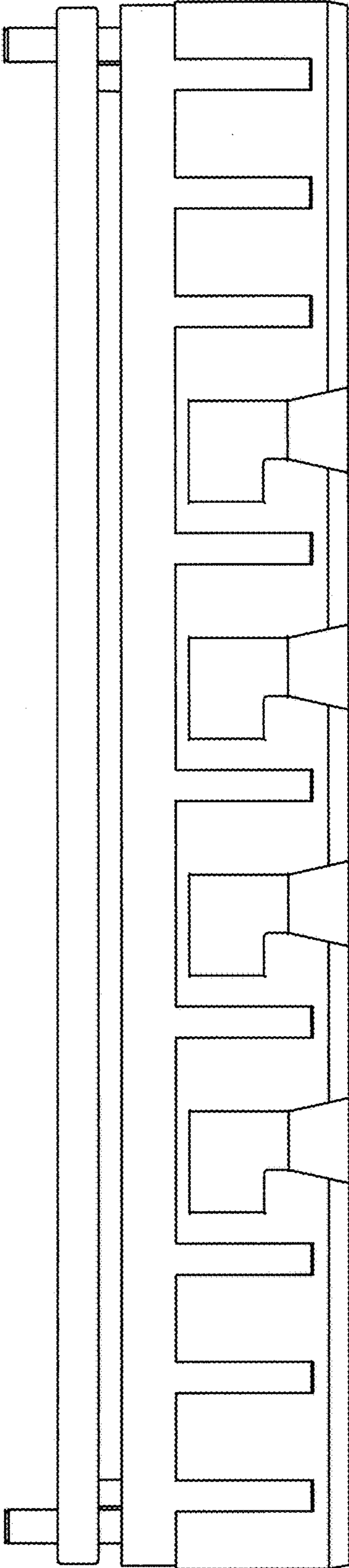

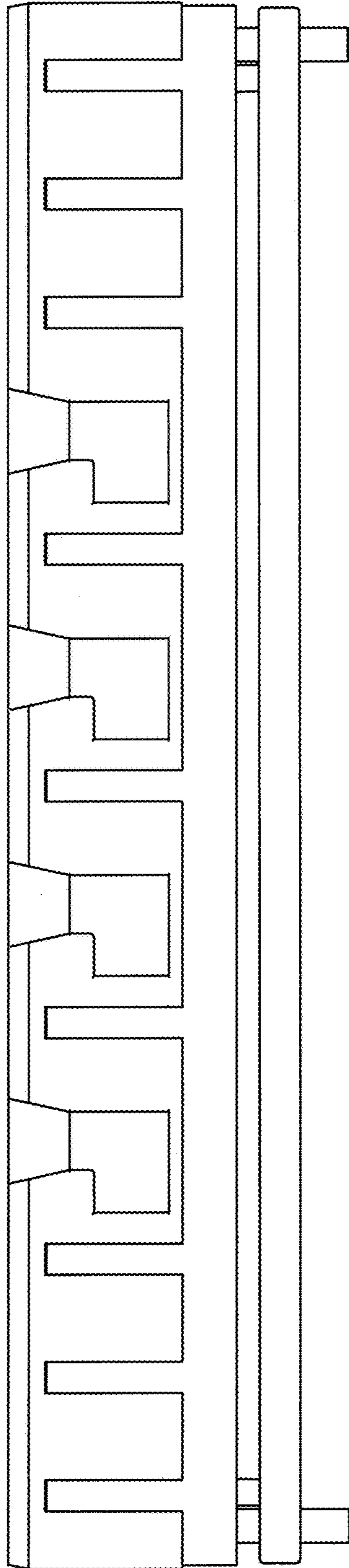

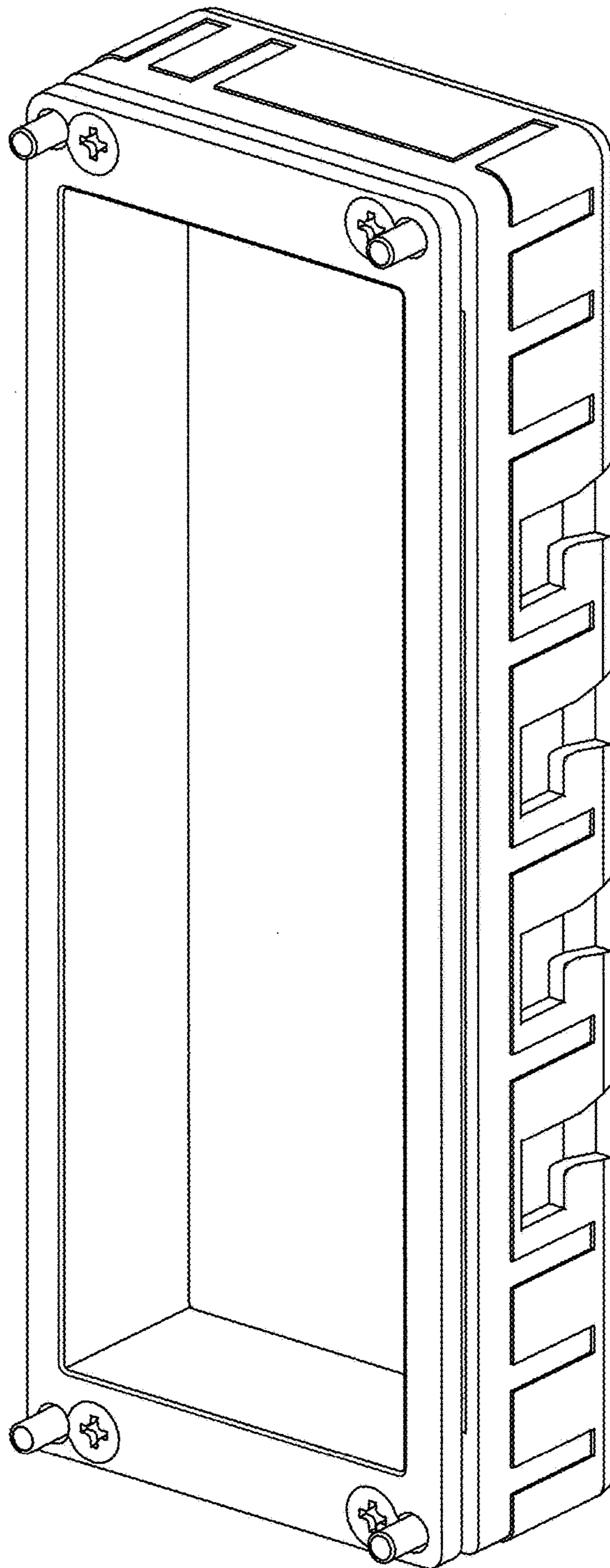

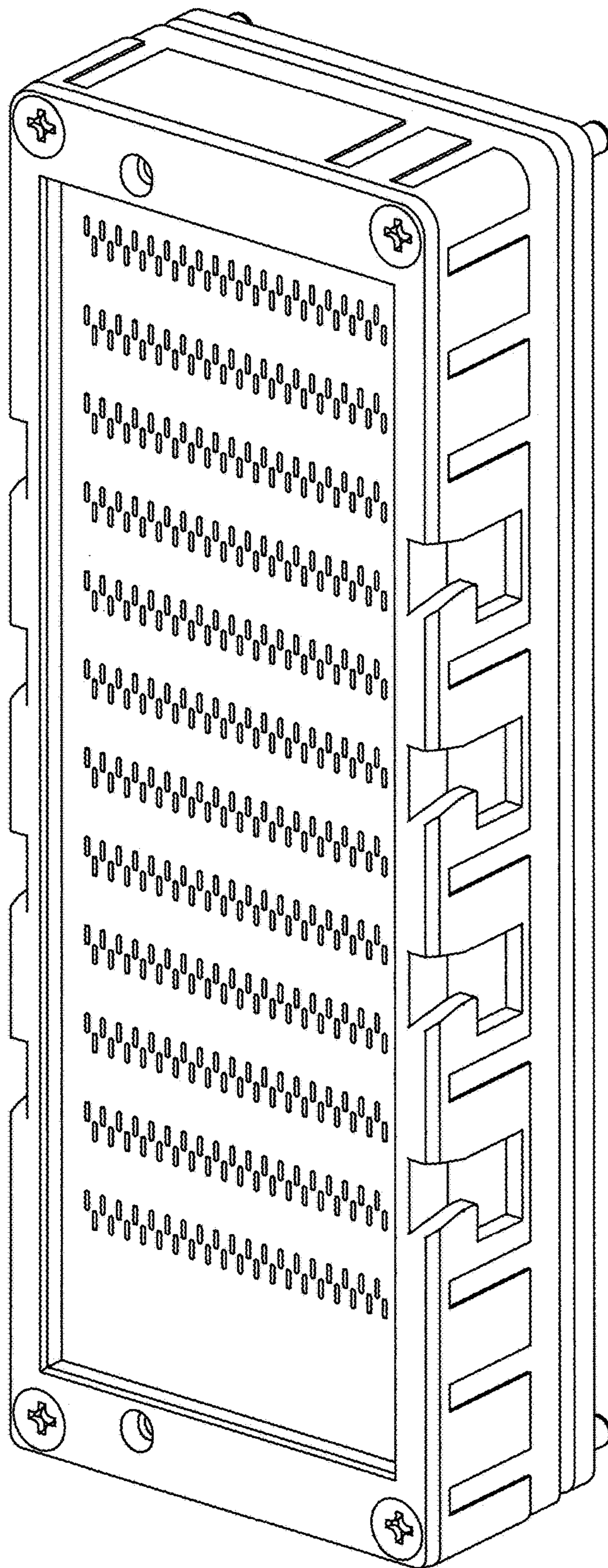

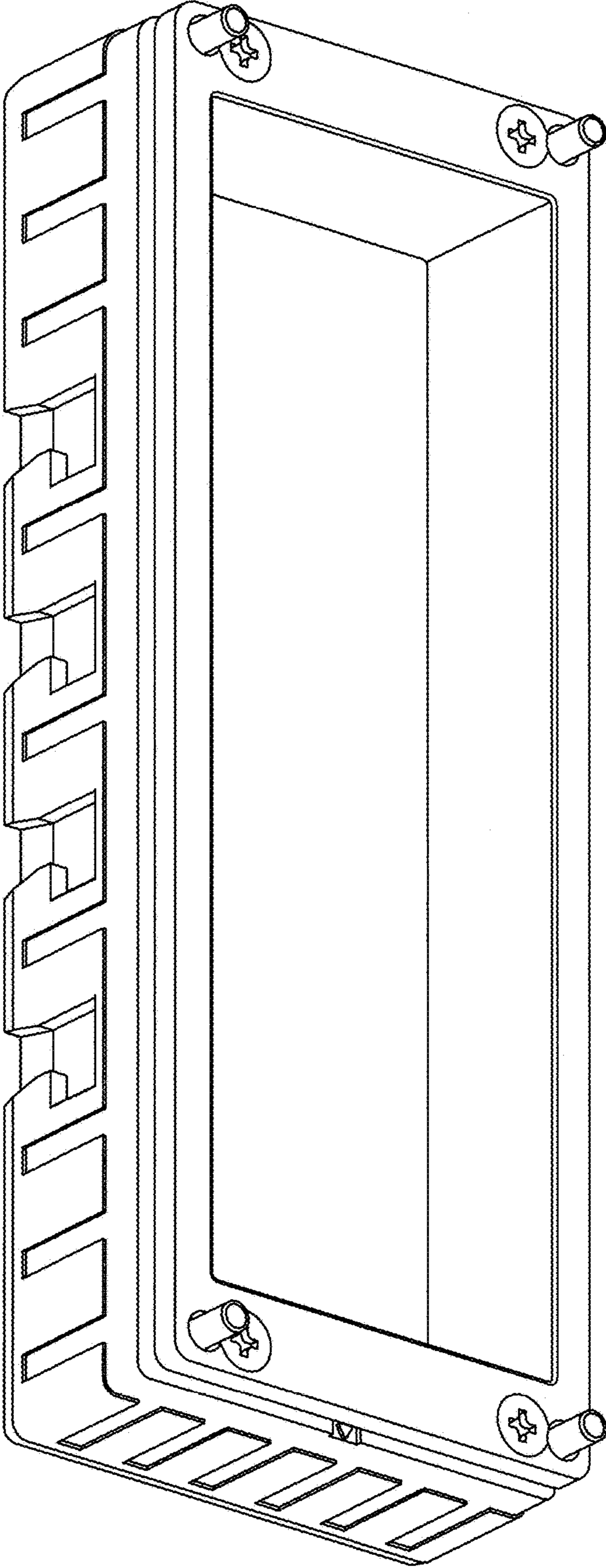
