**DESCRIPTION**

FIG. 1 is a front elevation view of an electrical connector, showing our new design;

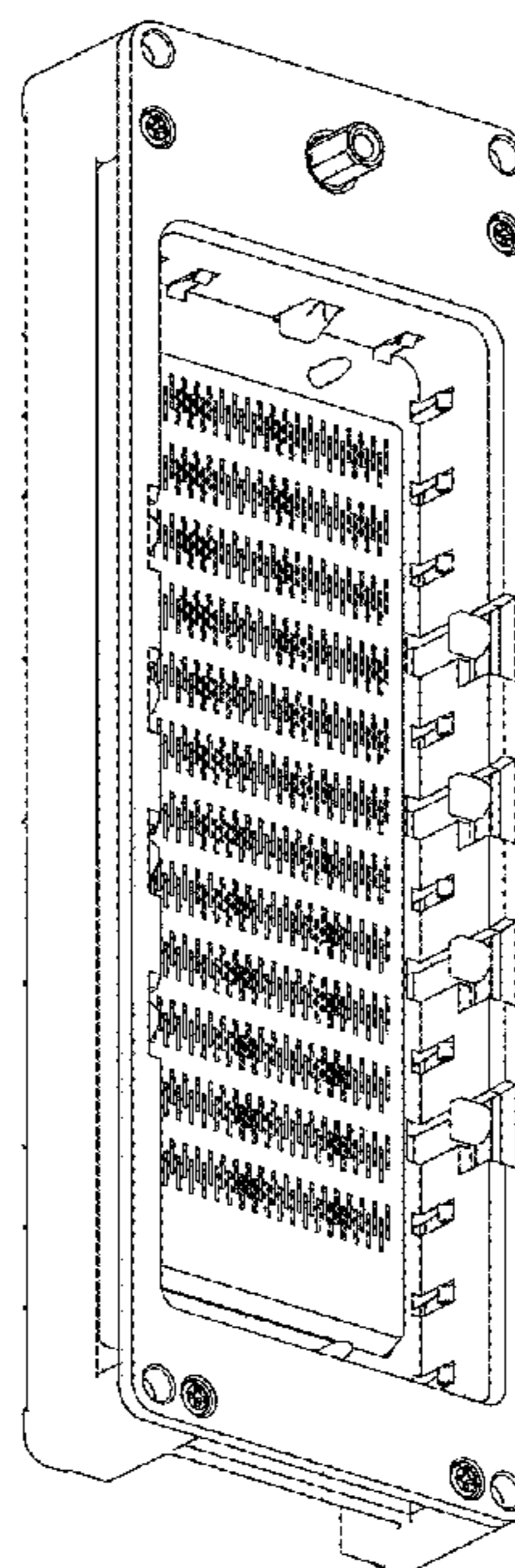
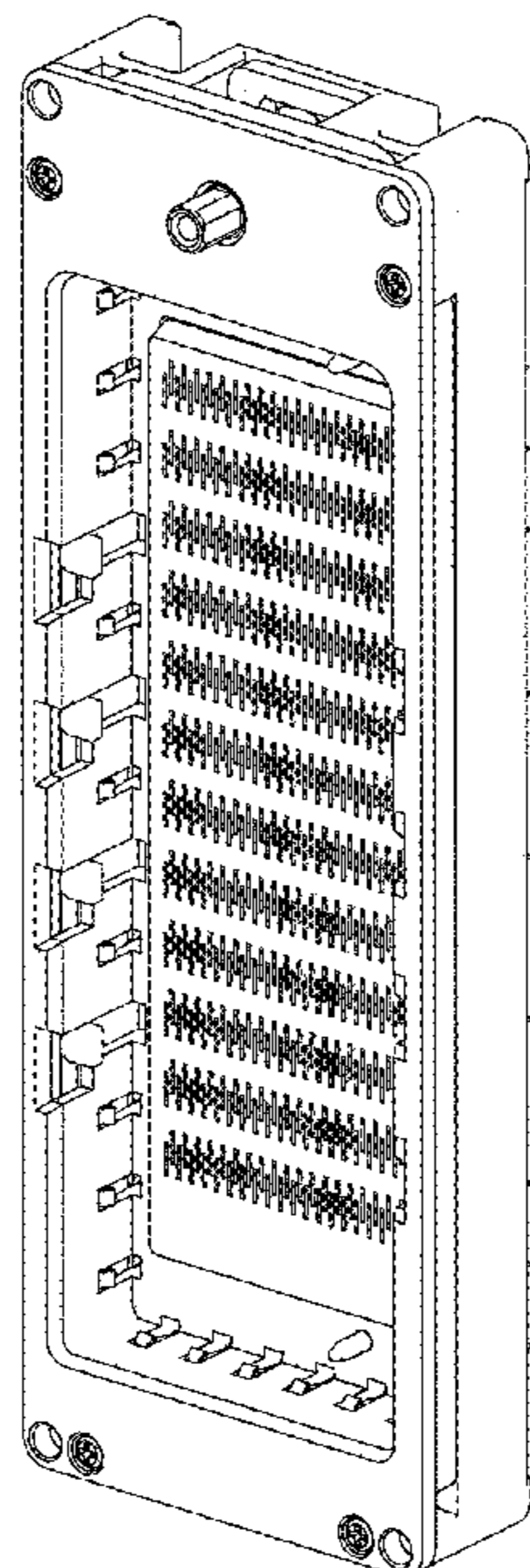

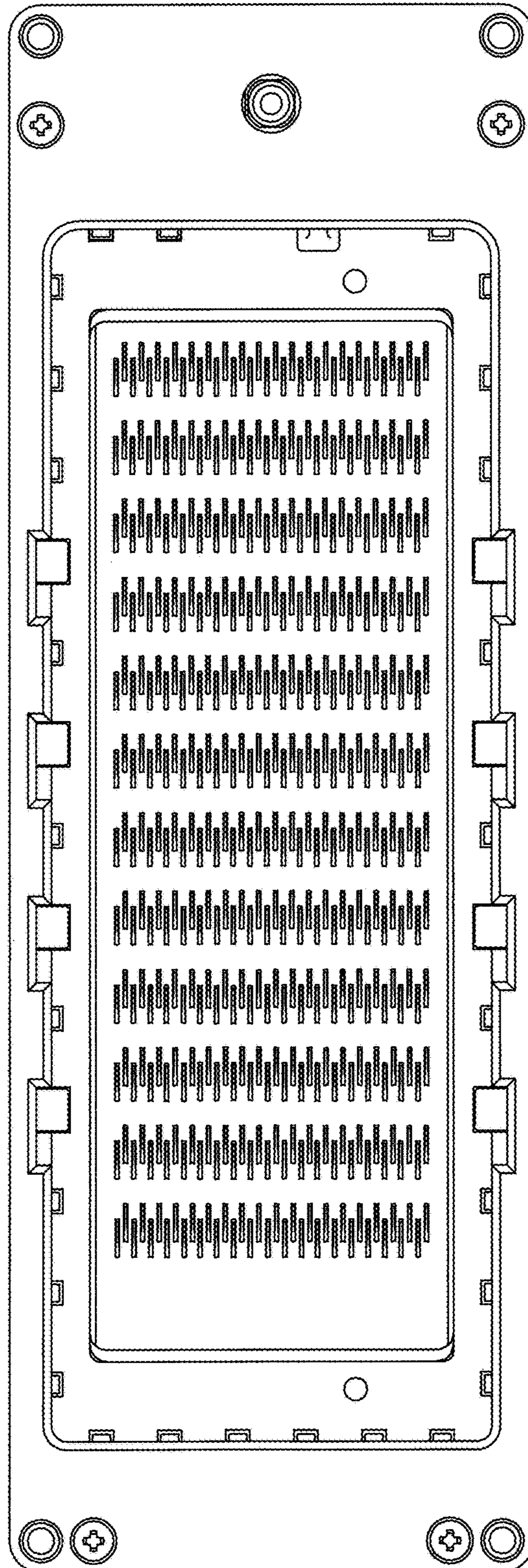

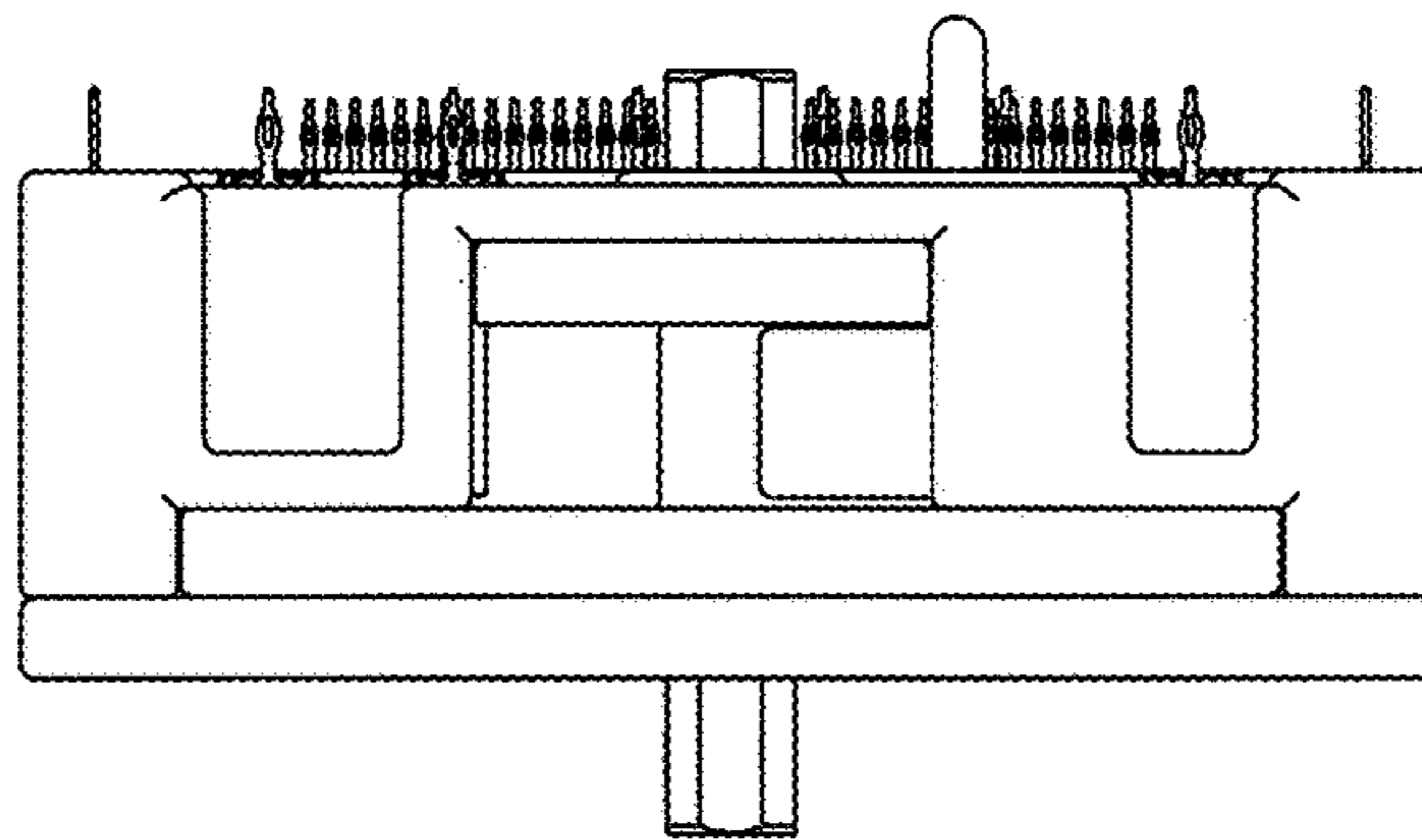

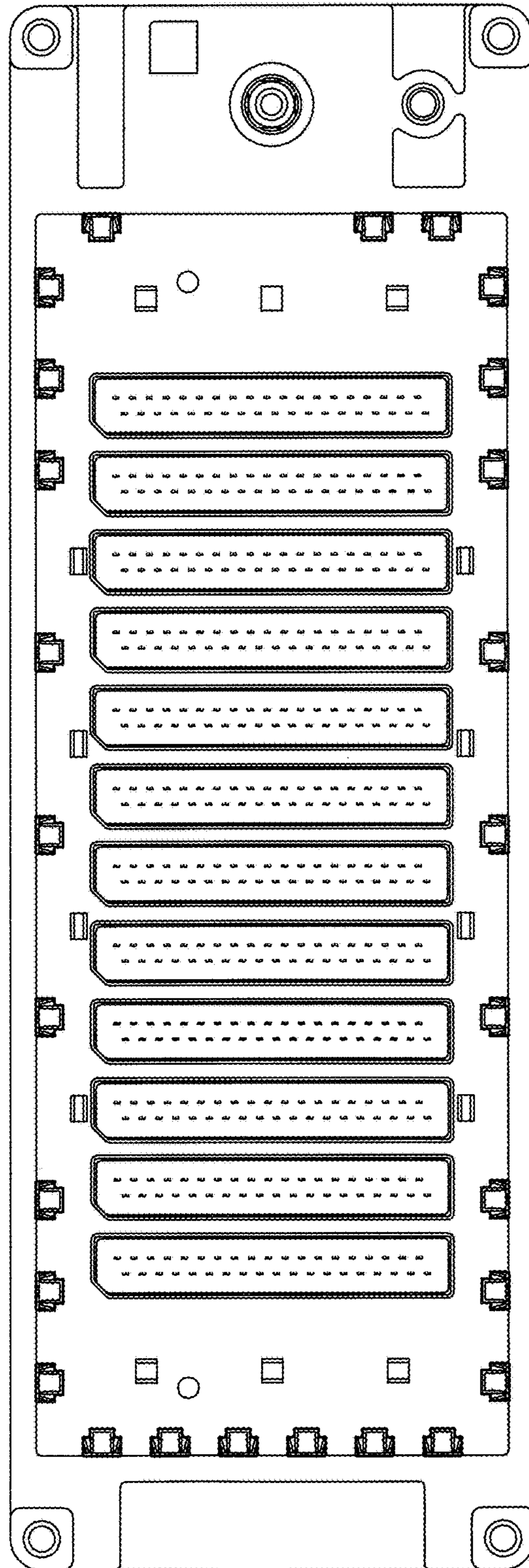

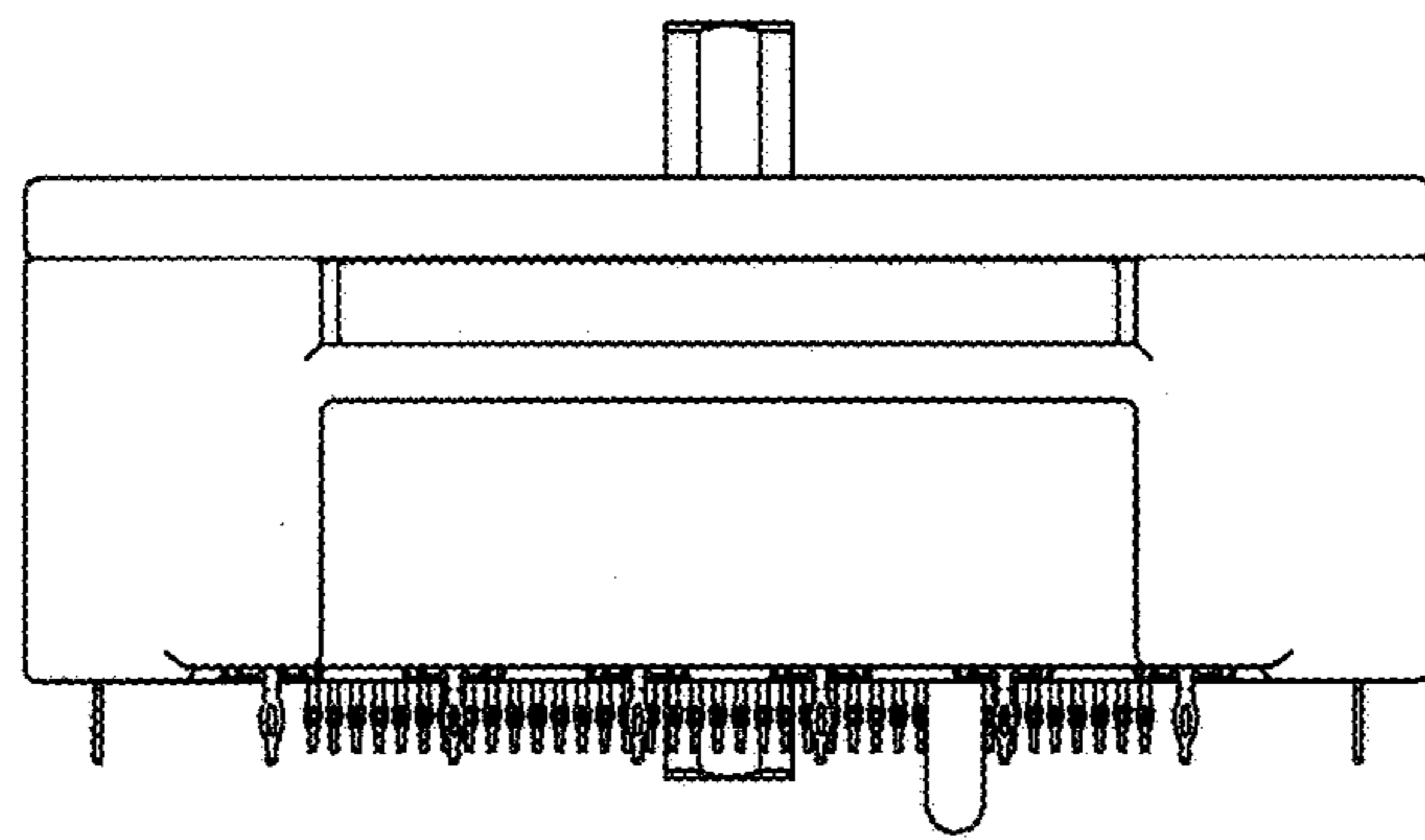

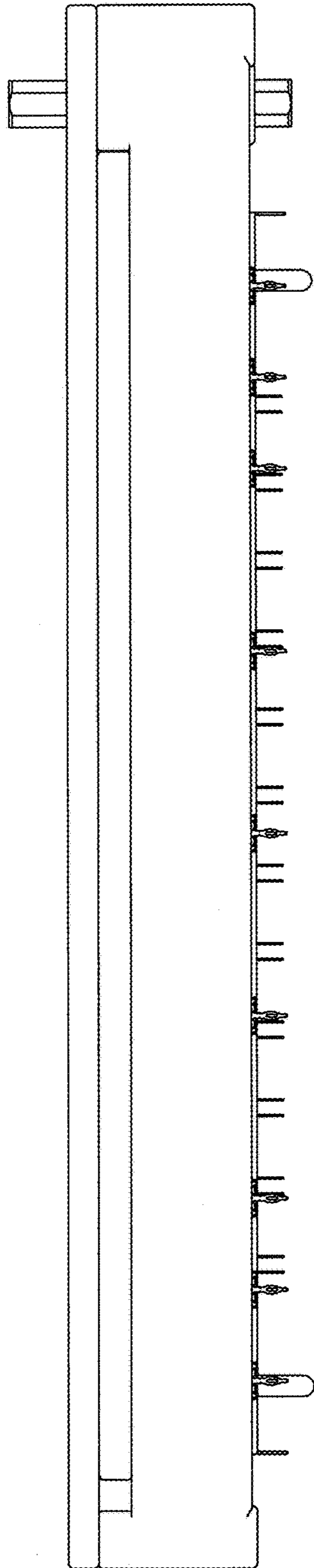

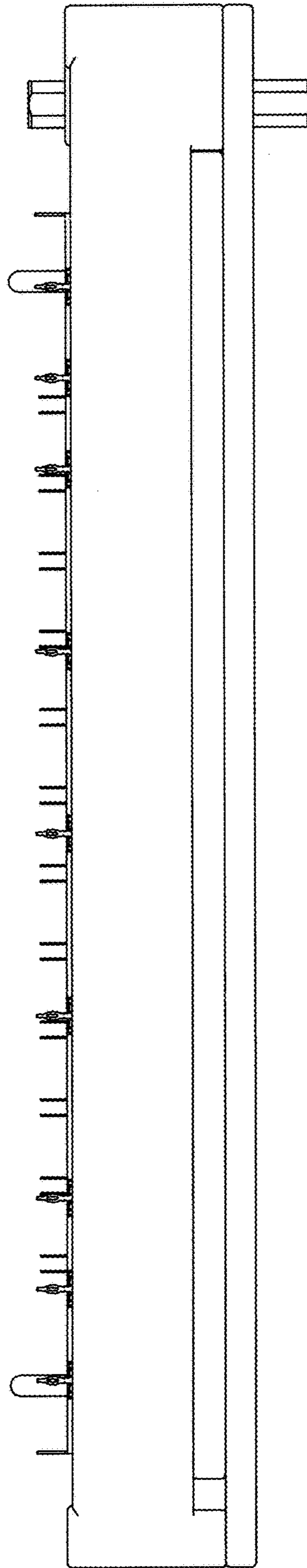

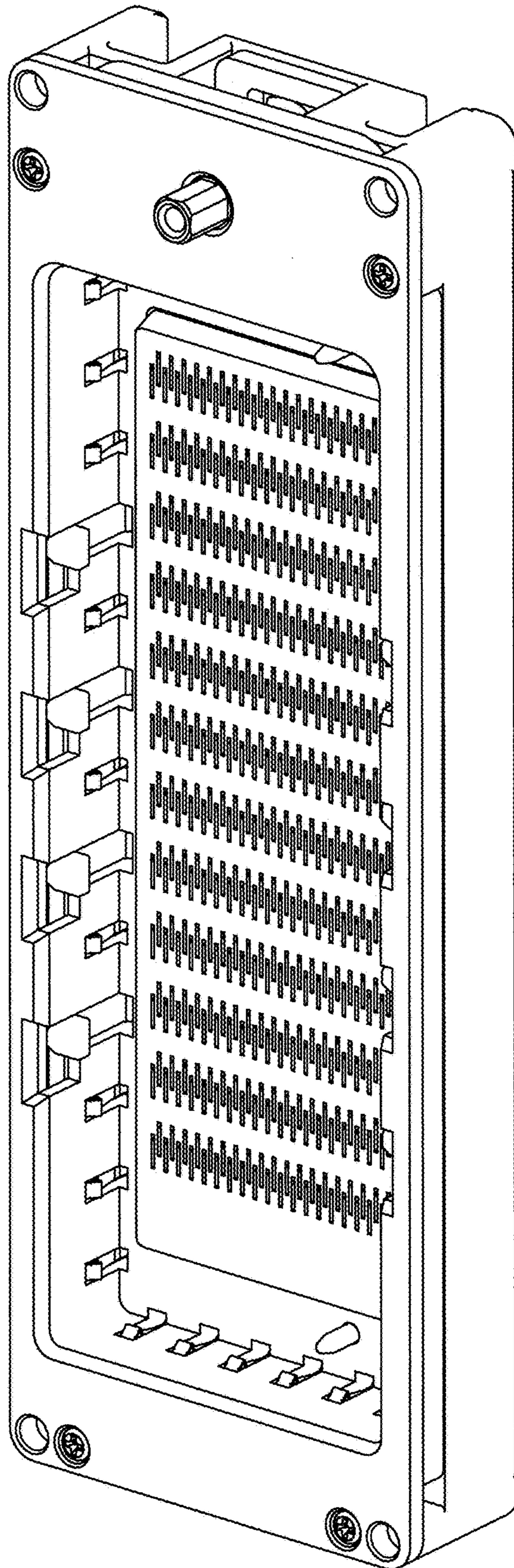

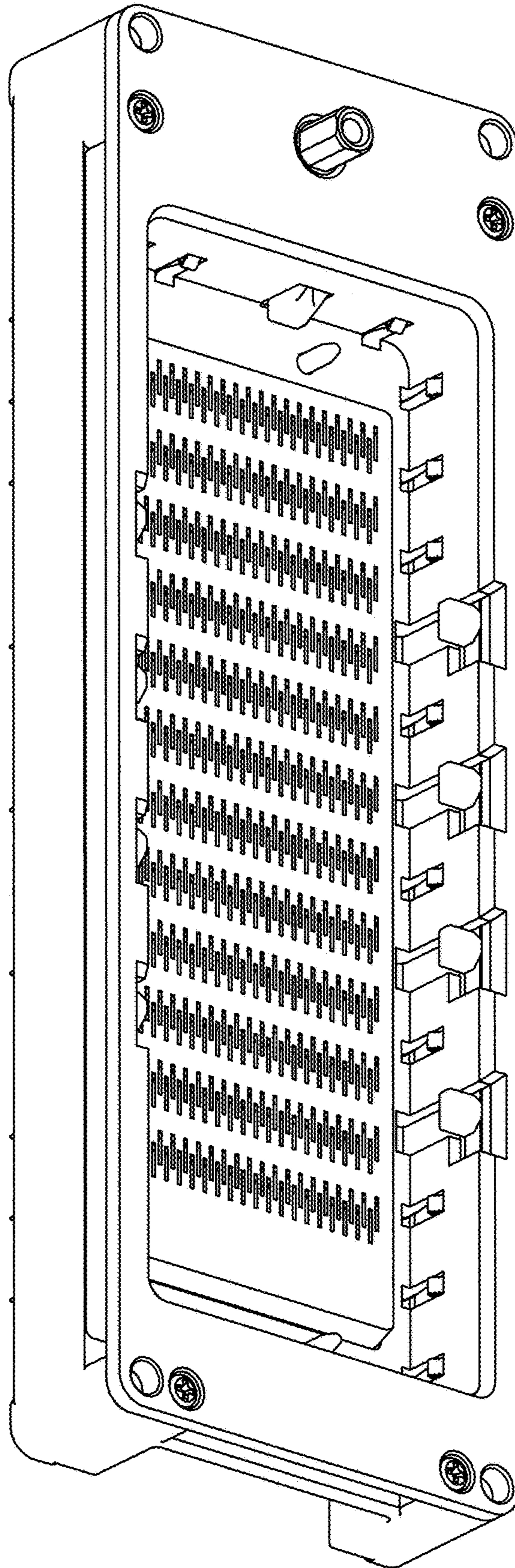

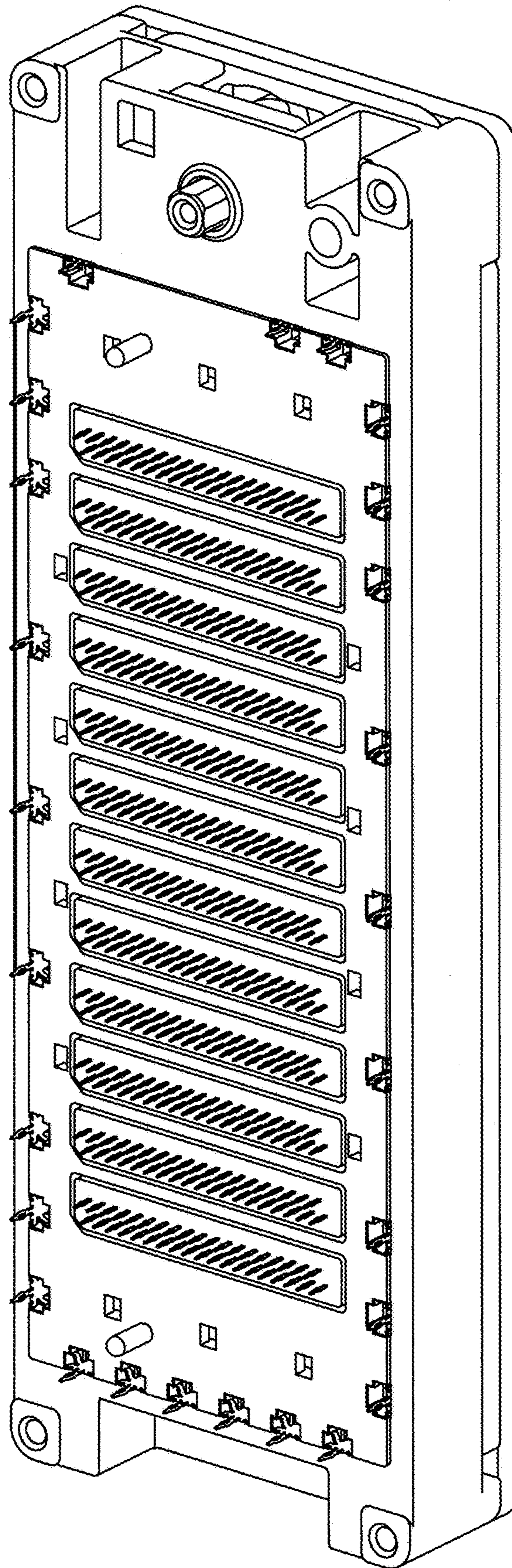
