FIG. 1 is a perspective view of a cable rail system showing
our design;

FIG. 3 is a bottom plan view thereof, with the top plan view
being identical;

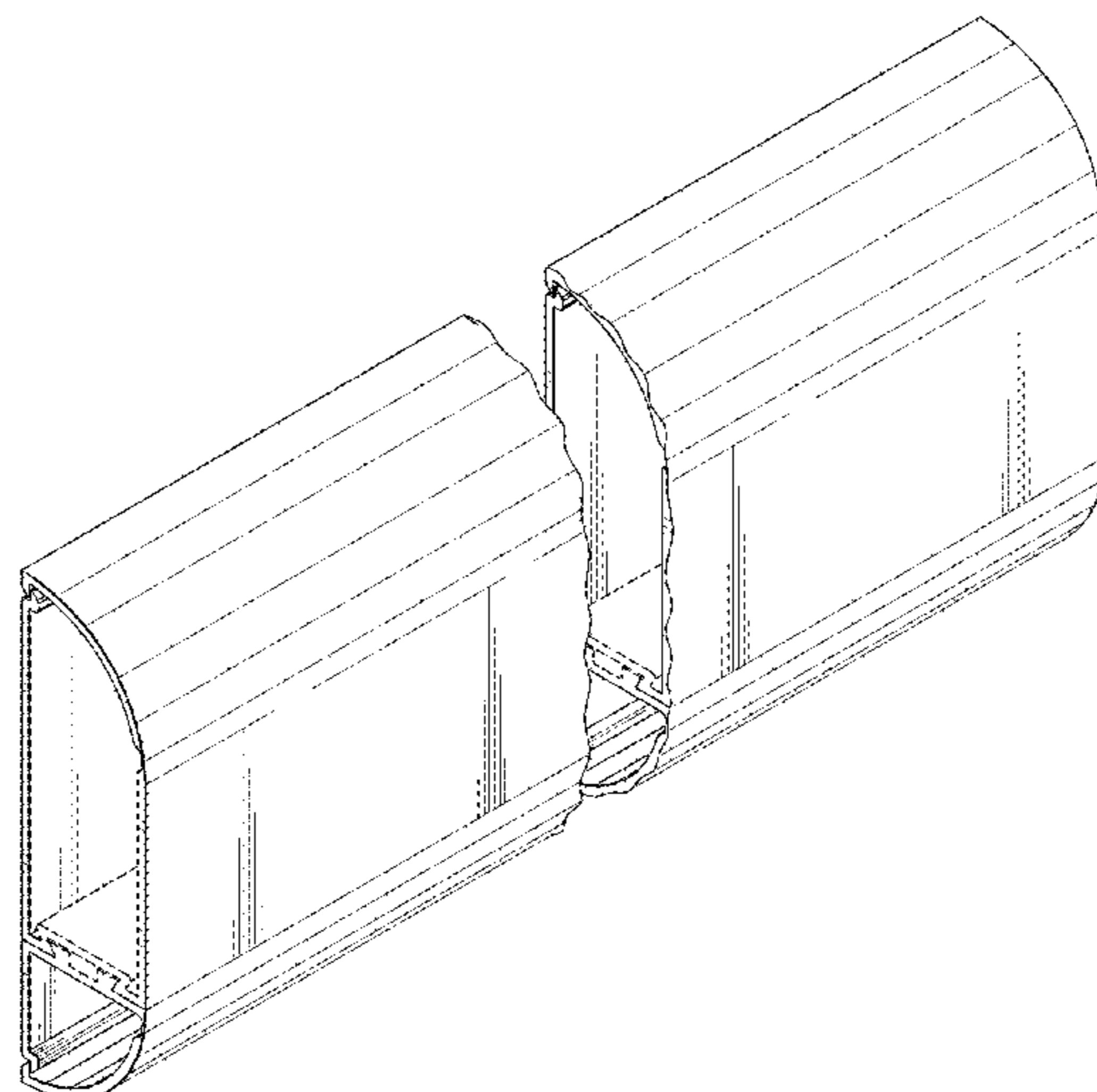
FIG. 4 is rear elevational view thereof; and,

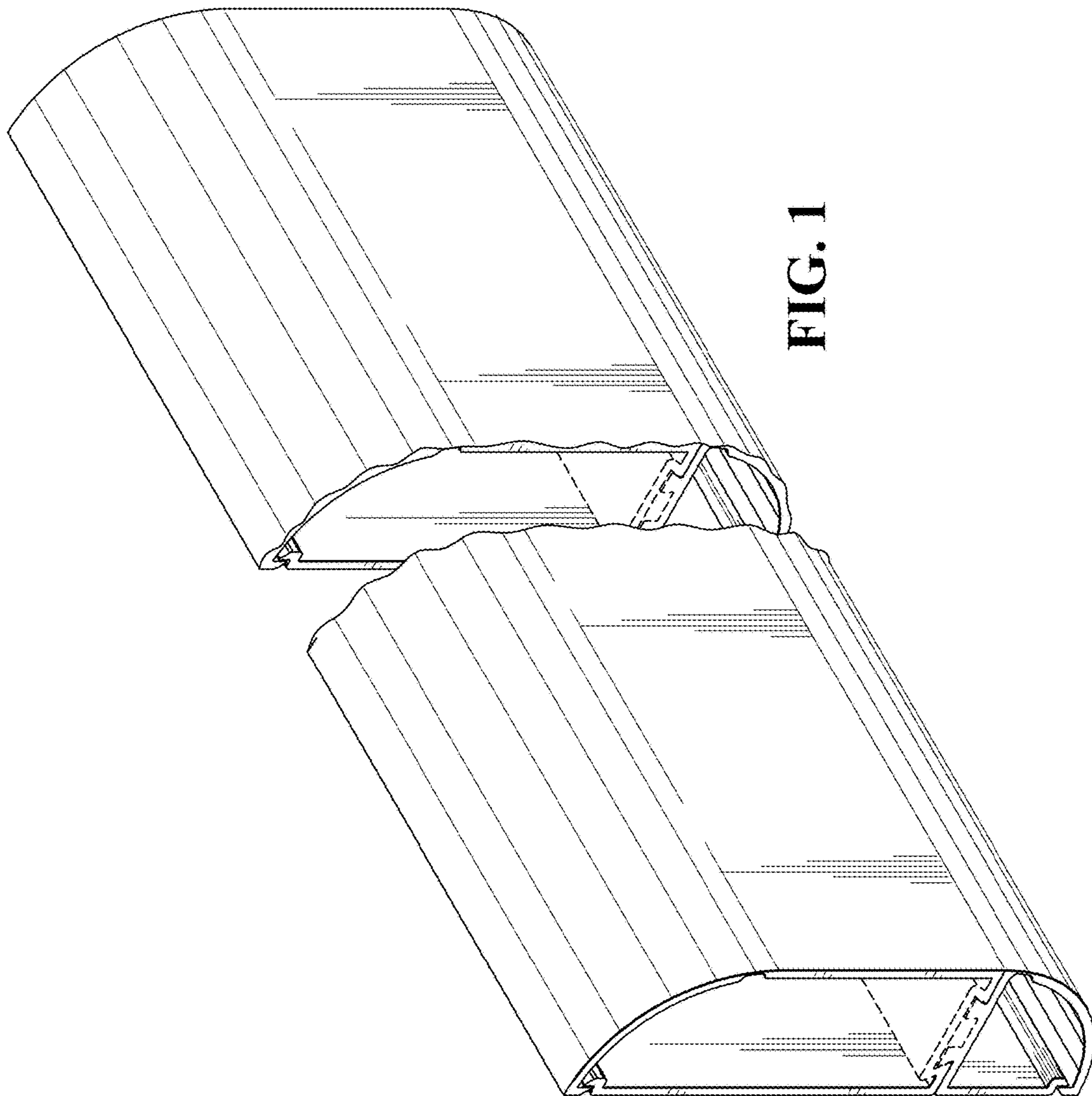

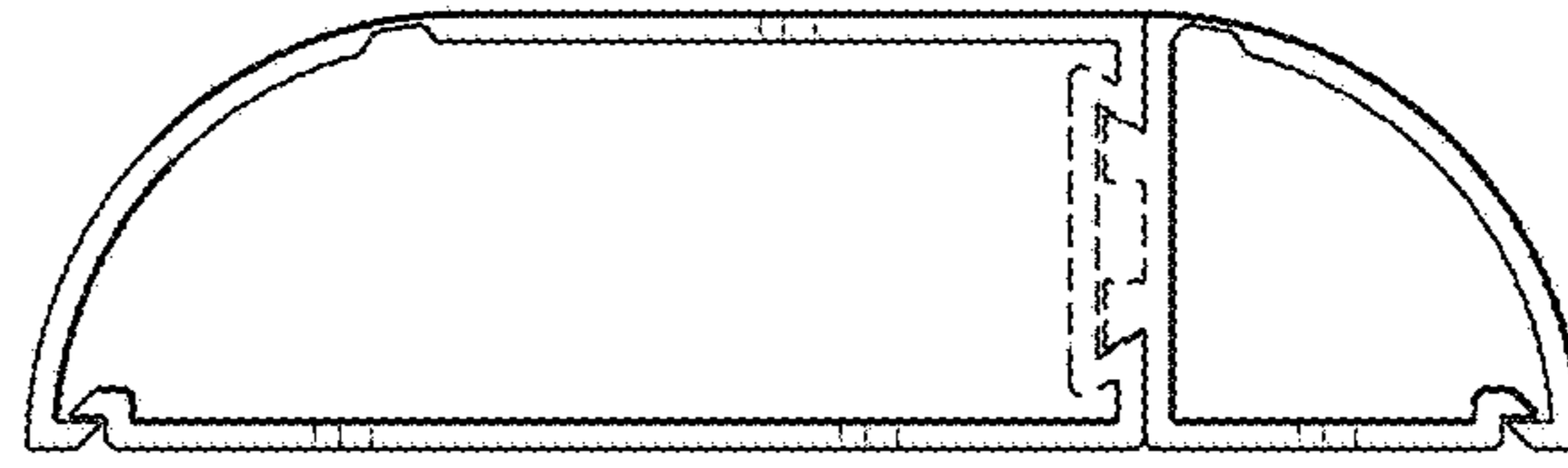

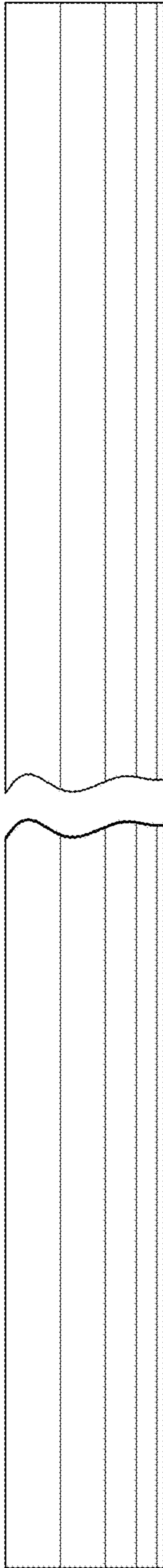

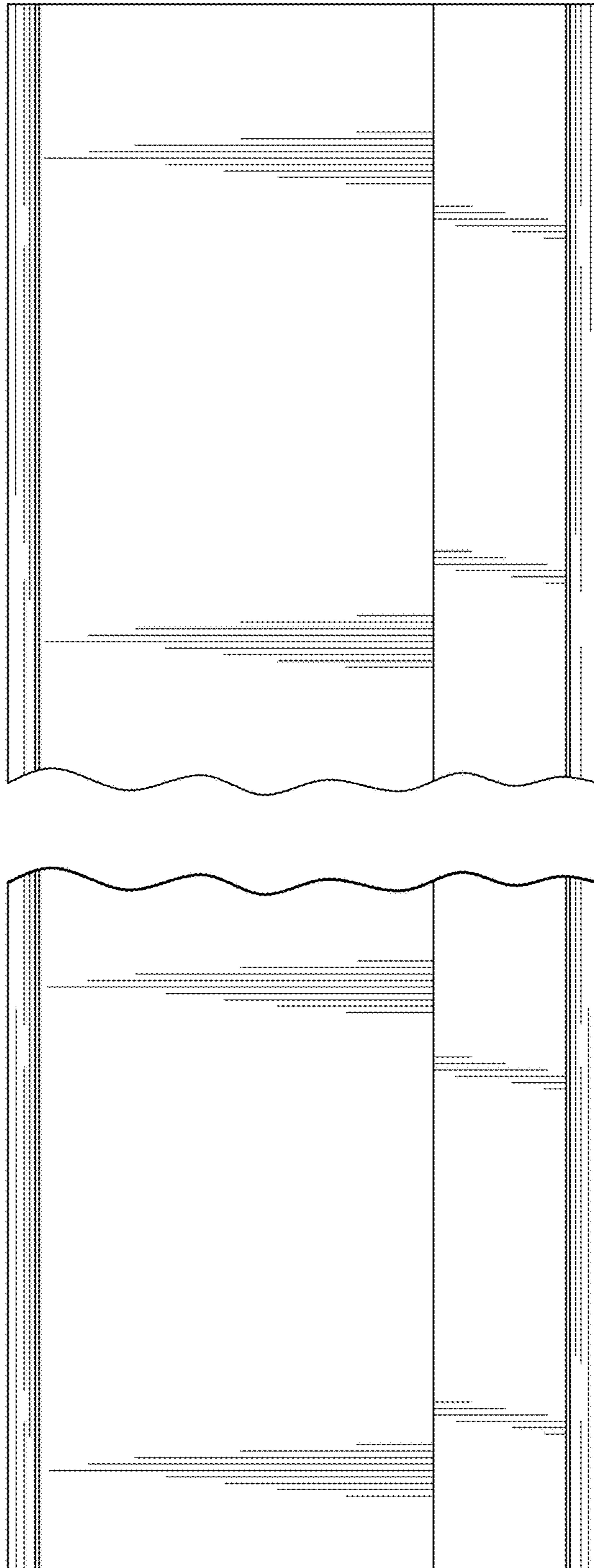

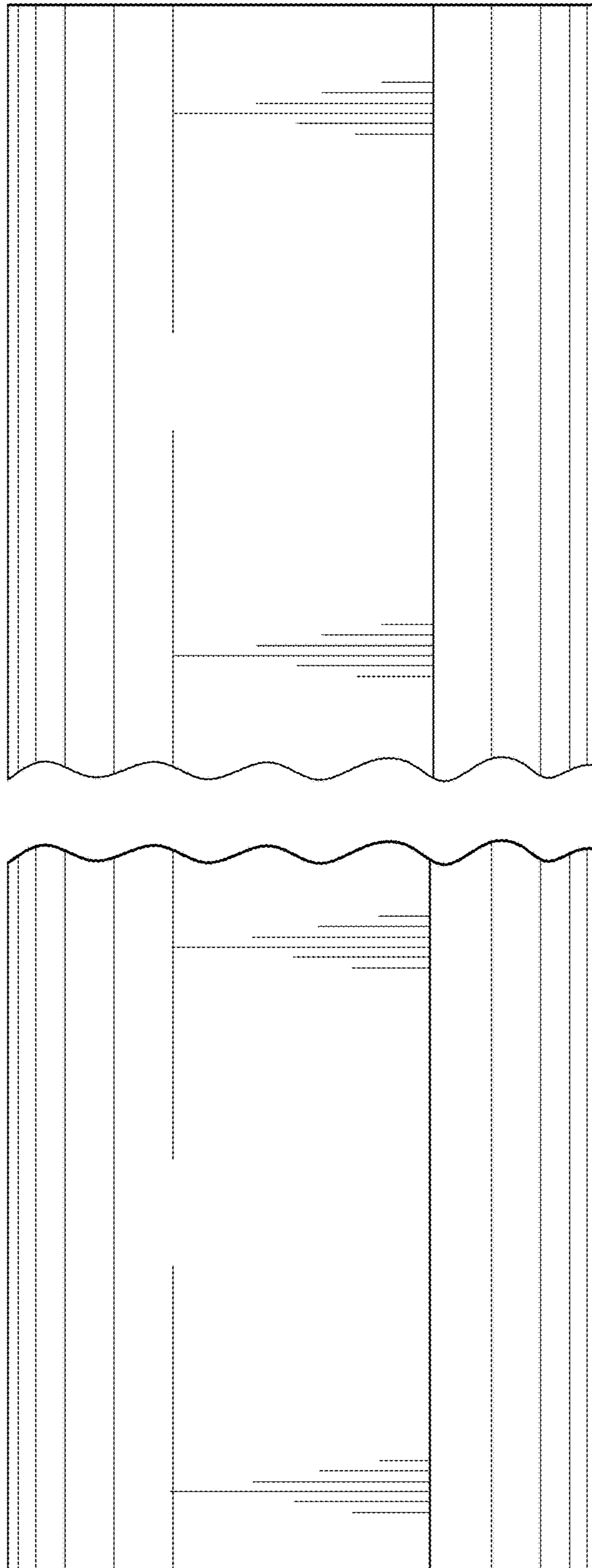
