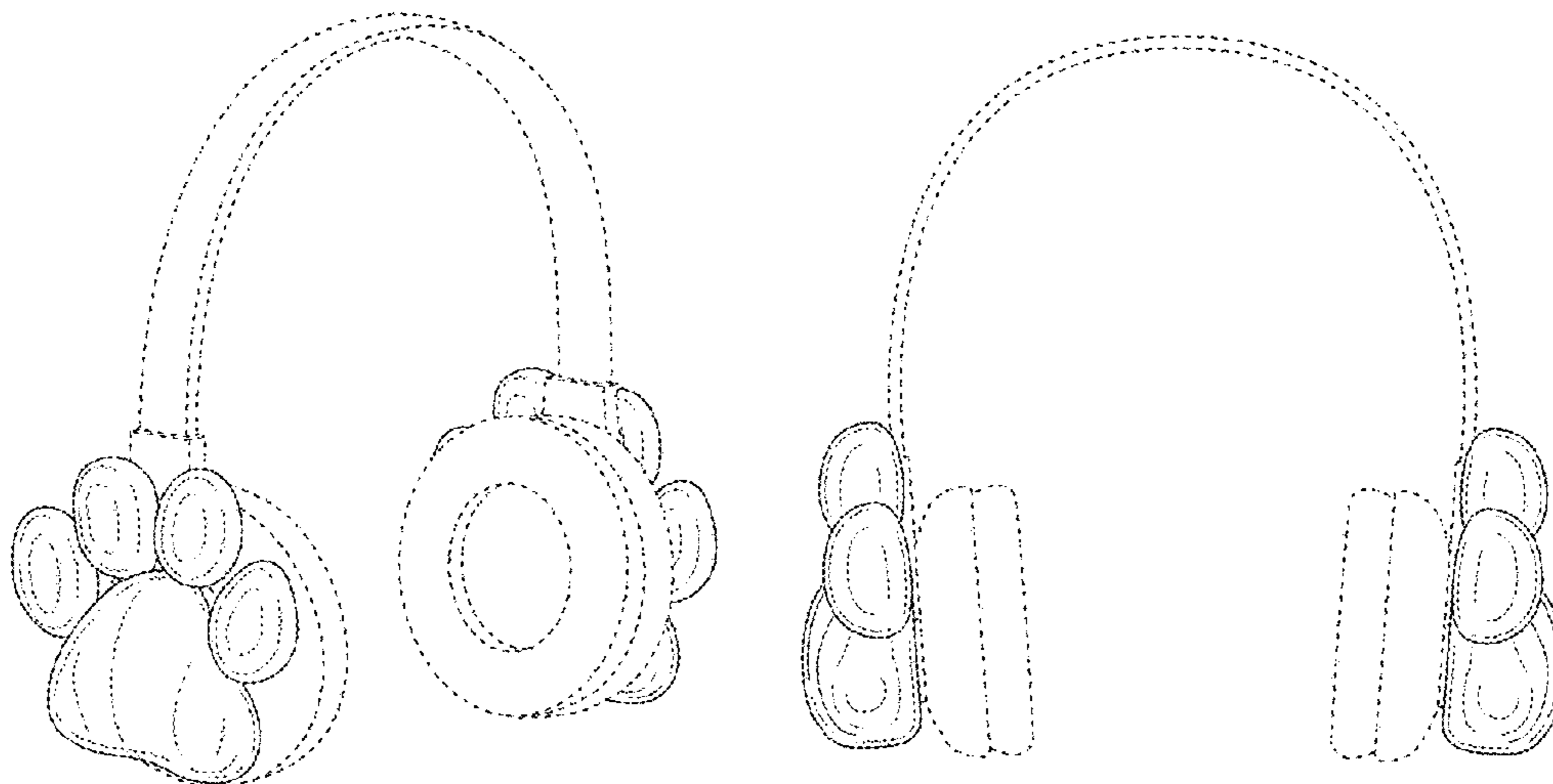
(57) **CLAIM**

The ornamental design for an animal paw-themed headphone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an animal paw-themed headphone, showing the new design; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof; FIG. 4 is a bottom view thereof; and, FIG. 5 is a top view thereof. 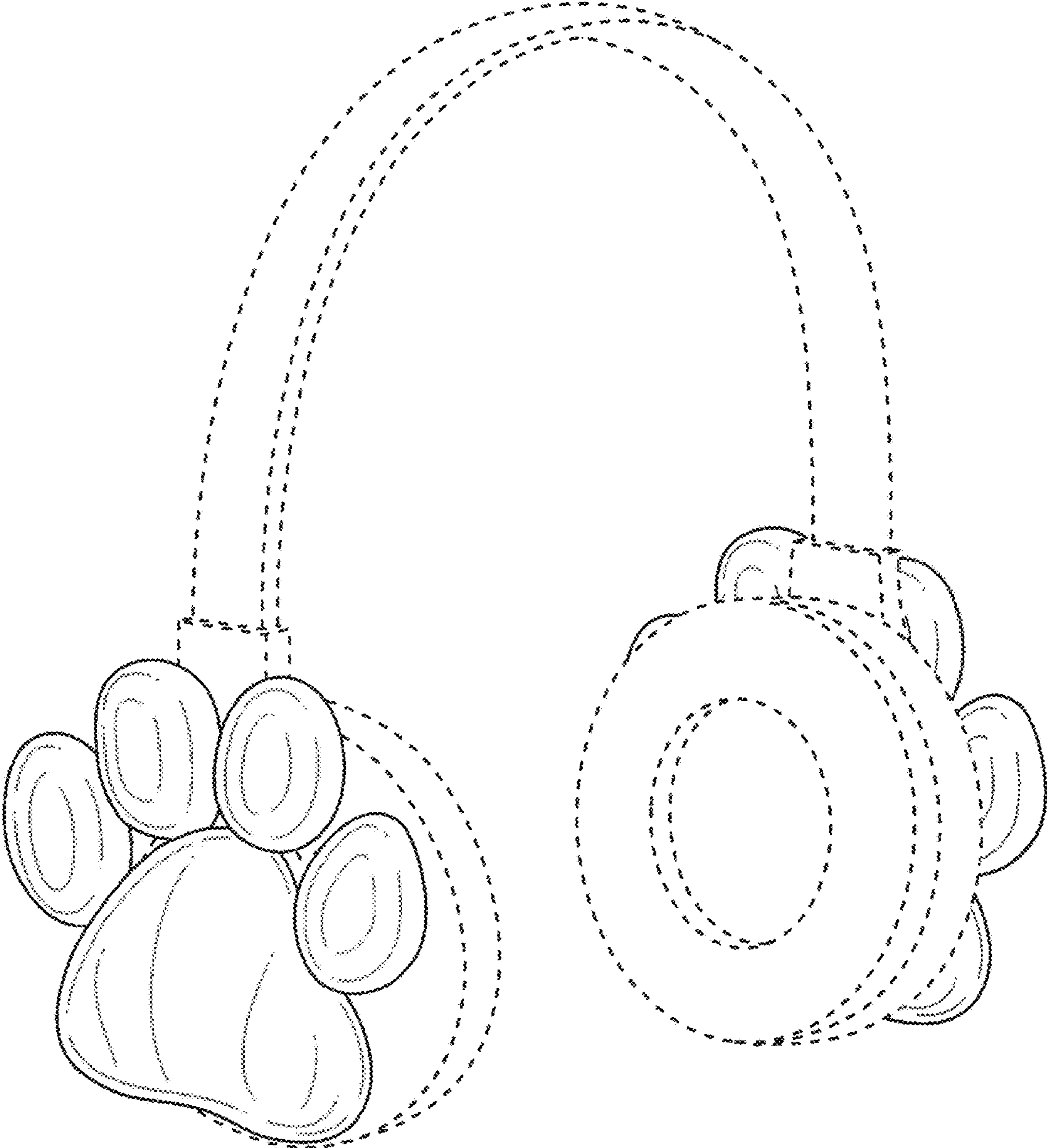

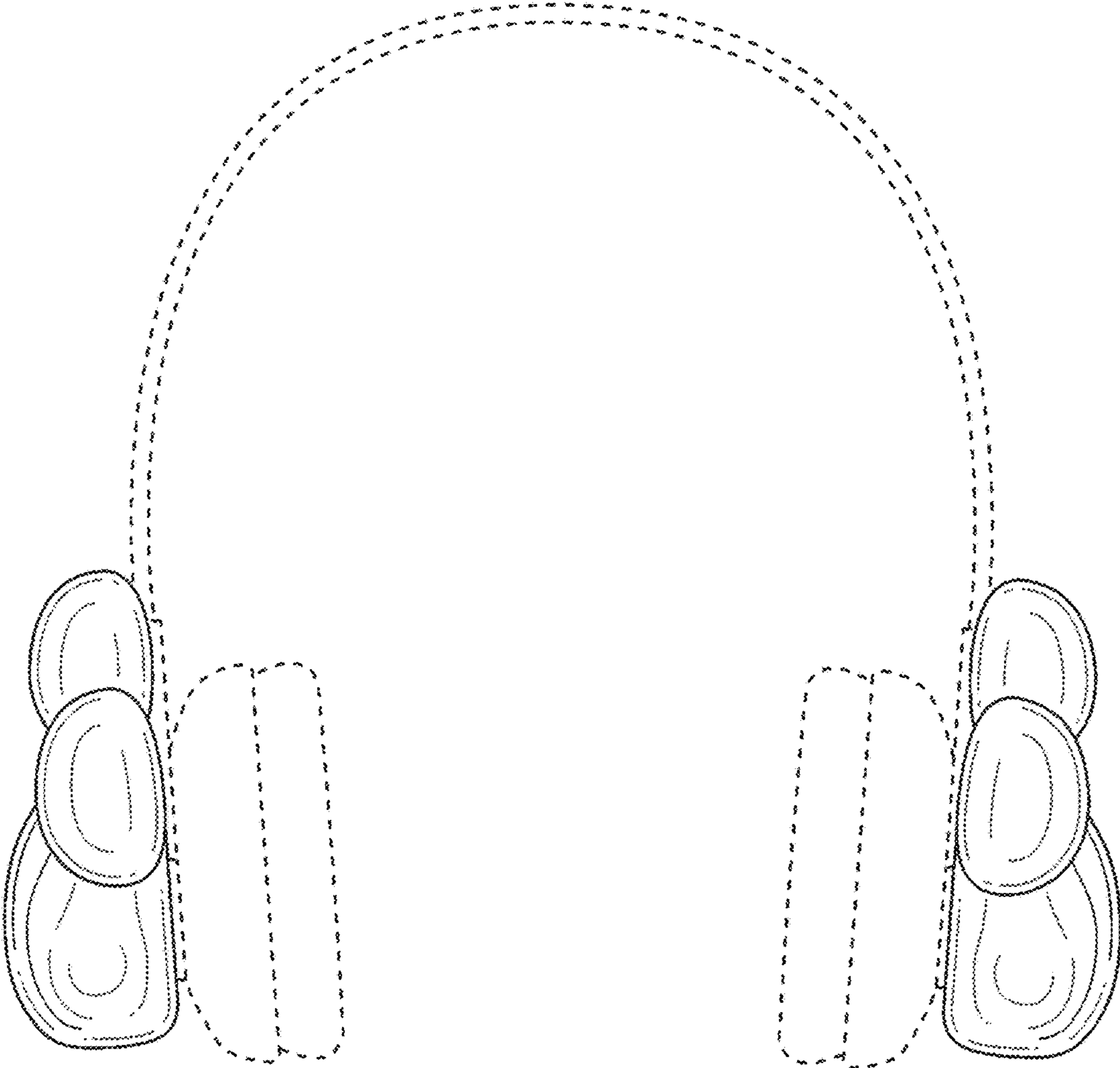

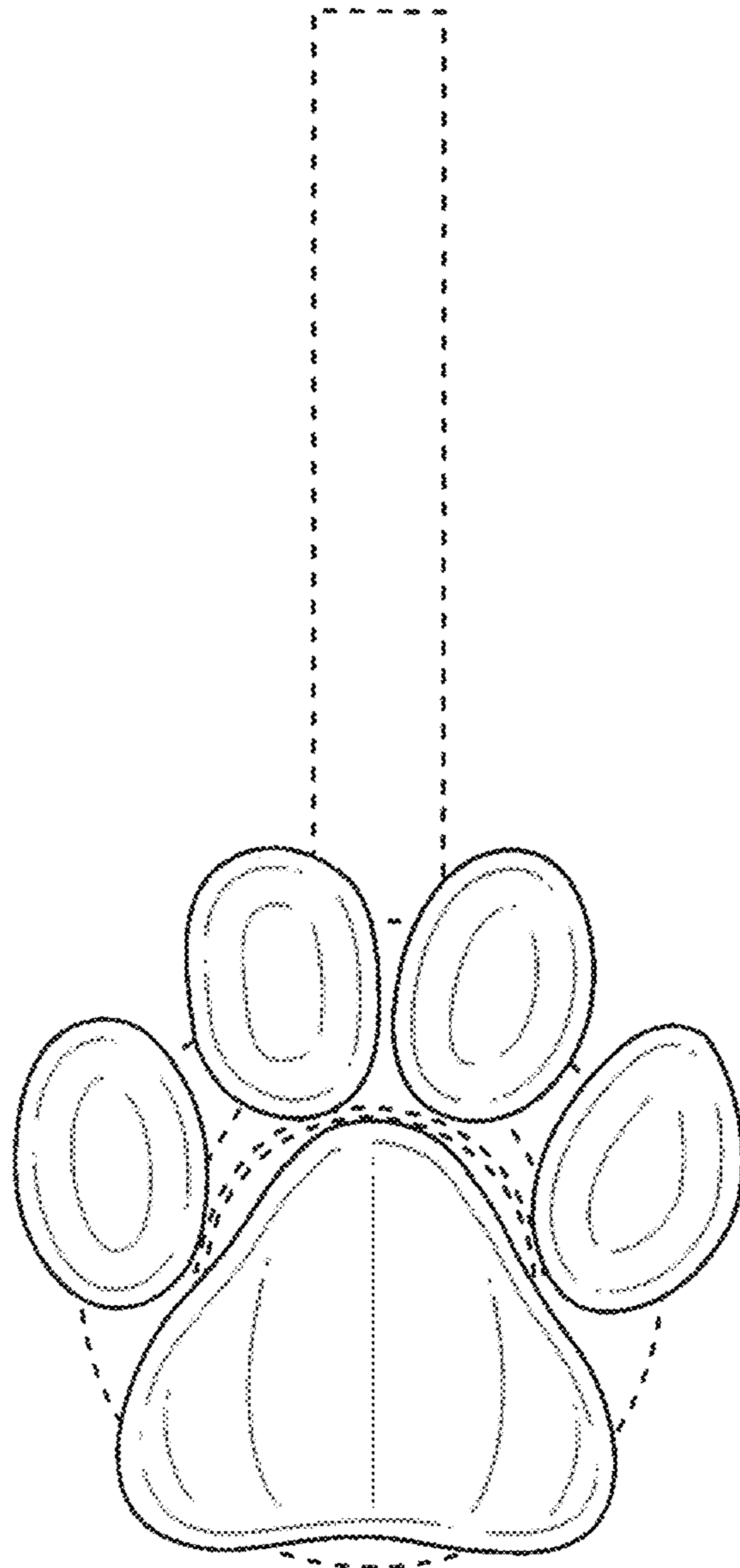

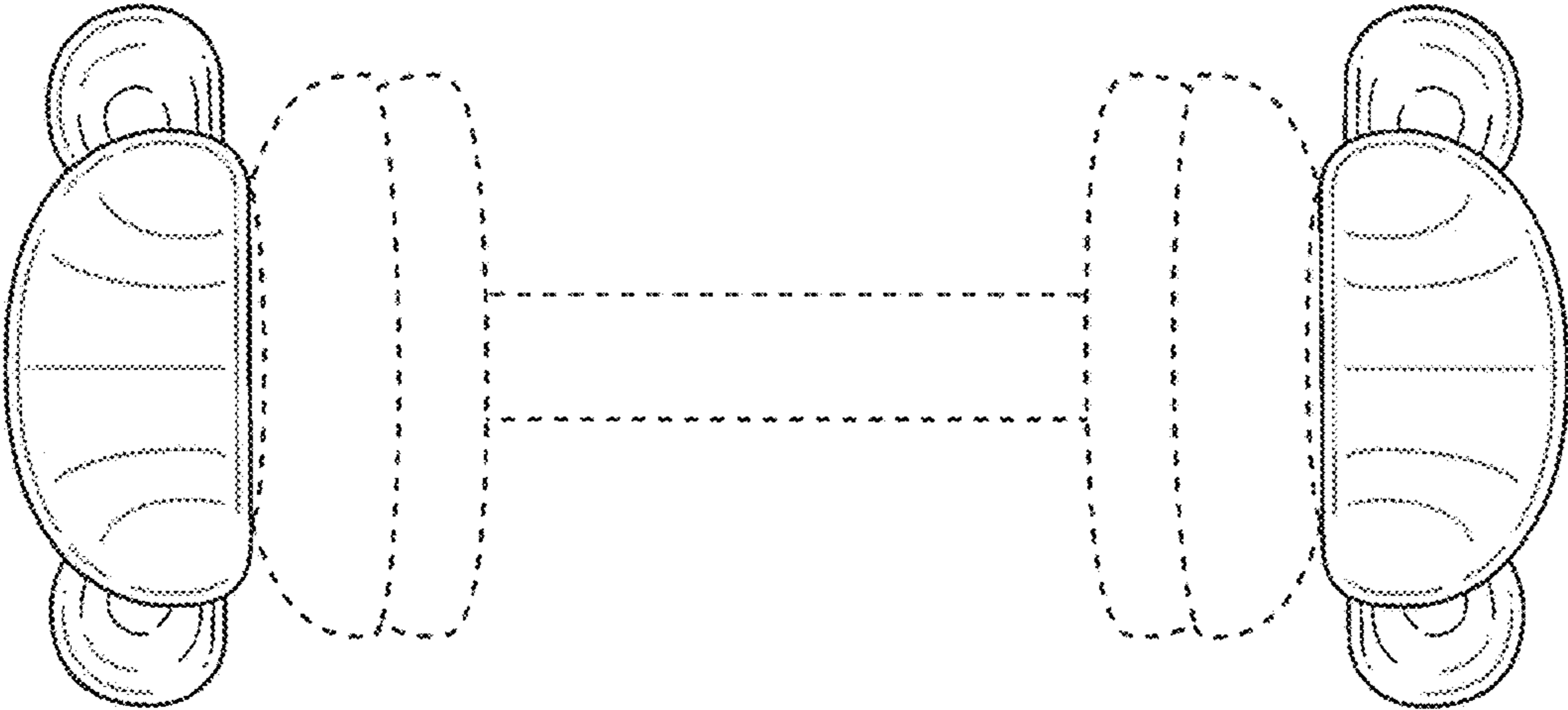

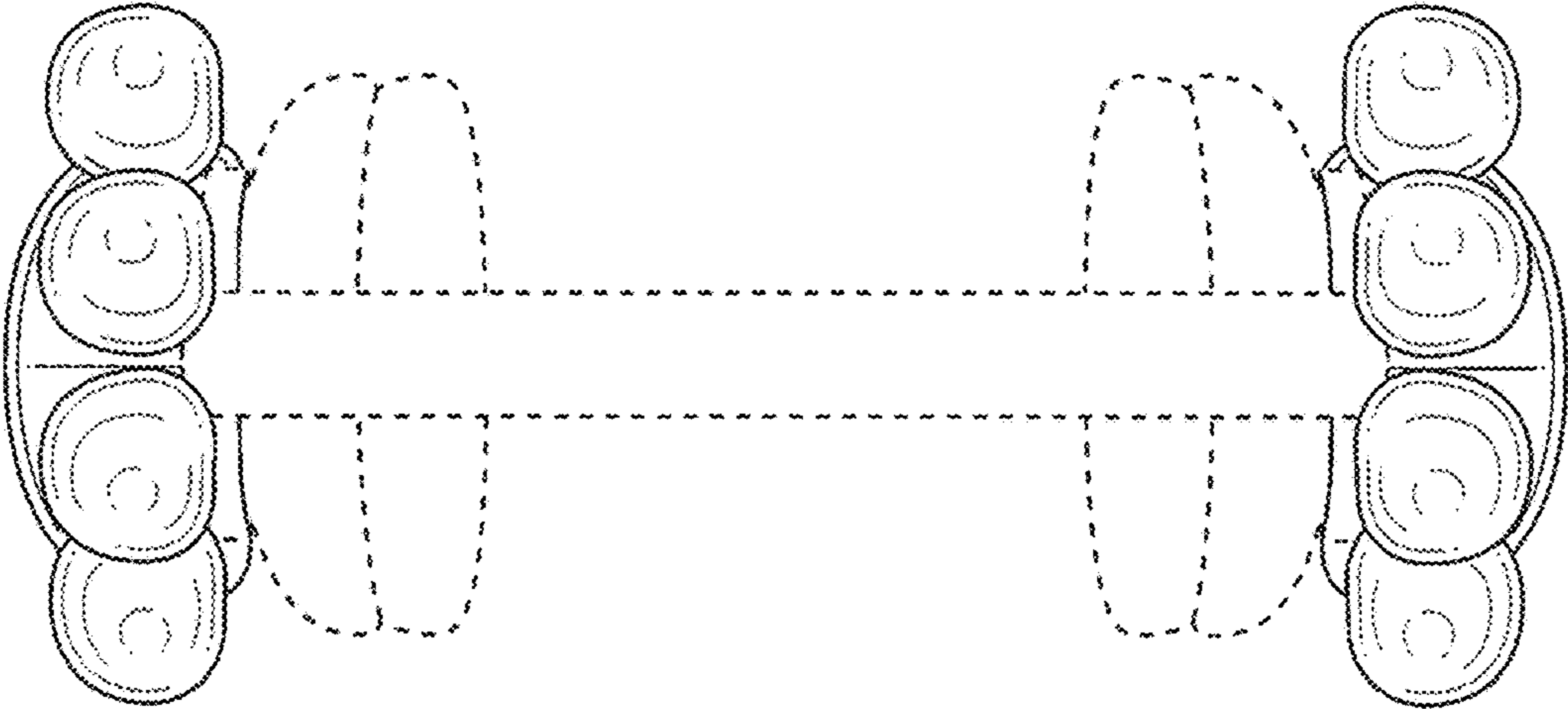
