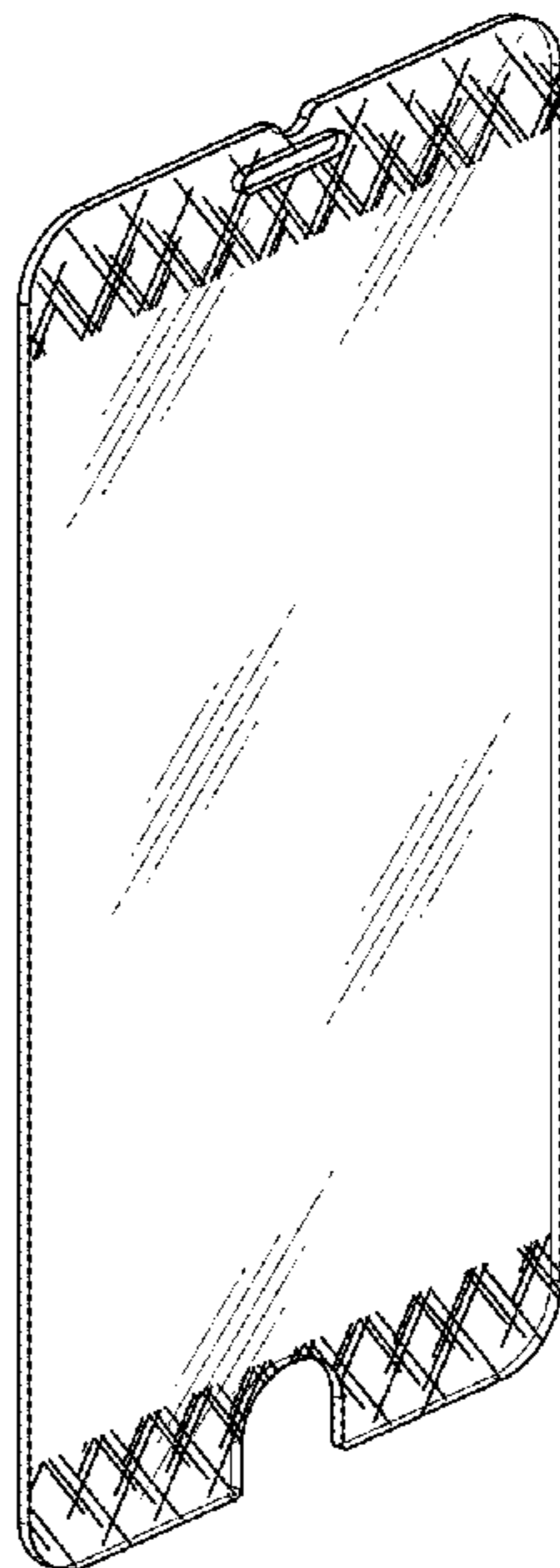
(57) **CLAIM**

The ornamental design for a glass screen cover for handheld electronic device, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the glass screen cover for handheld electronic device according to the design.

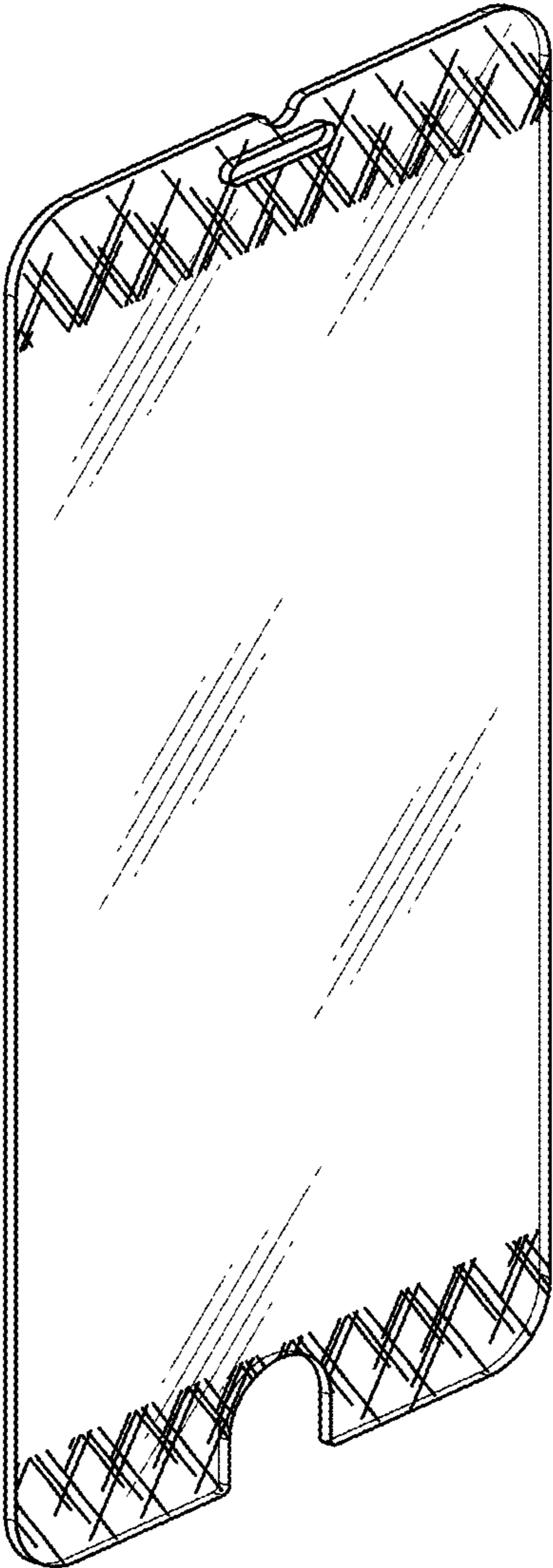

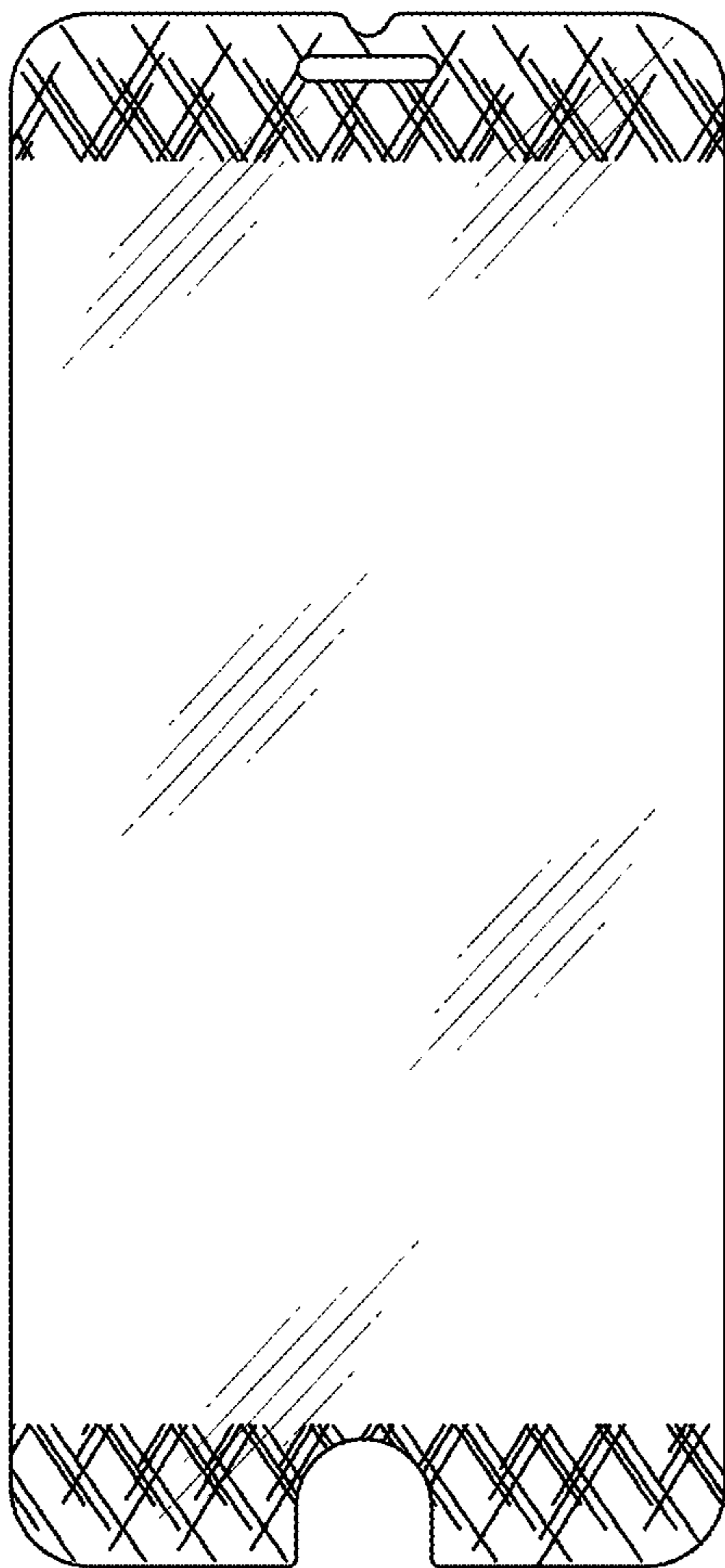

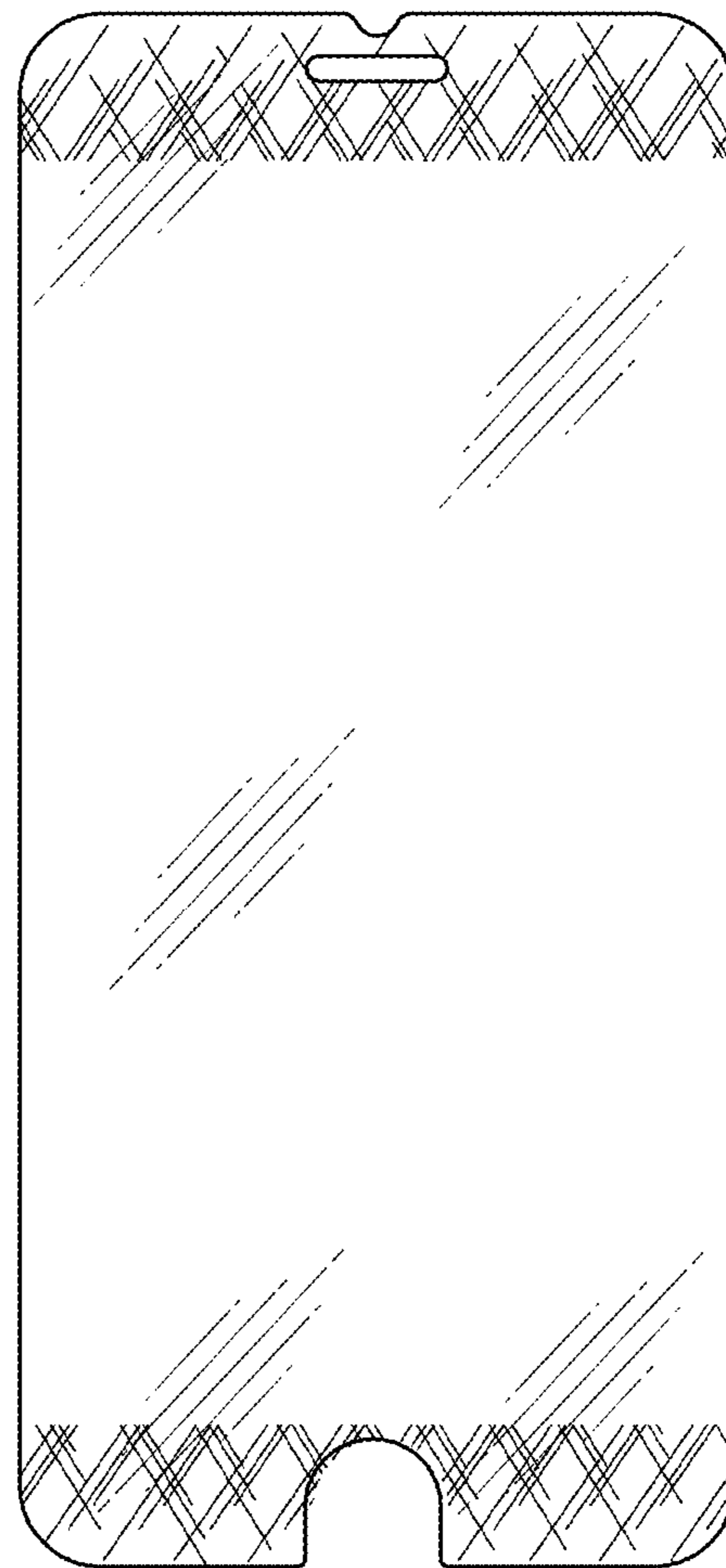

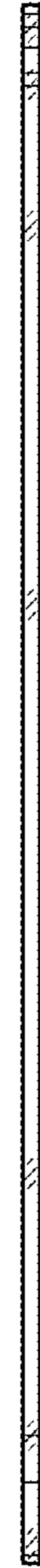

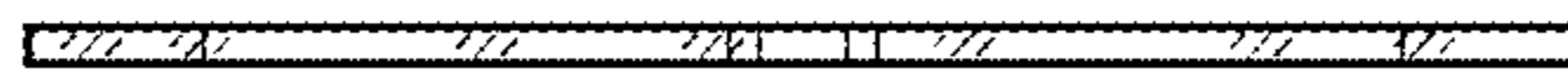
