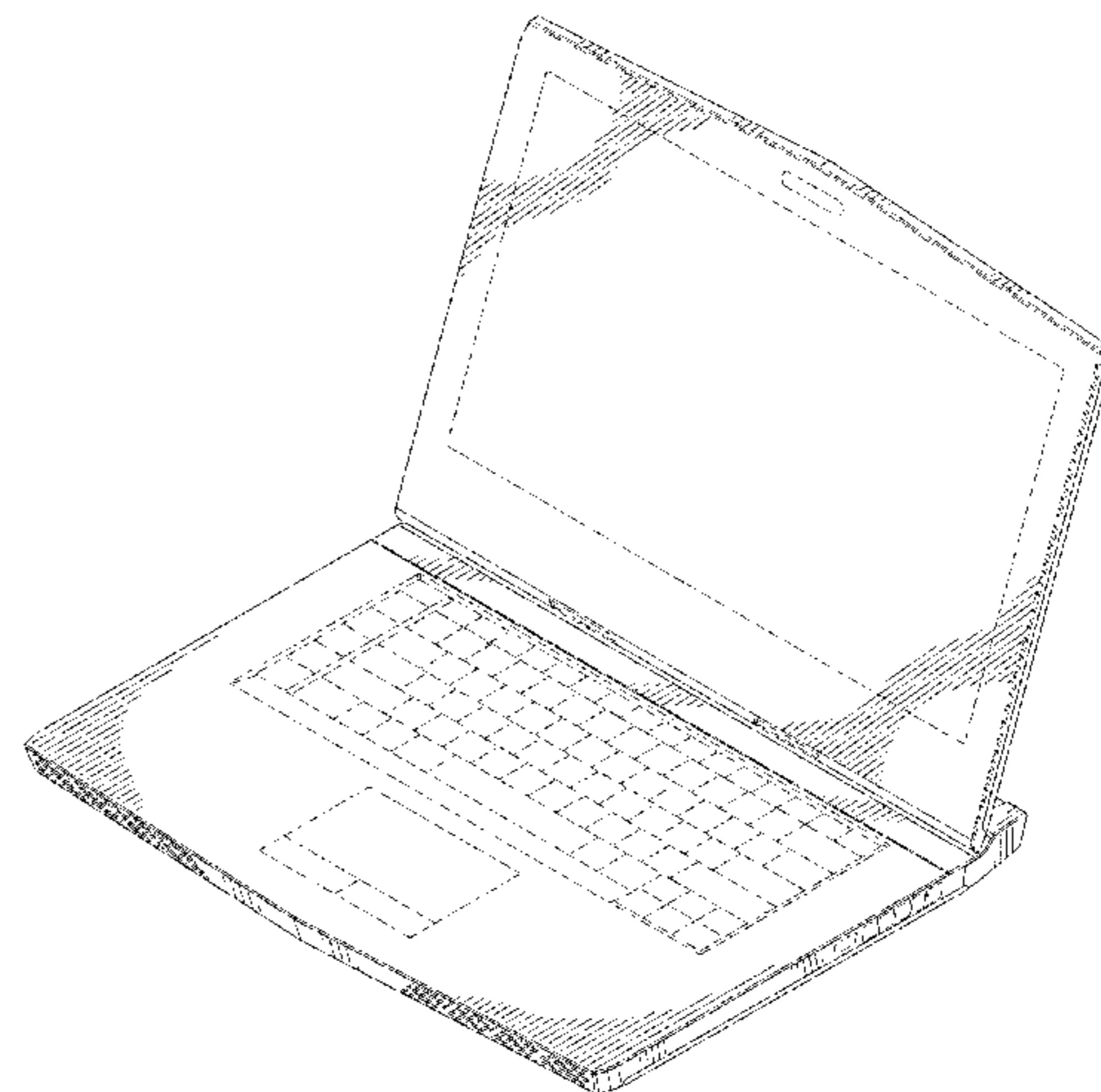
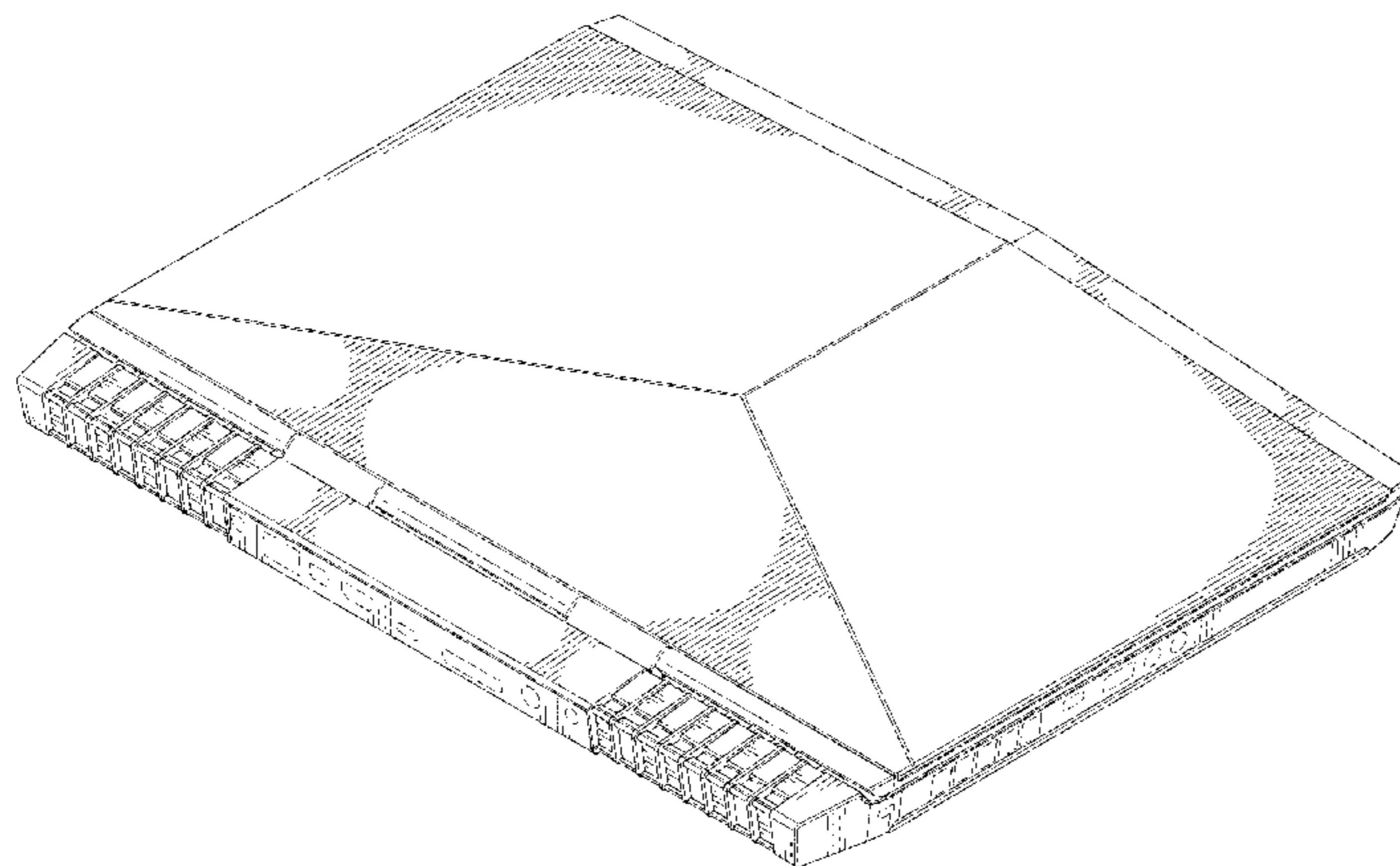
(57) **CLAIM**

We claim the ornamental design for the portable information handling system housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the portable information handling system housing comprising the present invention; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a front perspective view thereof in an open position. 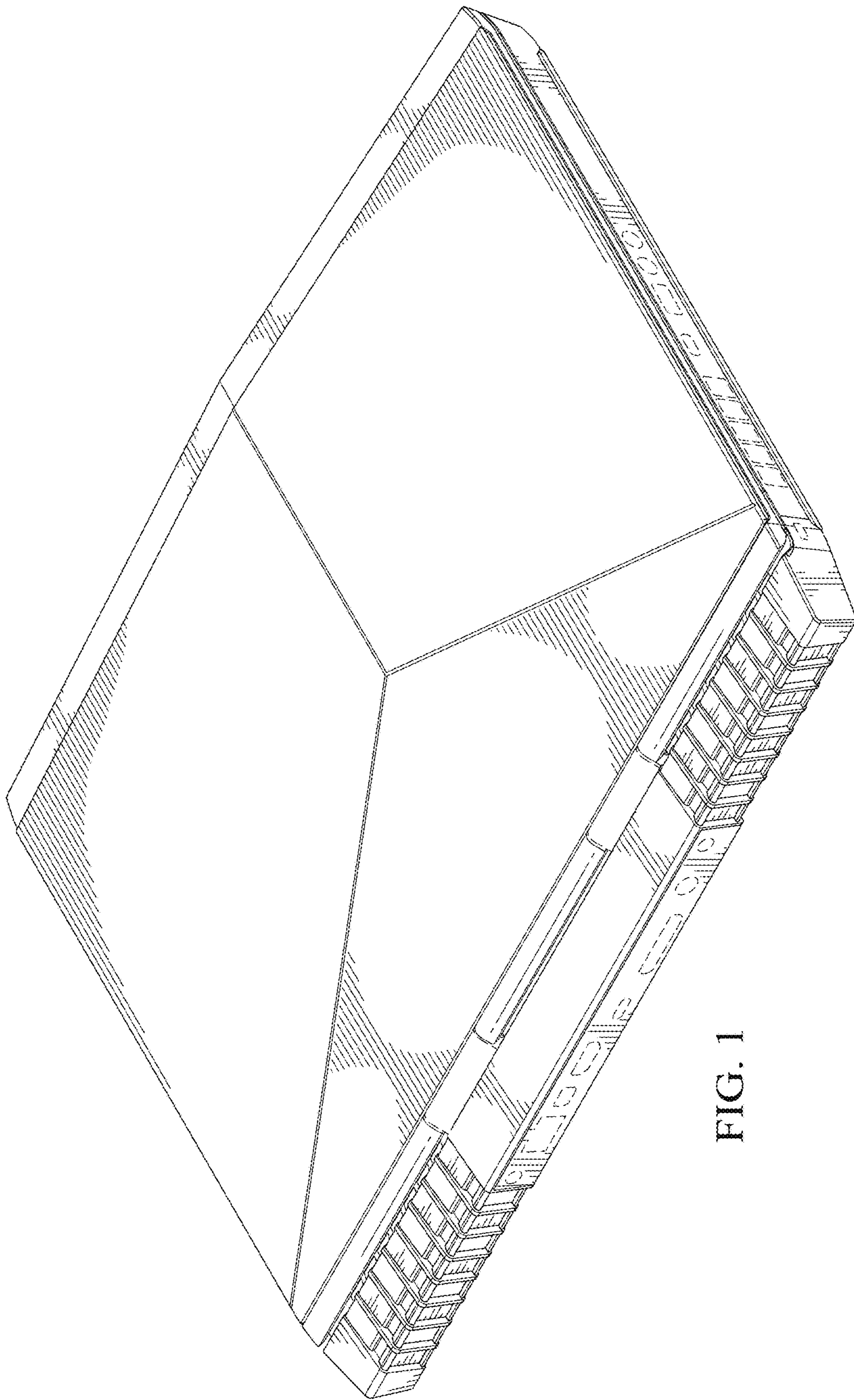

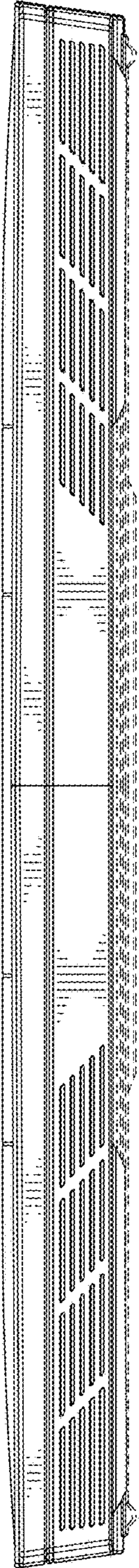

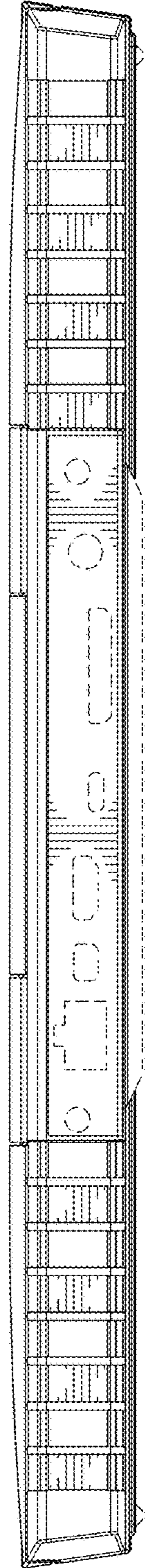

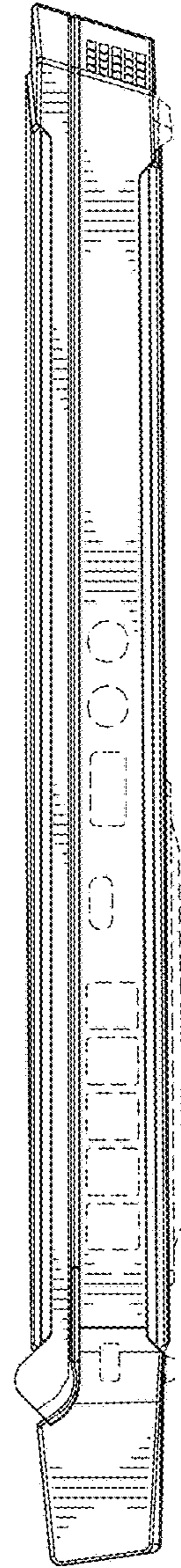

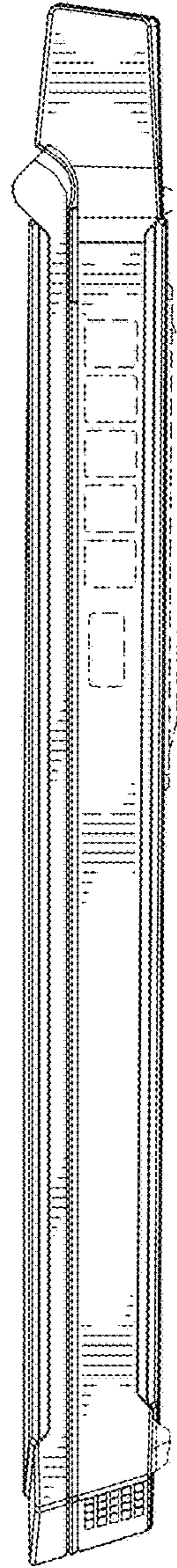

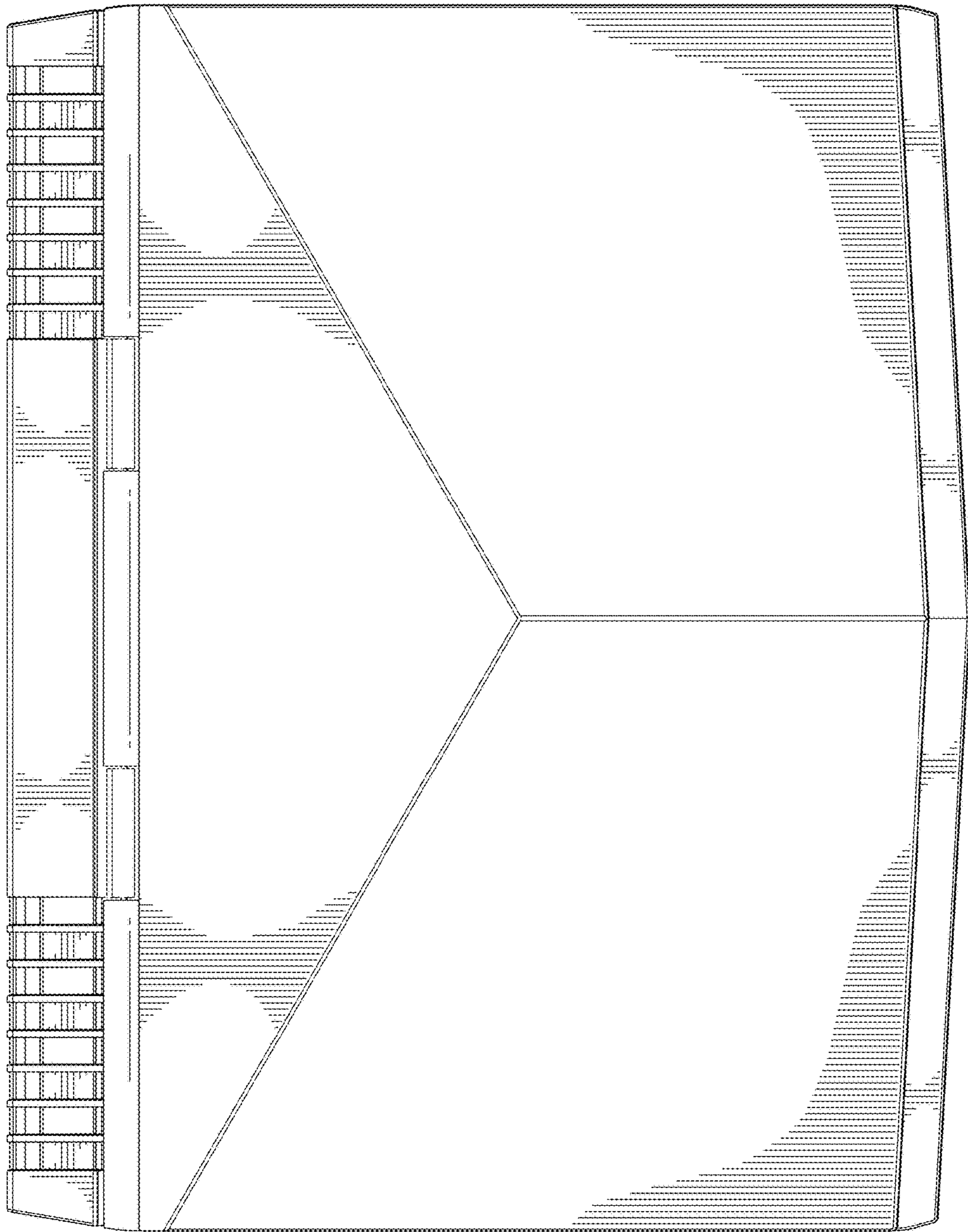

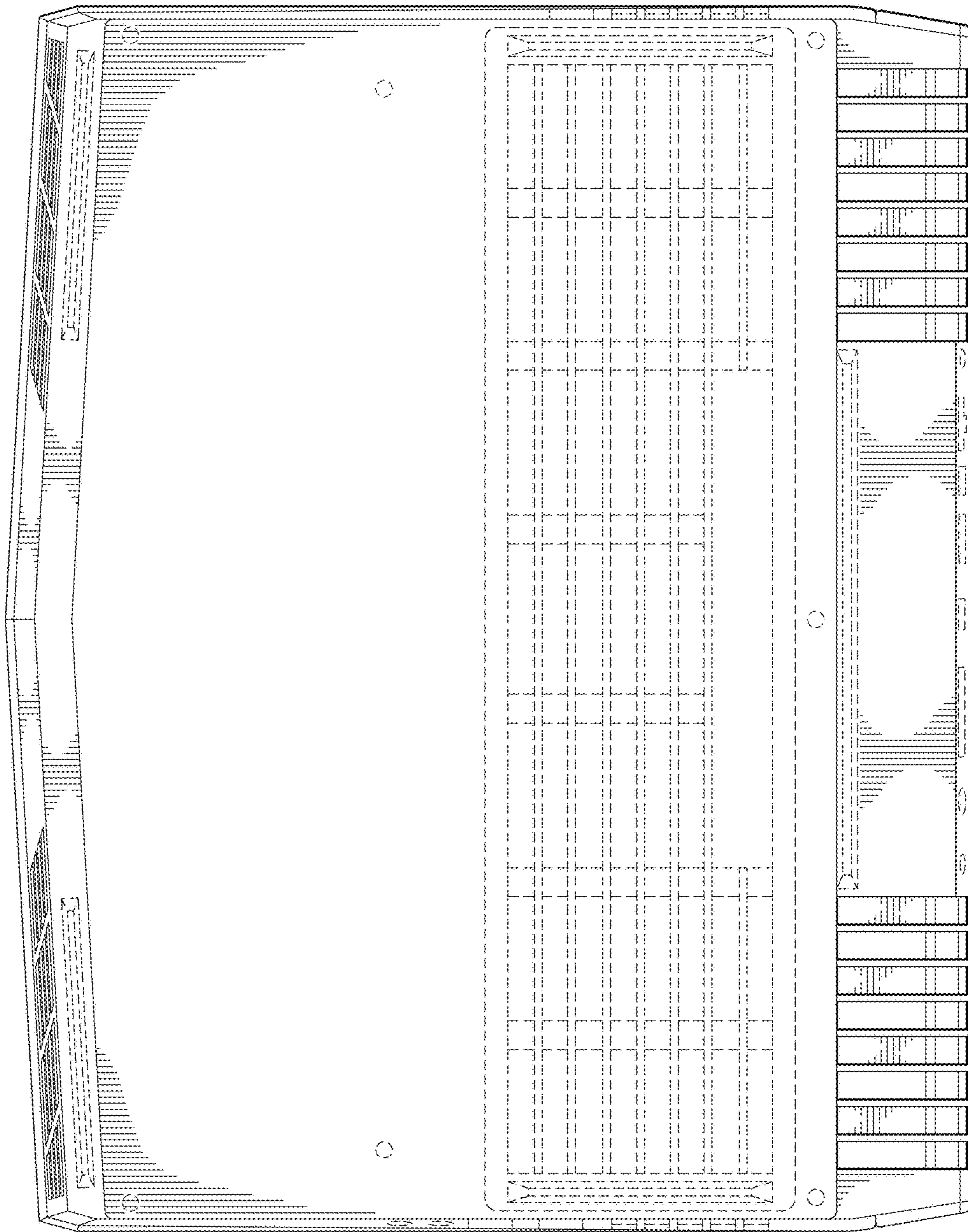

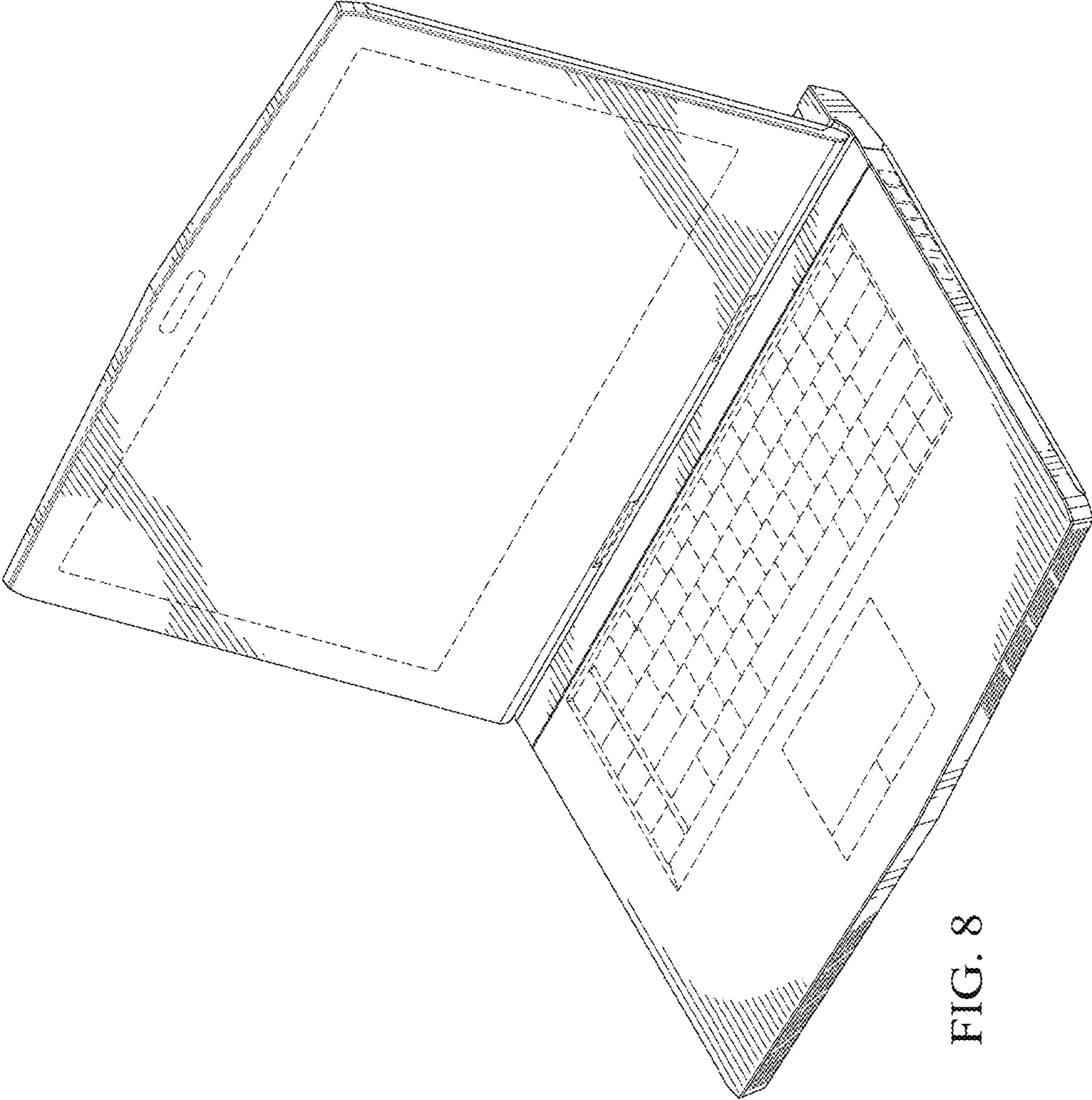
