(57) **CLAIM**

The ornamental design for a display screen or a portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence of a display screen or a portion thereof with animated graphical user interface, showing our new design;

FIG. 2 is a second image thereof;

FIG. 3 is a front view of a first image in a sequence of the design shown in FIGS. 1 through 2, but disclosed in an alternative environment;

FIG. 4 is a second image thereof;

FIG. 5 is a third image thereof;

FIG. 6 is a fourth image thereof;

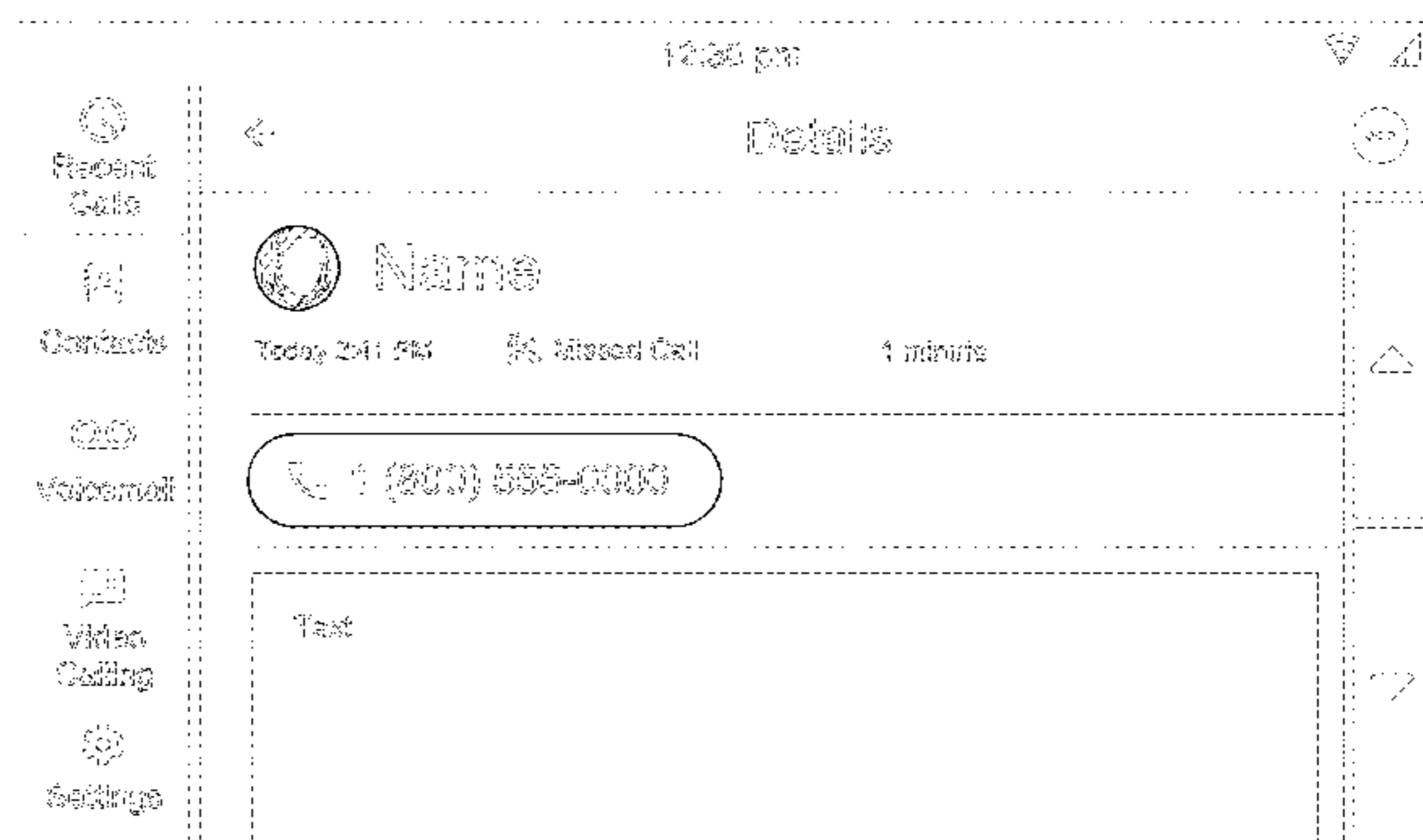
FIG. 7 is a front view of a first image in a sequence of the design shown in FIGS. 1 through 2, but disclosed in an alternative environment; and,

FIG. 8 is a second image thereof.

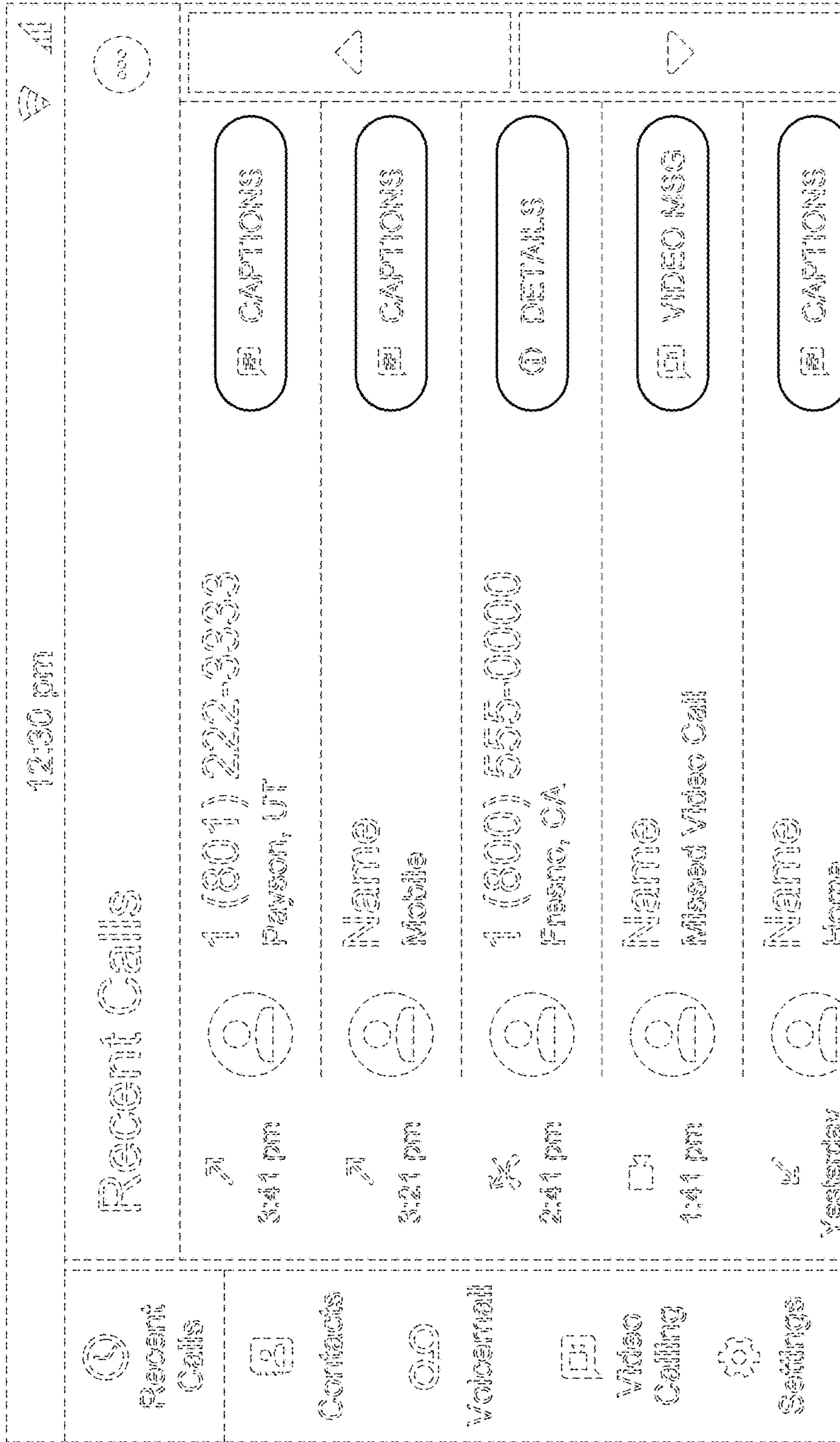

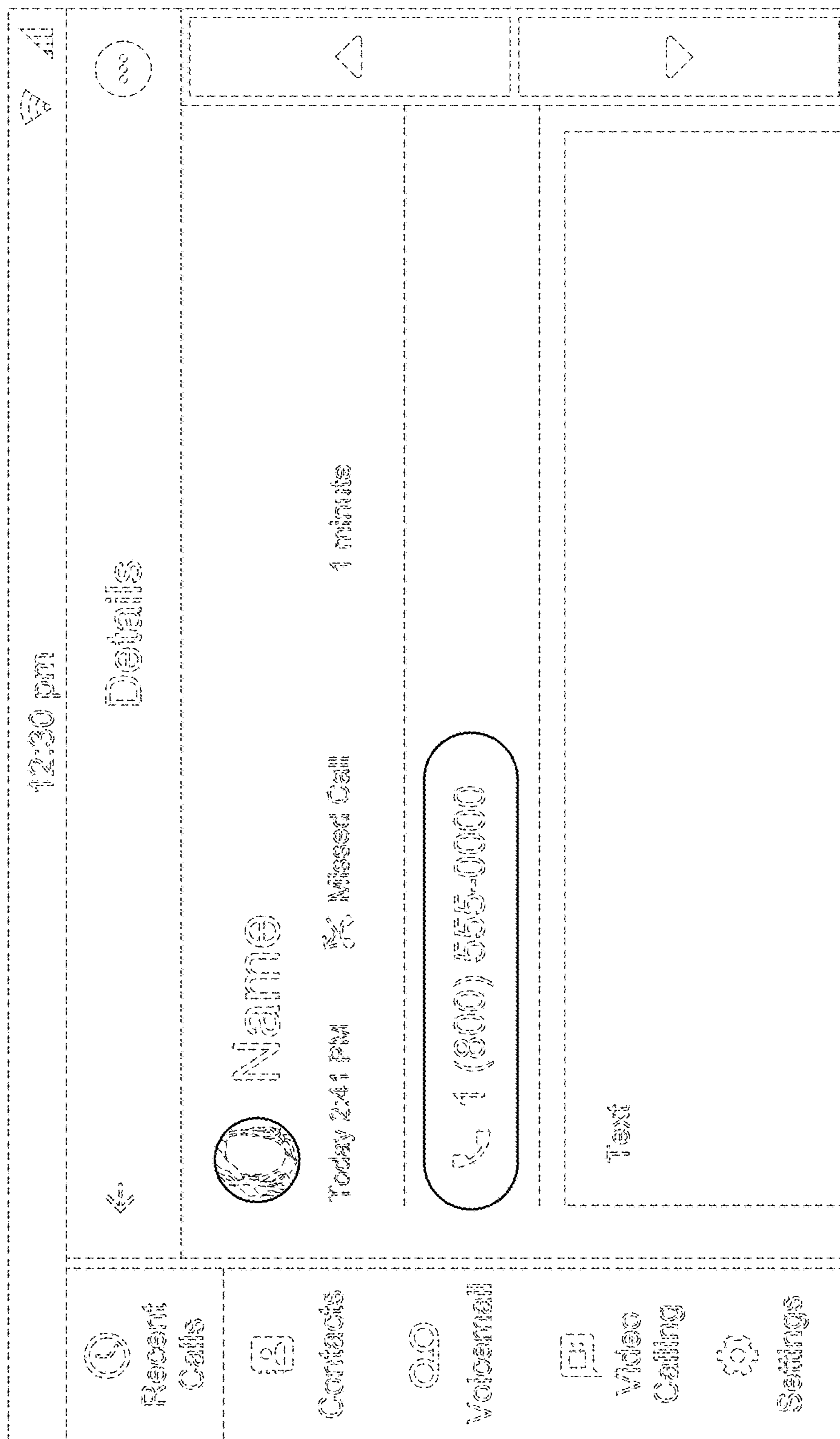

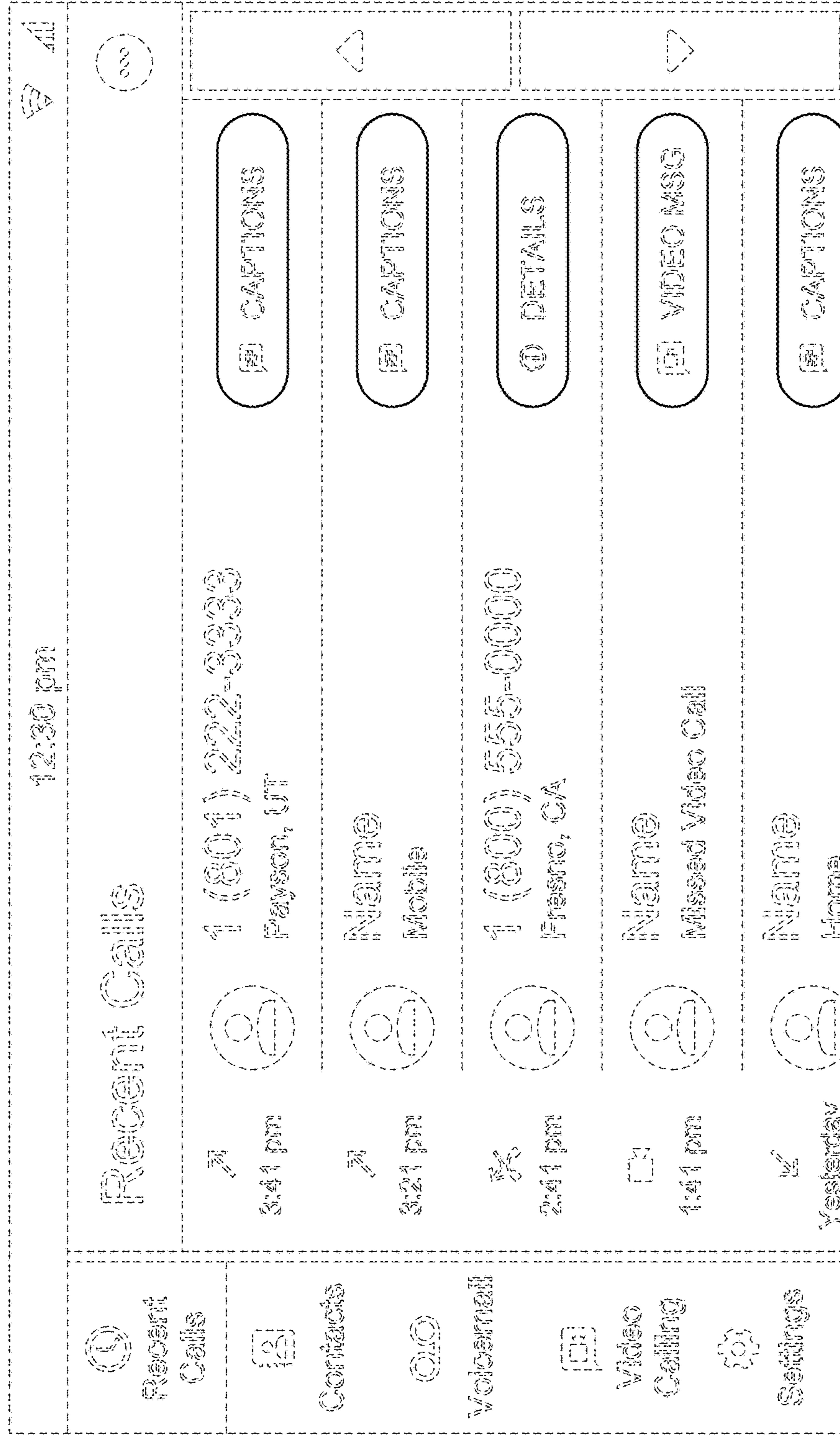

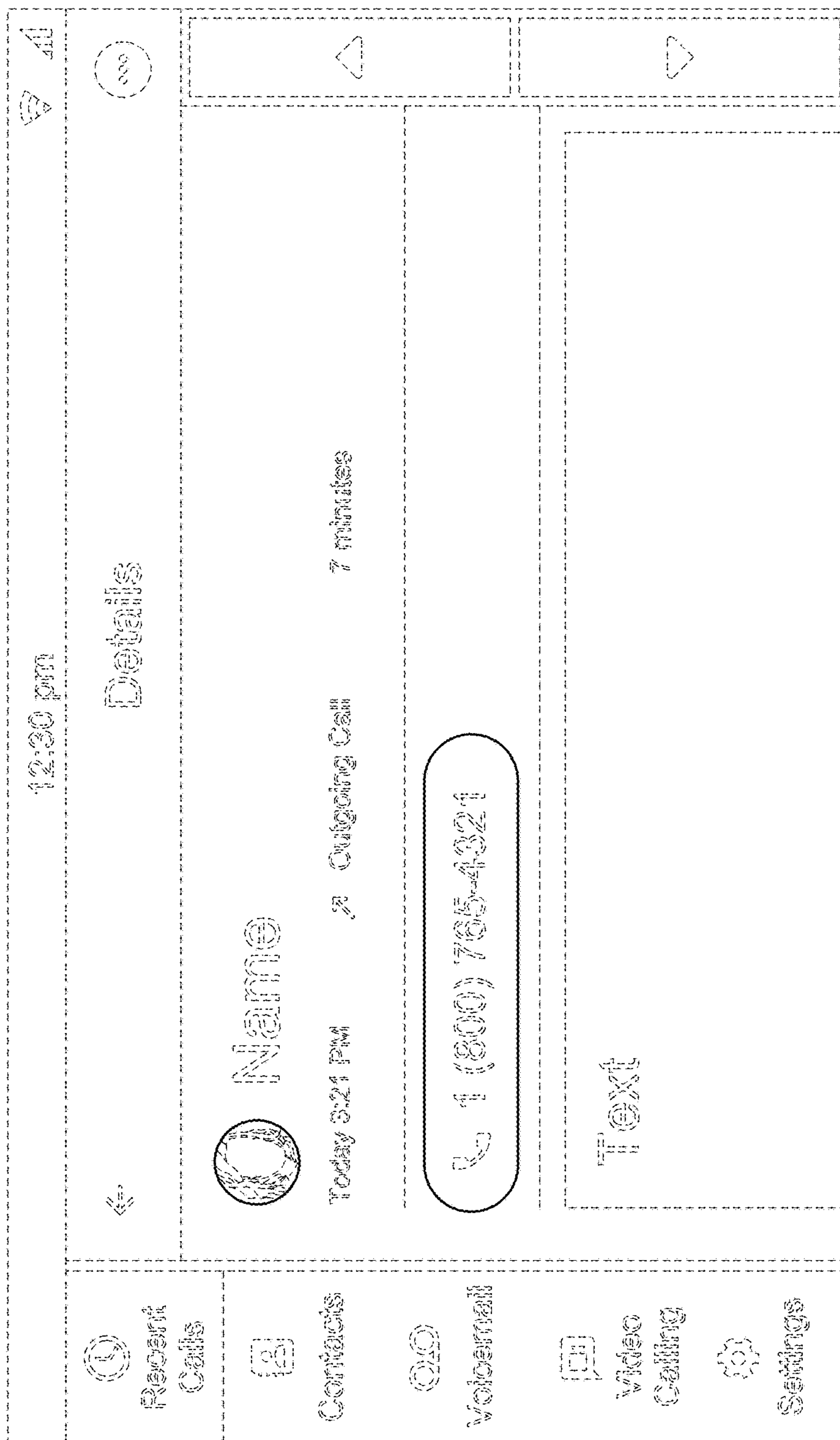

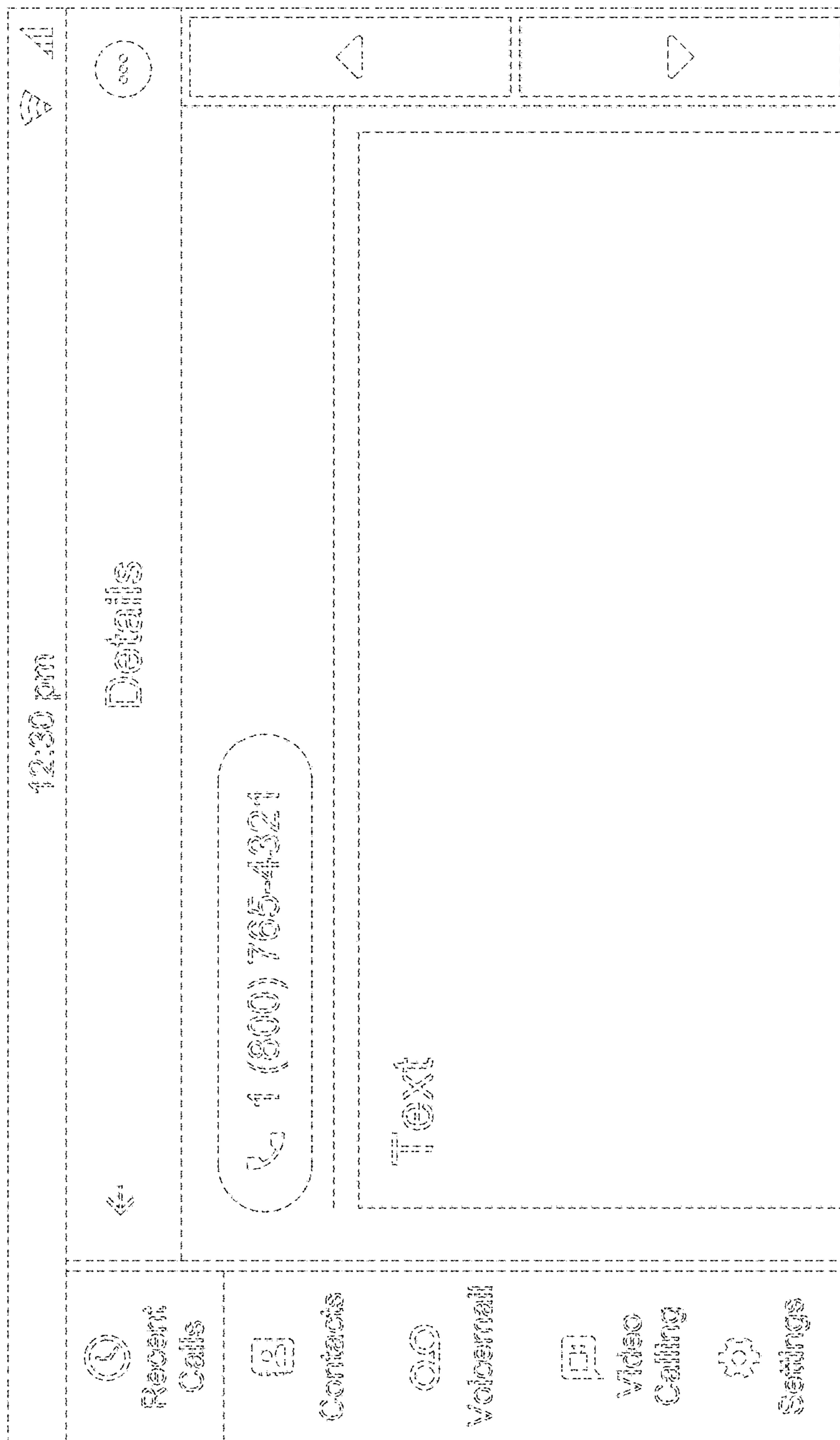

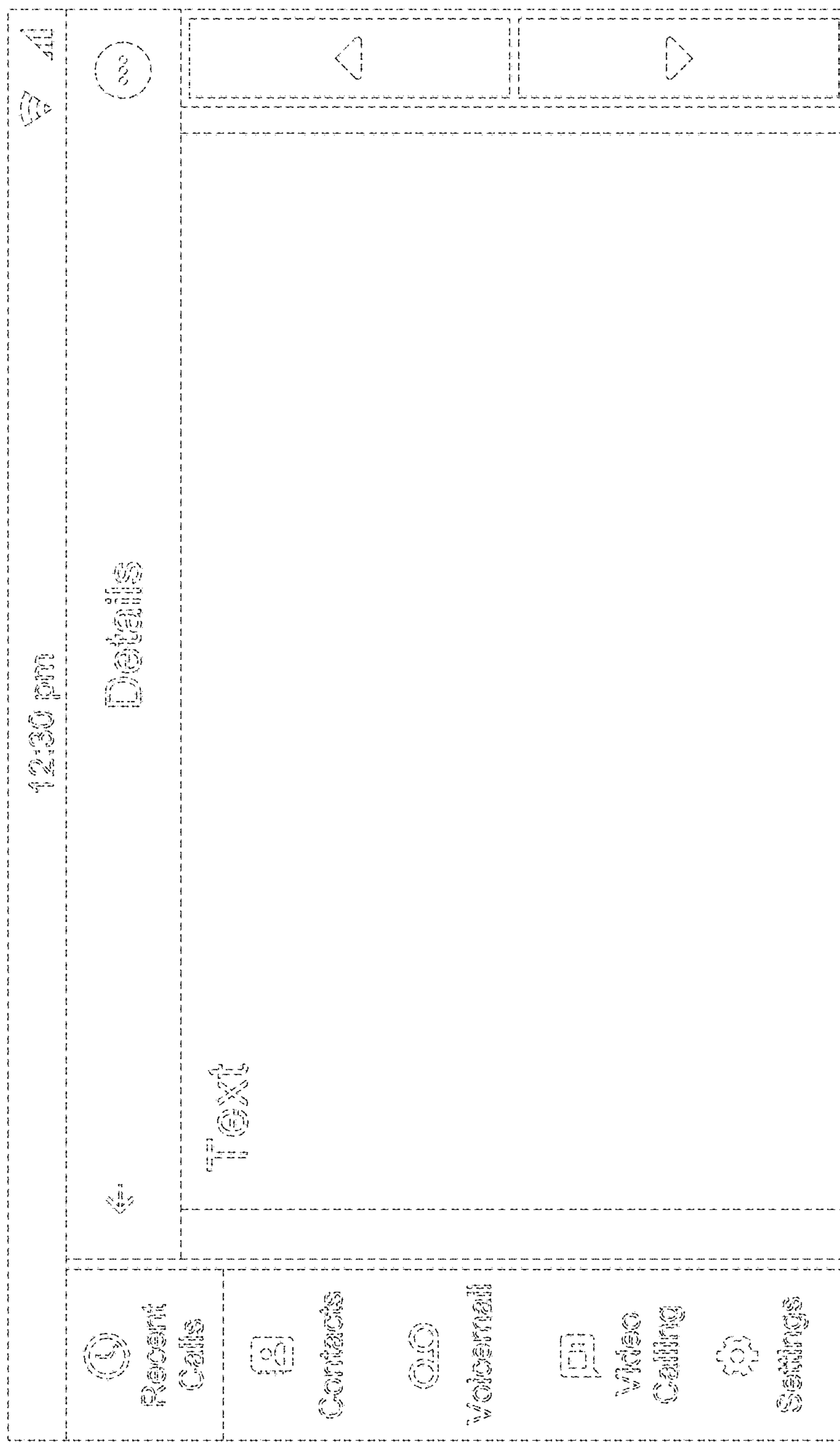

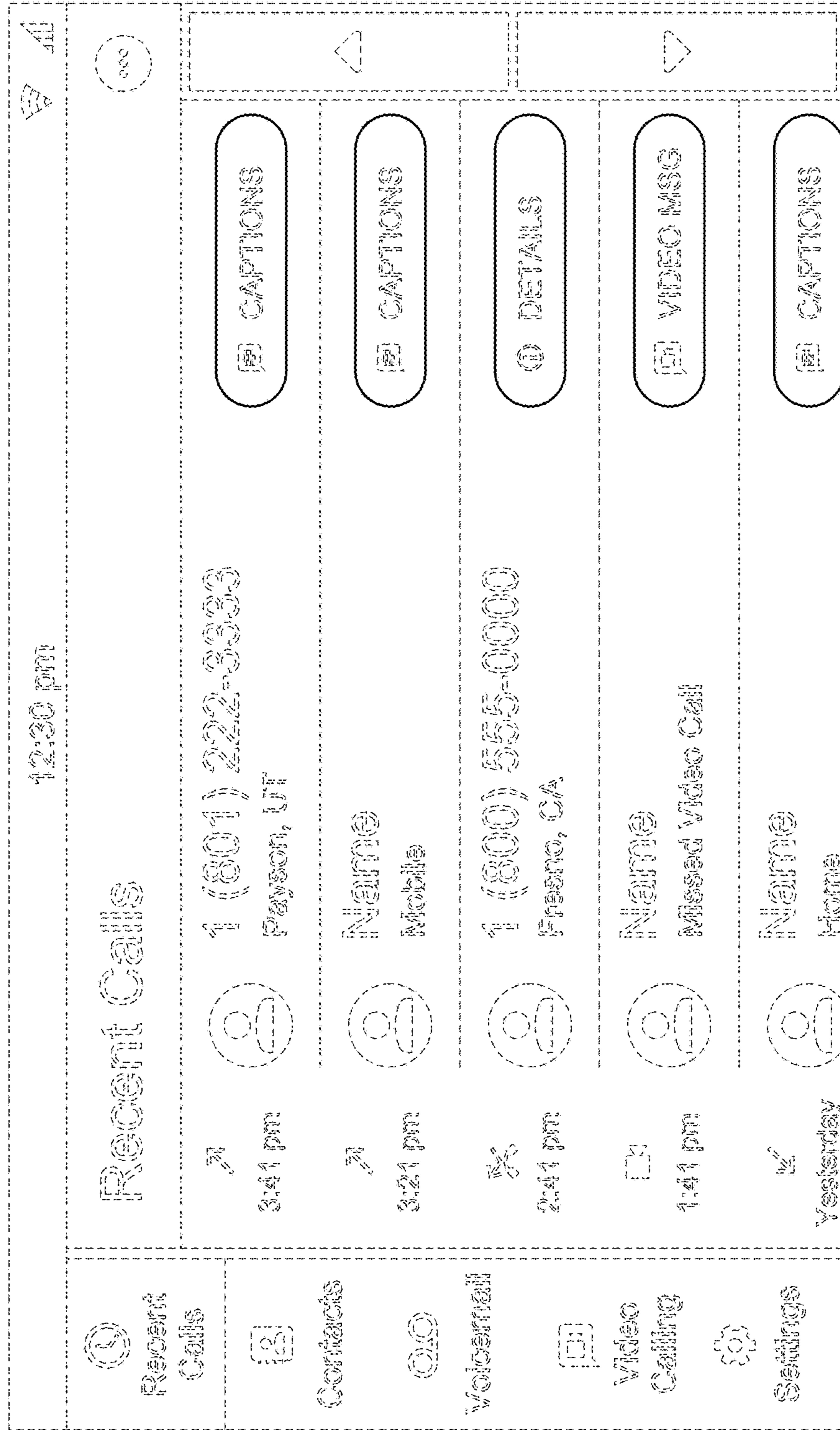

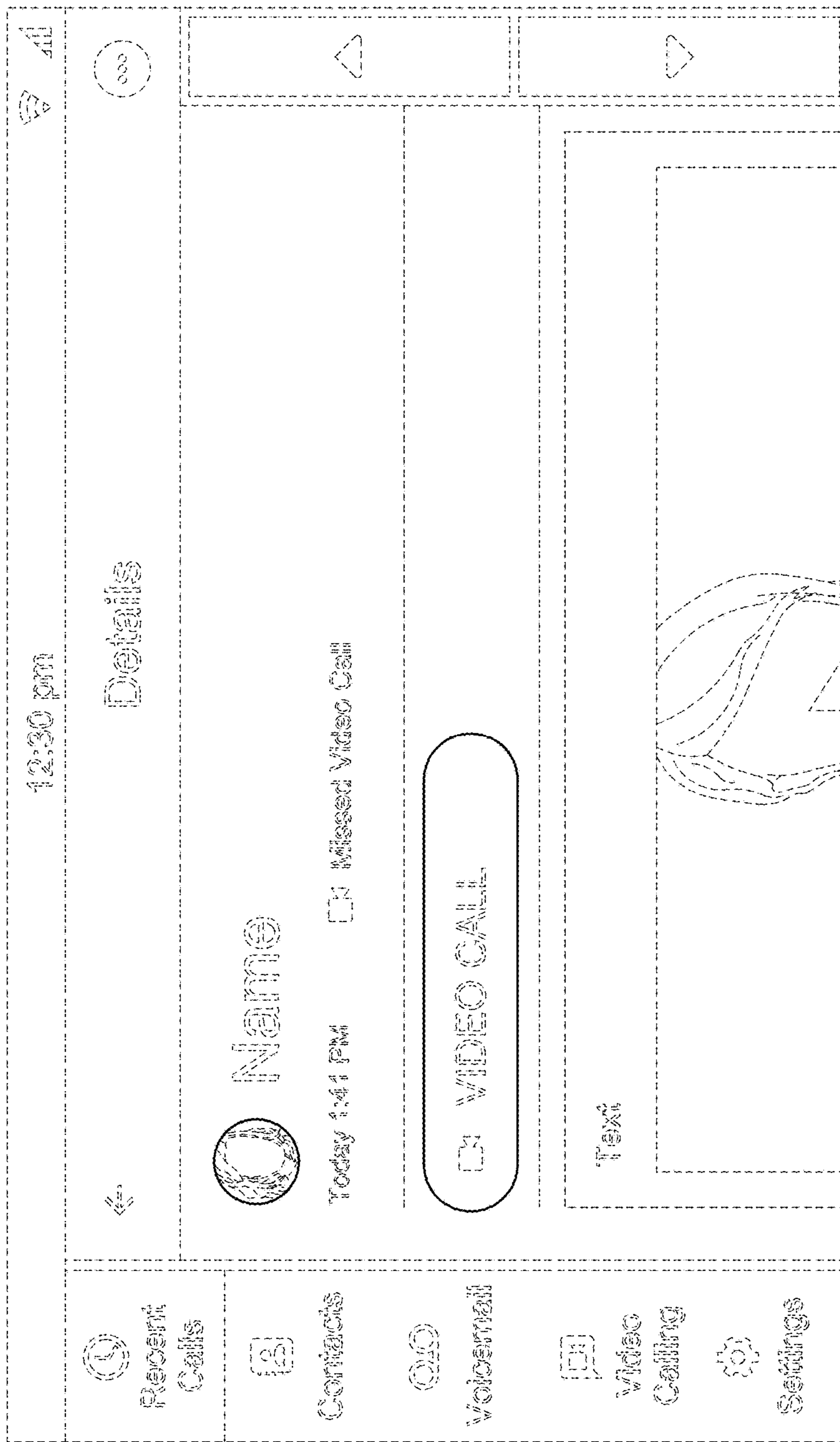
