FIG. 5 is an enlarged view of an icon in FIG. 2;

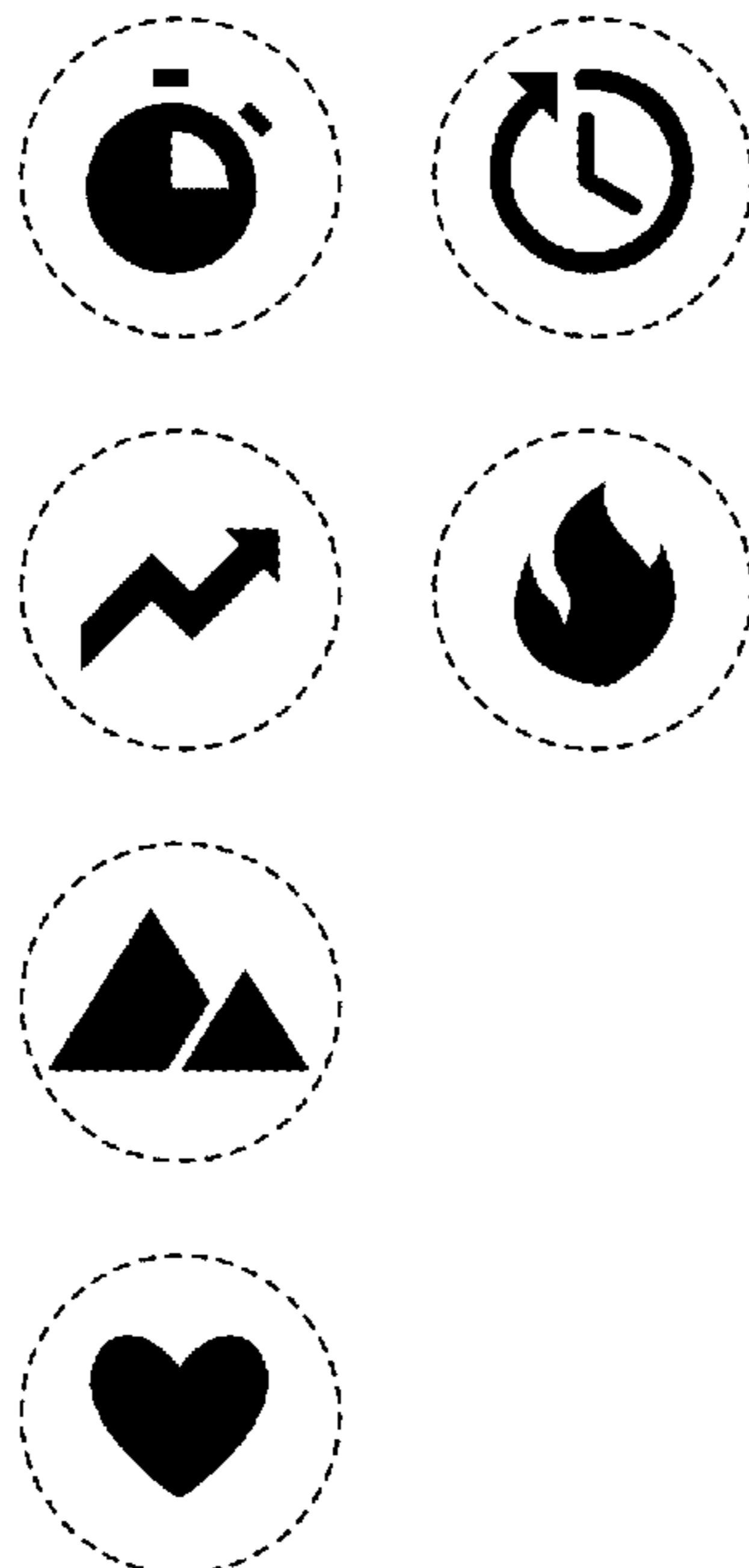
FIG. 6 is an enlarged view of an icon in FIG. 2;

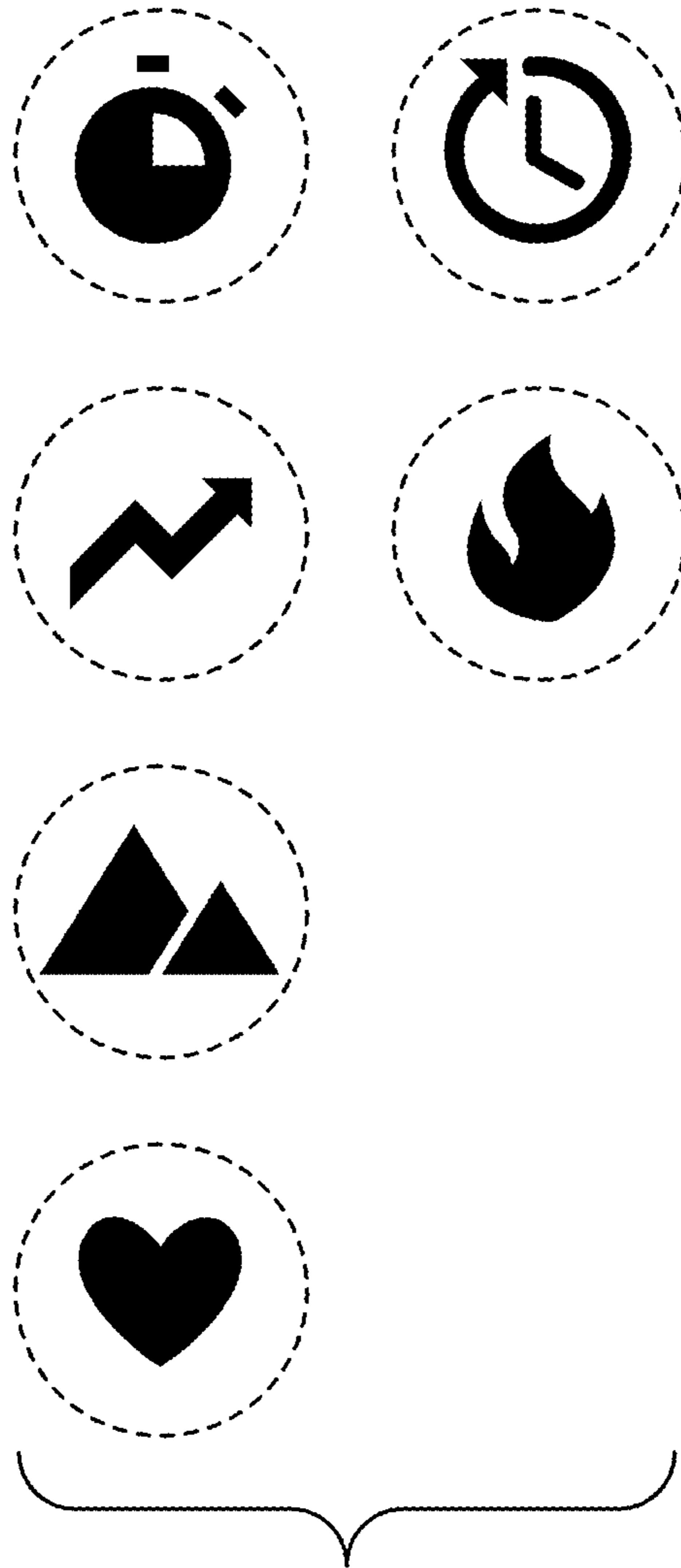

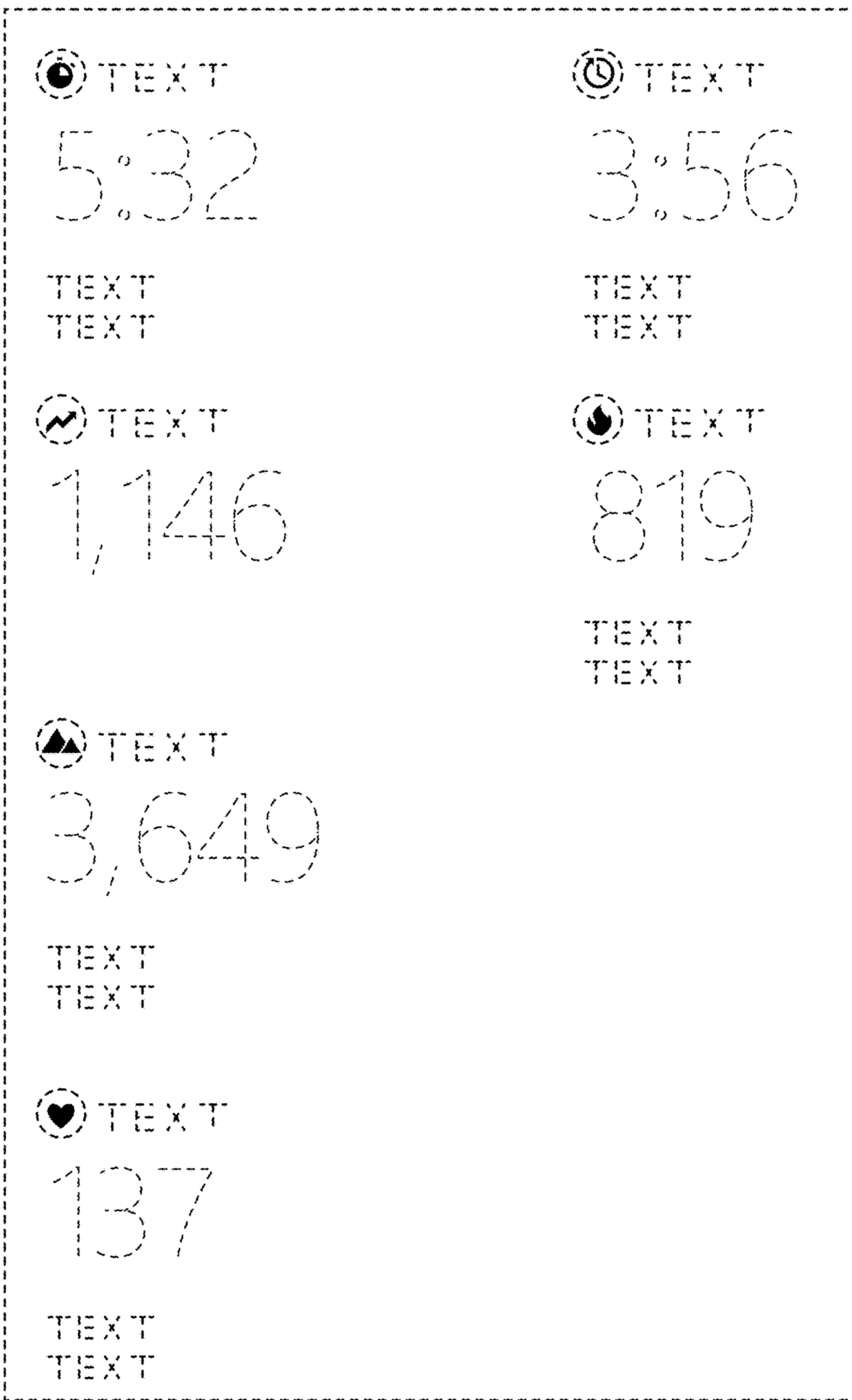

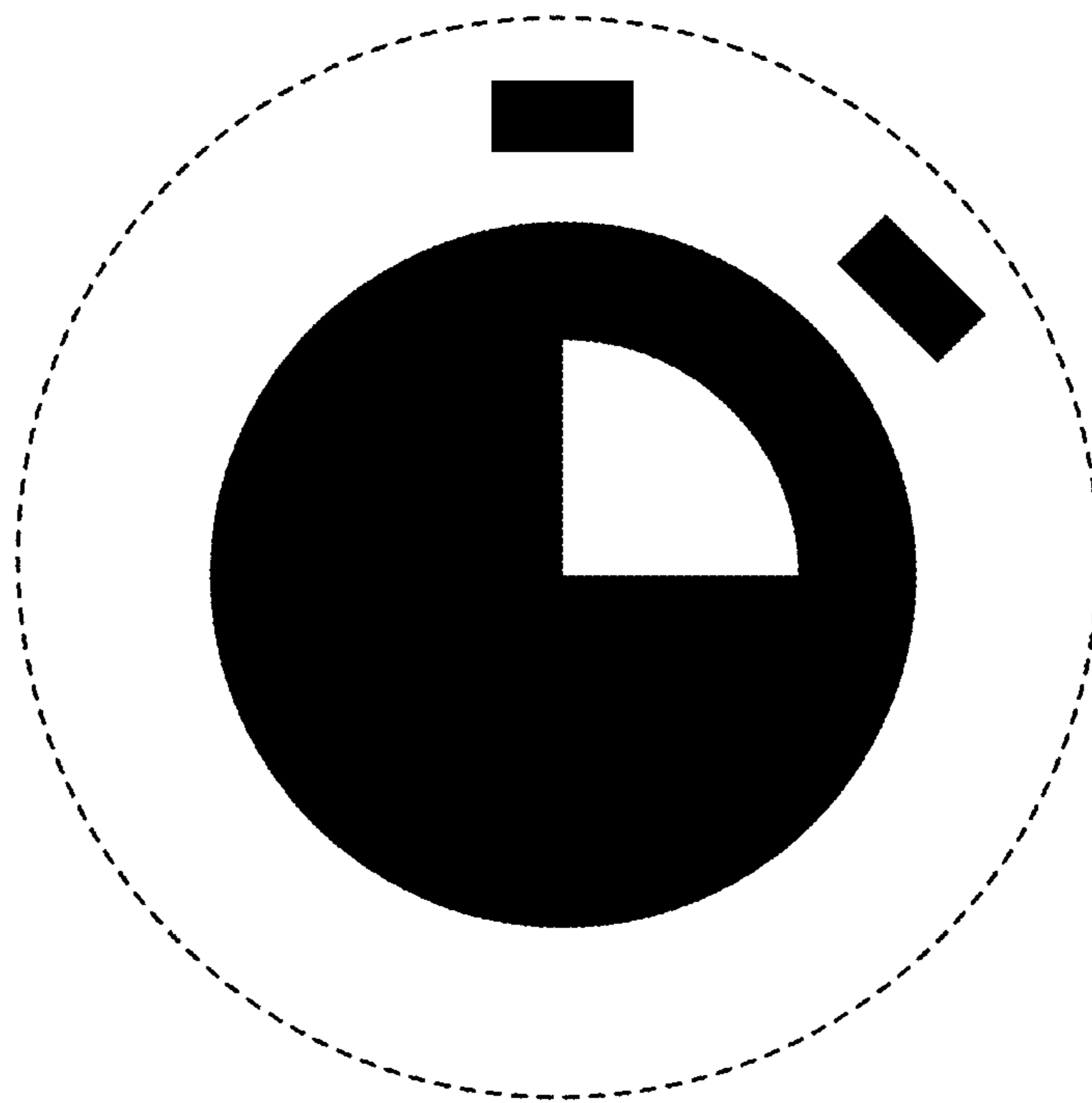

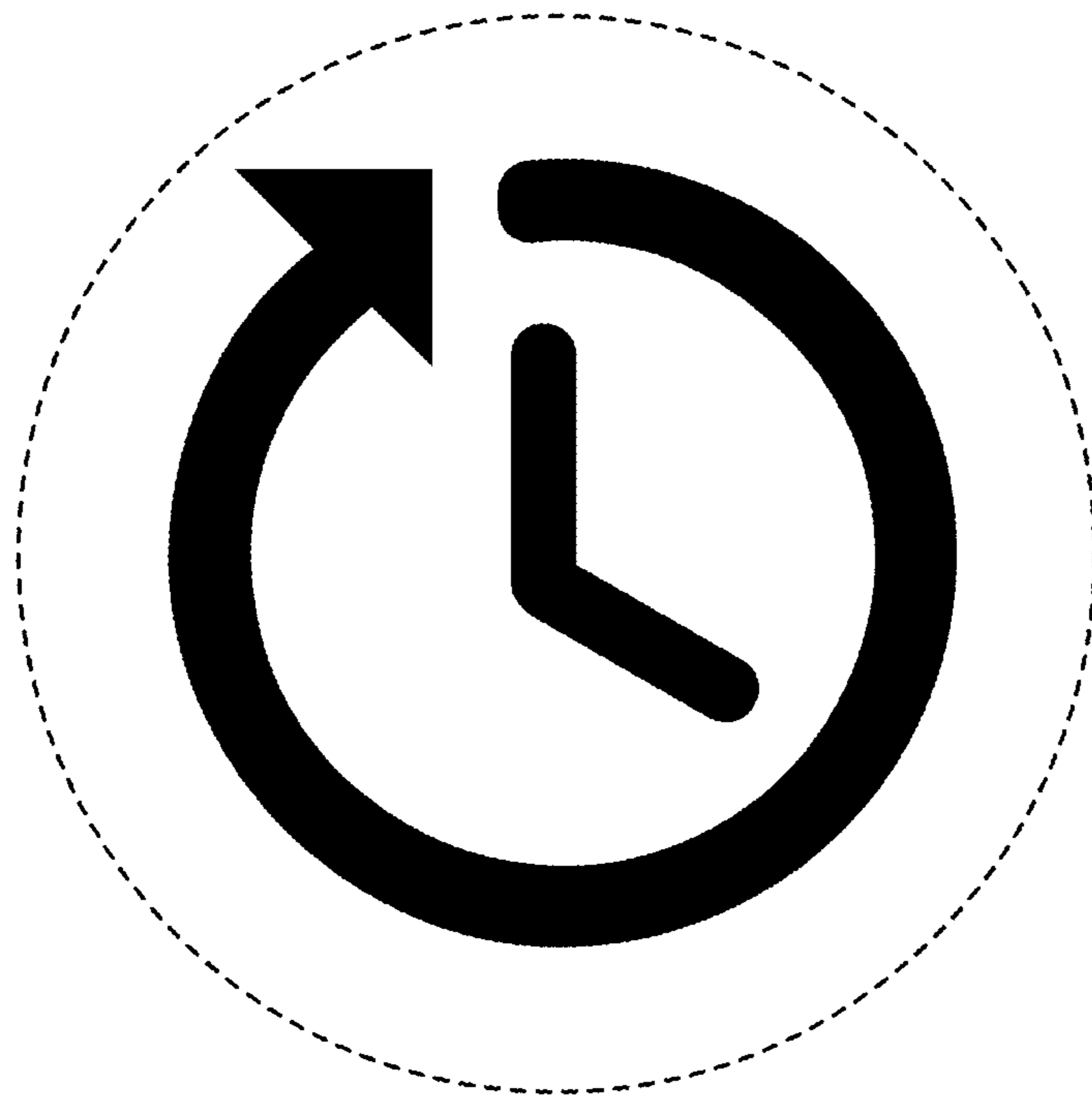

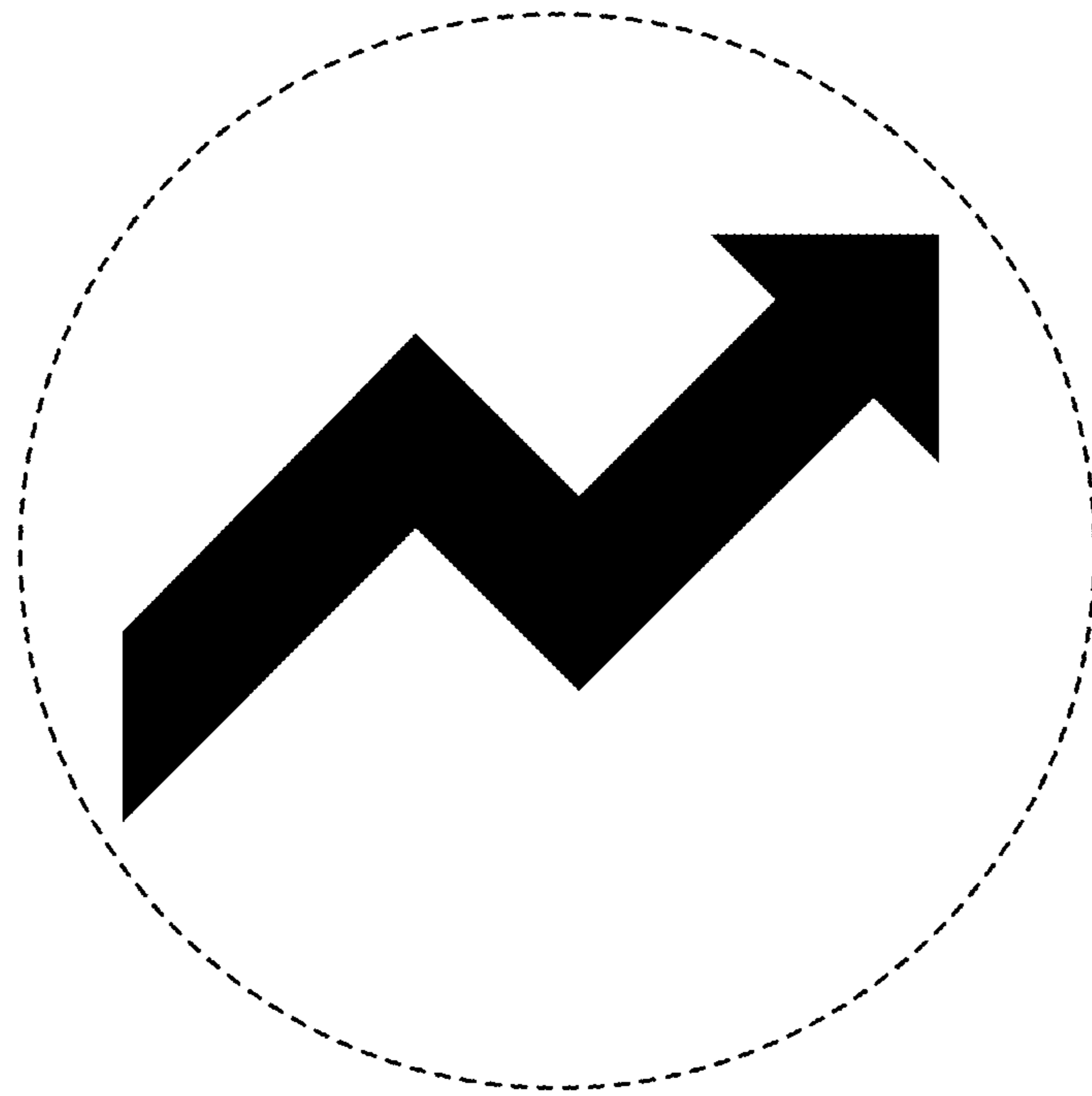

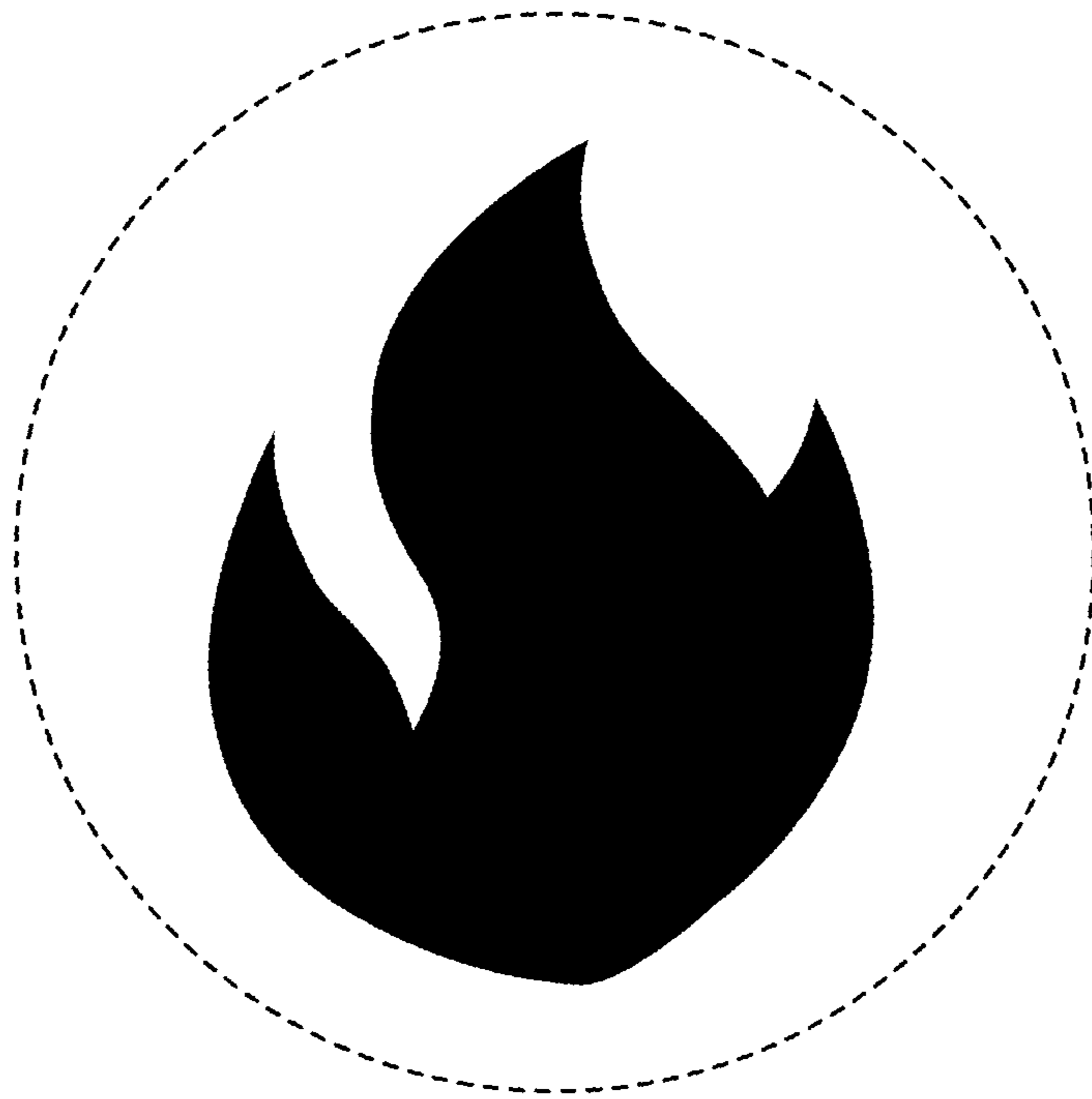

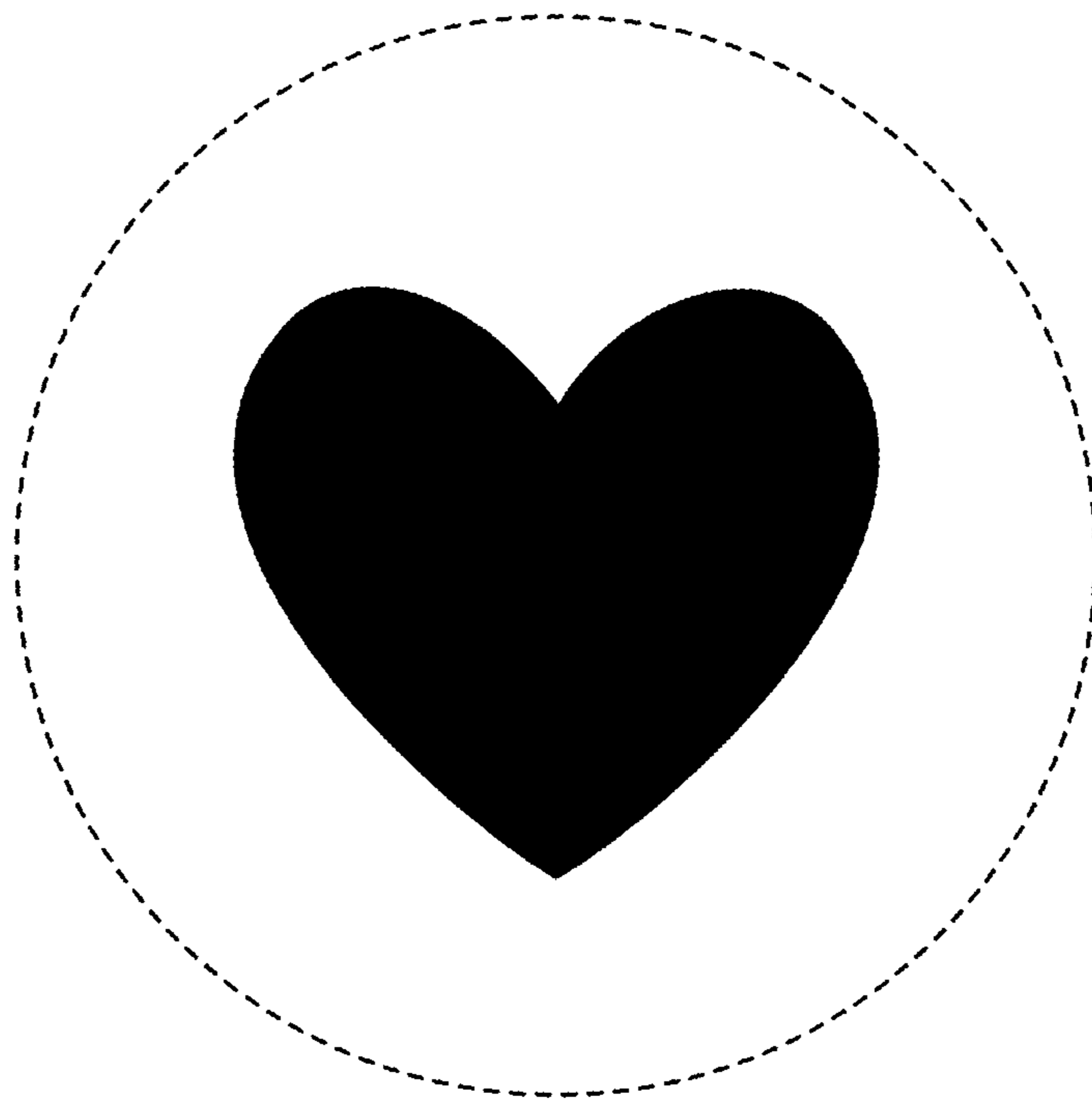
