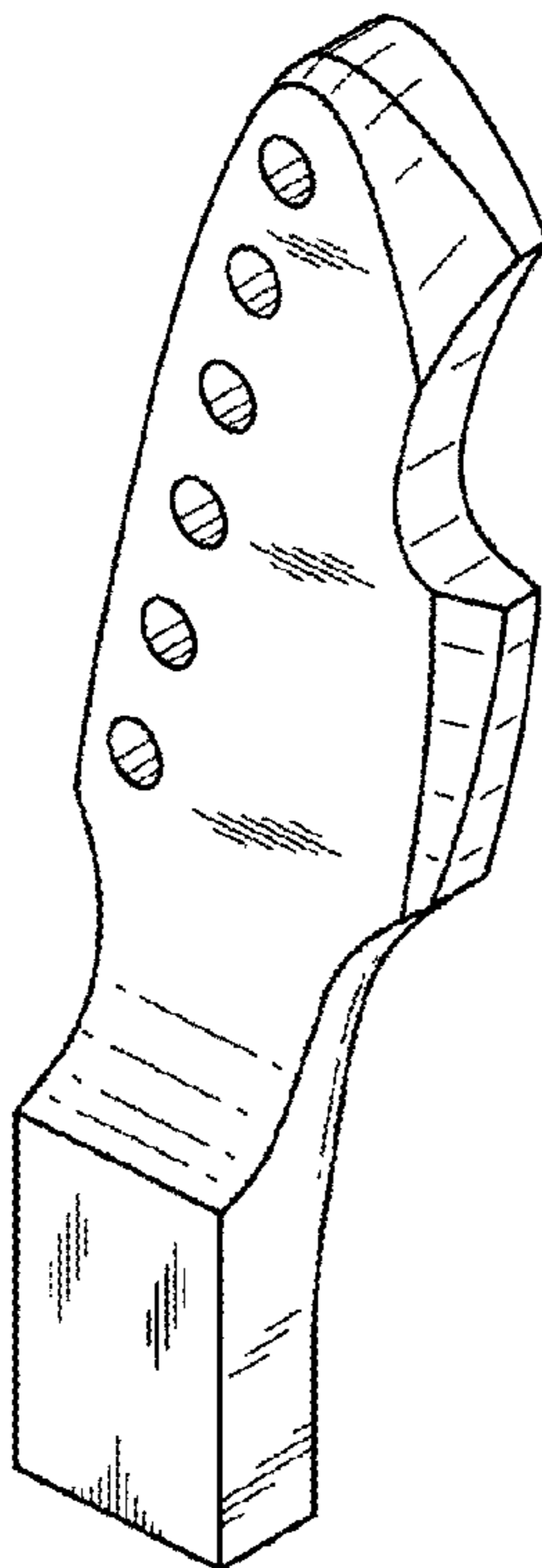
FIG. 1 is a front perspective view of the guitar headstock showing my new design.

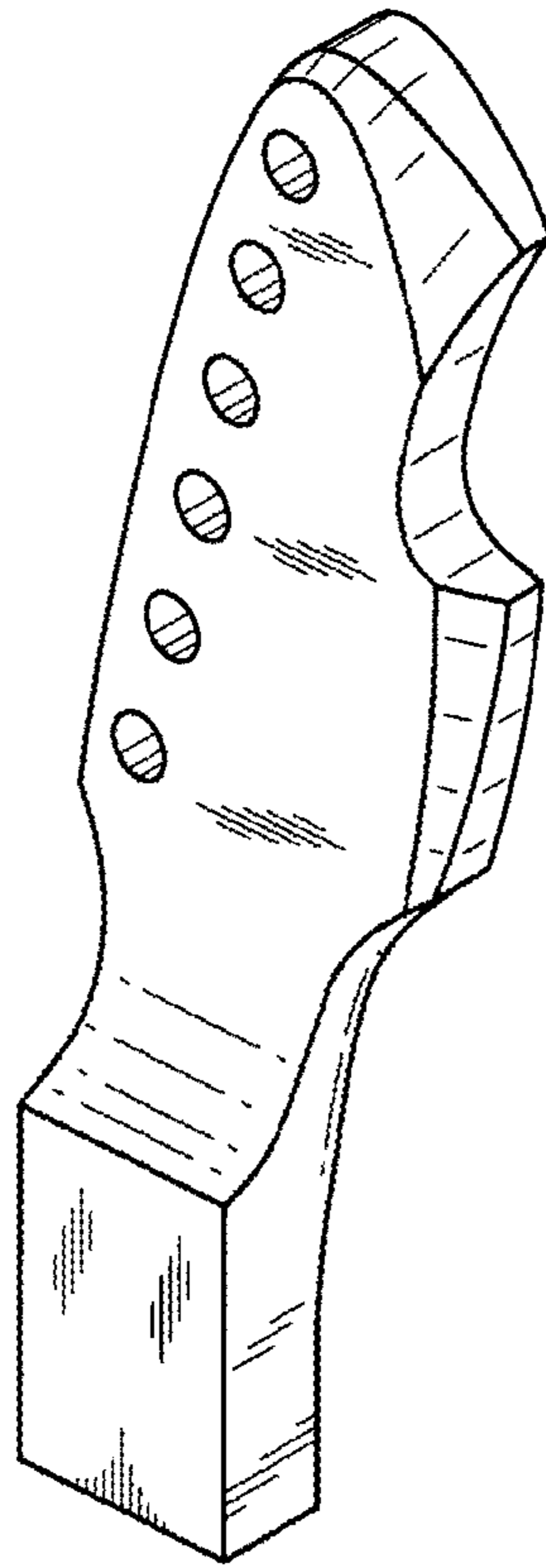

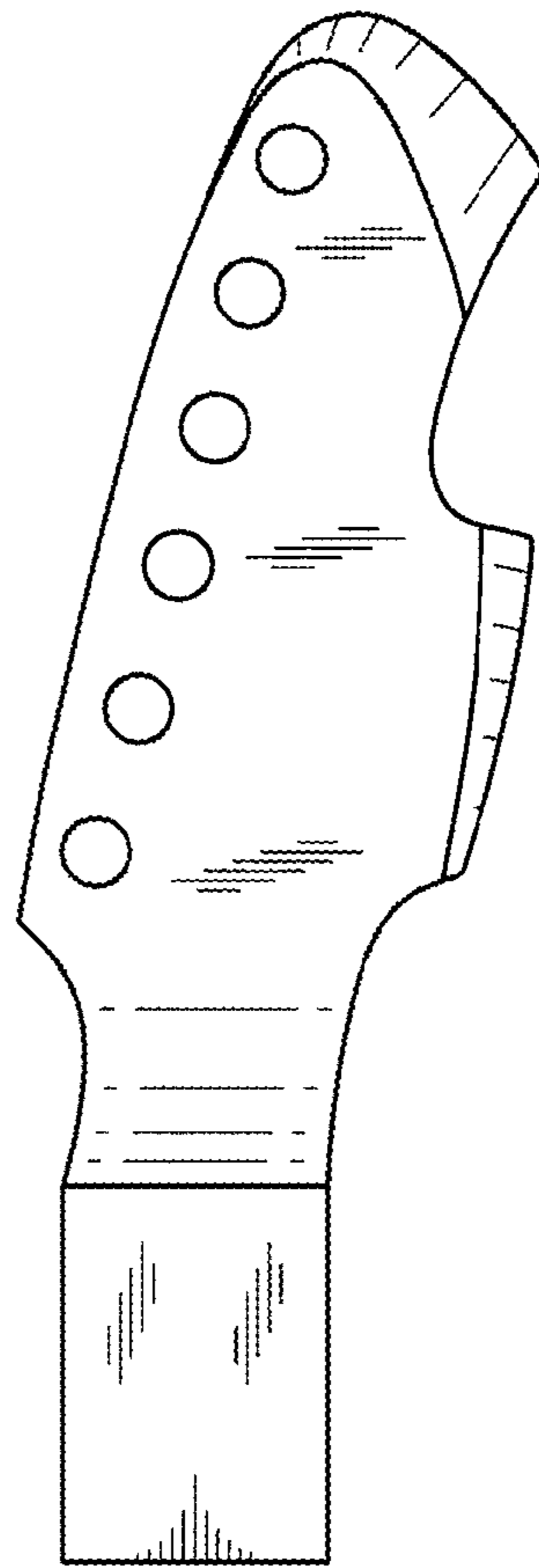

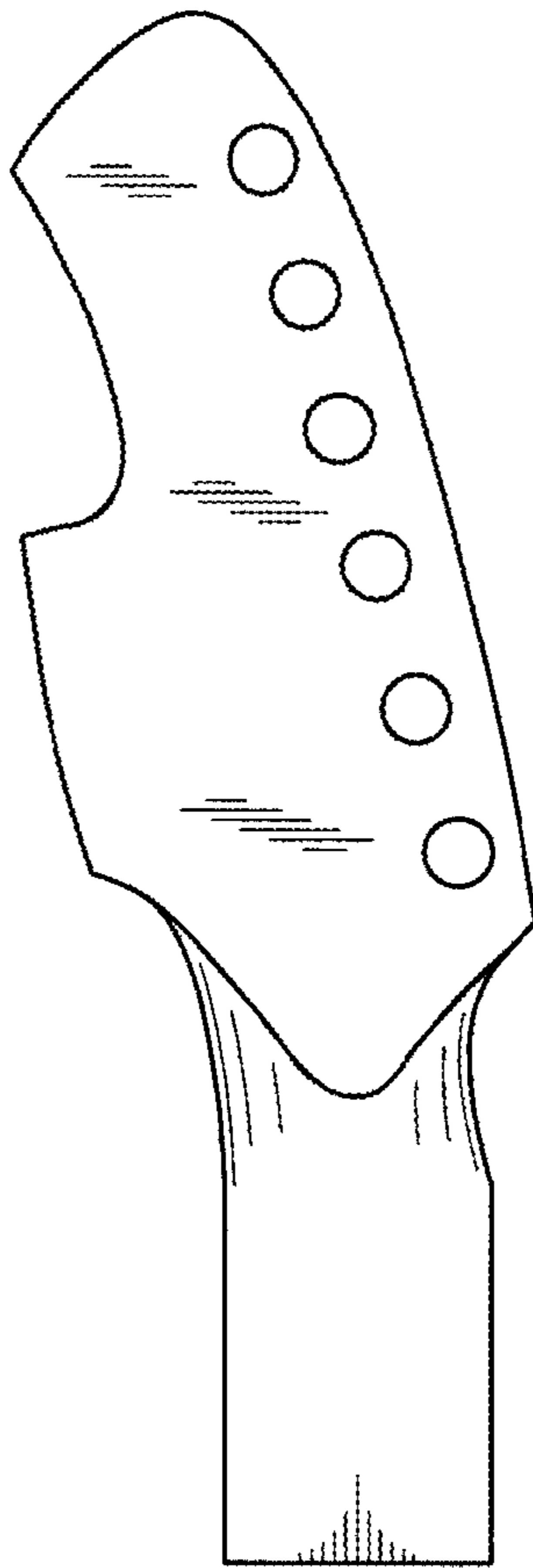

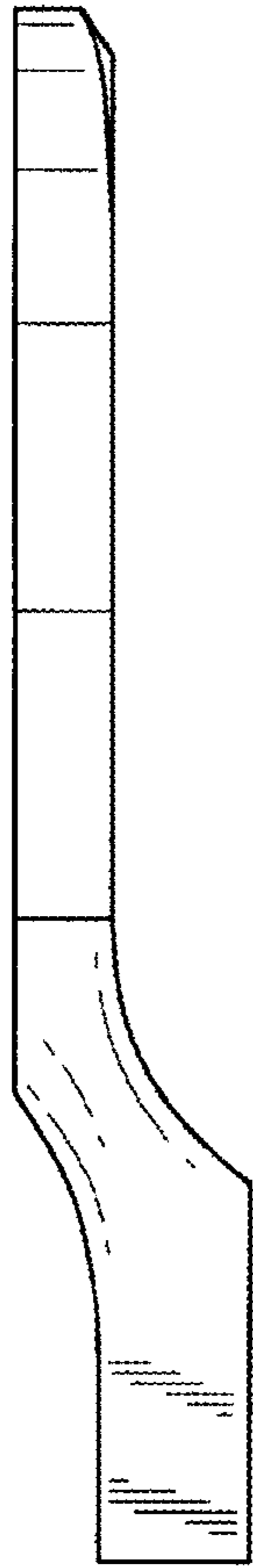

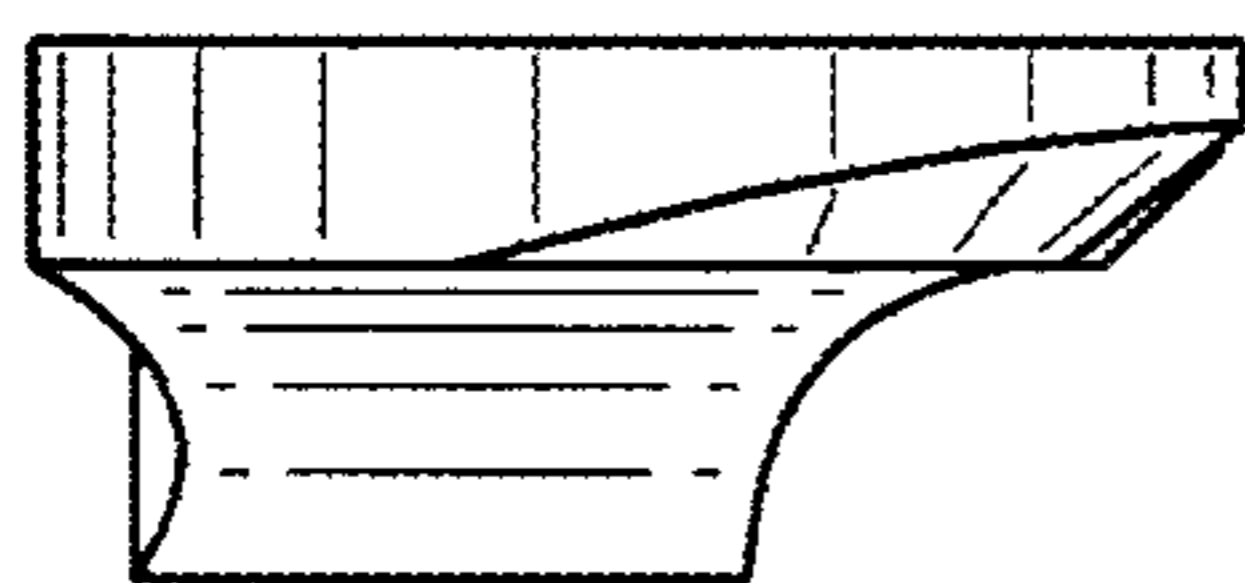

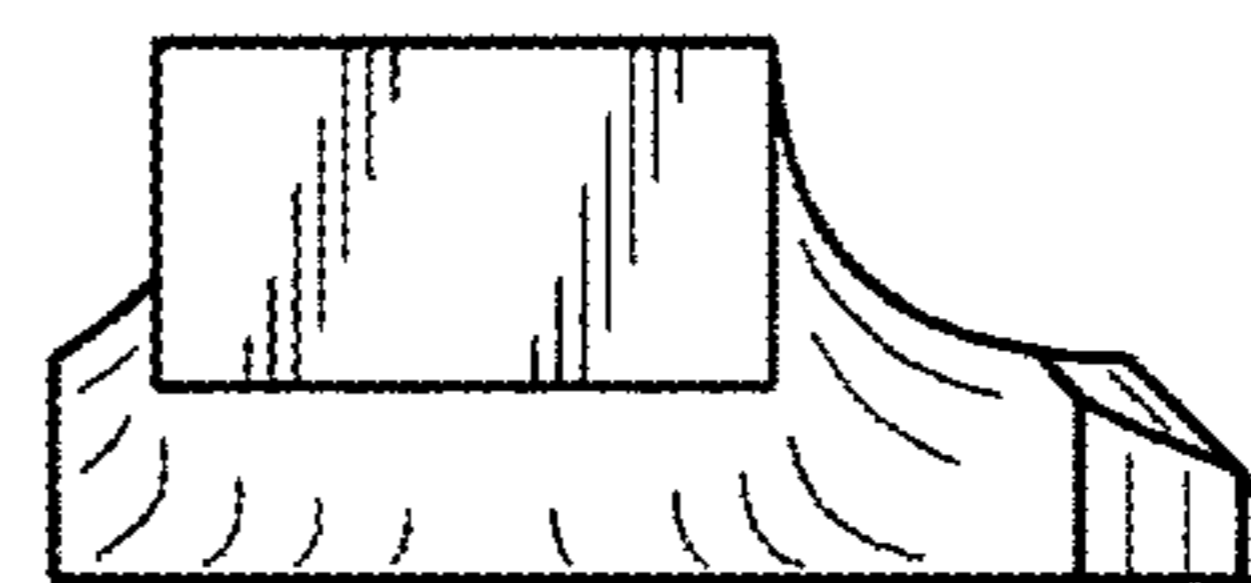
