DESCRIPTION

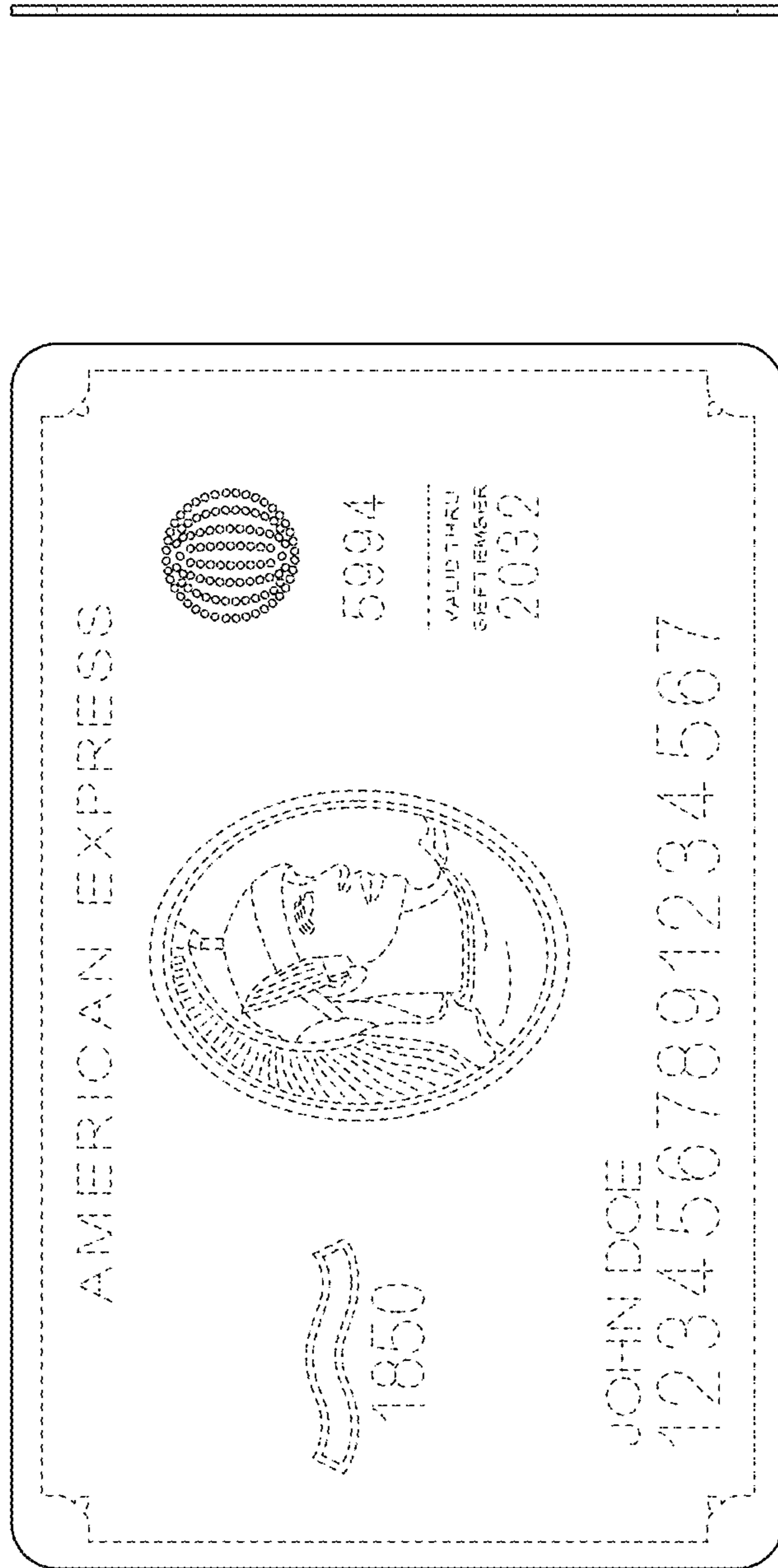

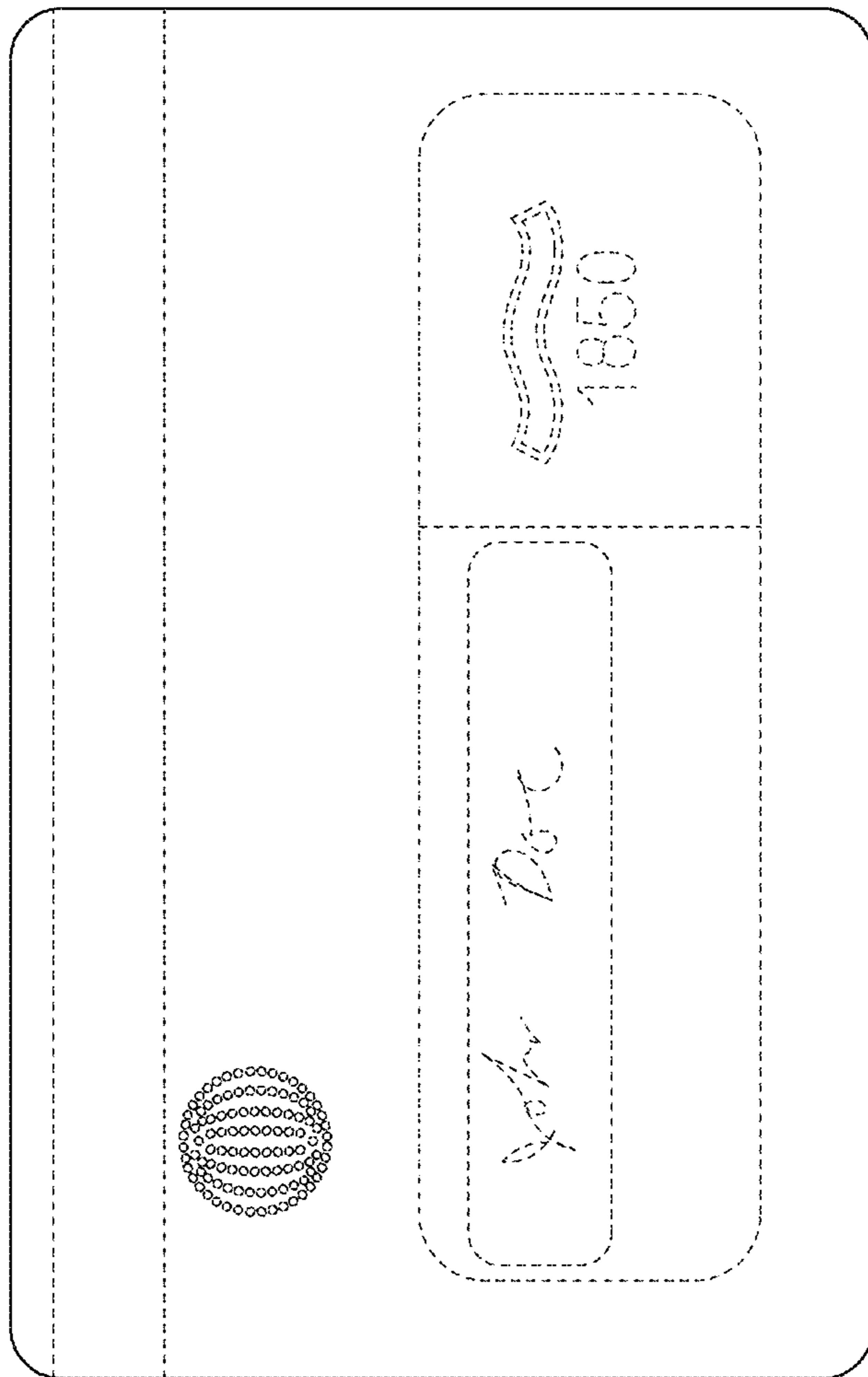
