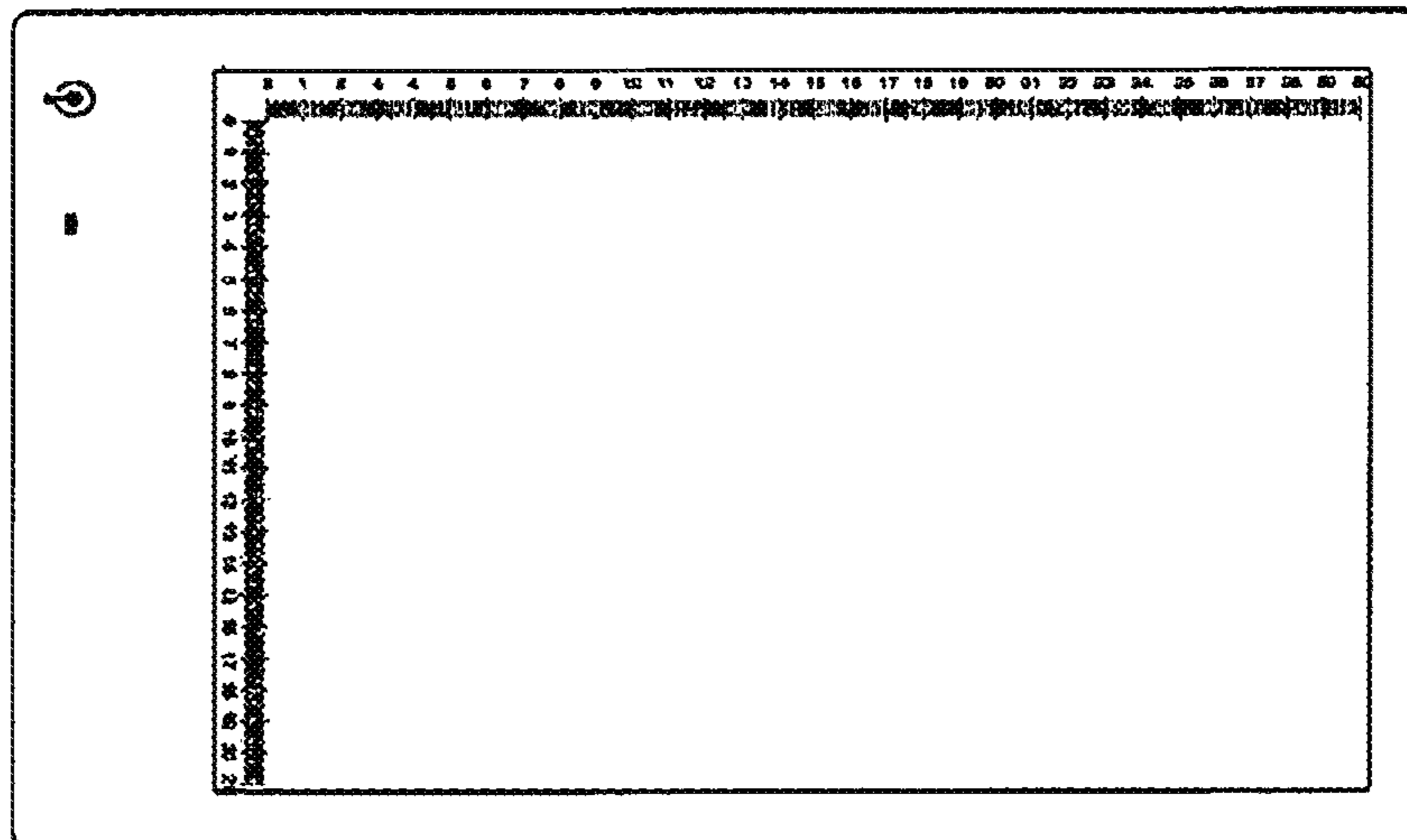
The ornamental design for drawing board, as shown and described.

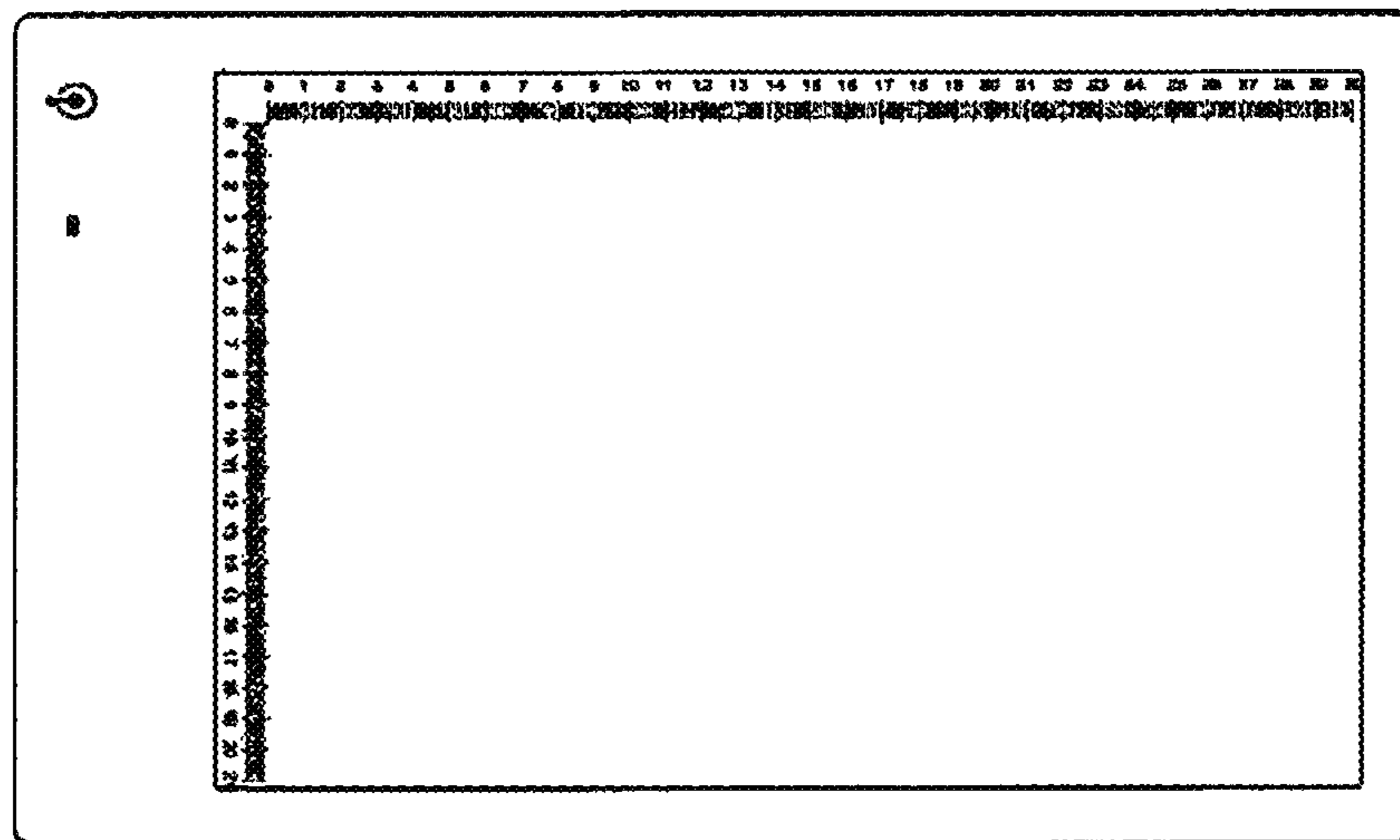

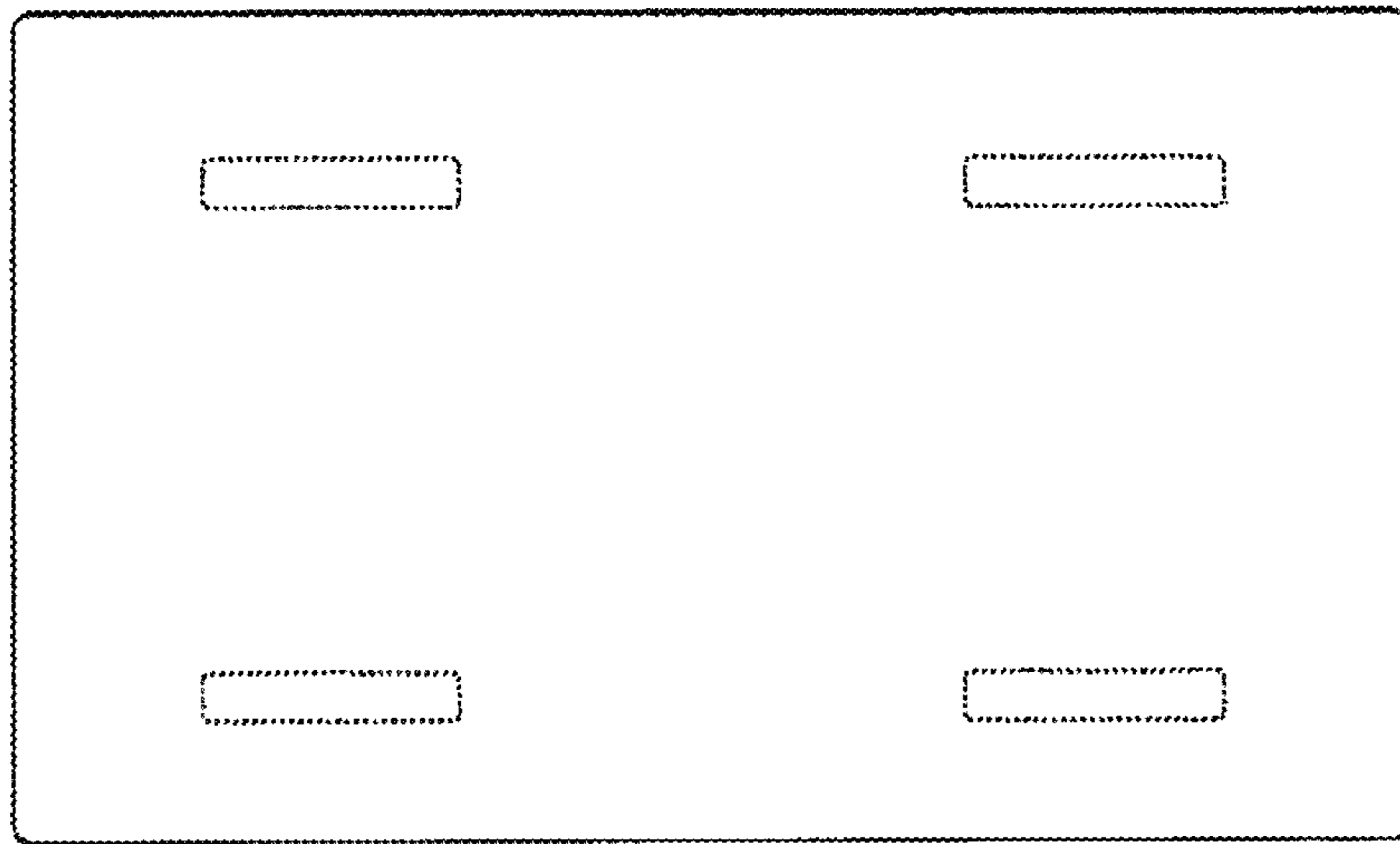

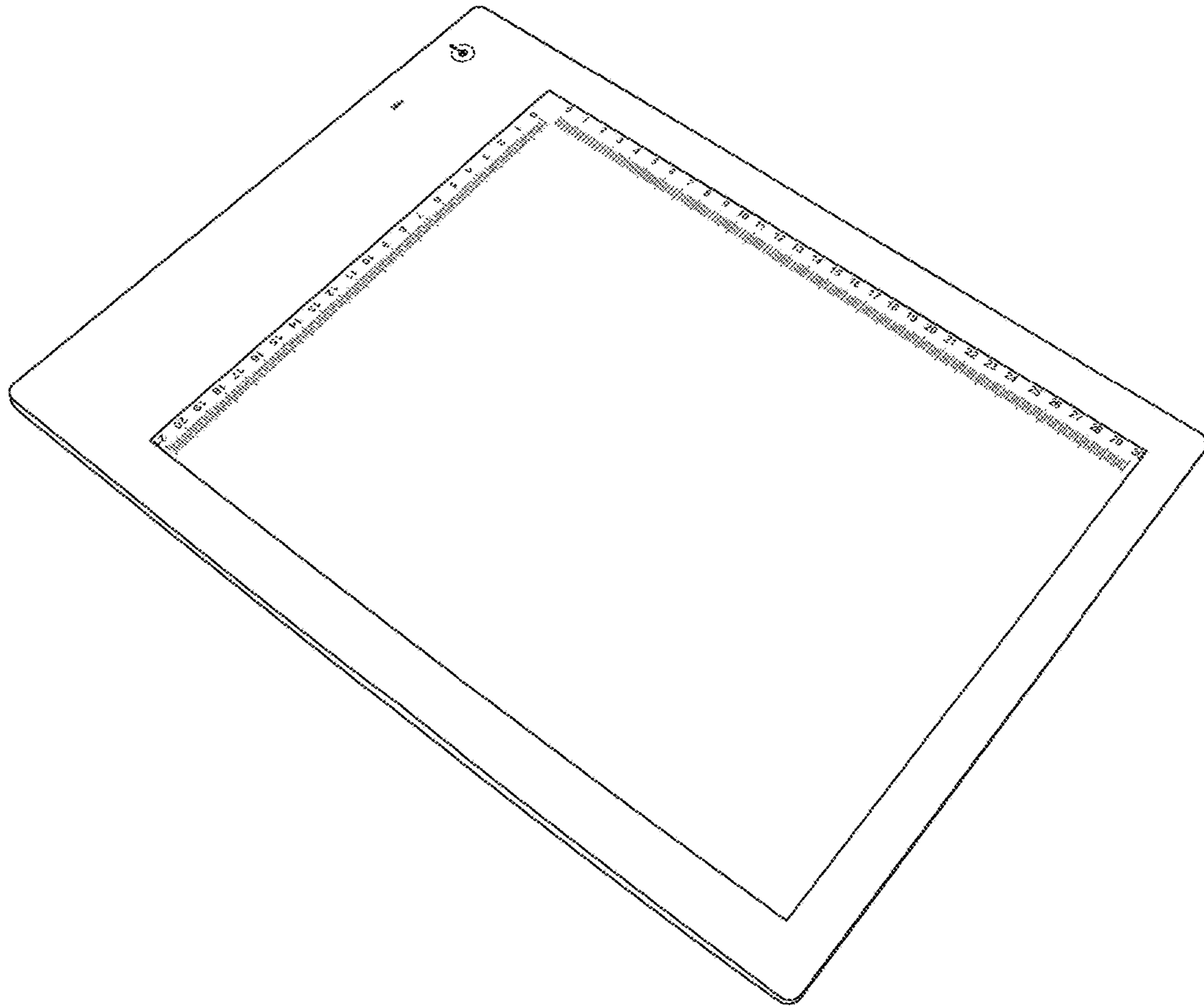
