The ornamental design for a water heater, as shown.

DESCRIPTION

FIG. 1 is a front view of a water heater of the present design;

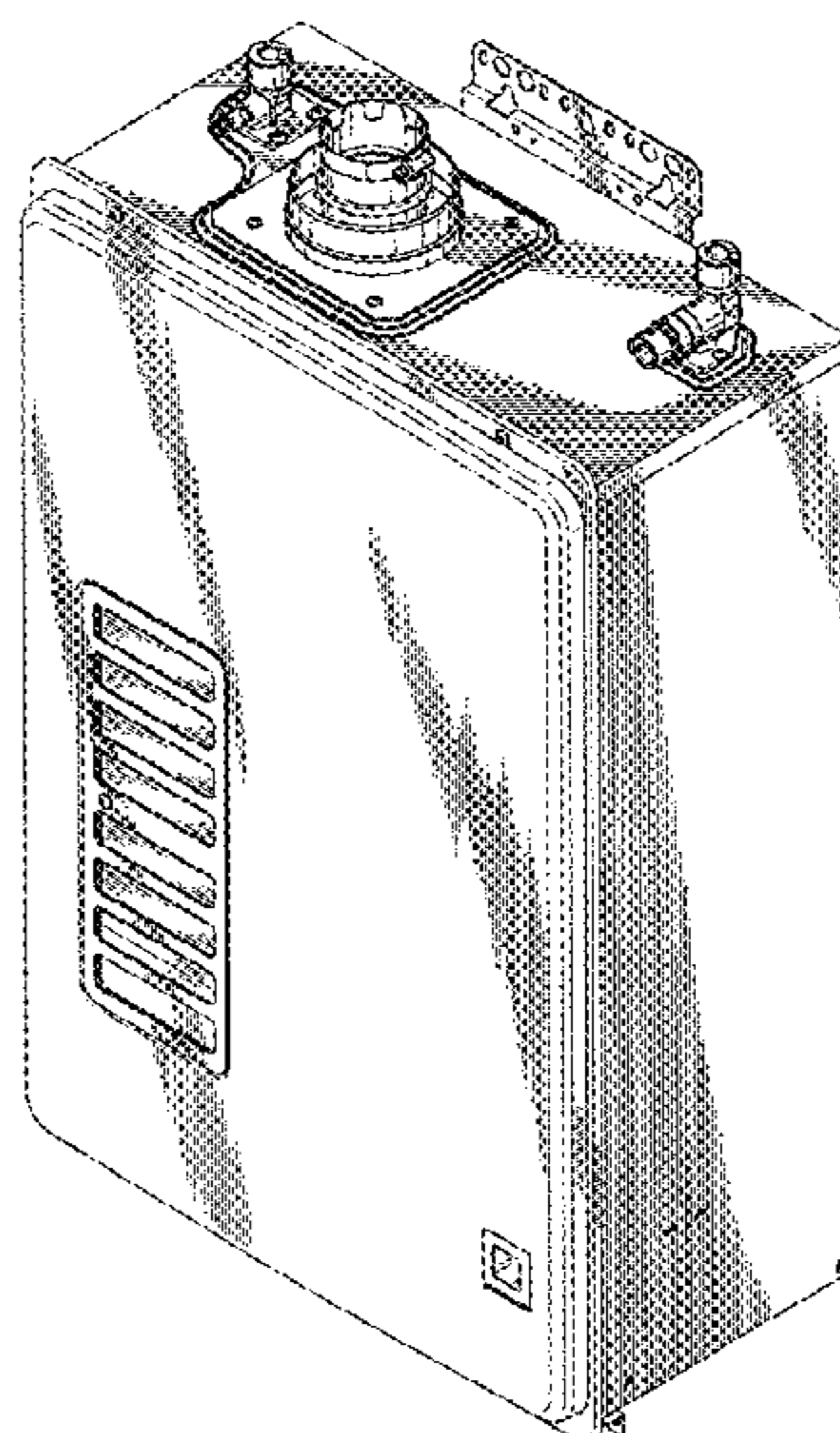

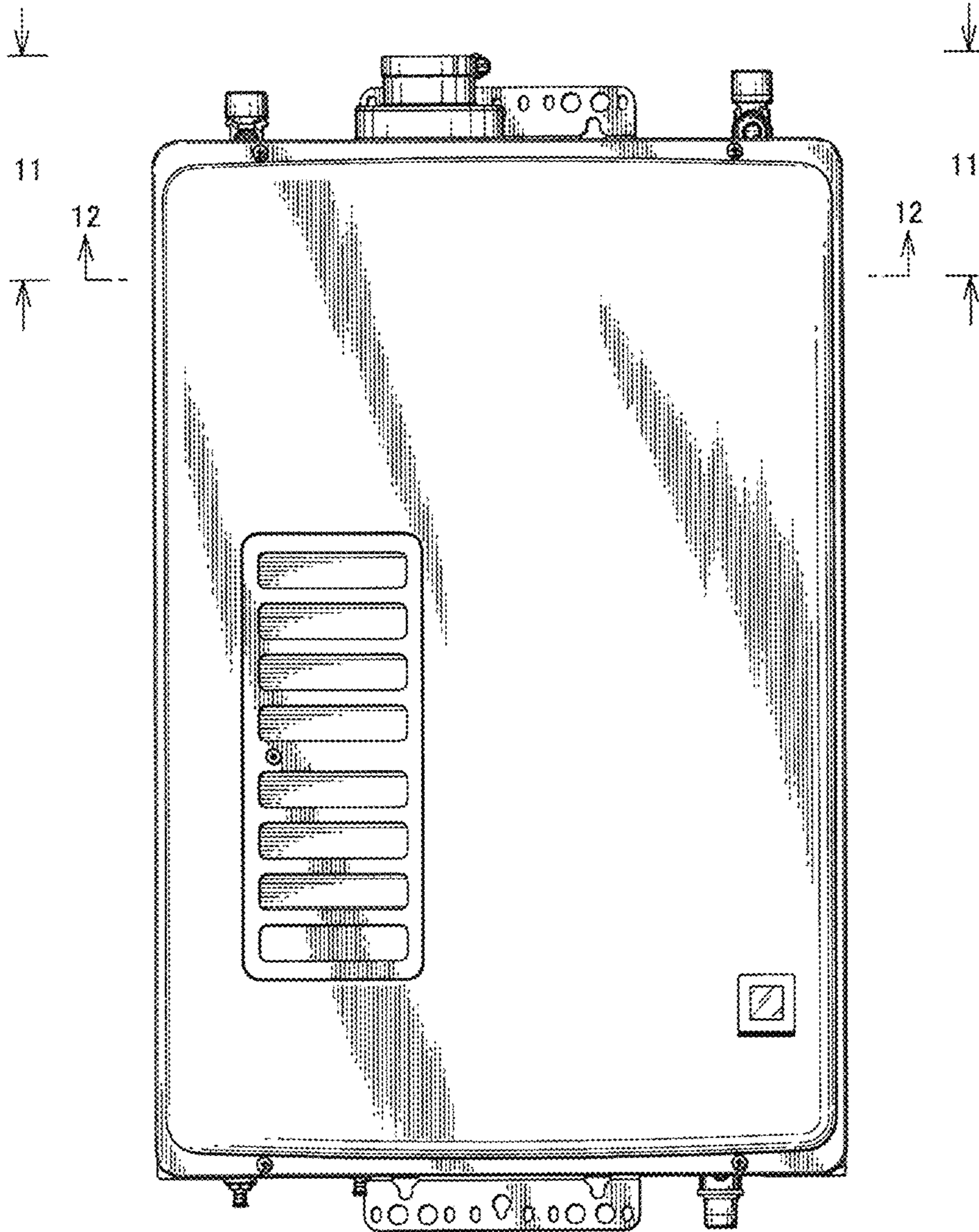

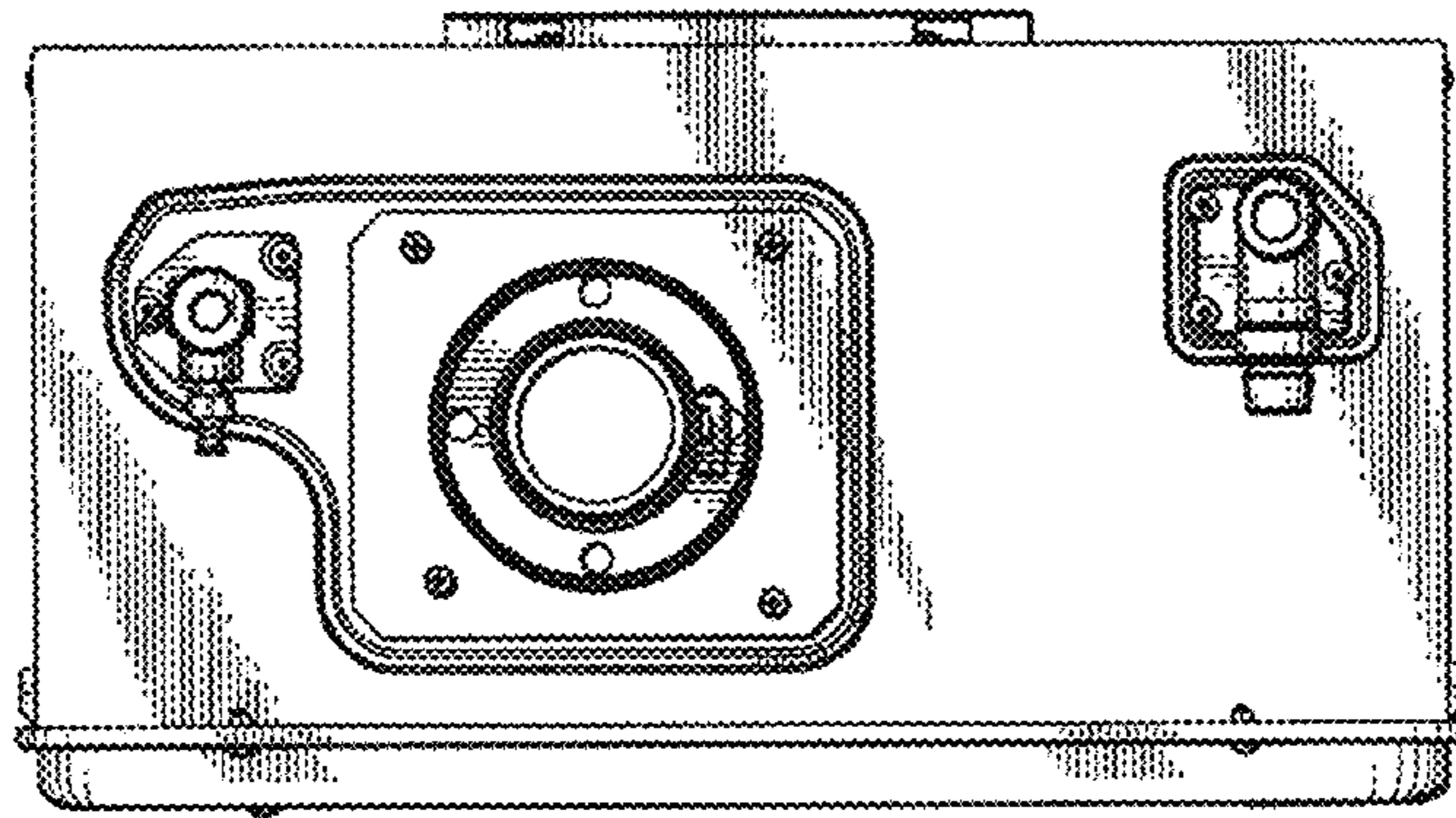

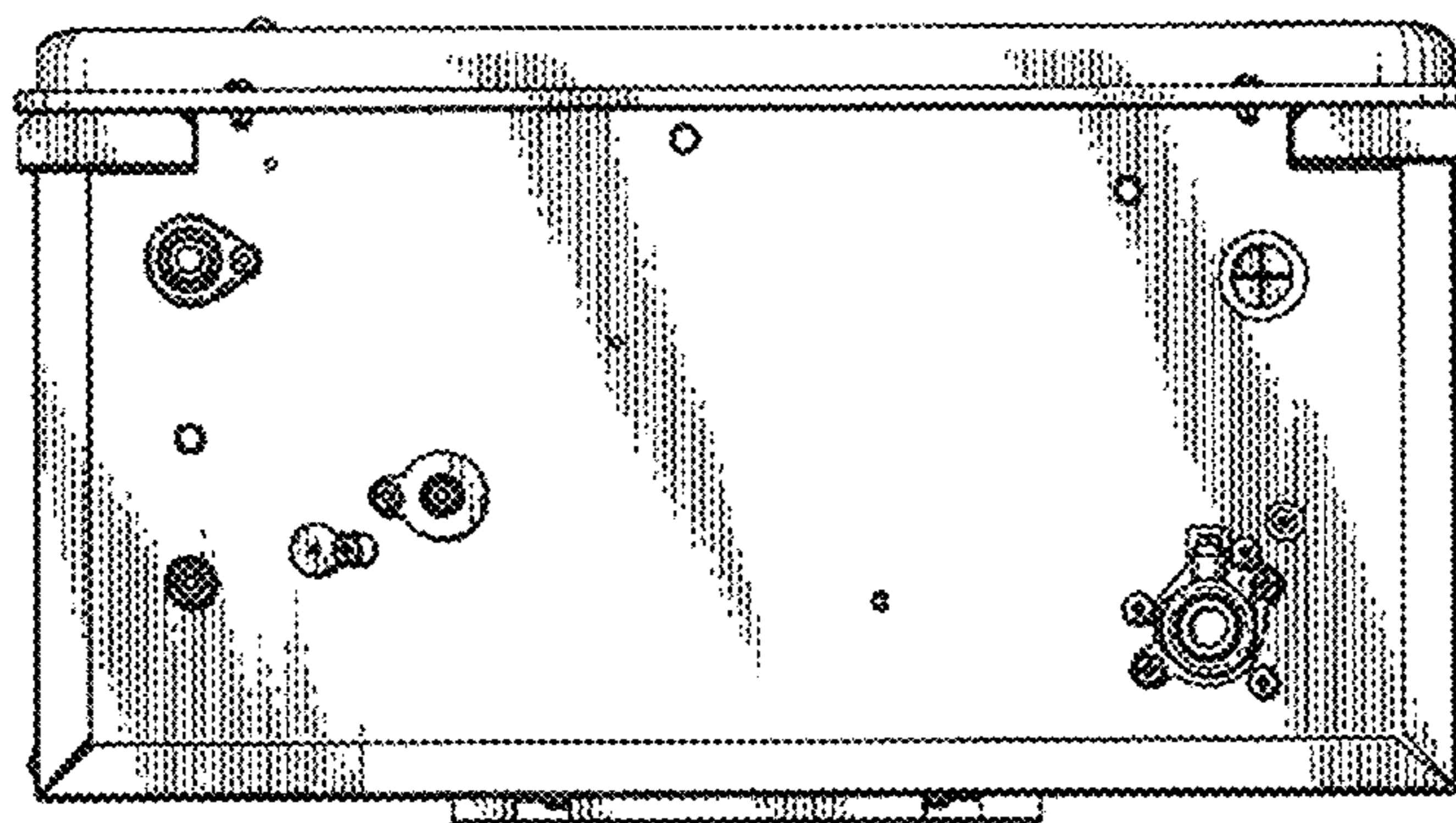

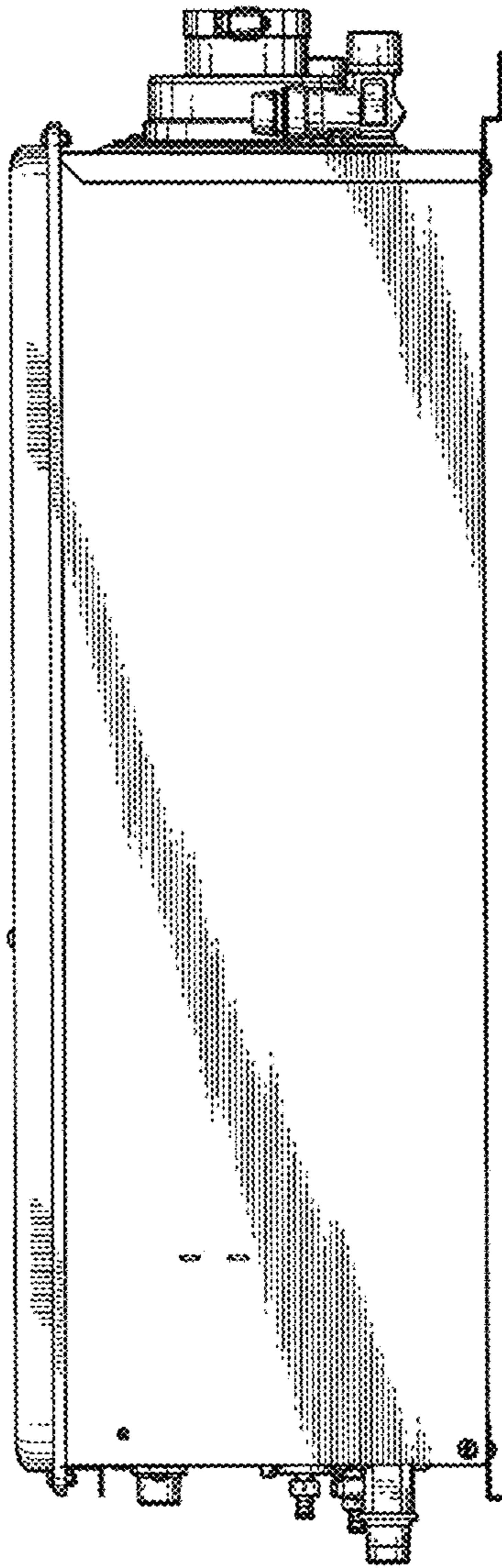

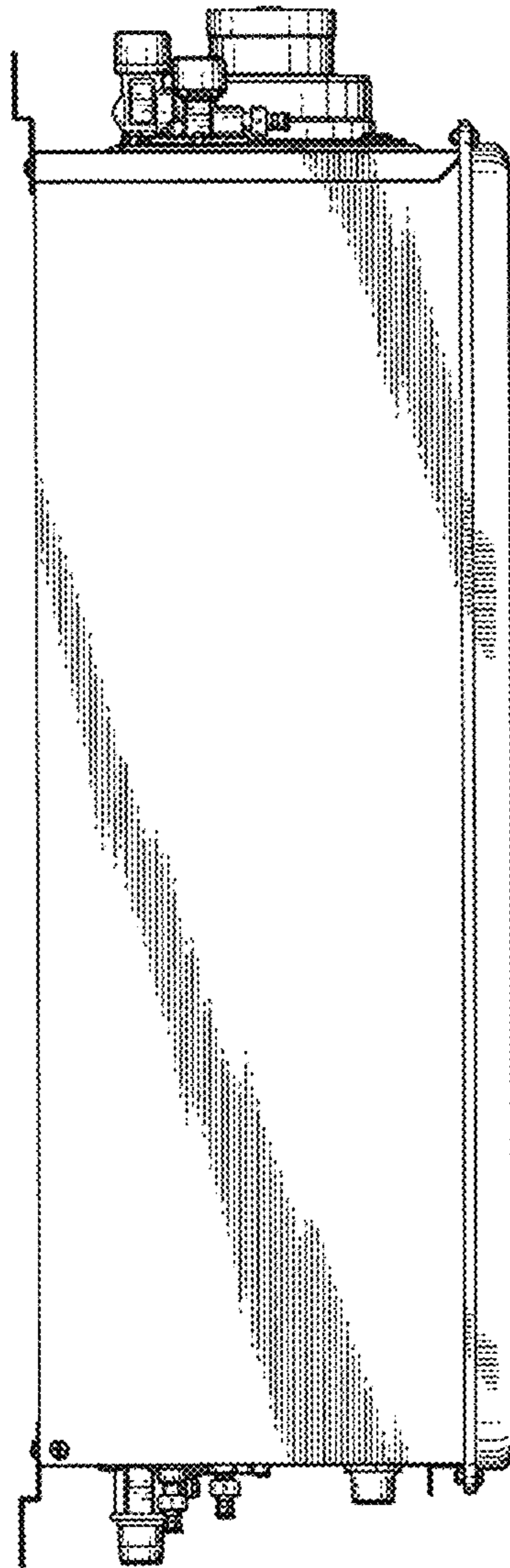

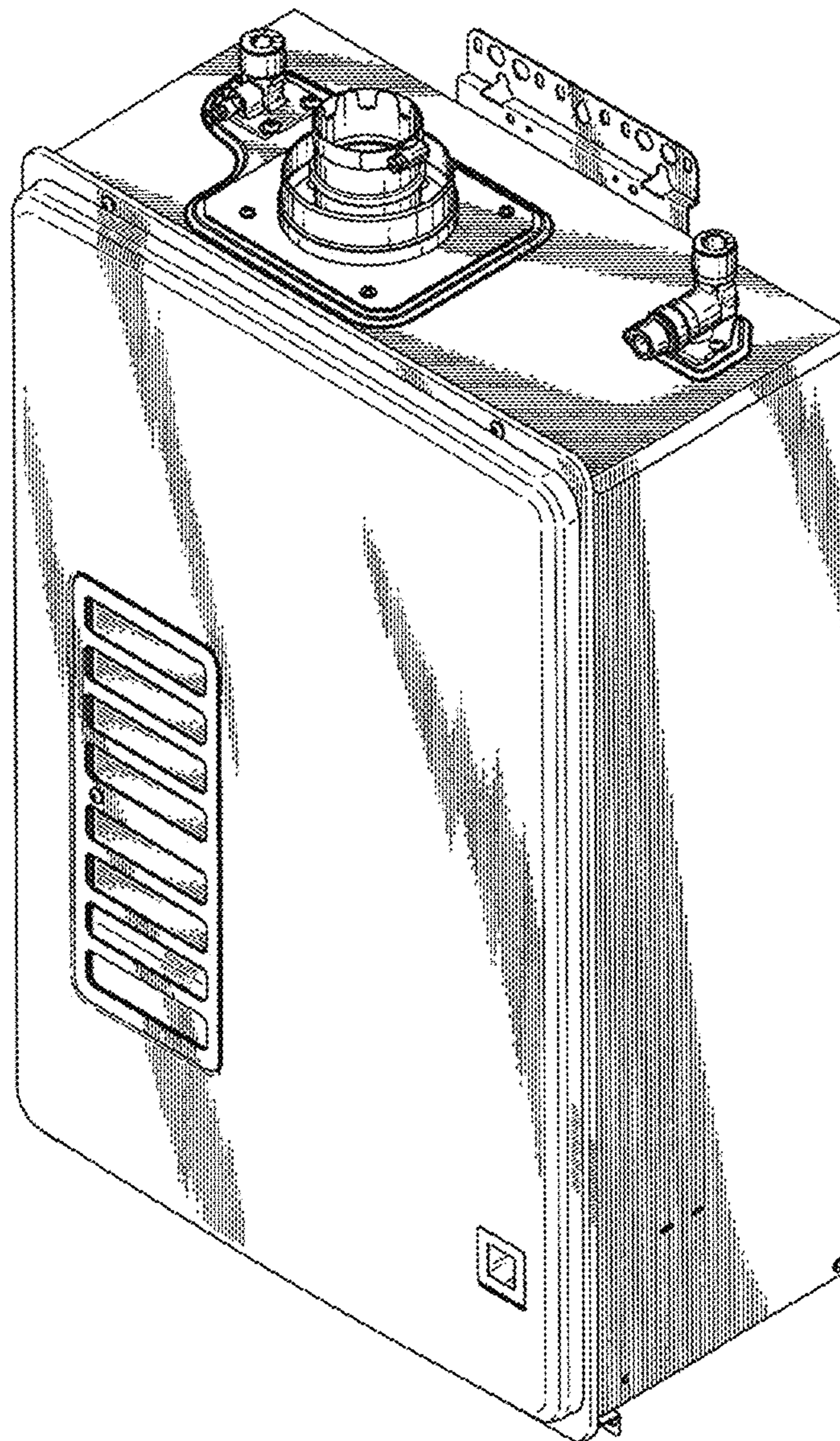

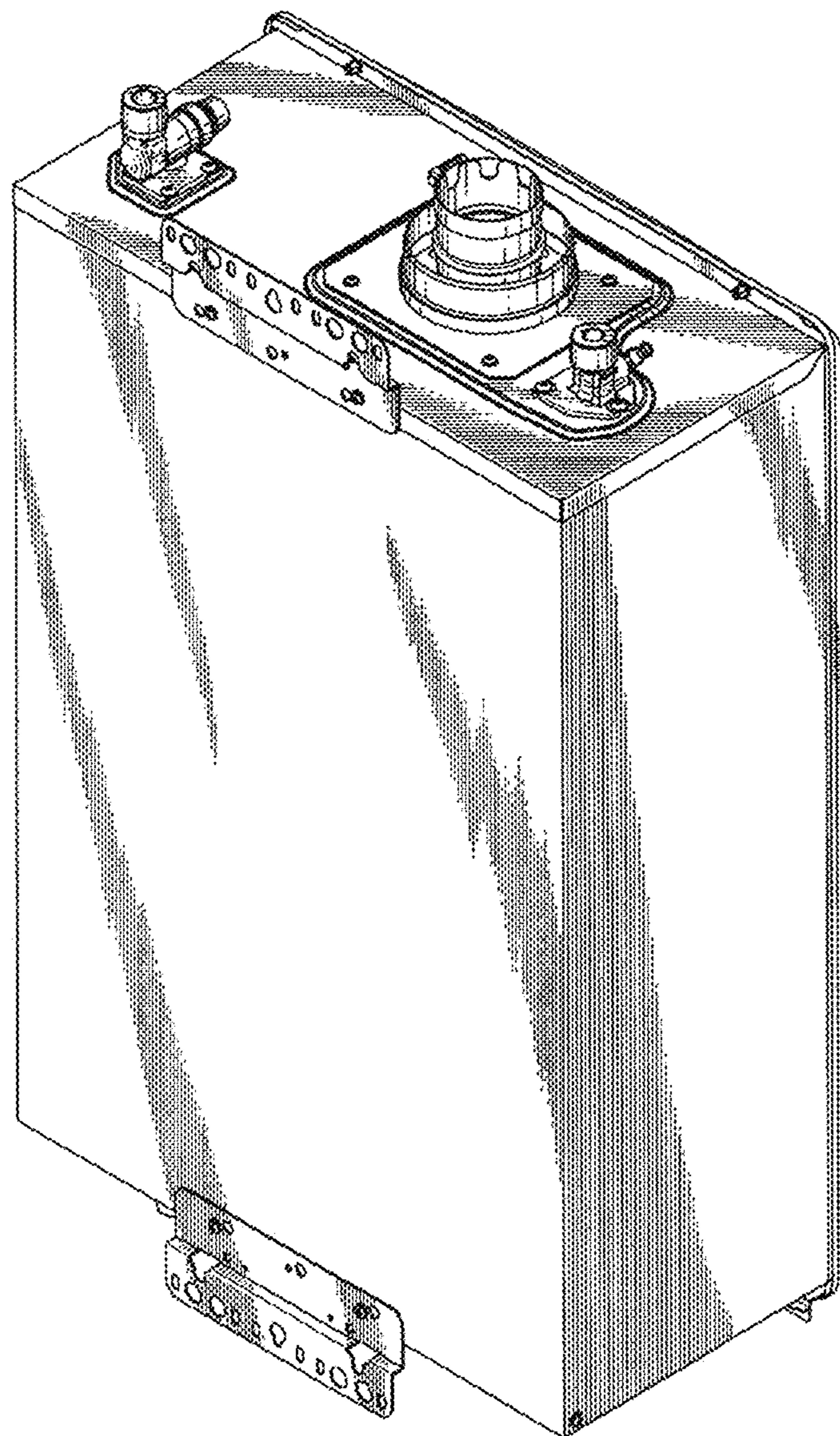

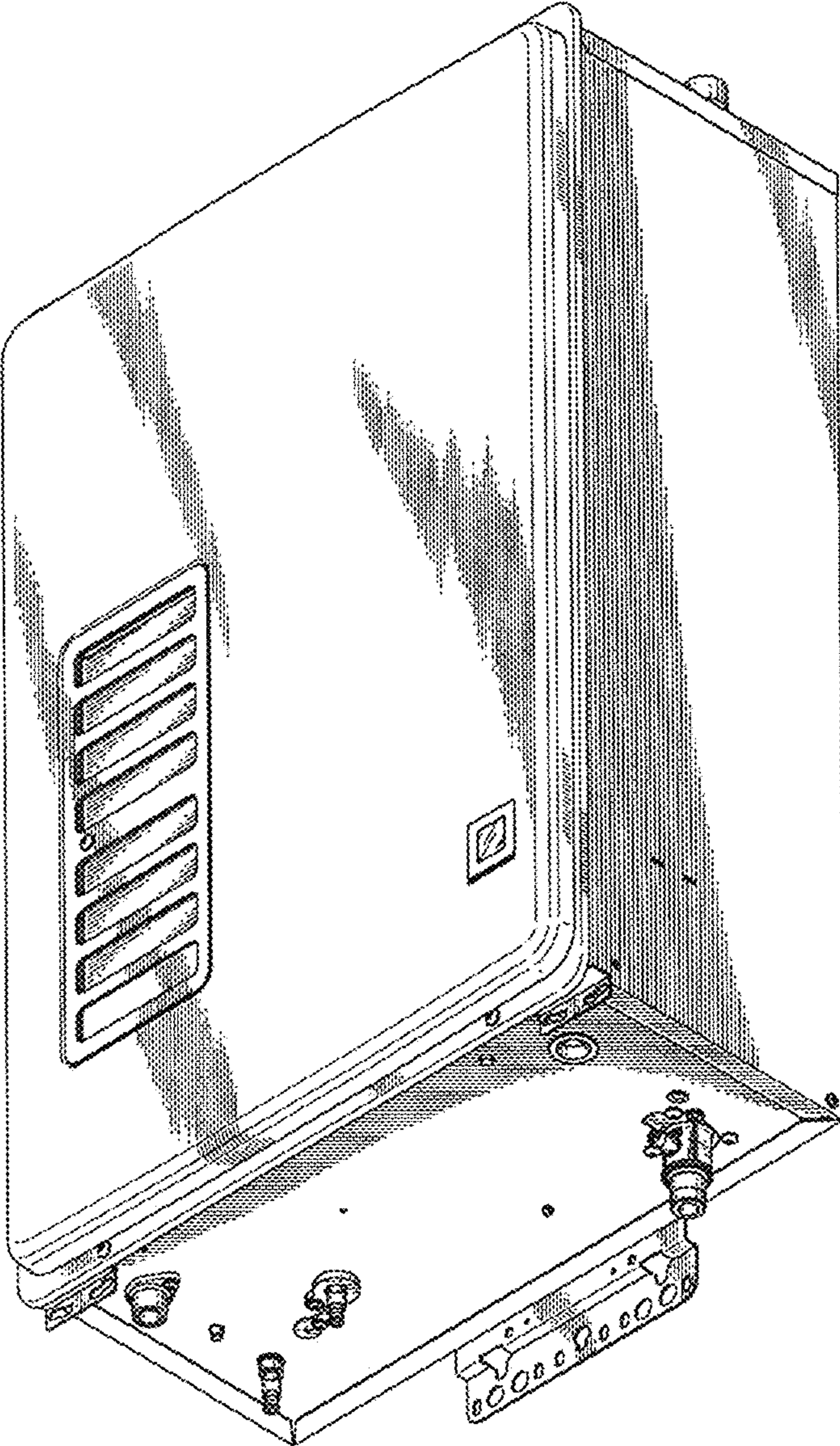

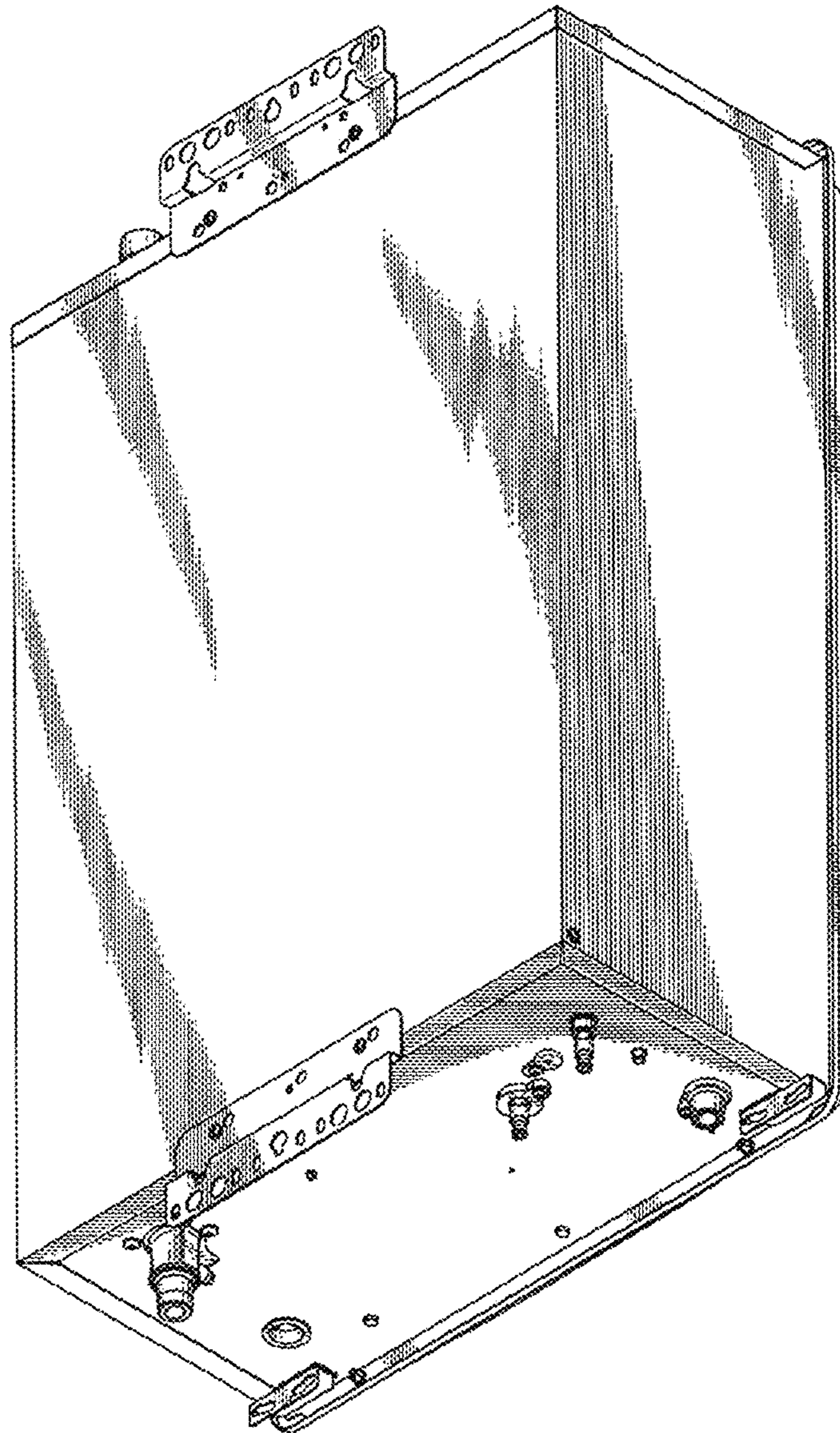

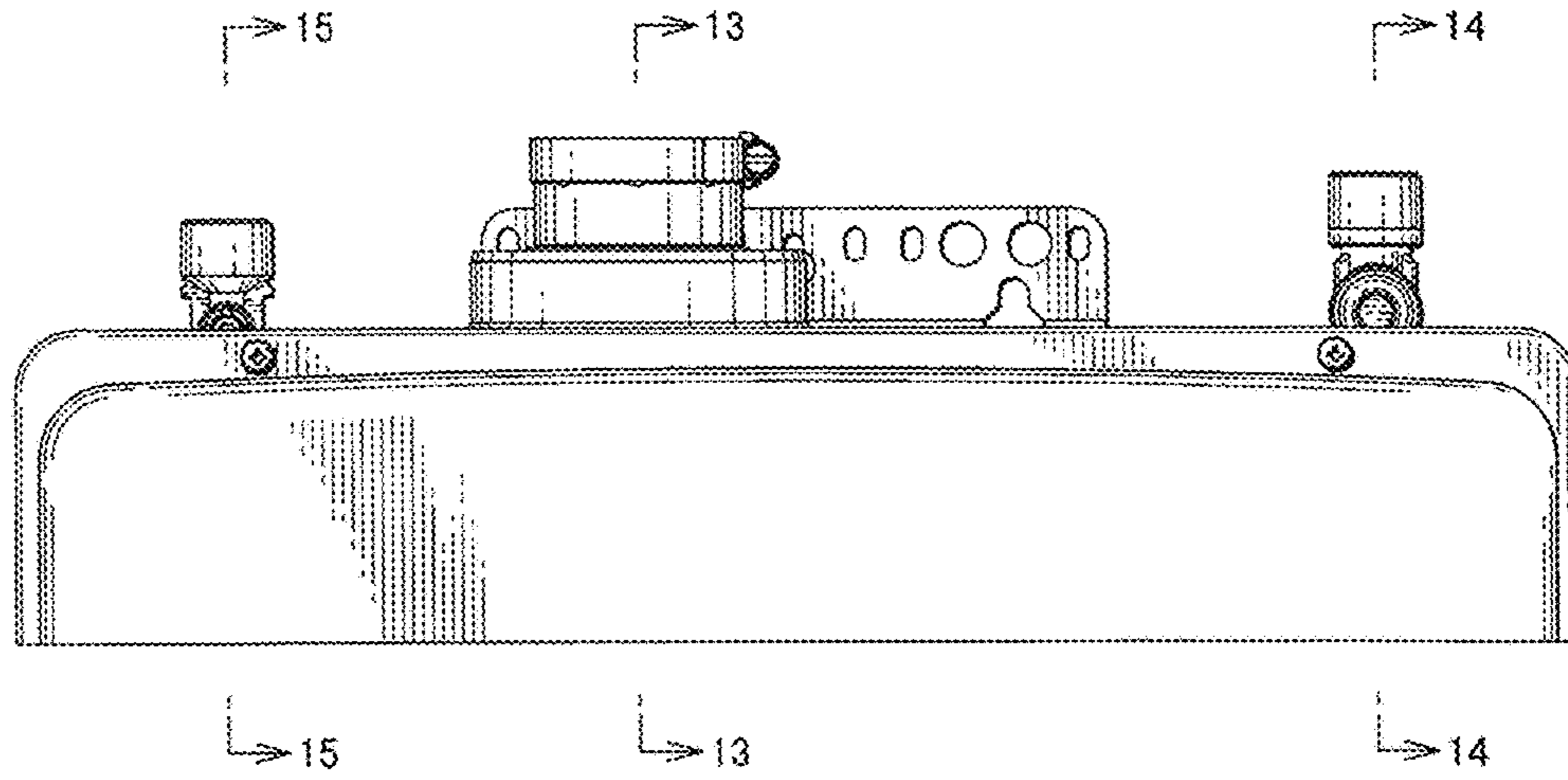

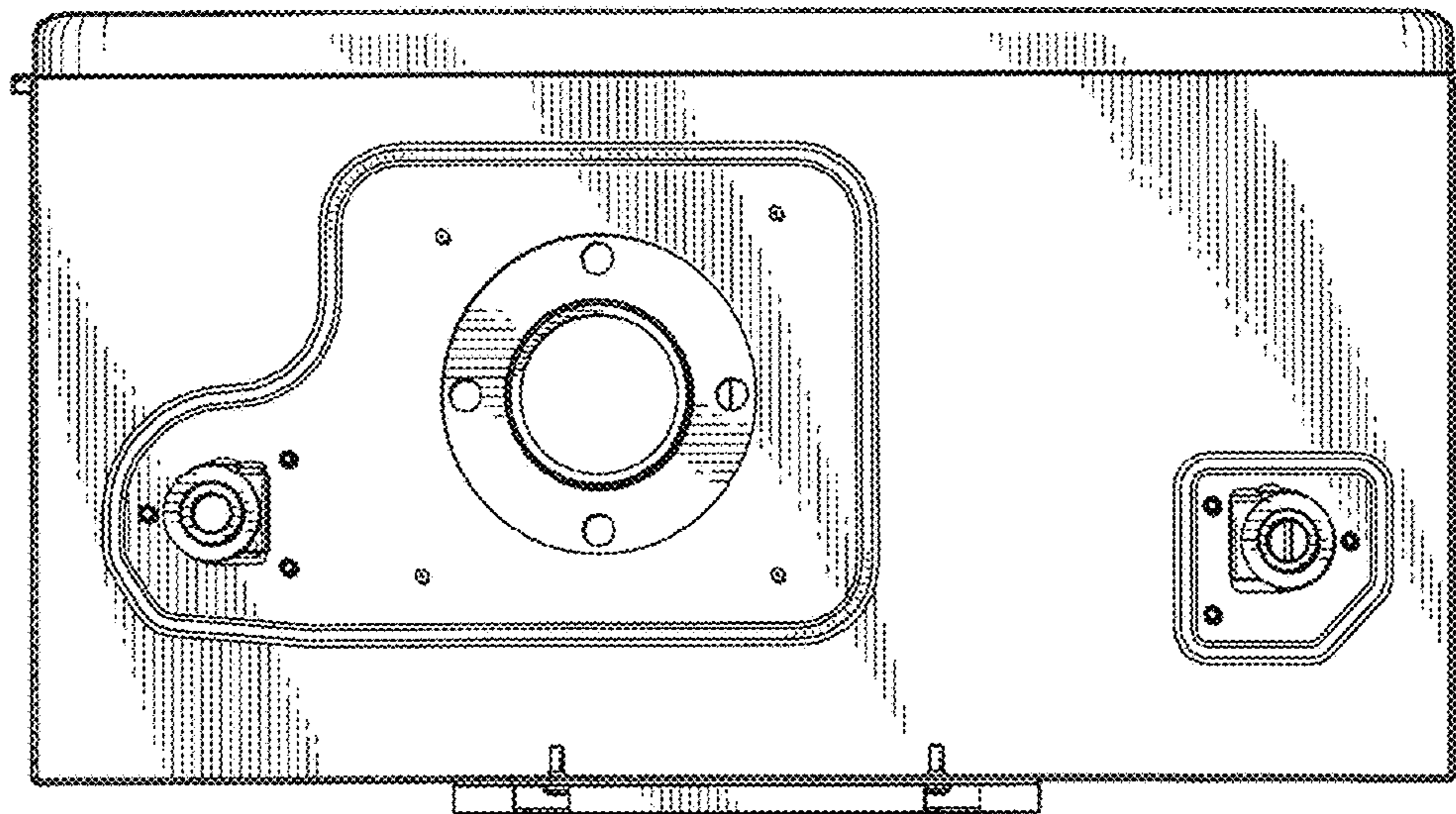

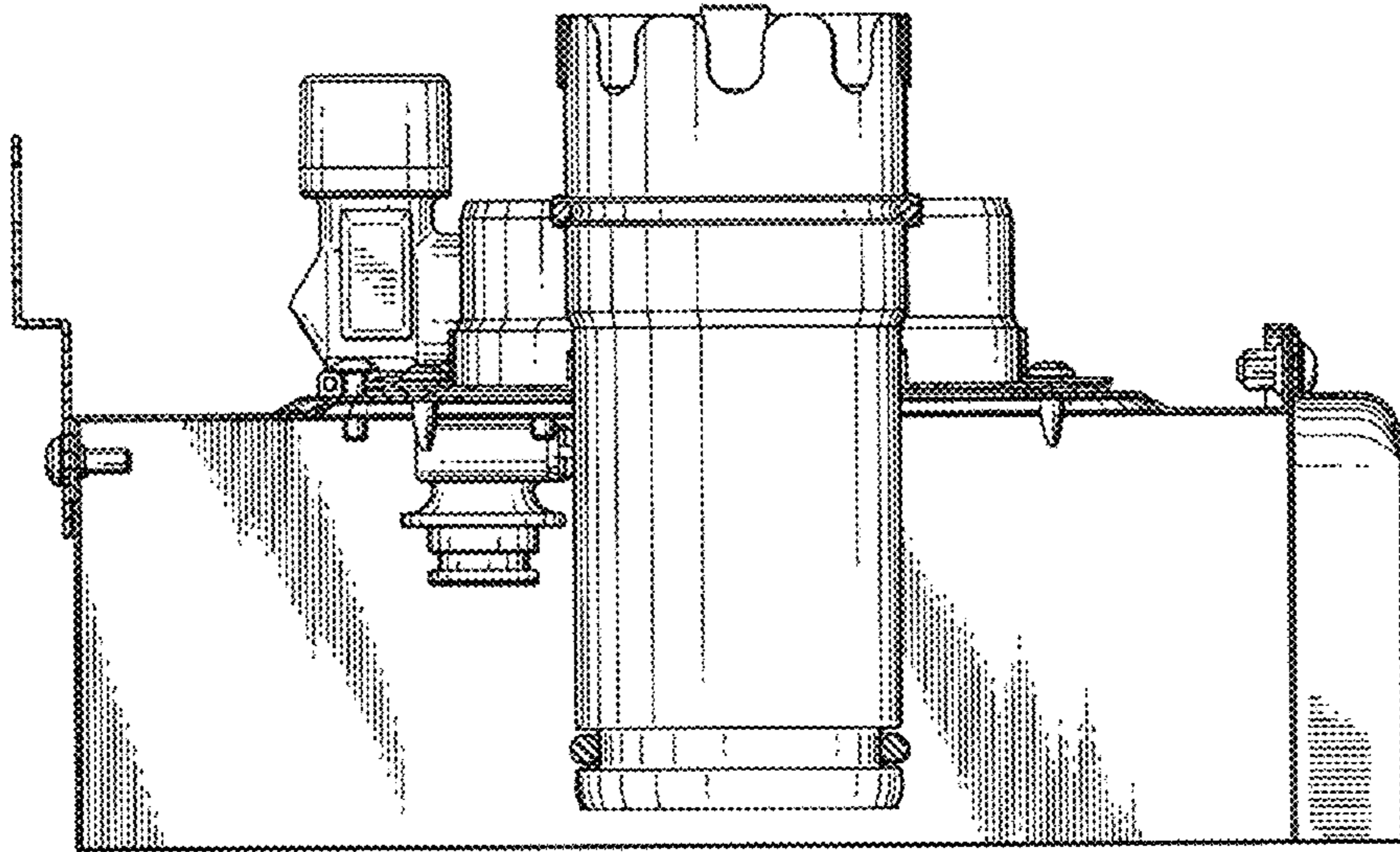

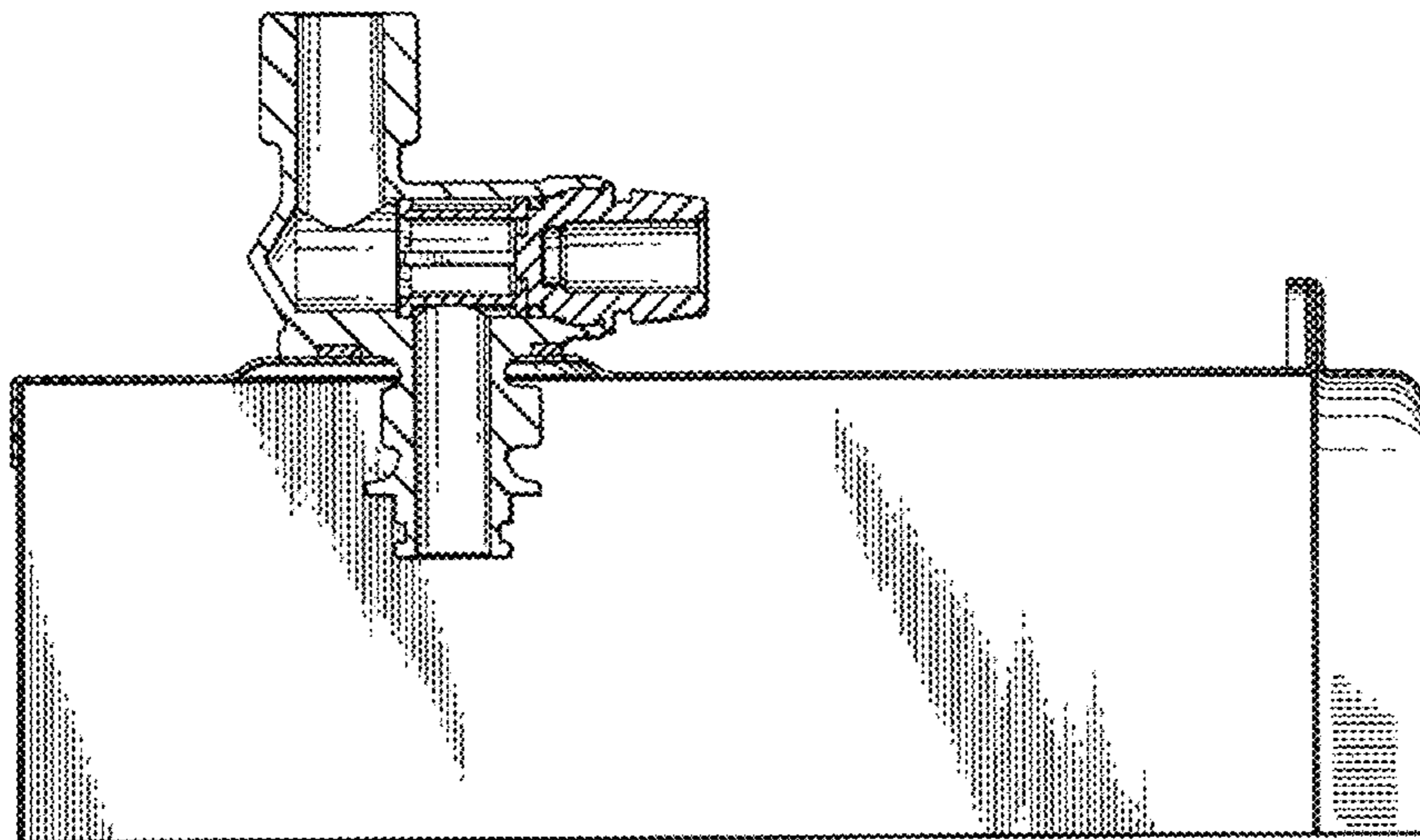
