(57) **CLAIM**

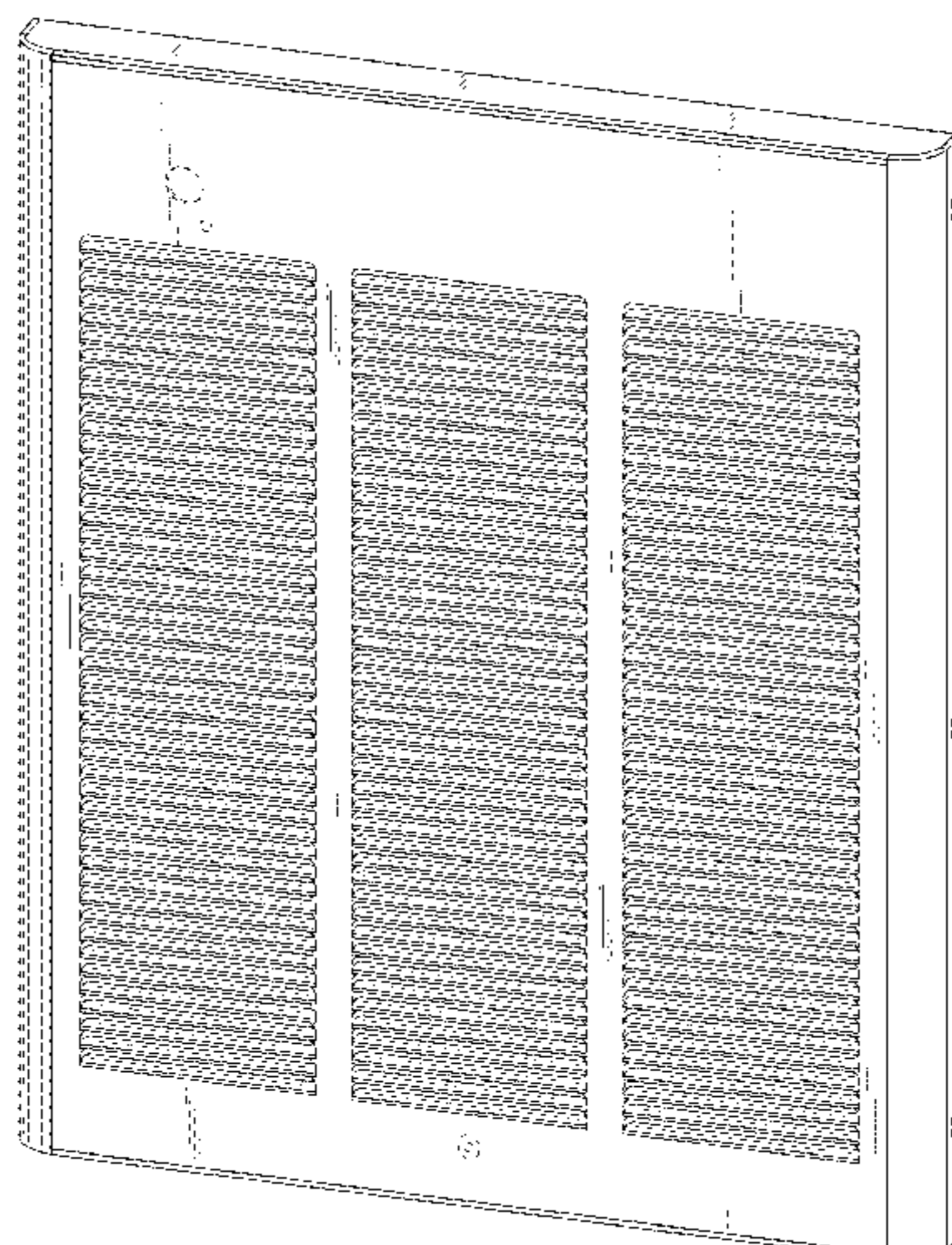
The ornamental design for a grille, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a grille showing a first embodiment of our new design;
FIG. 2 is a front view of the design shown in FIG. 1;
FIG. 3 is a rear view of the design shown in FIG. 1;
FIG. 4 is a left side view of the design shown in FIG. 1;
FIG. 5 is a right side view of the design shown in FIG. 1;
FIG. 6 is a top view of the design shown in FIG. 1;
FIG. 7 is a bottom view of the design shown in FIG. 1;
FIG. 8 is a cross-section view taken along the line 8-8 in FIG. 2.
FIG. 9 is a perspective view of a grille according to a second embodiment of our new design;
FIG. 10 is a front view of the design shown in FIG. 9;
FIG. 11 is a rear view of the design shown in FIG. 8;
FIG. 12 is a left side view of the design shown in FIG. 8;
FIG. 13 is a right side view of the design shown in FIG. 8;
FIG. 14 is a top view of the design shown in FIG. 8;
FIG. 15 is a bottom view of the design shown in FIG. 8; and
FIG. 16 is a cross-section view taken along the line 16-16 in FIG. 10.

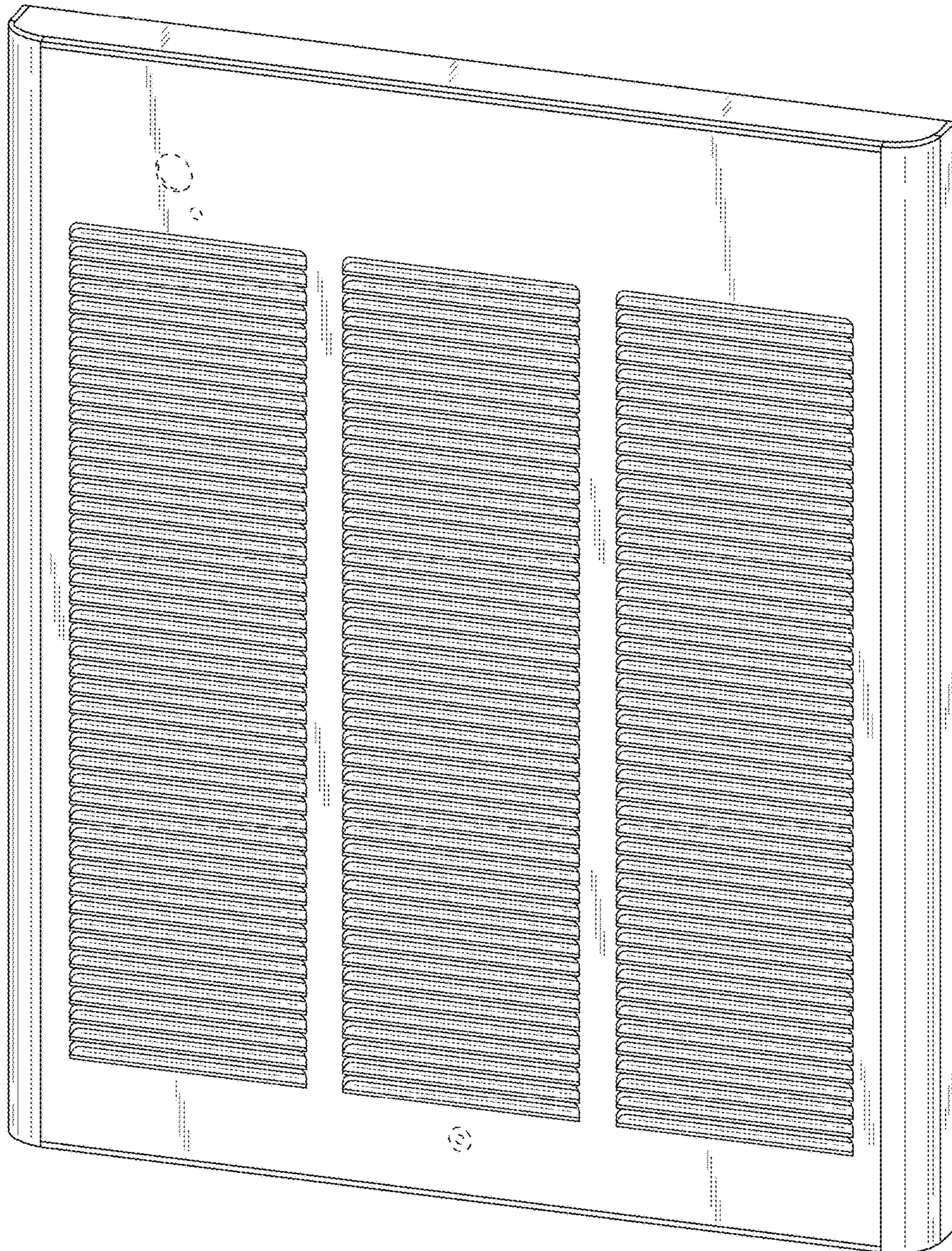

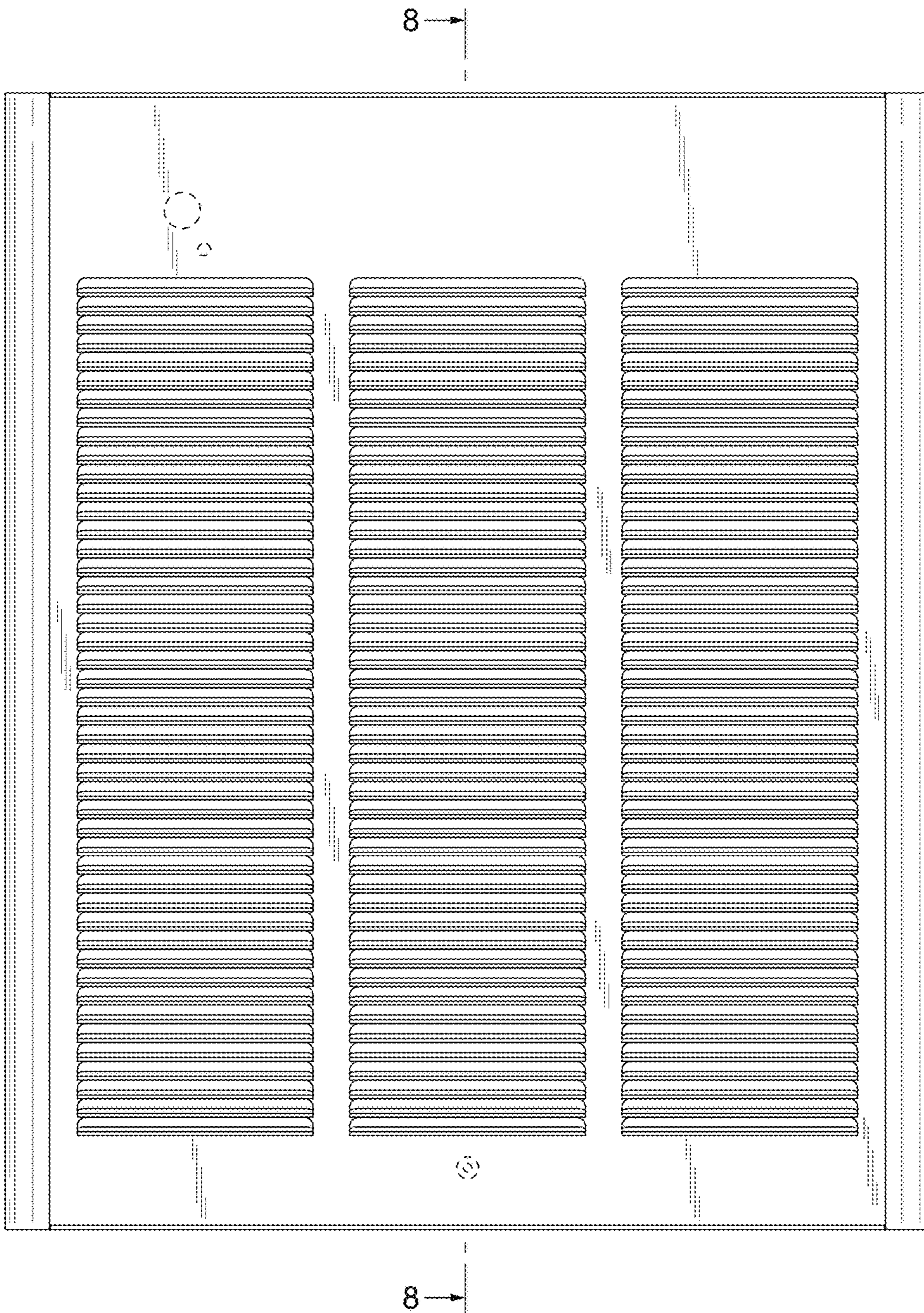

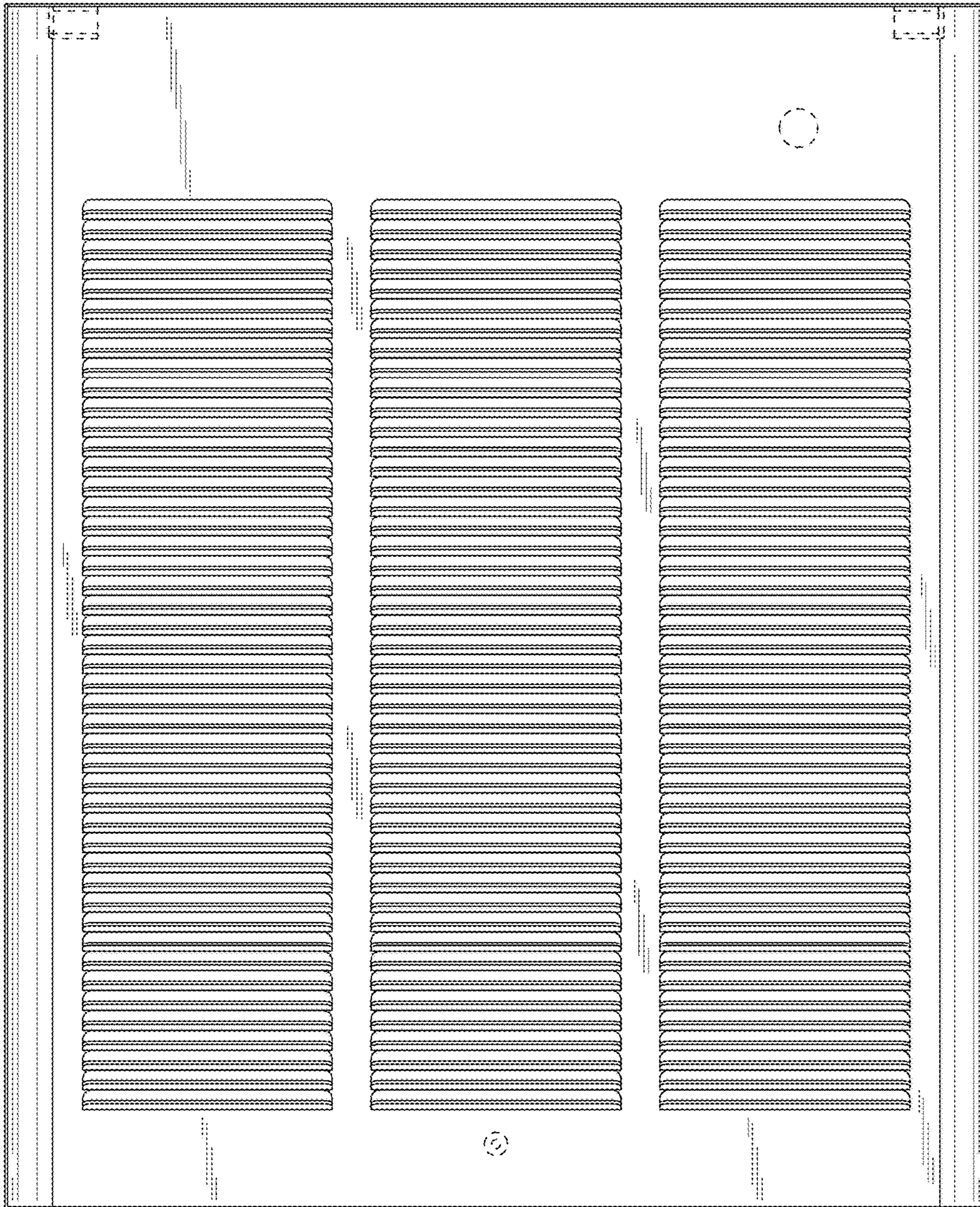

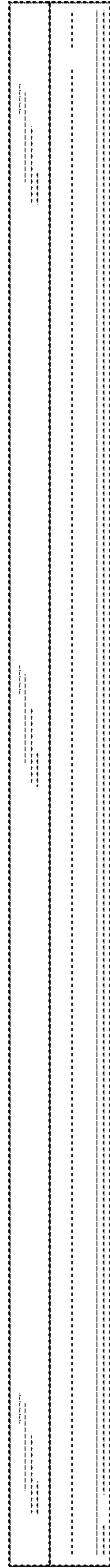

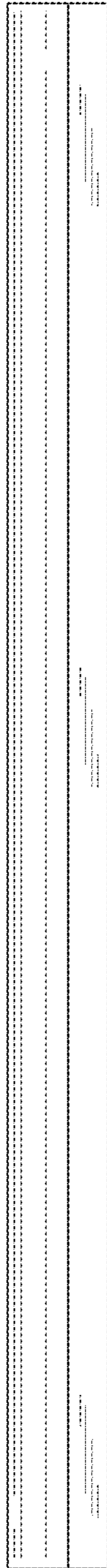

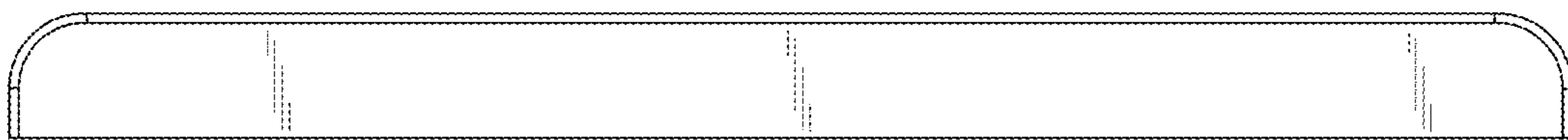

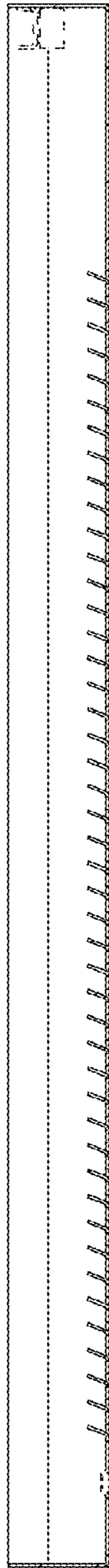

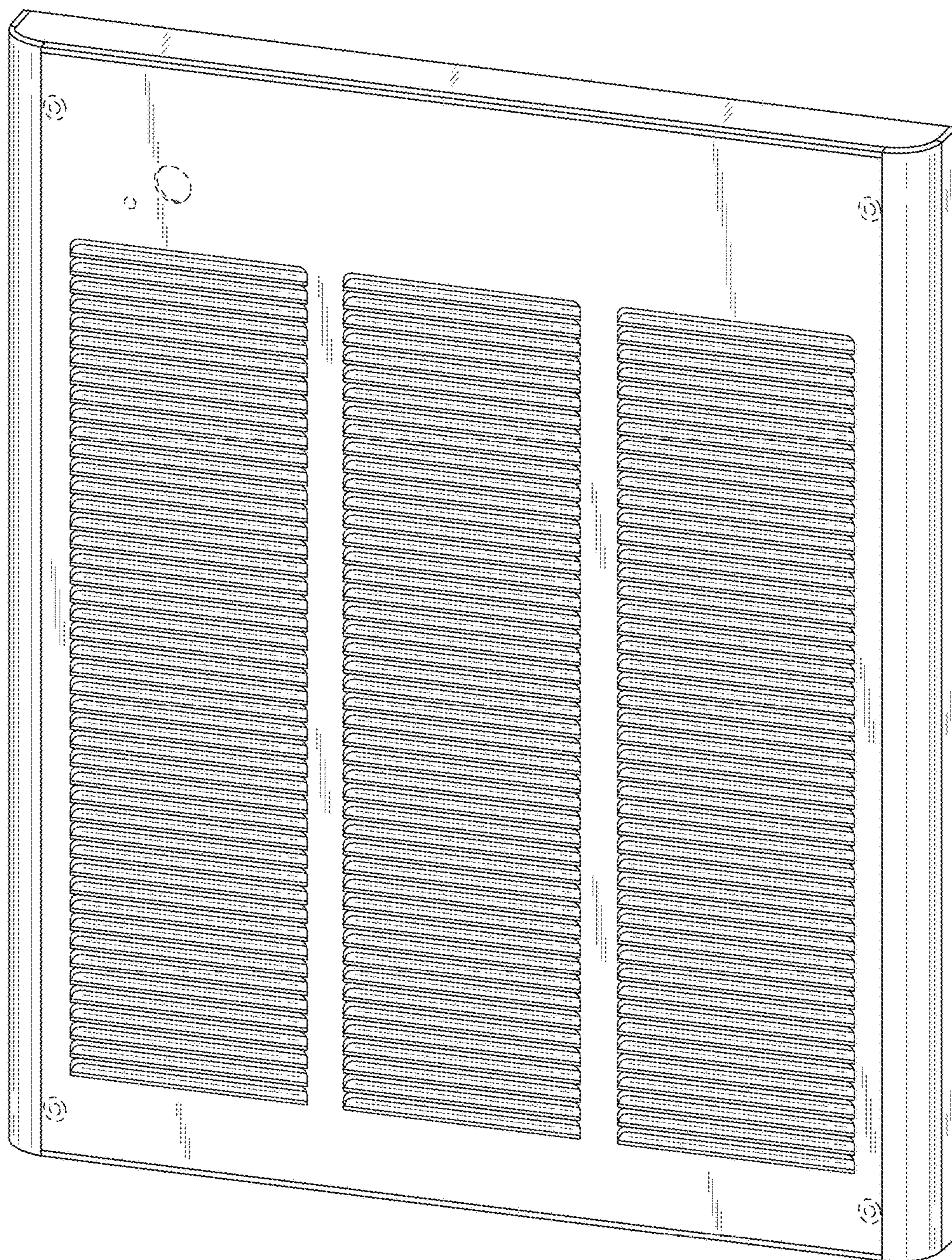

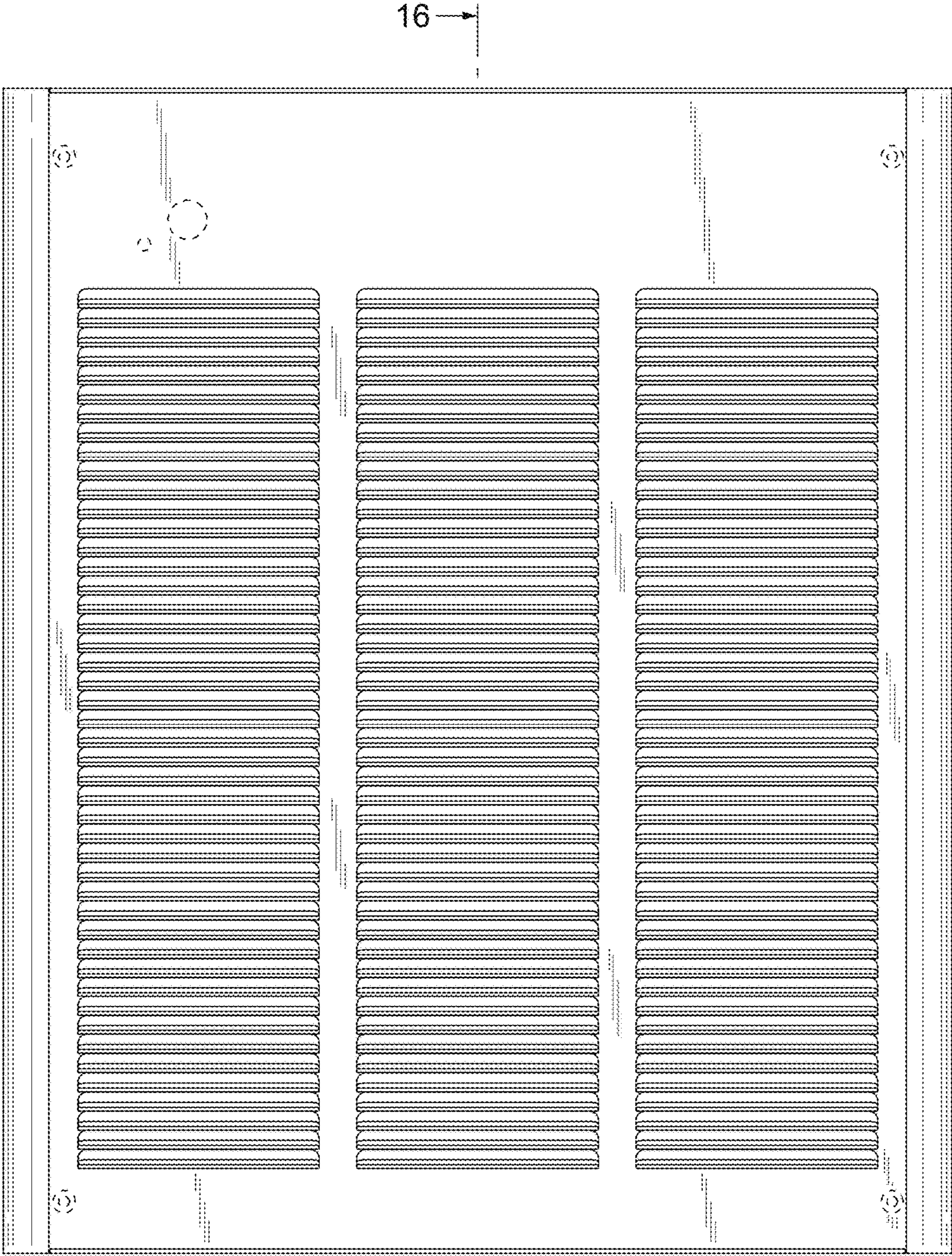

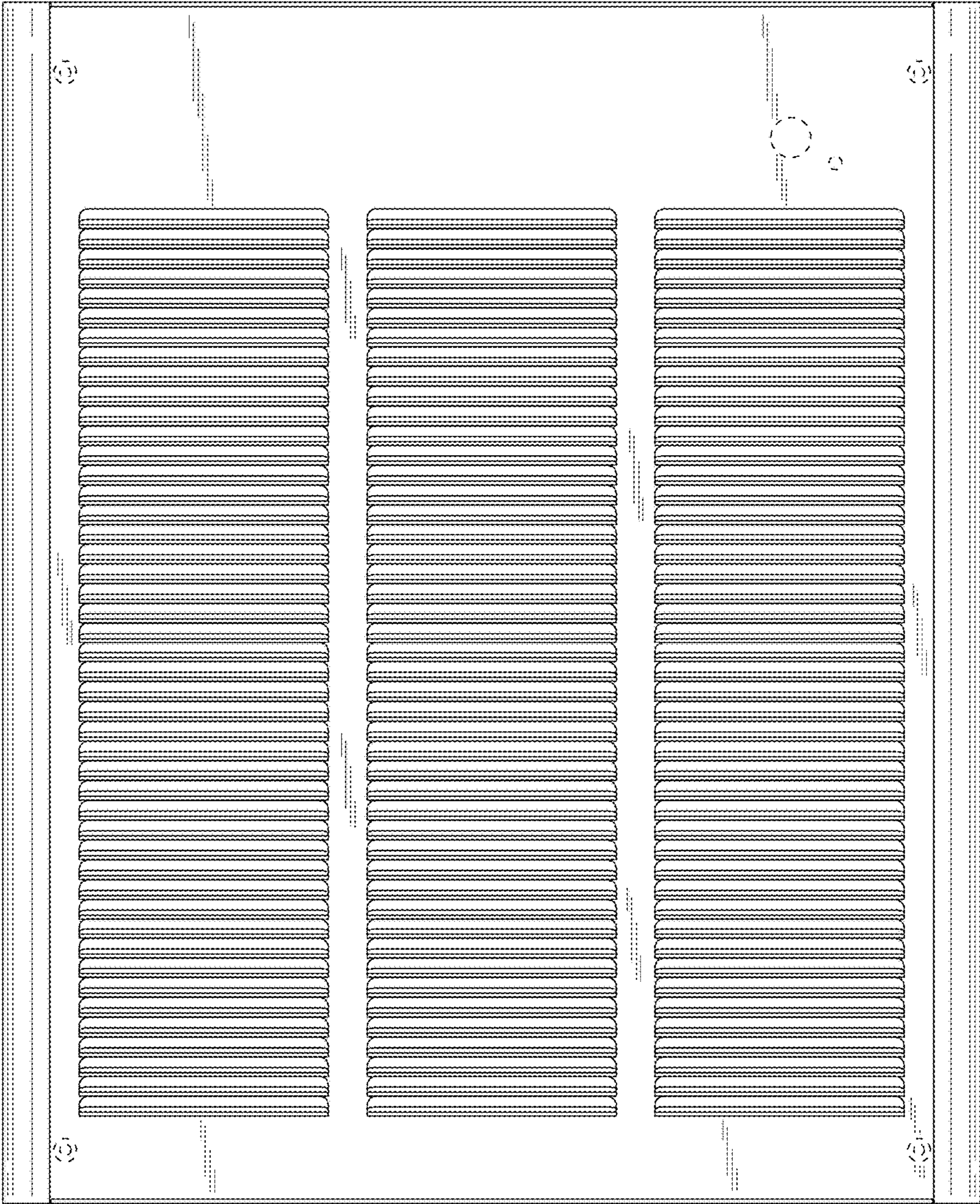

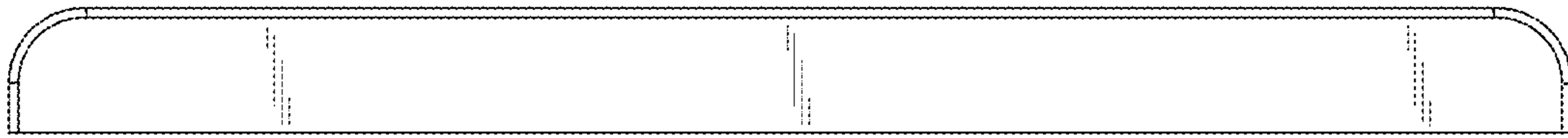

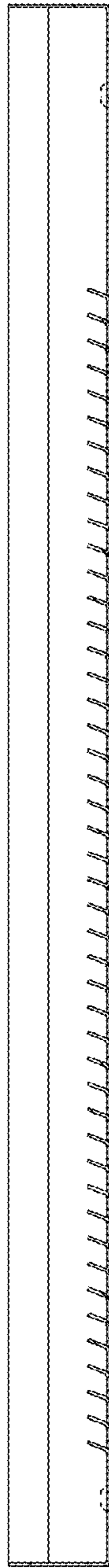
