(57) **CLAIM**

We claim the ornamental design for a catamenial tampon, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a catamenial tampon showing our new design; FIG. 2 is a top plan view of the embodiment of FIG. 1; FIG. 3 is a front view of the embodiment of FIG. 1; FIG. 4 is a perspective view of a second embodiment of a catamenial tampon; FIG. 5 is a top plan view of the embodiment of FIG. 4; and, FIG. 6 is a front view of the embodiment of FIG. 4. The broken lines show unclaimed subject matter only and form no part of the claimed design. All sides not shown in the application form no part of the claimed design.

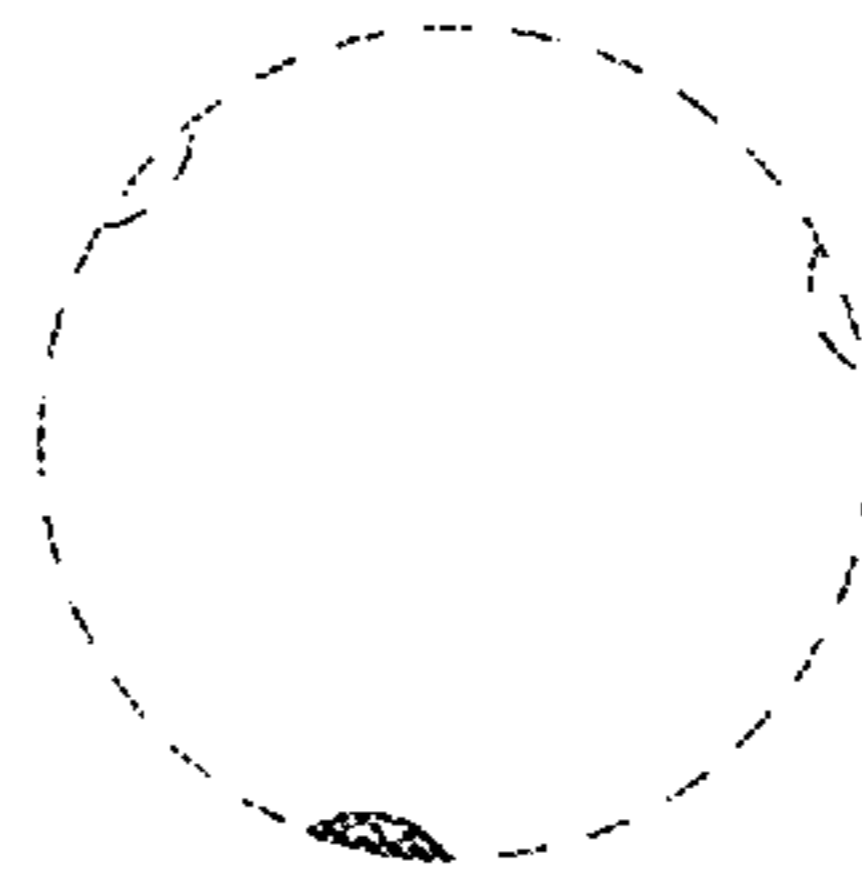

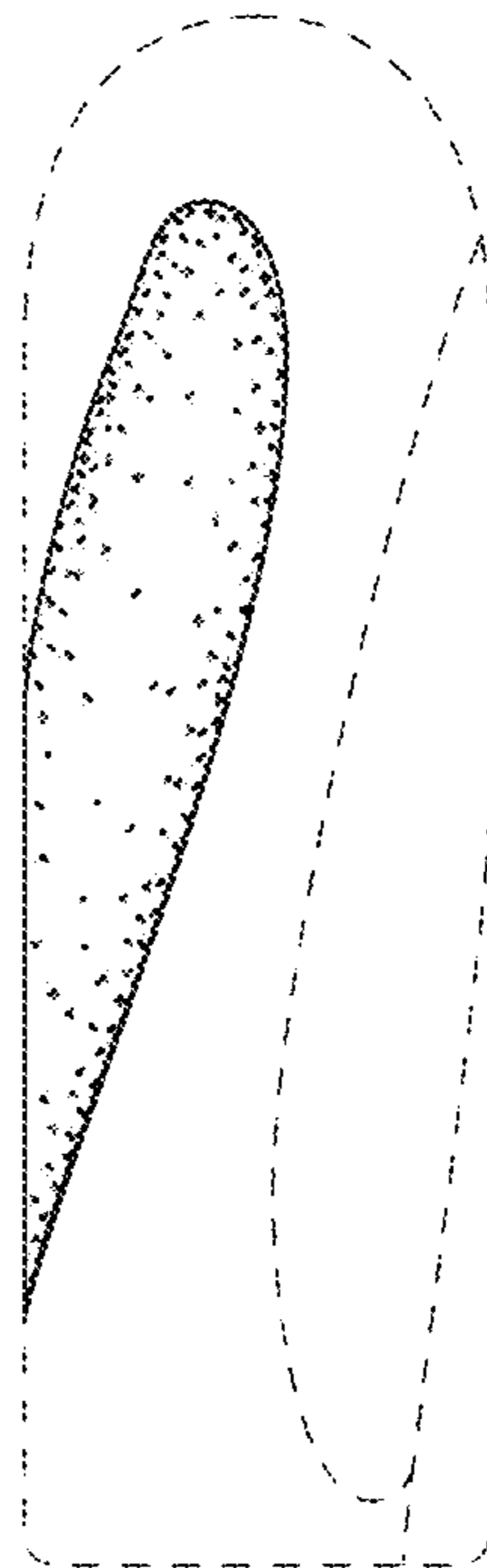

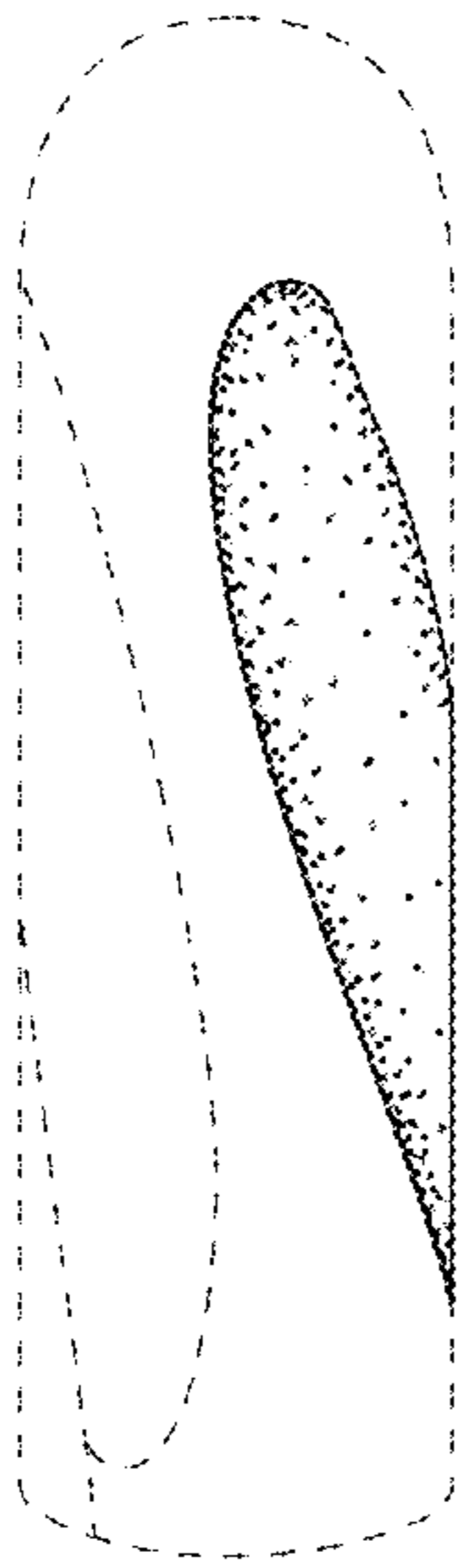

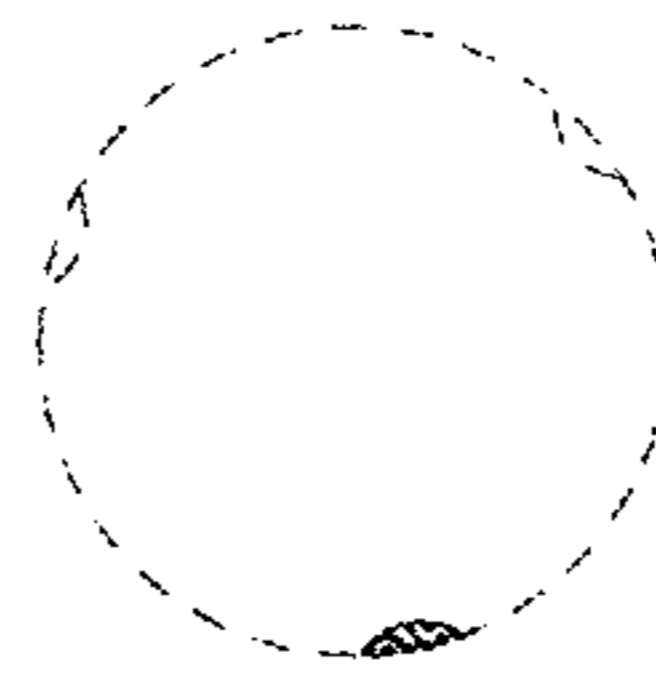
