The ornamental design for a surgical fastener, as shown and described.

DESCRIPTION

The present patent application is related to commonly assigned U.S. patent application Ser. No. 15/372,241, filed Dec. 7, 2016, the disclosure of which is hereby incorporated by reference herein.

FIG. 1 is a perspective view of a surgical fastener, showing our new design;

FIG. 2 is a front elevation view of the surgical fastener shown in FIG. 1;

FIG. 3 is a rear elevation view of the surgical fastener shown in FIG. 1;

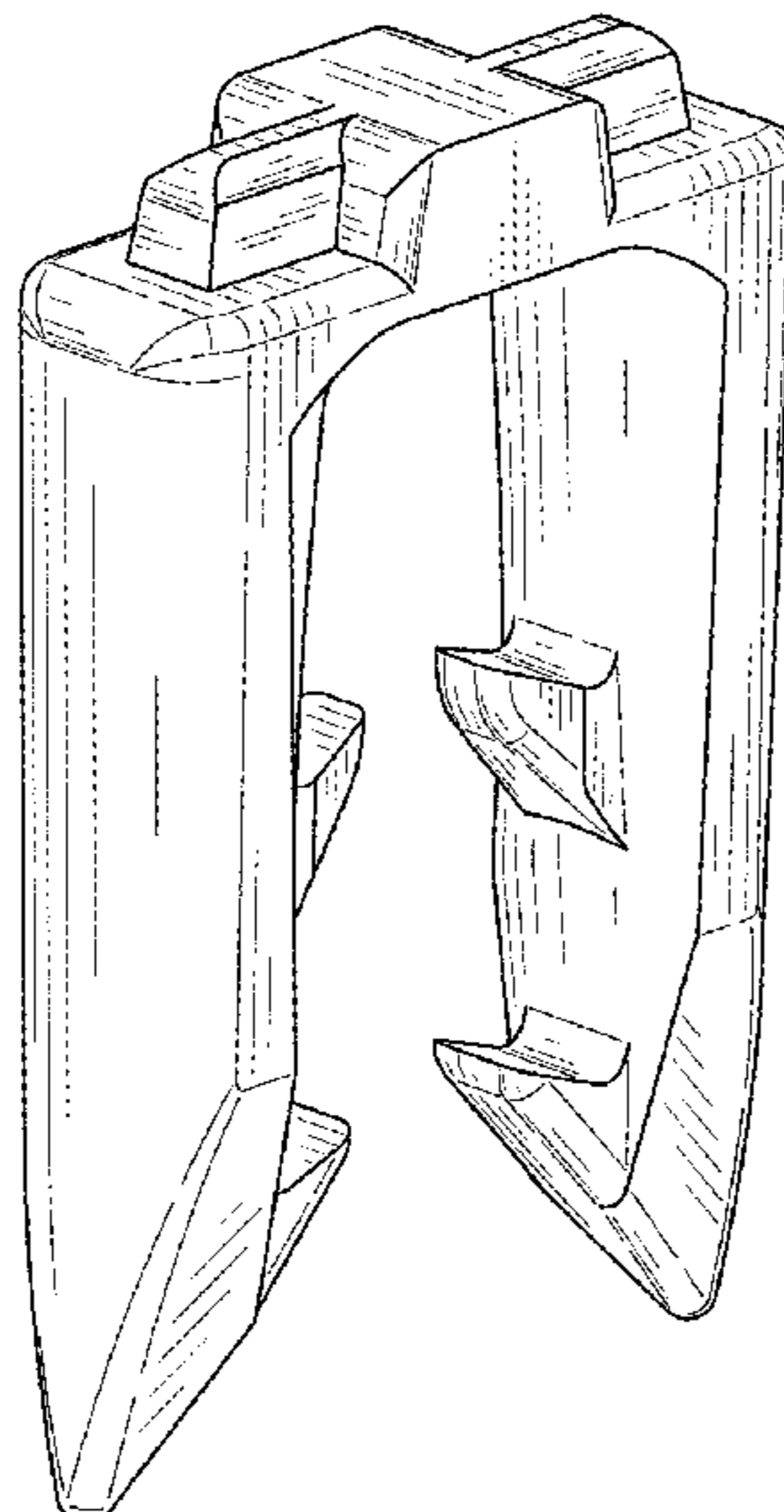
FIG. 4 is a right side view of the surgical fastener shown in FIG. 1;

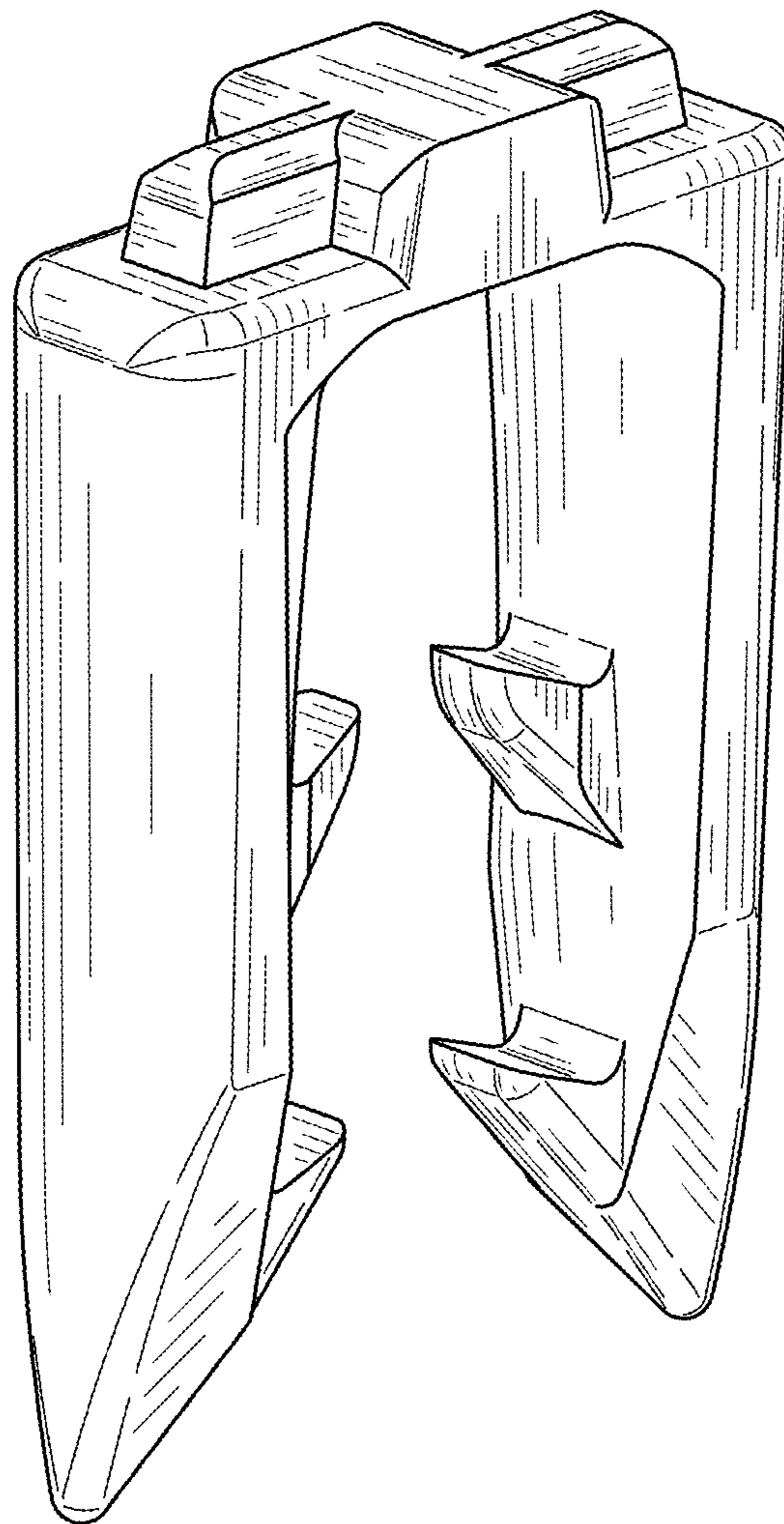

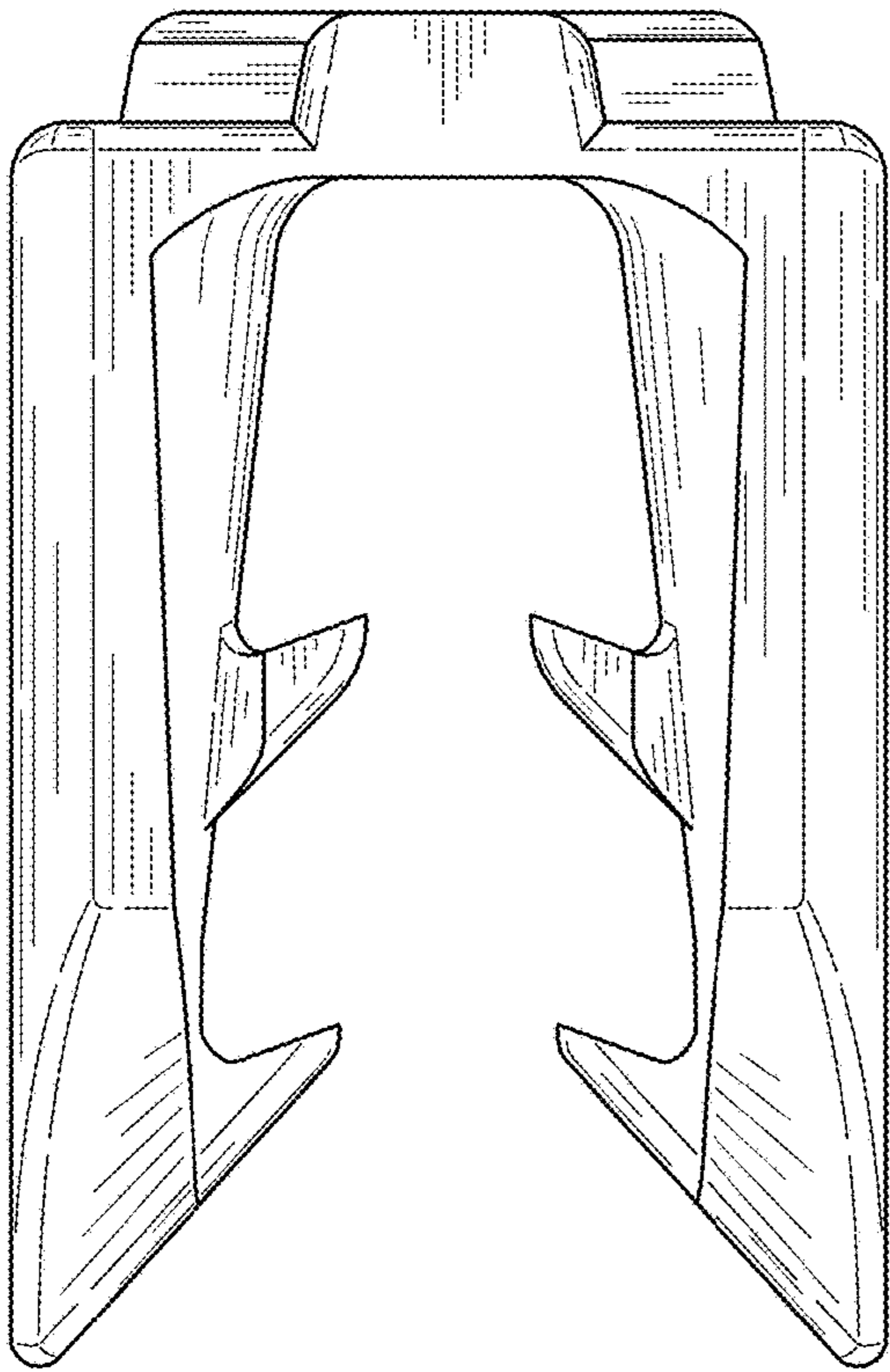

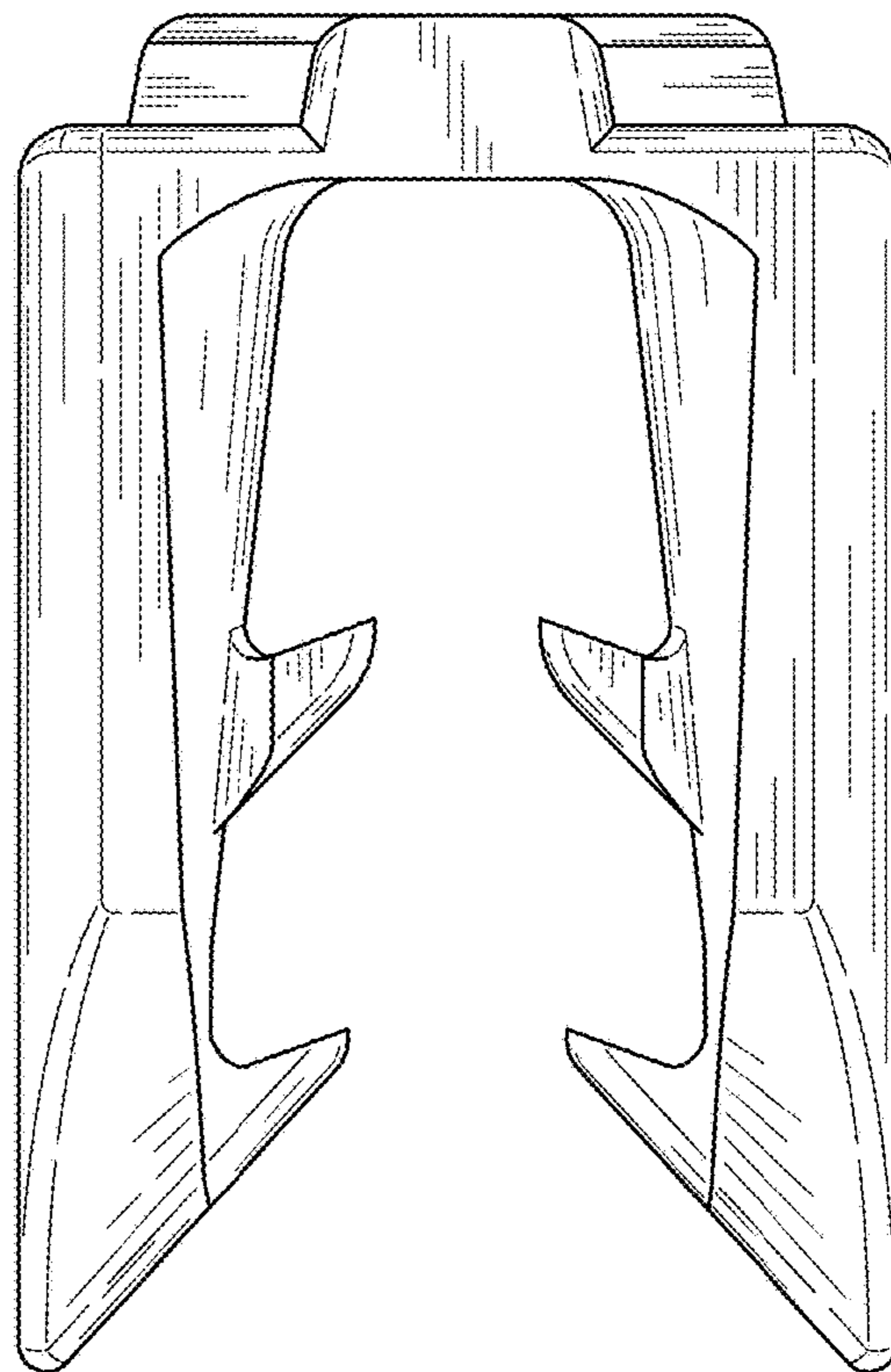

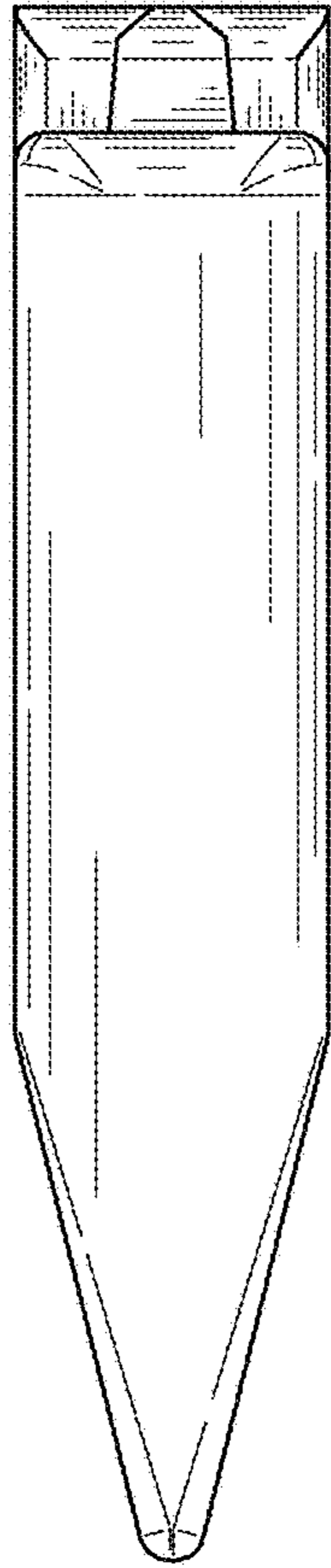

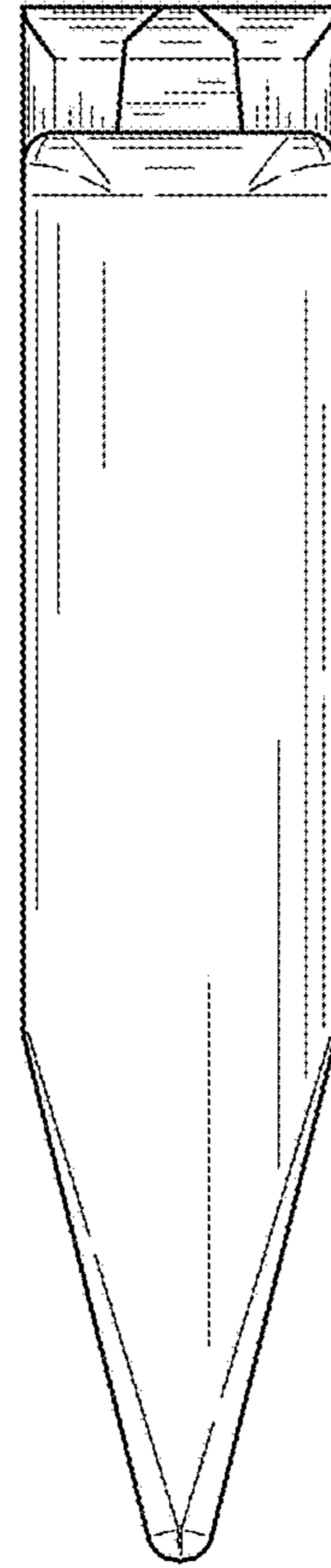

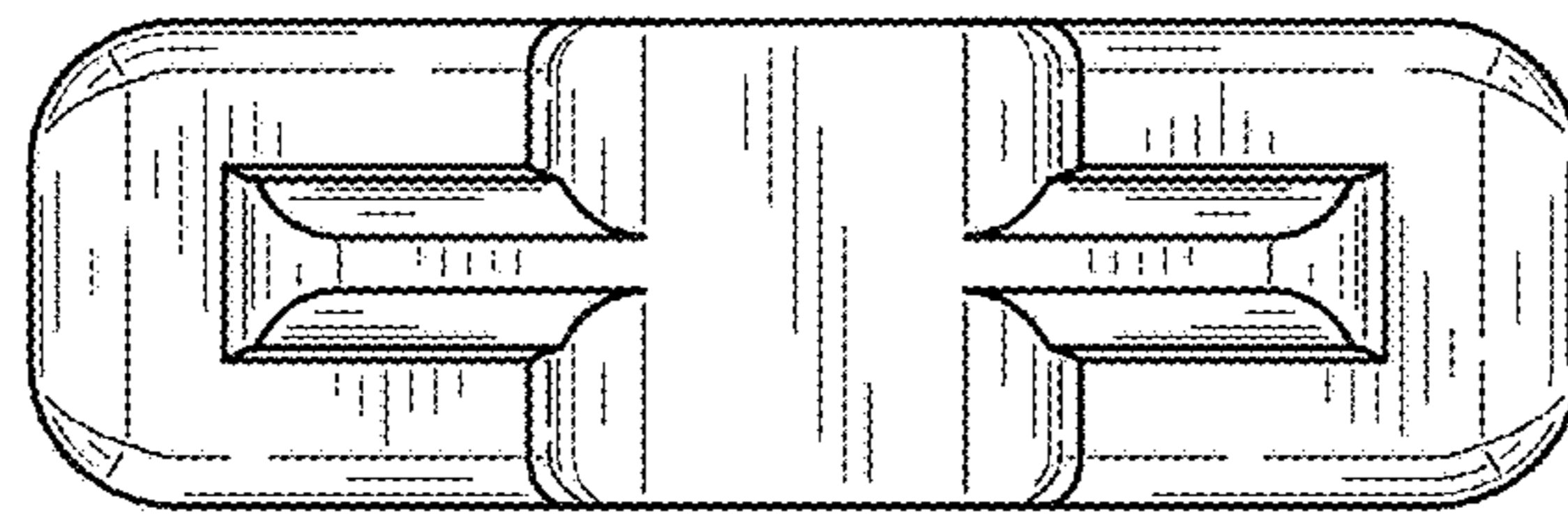

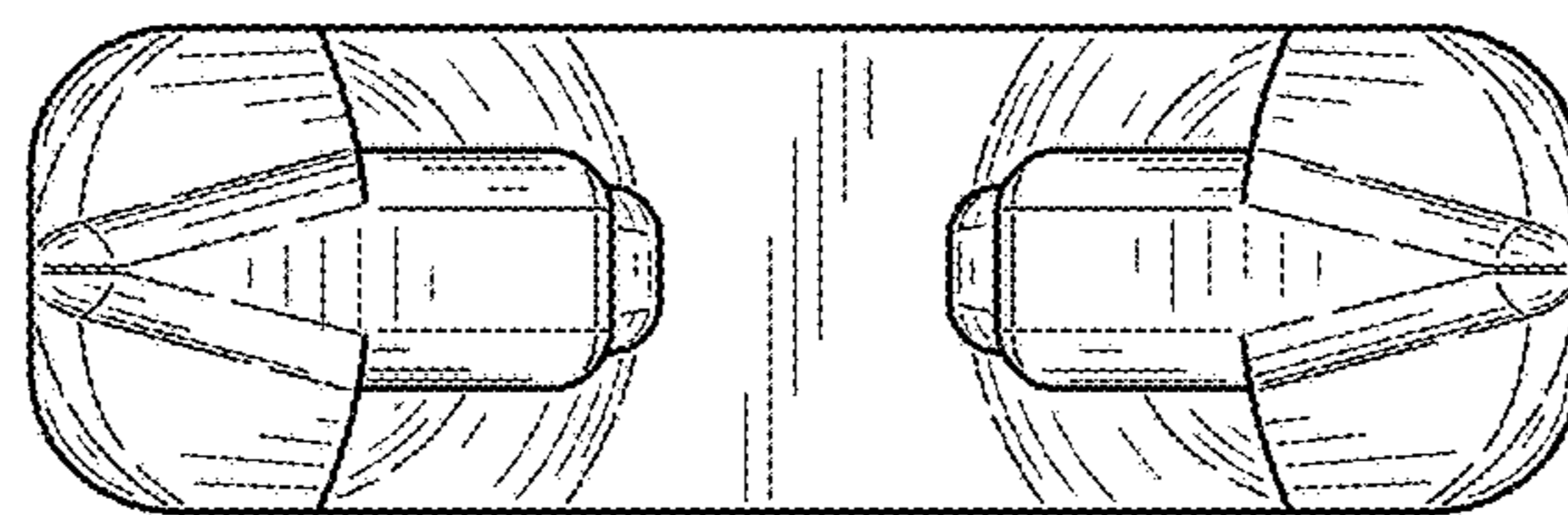
