The ornamental design for an absorbent article with a
pattern, as shown and described.

DESCRIPTION

1 is a perspective view of an absorbent article with a pattern;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The stitching shown in **FIGS. 1-2** and **FIGS. 4-6** that rest on
the surface itself form a lace pattern and form no part of the
claimed design. The surfaces that rest underneath the lace
pattern form a part of the claimed design.

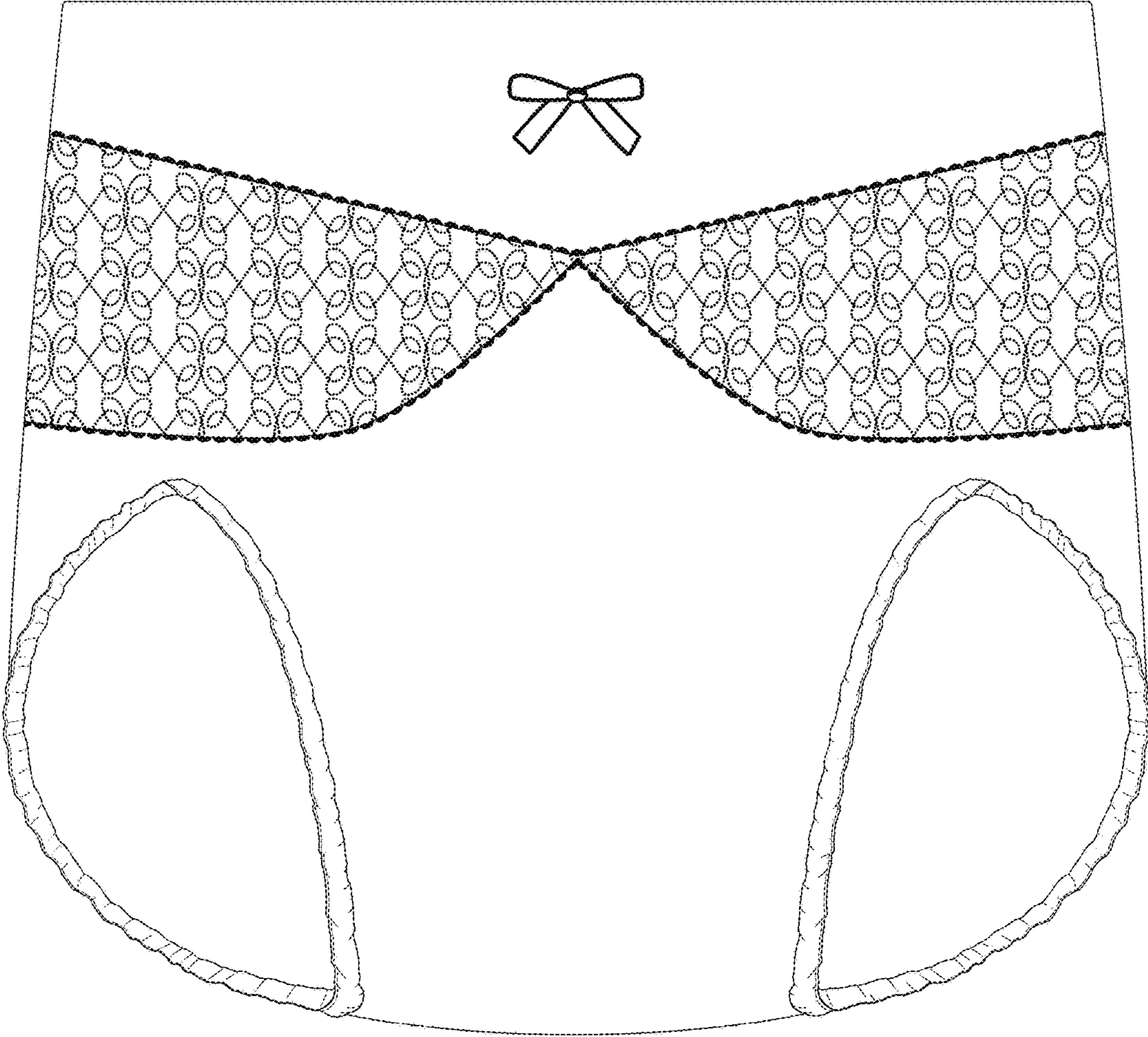

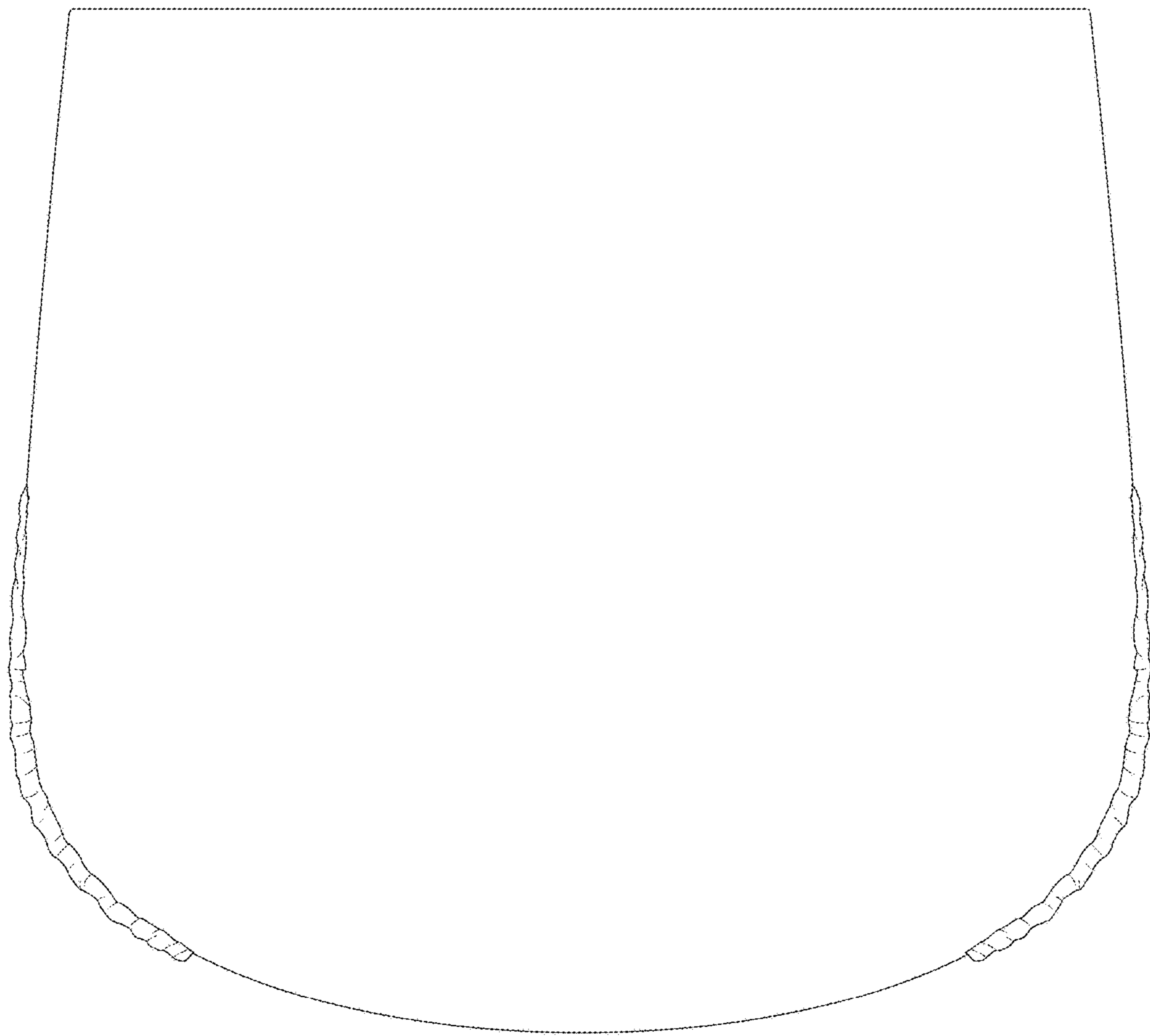

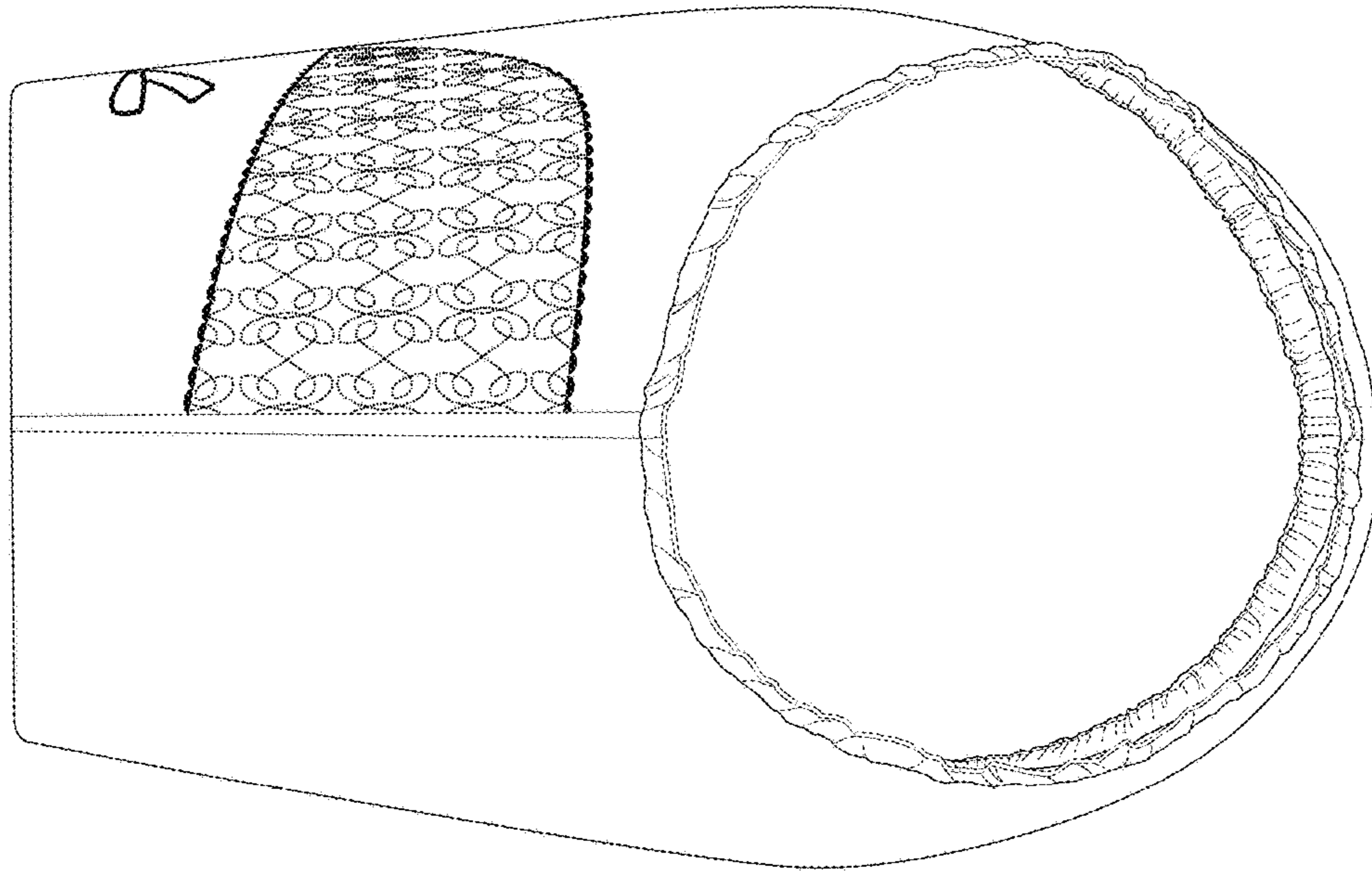

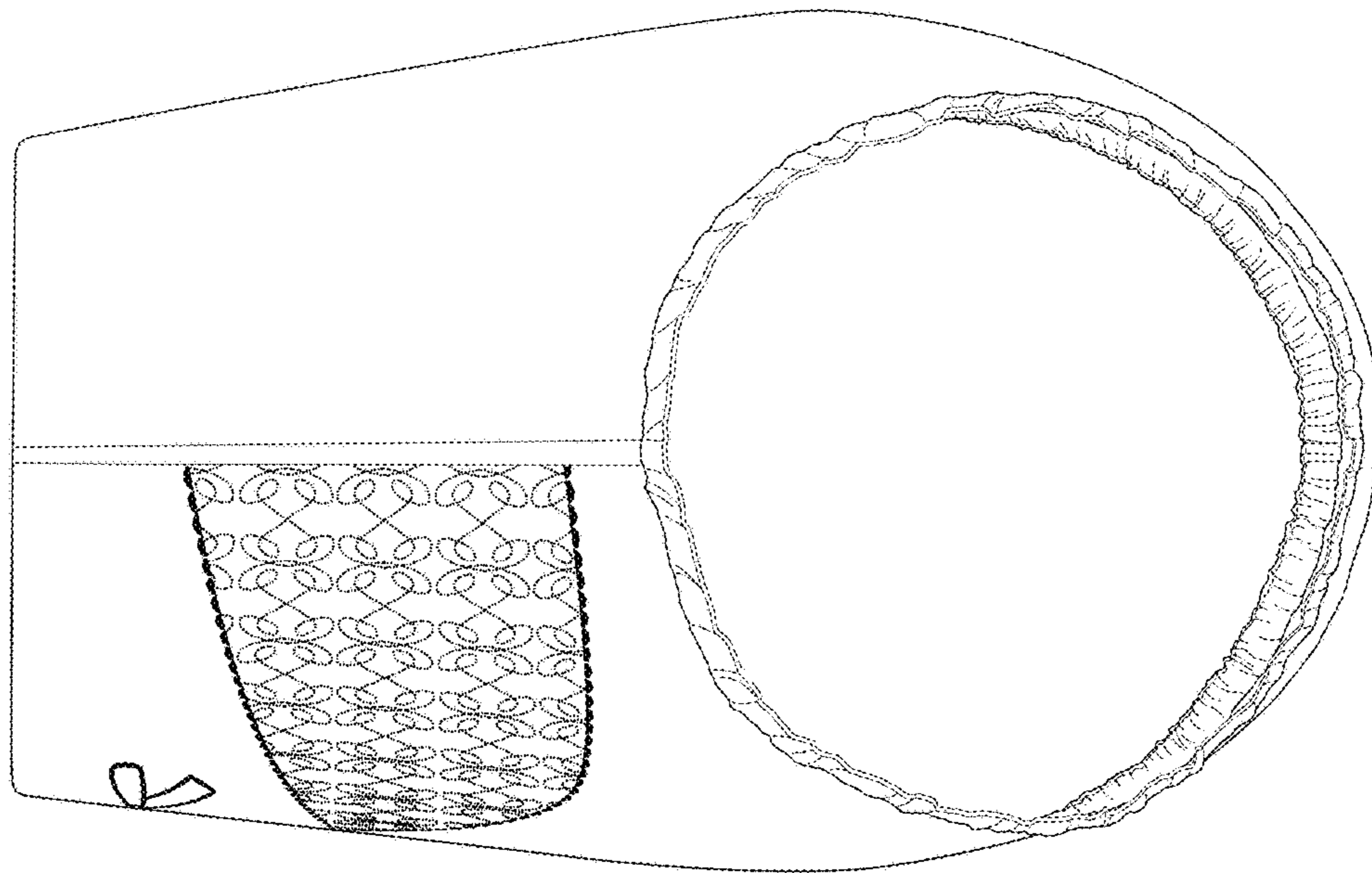

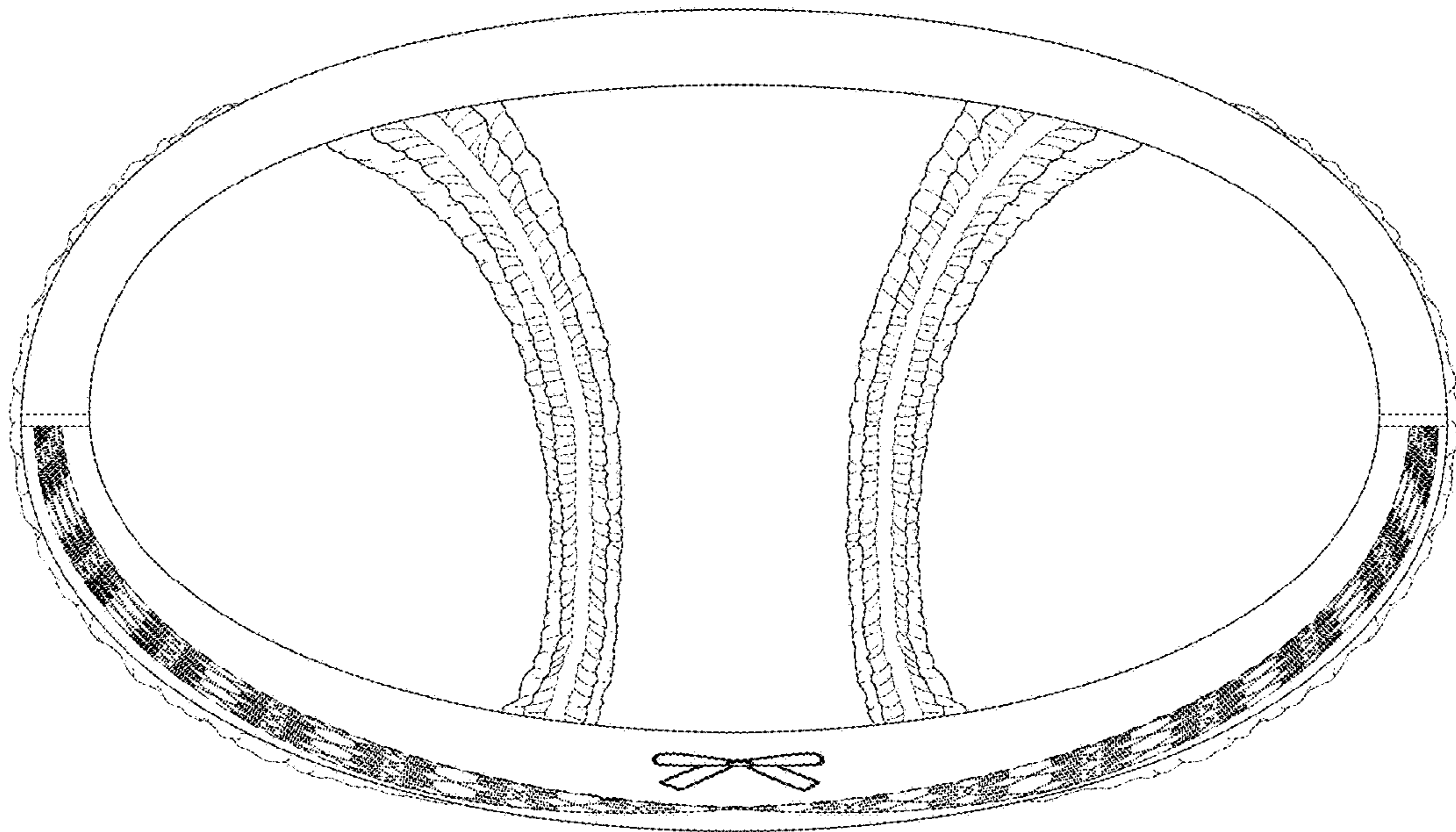

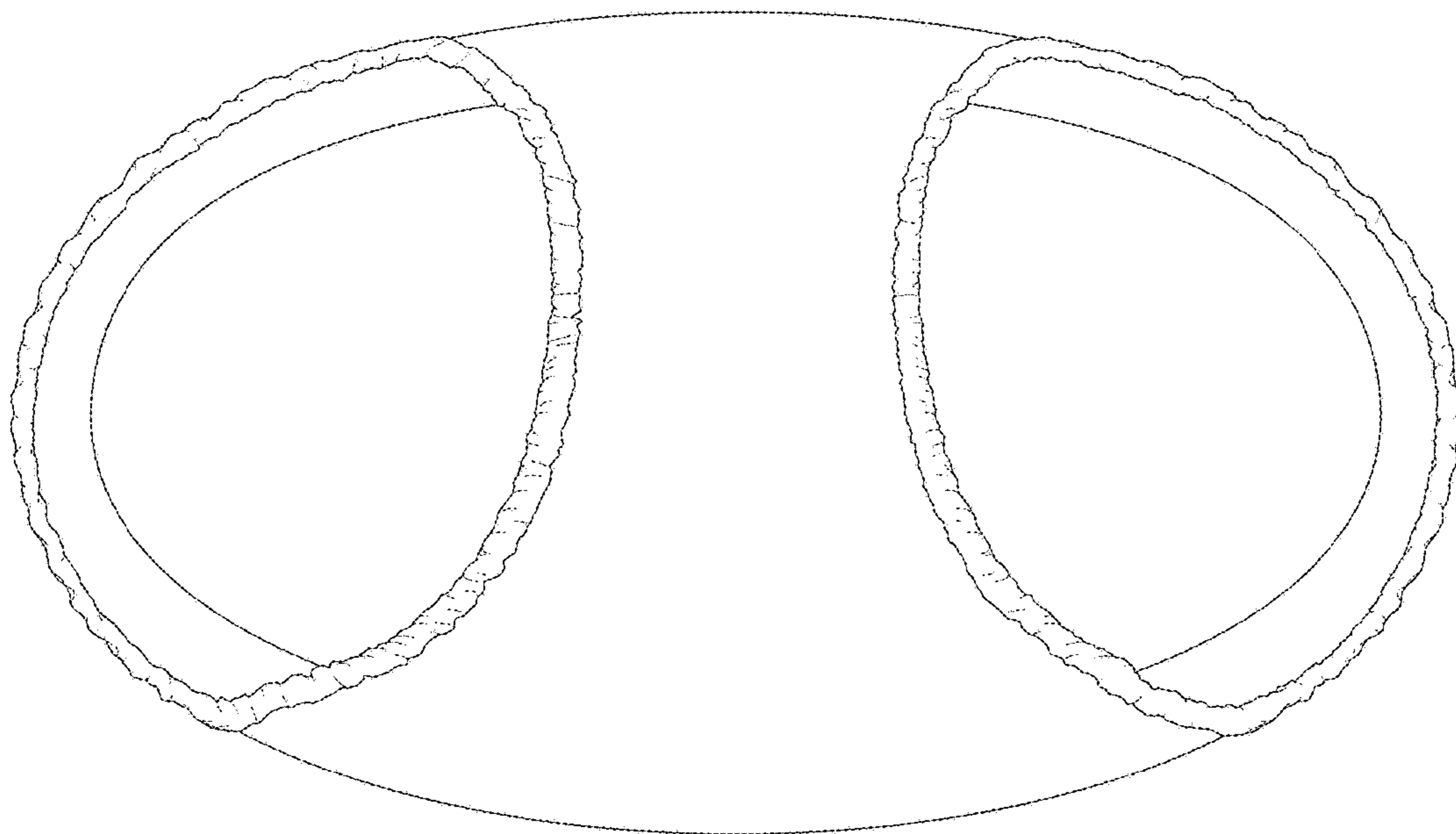
