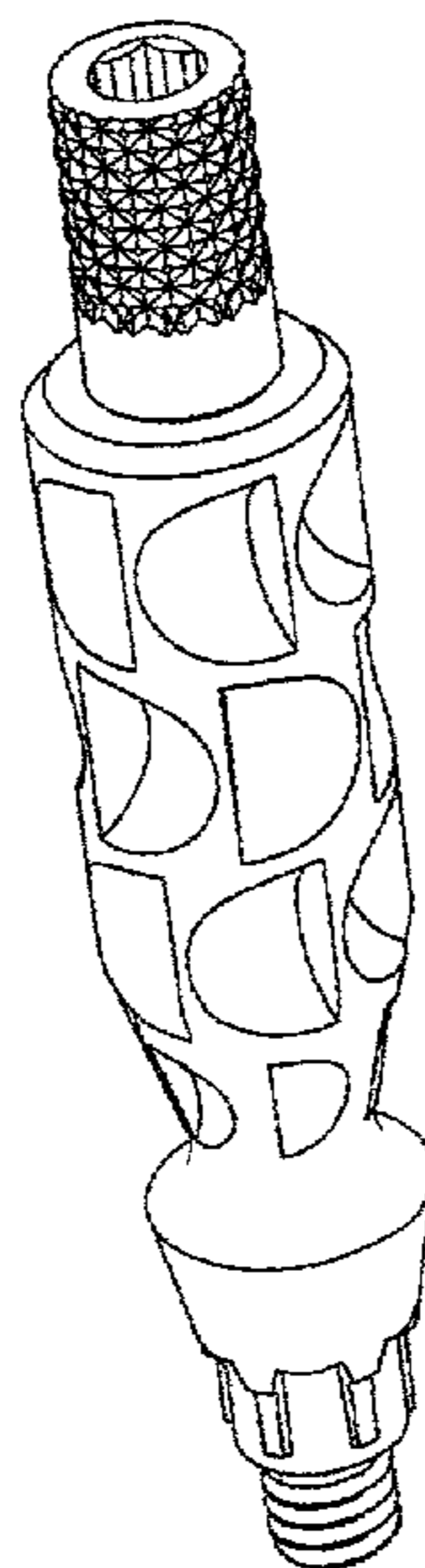

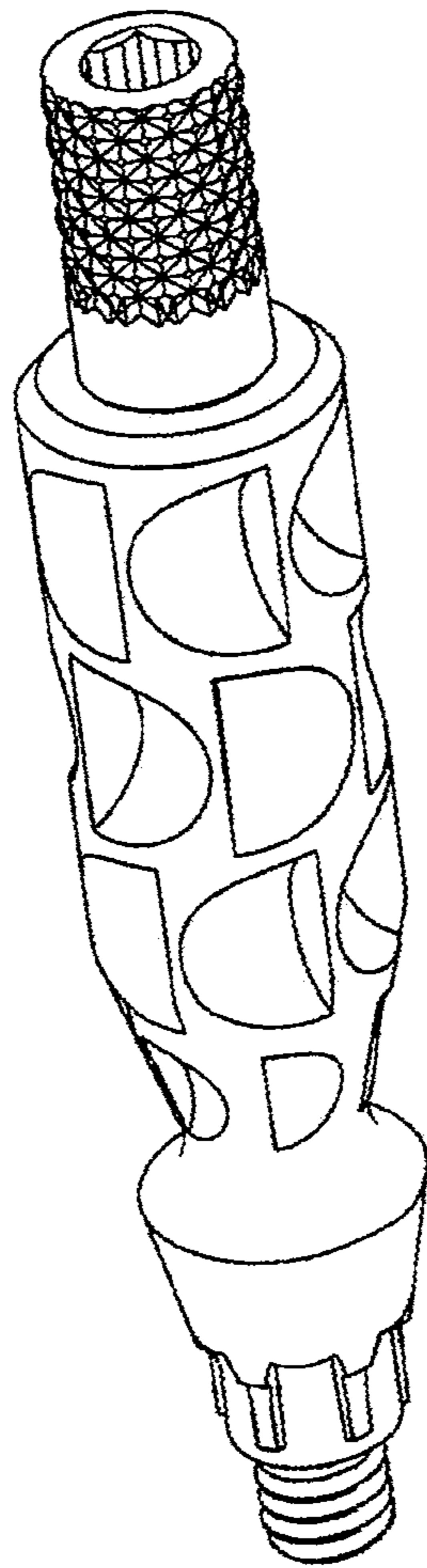
The ornamental design for a dental implant, as shown and described is claimed.

**DESCRIPTION**

FIG. 1 is a perspective view of a dental implant of the present invention;

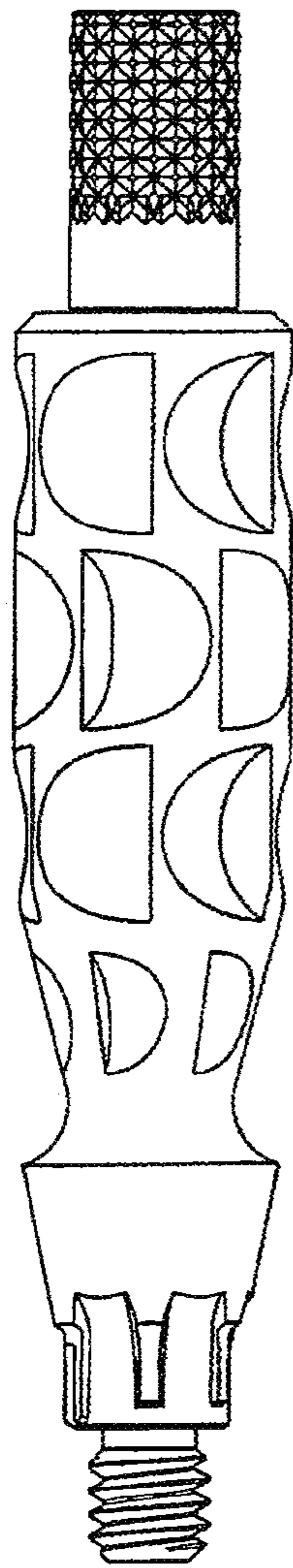

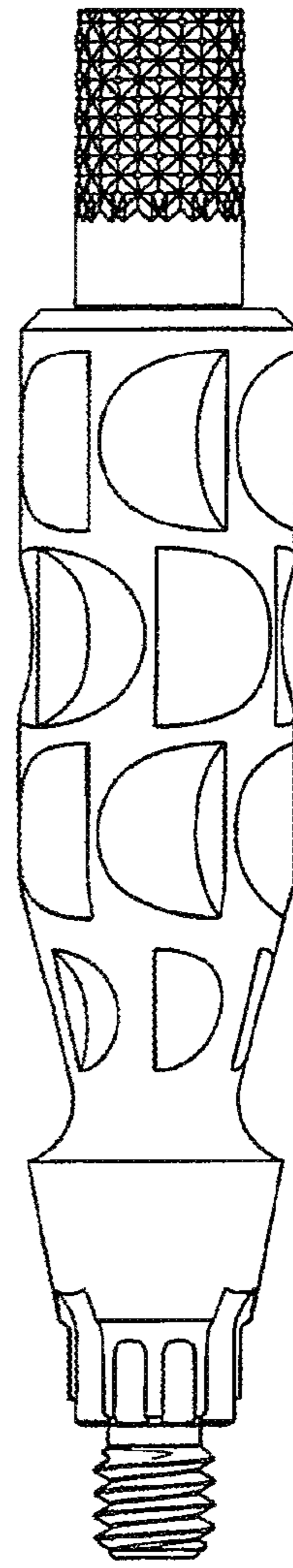

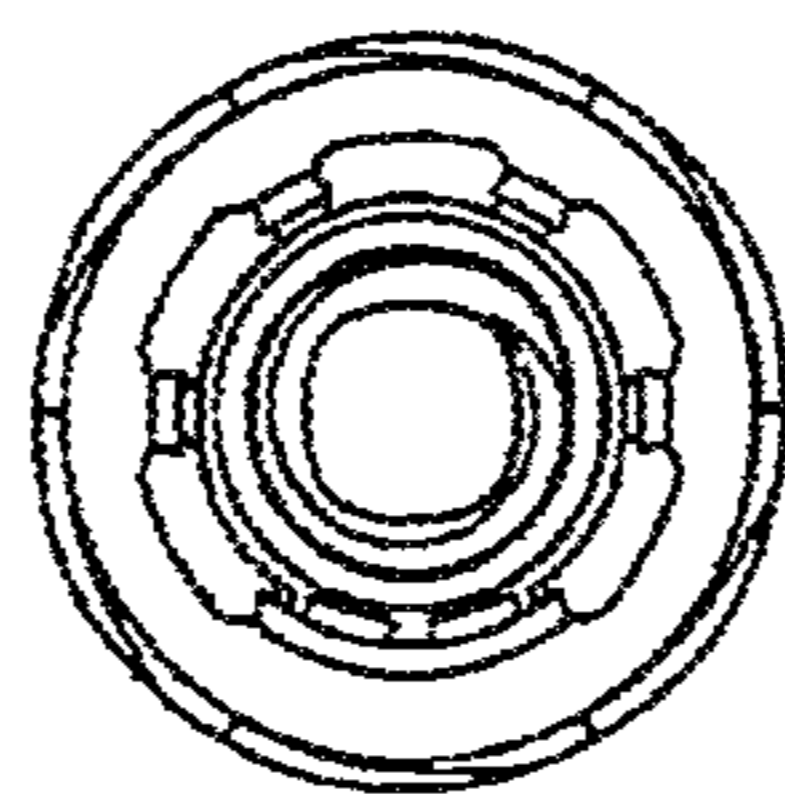

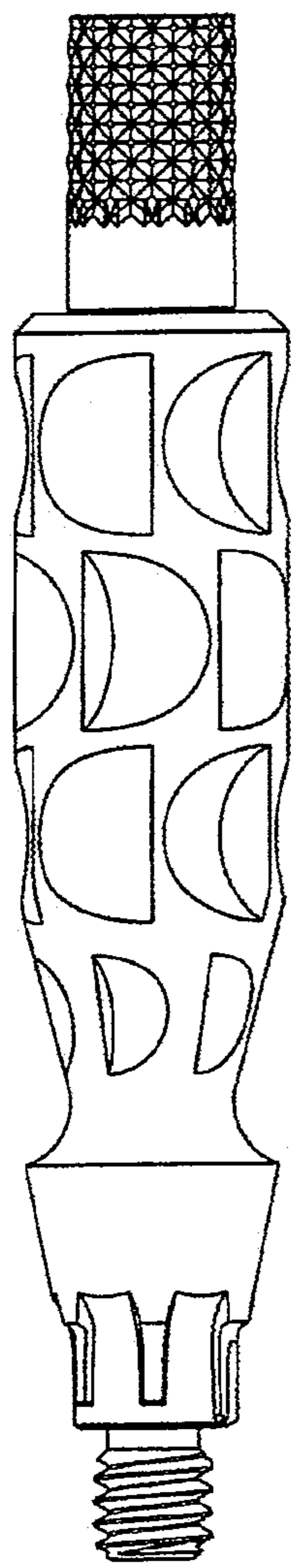

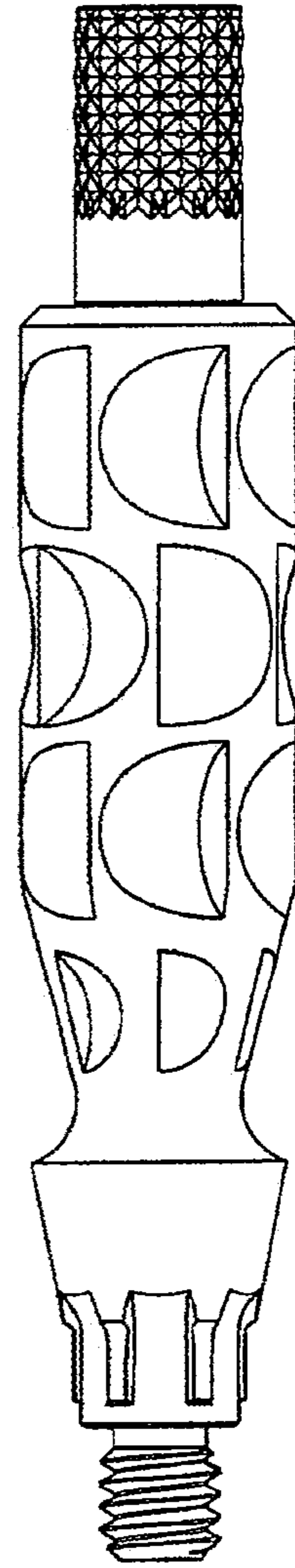

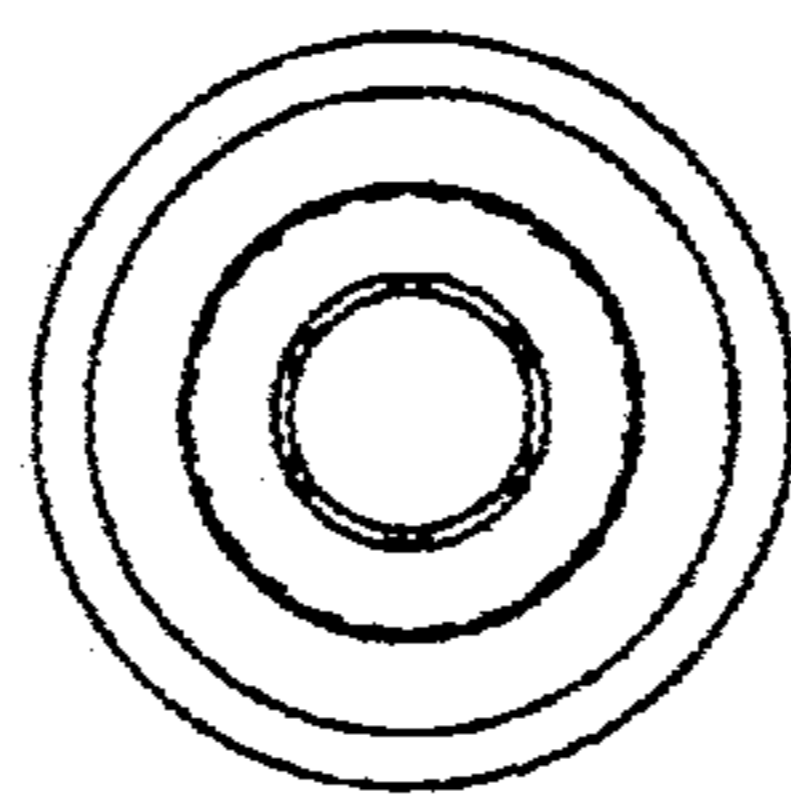
