(57) **CLAIM**

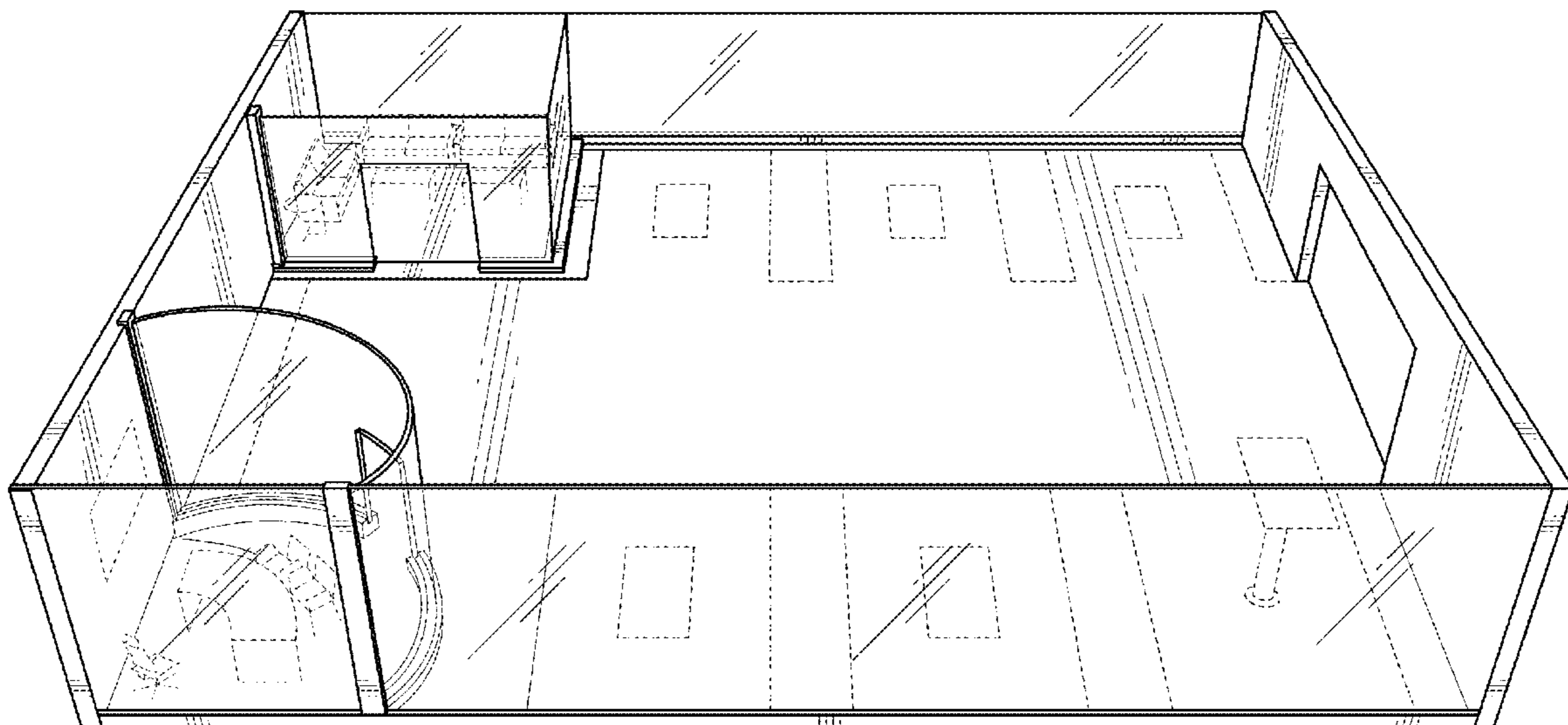
The ornamental design for a parking garage service center, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the parking garage service center showing my new design;

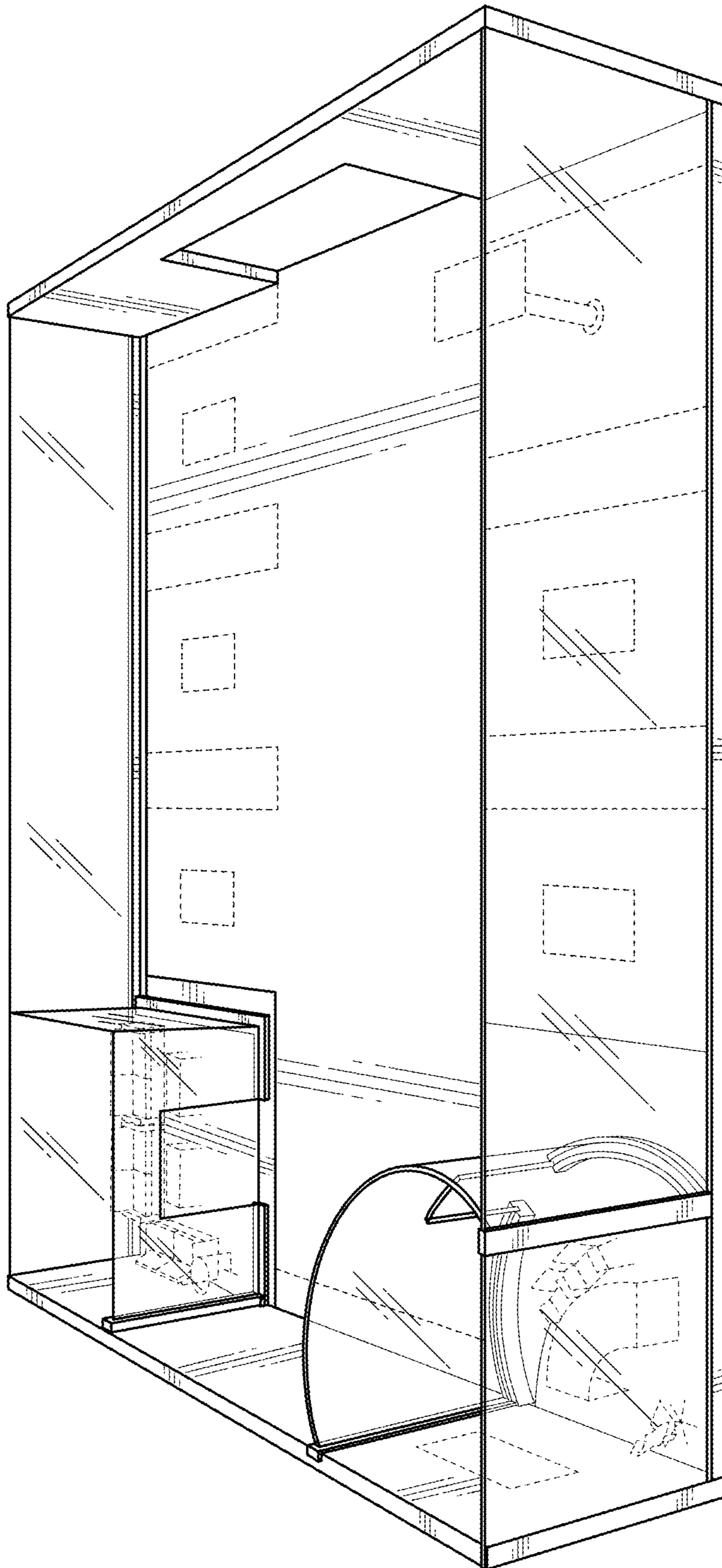

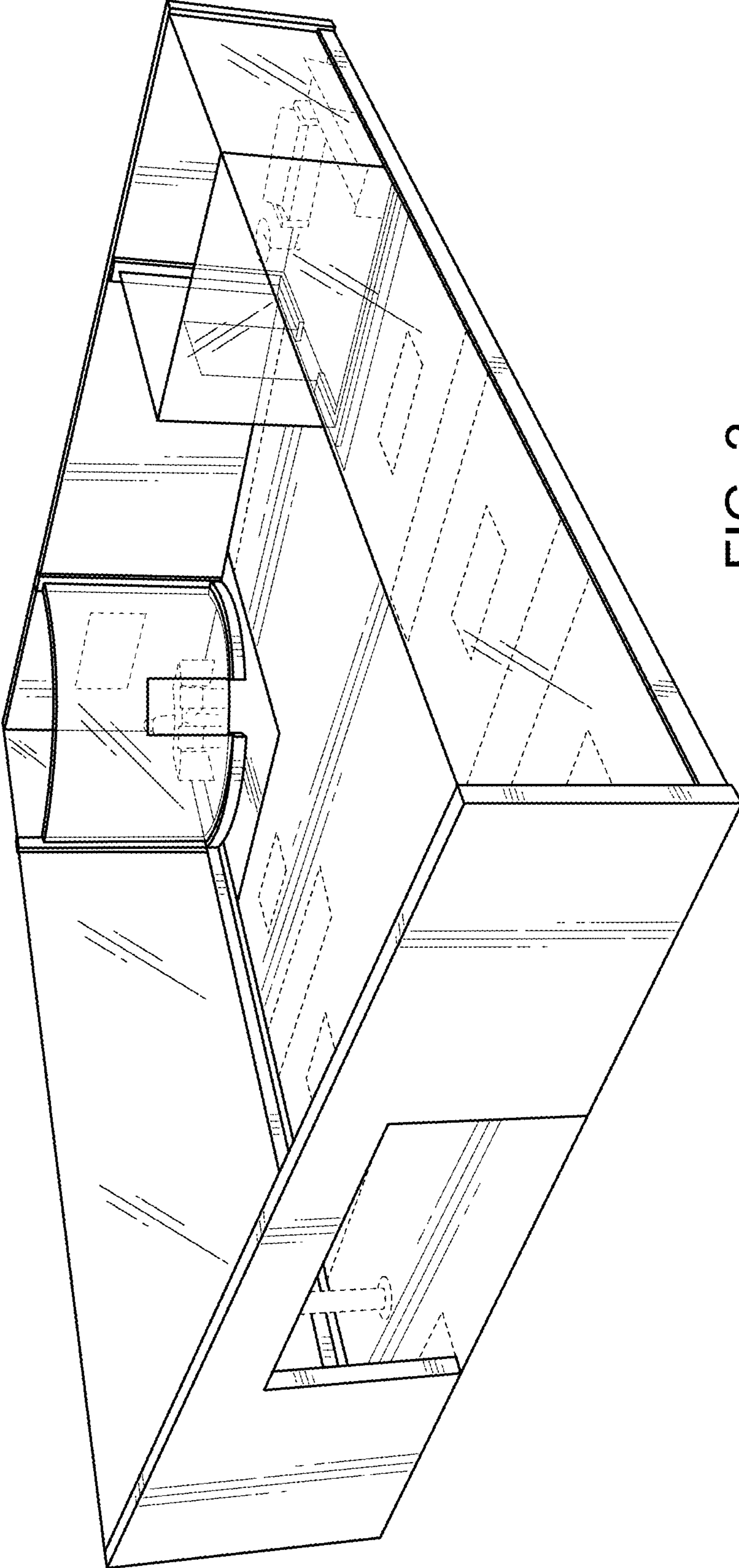

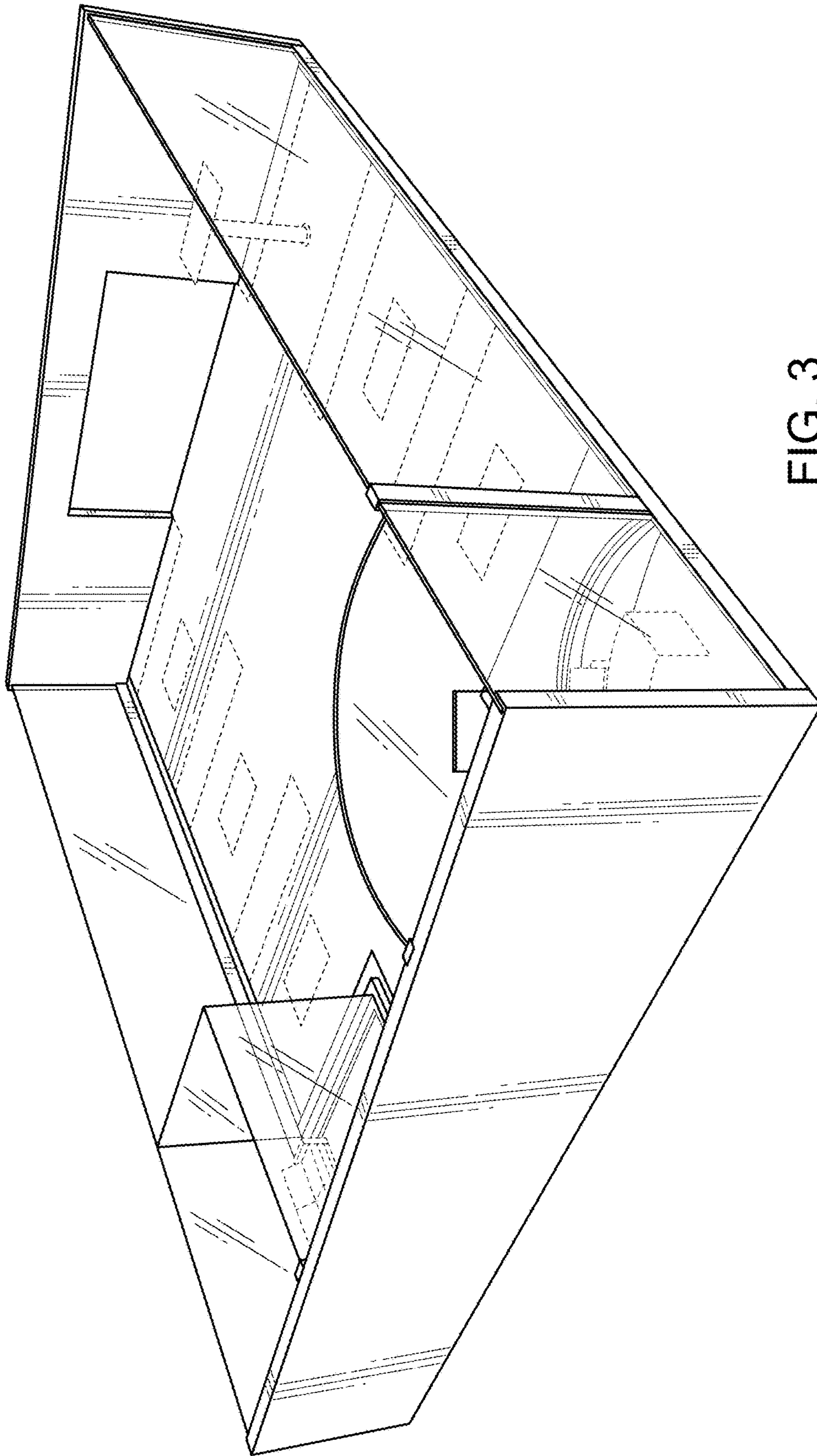

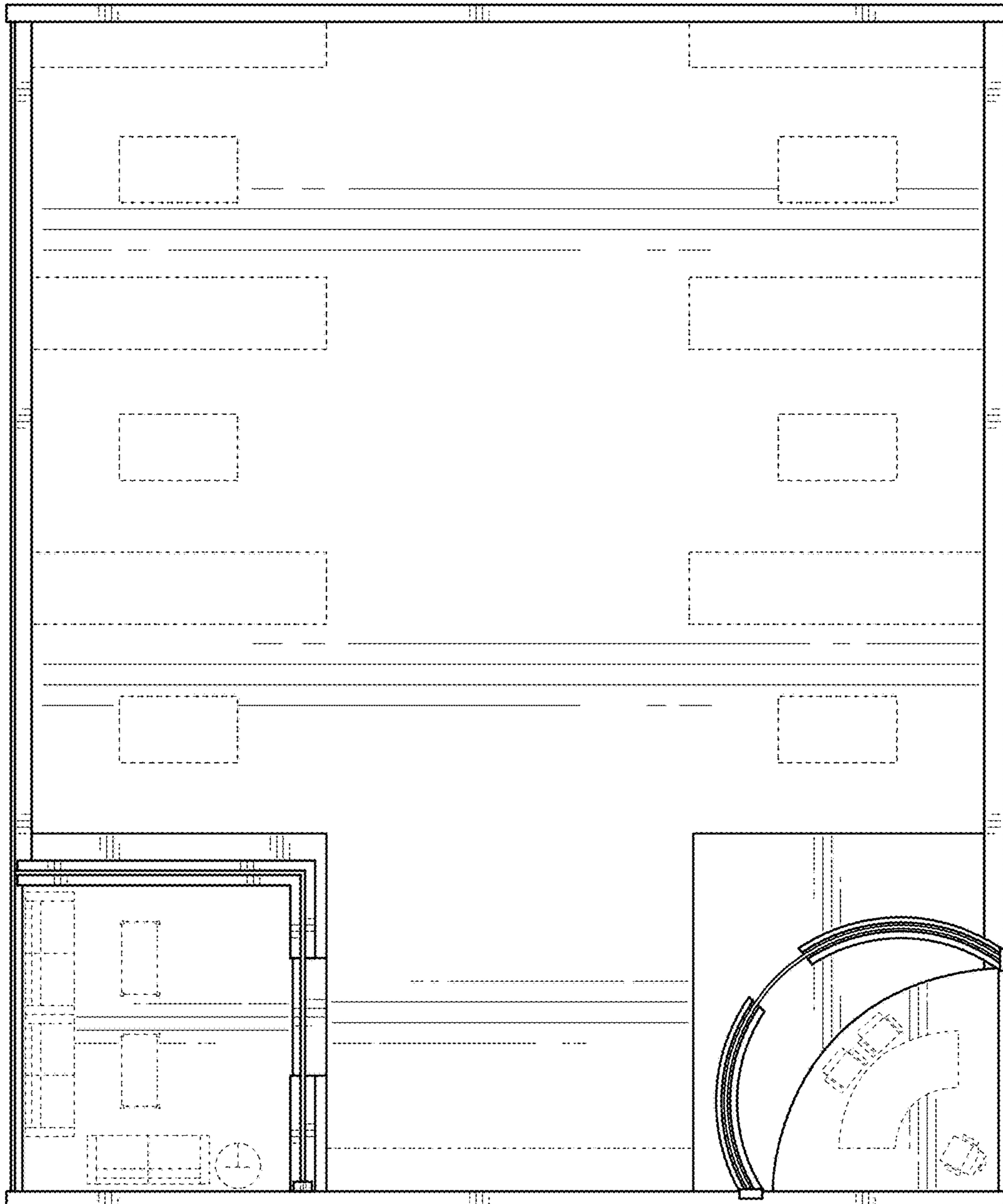

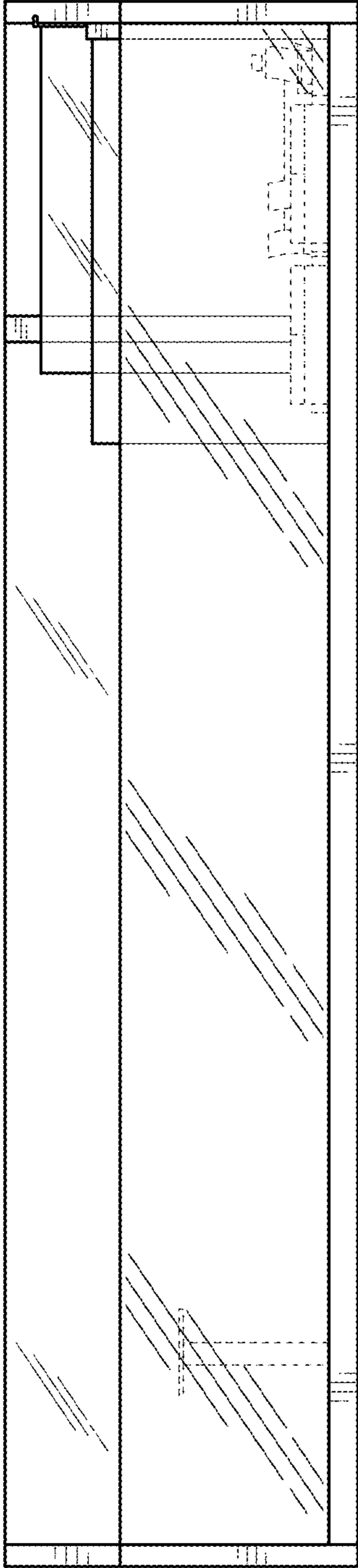

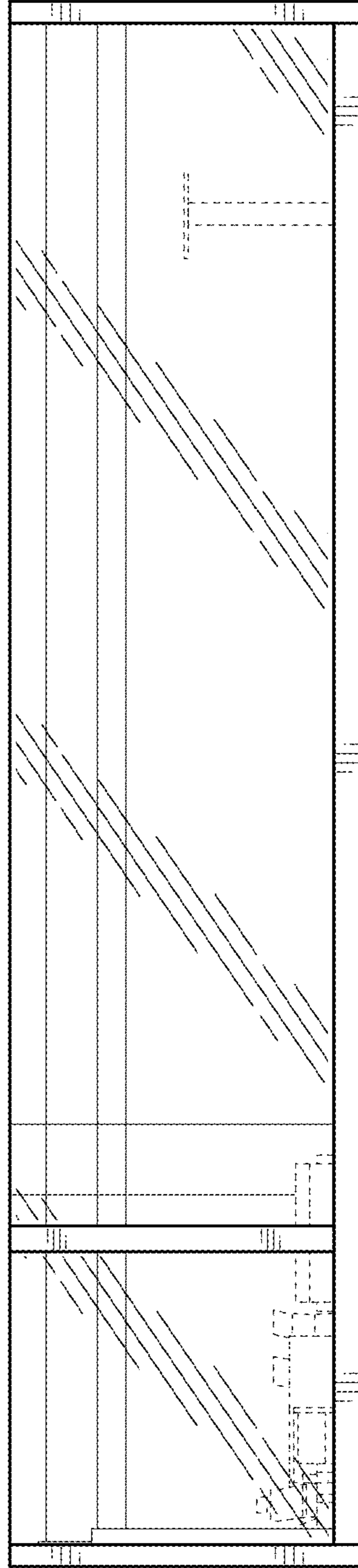

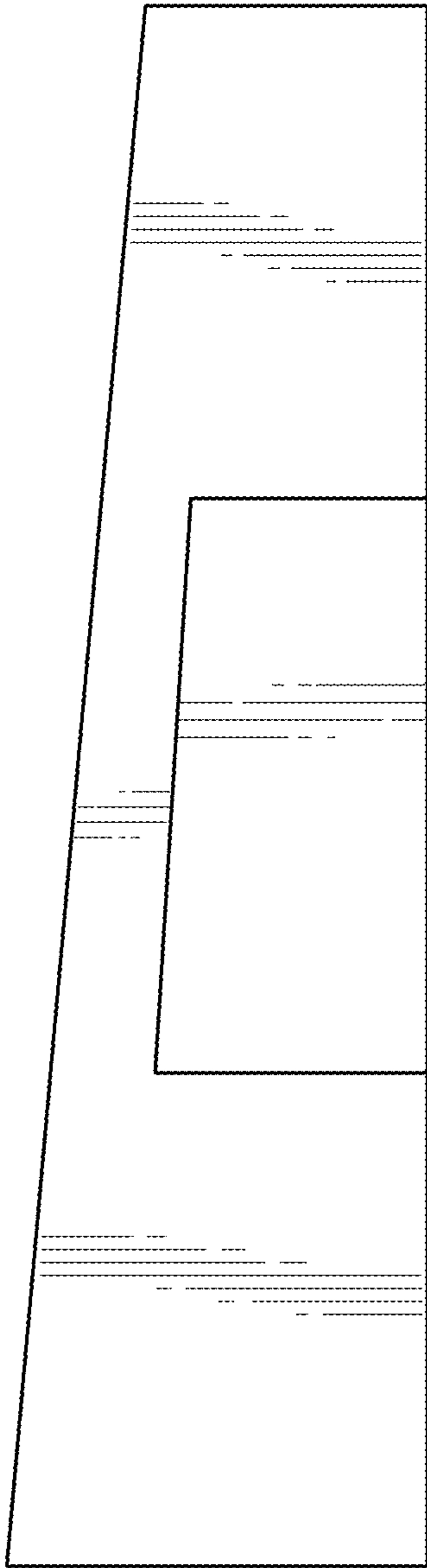

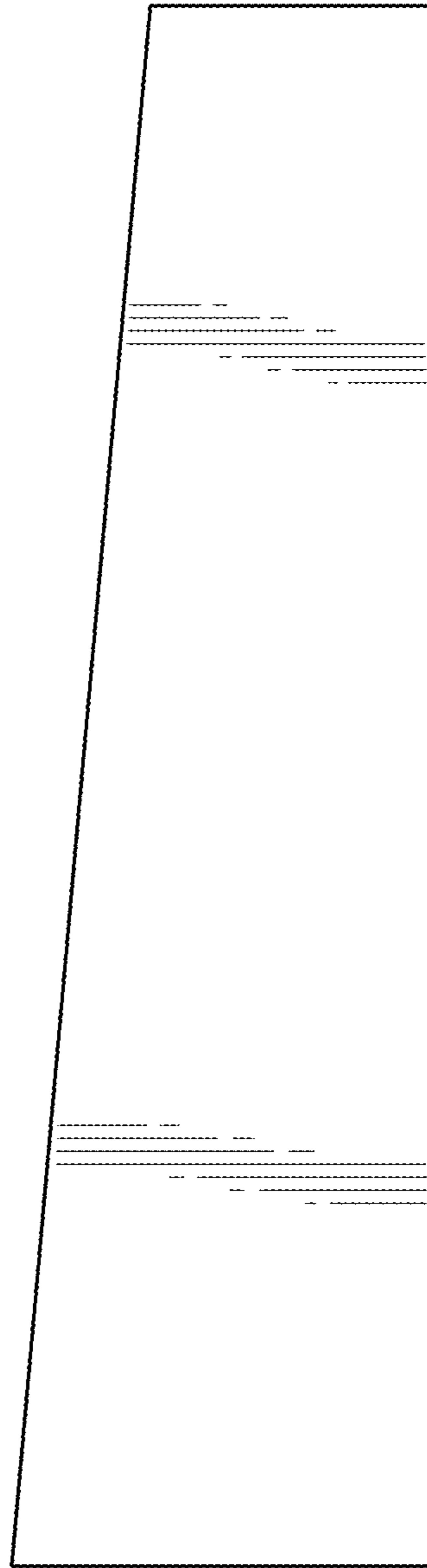
