**DESCRIPTION**

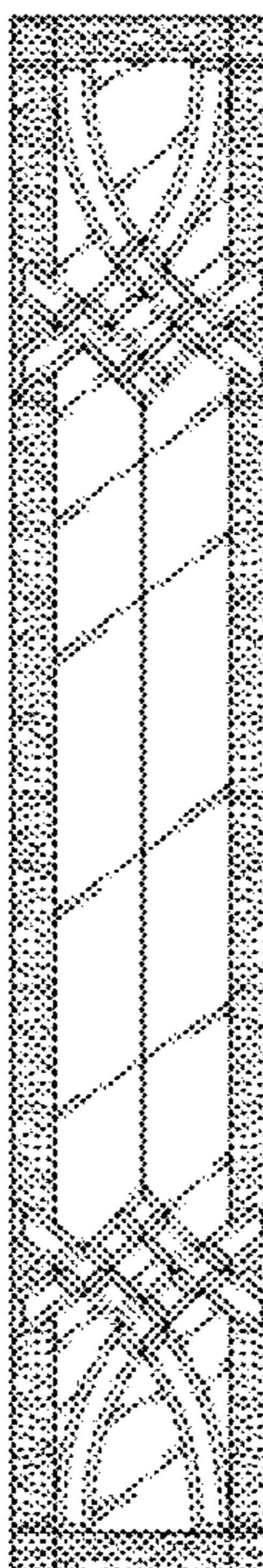
FIG. 1 is a front plan view our design, with the rear view being a mirror image; and,

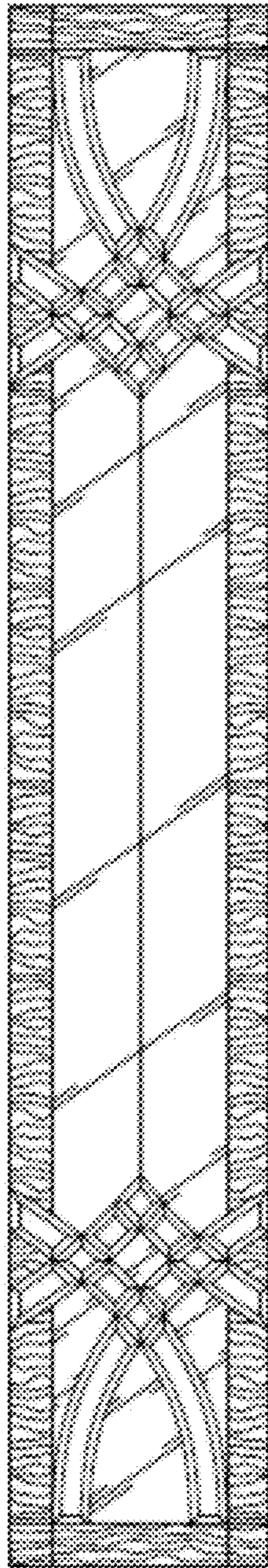
