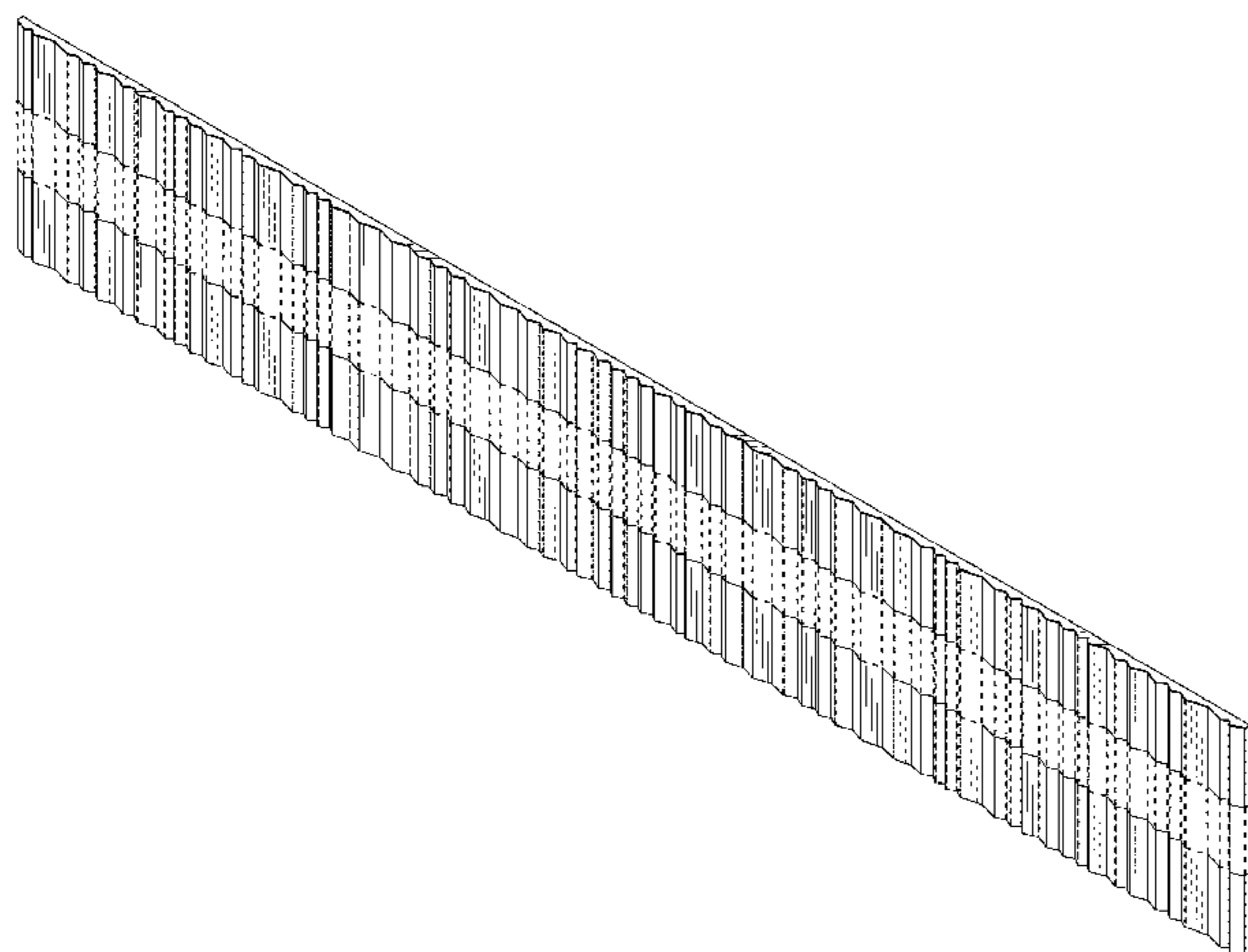
(57) **CLAIM**

A panel member design, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a panel member, showing the new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a right side elevation view thereof. The evenly dashed lines shown in the figures illustrate portions of the panel member that form no part of the claimed design. The dot-dot-dash lines shown in the figures indicate boundaries of the claimed design. The appearance of any portion of the article between these lines forms no part of the claimed design.

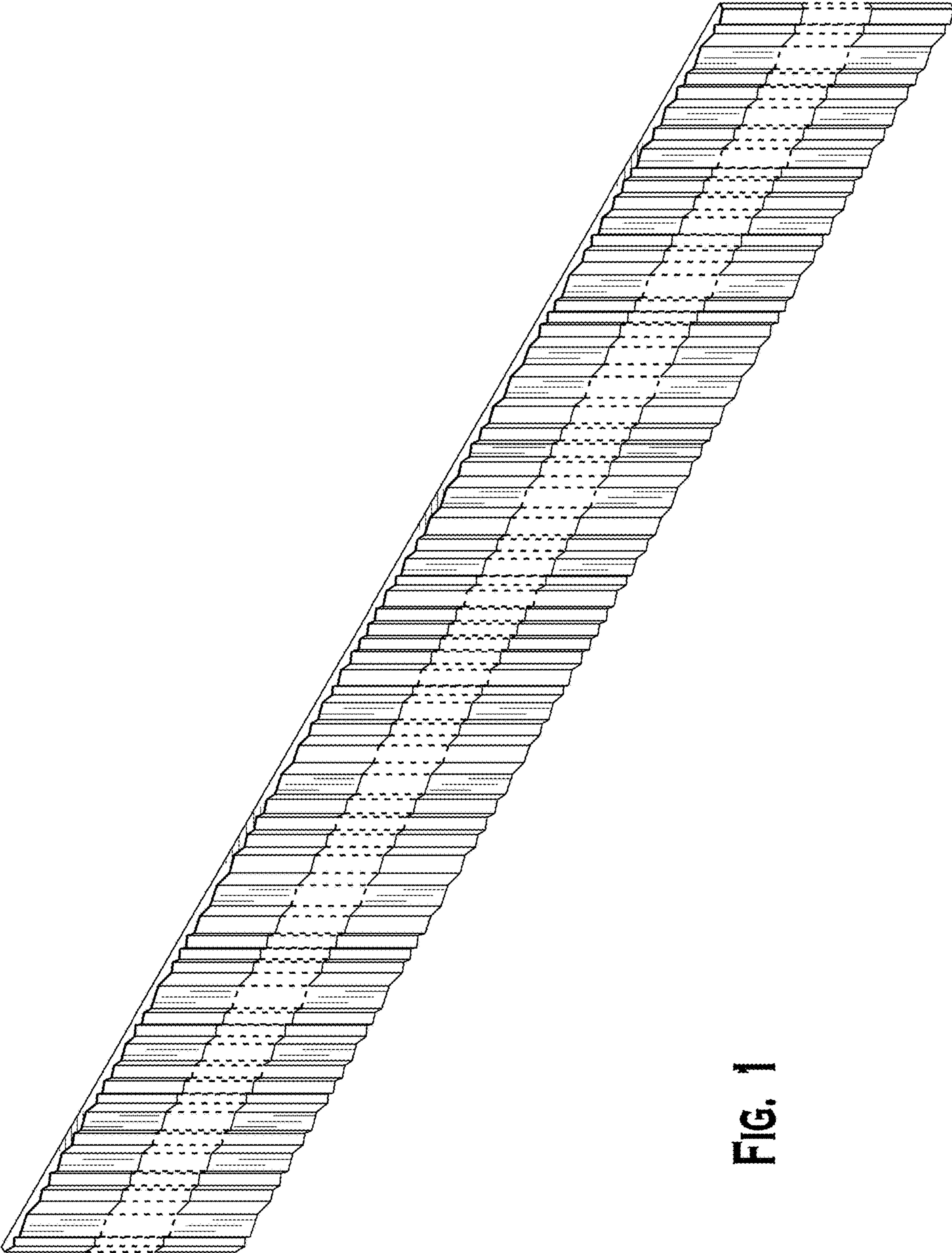

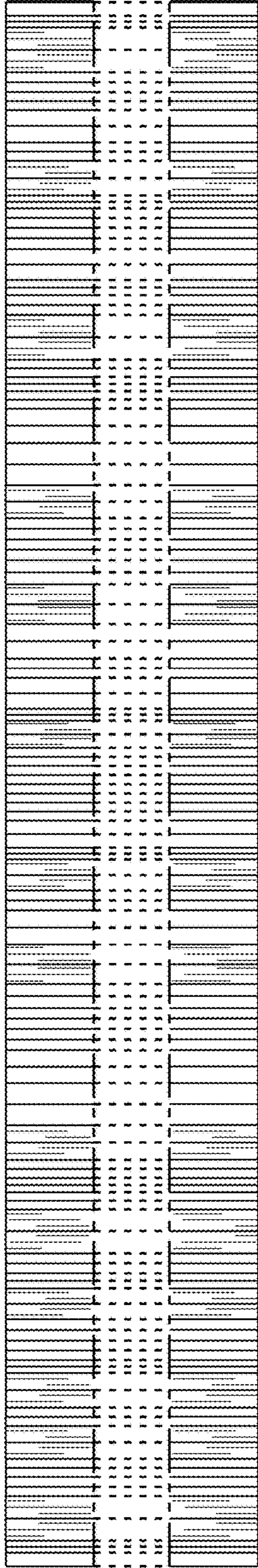

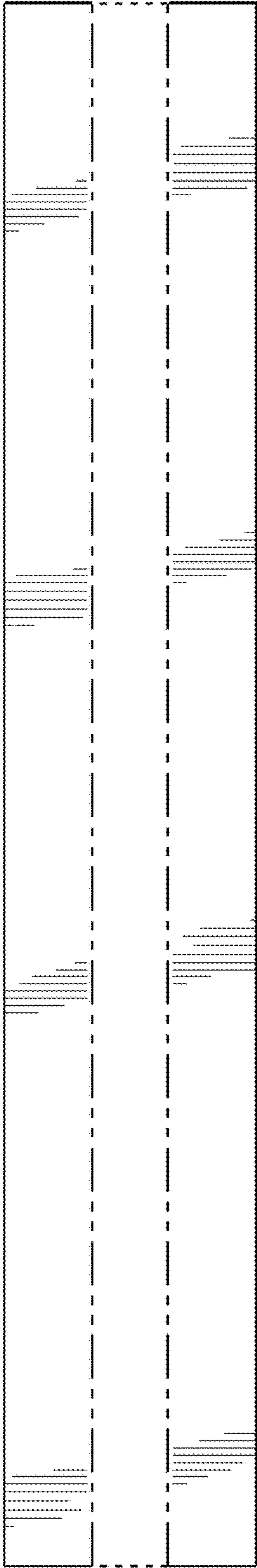

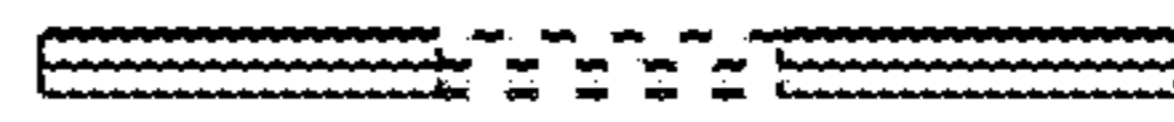
