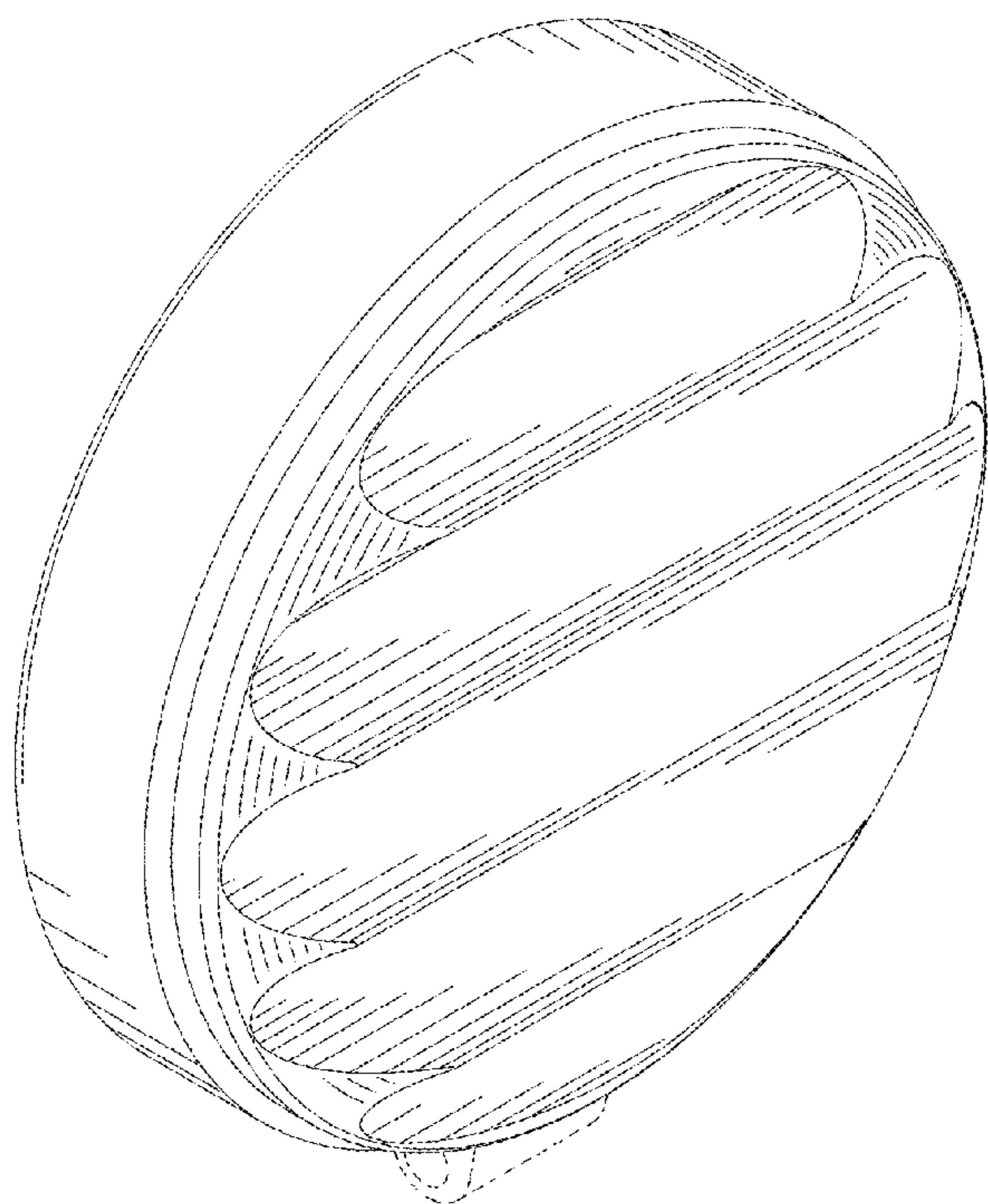
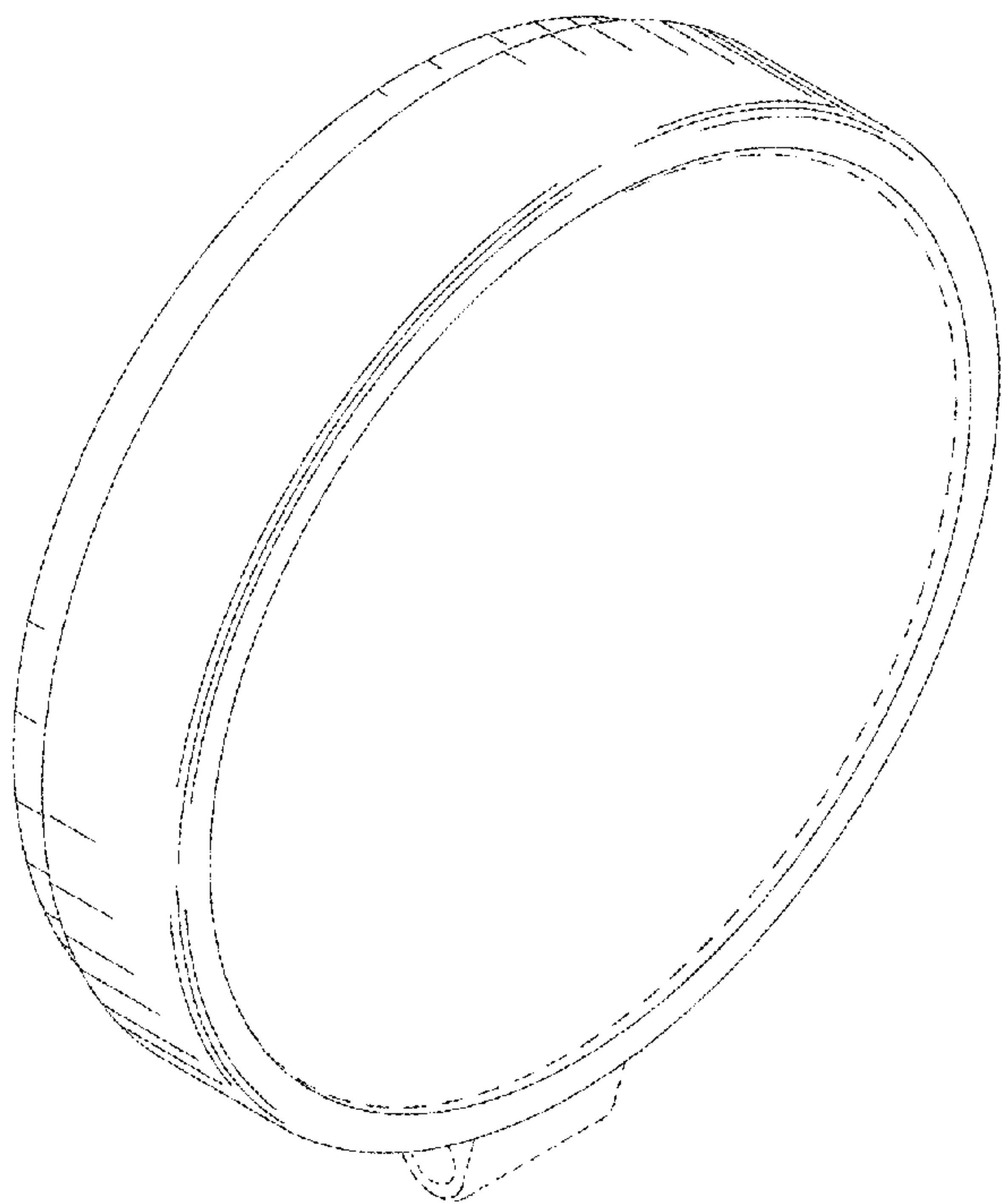
(57) **CLAIM**

The ornamental design for a LED work light, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an LED work light showing my new design;
FIG. 2 is a rear perspective view of FIG. 1;
FIG. 3 is a top plan view of FIG. 1;
FIG. 4 is a front elevation view of FIG. 1;
FIG. 5 is a bottom plan view of FIG. 1;
FIG. 6 is a right elevation view of FIG. 1, the left elevation view being a mirror image thereof; and,
FIG. 7 is a rear elevation view of FIG. 1.
The broken lines shown in the drawings depict portions of the LED work light that form no part of the claimed design.

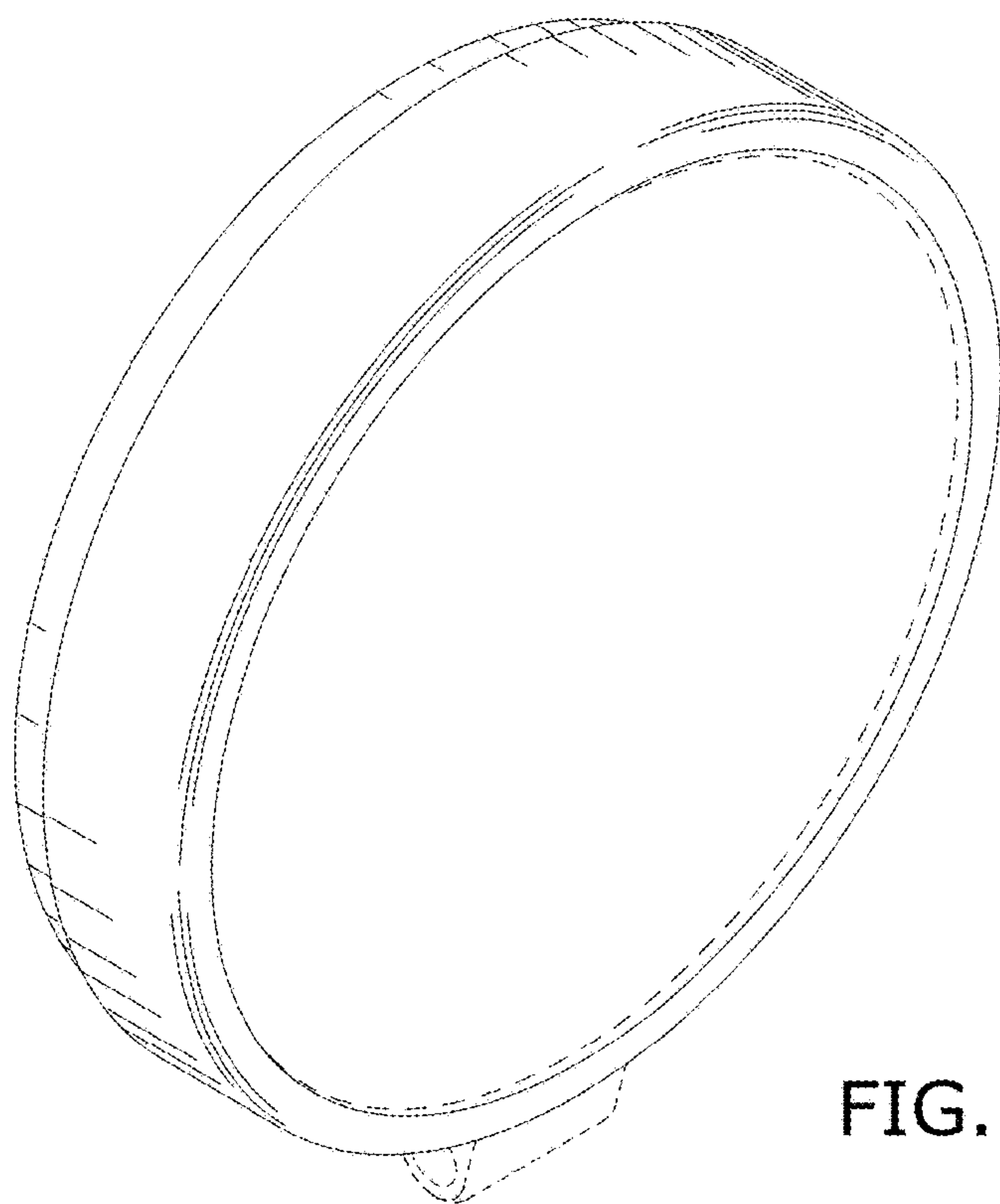

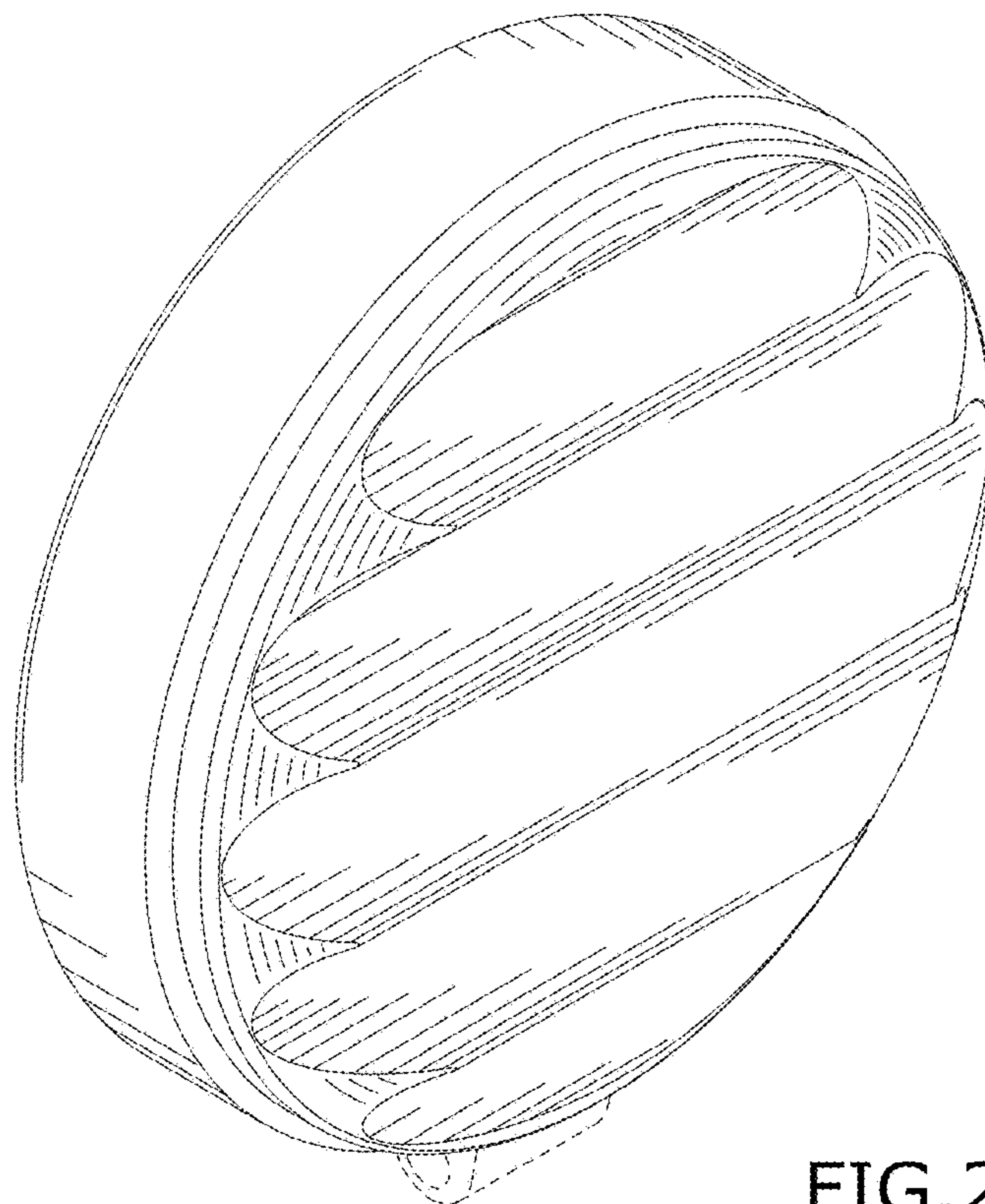

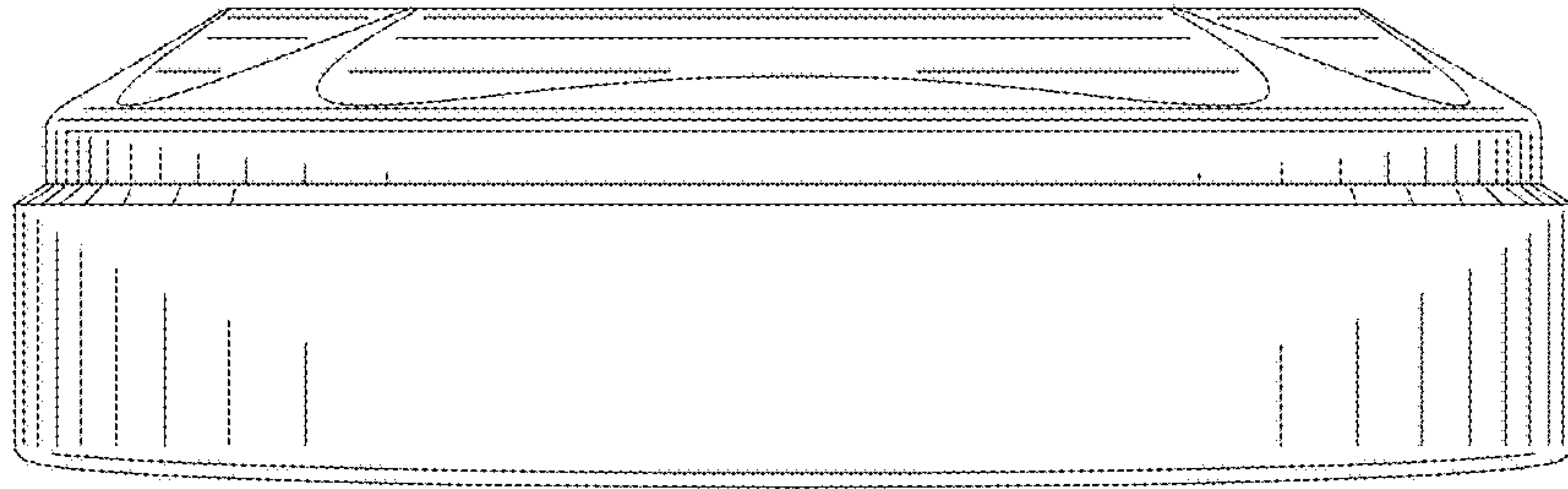

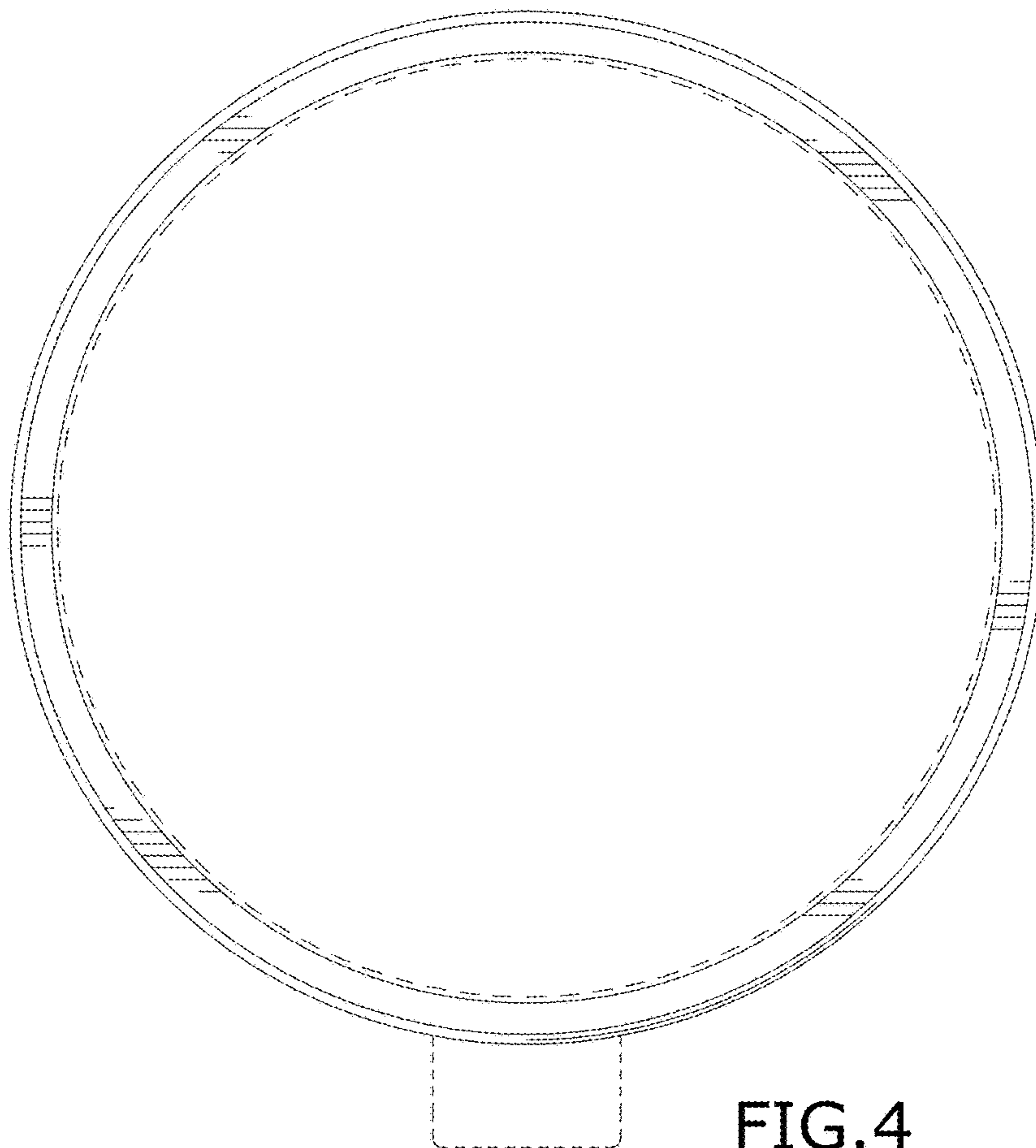

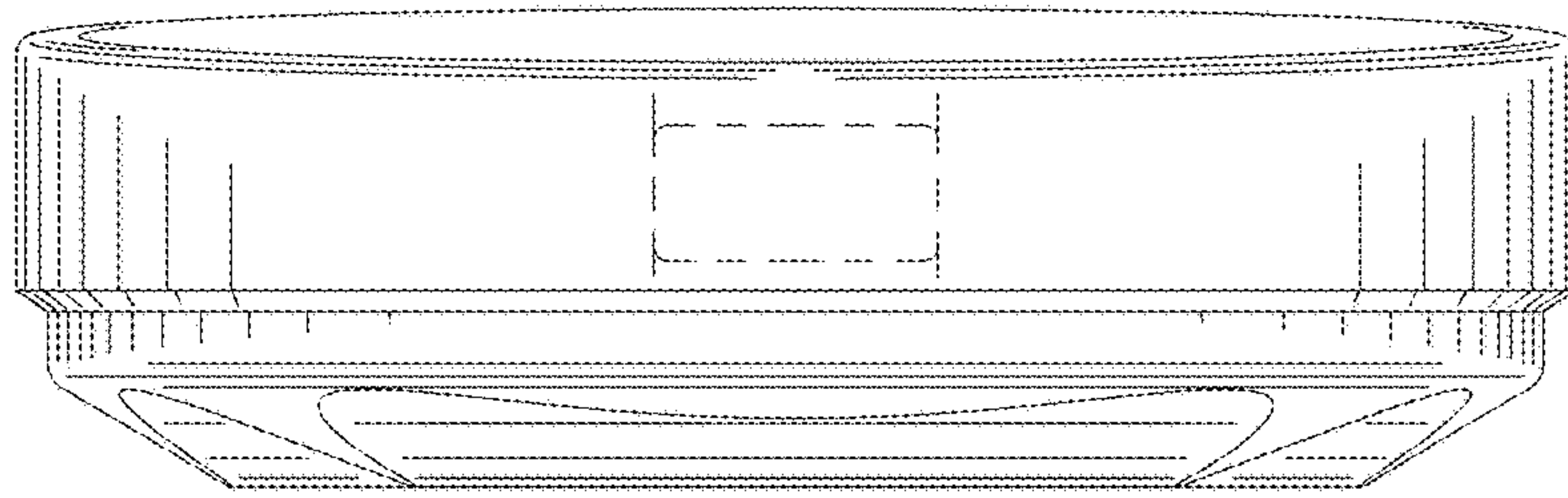

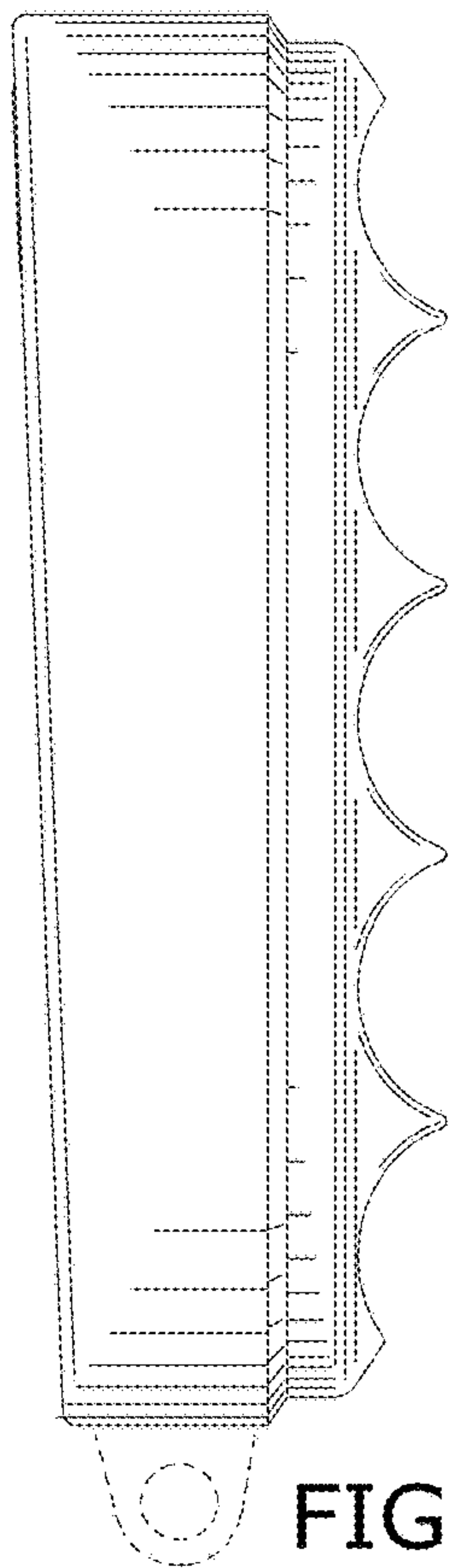

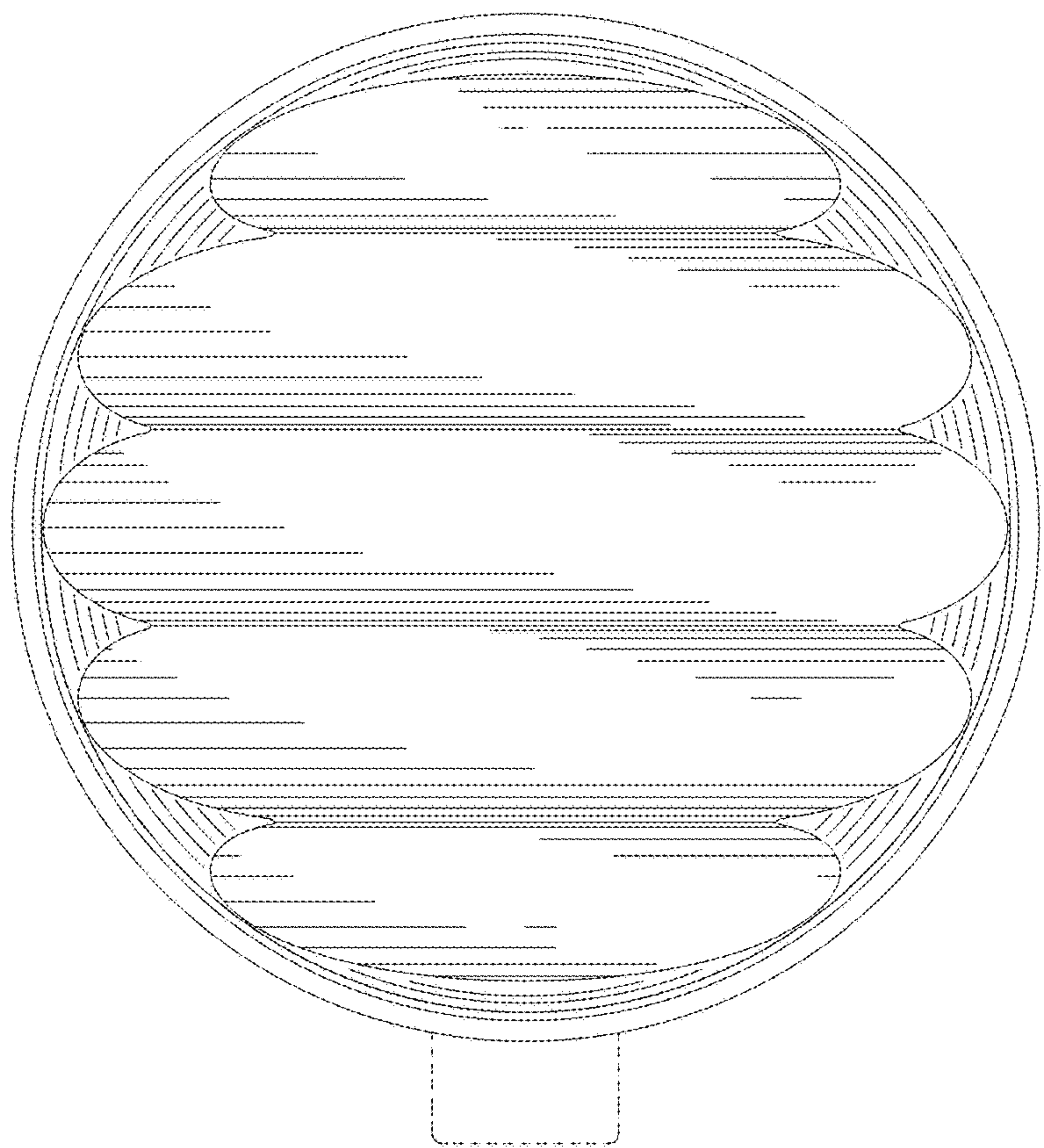
