FIG. 2 is a top plan view thereof;

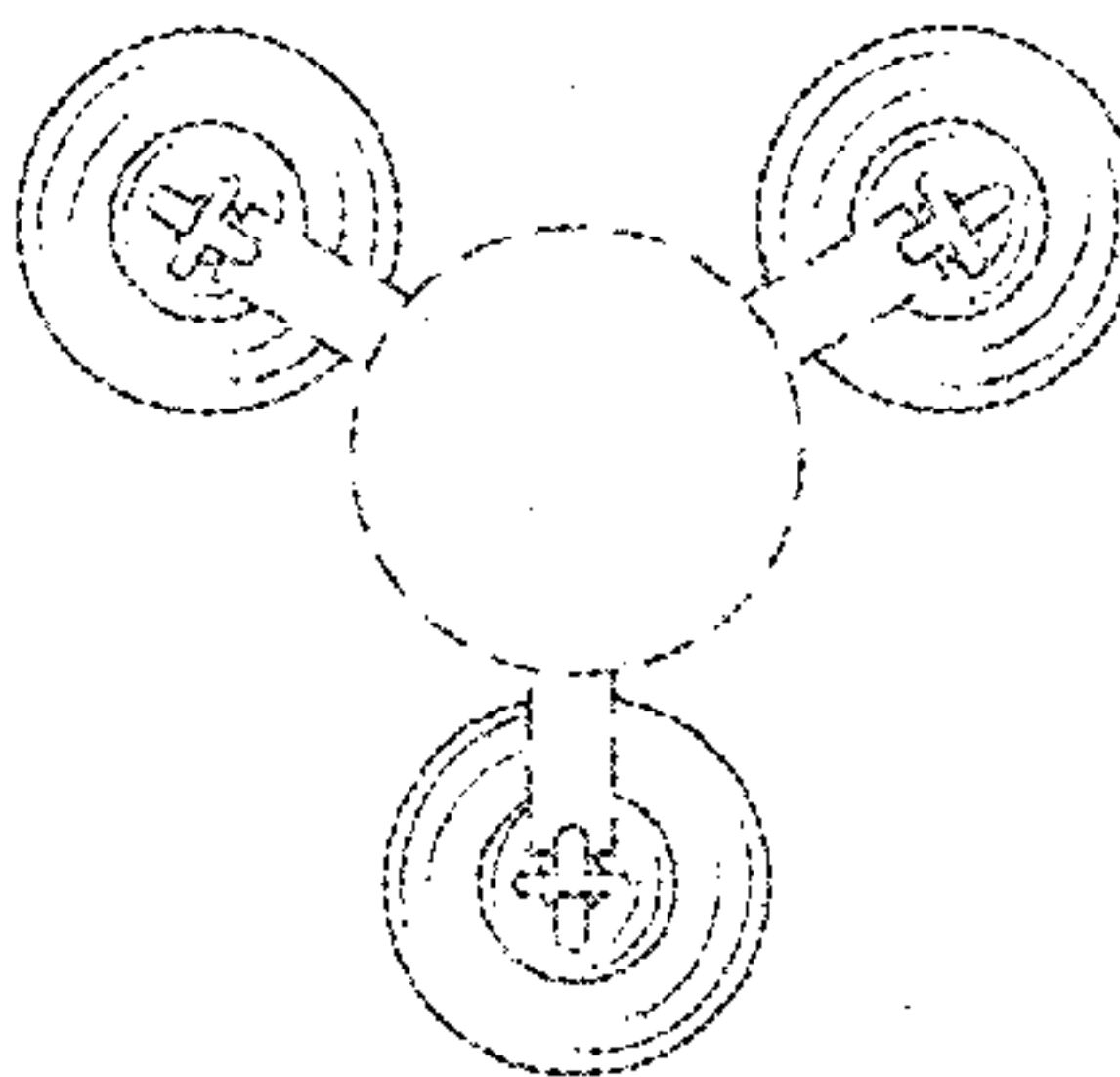
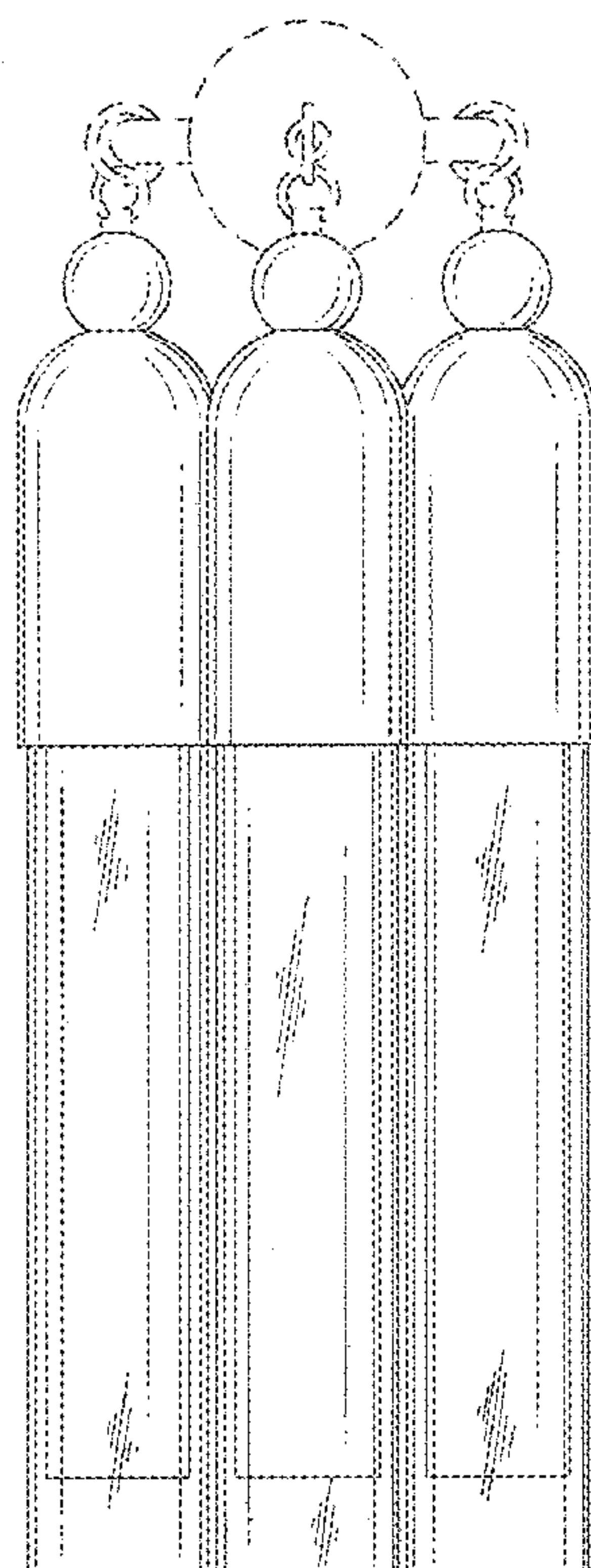
FIG. 3 is a right side elevational view thereof, with the left side elevational view being the mirror-image;

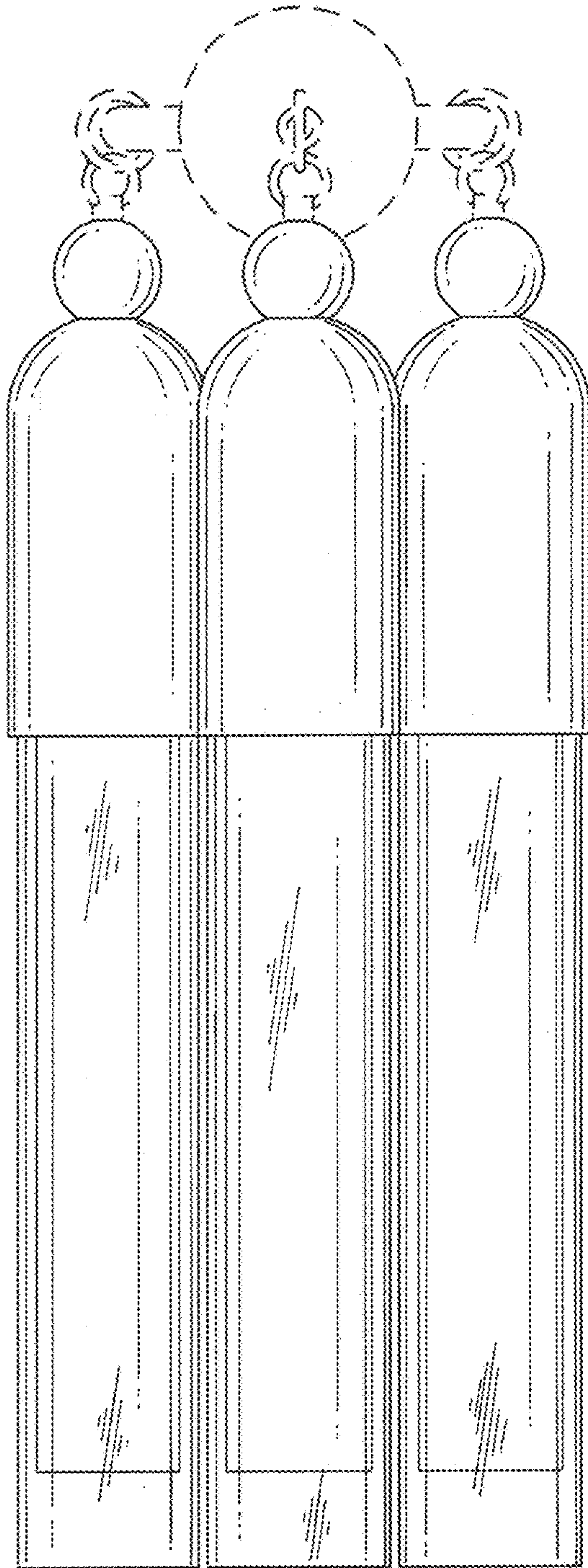

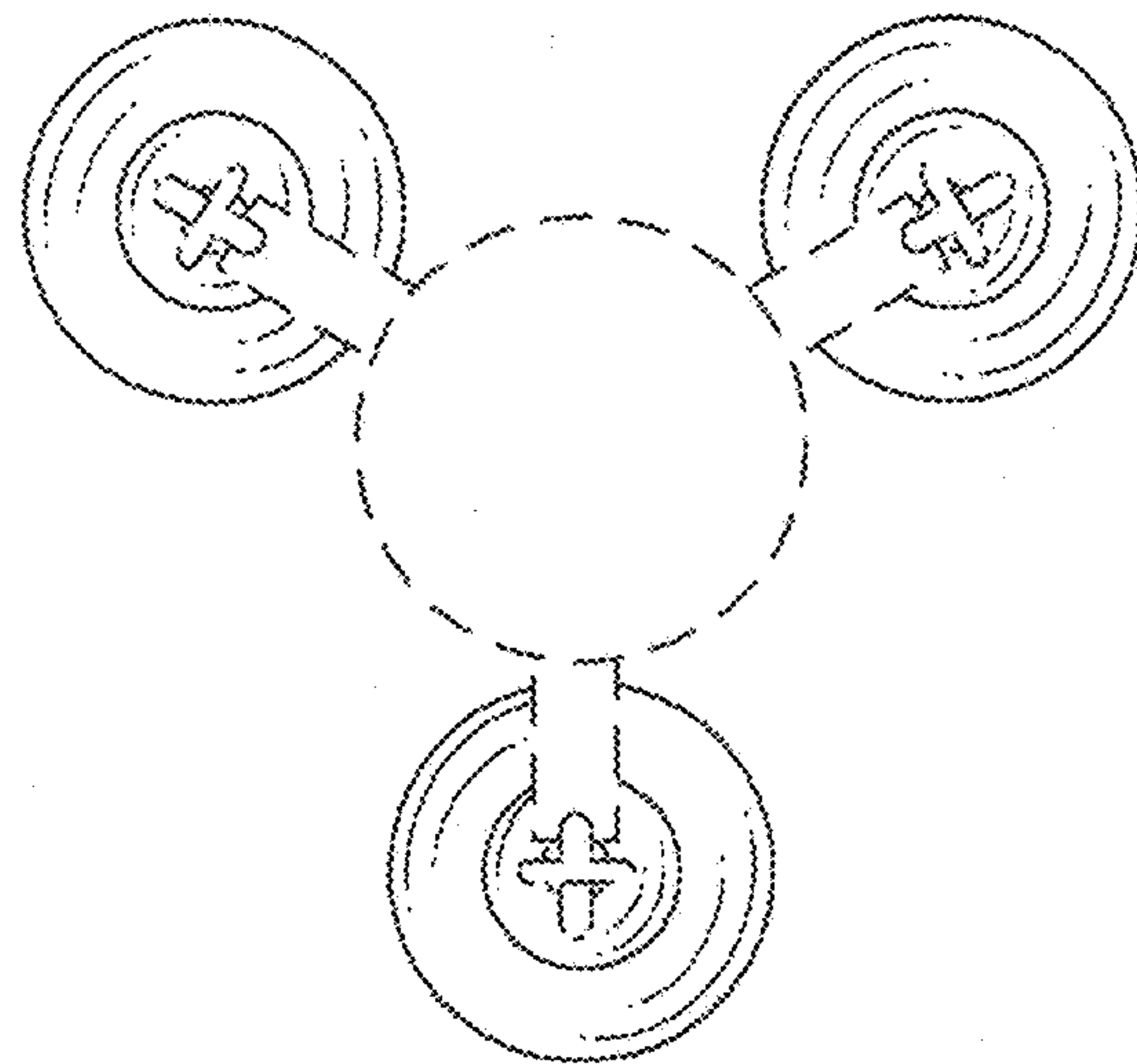

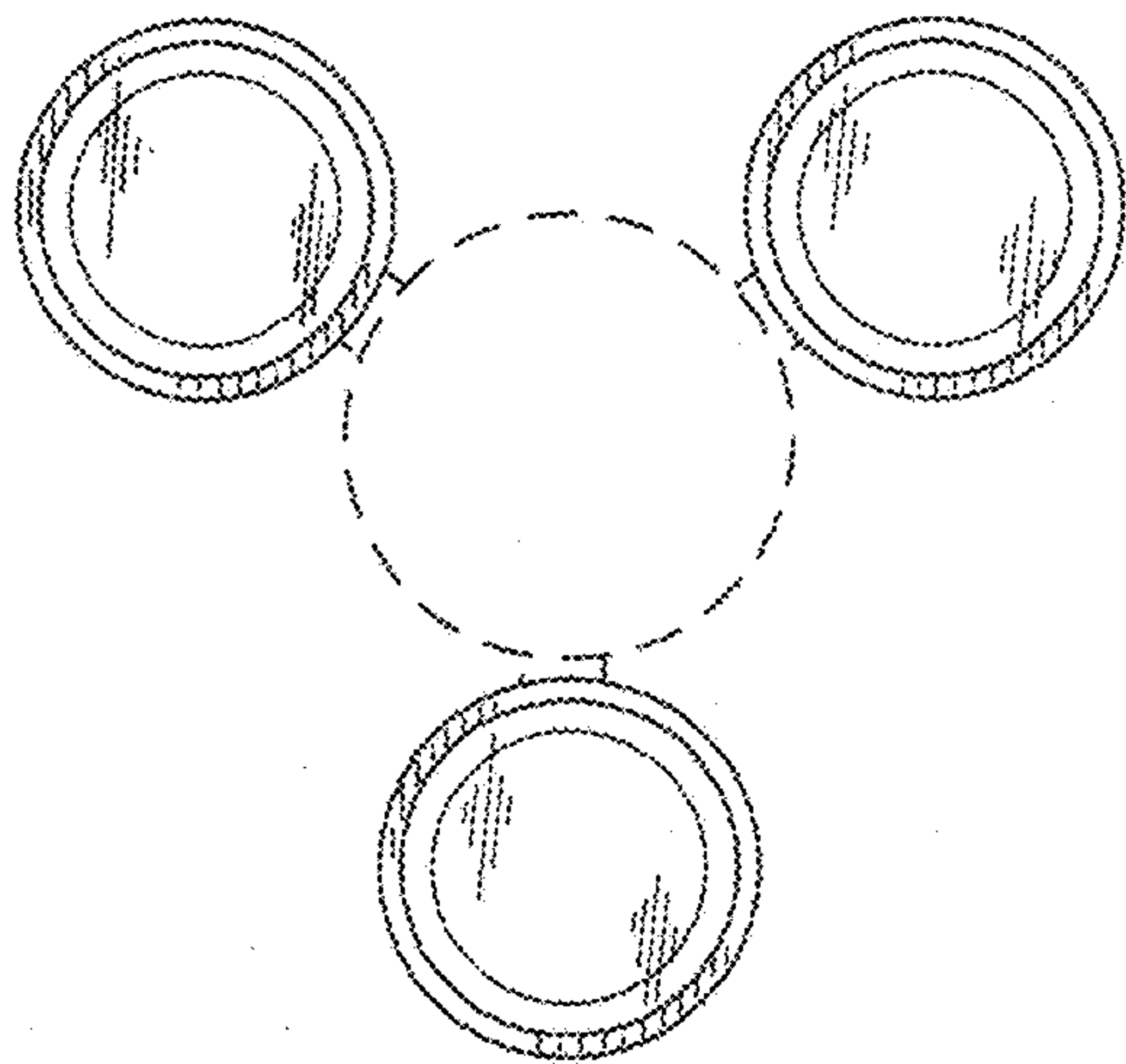
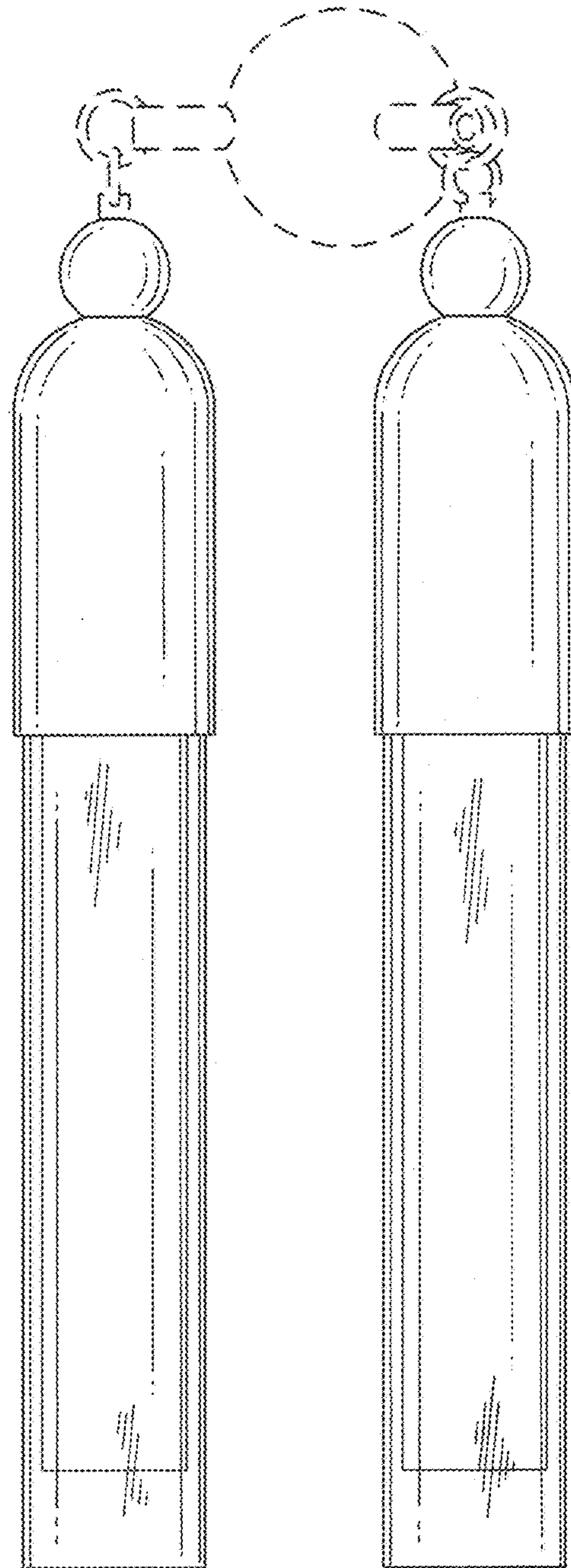

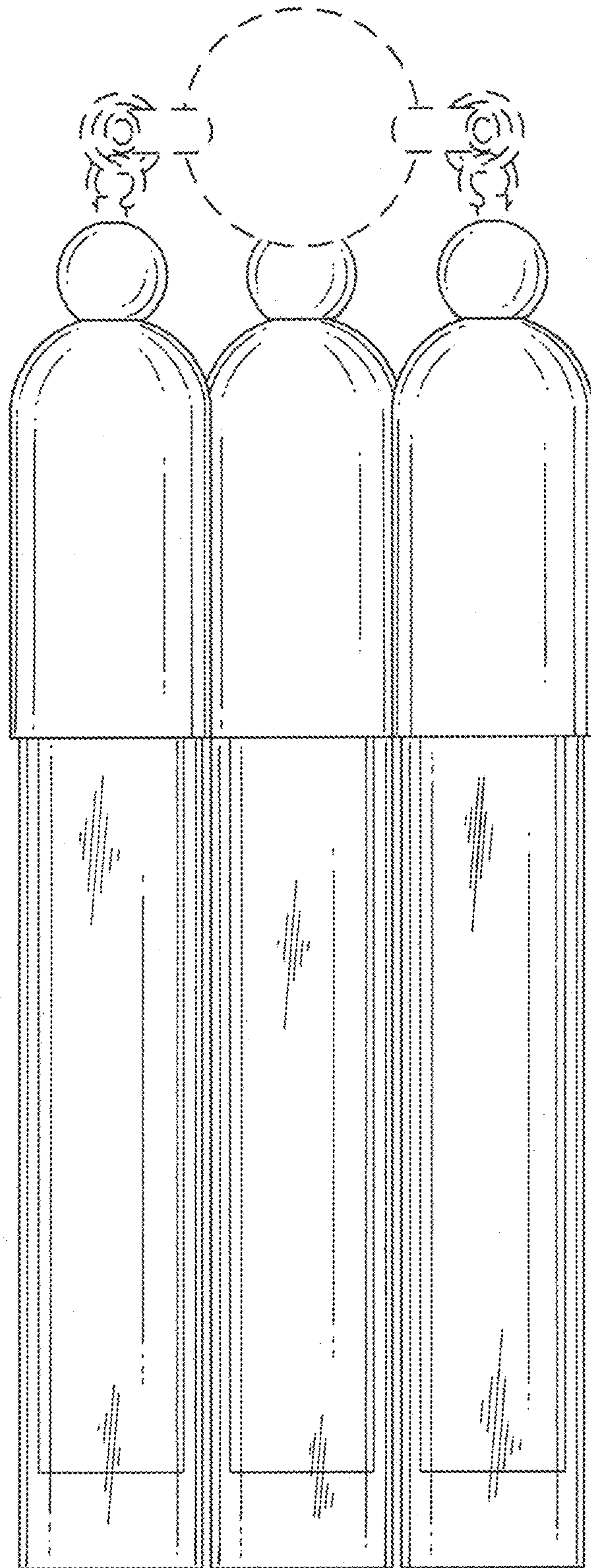
