The ornamental design for a shoulder pad, as shown and described.

DESCRIPTION

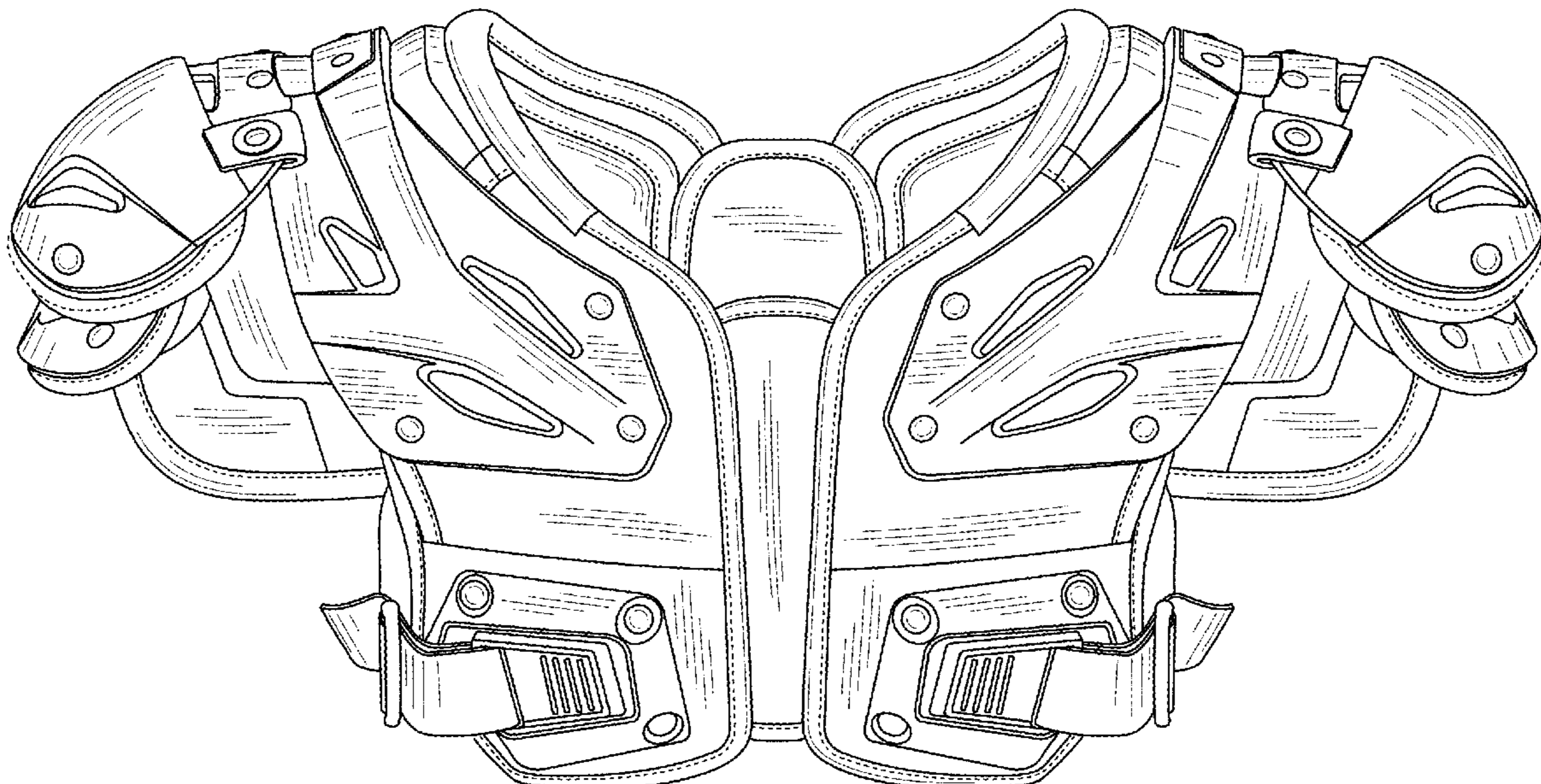
FIG. 1 is a front view of a shoulder pad;
 FIG. 2 is a rear view of the shoulder pad, showing the right side buckle unclashed;
 FIG. 3 is a top plan view of the shoulder pad;
 FIG. 4 is a right side view of the shoulder pad, showing the right side buckle unclashed;
 FIG. 5 is a front perspective view of the shoulder pad as seen from the right side of the shoulder pad, showing the right side buckle unclashed; and,
 FIG. 6 is a rear perspective view of the shoulder pad as seen from a left side of the shoulder pad, showing the right side buckle unclashed.
 The right side buckle is shown unclashed in FIGS. 2, 4, 5, and 6 in order to show aspects of the design that are not otherwise apparent.
 The broken lines represent stitching and do not form part of the claimed design.

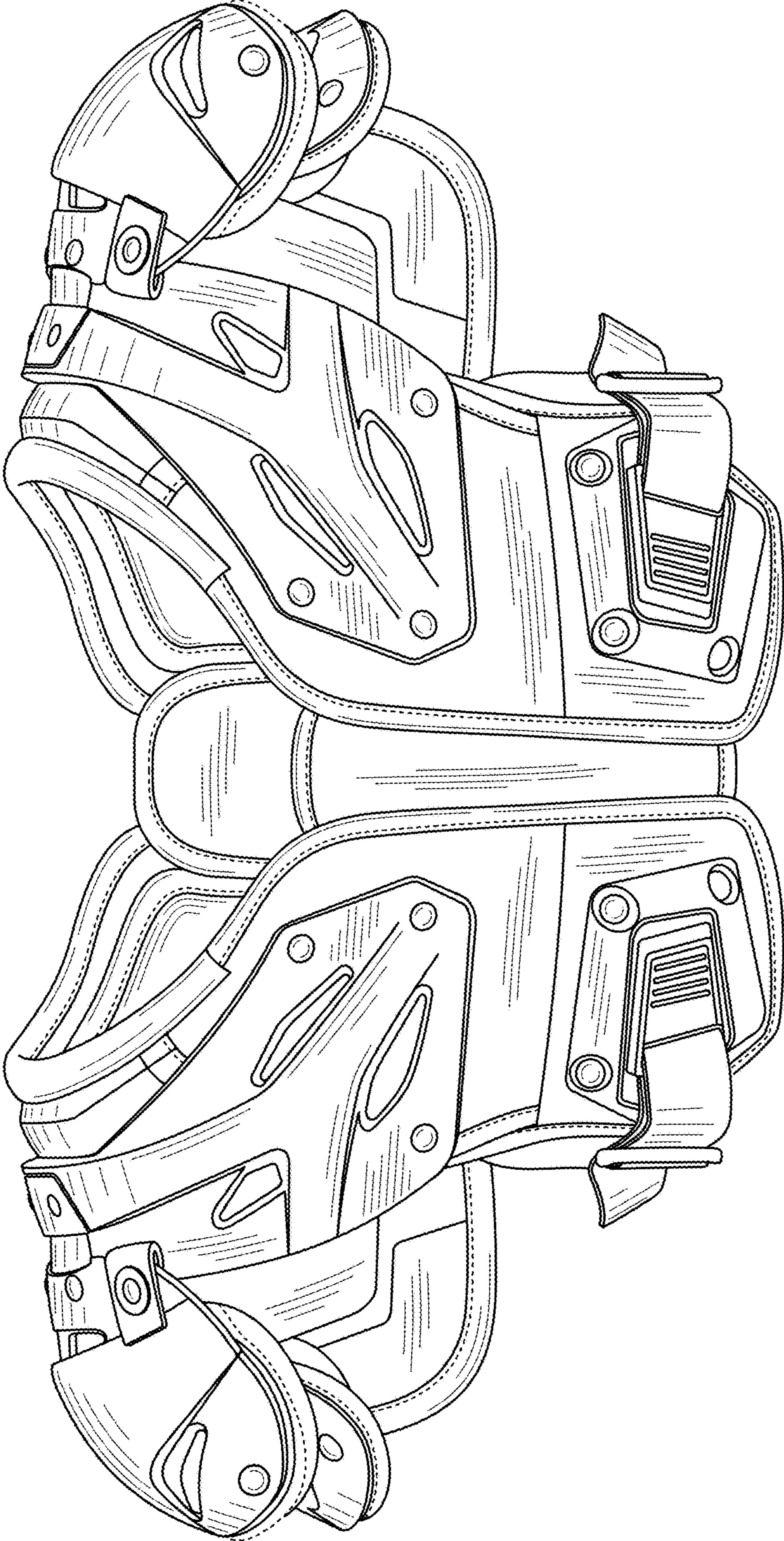

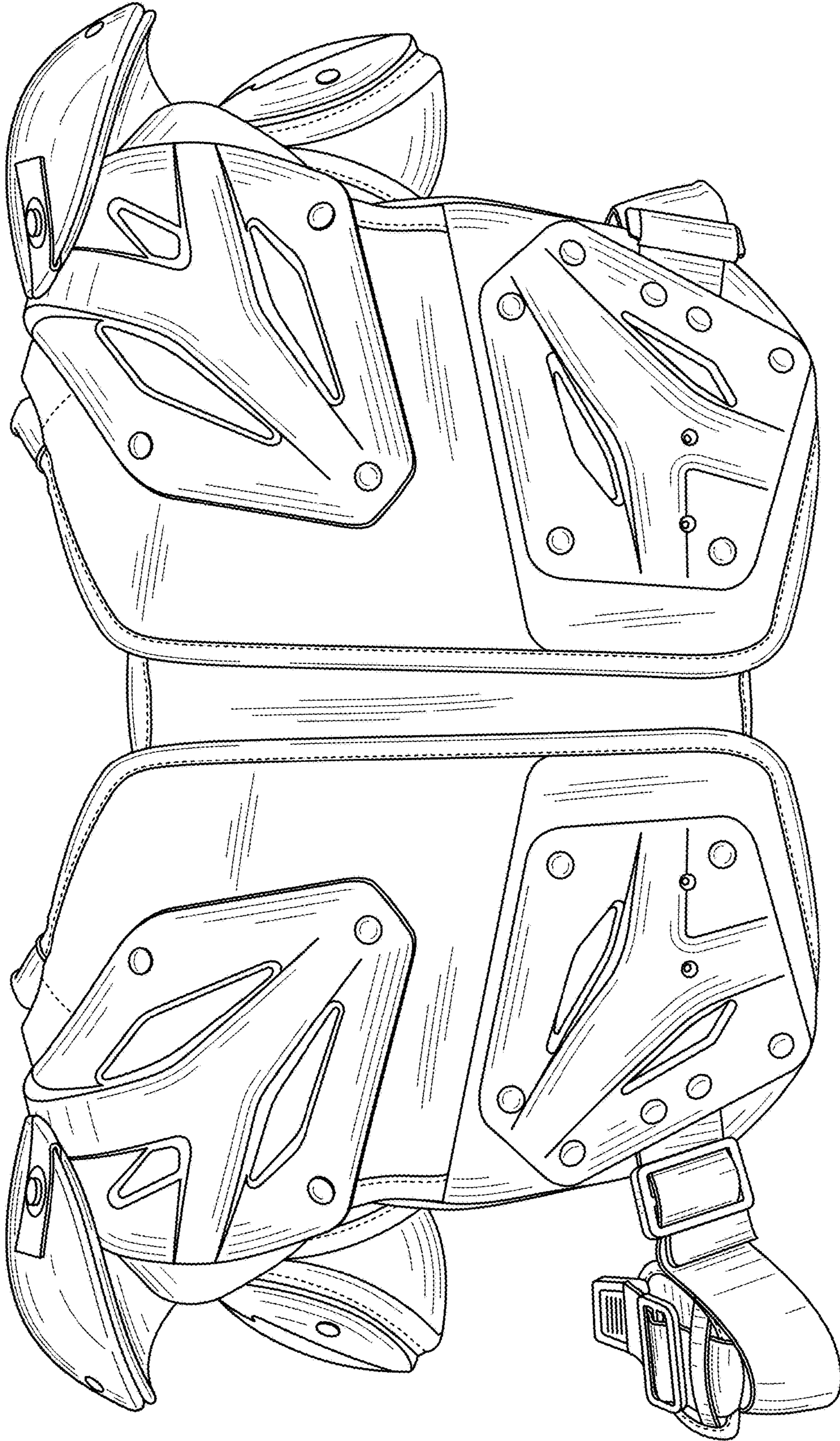

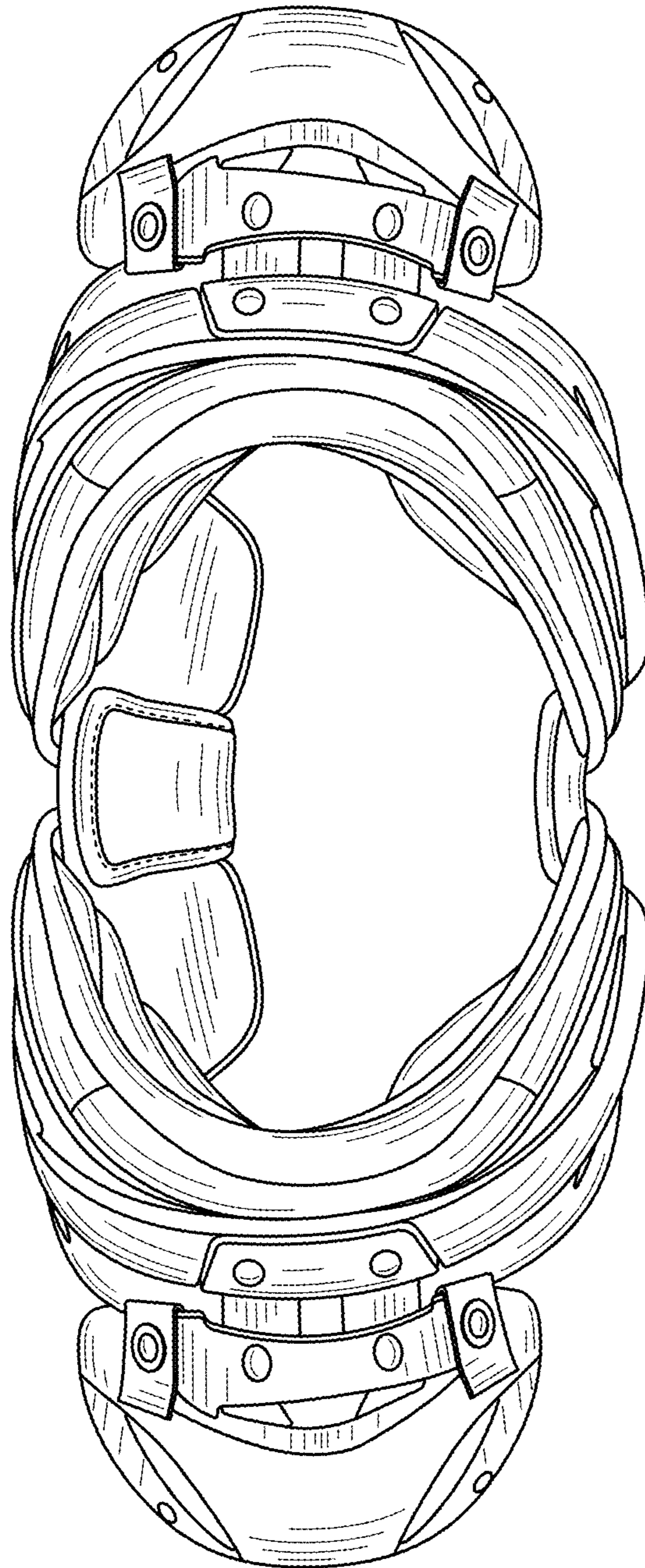

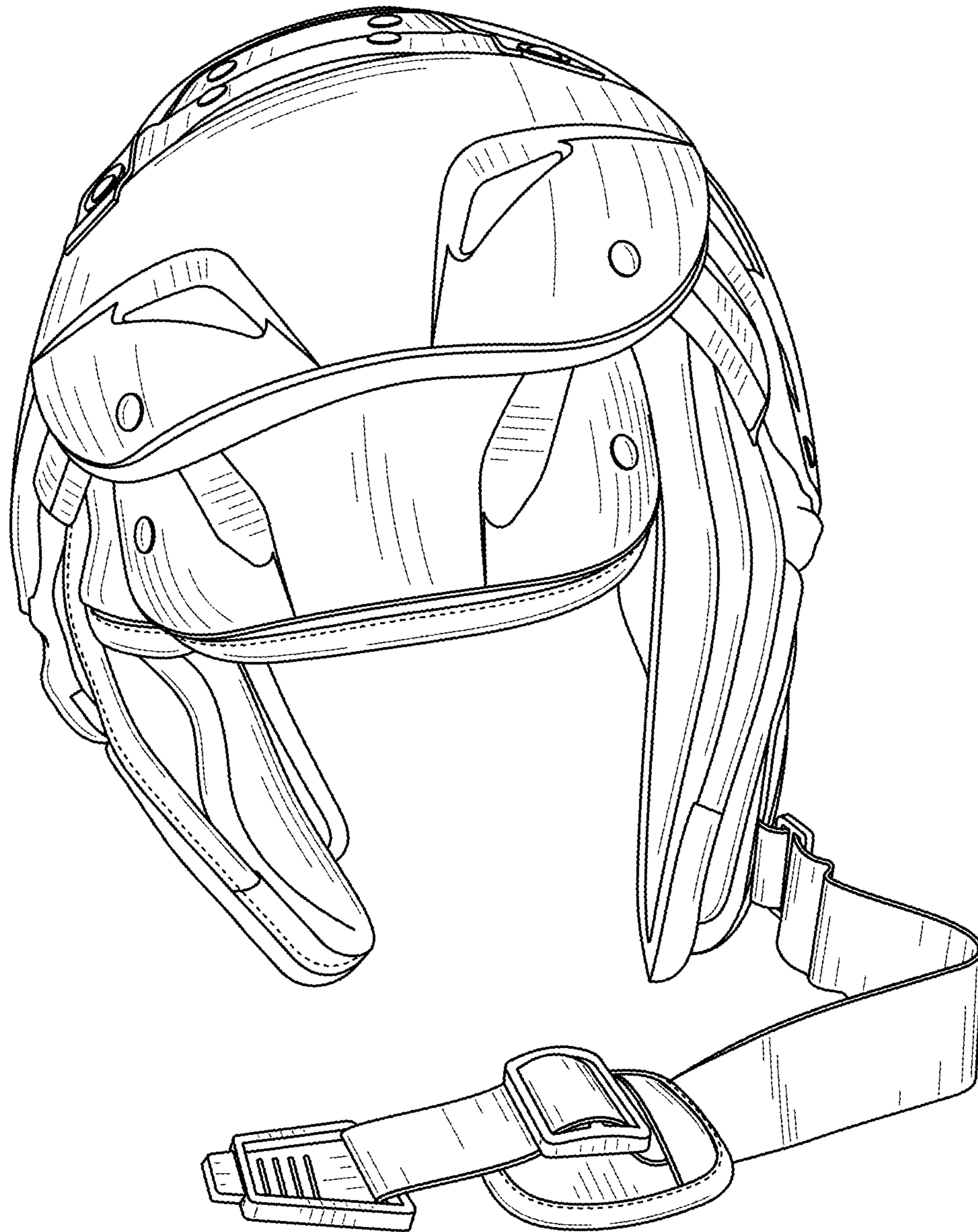

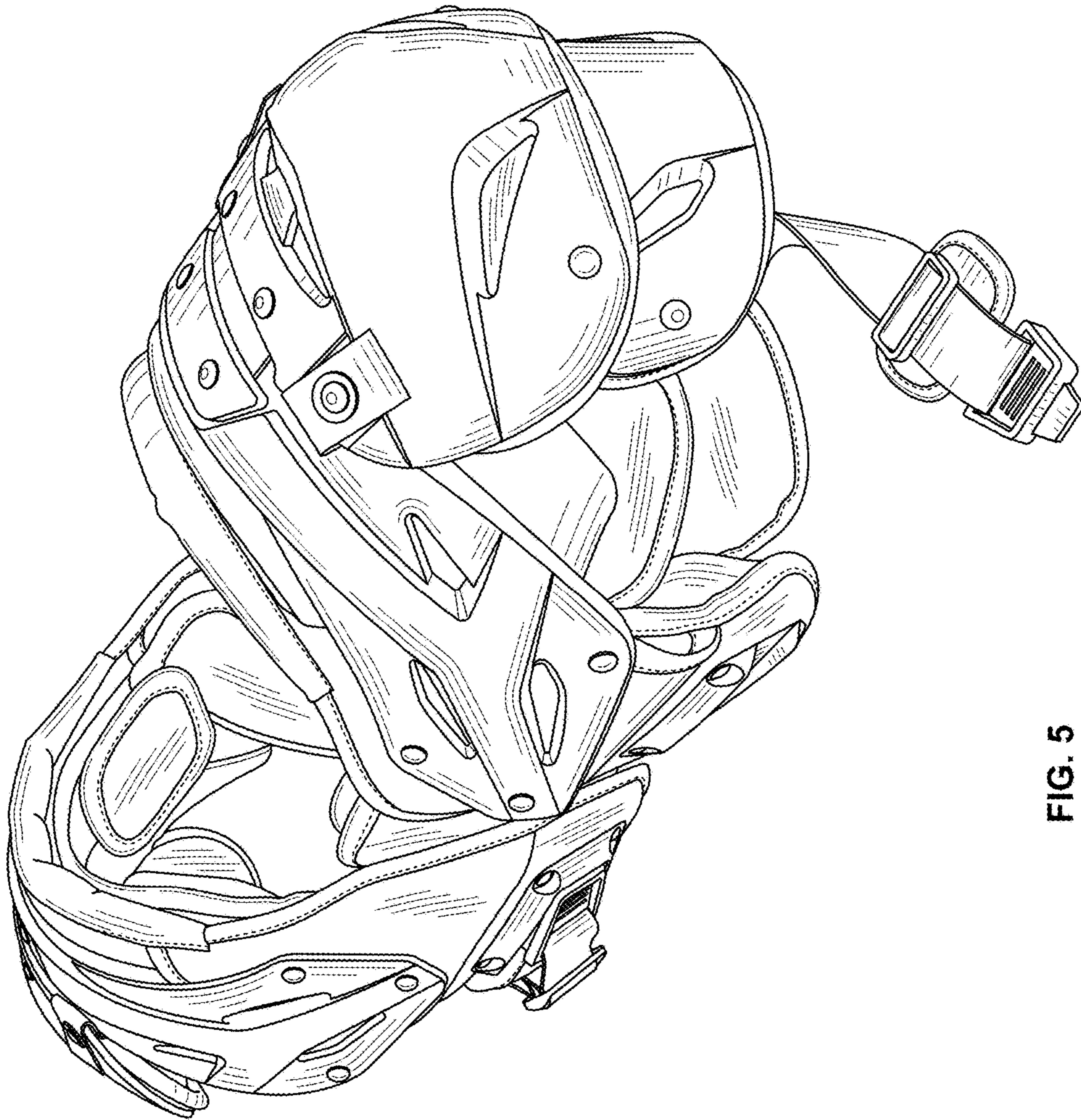

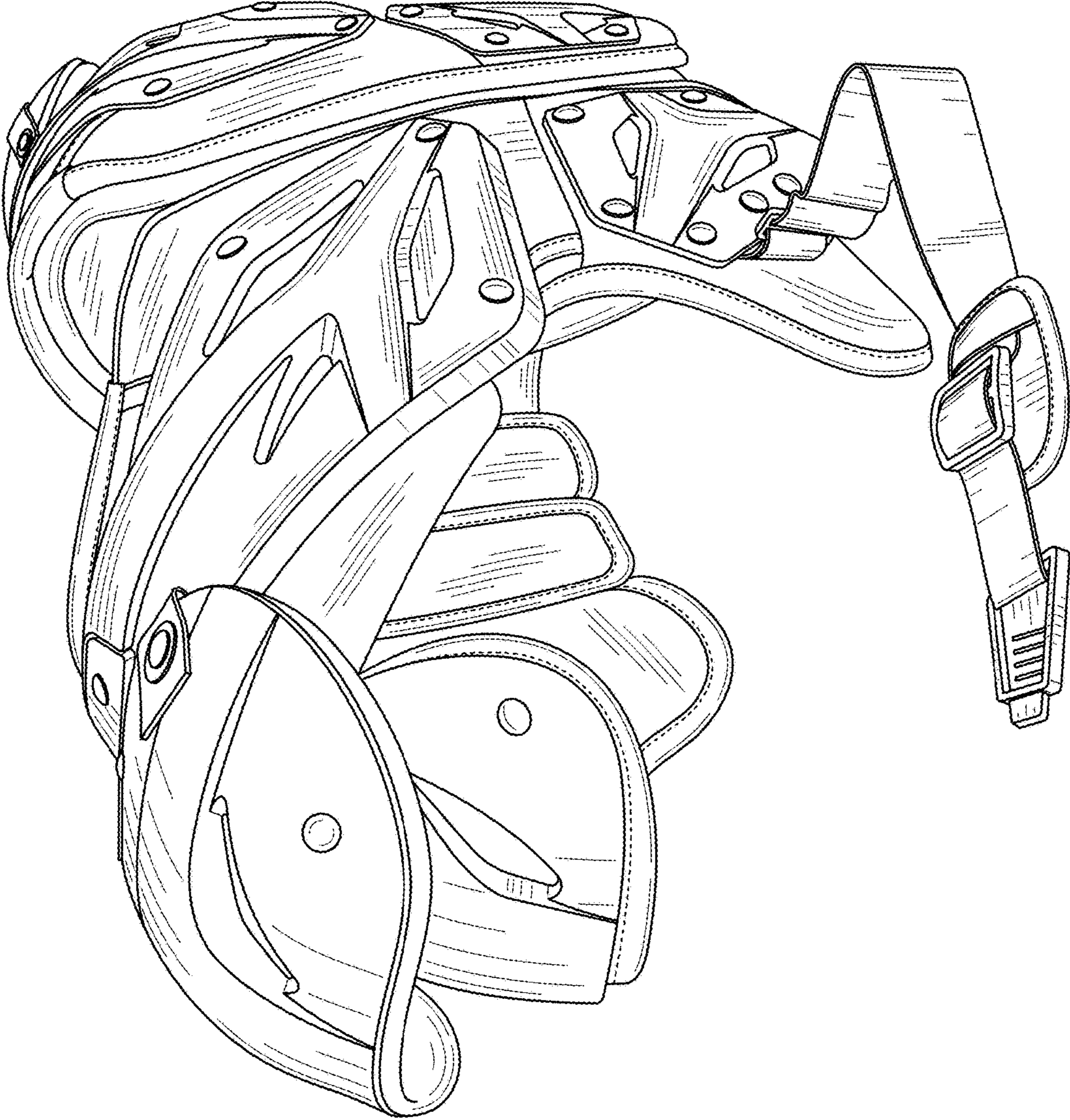
