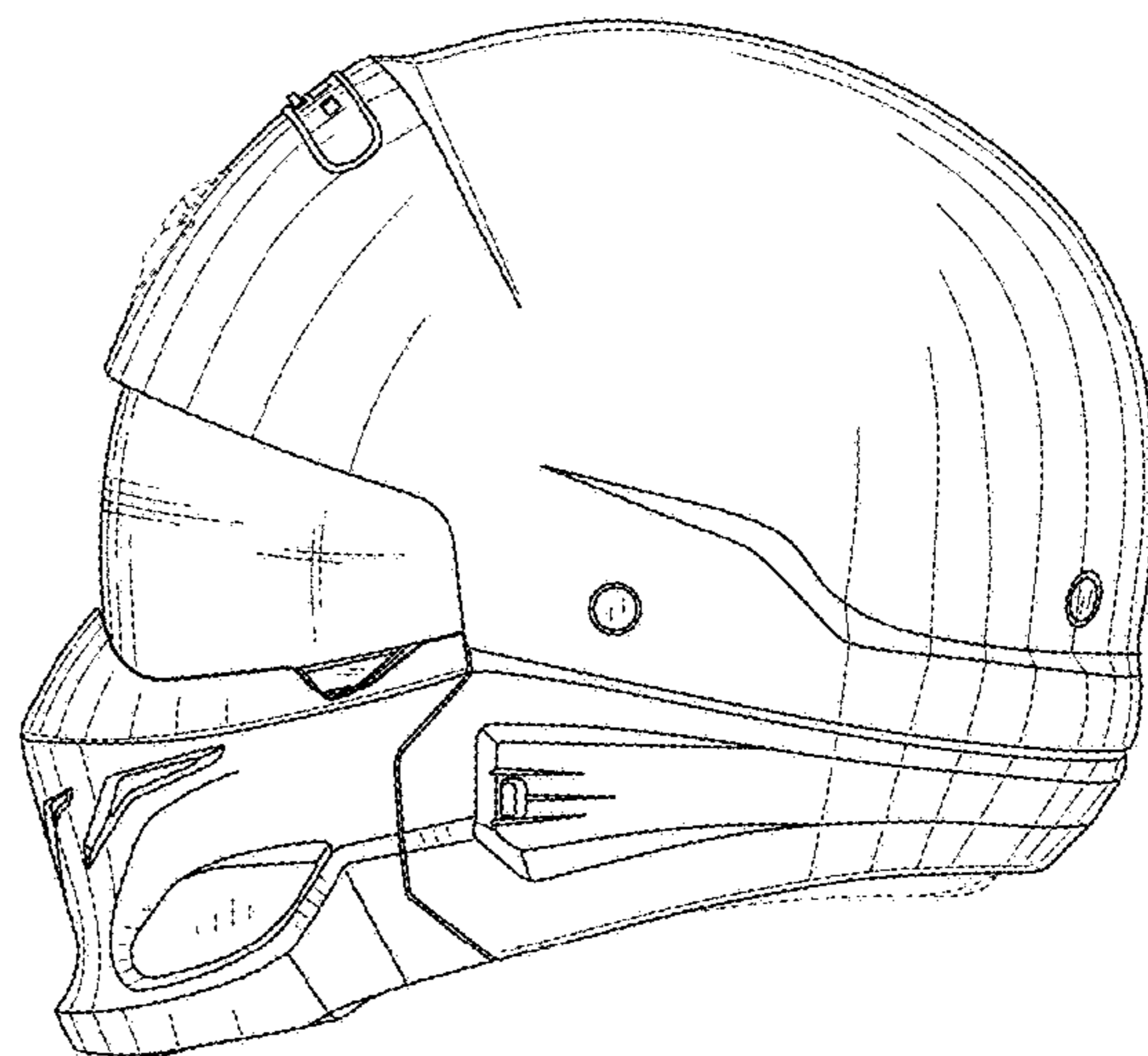
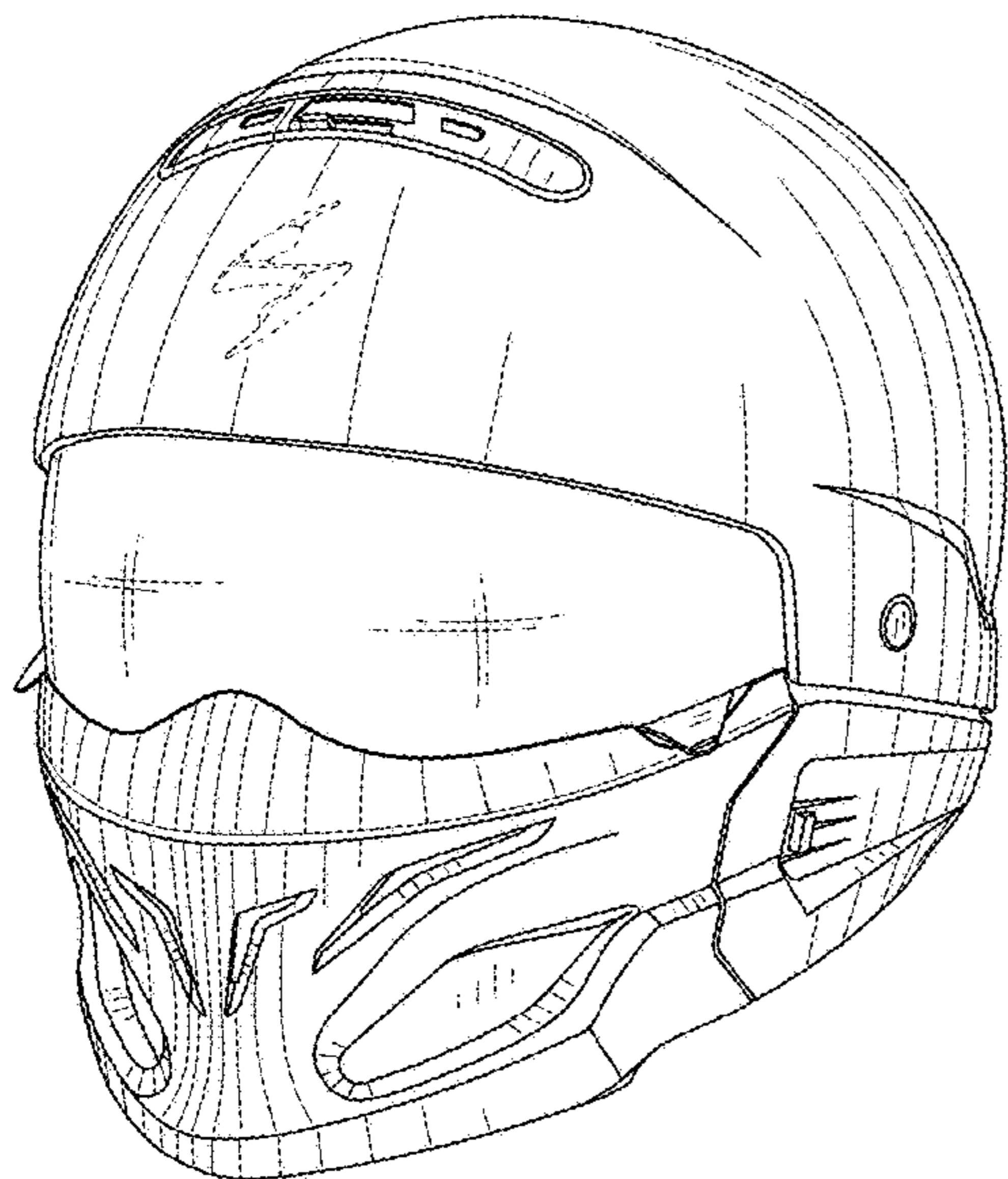
(57) **CLAIM**

I claim the ornamental design for a helmet, as shown and described.

DESCRIPTION

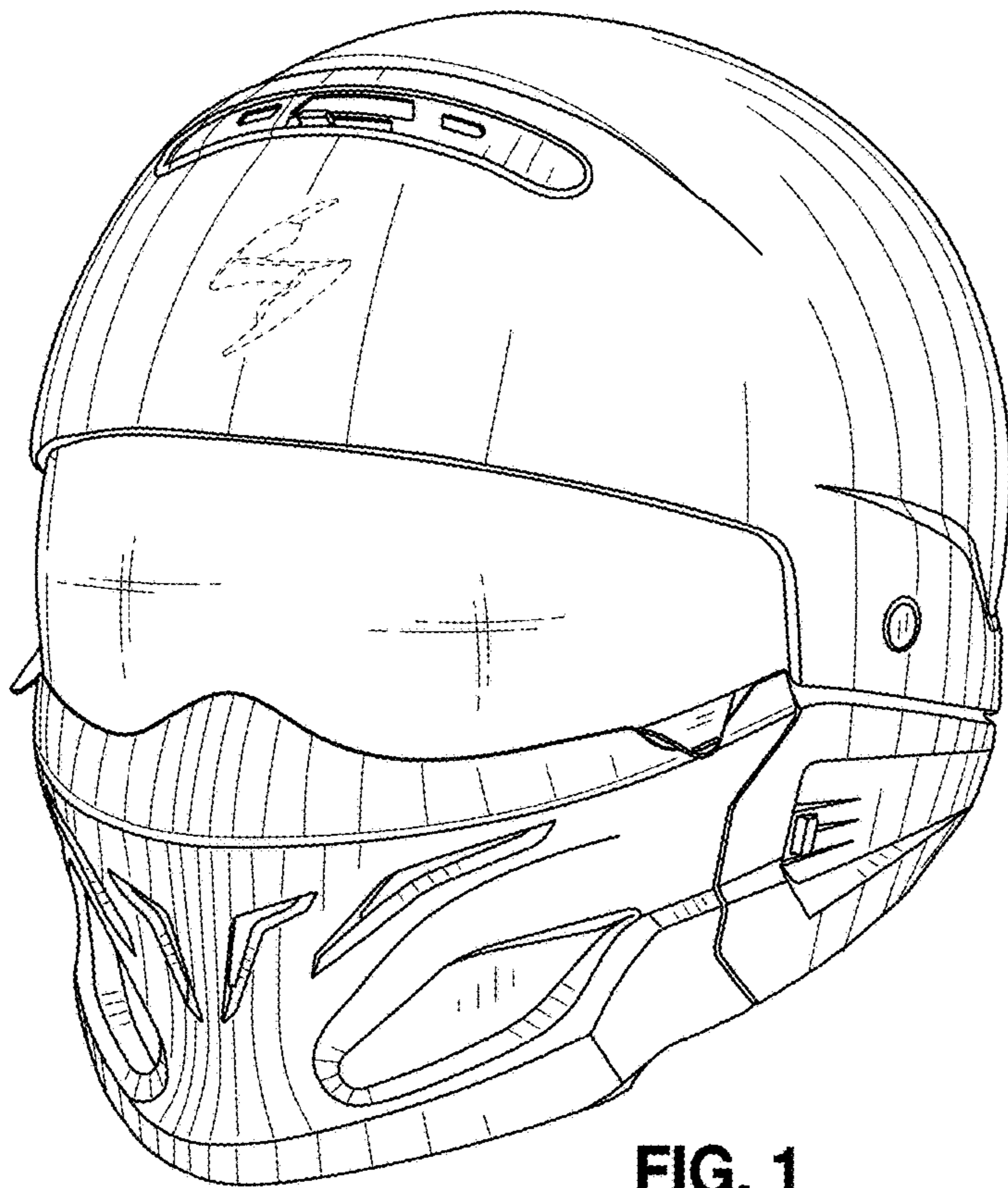

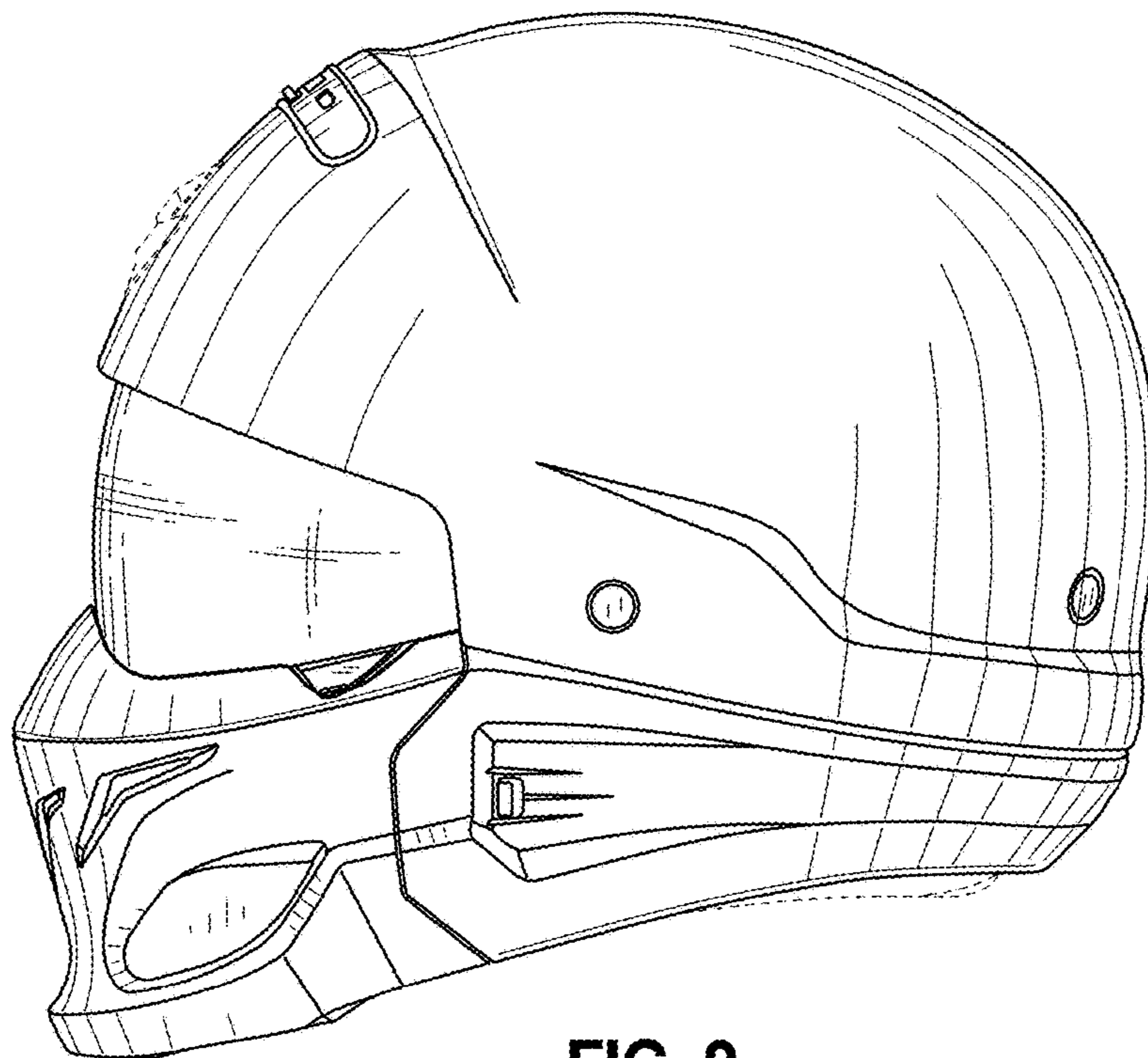

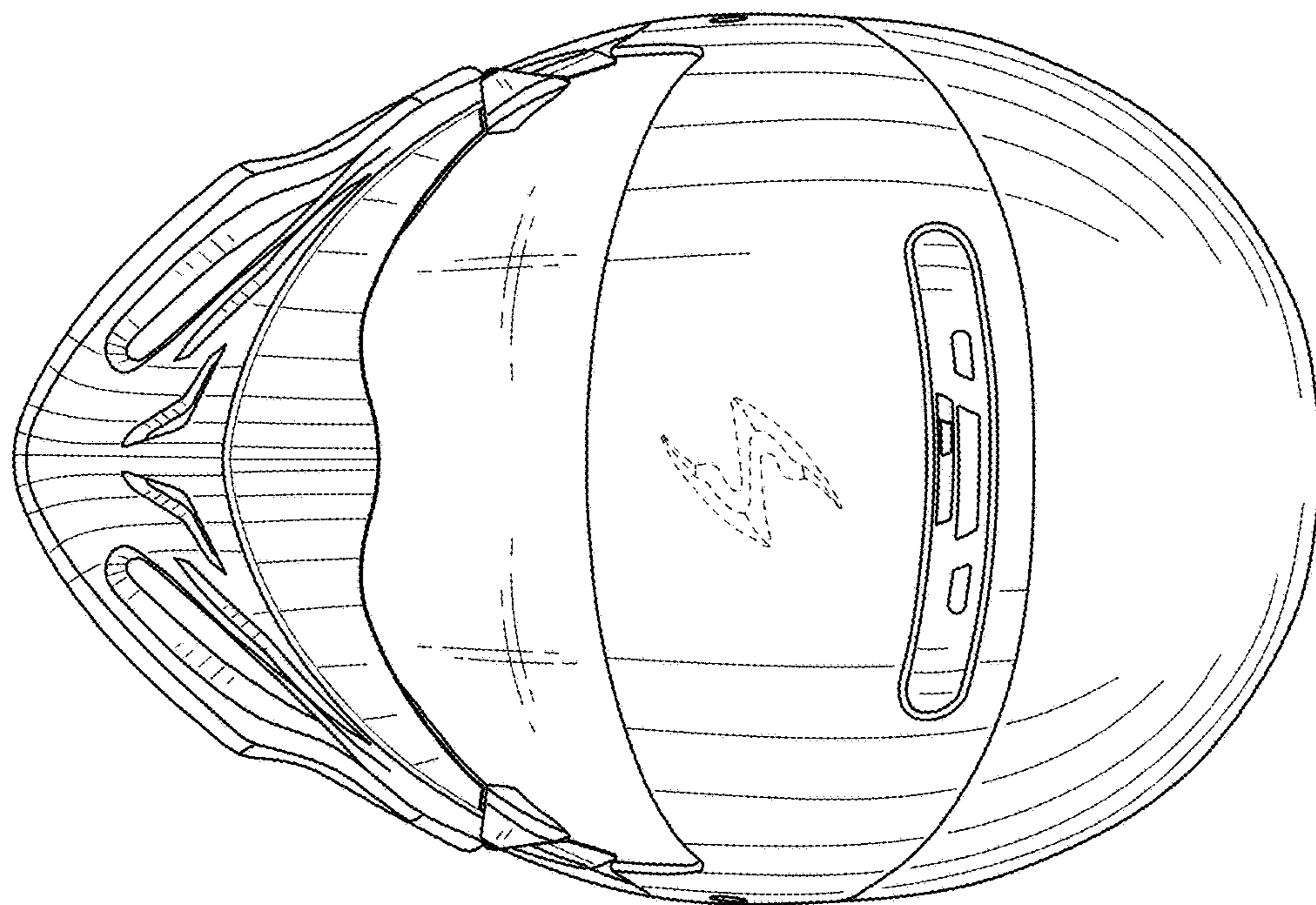

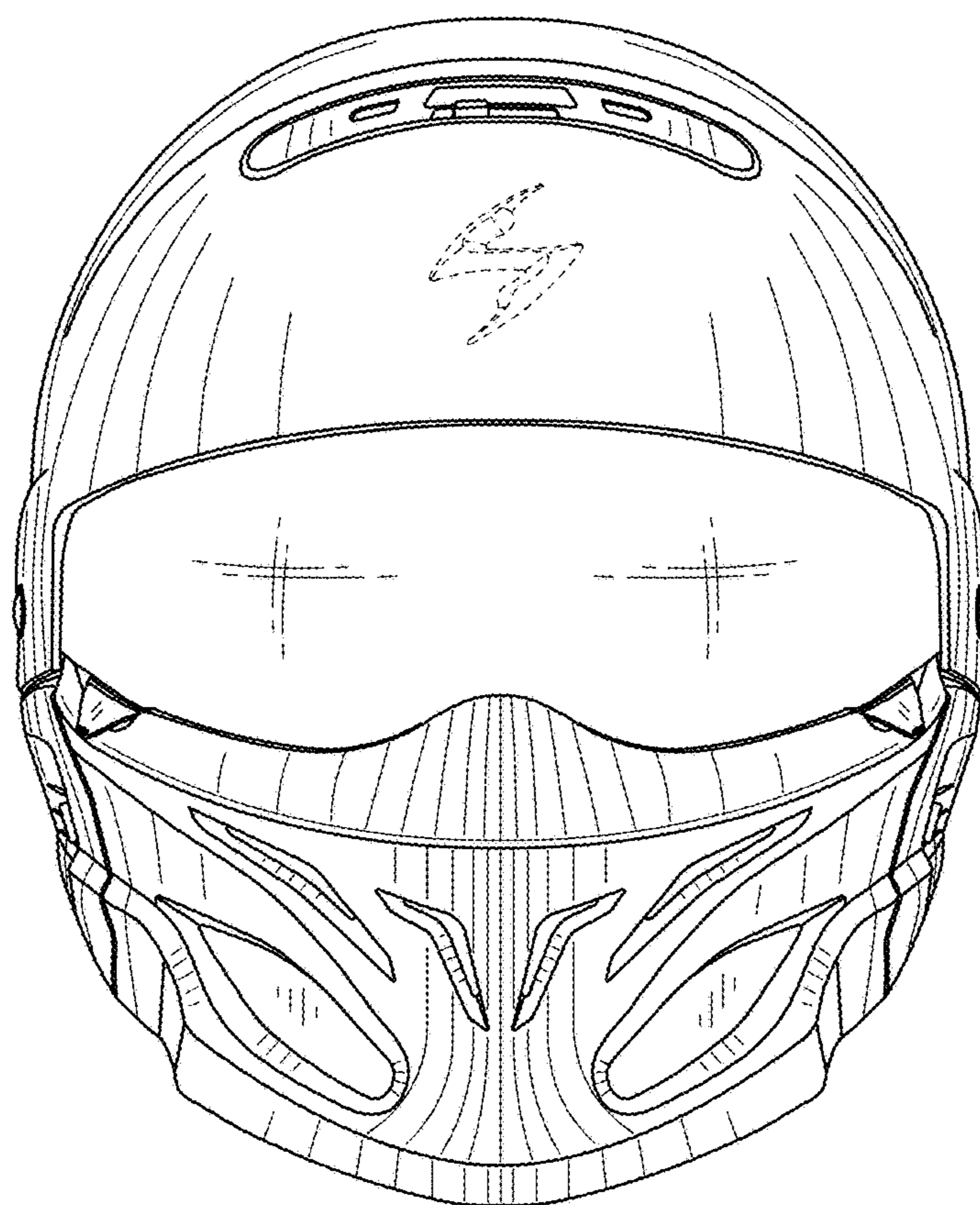

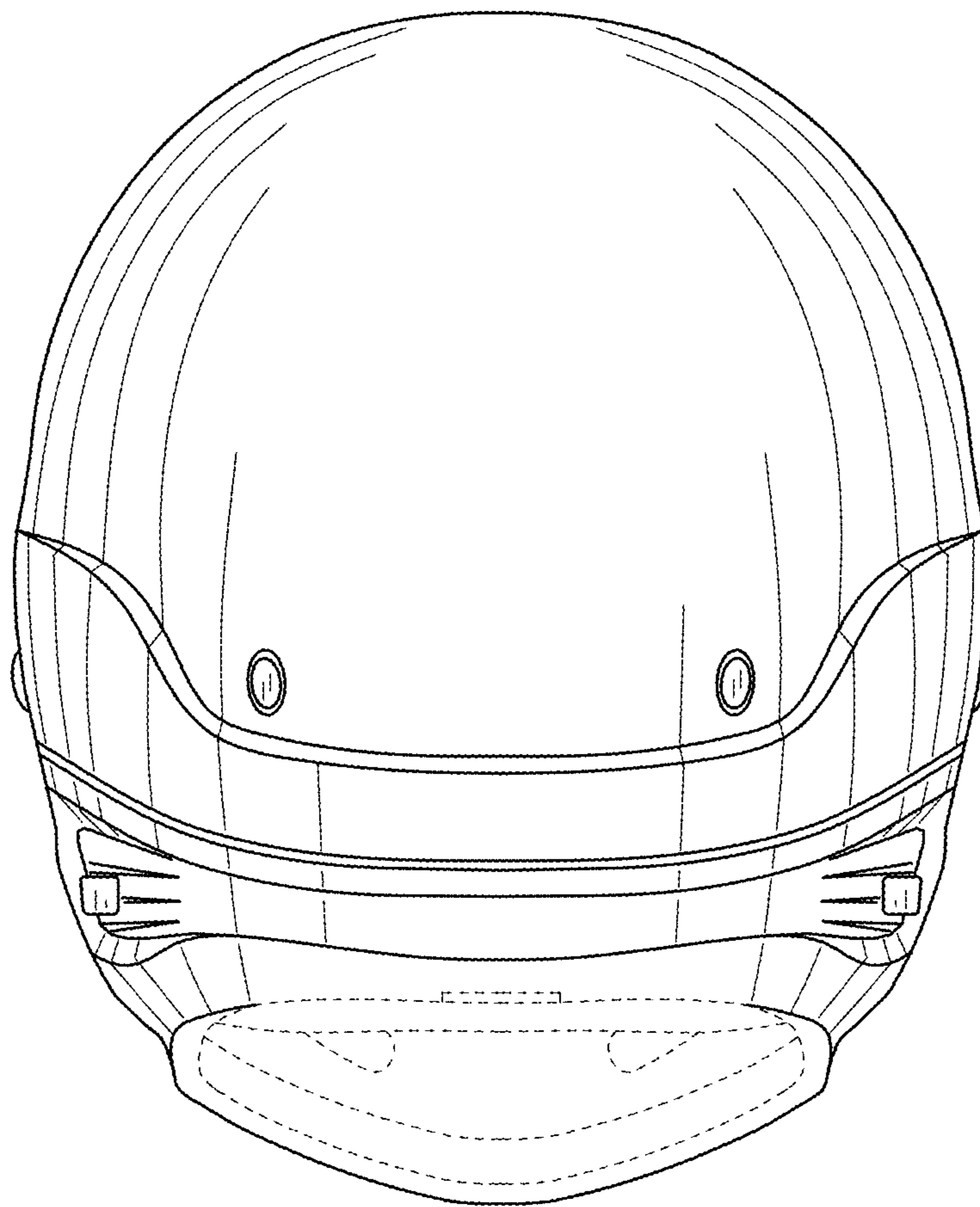
