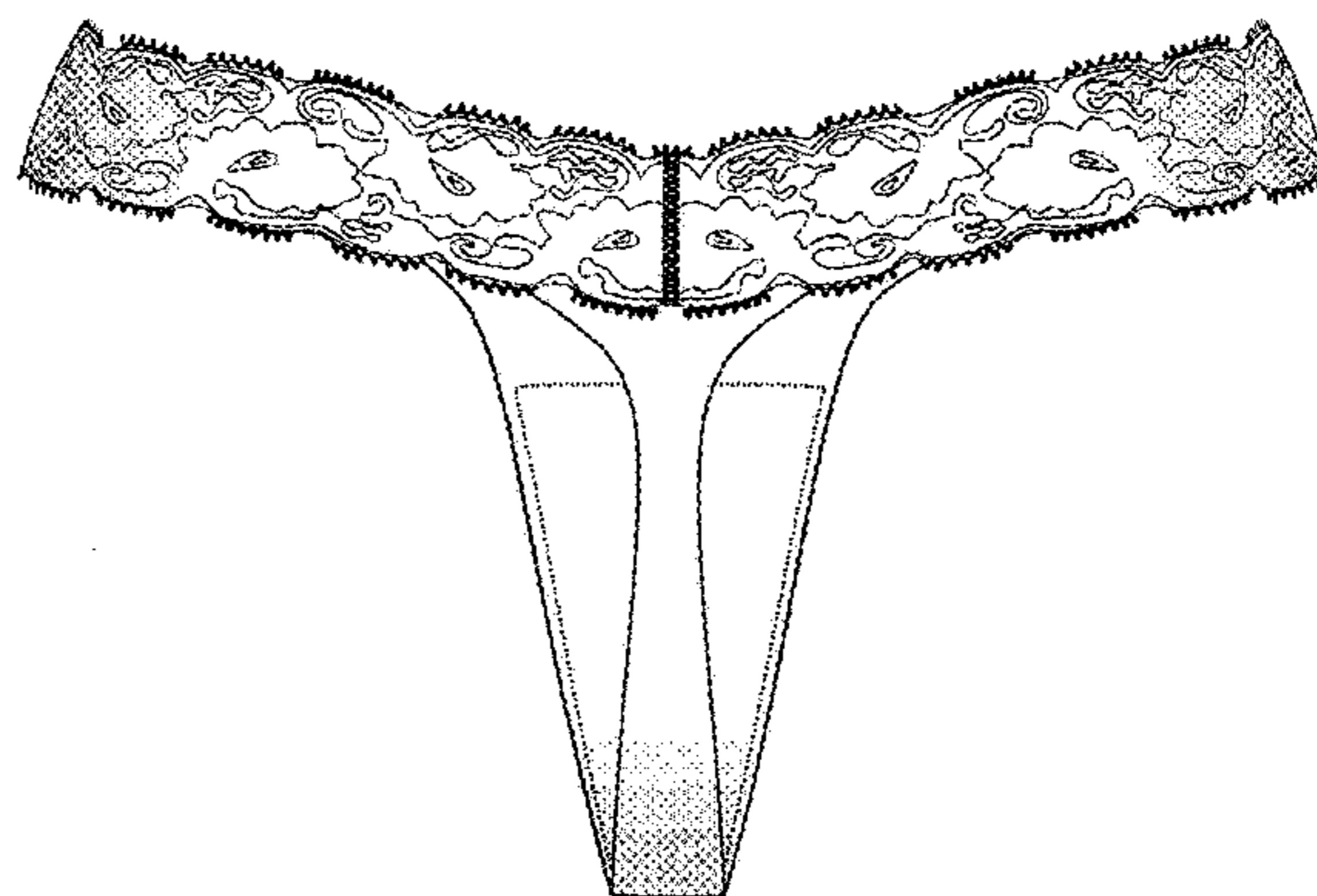
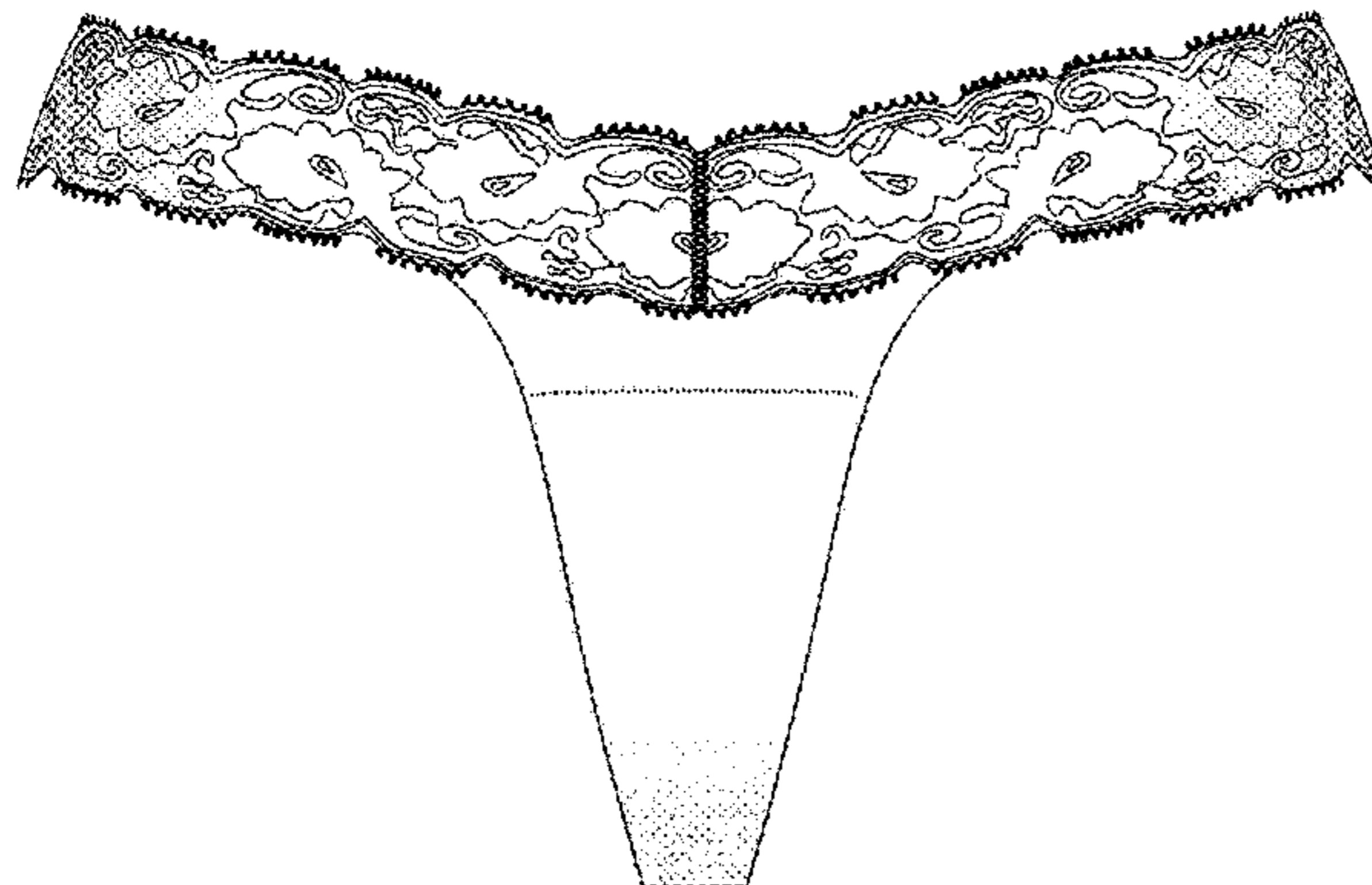
(57) **CLAIM**

The ornamental design for a visual privacy garment, as shown and described.

DESCRIPTION

FIG. 1 is a front plan view of the visual privacy garment; FIG. 2 is a rear plan view thereof; FIG. 3 is a right side perspective view thereof; FIG. 4 is a rear top perspective view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a top oblique perspective view thereof. The broken lines in the drawings represent stitching in the fabric.

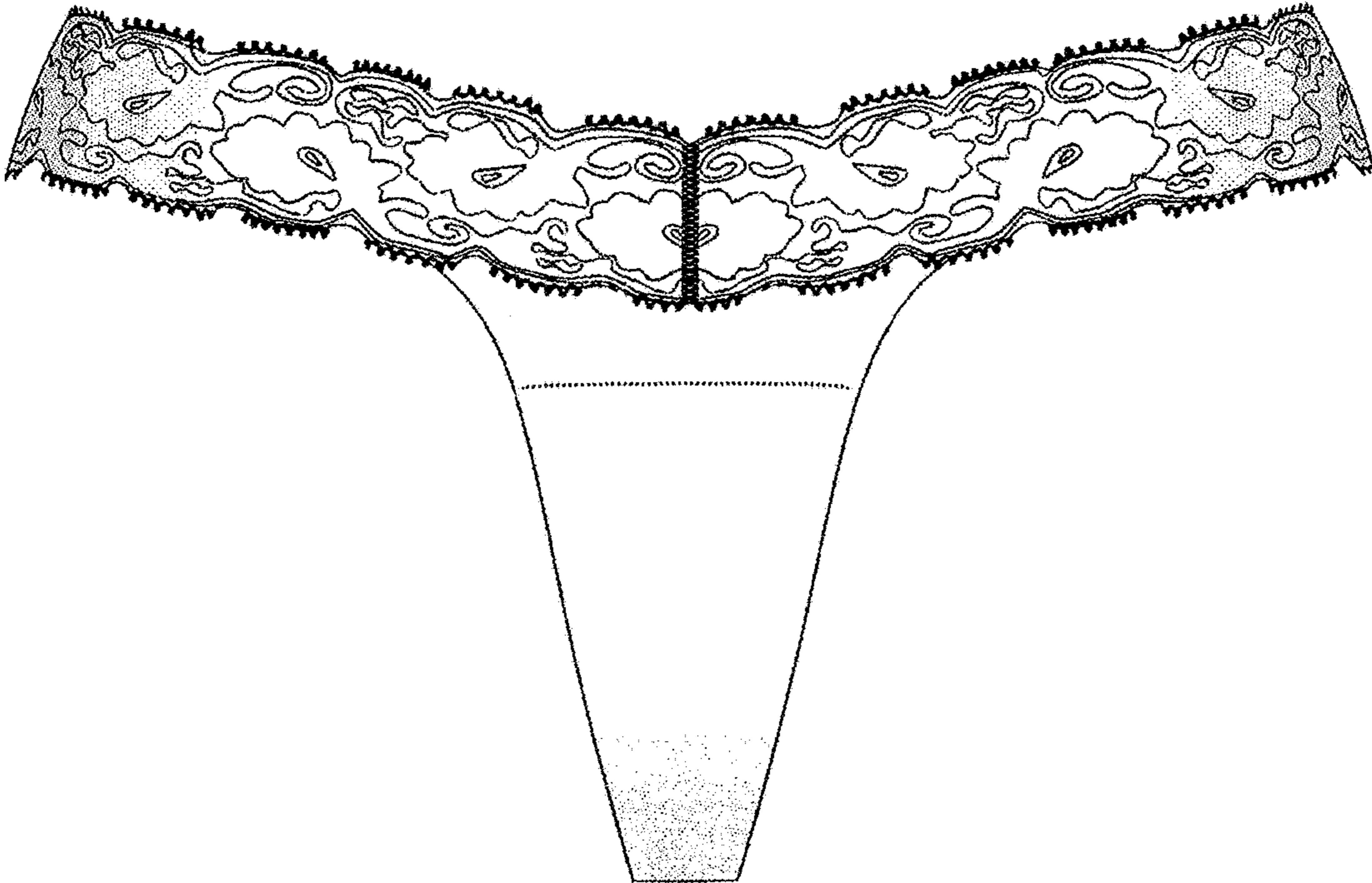

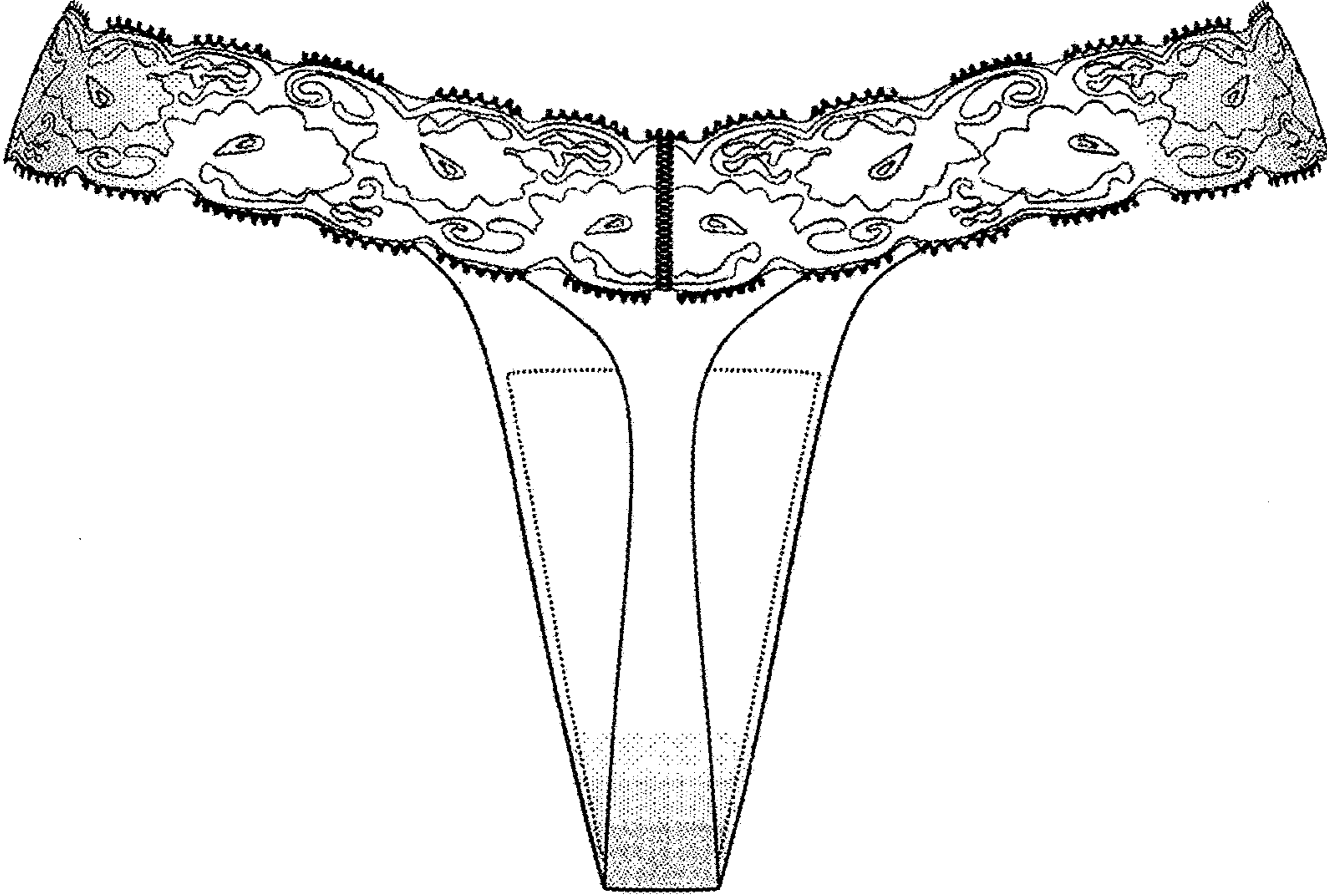

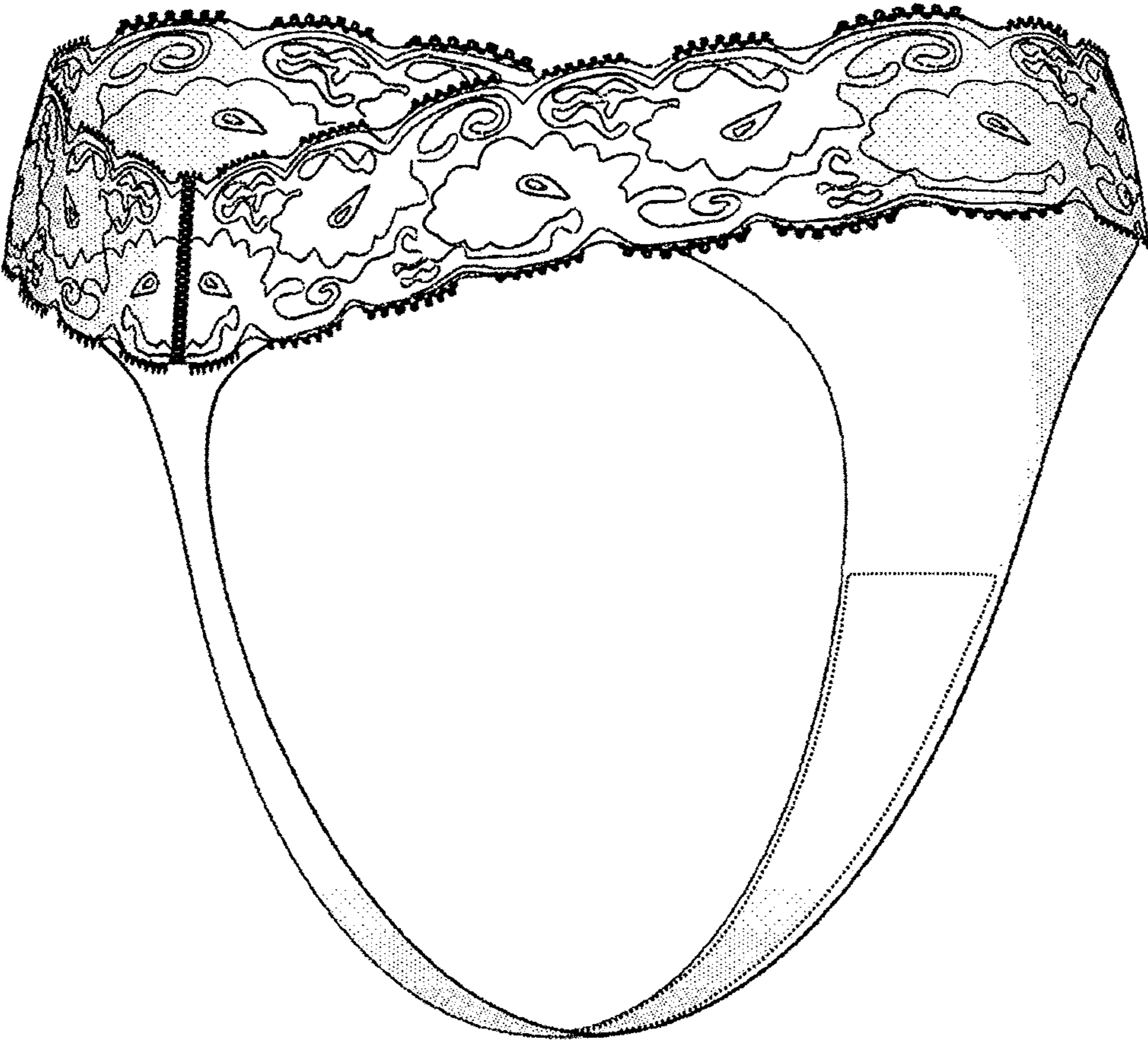

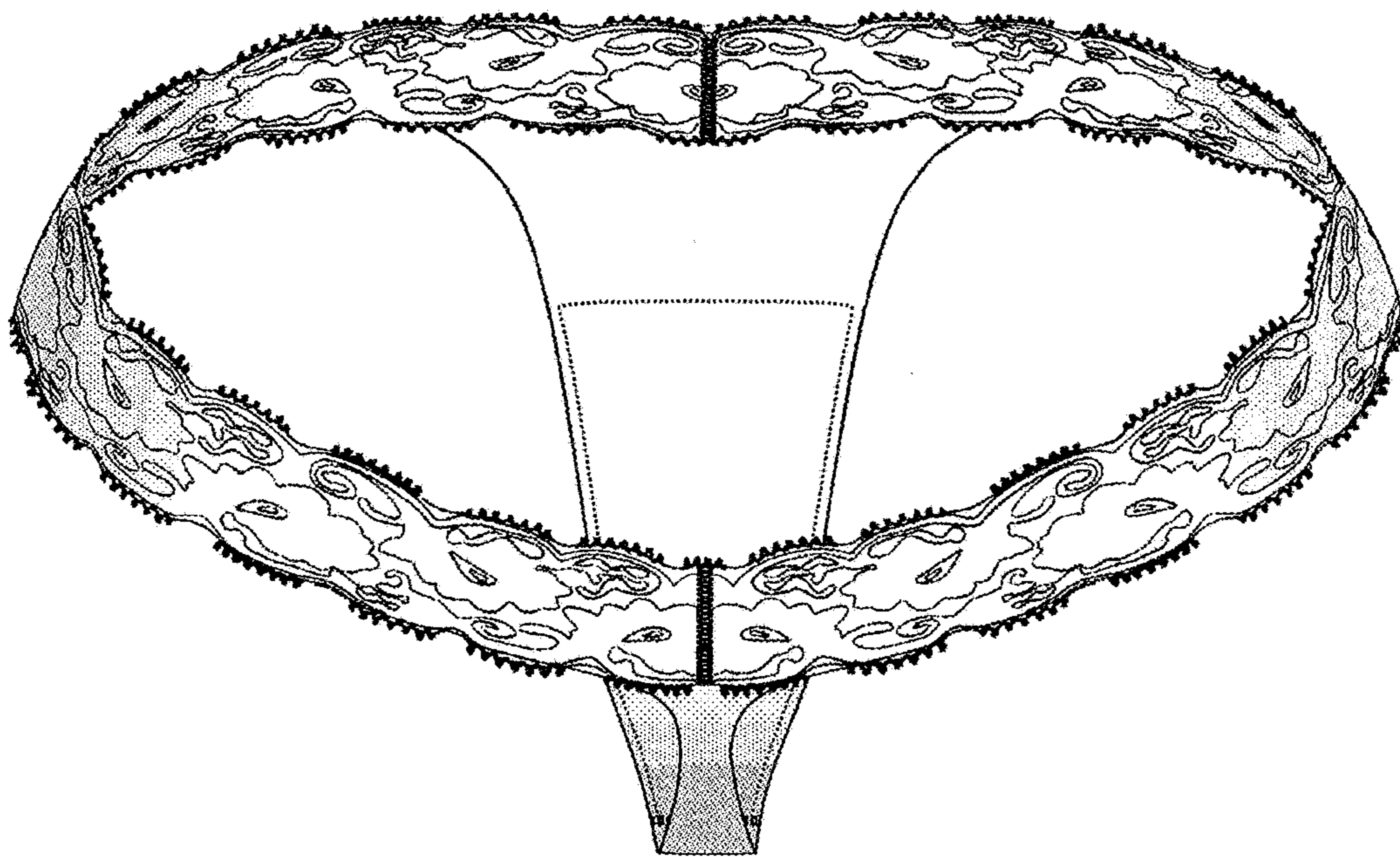

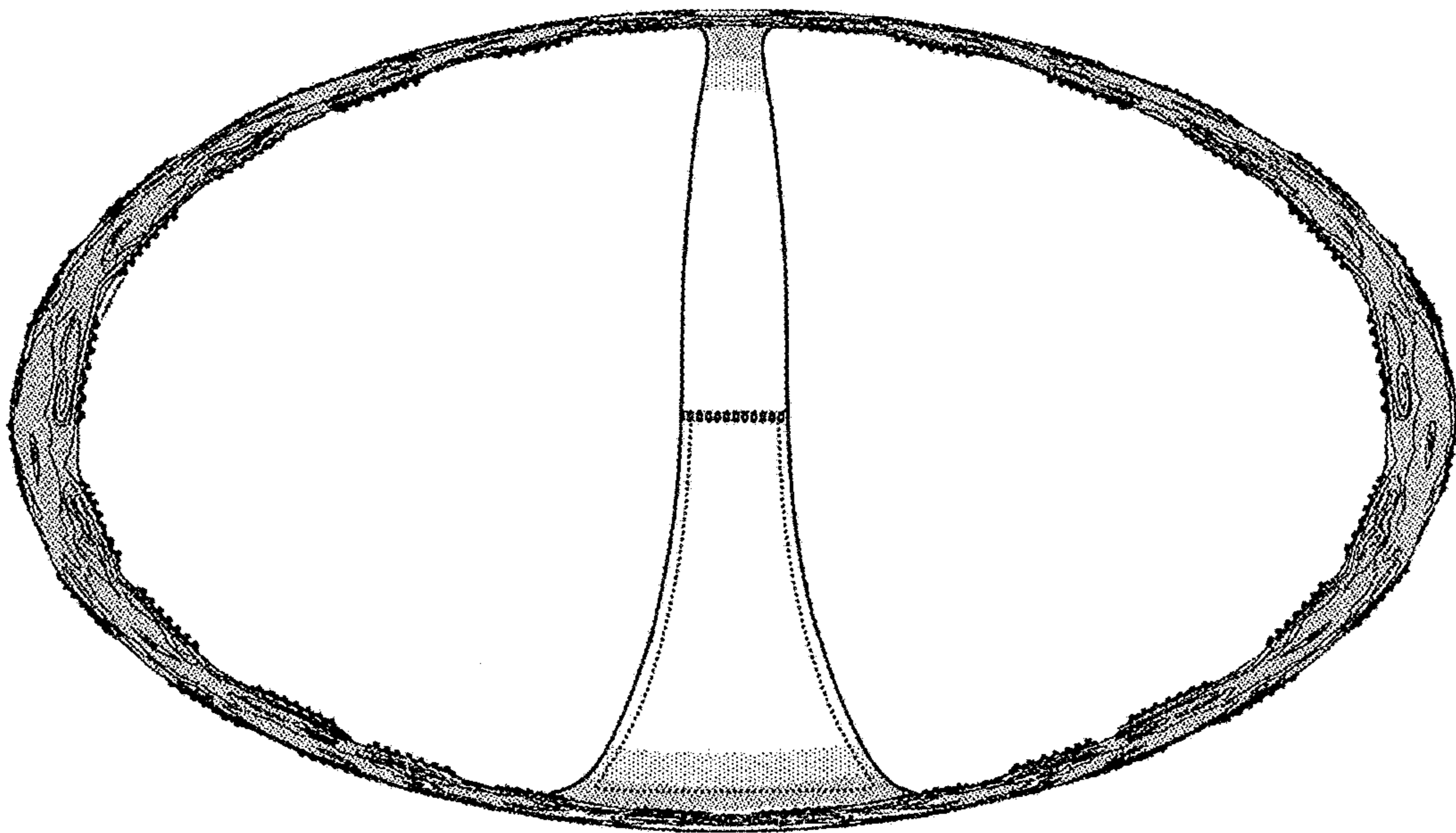
