DESCRIPTION

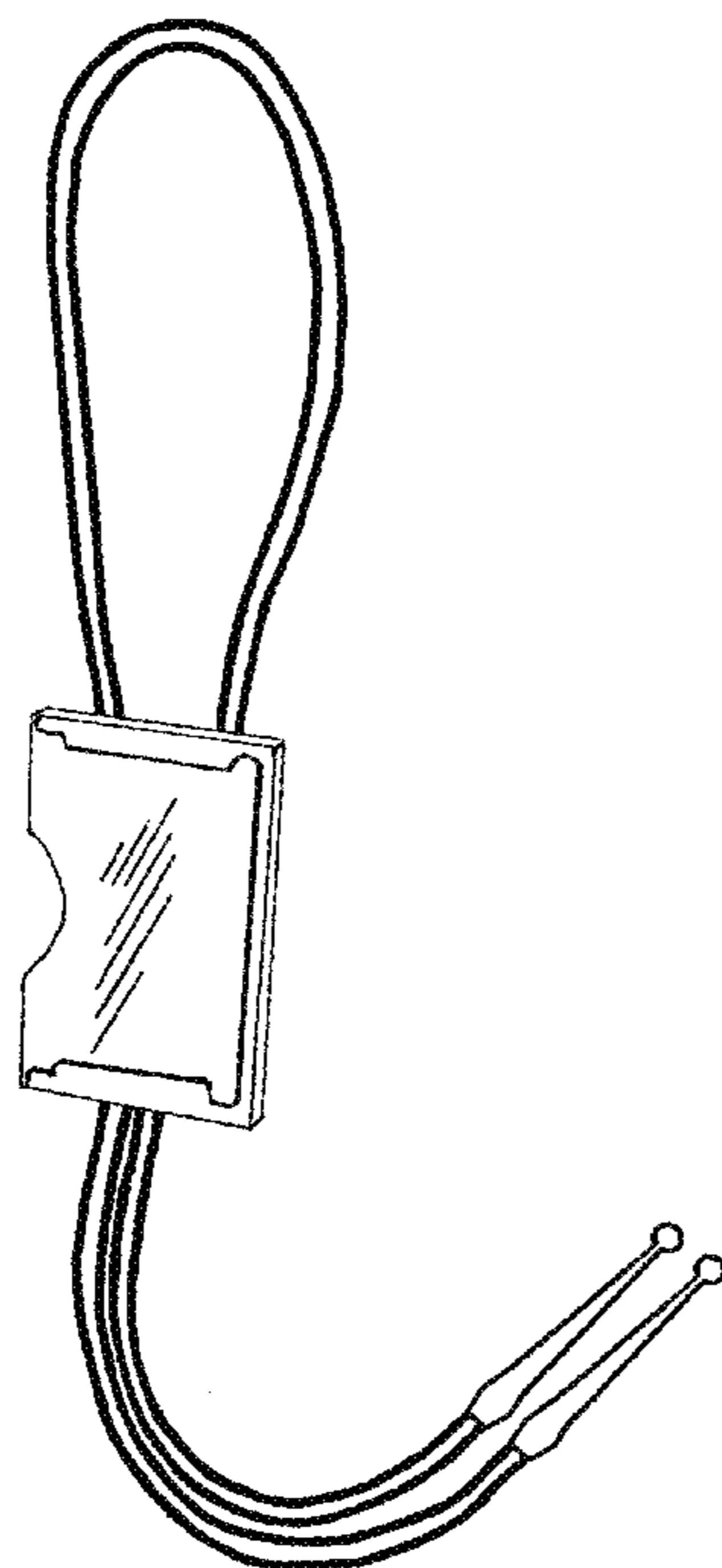
FIG. 1 is an upper perspective view of a bolo tie ID badge holder showing my new design.

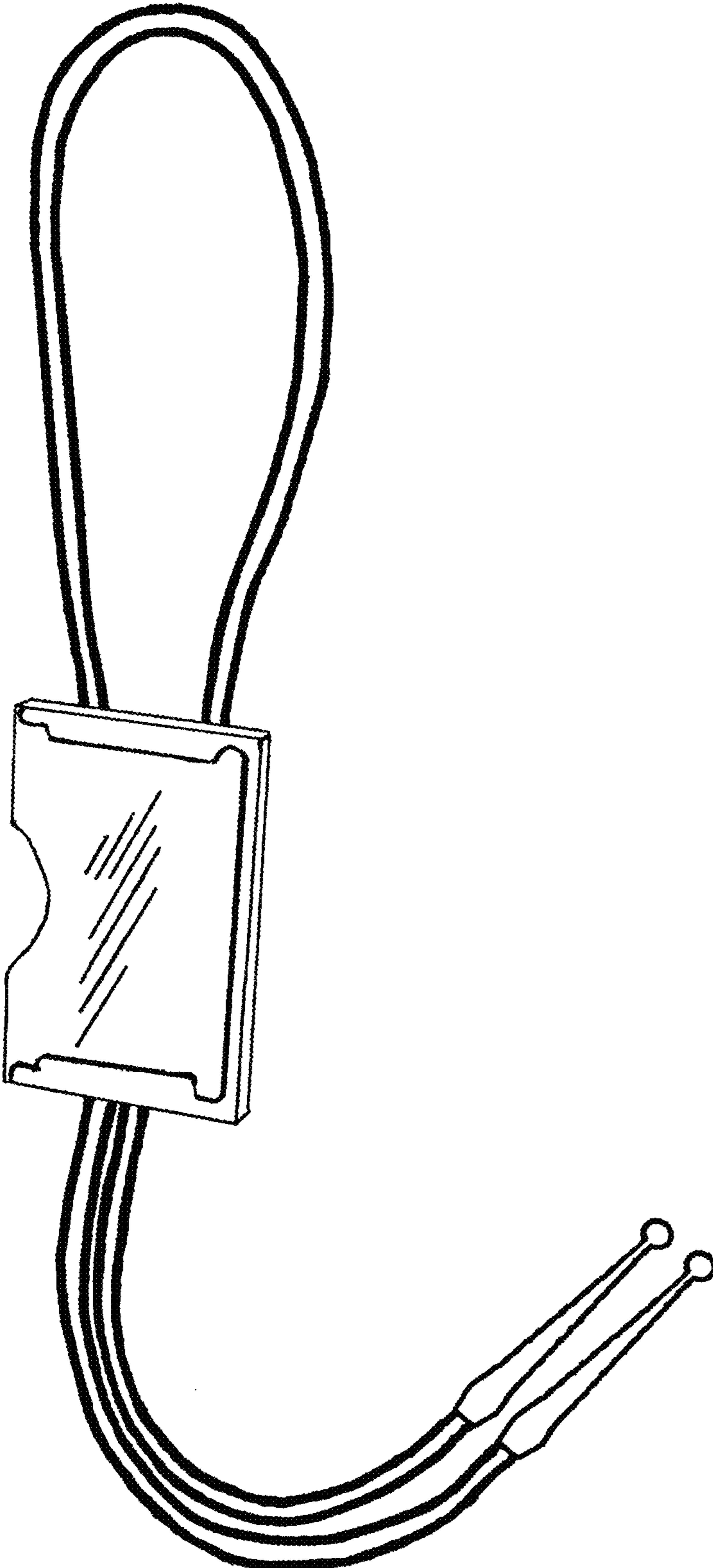

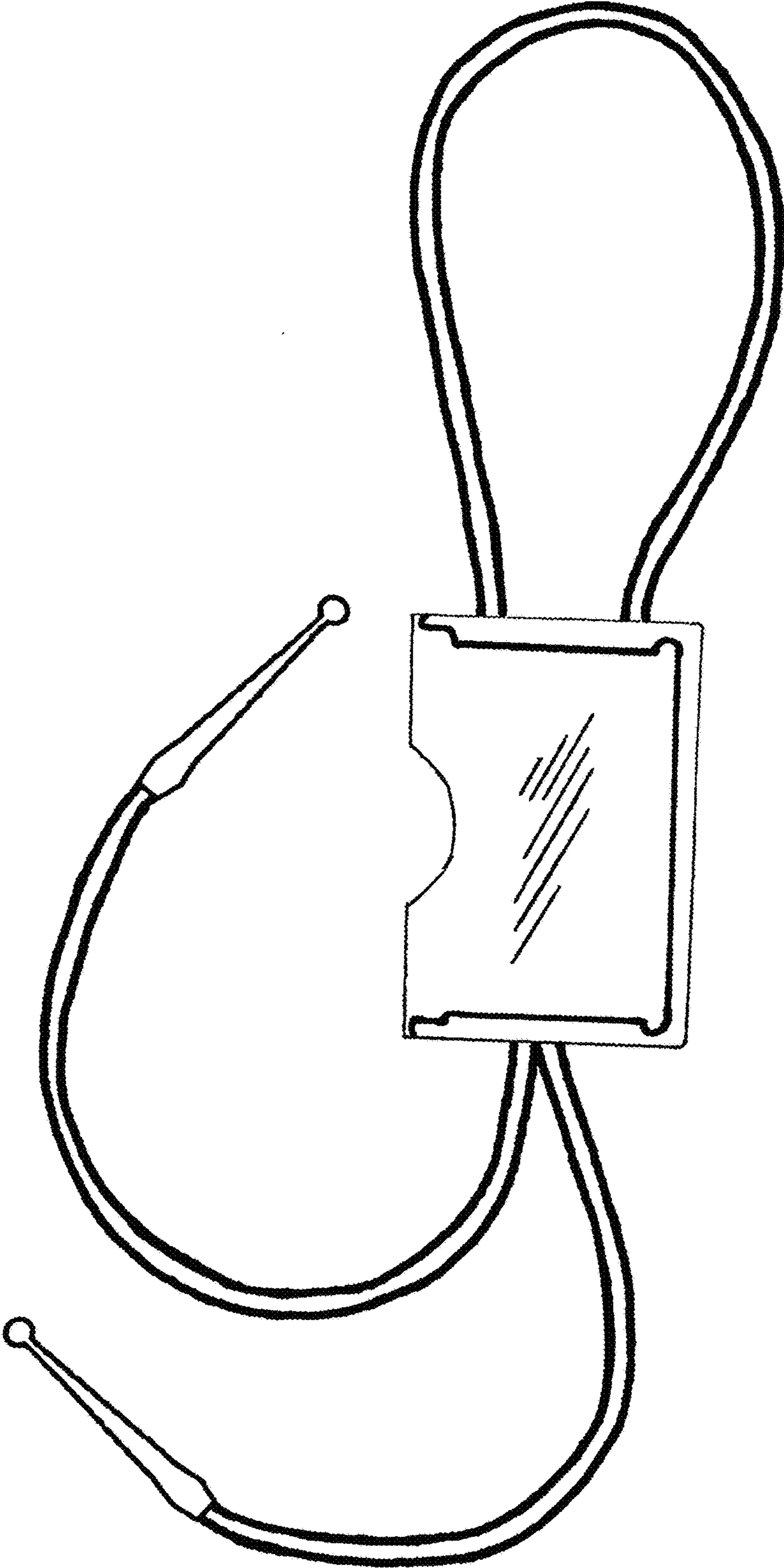

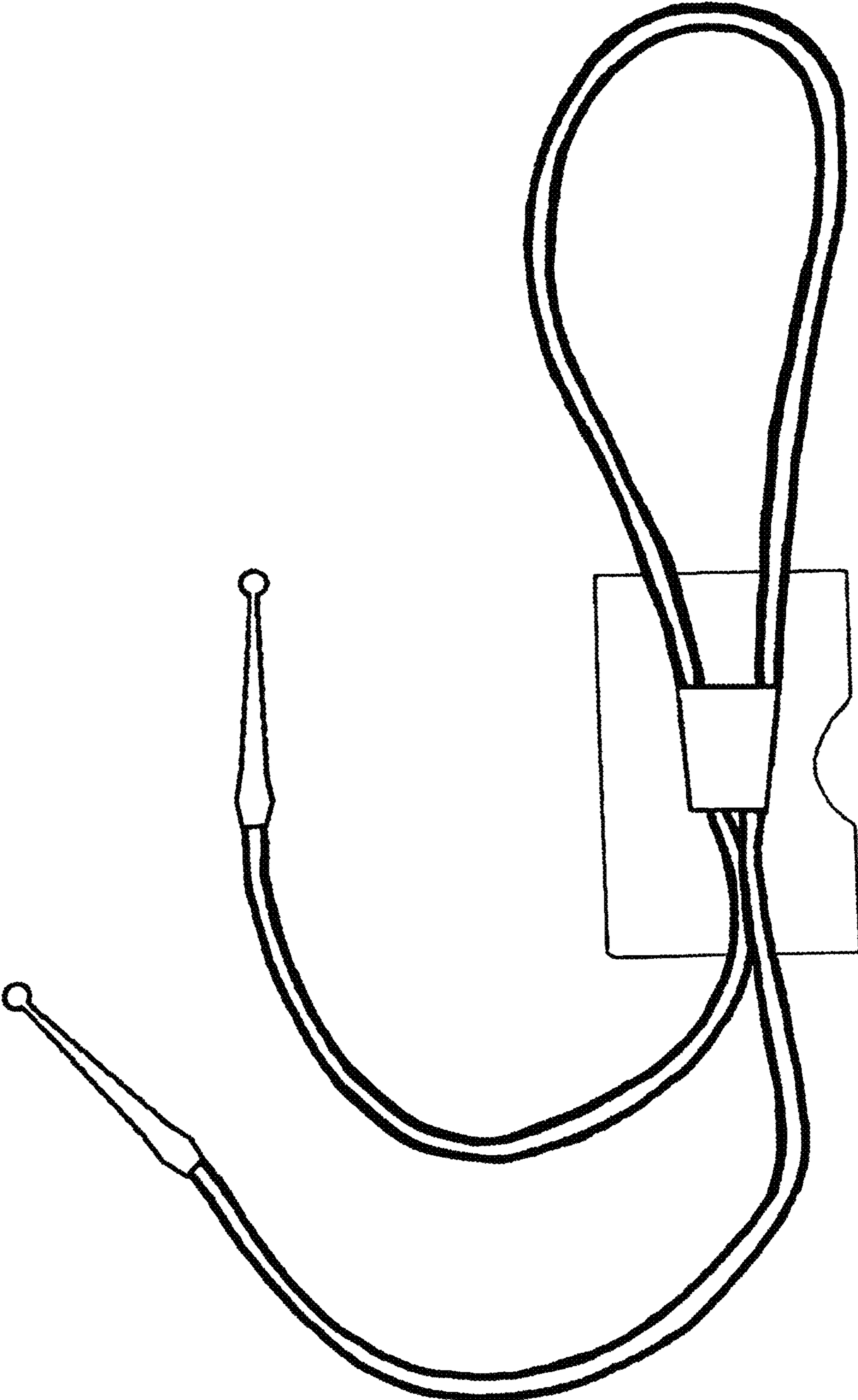

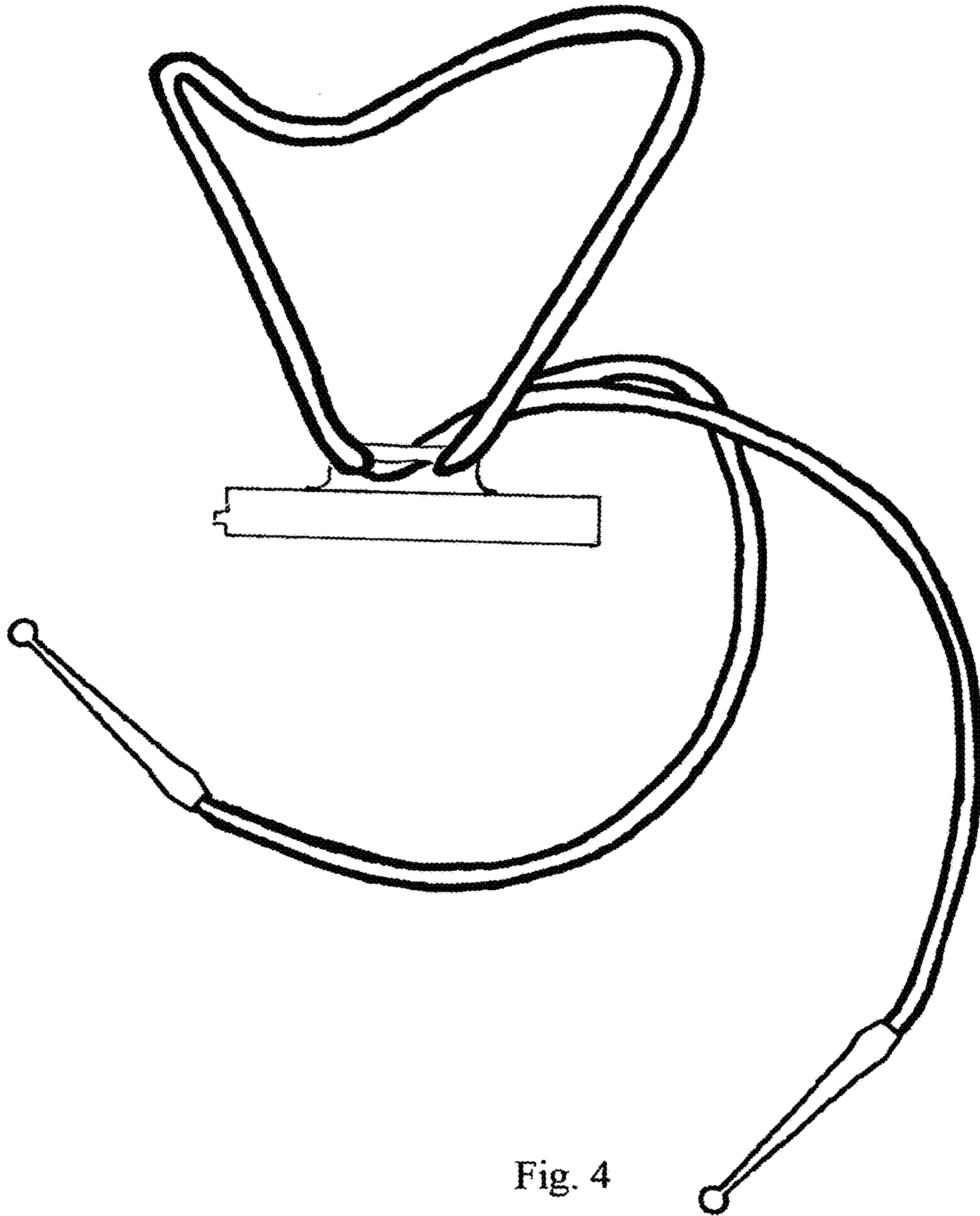

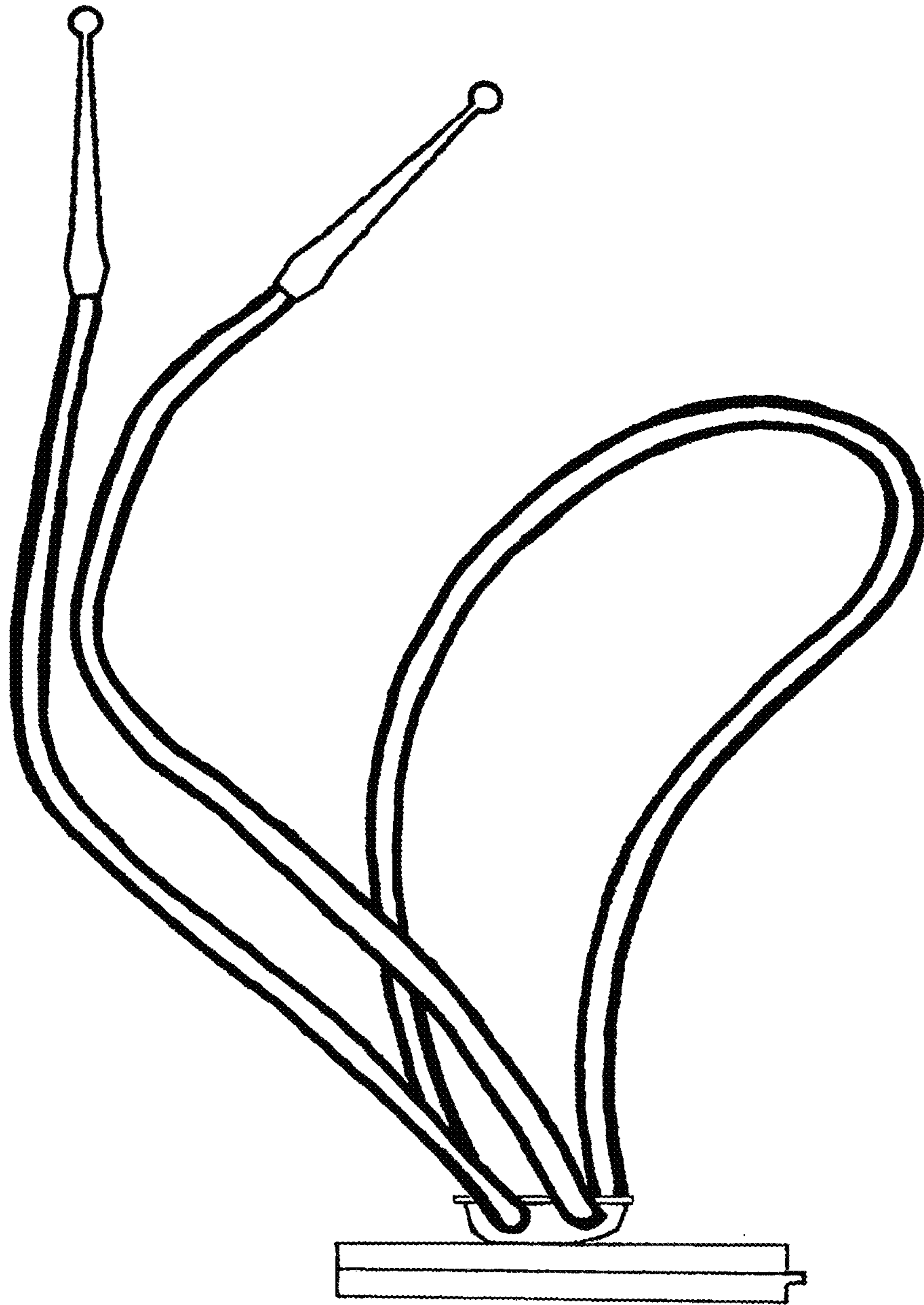

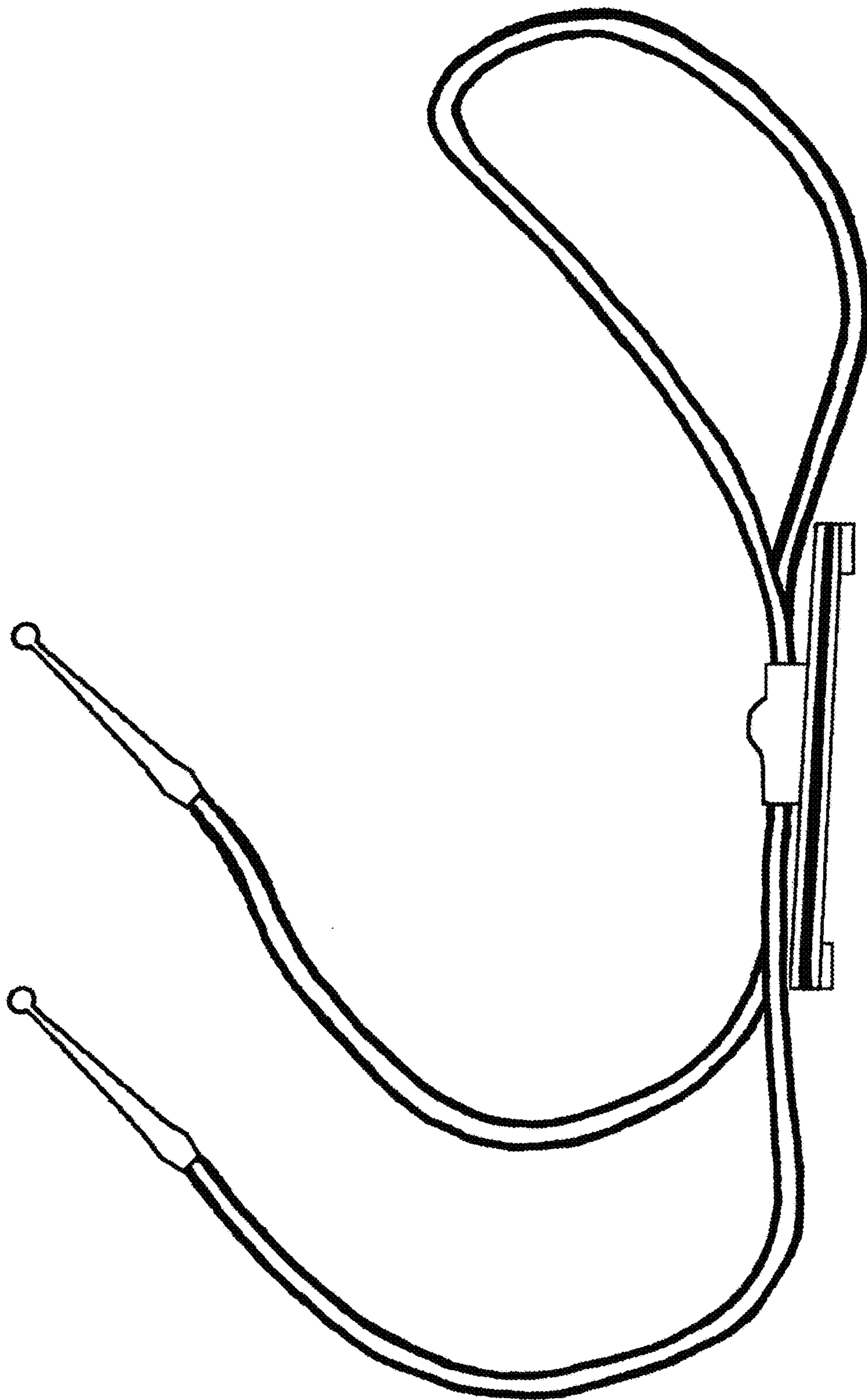

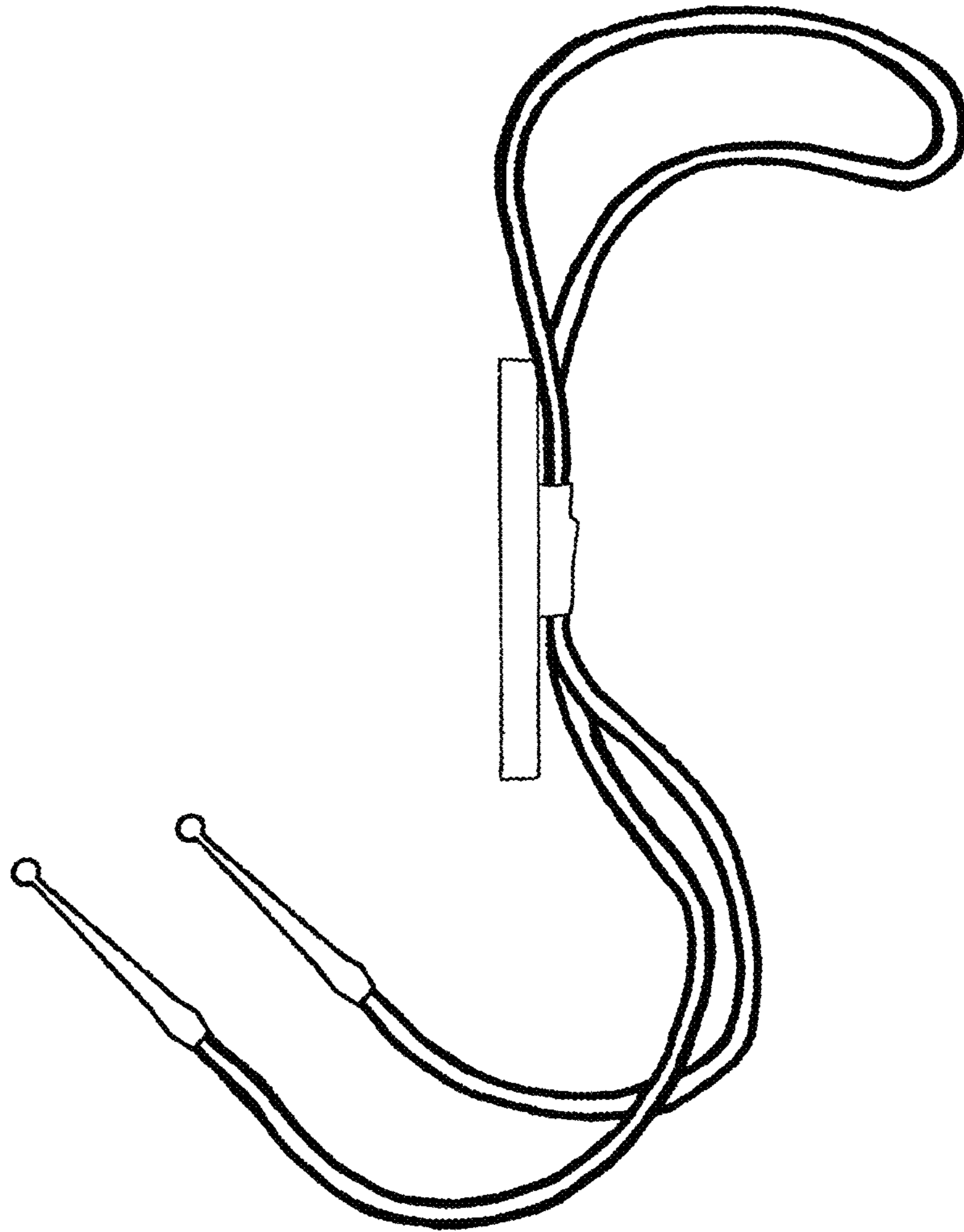
