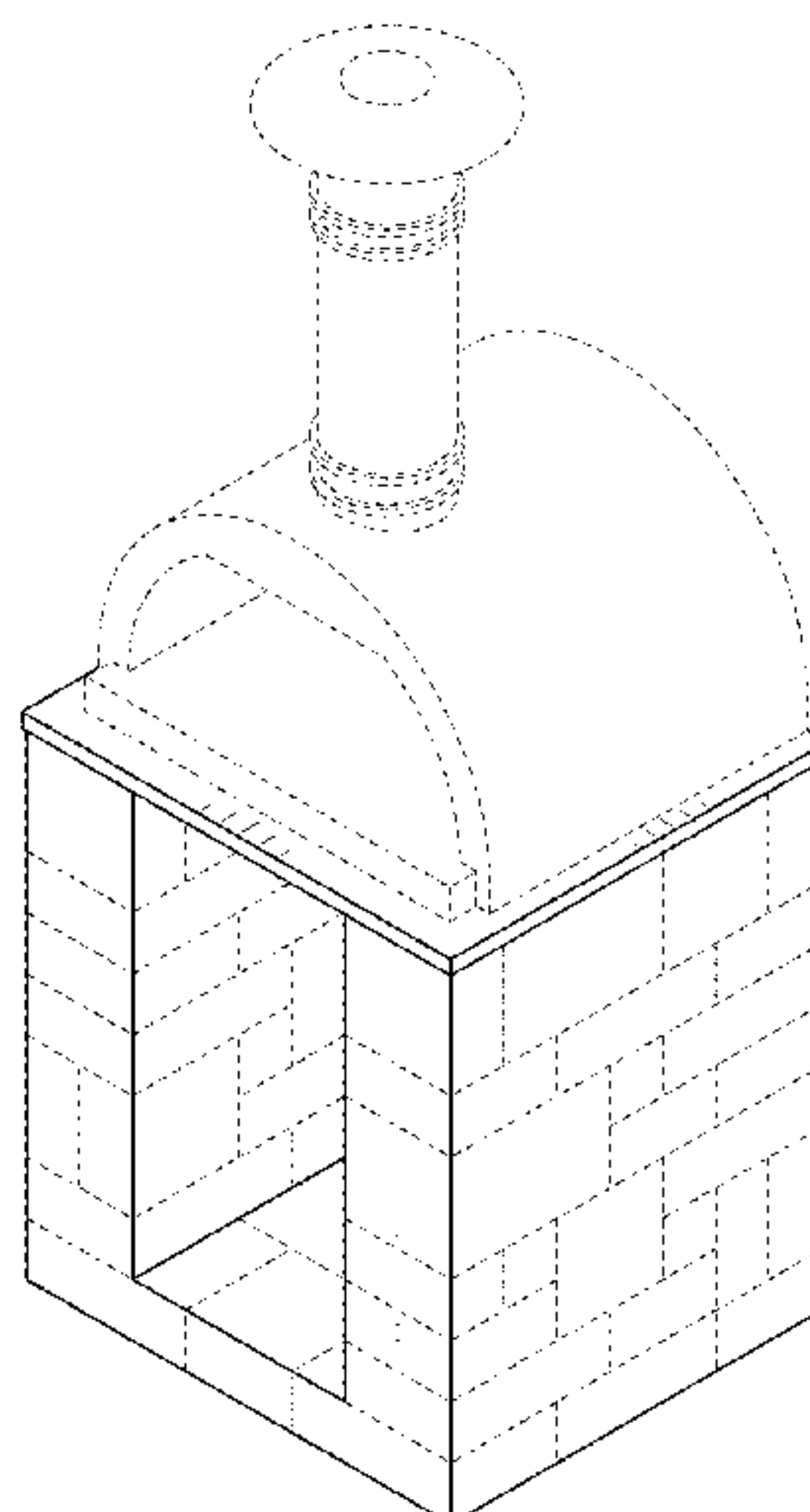
#### CLAIM

#### DESCRIPTION

FIG. 1 is a perspective view of an oven cabinet.  
FIG. 2 is a front view of the oven cabinet of FIG. 1.  
FIG. 3 is a back view of the oven cabinet of FIG. 1.  
FIG. 4 is a left side view of the oven cabinet of FIG. 1.  
FIG. 5 is a right side view of the oven cabinet of FIG. 1.  
FIG. 6 is a top view of the oven cabinet of FIG. 1.  
FIG. 7 is a bottom view of the oven cabinet of FIG. 1.  
FIG. 8 is an illustration of the oven cabinet of FIG. 1 as part  
of a first exemplary outdoor kitchen; and,  
FIG. 9 is an illustration of the oven cabinet of FIG. 1 as part  
of a second exemplary outdoor kitchen.  
The broken lines depict environment and form no part of the

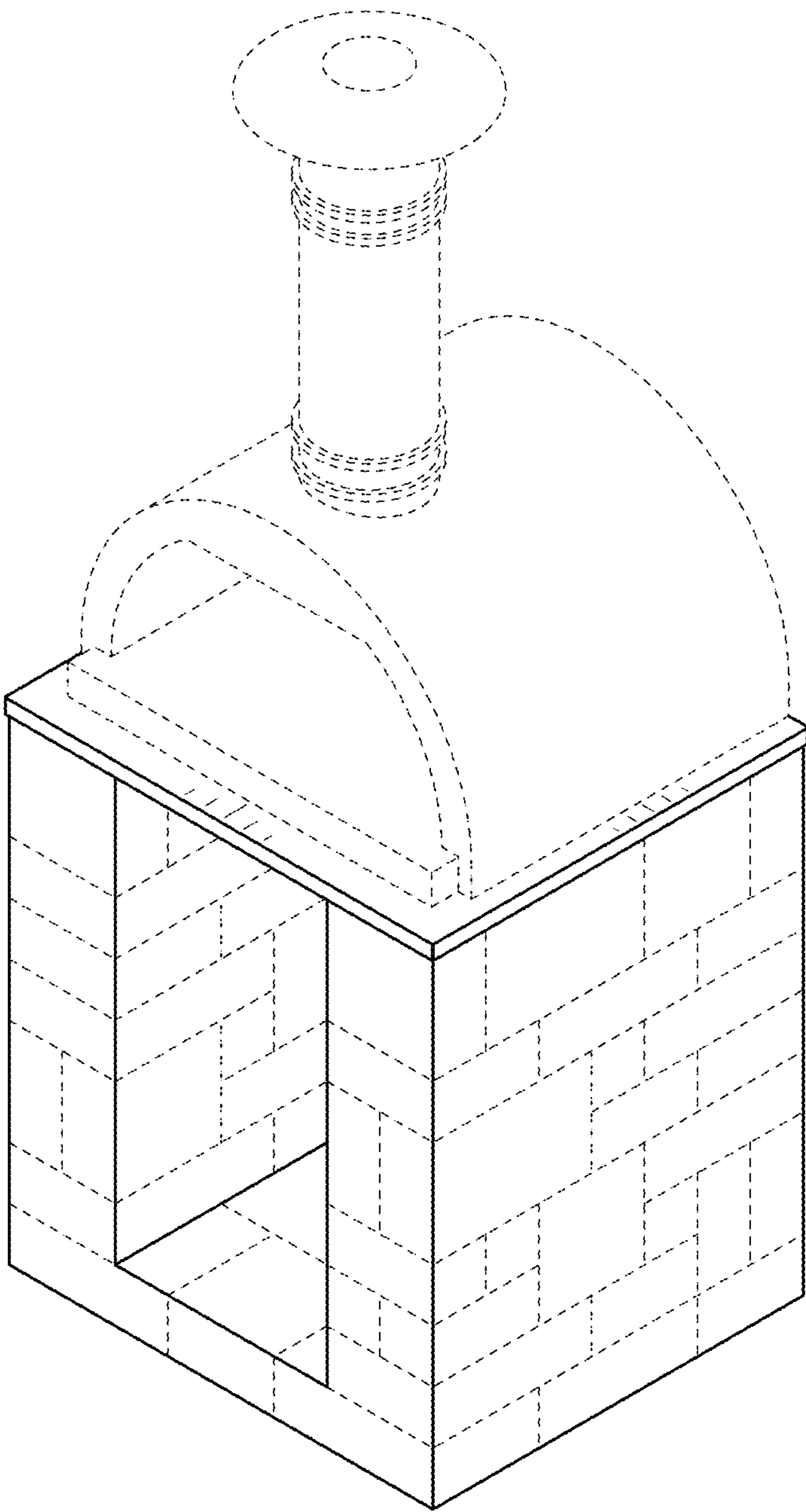

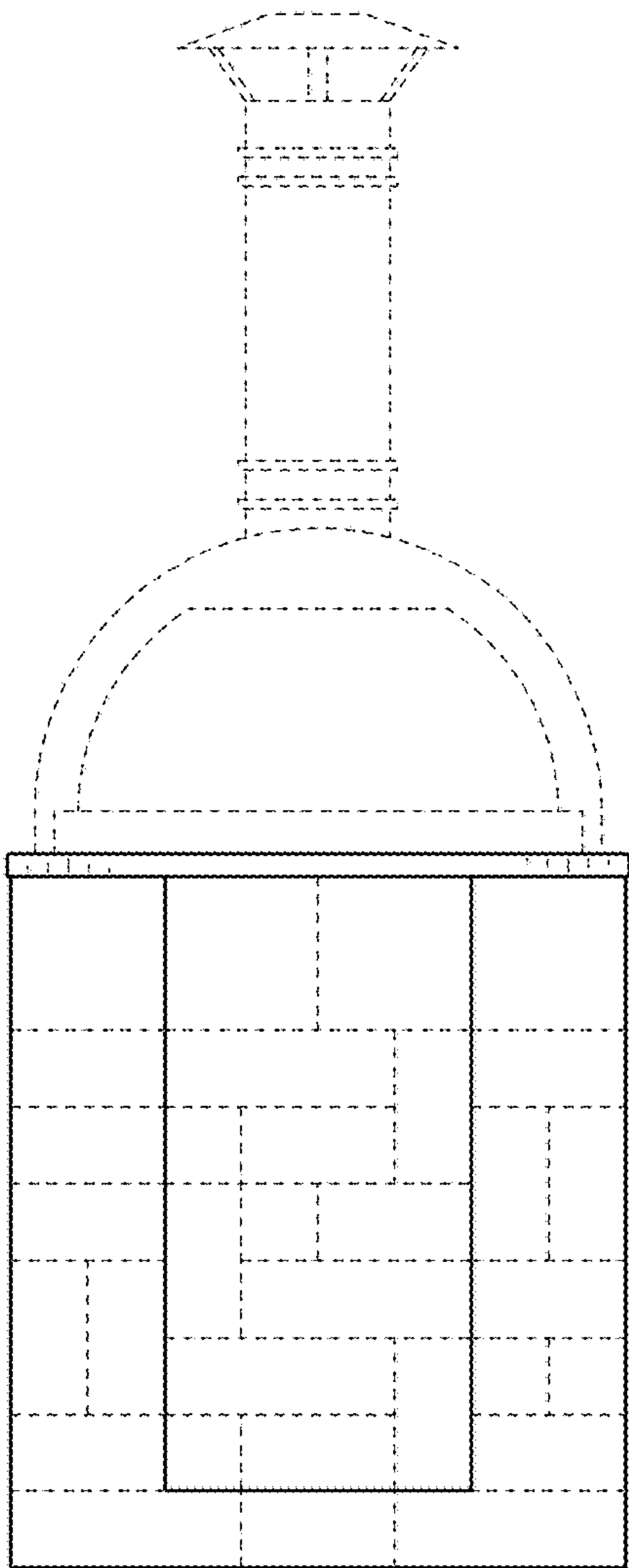

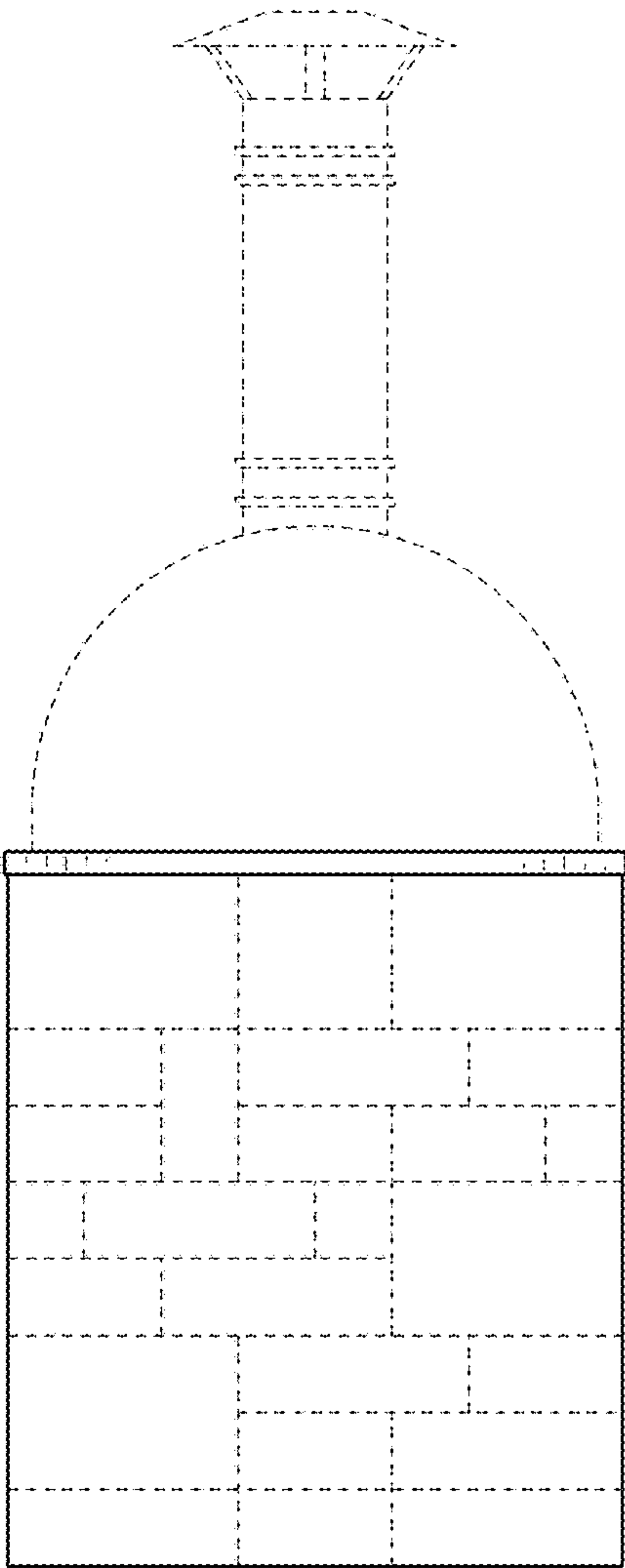

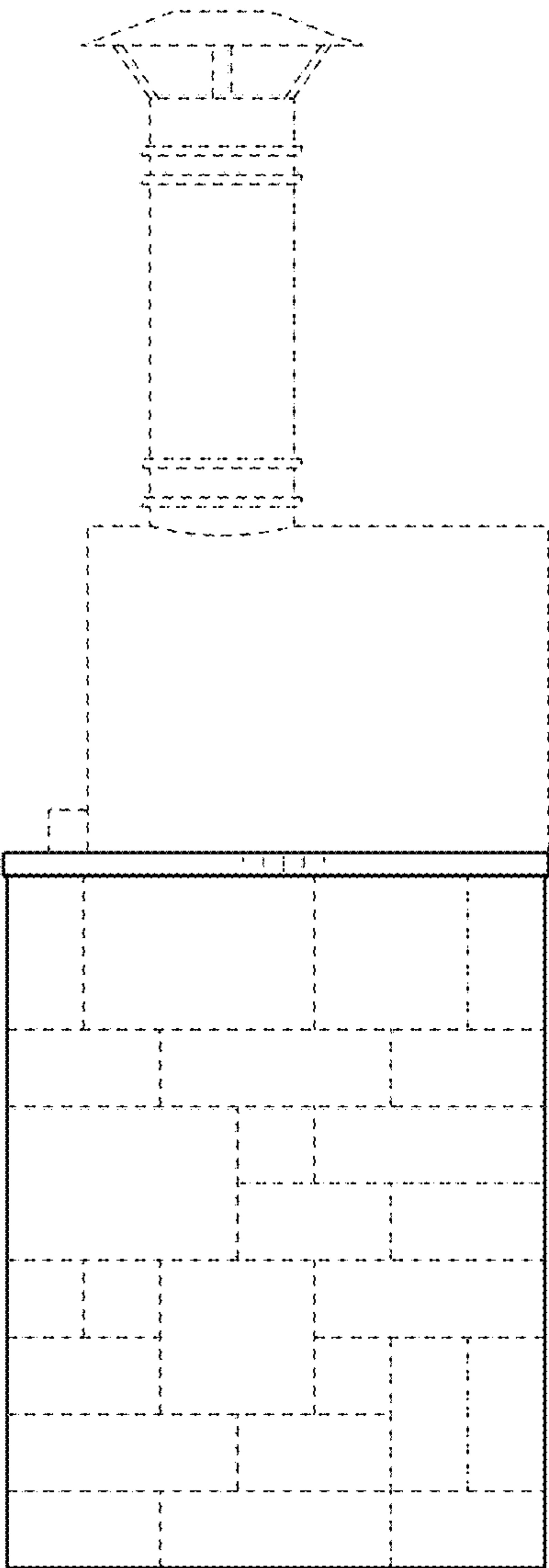

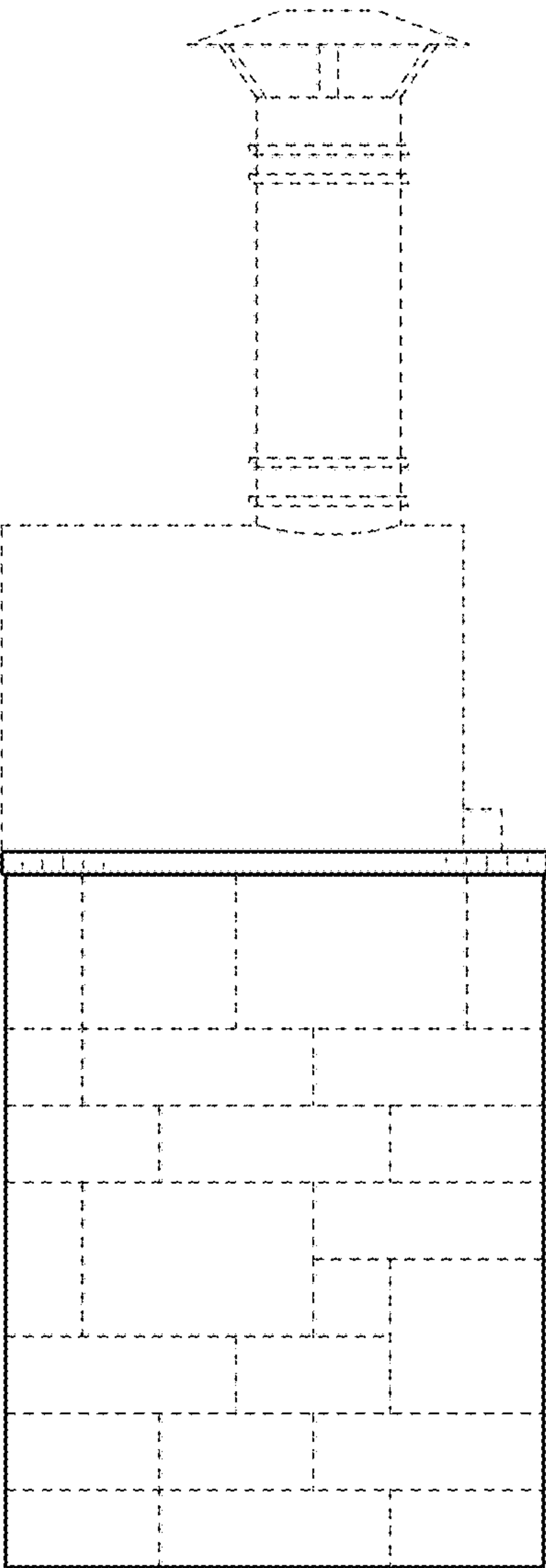

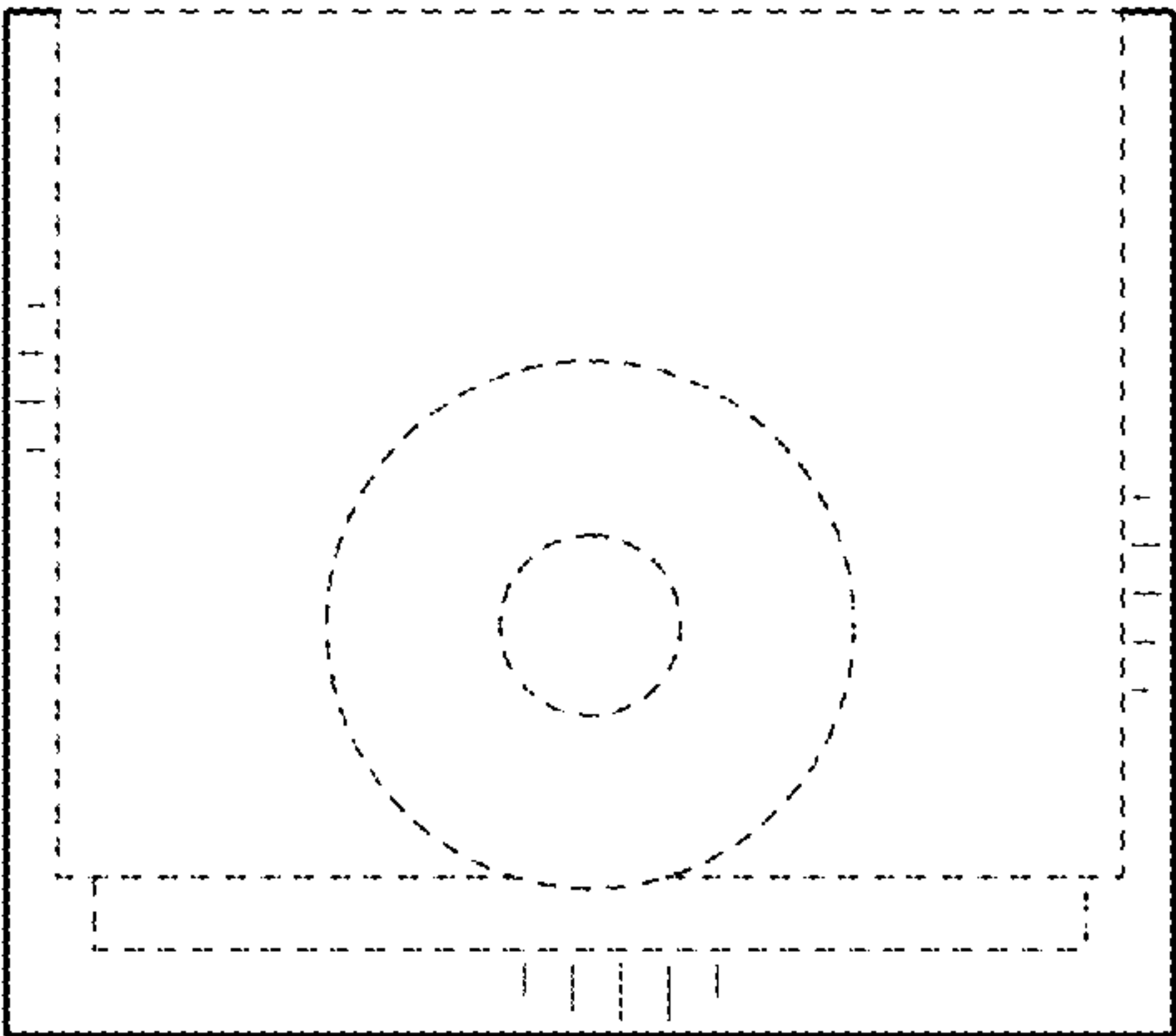

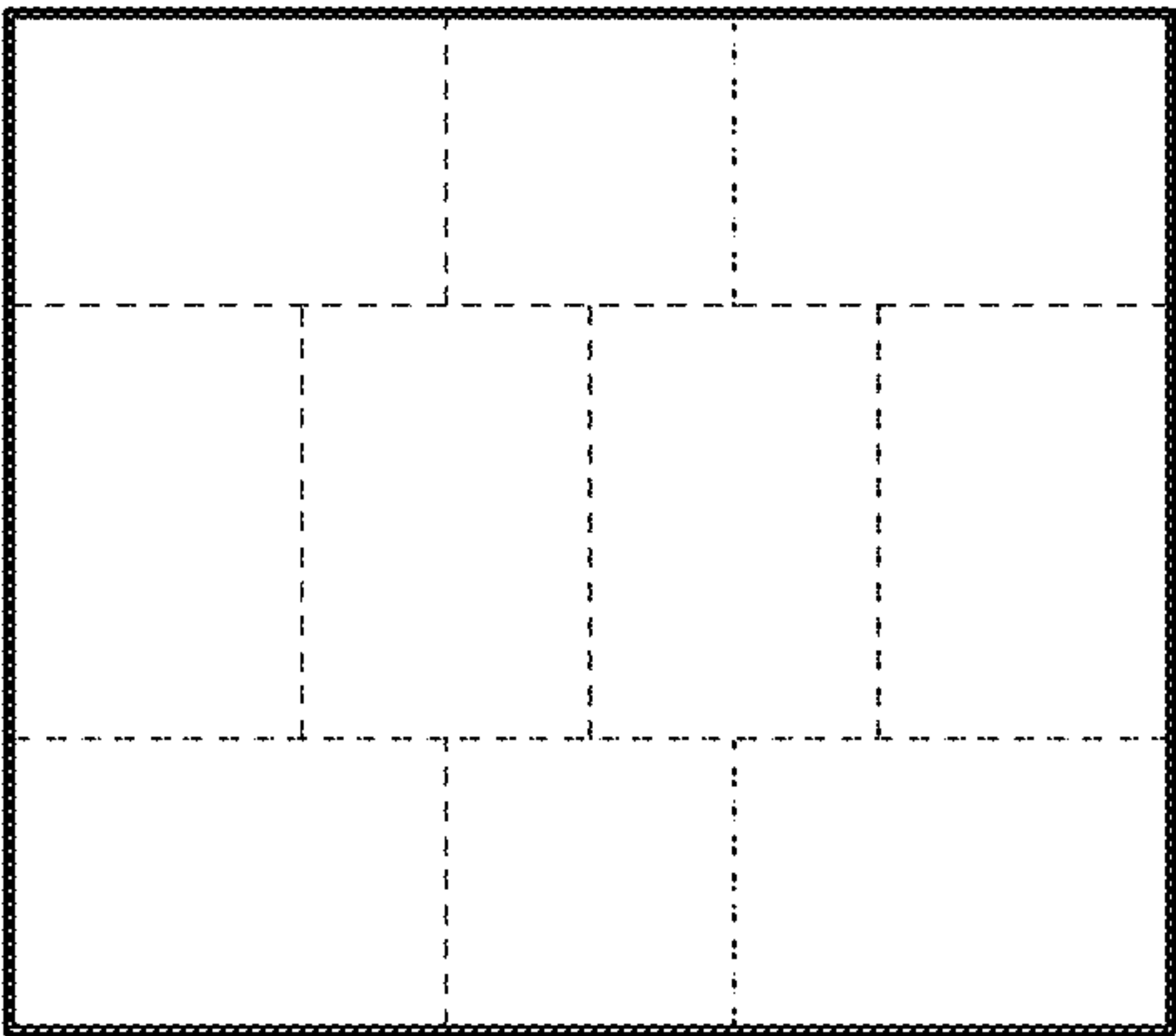

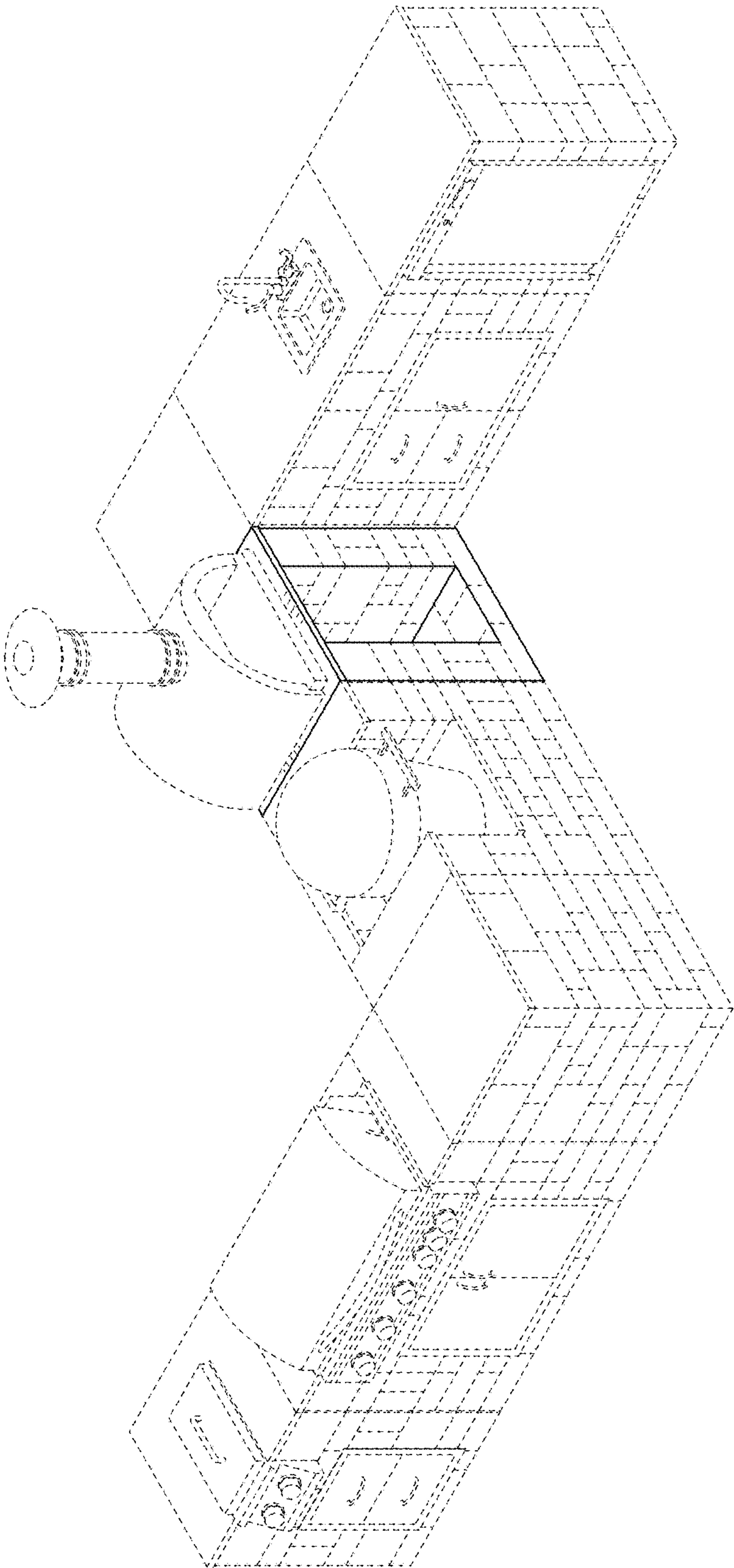

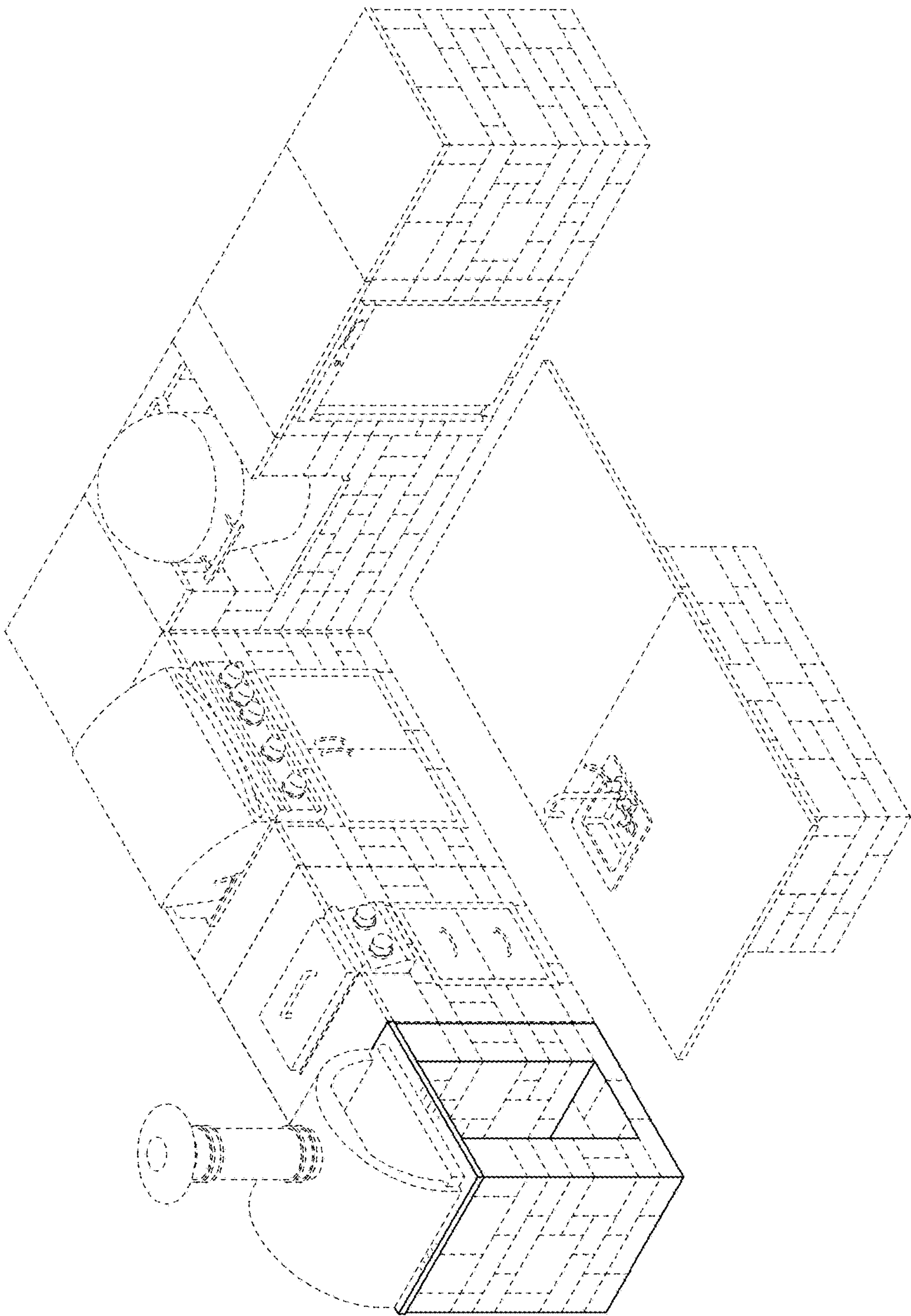
