FIG. 1 is a perspective view of a goblet showing my new design;

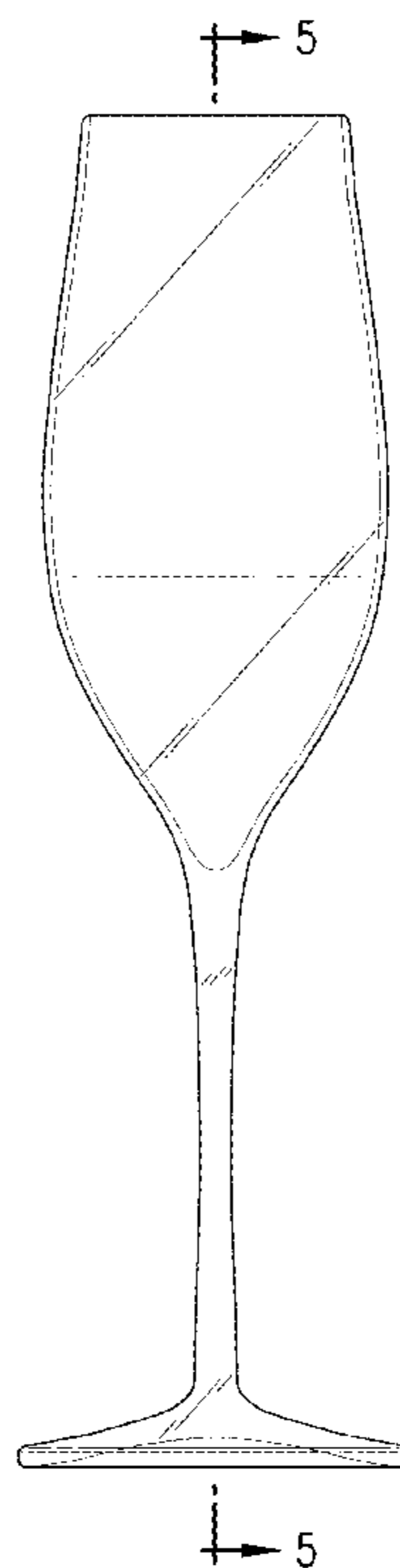
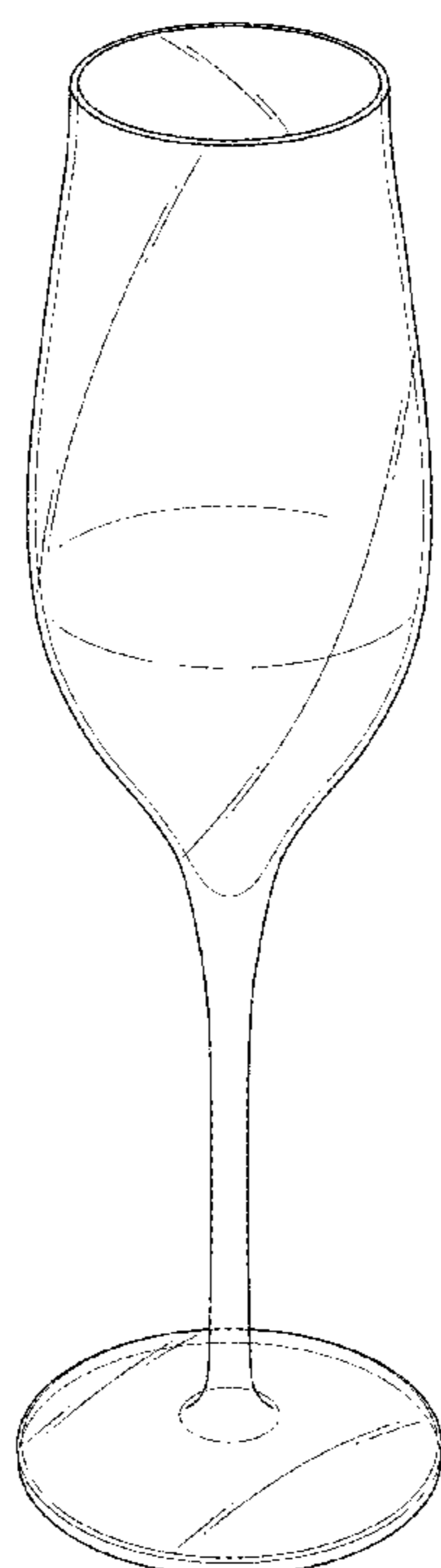
FIG. 2 is a front elevational view thereof; the rear, right side, and left side elevational views being a mirror image thereof;

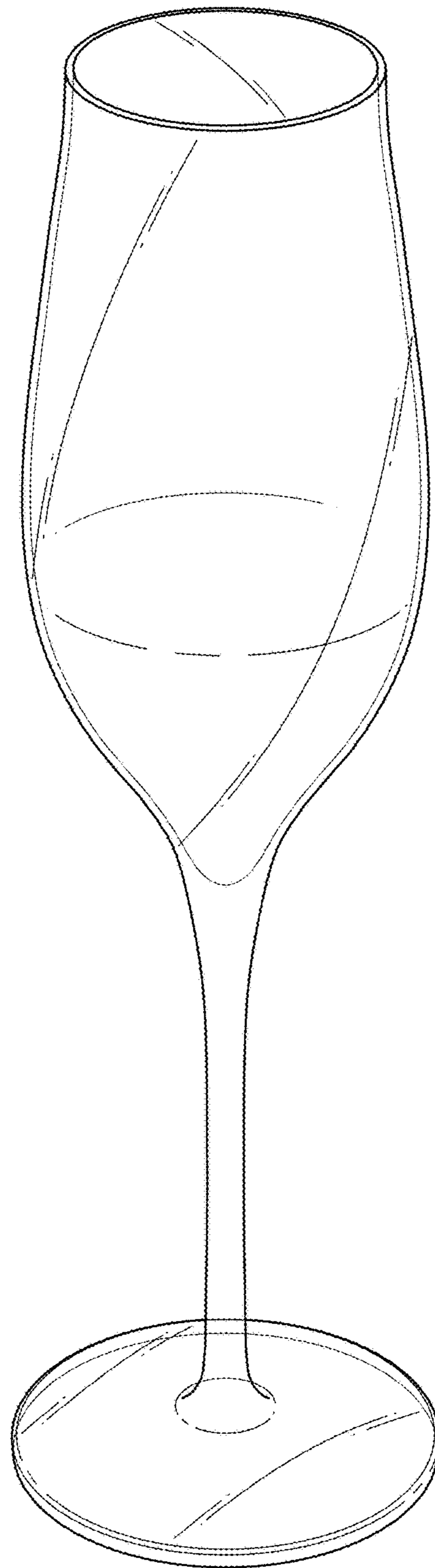

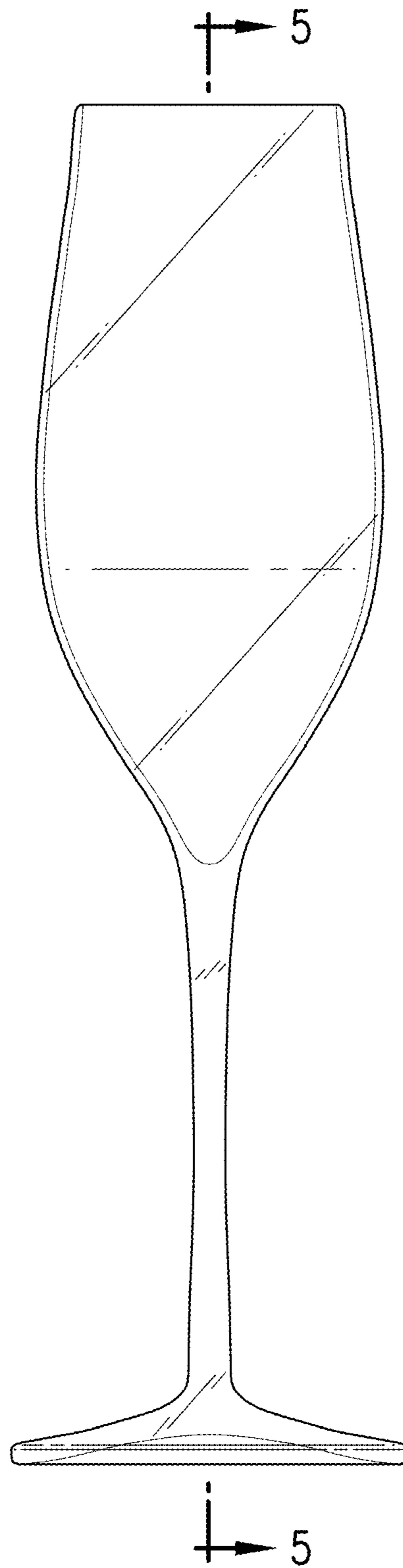

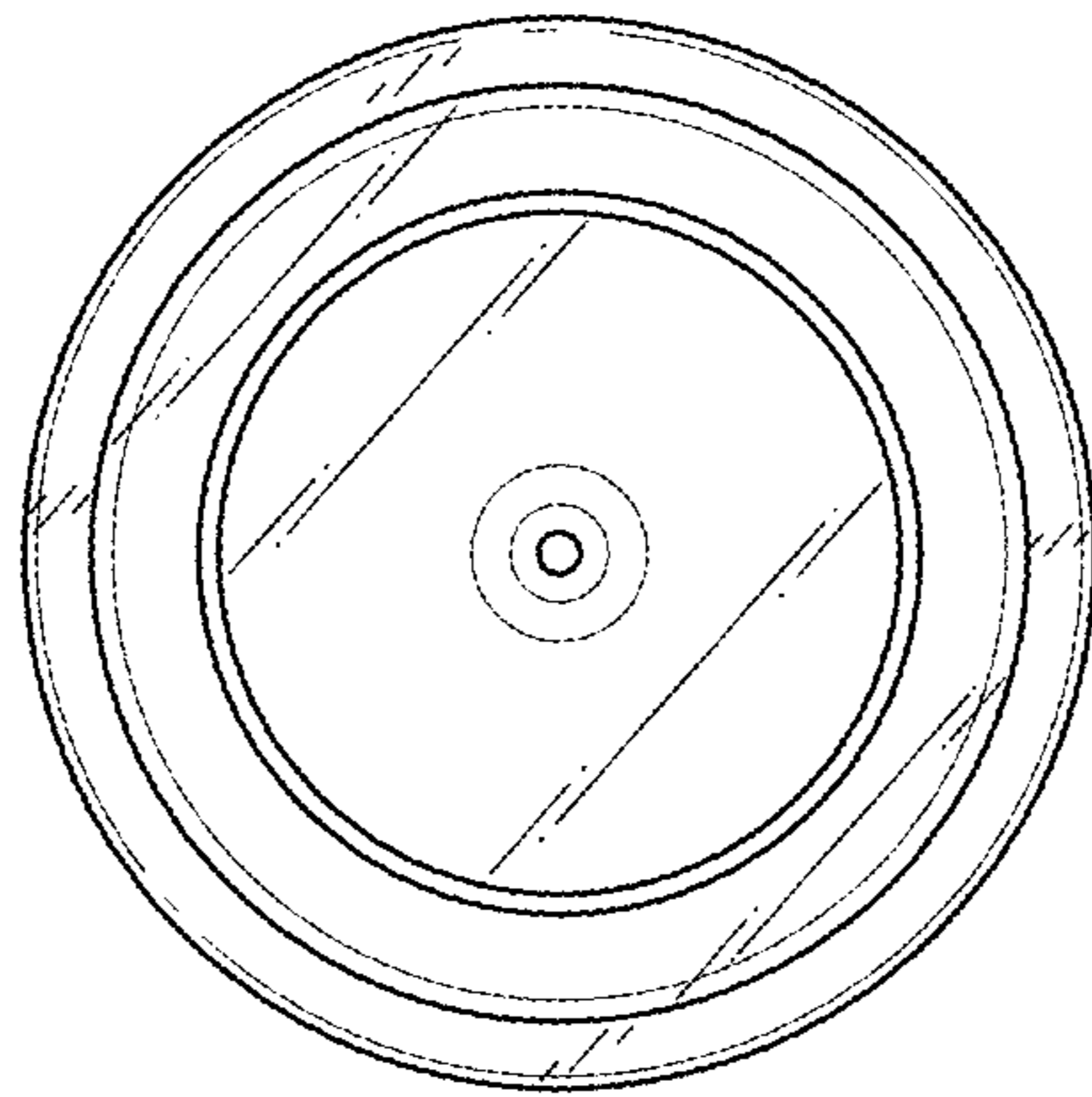

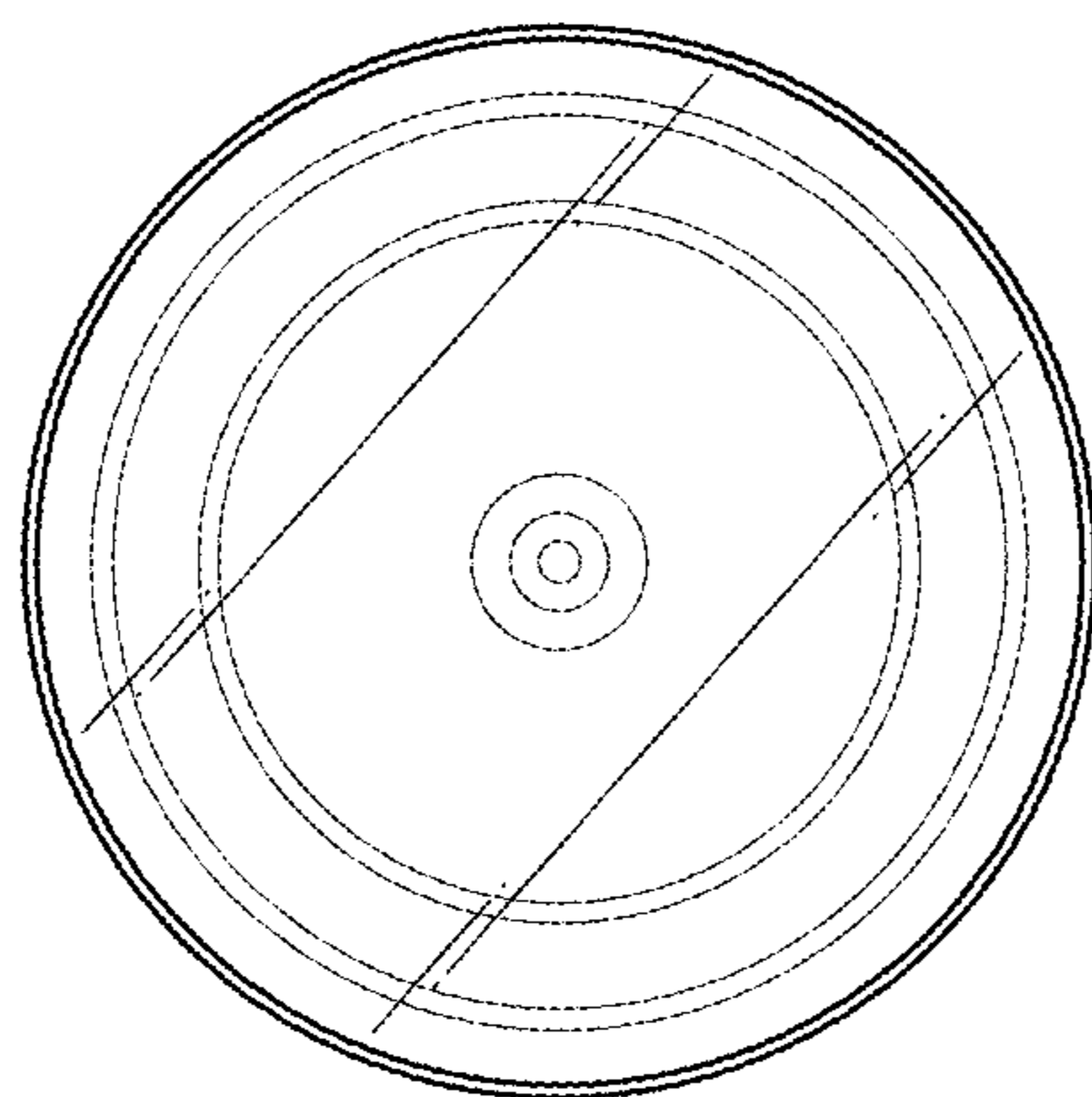

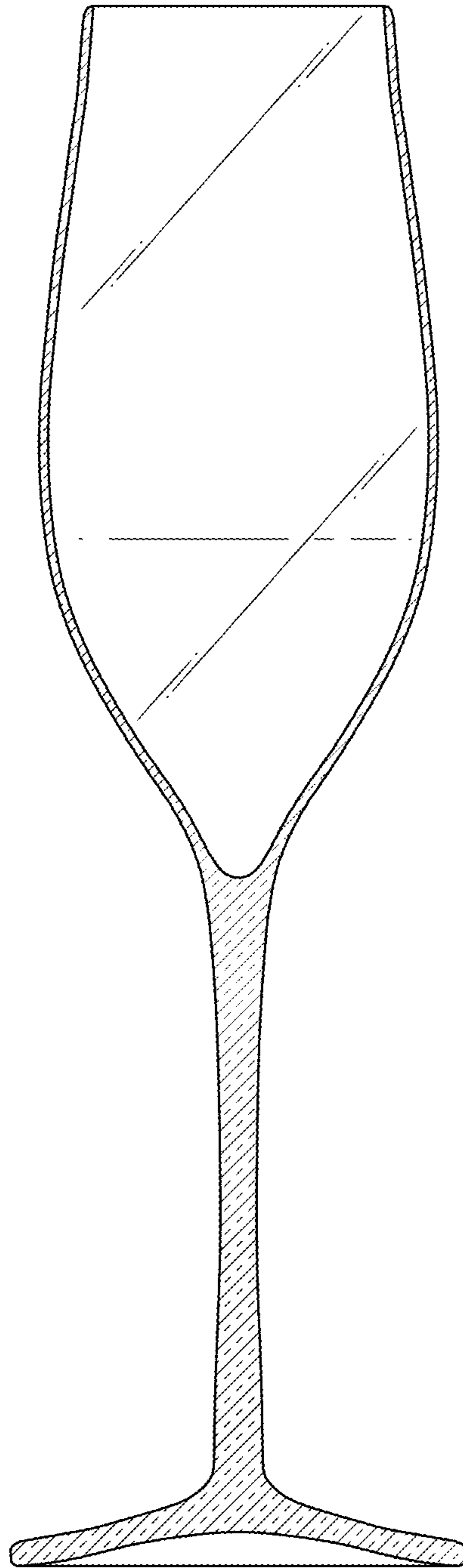
