An ornamental design for a storage container, as shown and described.

**DESCRIPTION**

FIG. 4 is a left-side, elevational view of the storage container of FIG. 1;

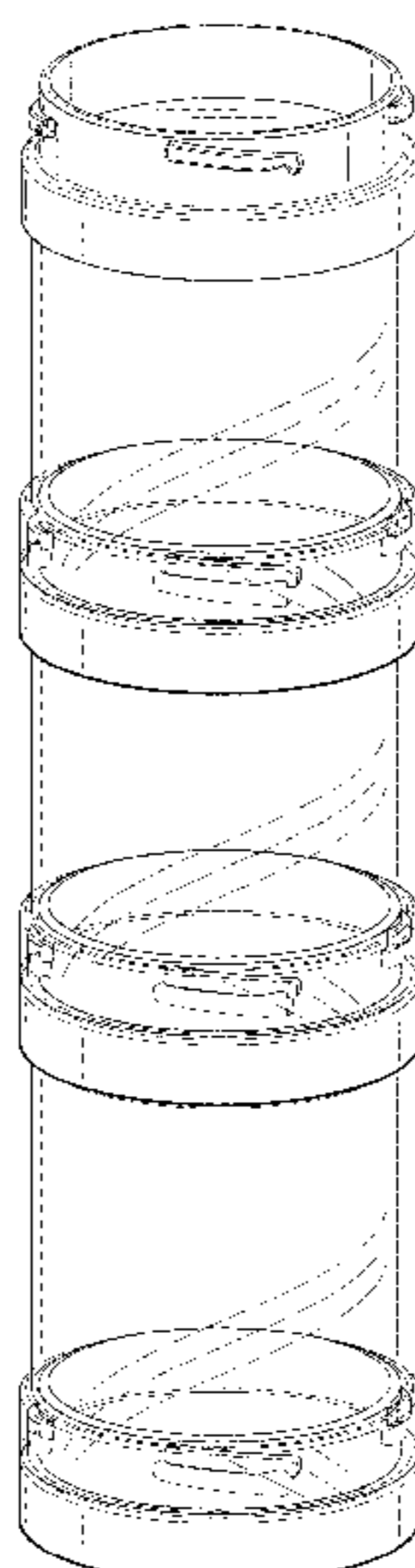
FIG. 5 is a right-side, elevational view of the storage container of FIG. 1;

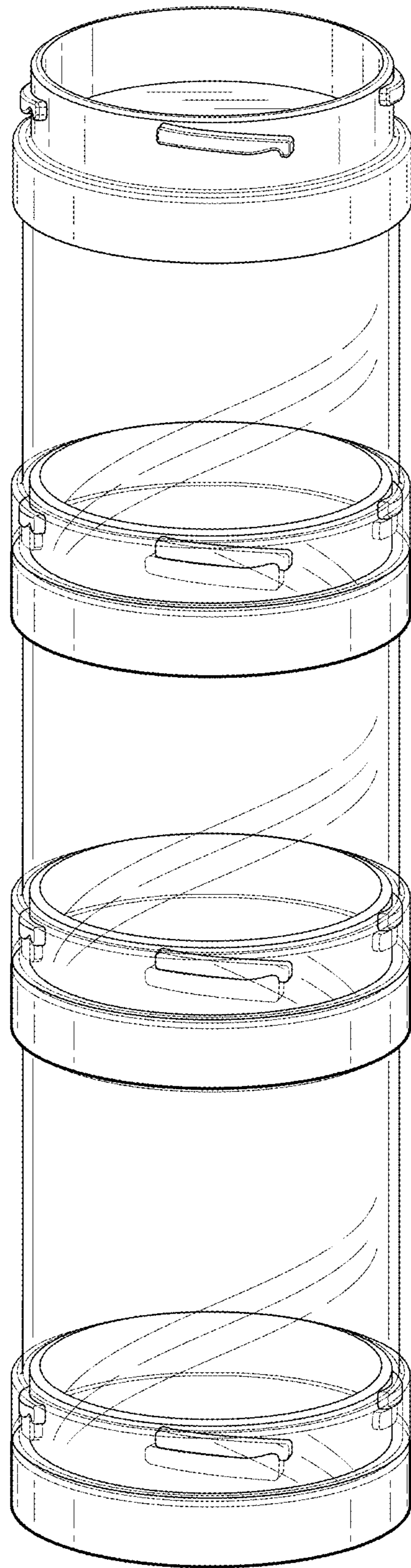

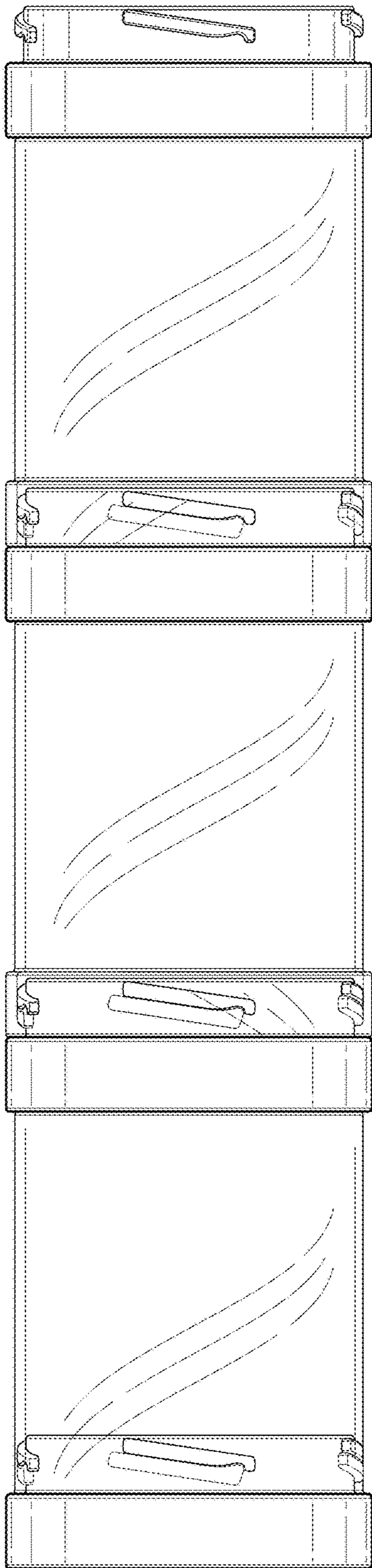

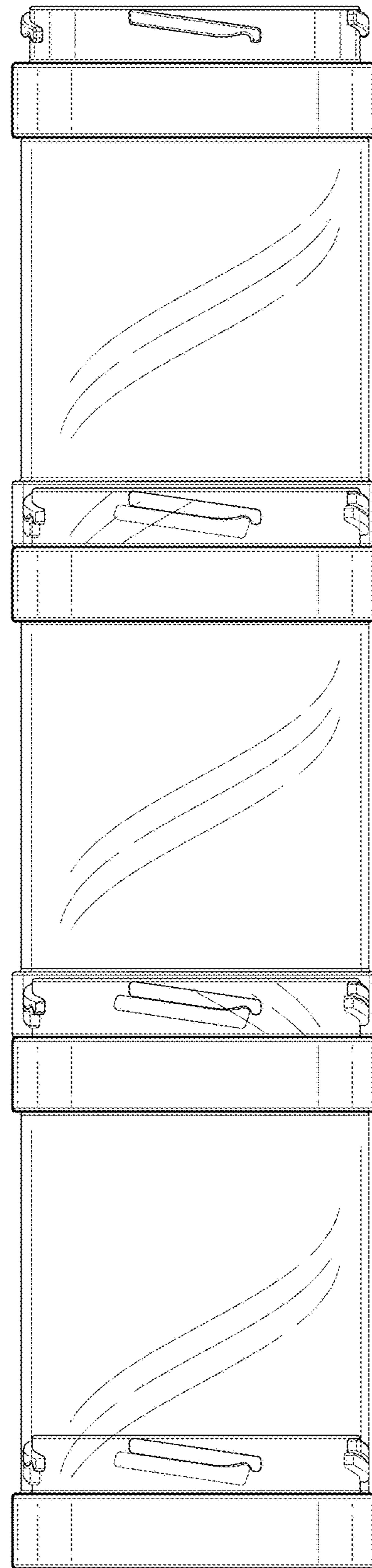

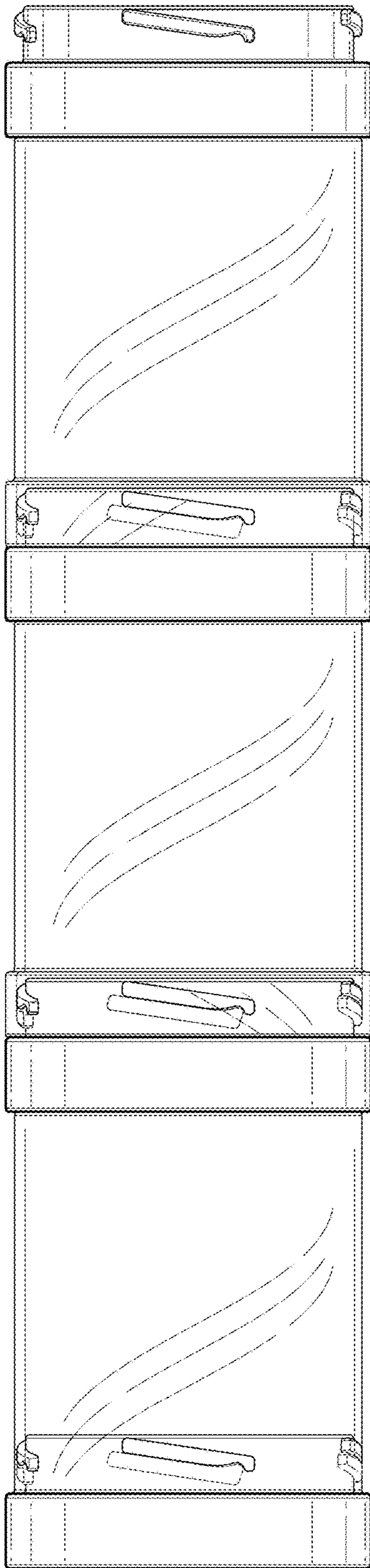

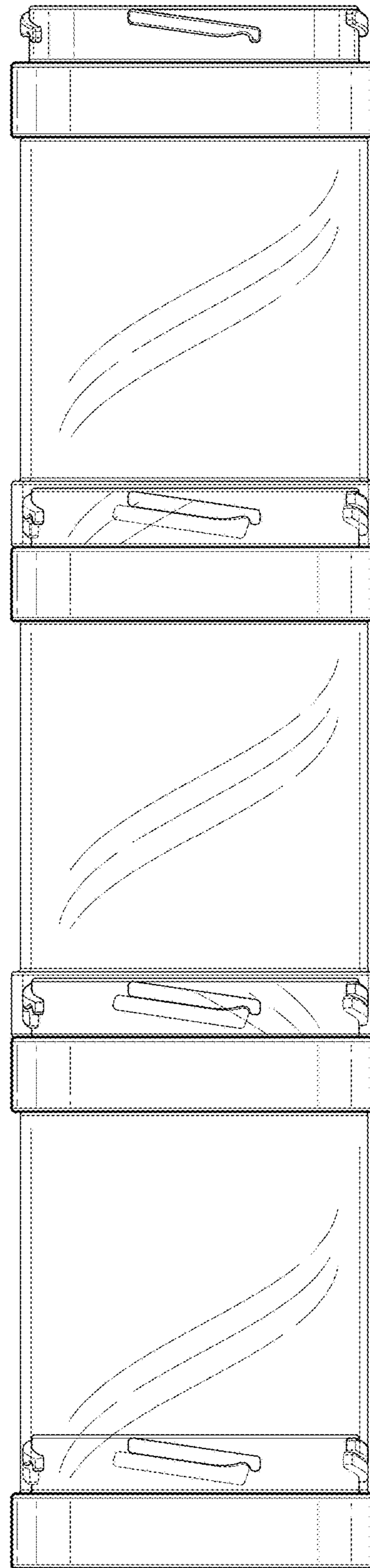
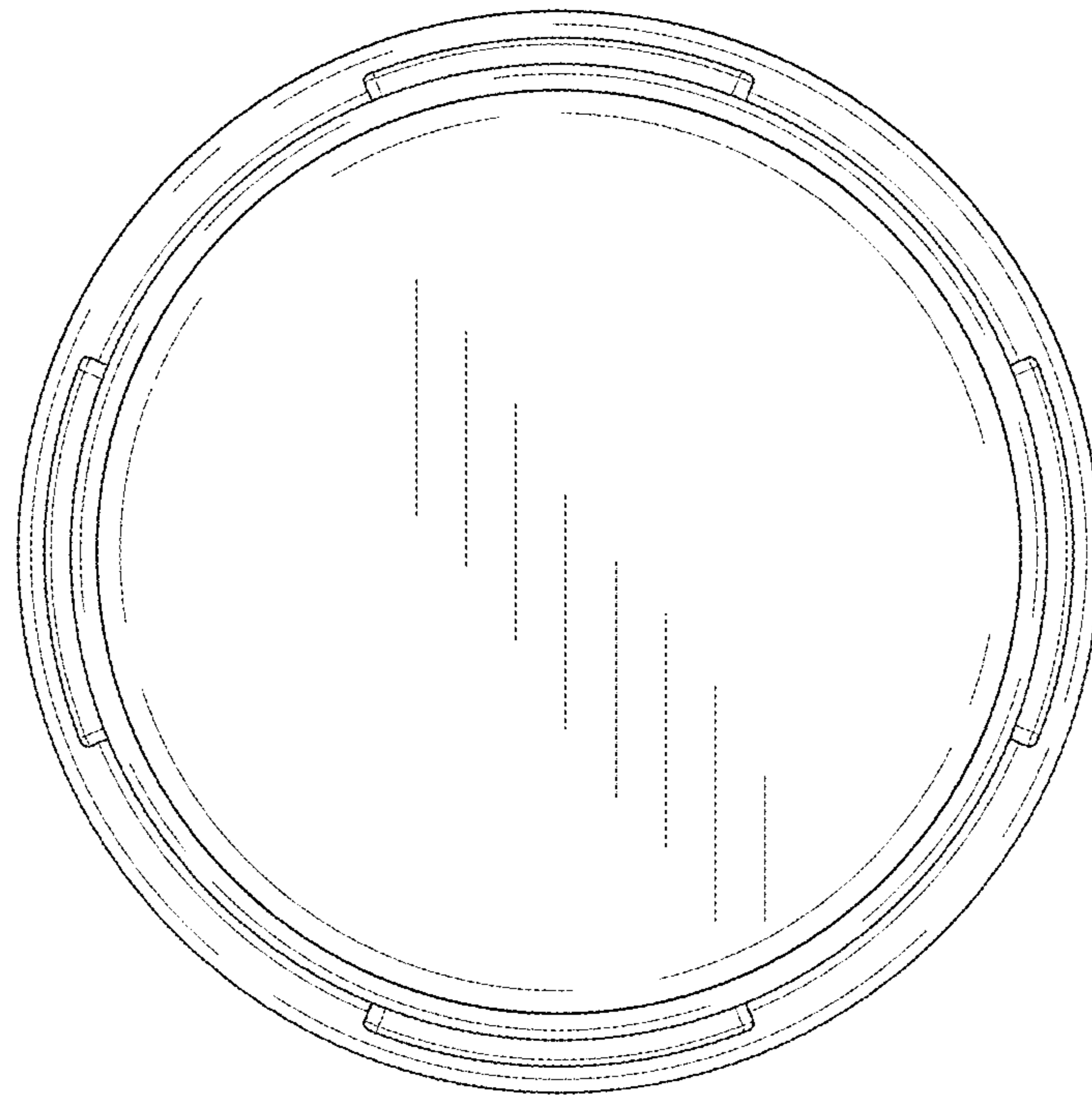
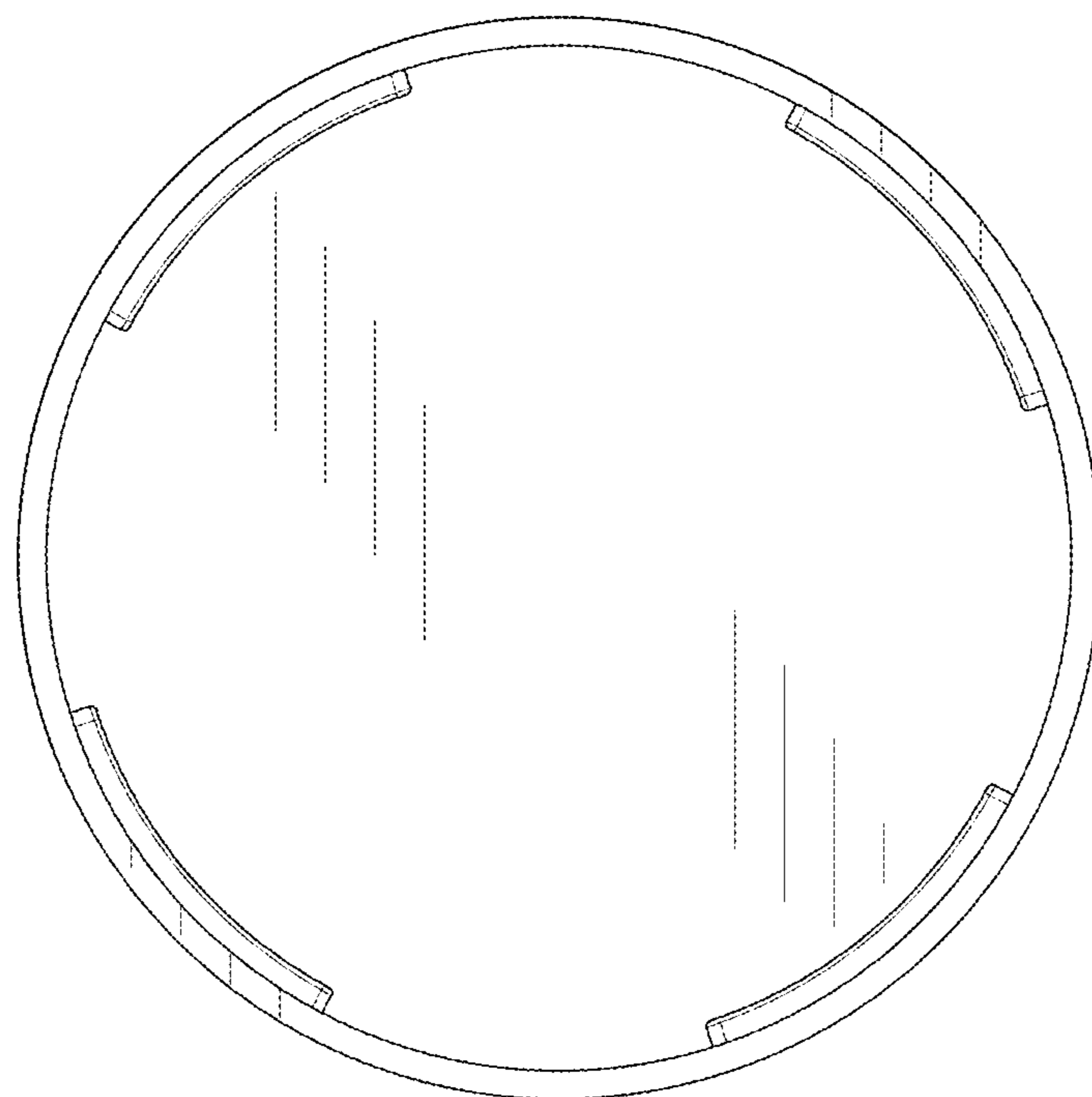

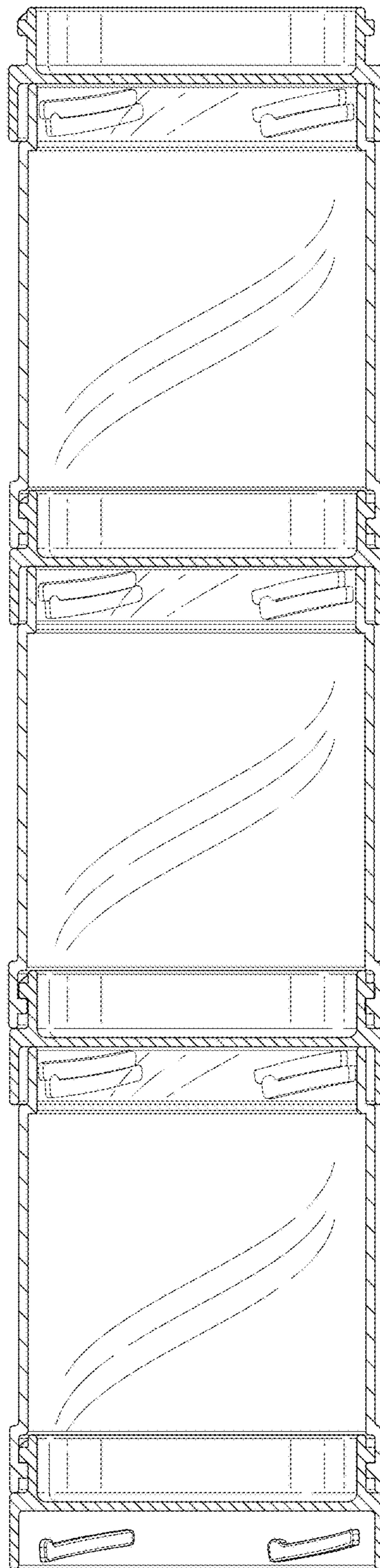
