**DESCRIPTION**

FIG. 1 is a front elevation view of a necklace showing my new design.

FIG. 2 is an enlarged view of the portion highlighted in FIG. 1.

FIG. 3 is a rear elevation view of the necklace of FIG. 1.

FIG. 4 is an enlarged view of the portion highlighted in FIG. 3.

FIG. 5 is a left side elevation view of the necklace of FIG. 1.

FIG. 6 is an enlarged view of the portion highlighted in FIG. 5.

FIG. 7 is a right side elevation view of the necklace of FIG. 1.

FIG. 8 is an enlarged view of the portion highlighted in FIG. 7.

FIG. 9 is a top plan view of the necklace of FIG. 1.

FIG. 10 is a bottom plan view of the necklace of FIG. 1.

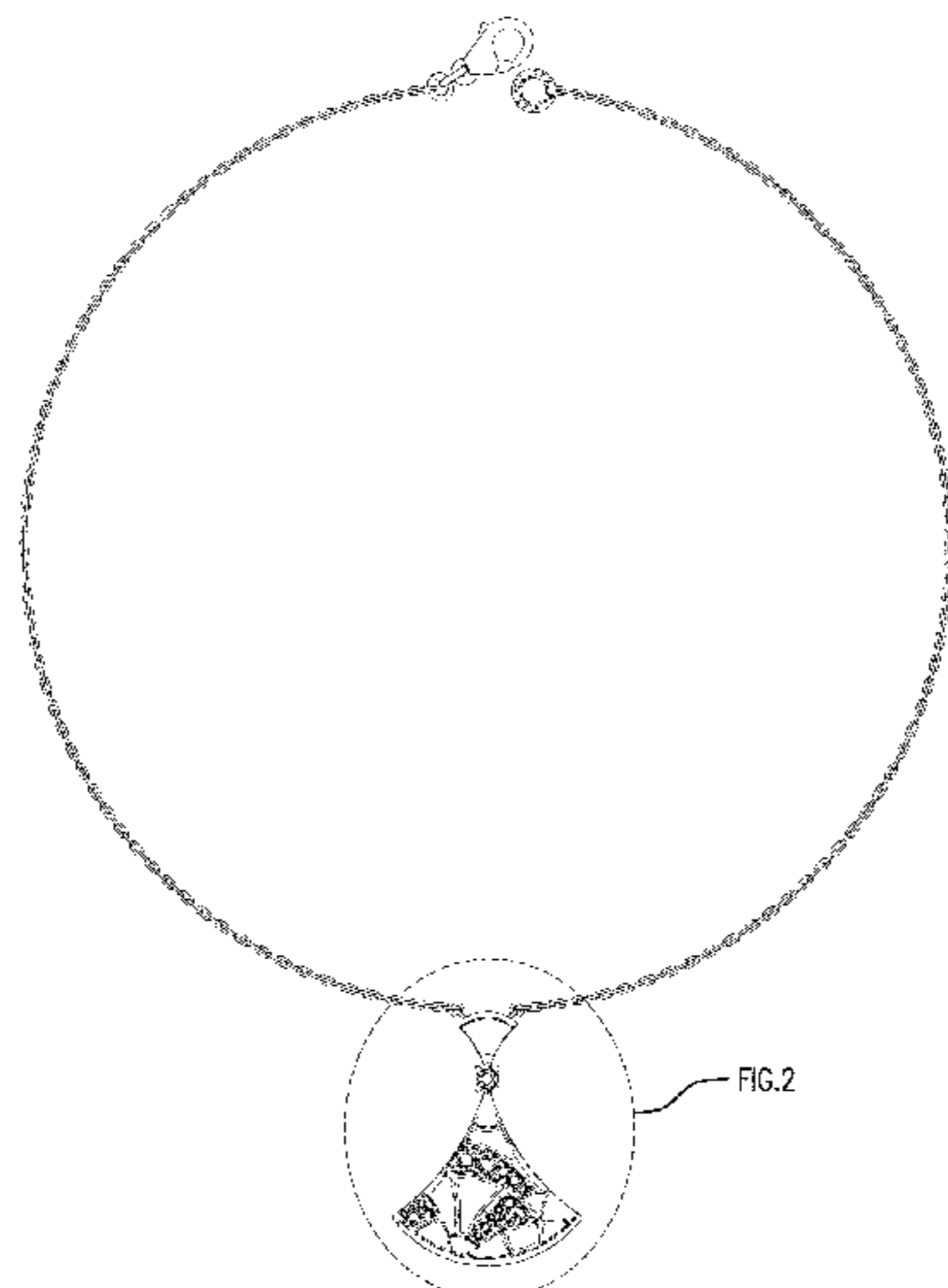
FIG. 11 is a top perspective view of the necklace of FIG. 1.

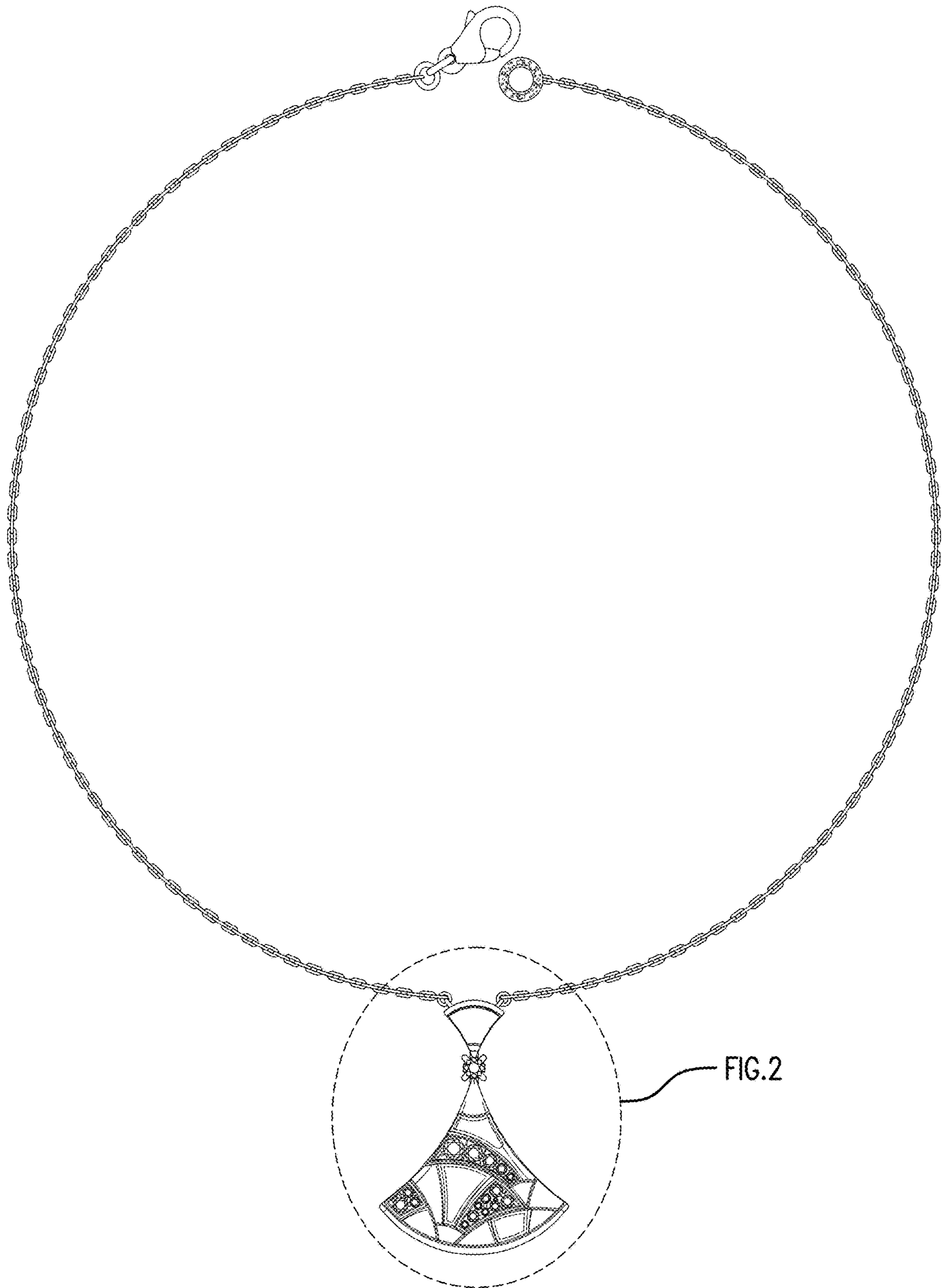

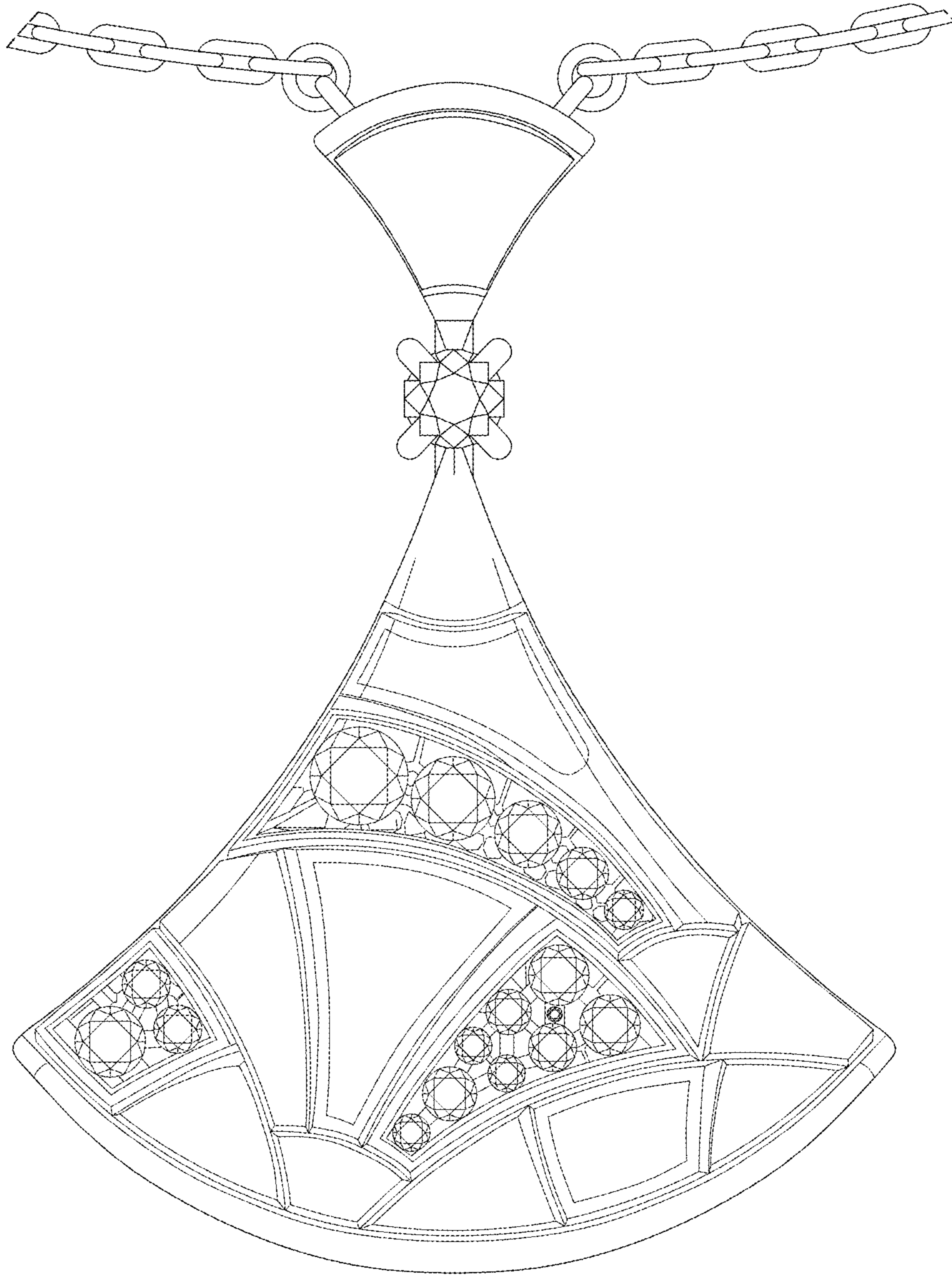

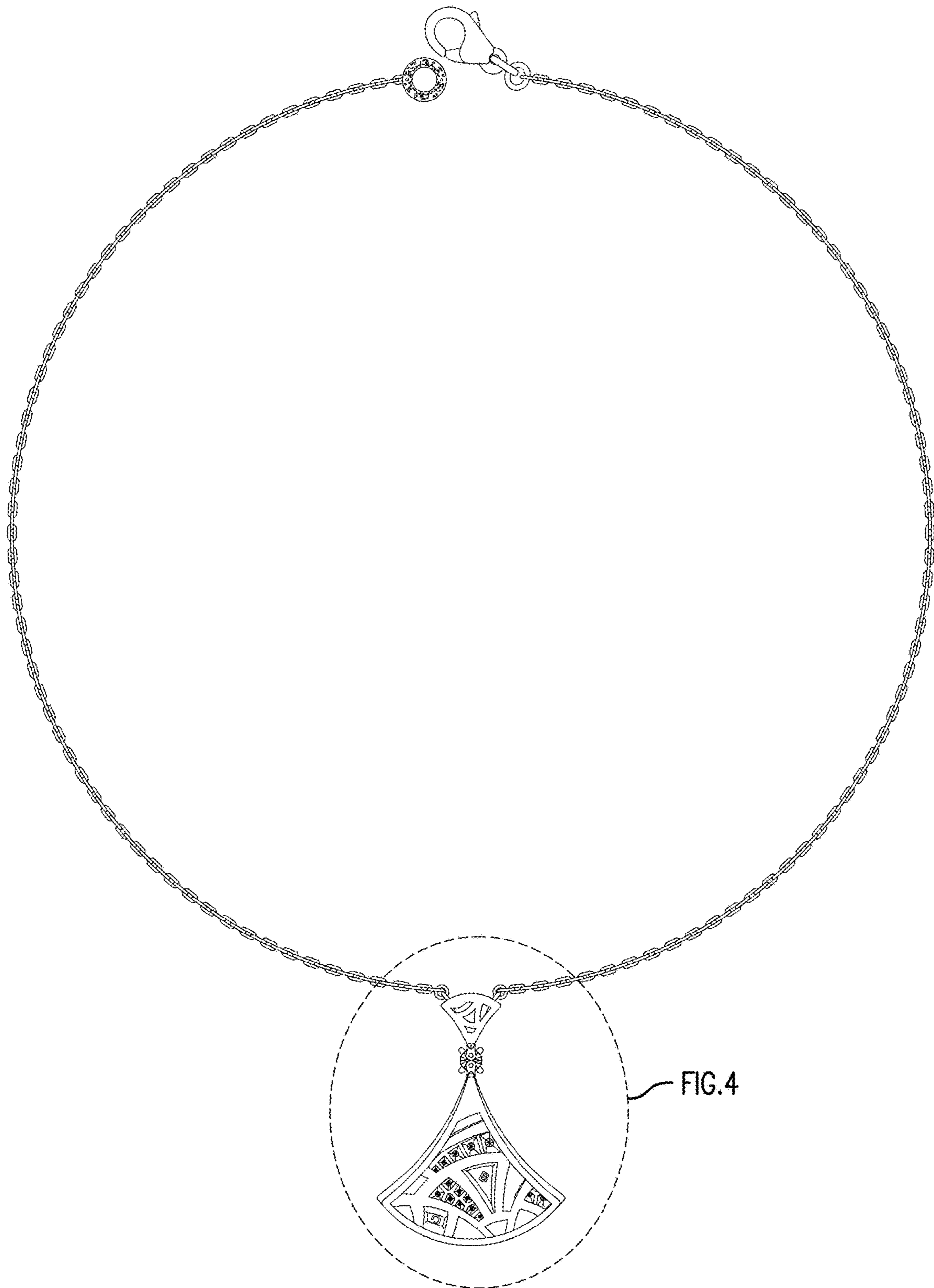

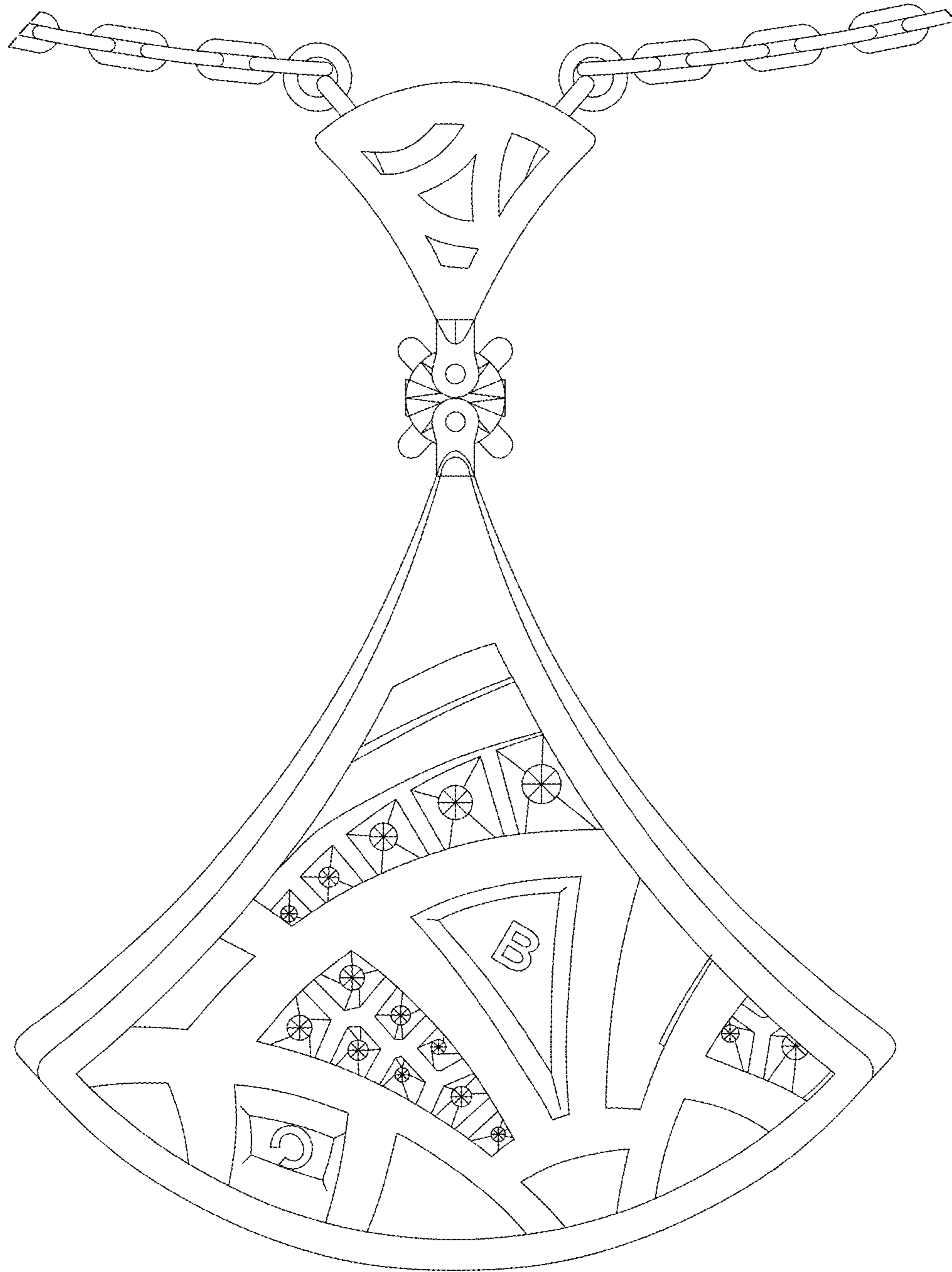

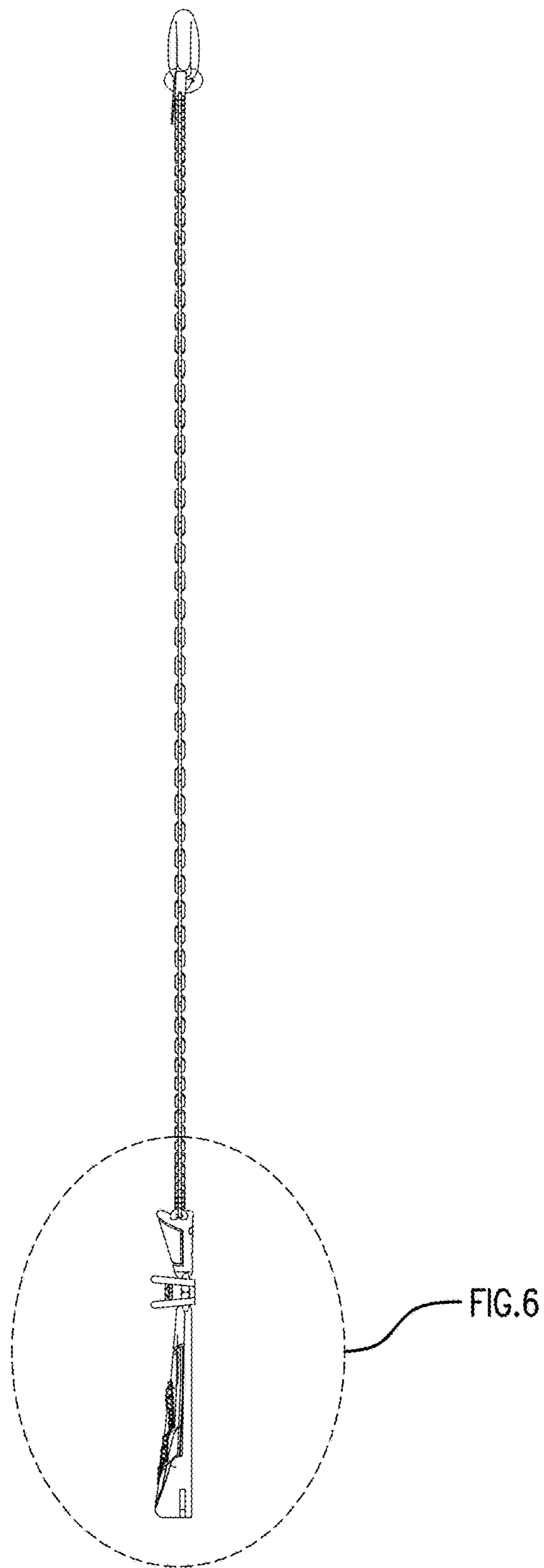

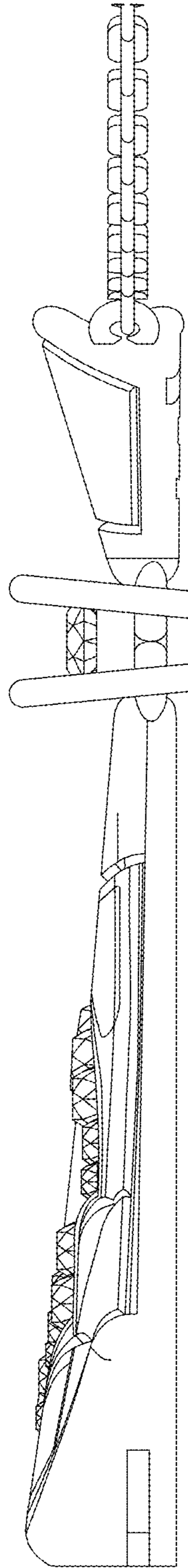

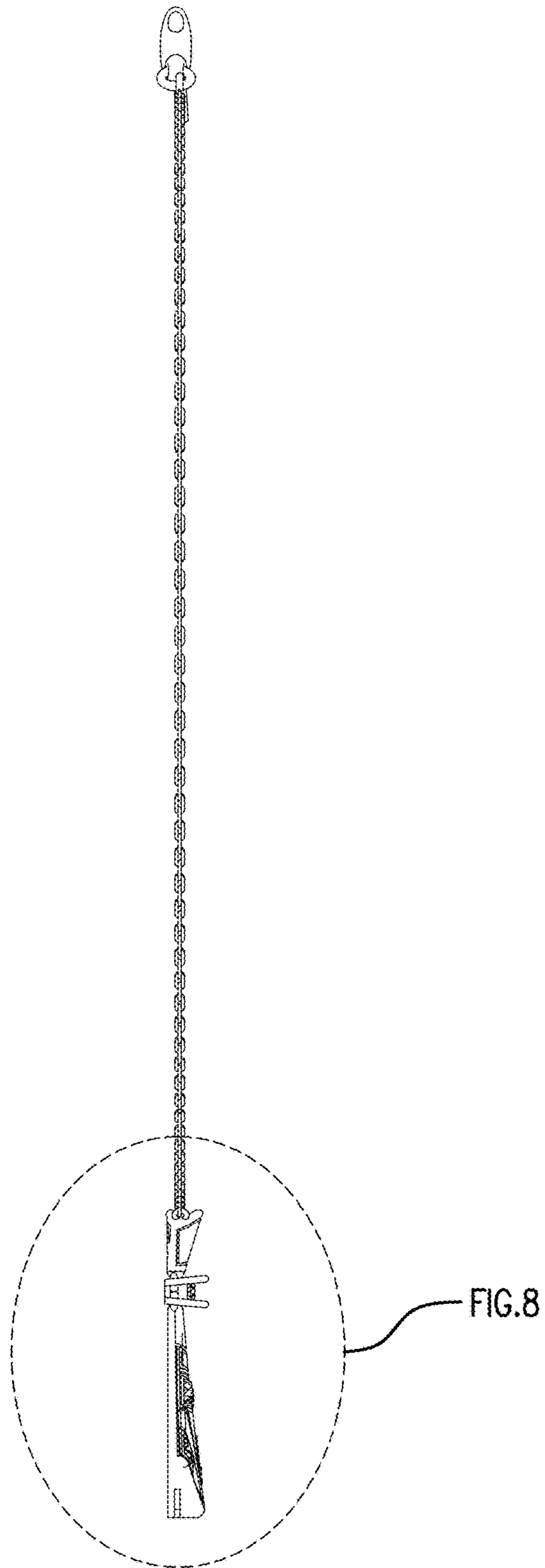

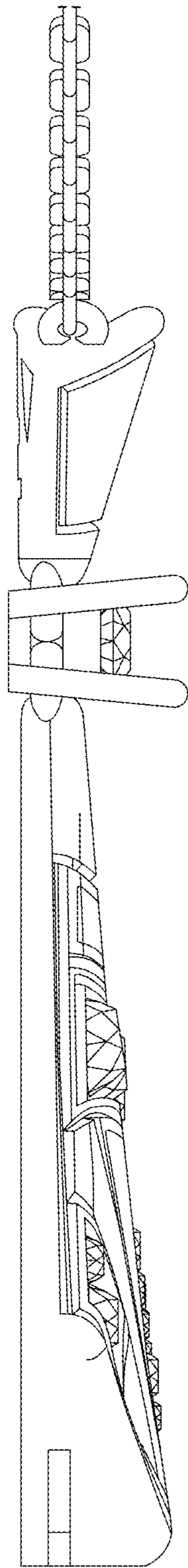

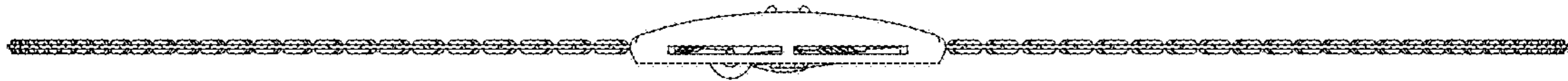

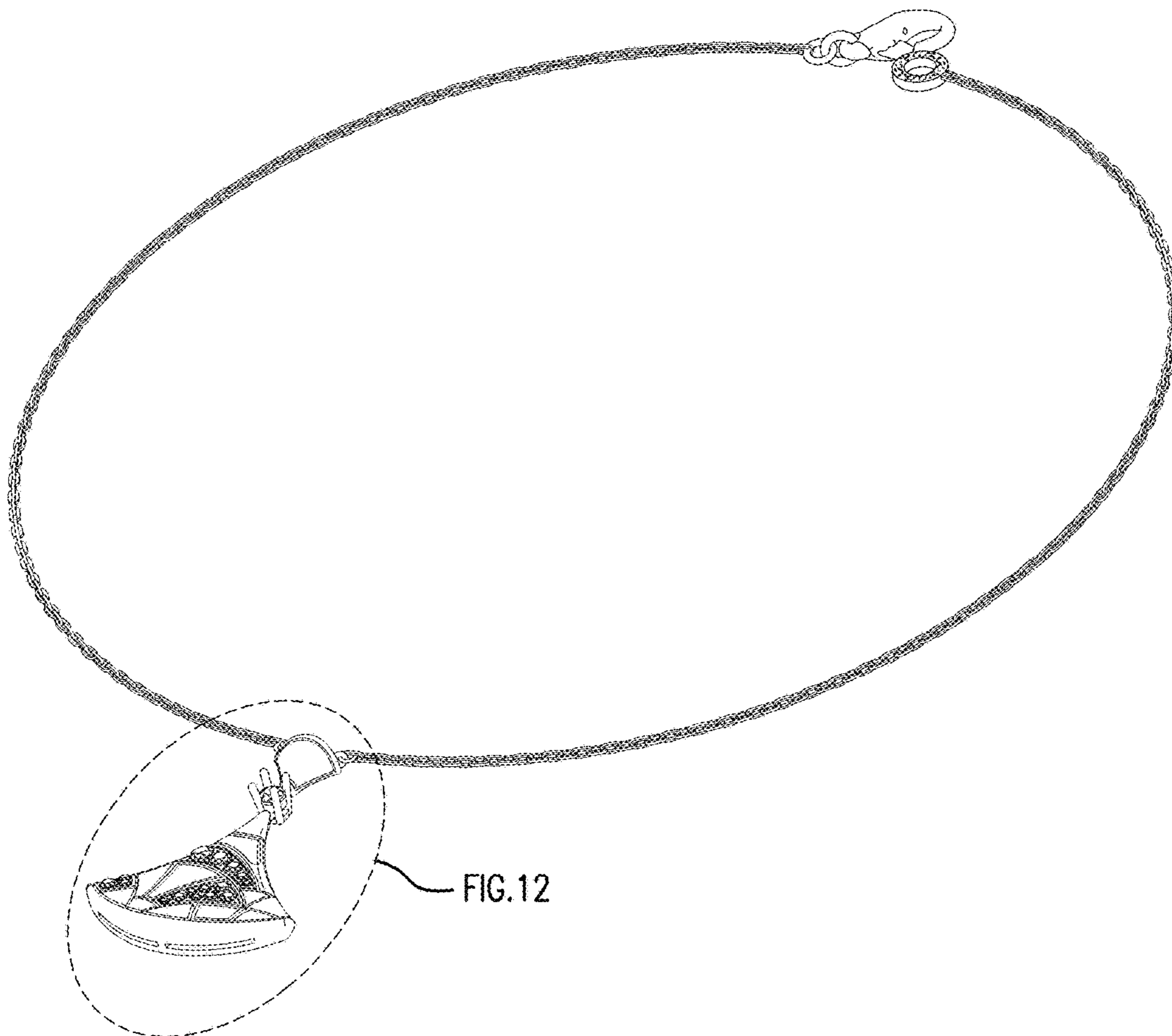

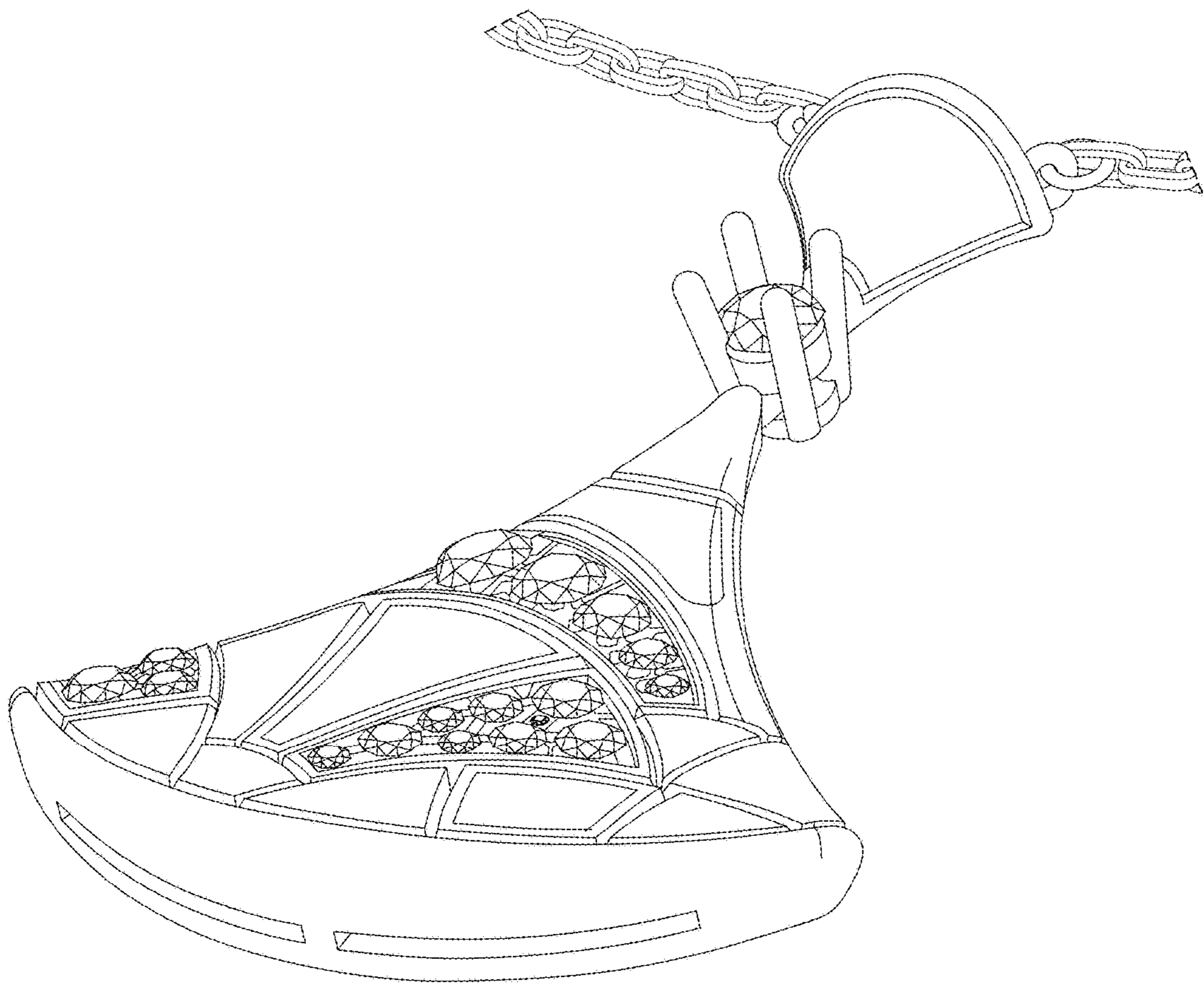

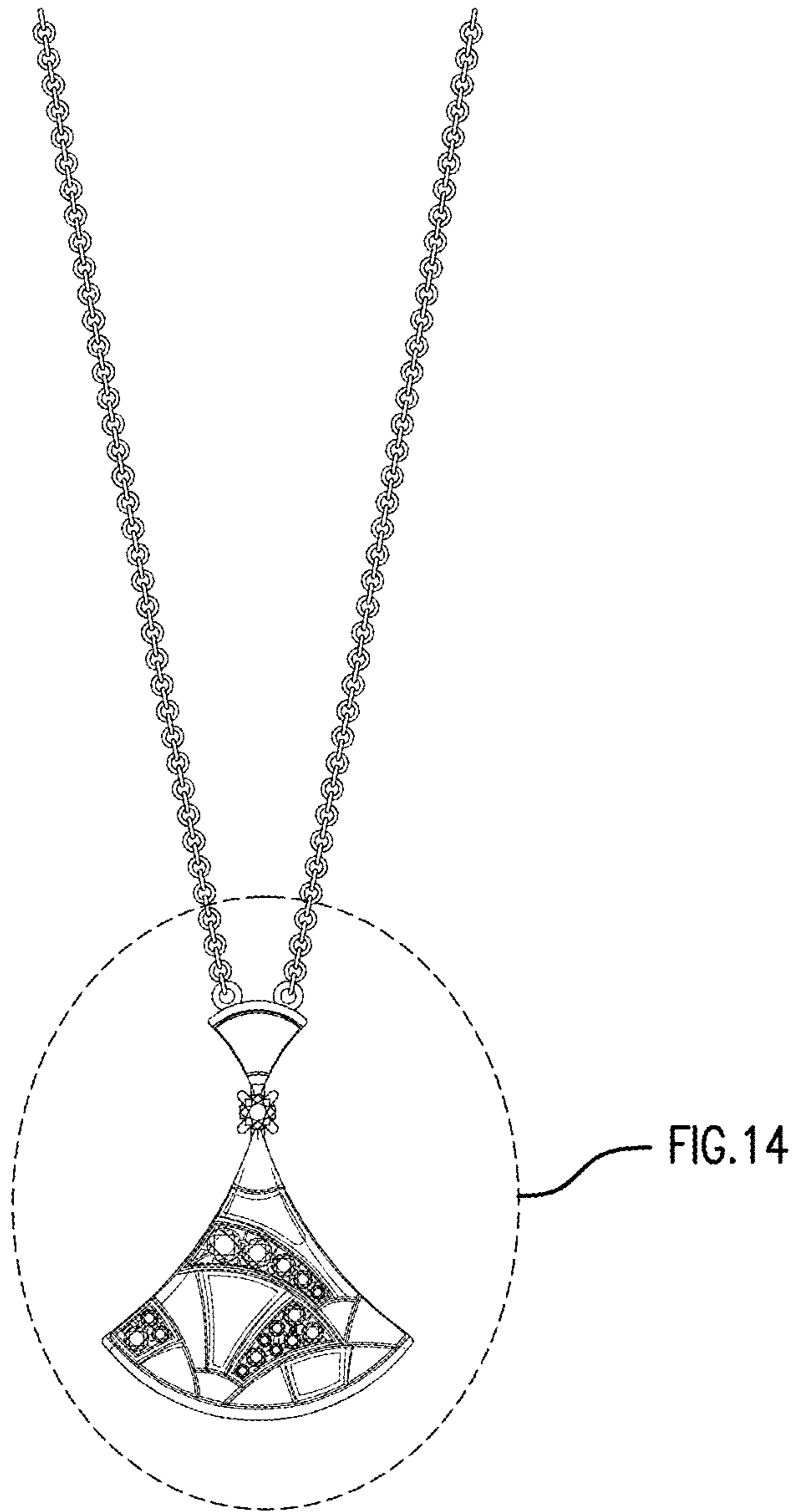

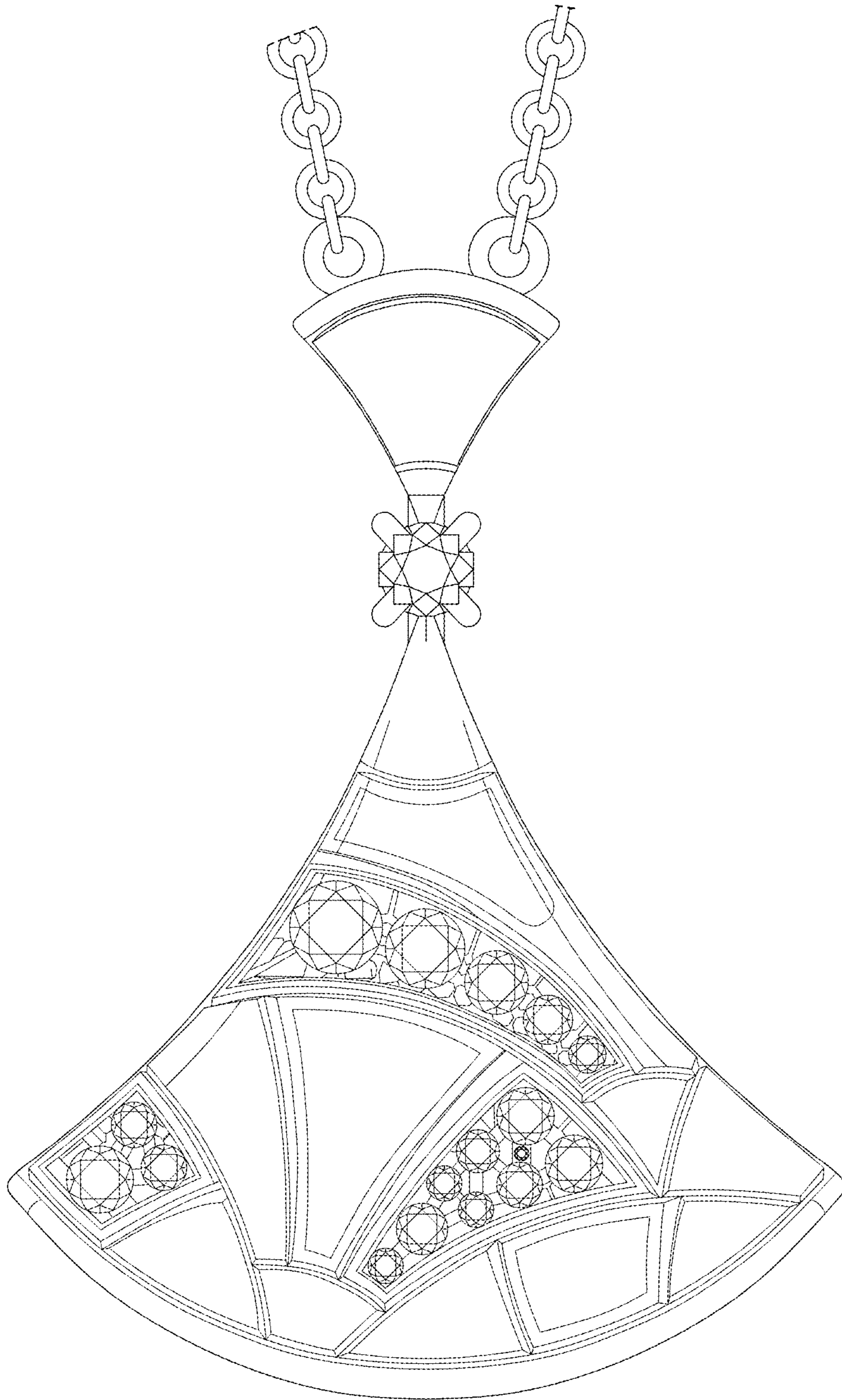
