(57) **CLAIM**

The ornamental design for a scanner device, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a scanner device, taken from the back;

FIG. 2 is a second perspective view of the scanner device, taken from the front;

FIG. 3 is a front view of the scanner device as shown in FIG. 1;

FIG. 4 is a back view of the scanner device as shown in FIG. 1;

FIG. 5 is a right-side view of the scanner device as shown in FIG. 1;

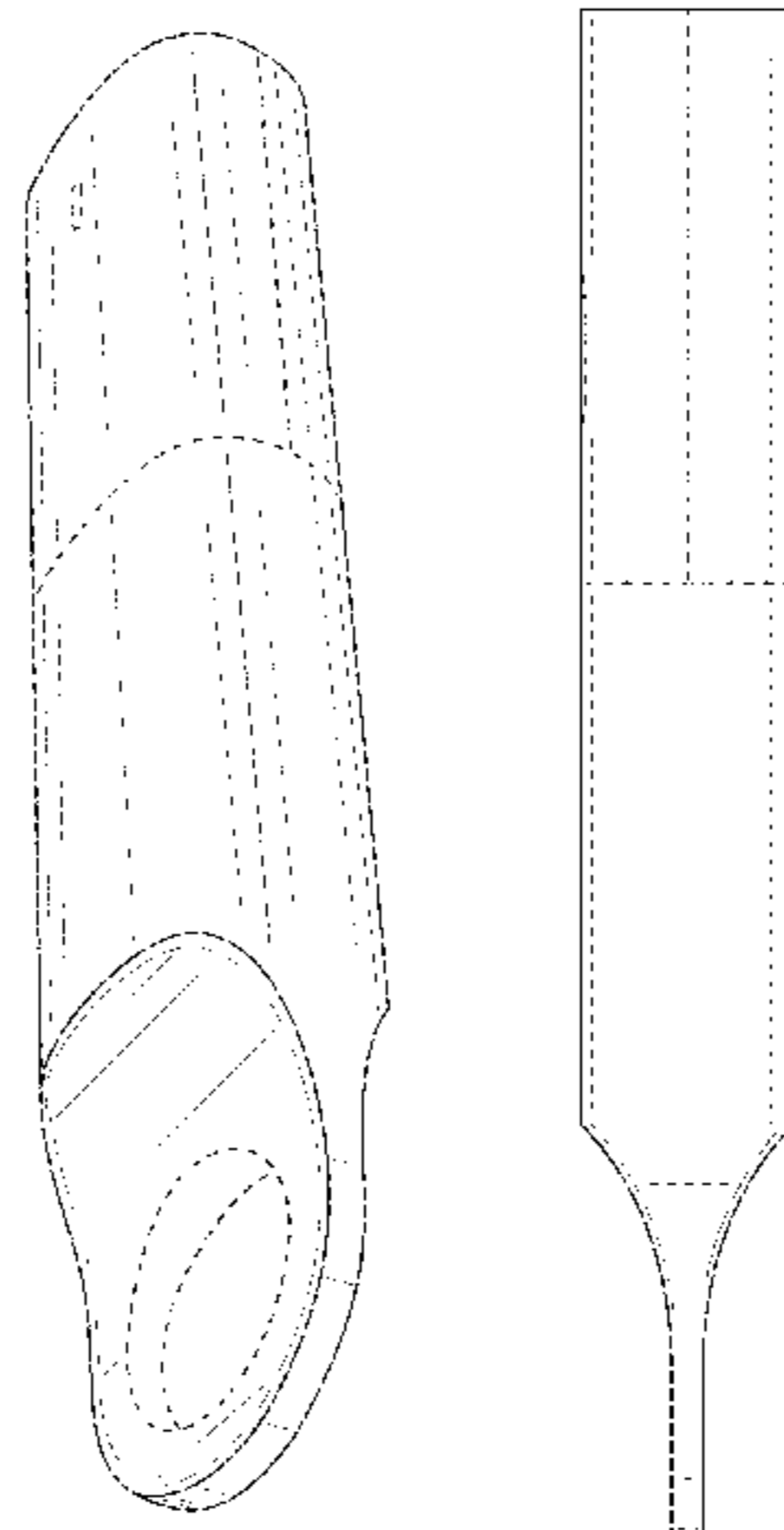
FIG. 6 is a left-side view of the scanner device as shown in FIG. 1;

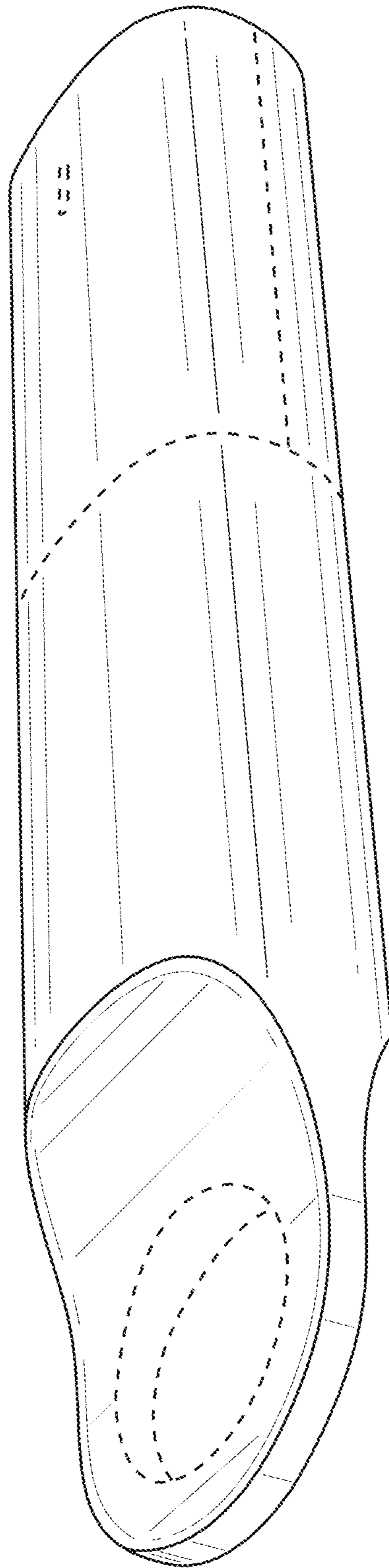

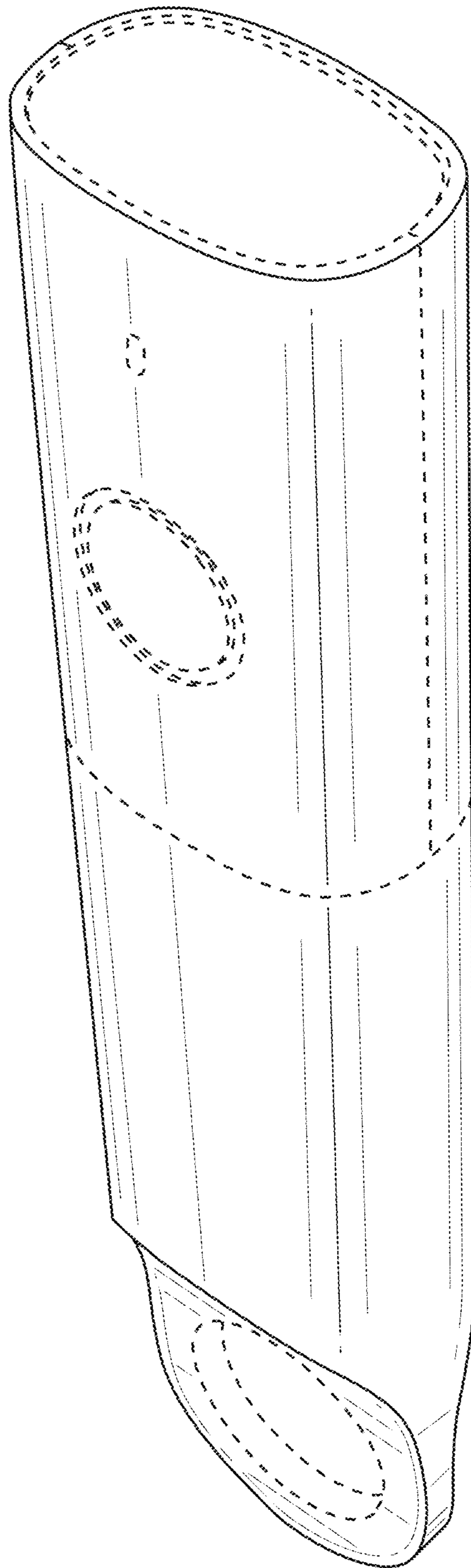

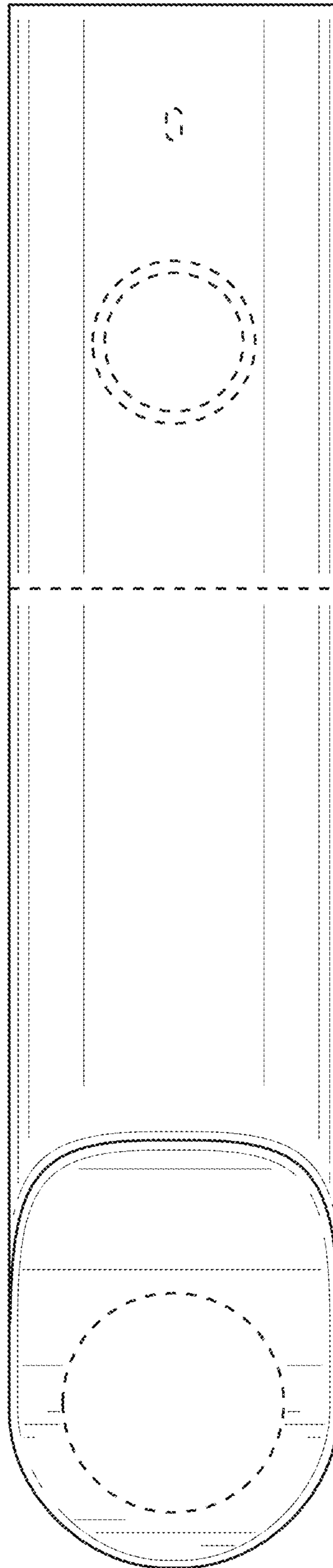

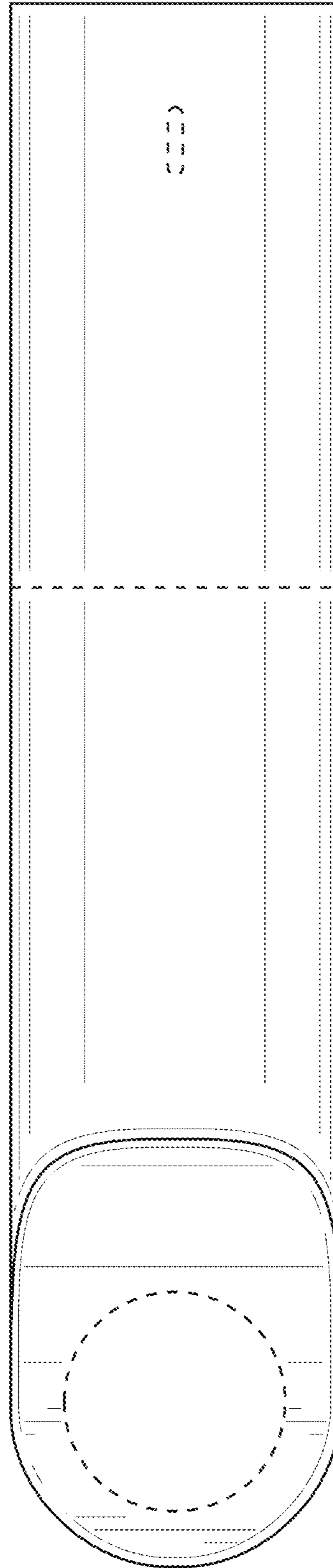

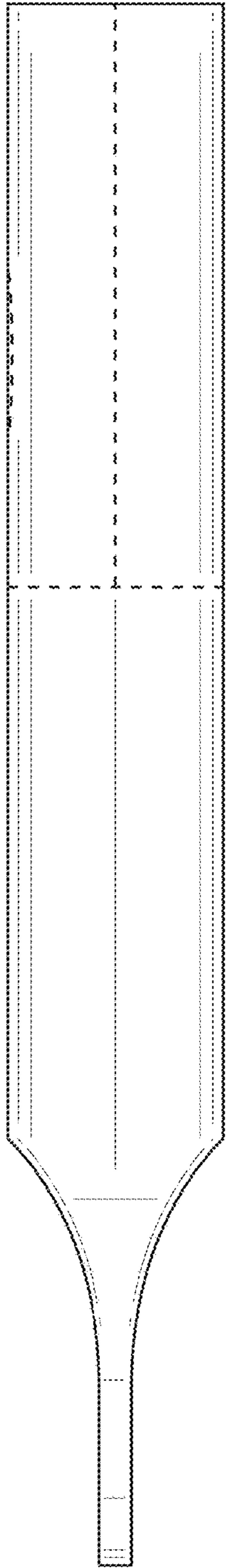

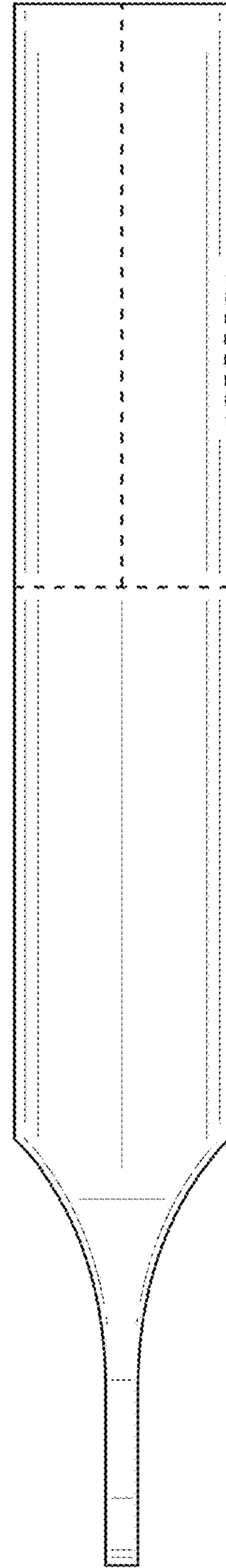

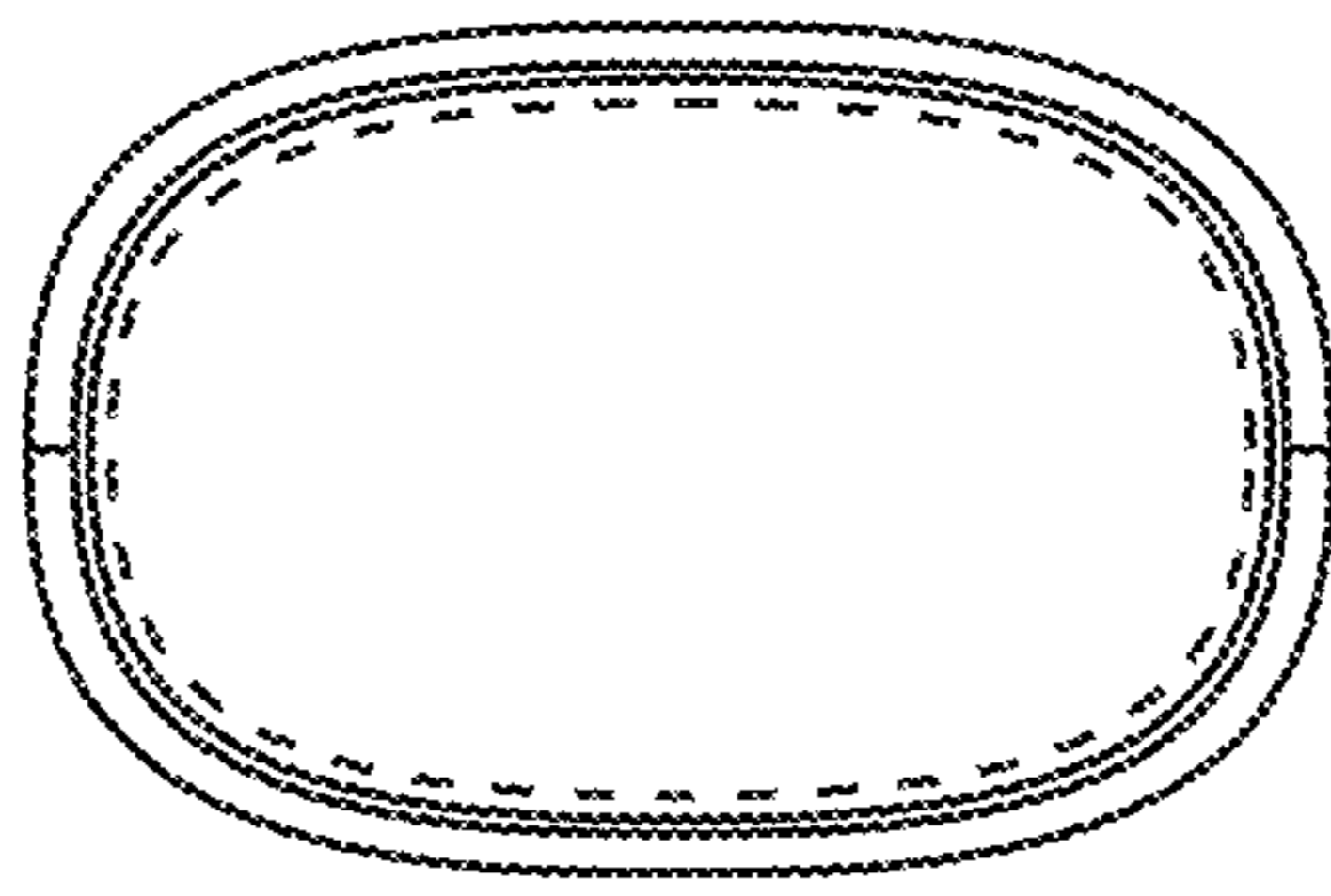

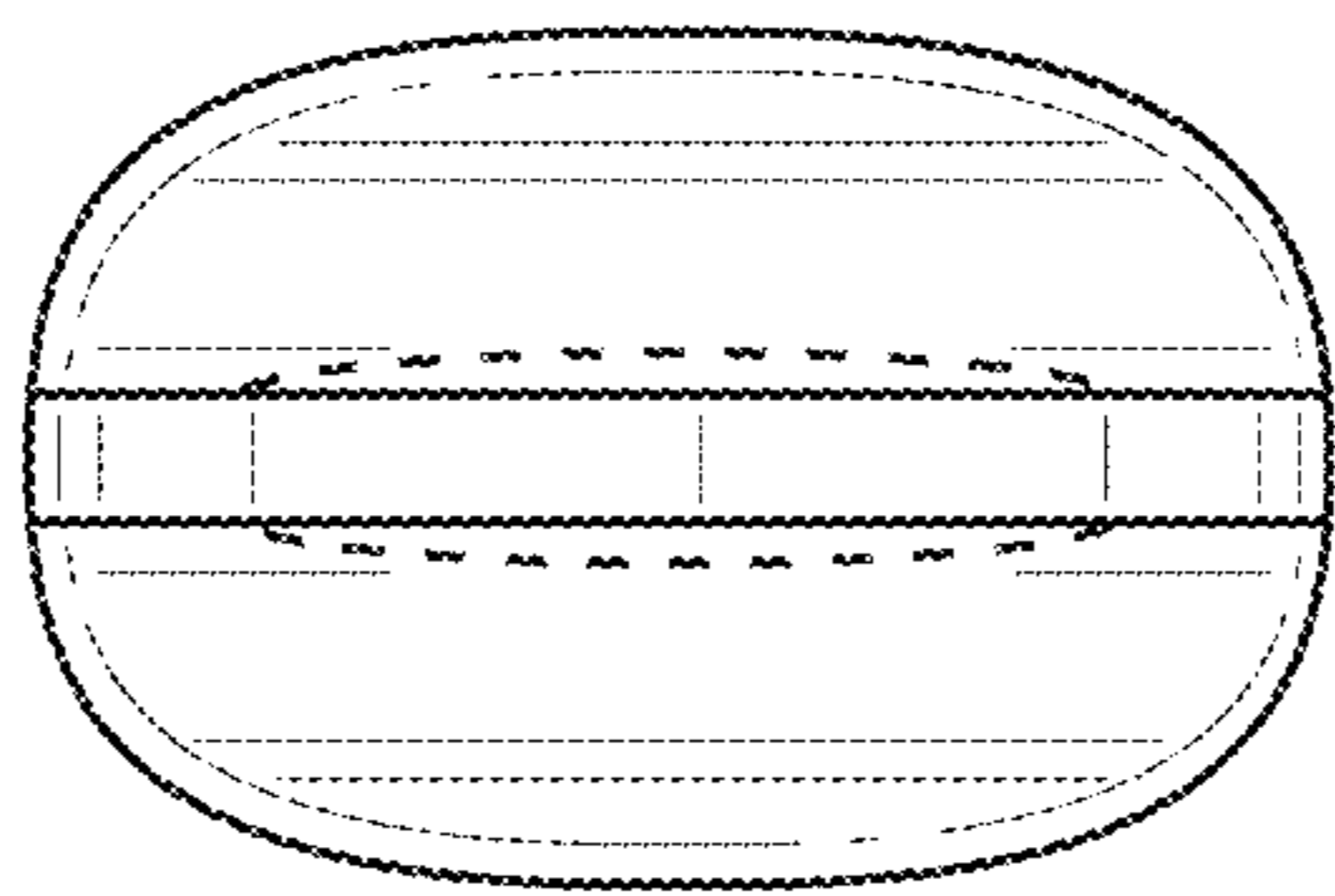
